**DESCRIPTION**

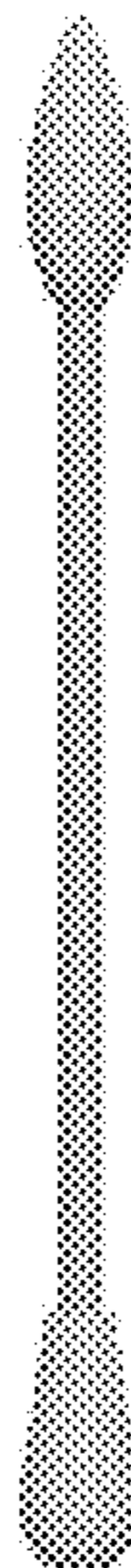
FIG. 1 is a front perspective view of a swab according to the new design;

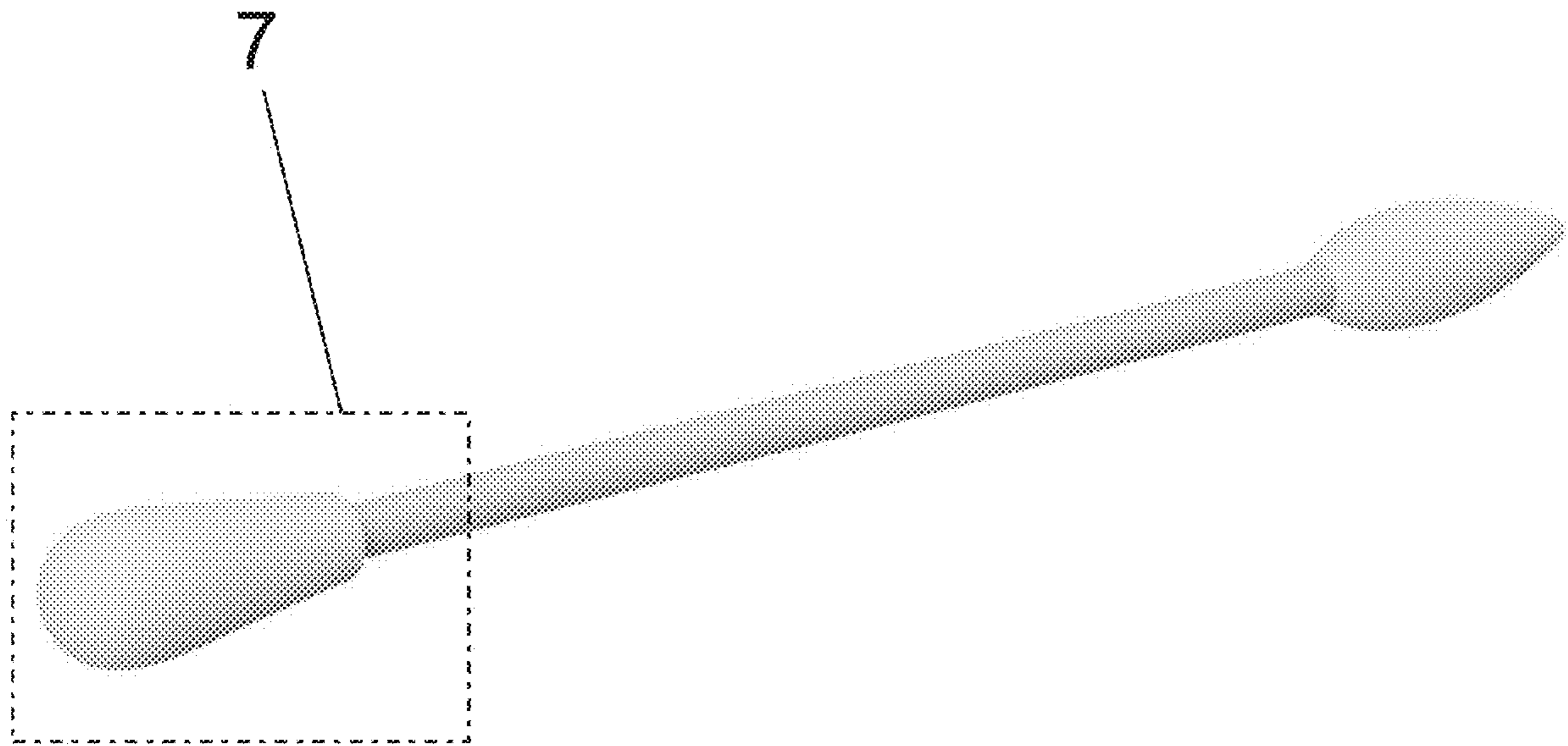

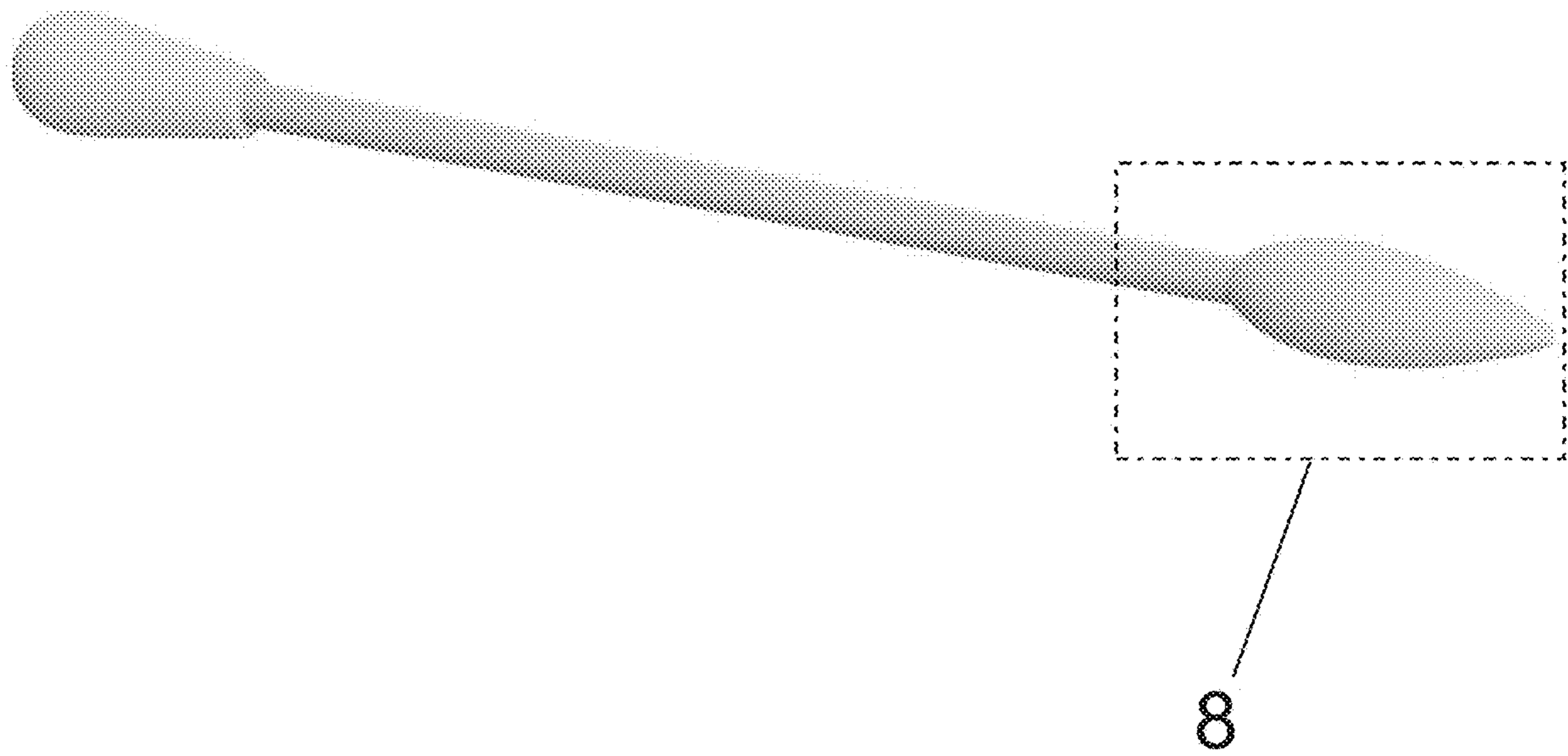

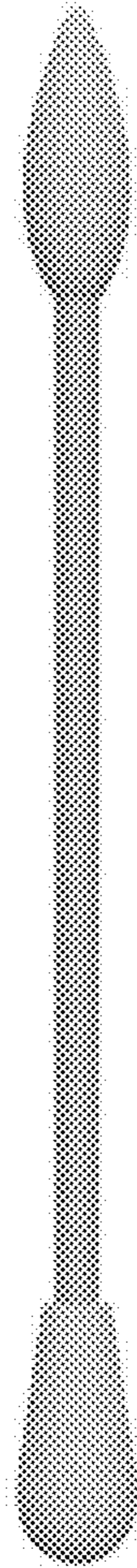

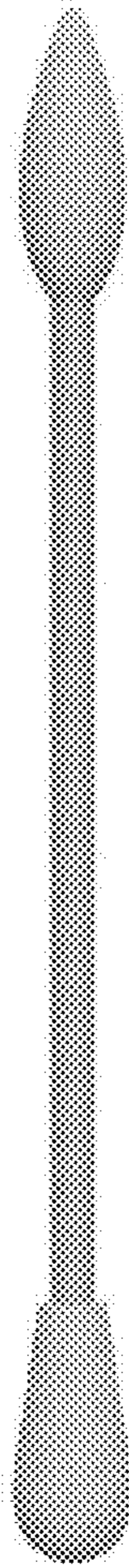
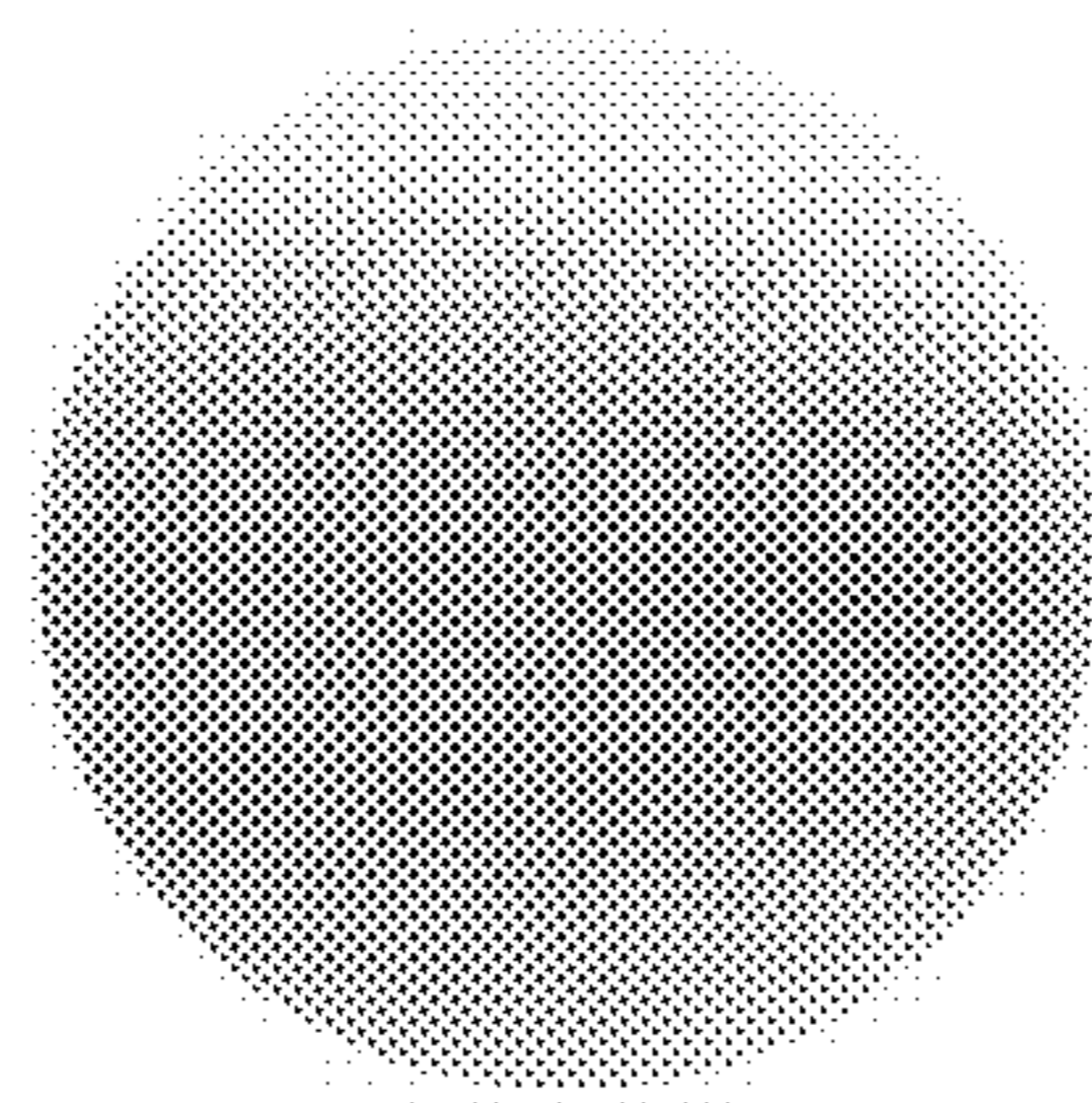

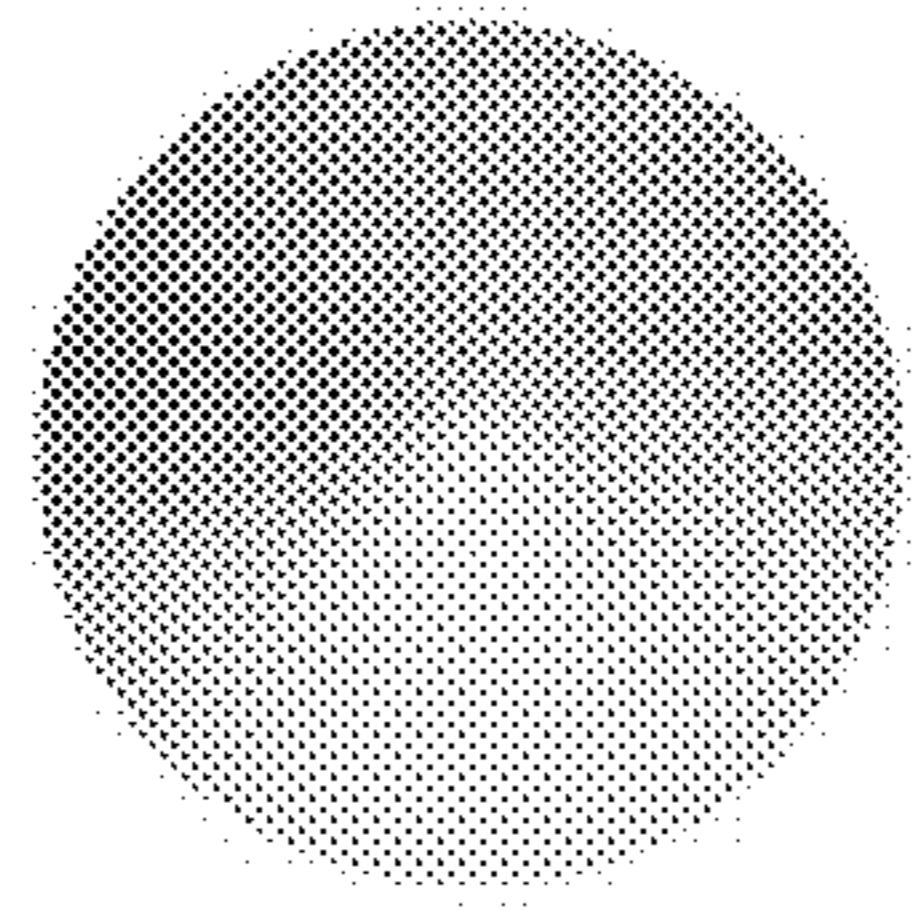

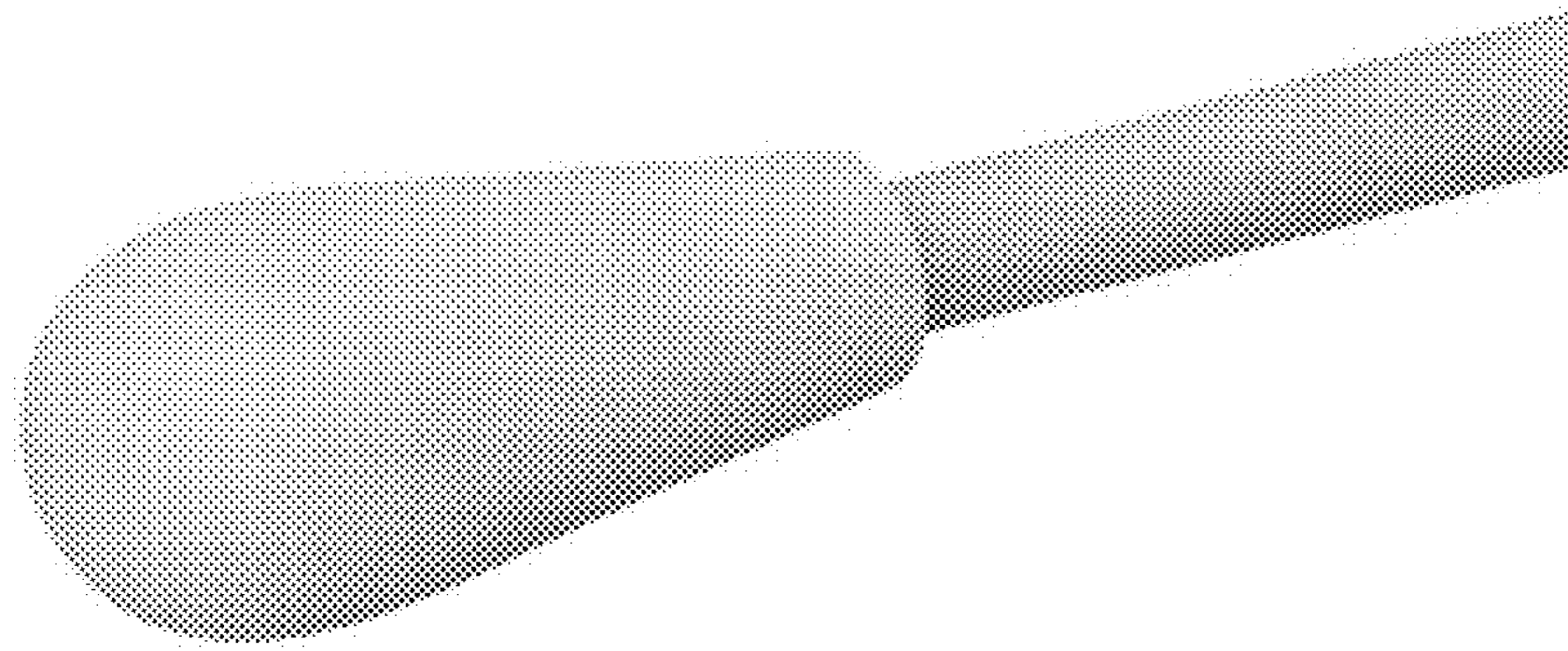

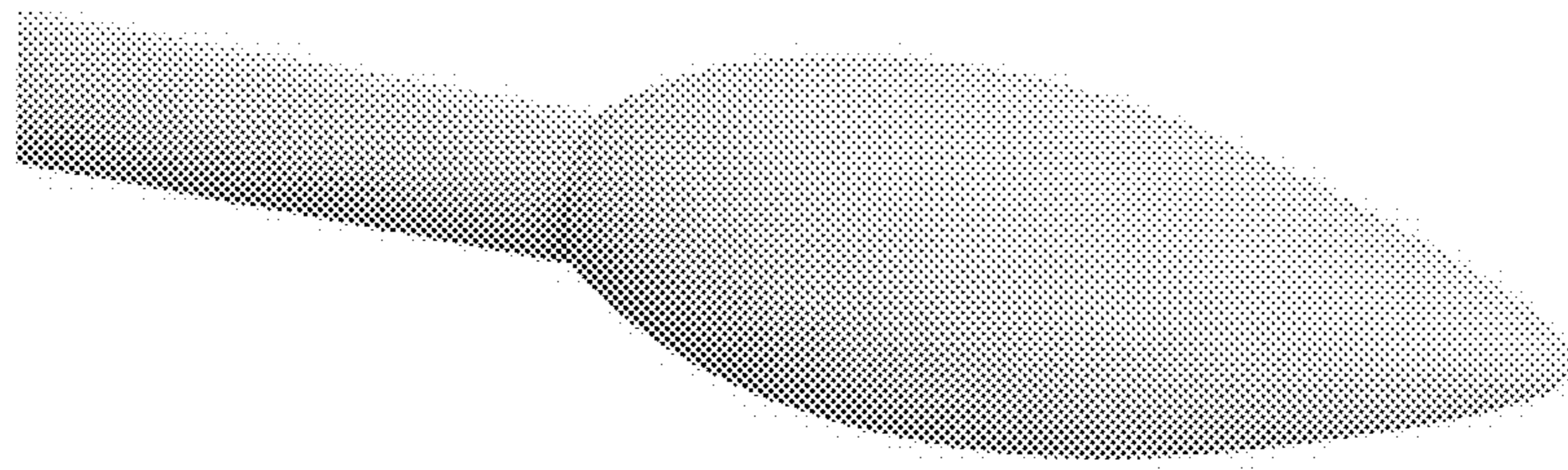
