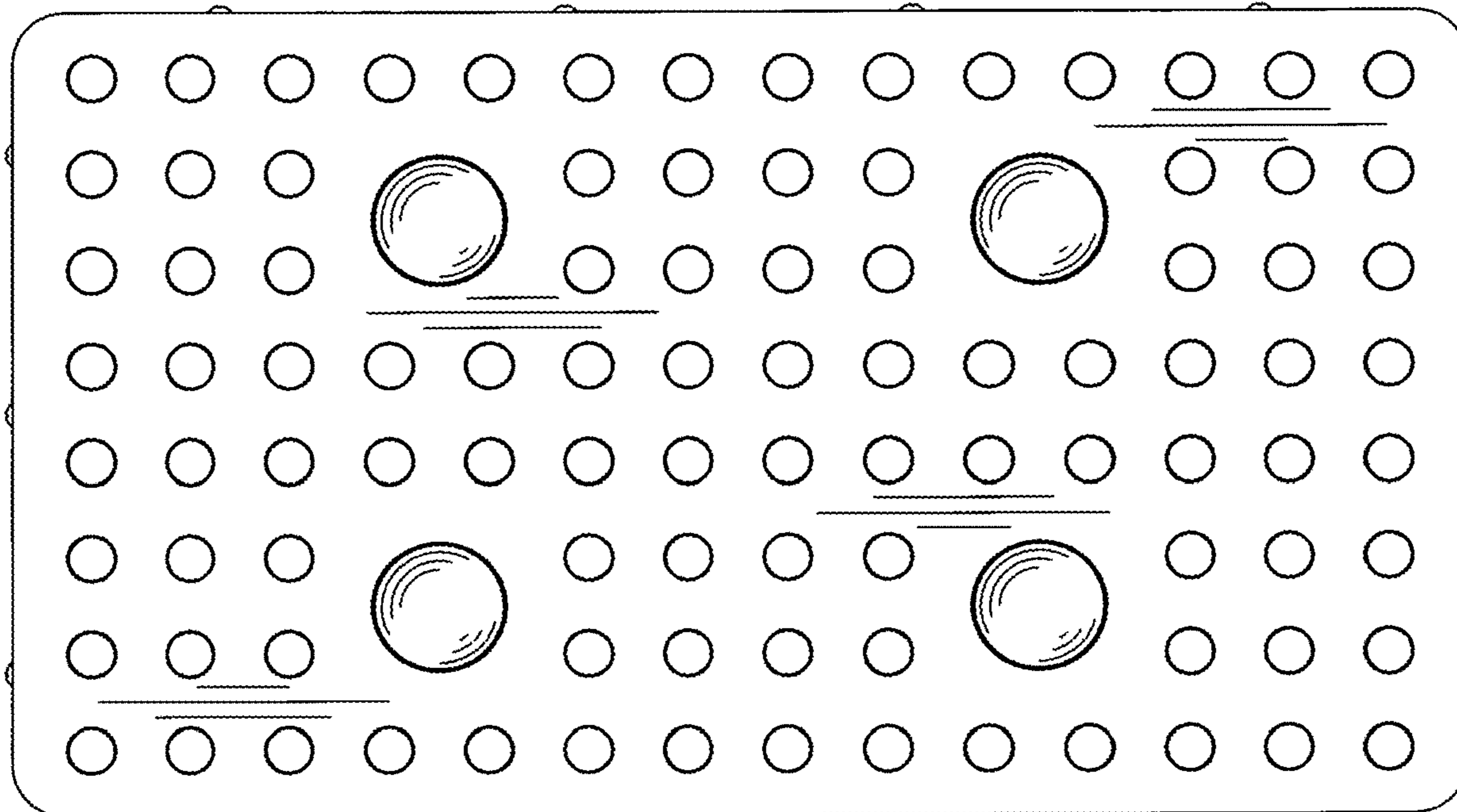
(57) **CLAIM**

The ornamental design for a LED grow light, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a LED grow light showing my new design;

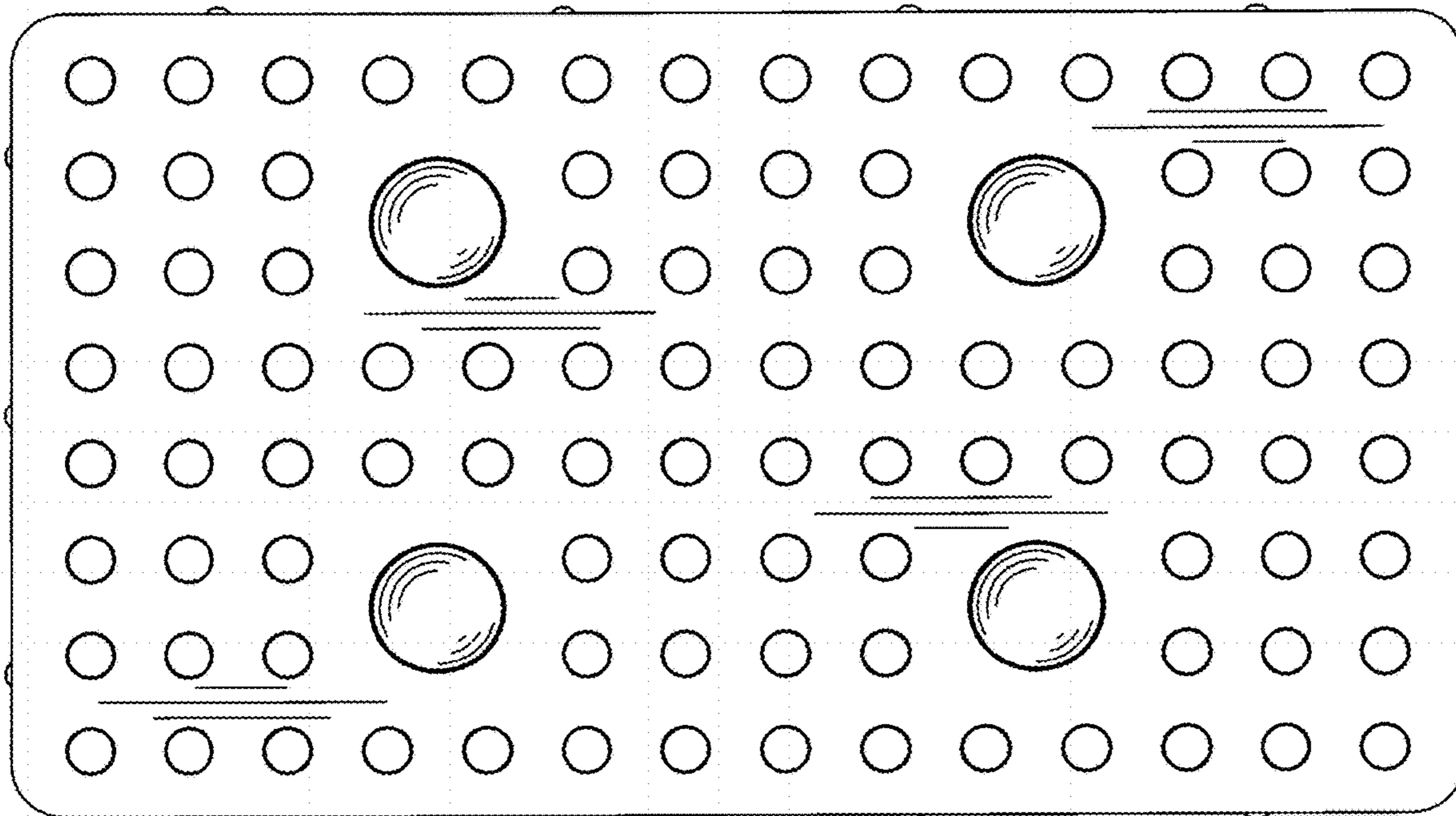

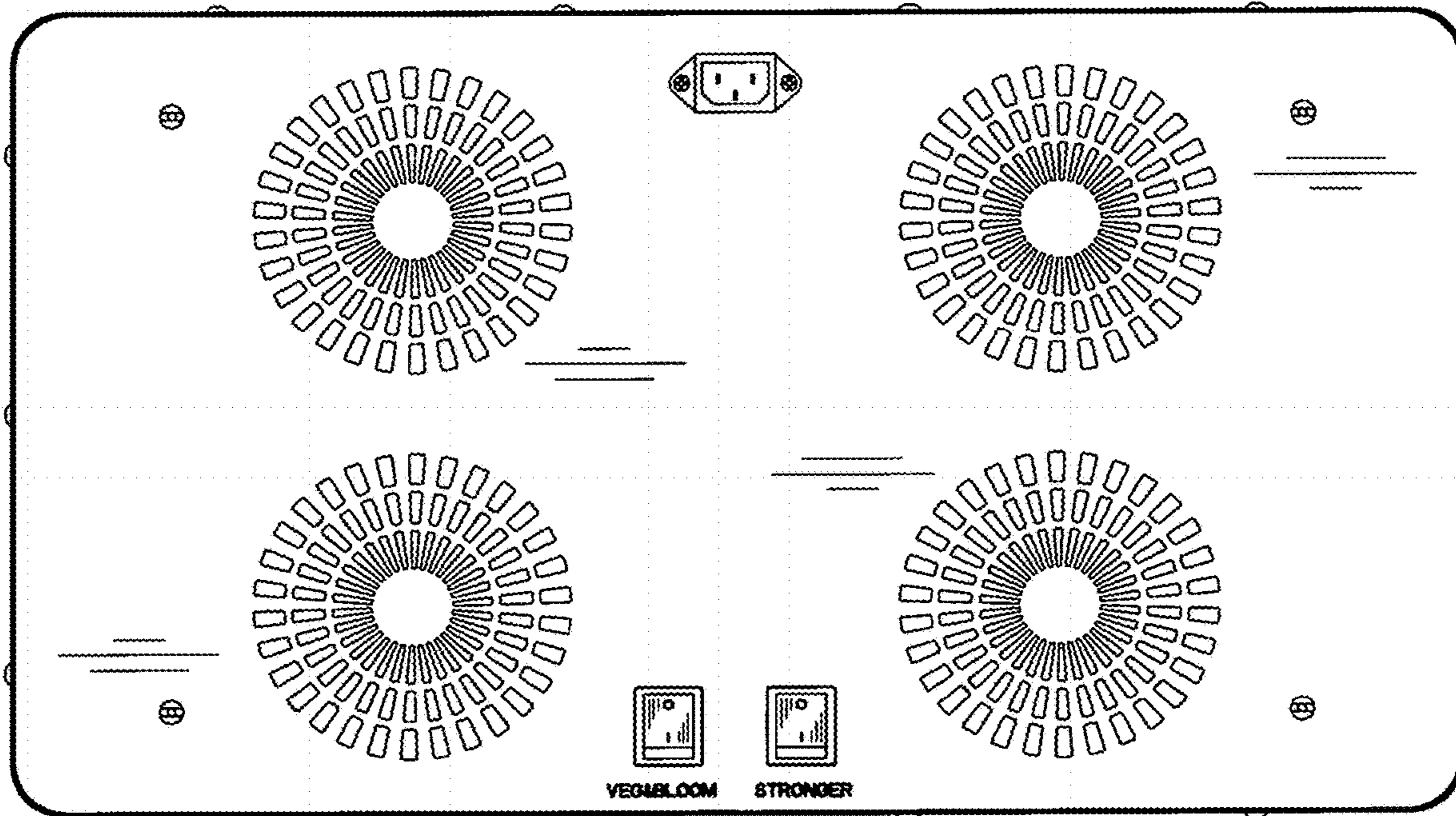

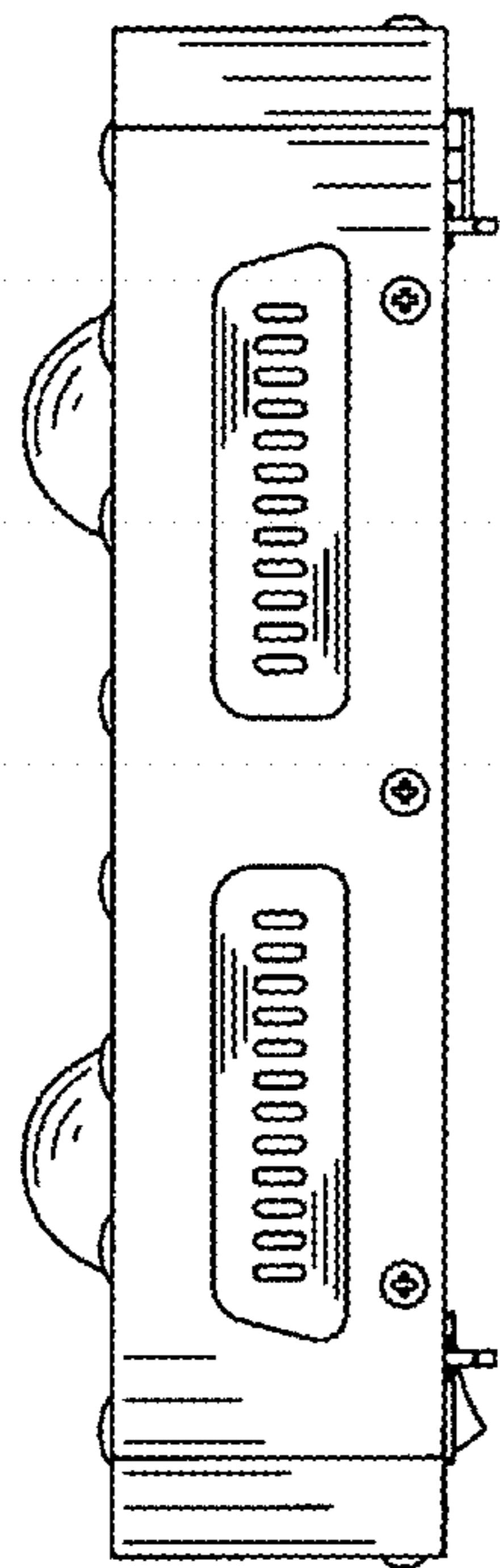

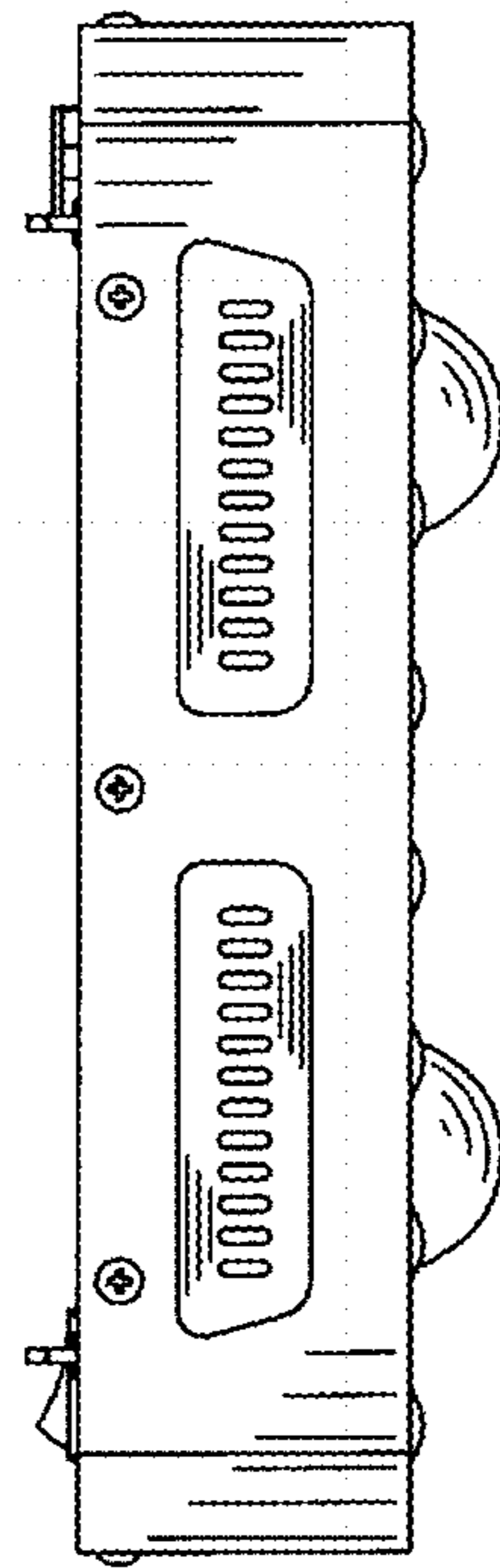

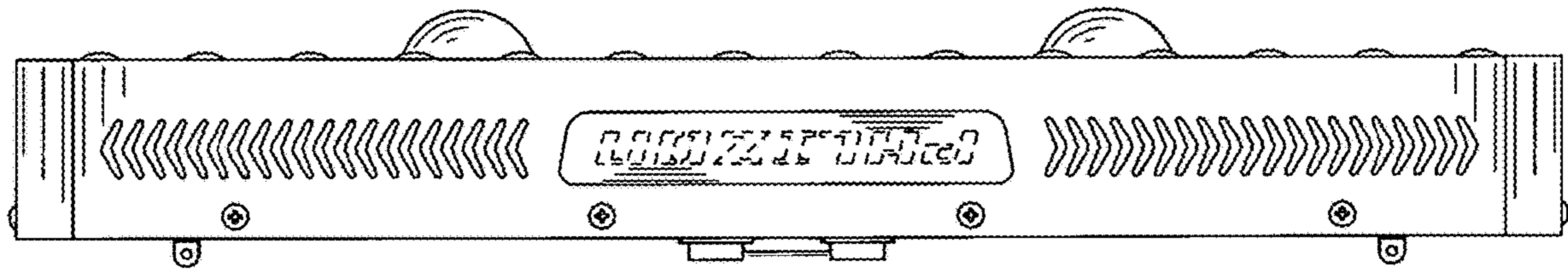

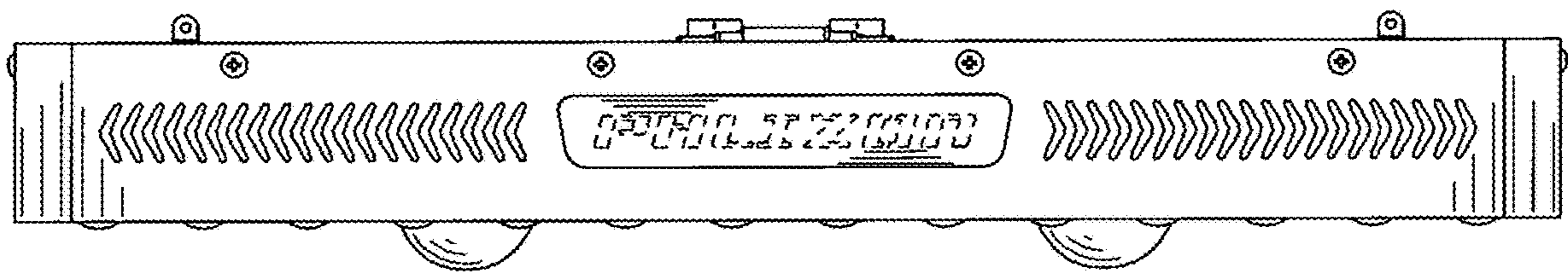

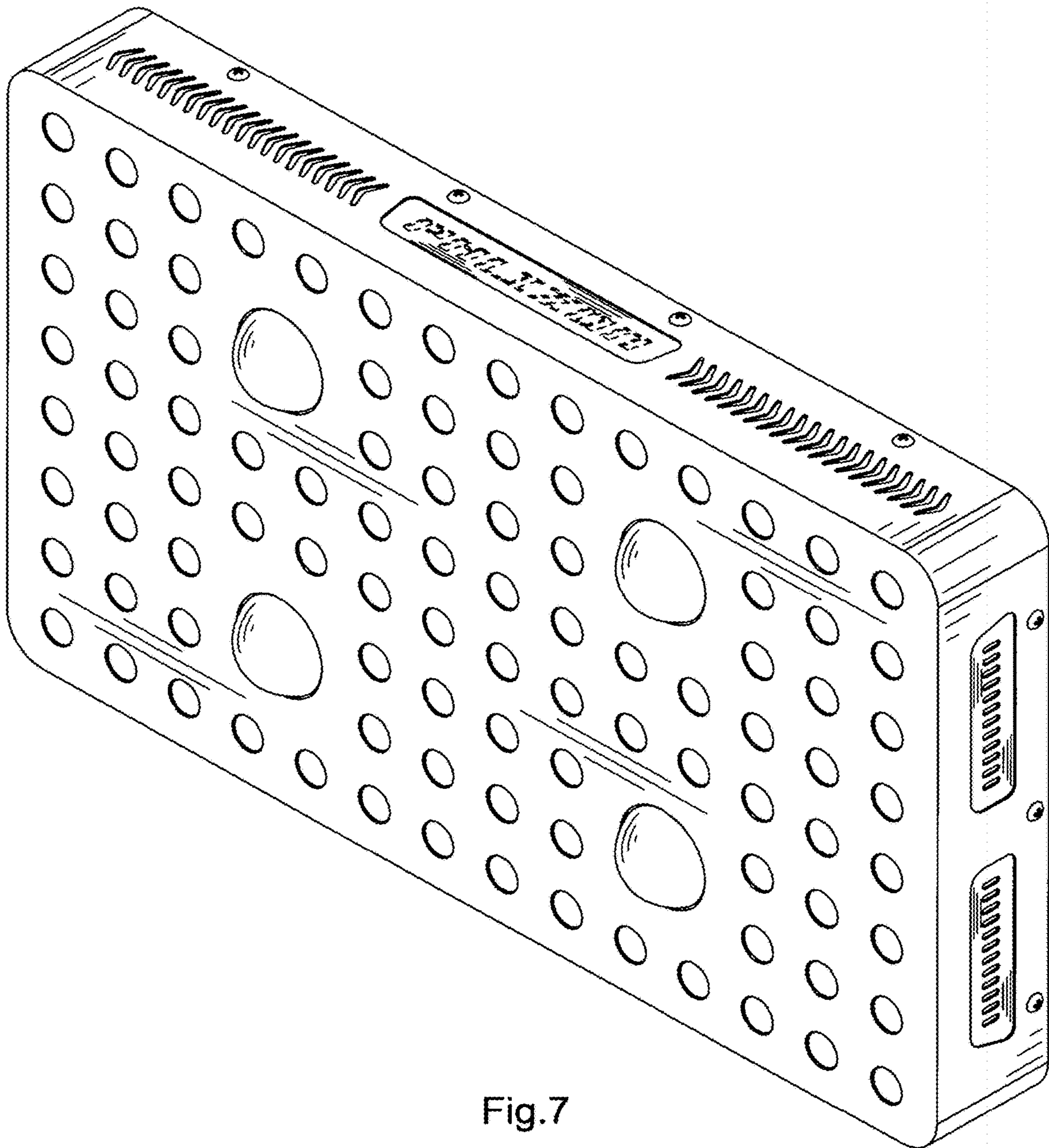

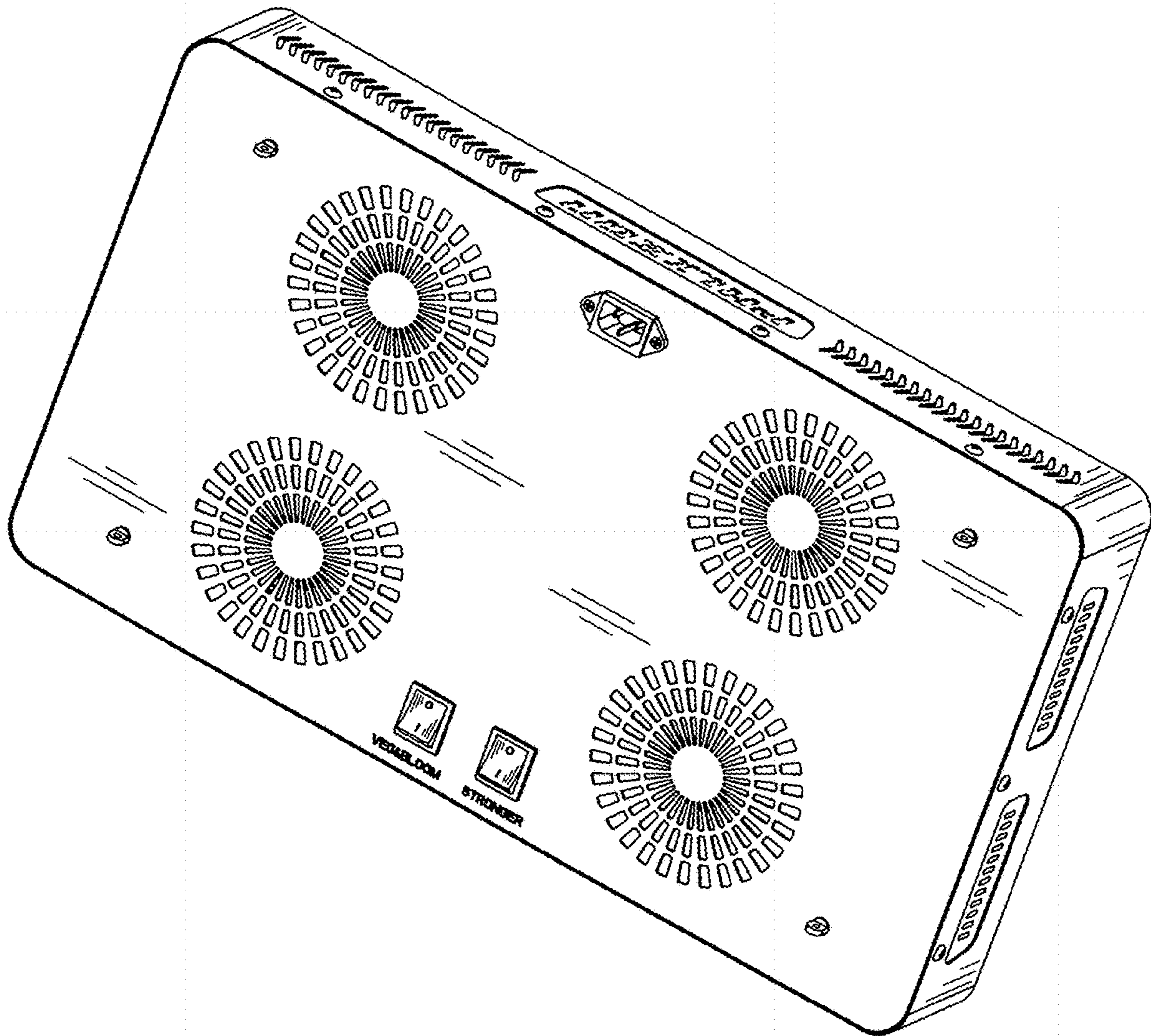
