(57) **CLAIM**

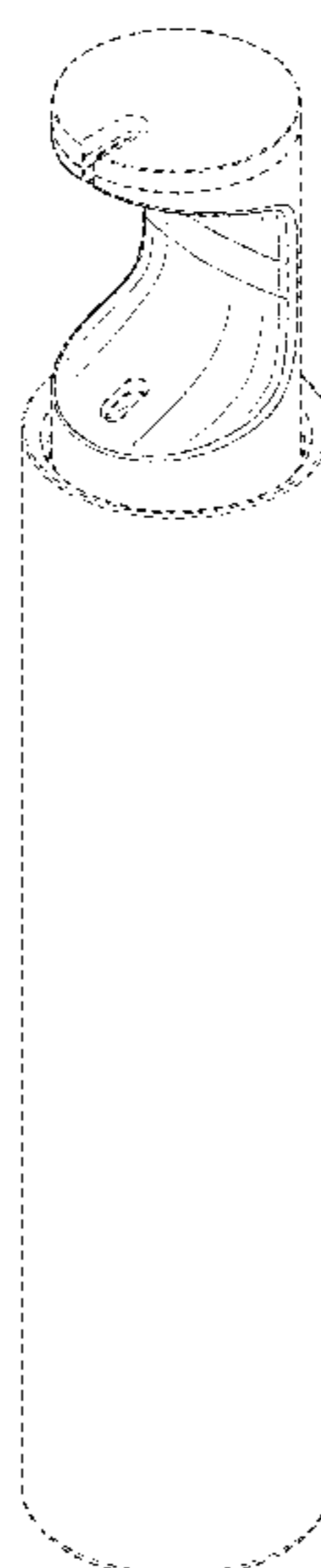
The ornamental design for a dental floss dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a top perspective view of a dental floss dispenser; FIG. 2 is a bottom perspective view of the dental floss dispenser; FIG. 3 is a side view of the dental floss dispenser; FIG. 4 is another side view of the dental floss dispenser; FIG. 5 is a further side view of the dental floss dispenser; FIG. 6 is yet another side view of the dental floss dispenser; FIG. 7 is a top view of the dental floss dispenser; FIG. 8 is a bottom view of the dental floss dispenser; FIG. 9 is another top perspective view of the dental floss dispenser showing a dental floss dispensing portion extended from the dental floss dispenser; FIG. 10 is another bottom perspective view of the dental floss dispenser showing the dental floss dispensing portion extended from the dental floss dispenser; FIG. 11 is another side view of the dental floss dispenser showing the dental floss dispensing portion extended from the dental floss dispenser; FIG. 12 is another side view of the dental floss dispenser showing the dental floss dispensing portion extended from the dental floss dispenser; FIG. 13 is yet another side view of the dental floss dispenser showing the dental floss dispensing portion extended from the dental floss dispenser; FIG. 14 is yet another side view of the dental floss dispenser showing the dental floss dispensing portion extended from the dental floss dispenser; FIG. 15 is another top view of the dental floss dispenser showing the dental floss dispensing portion extended from the dental floss dispenser; and, FIG. 16 is another bottom view of the dental floss dispenser showing the dental floss dispensing portion extended from the dental floss dispenser.

The broken lines depicting the outer container of the dental floss dispenser, the top of the dental floss dispenser and the small opening on the inside of the dental floss dispenser are for illustrative purposes and do not form part of the claimed design.

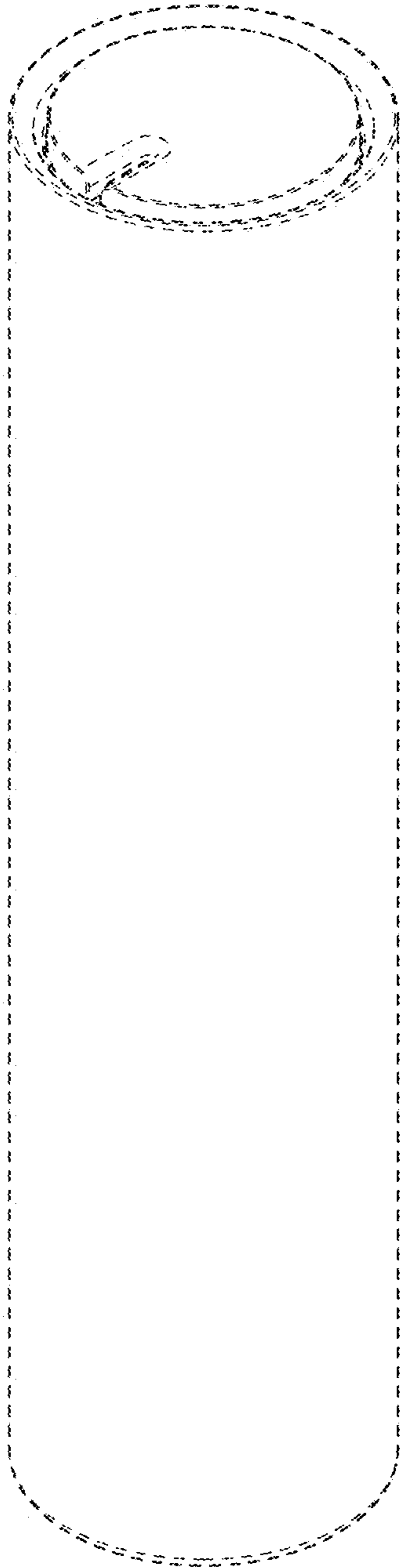

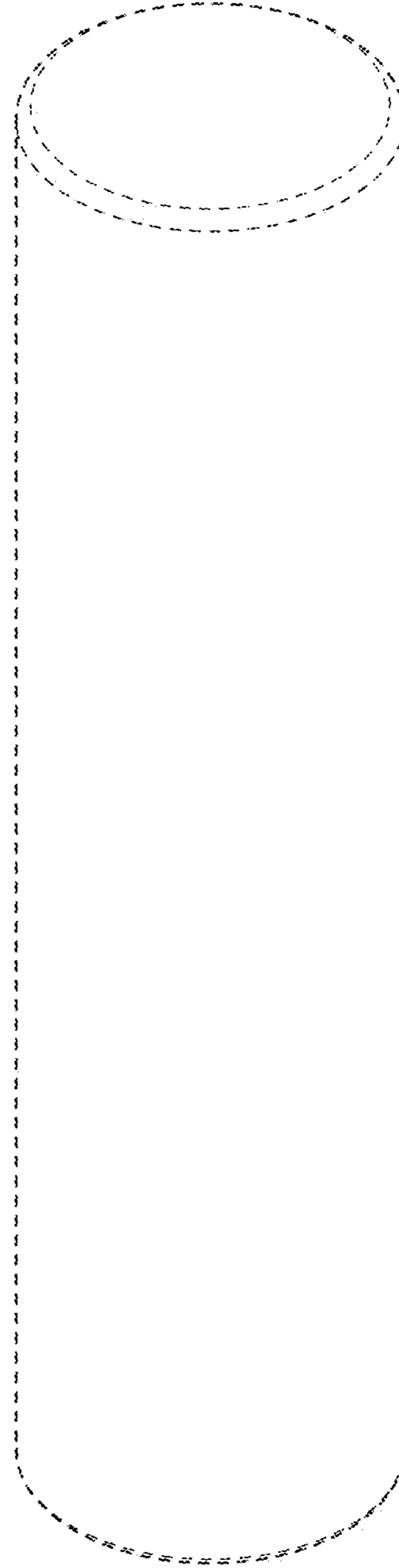

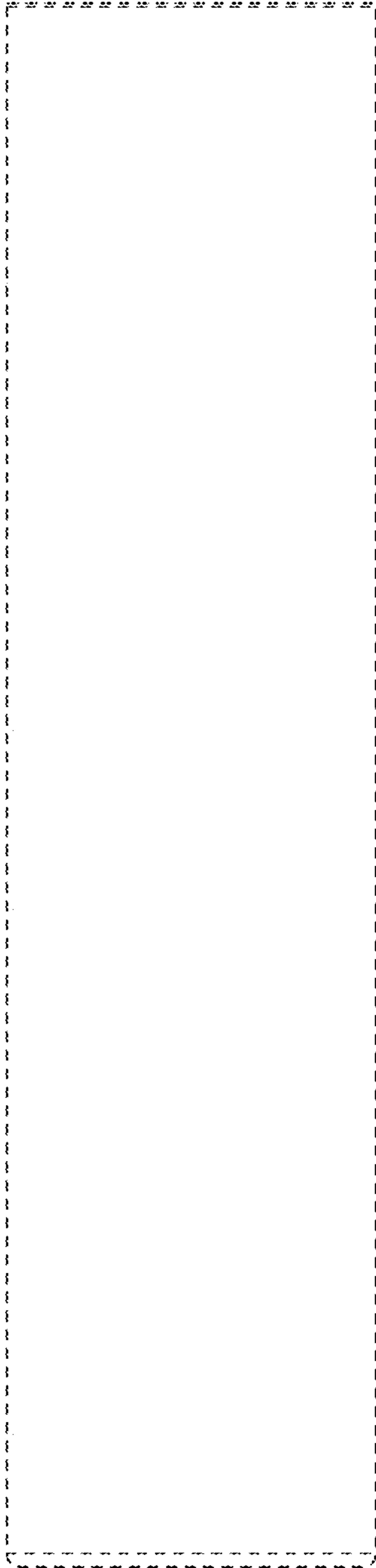

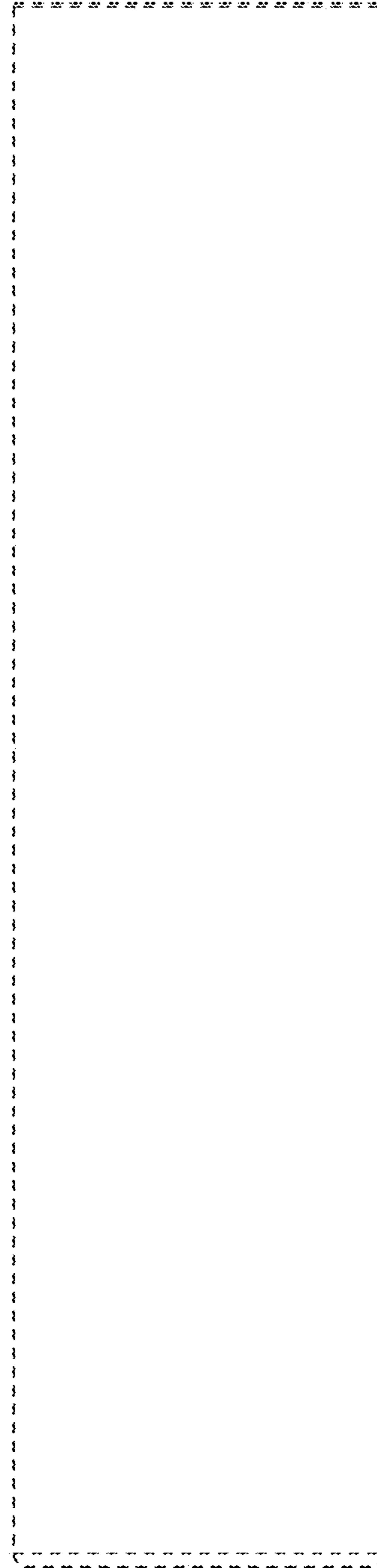

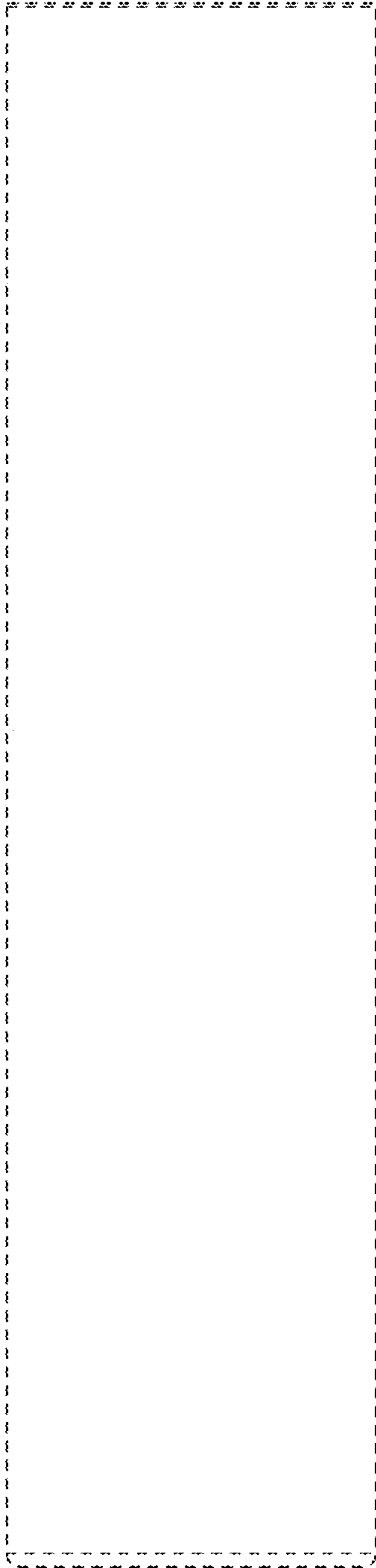

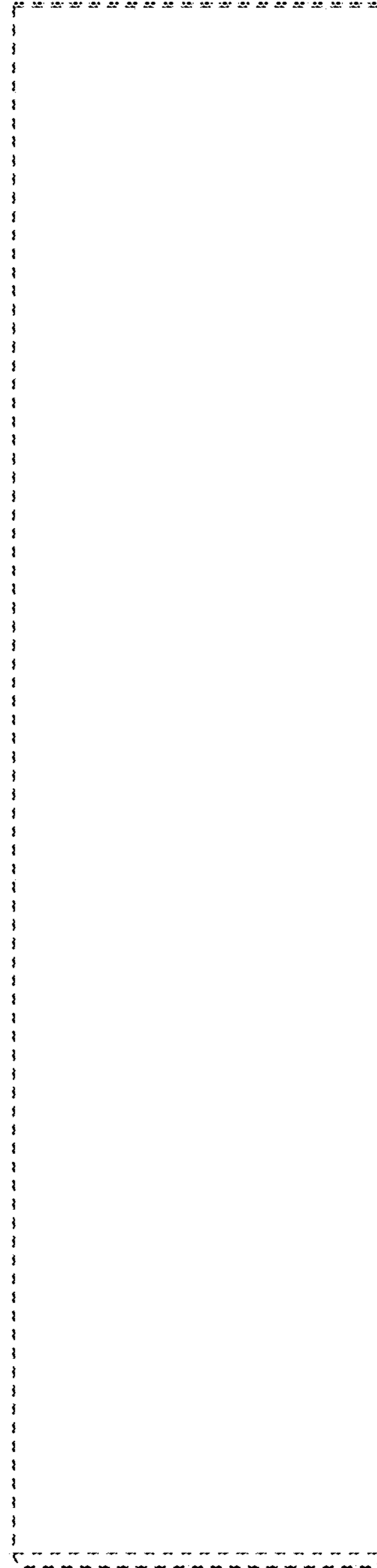

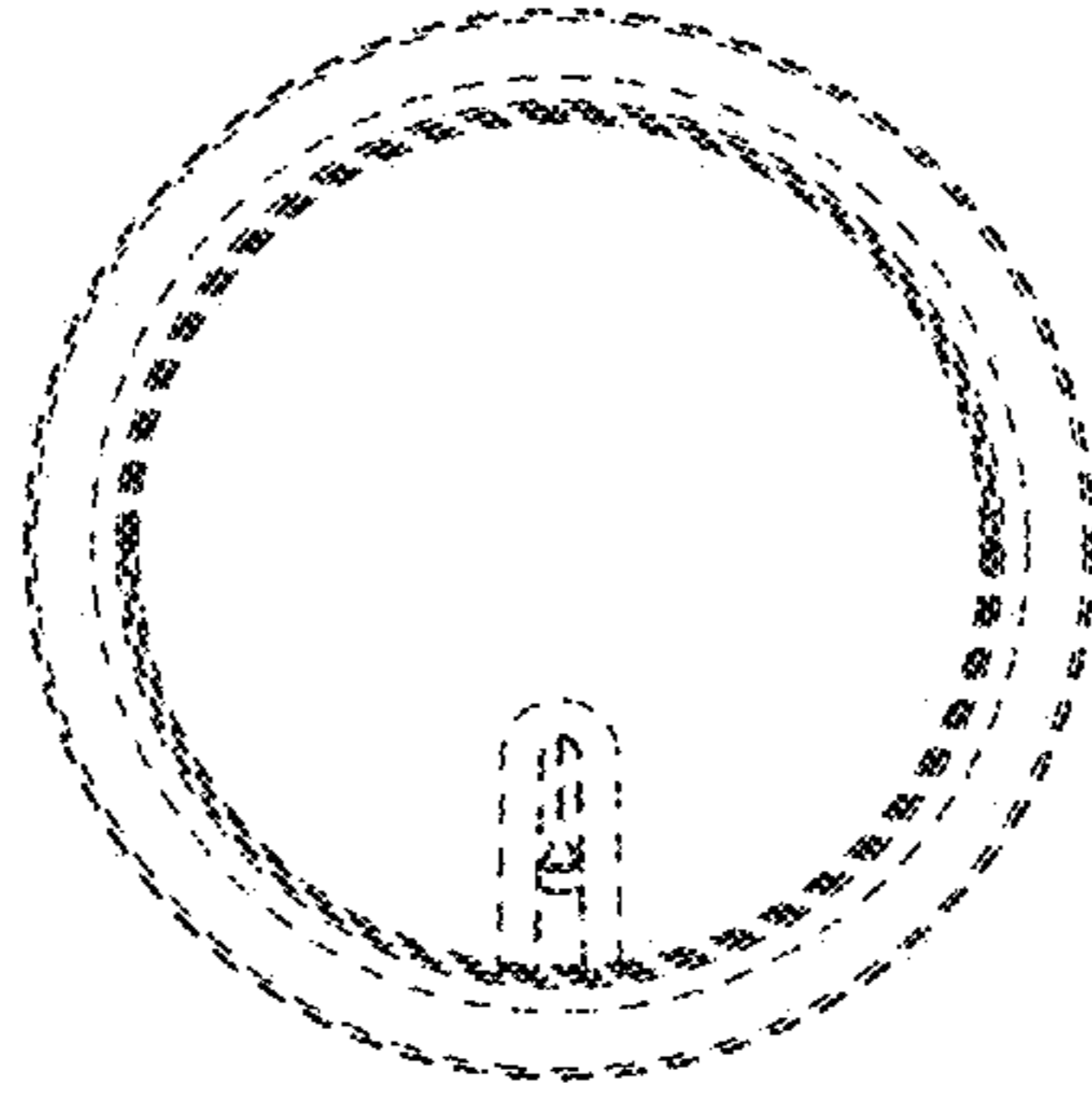

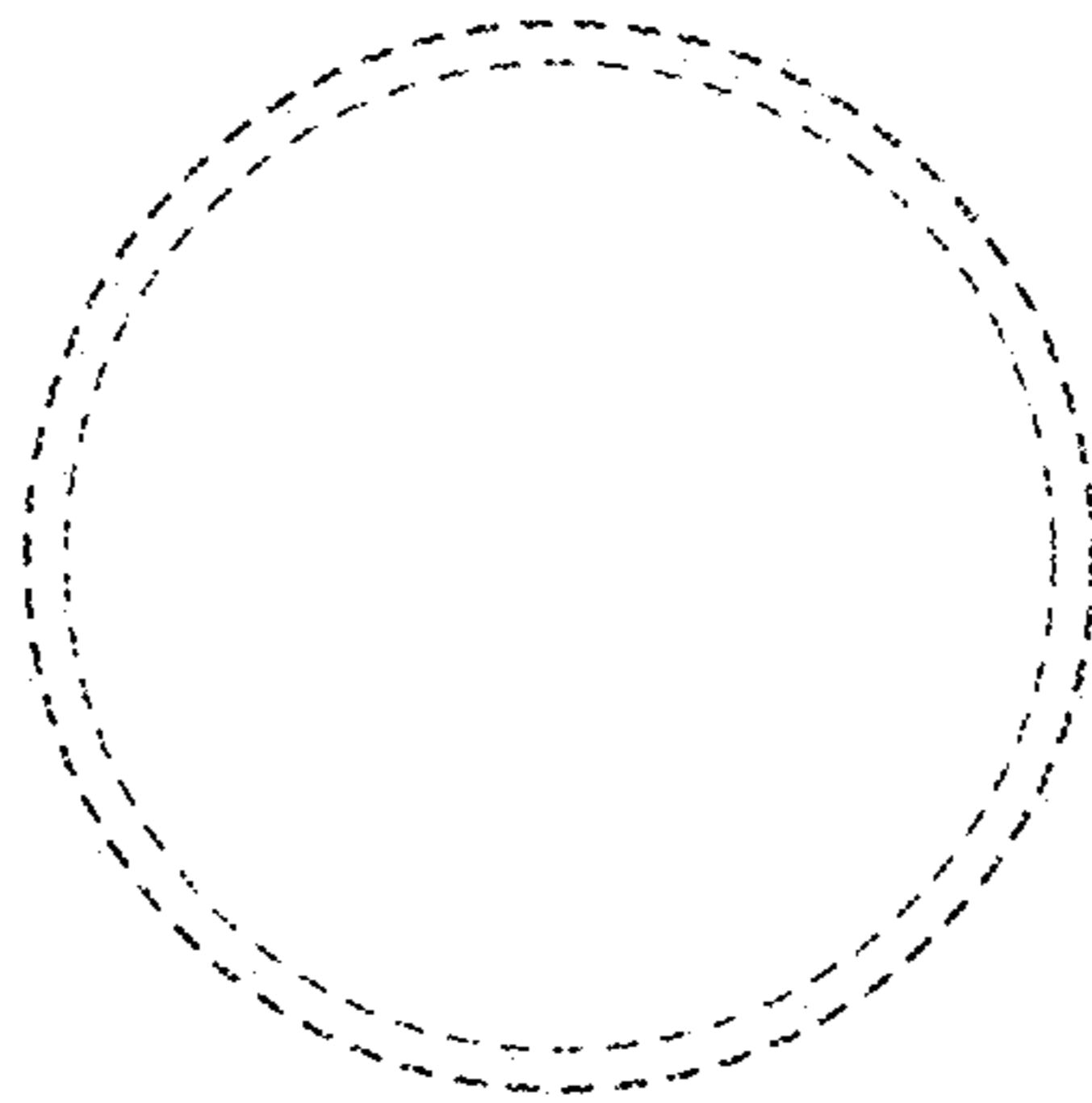

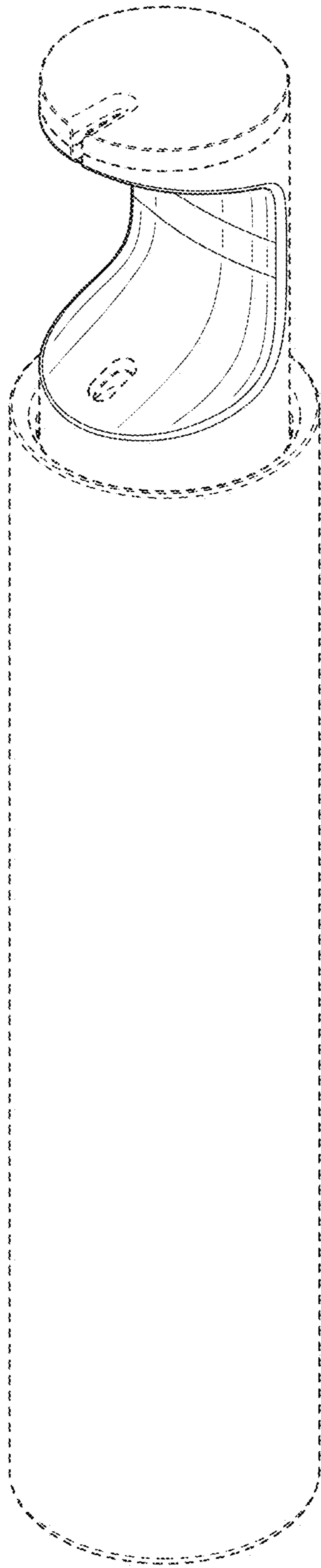

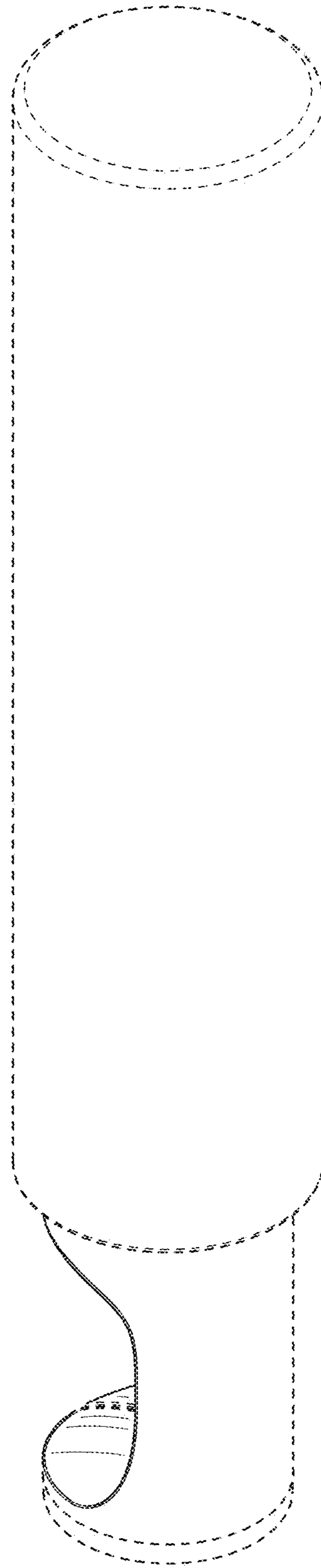

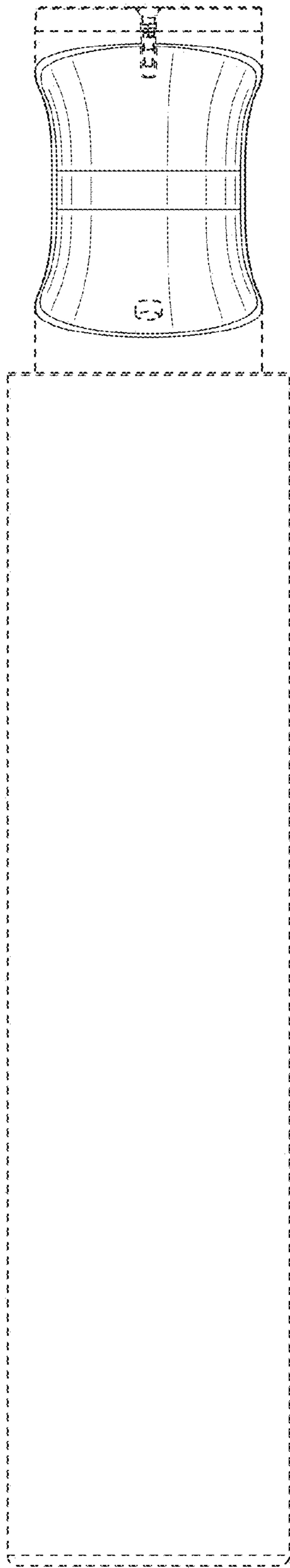

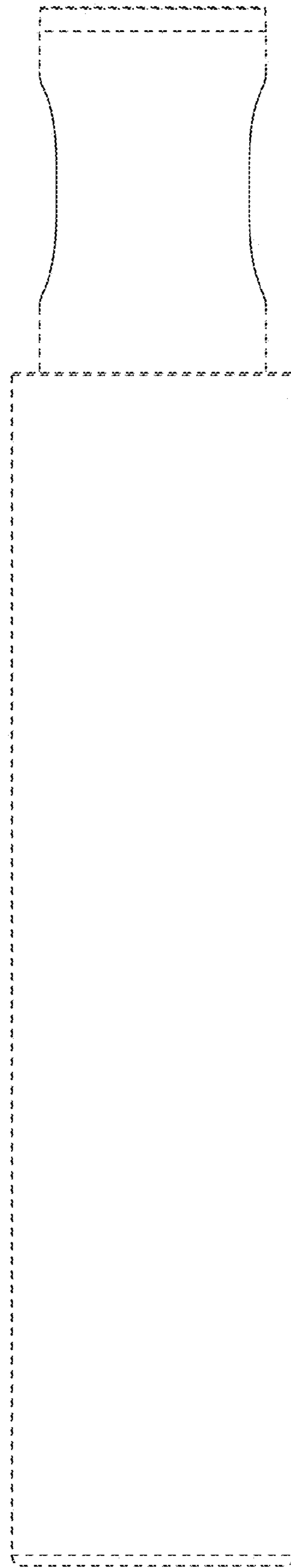

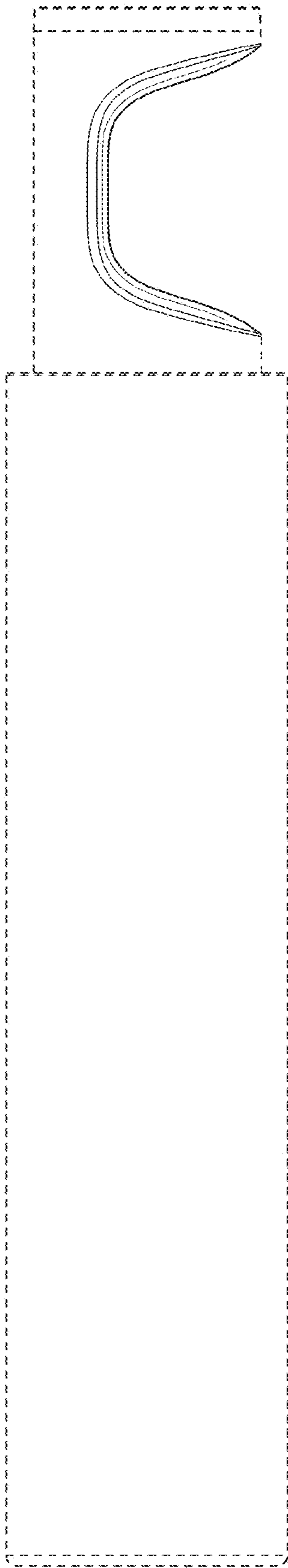

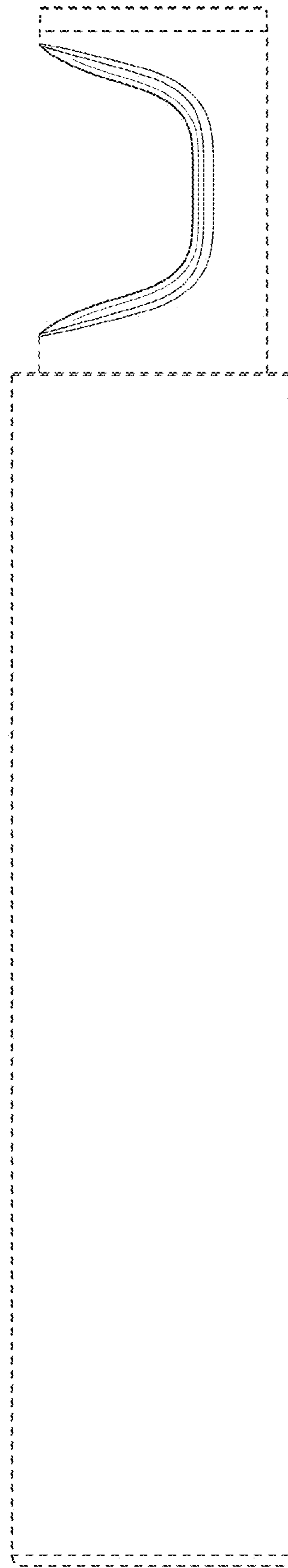

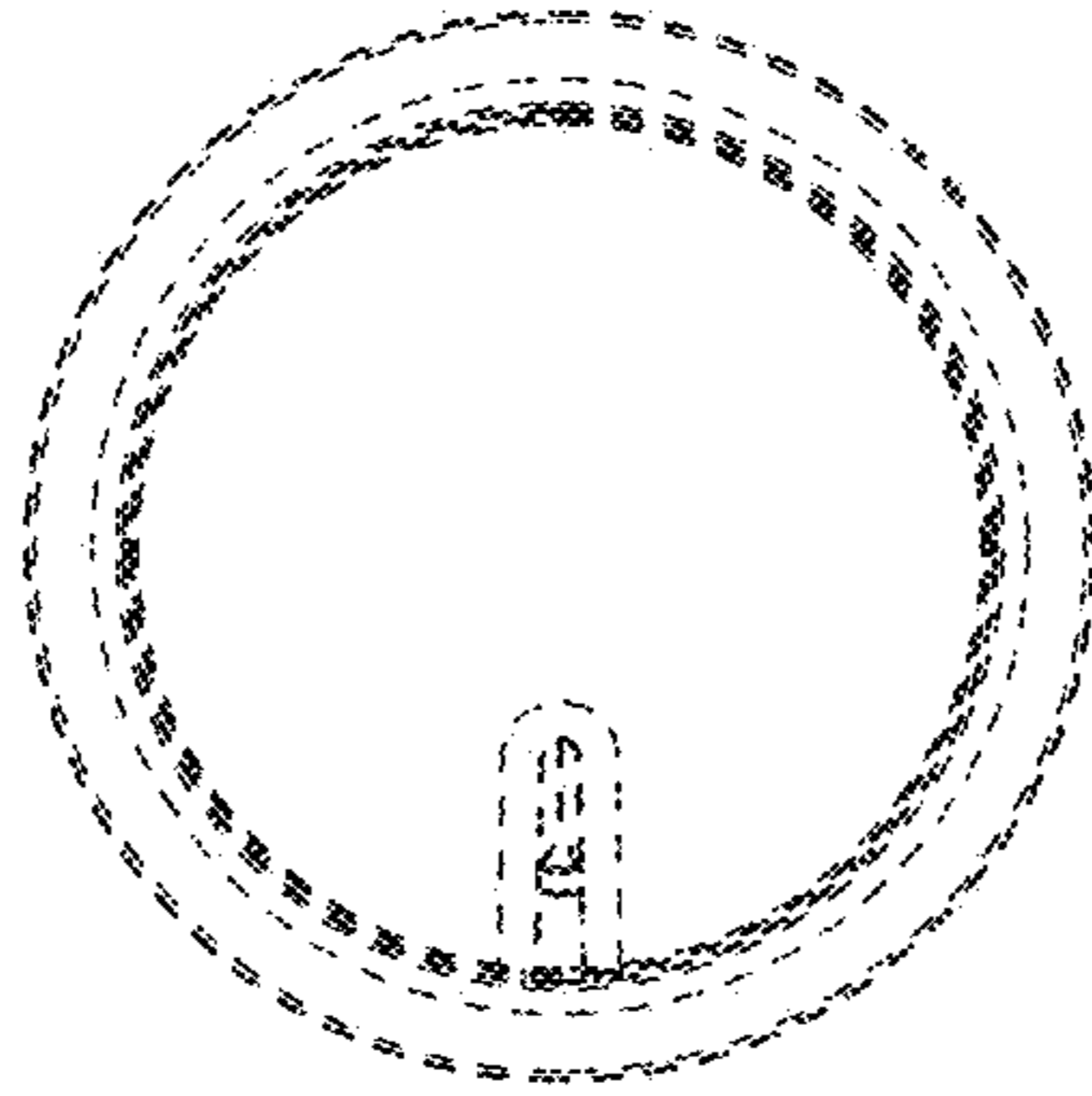

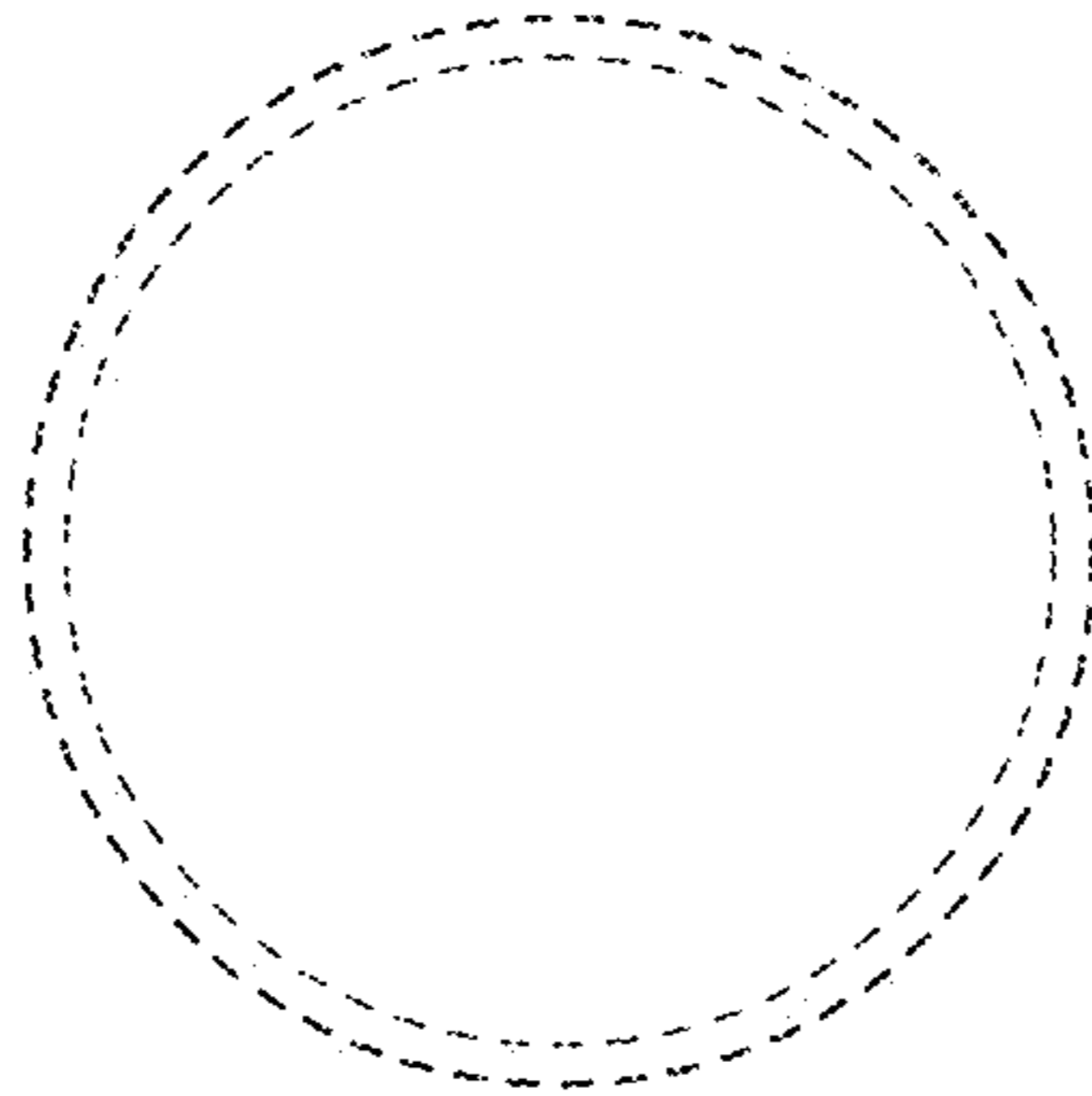
