(57) **CLAIM**

The ornamental design for an ultraviolet sterilizer for chopping board, as shown and described.

FIG. 4 is a left side elevational view thereof;

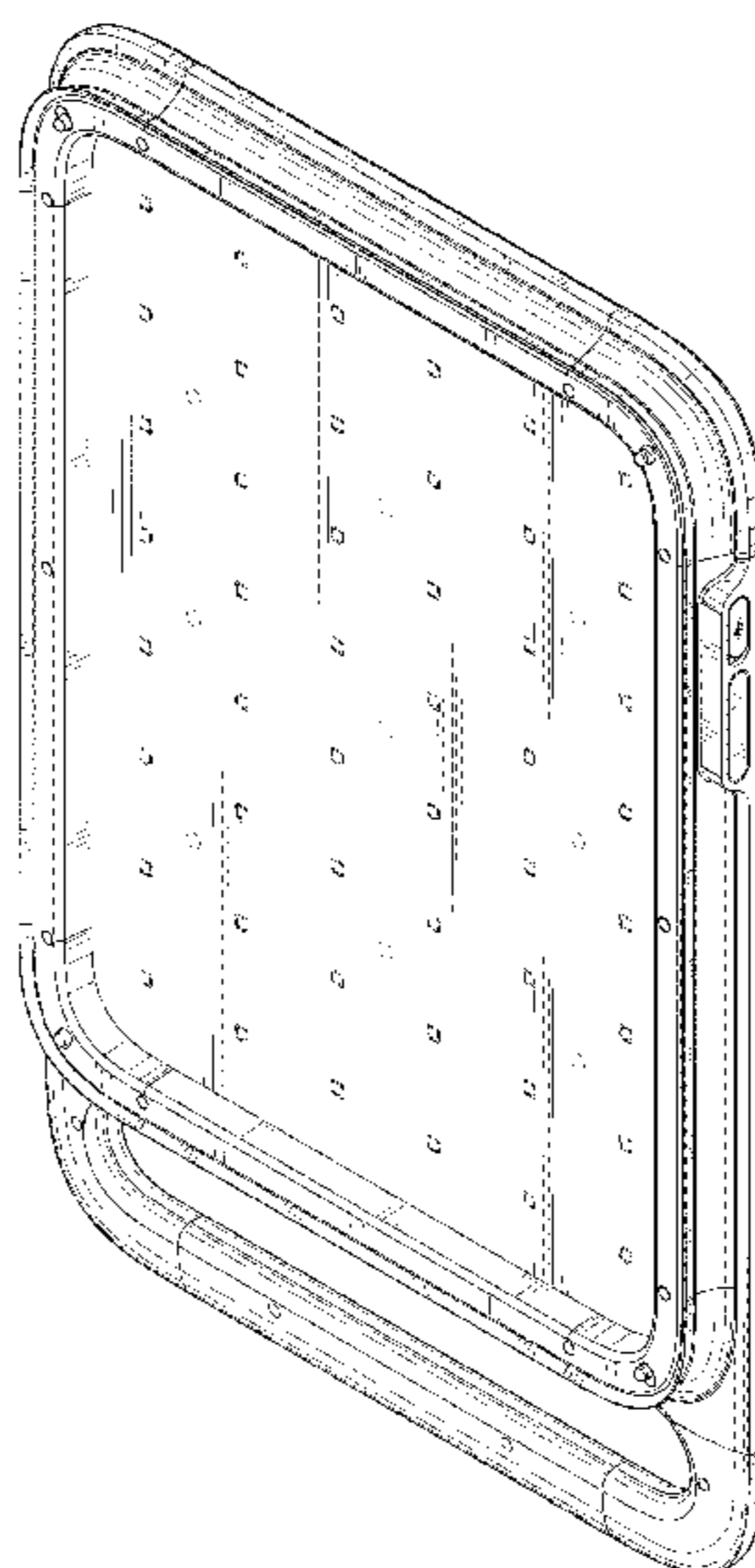
FIG. 5 is a right side elevational view thereof;

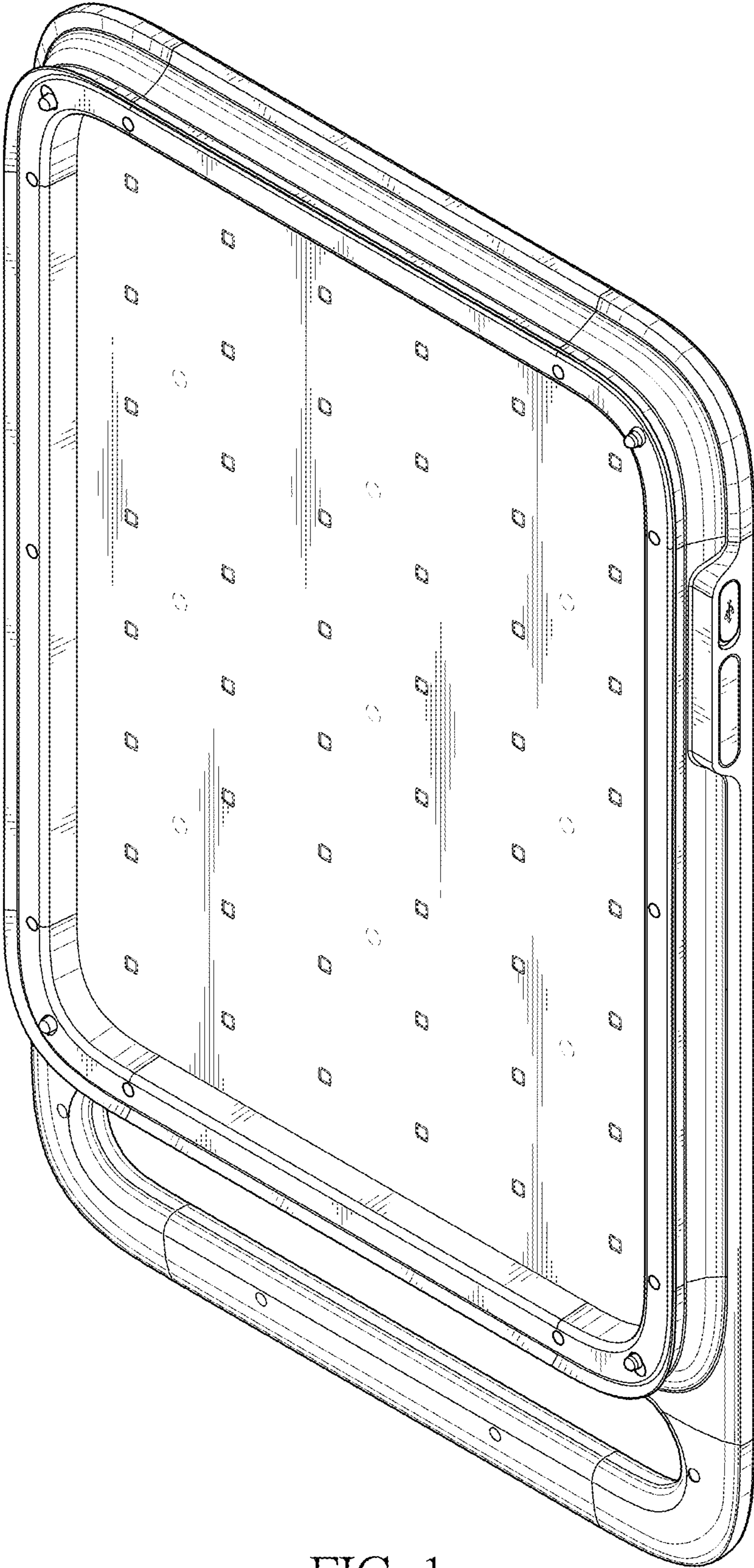

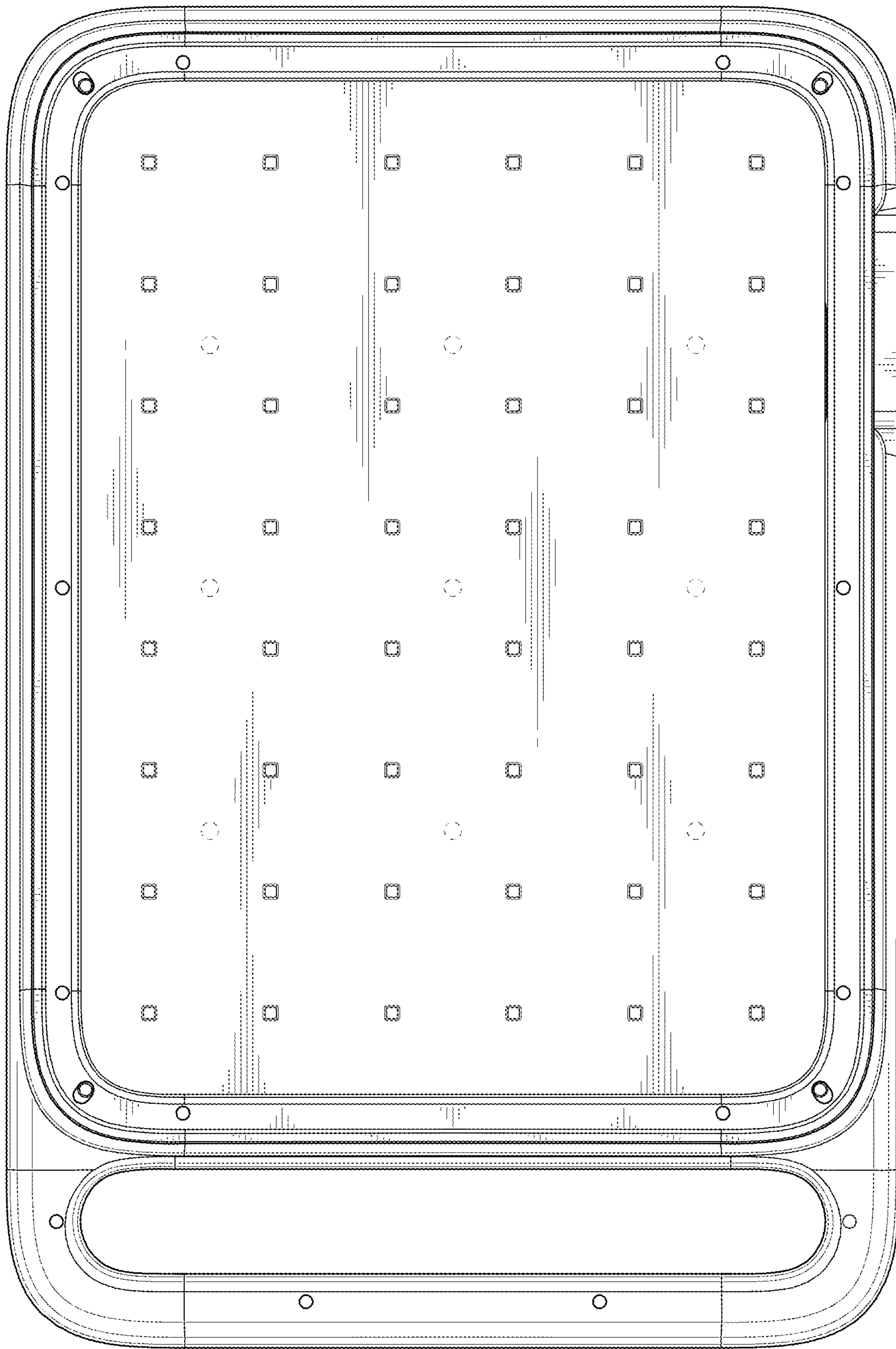

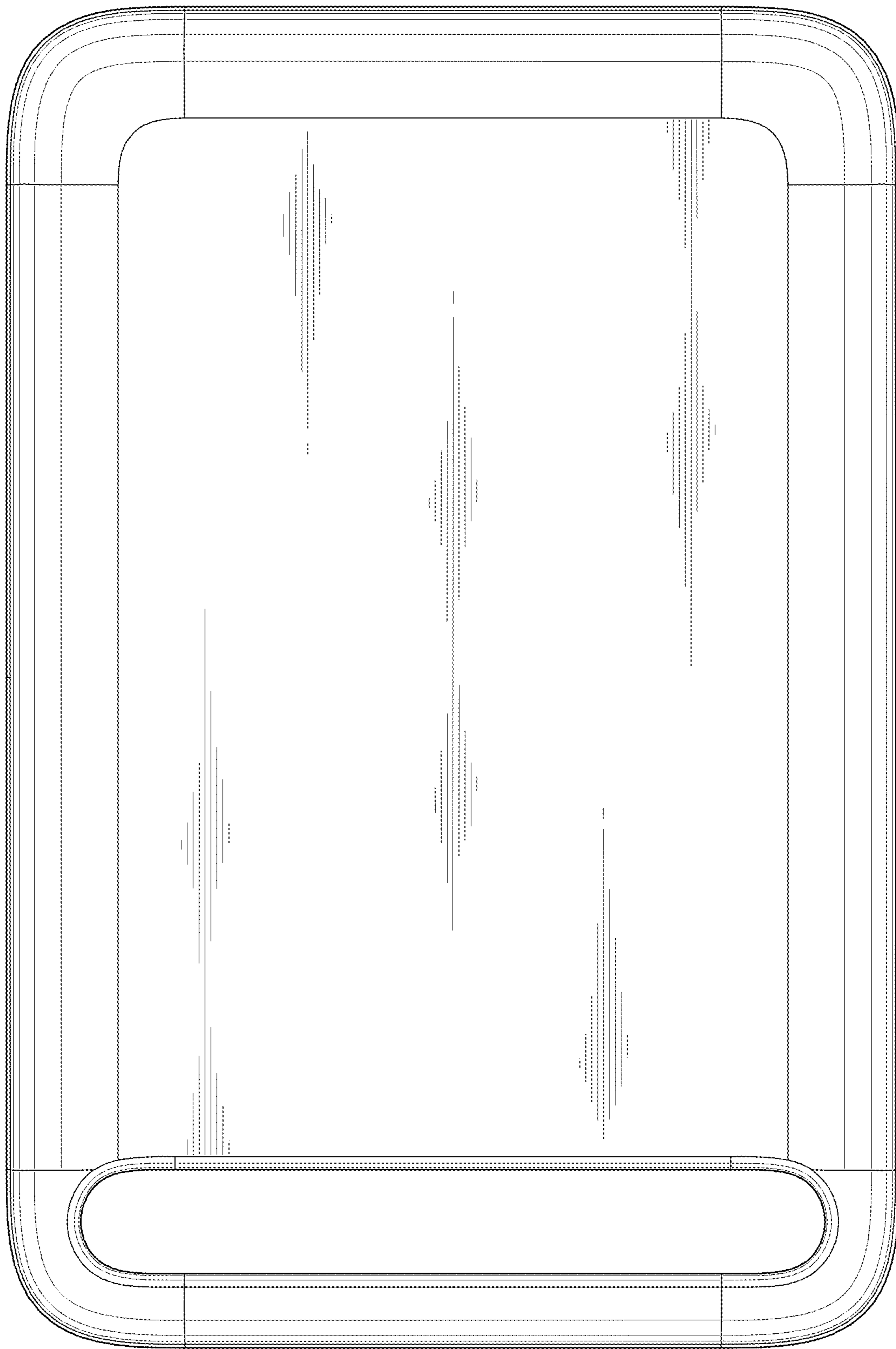

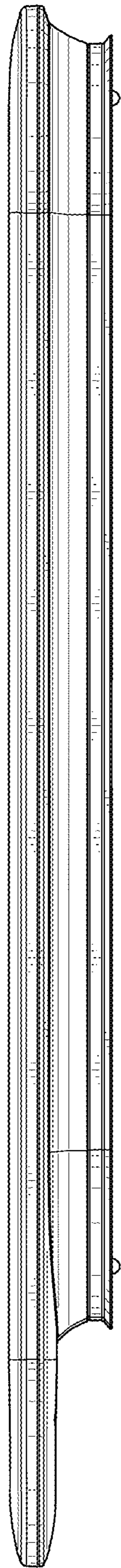

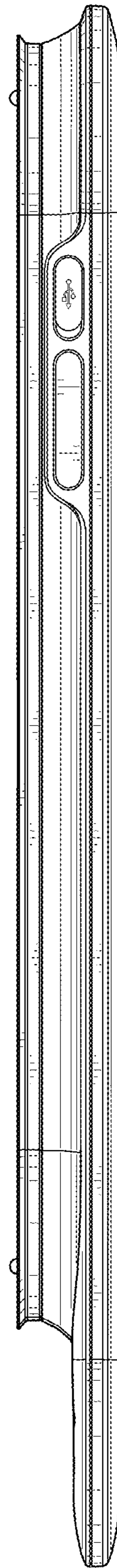

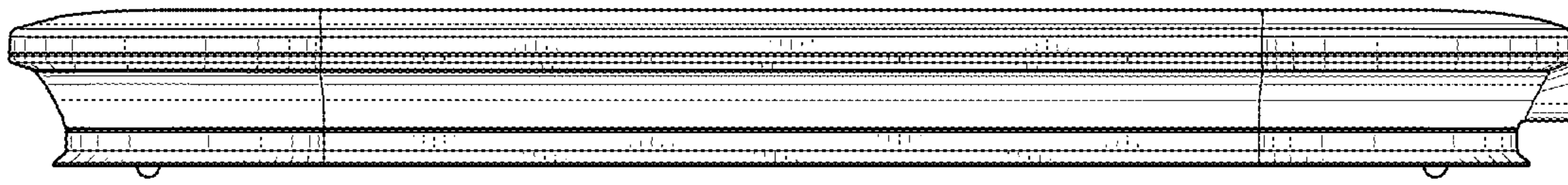

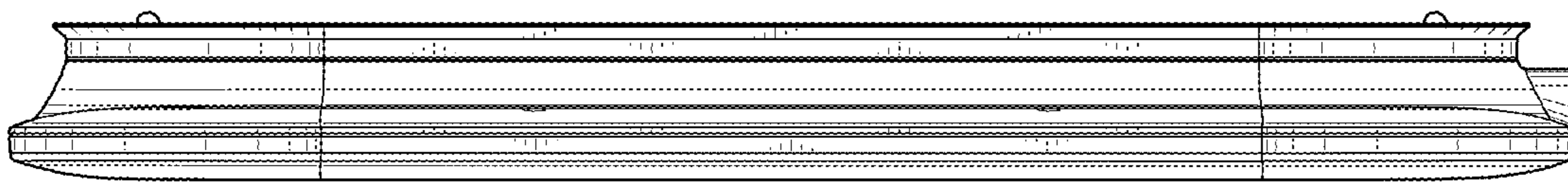
