DESCRIPTION

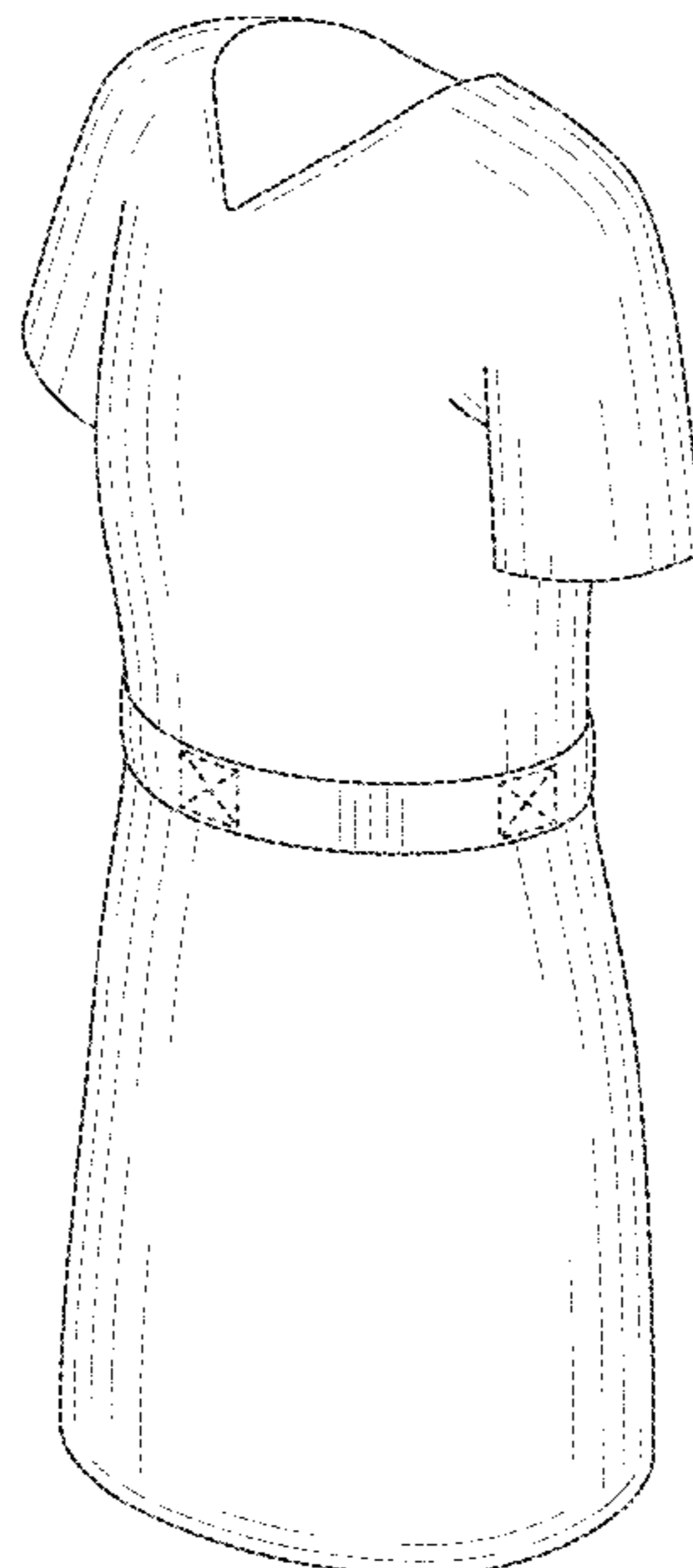
FIG. 1 is perspective view of the garment with an integrated gait belt; and

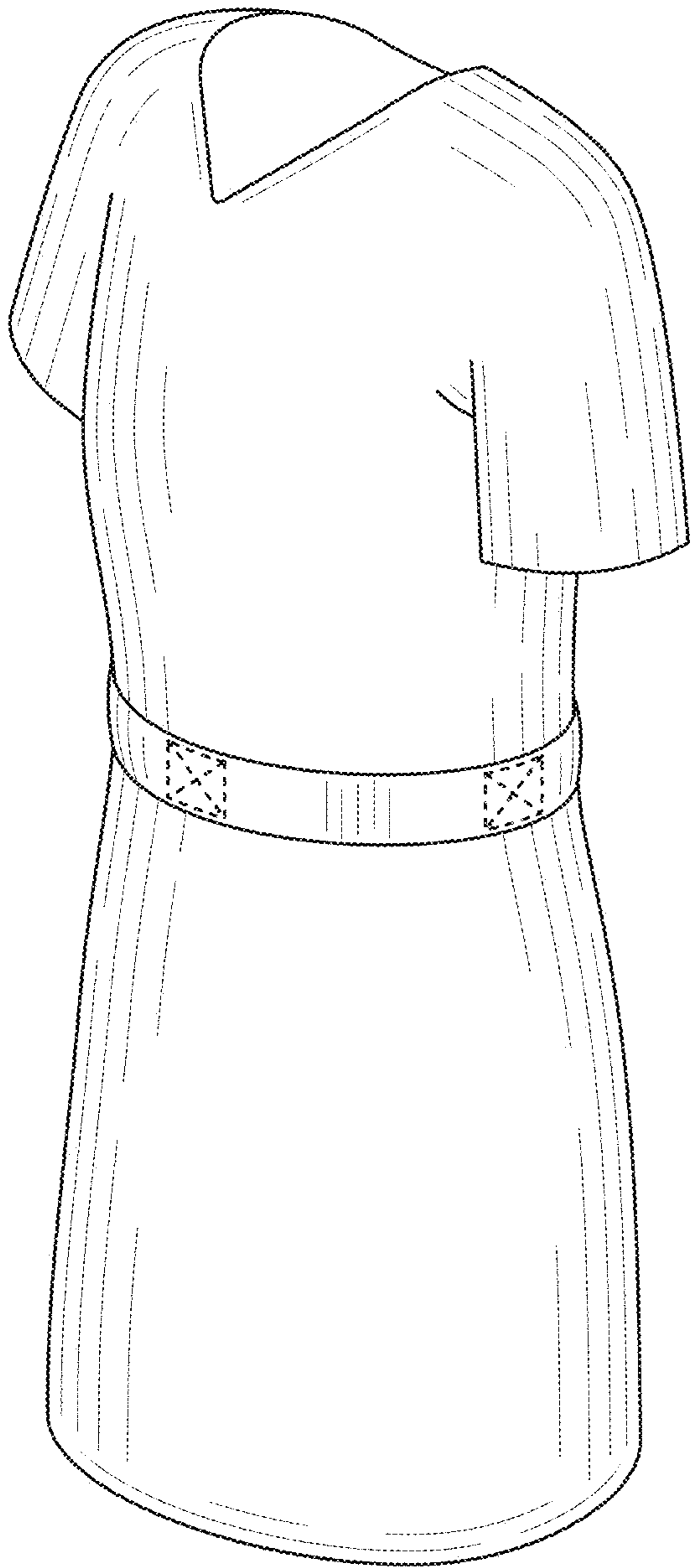

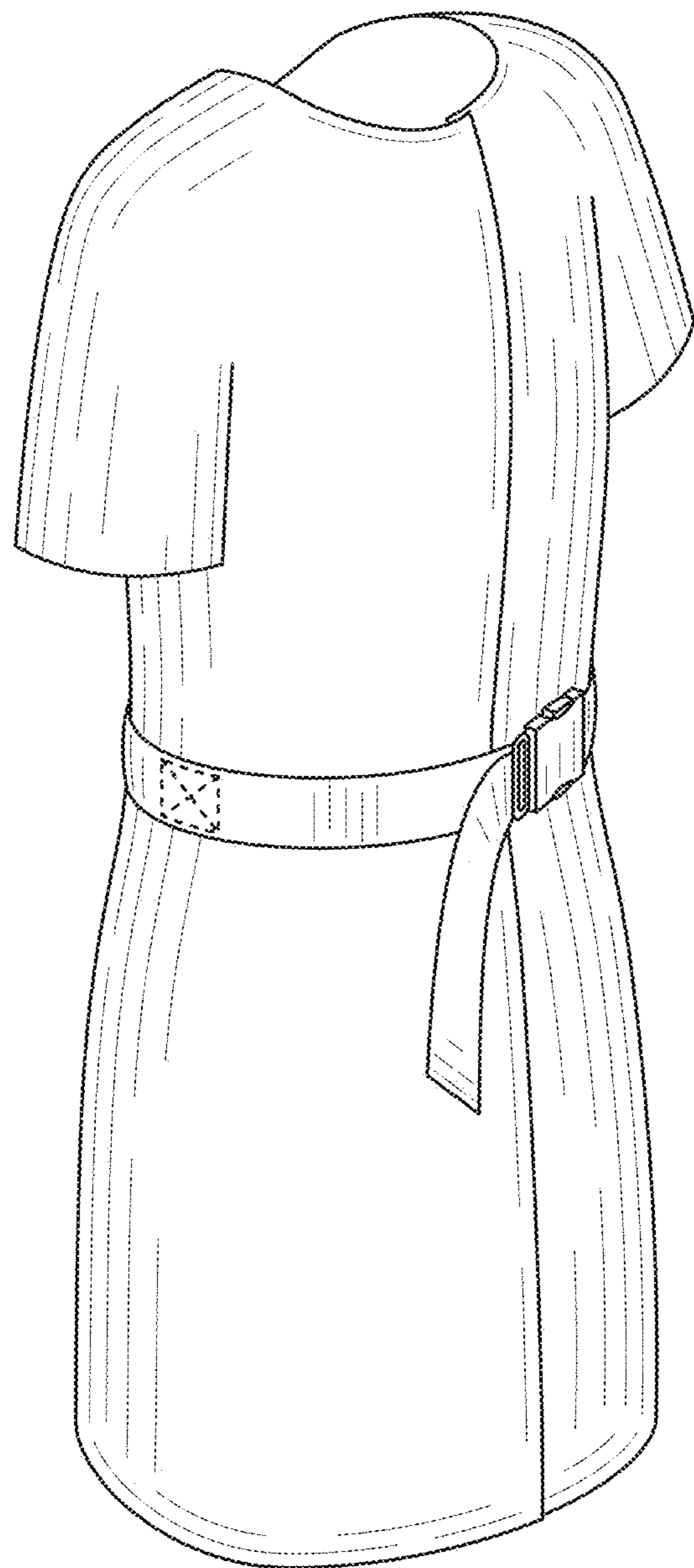

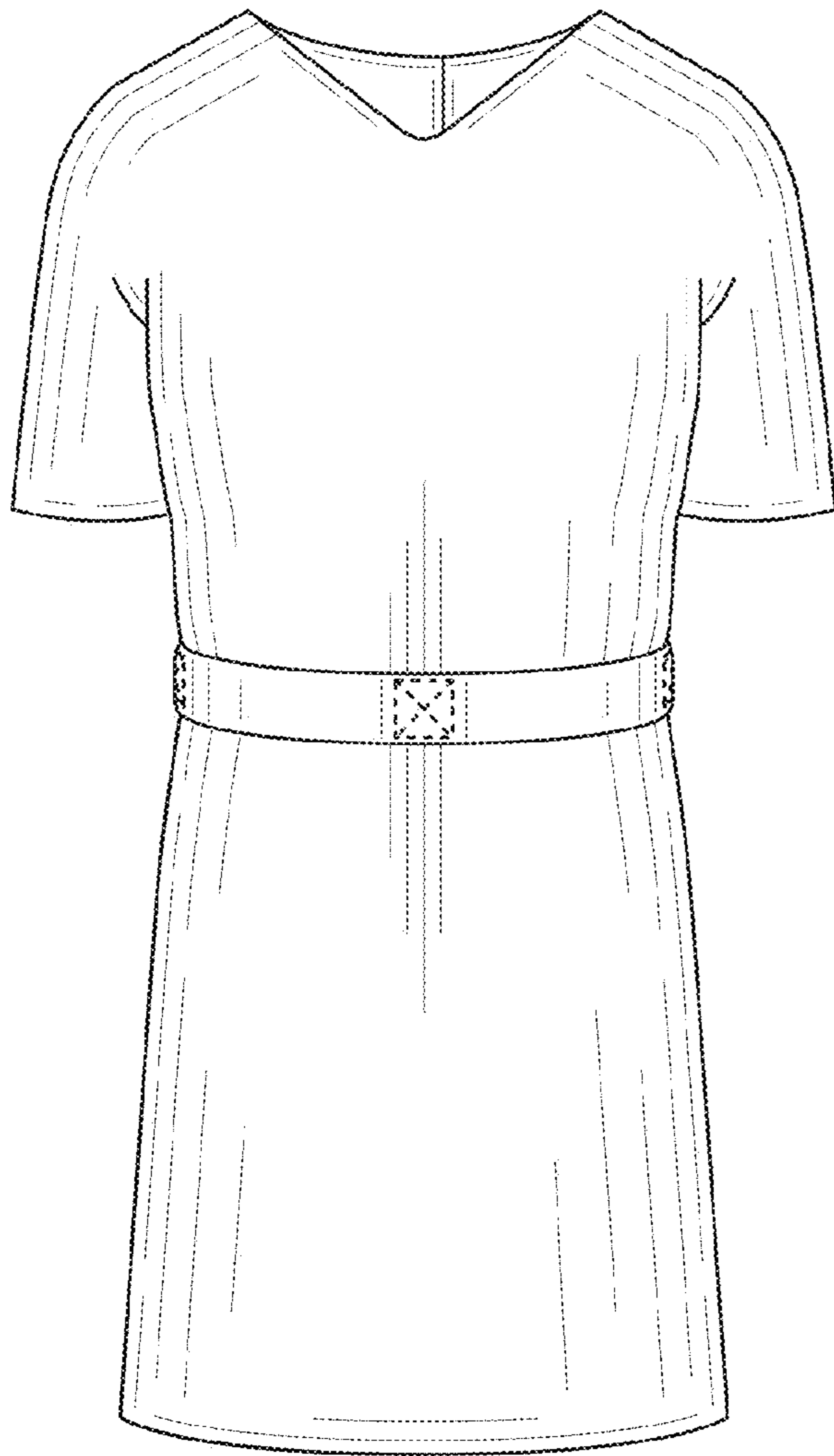

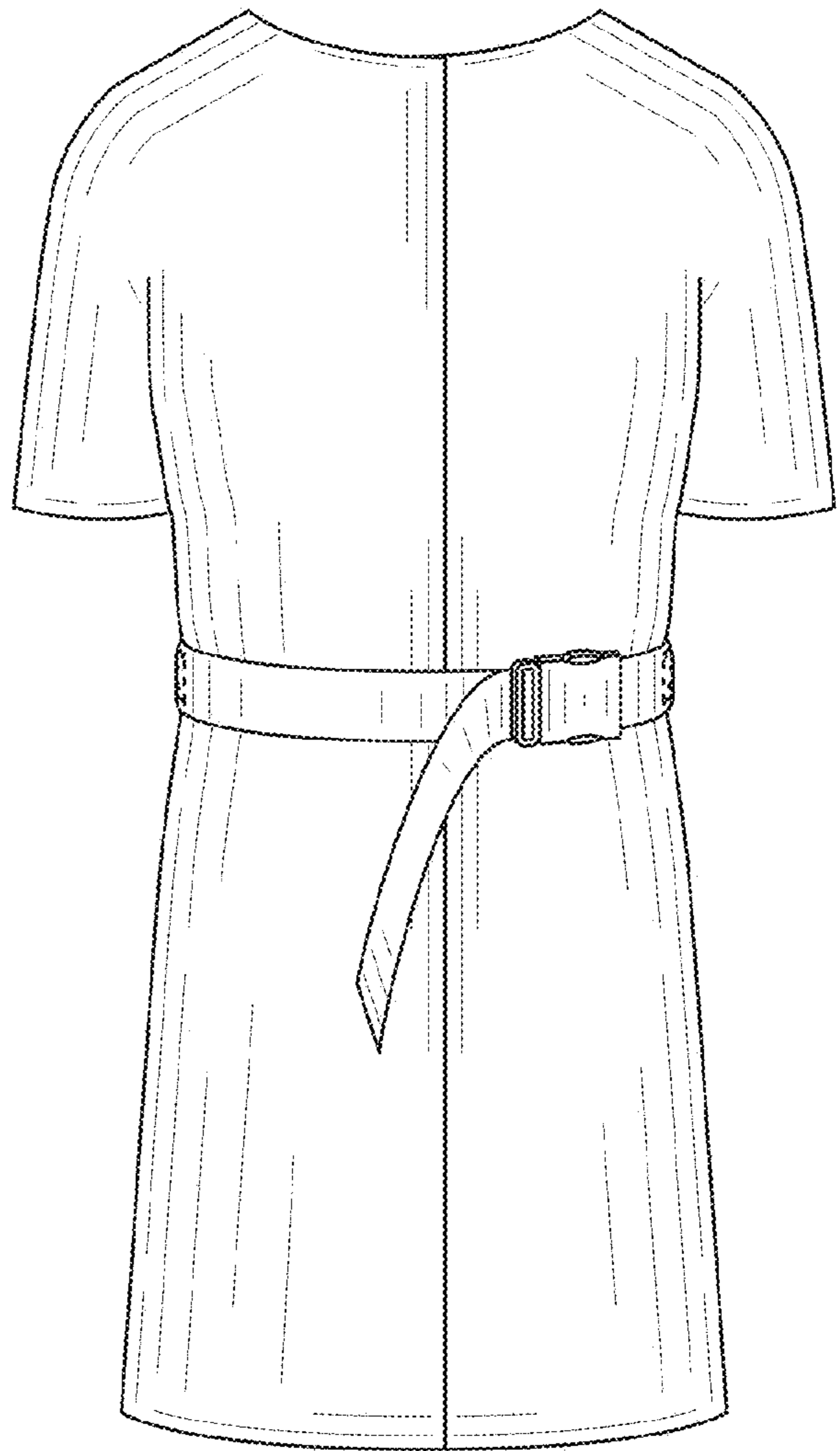

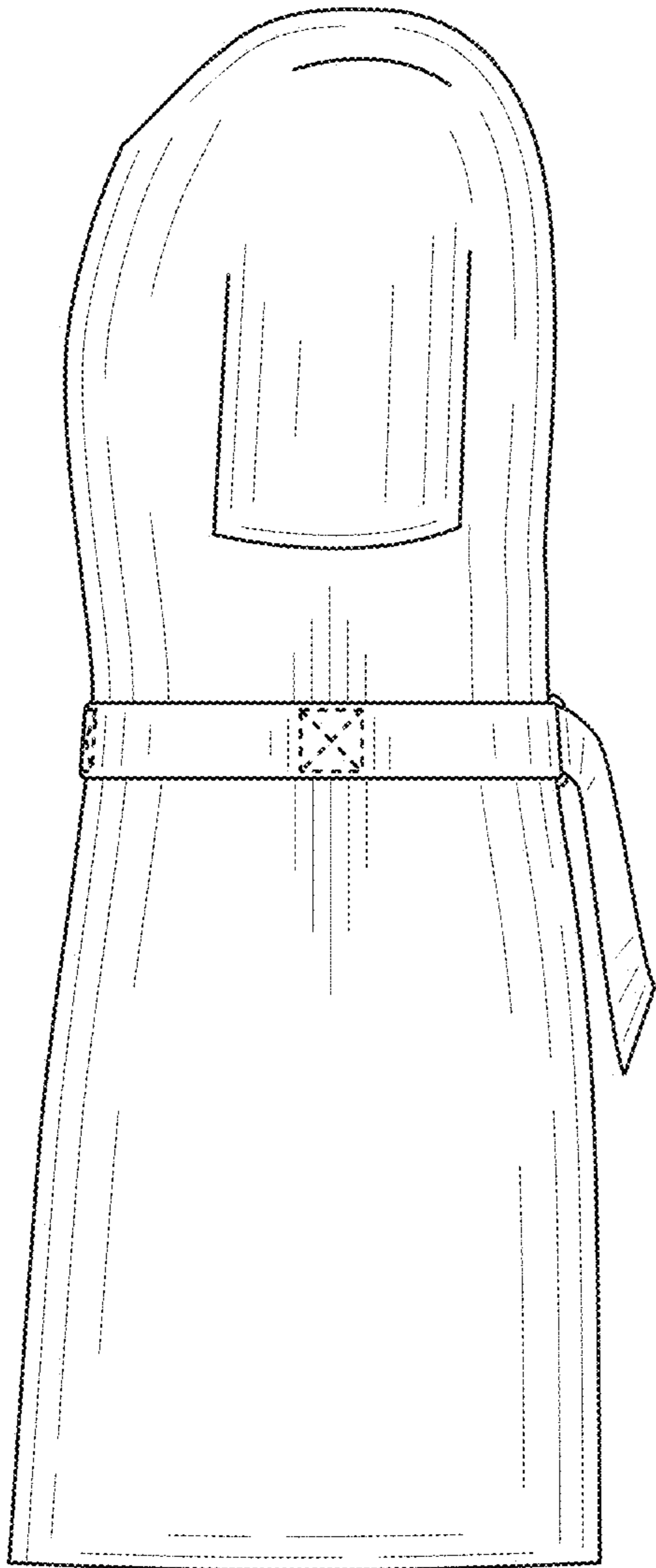

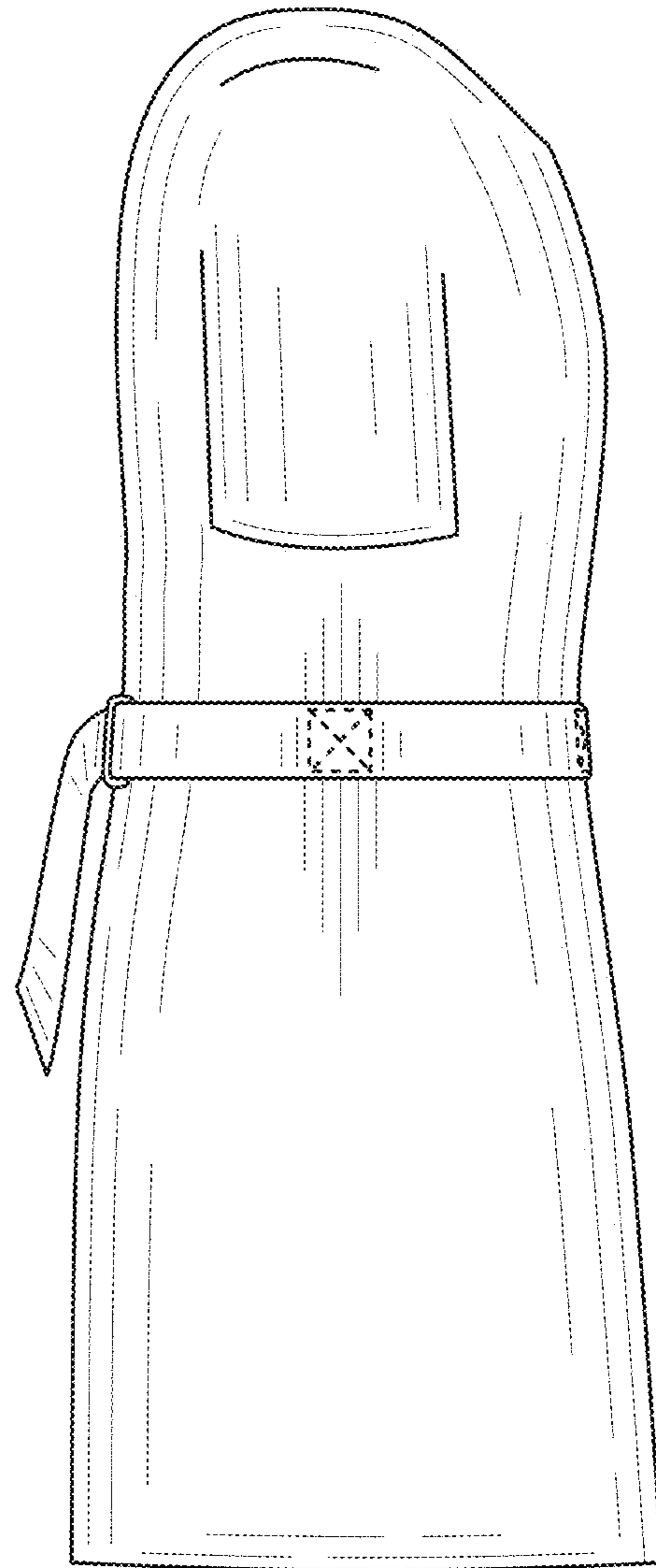

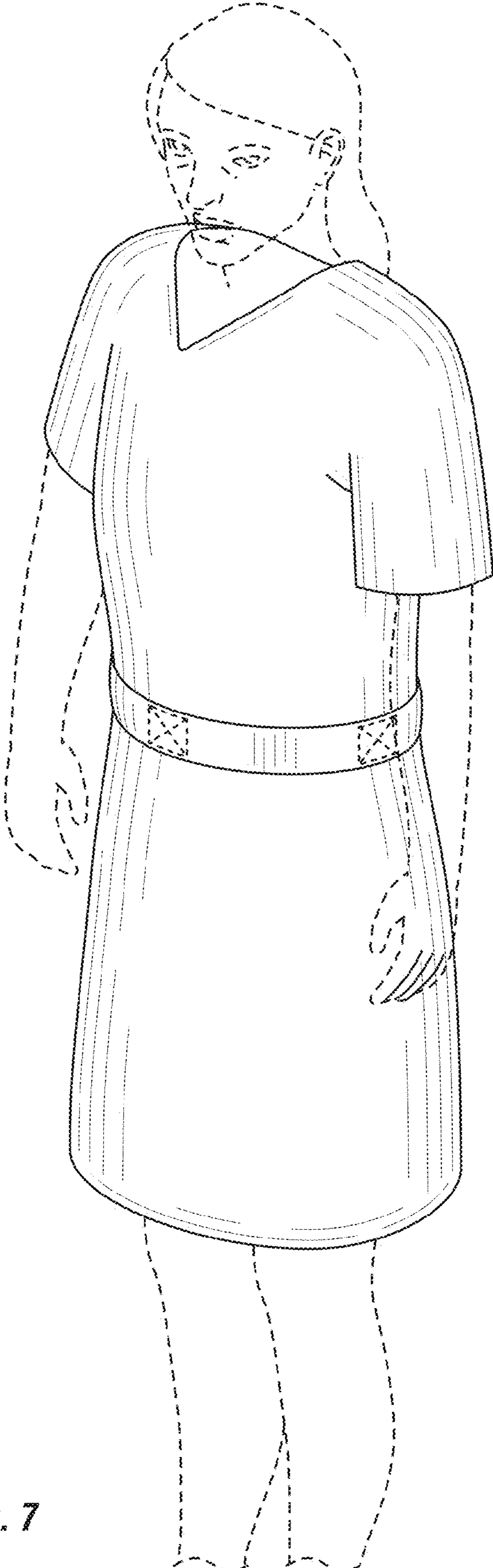
