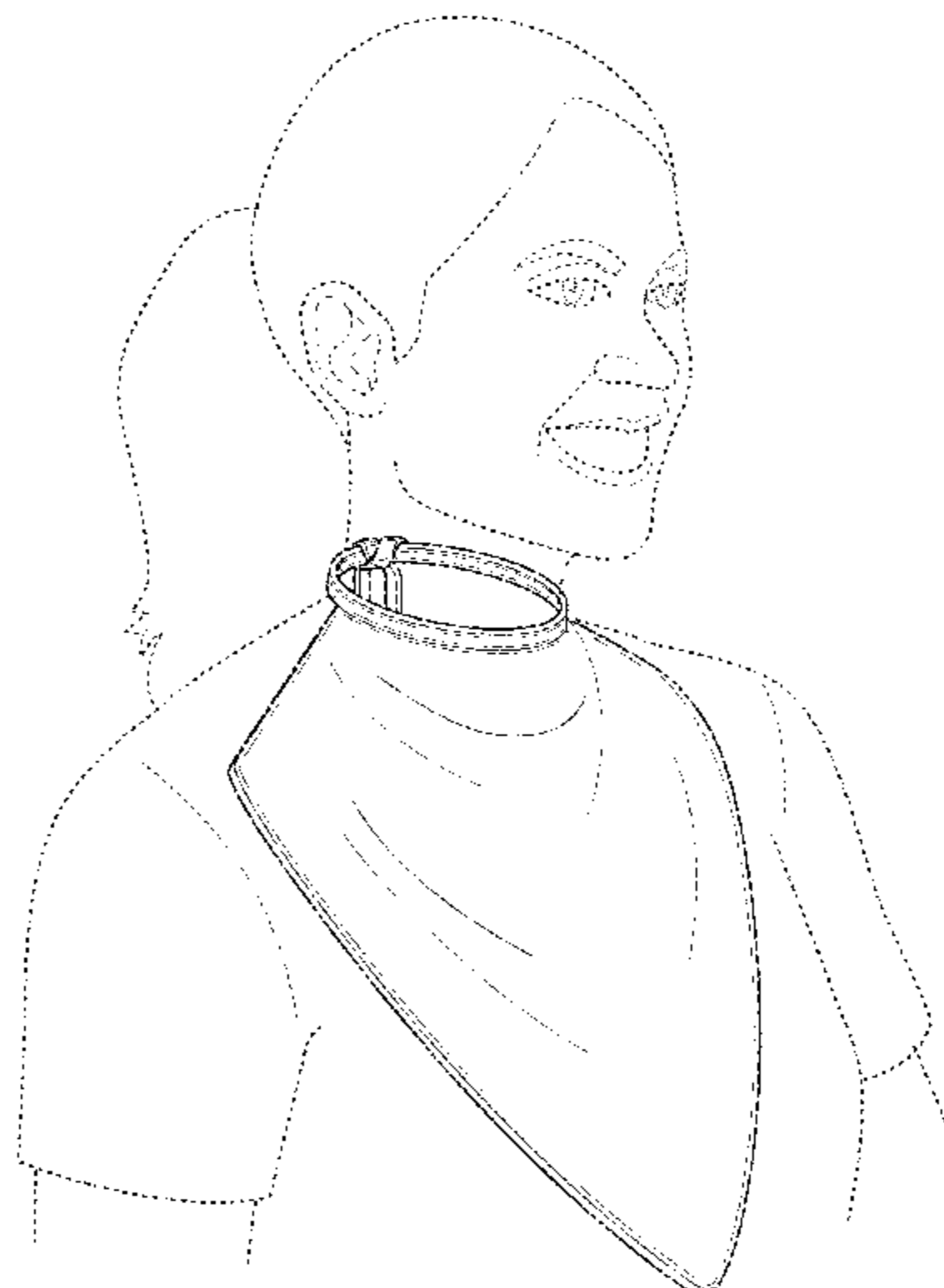
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, right perspective view of the cover-up showing the present design;
FIG. 2 is a front elevation view thereof, shown in an untied configuration;
FIG. 3 is a front elevation view thereof, shown in a tied configuration;
FIG. 4 is a back elevation view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a right side elevation view thereof; and,
FIG. 8 is a left side elevation view thereof.
The broken lines shown in FIG. 1 illustrate environment and form no part of the claimed design.

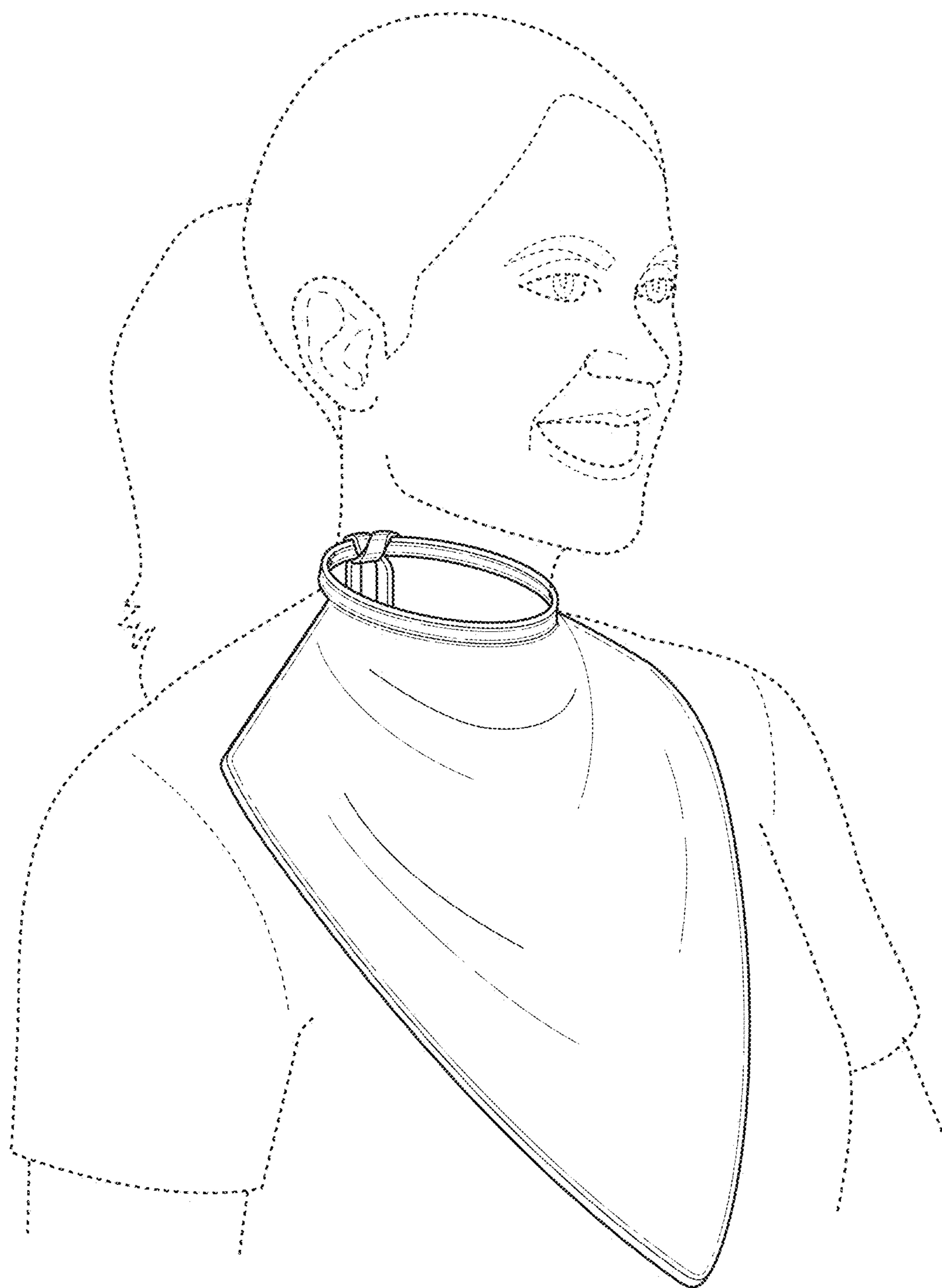

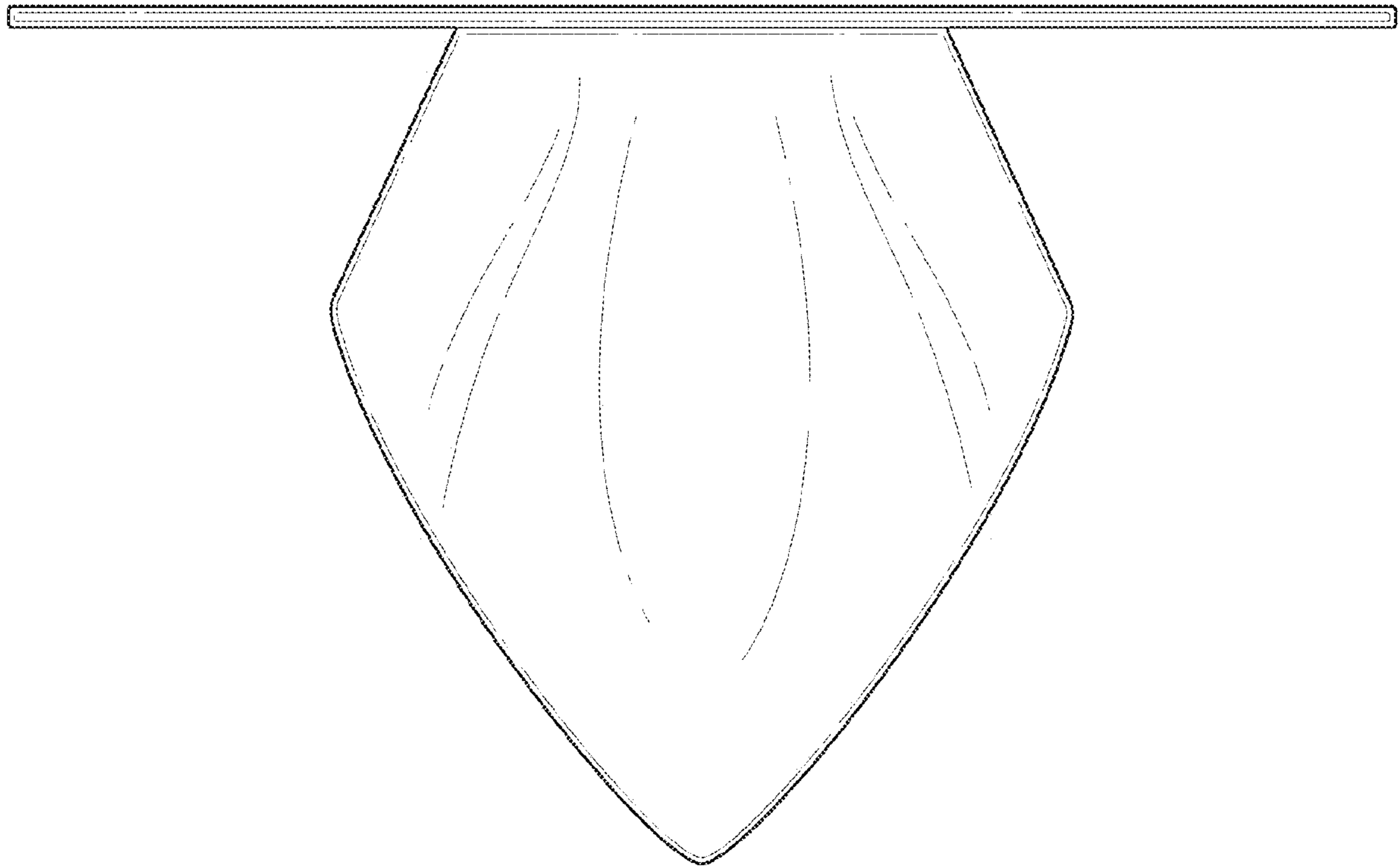

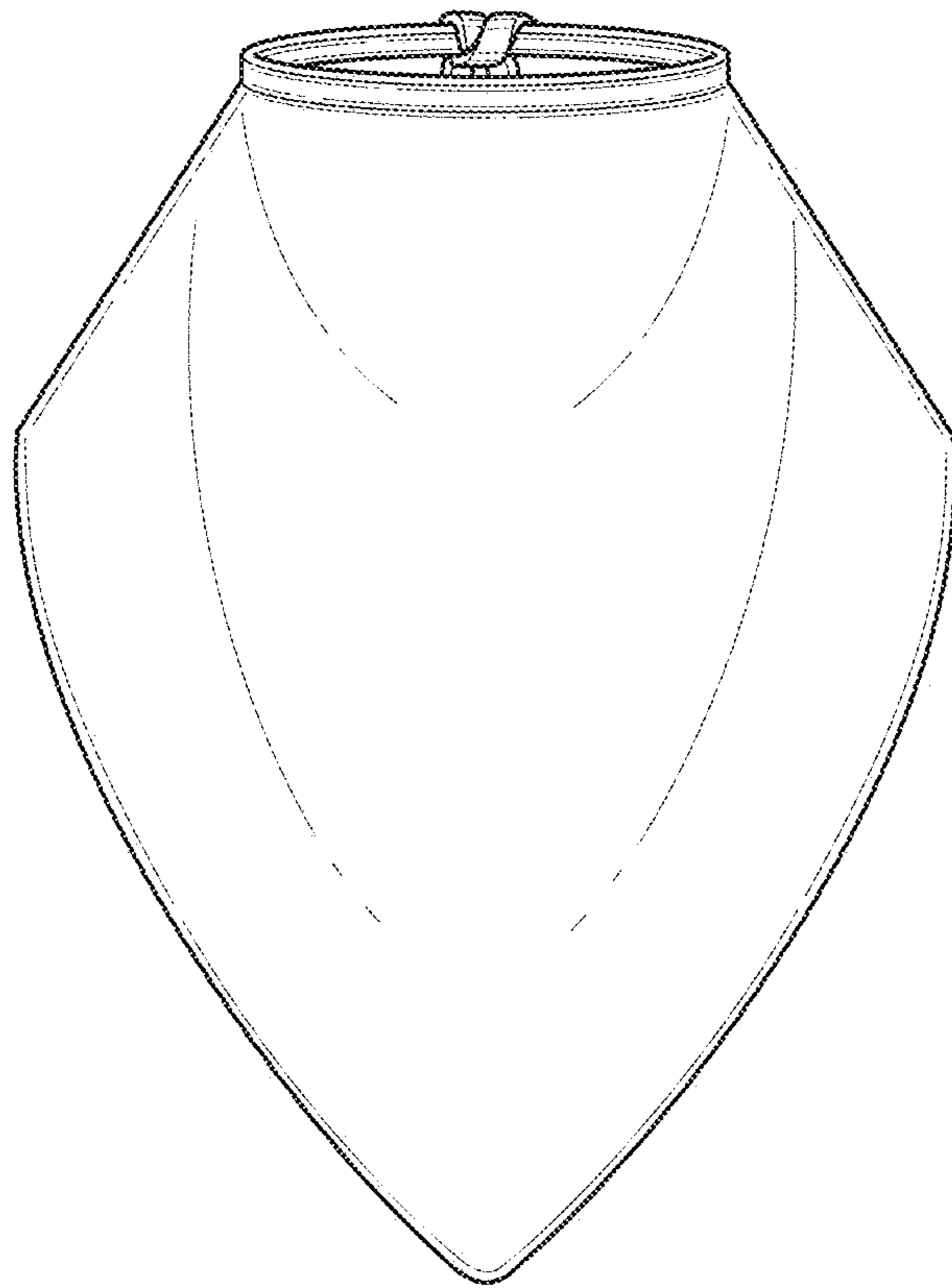

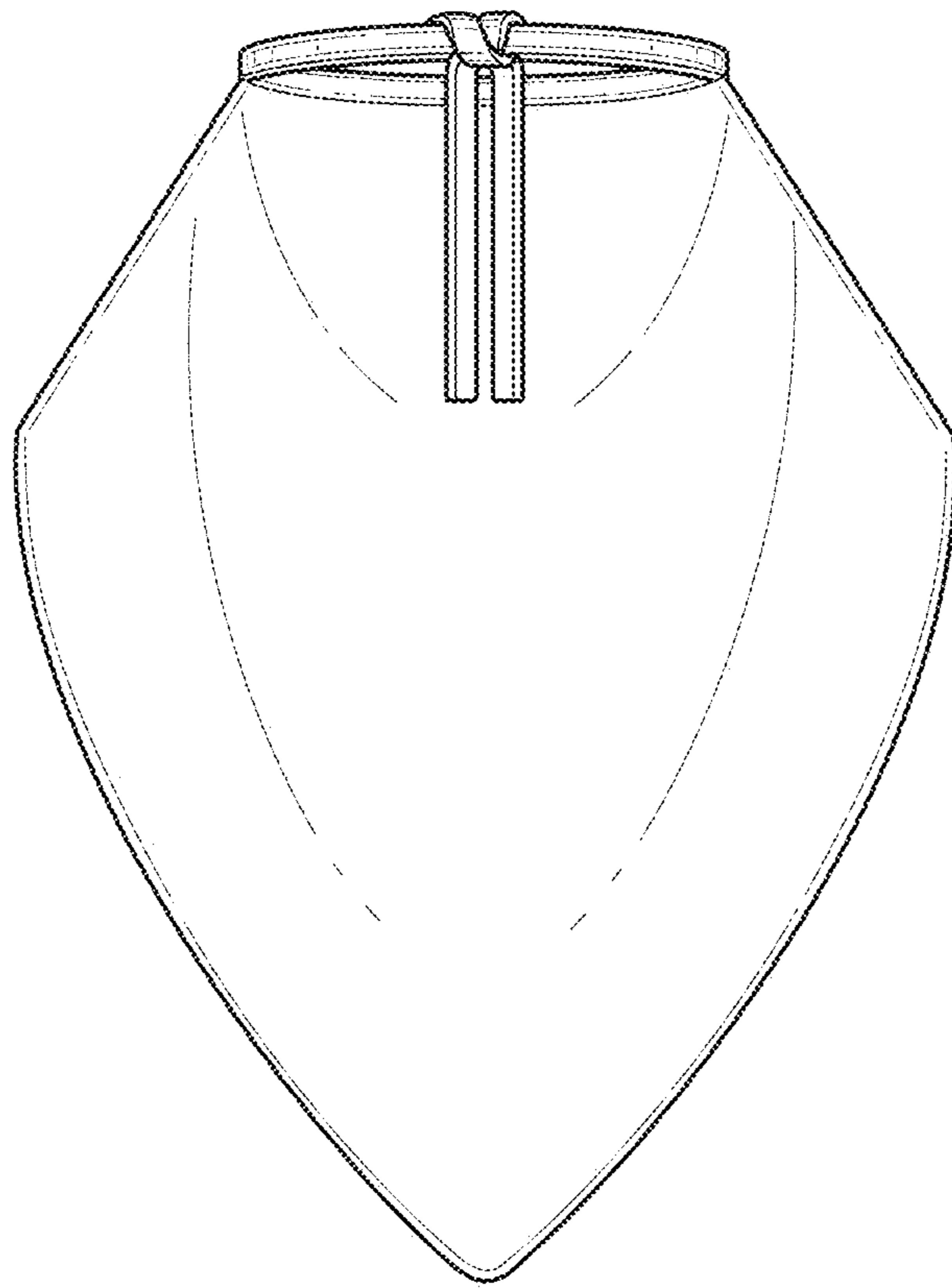

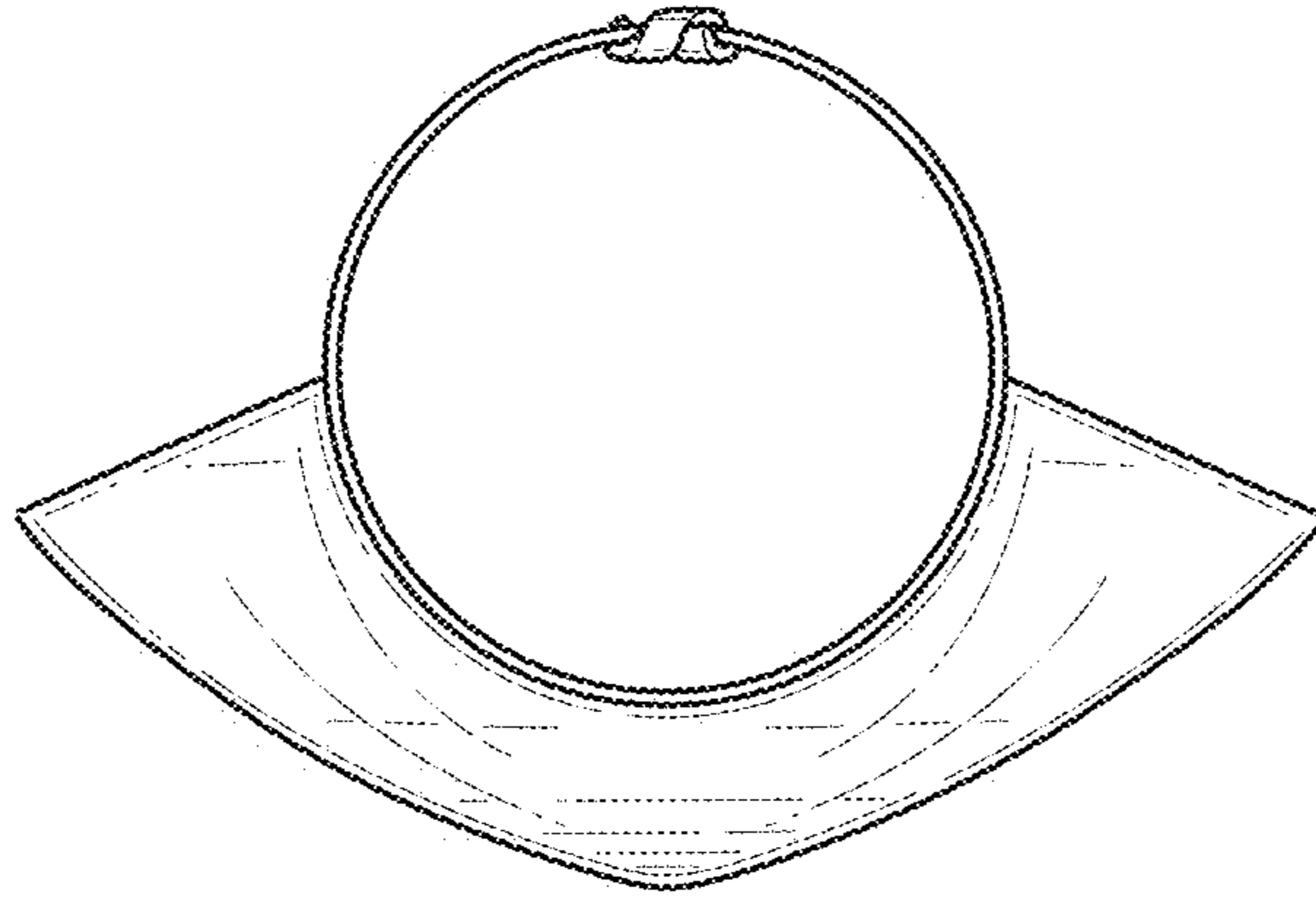

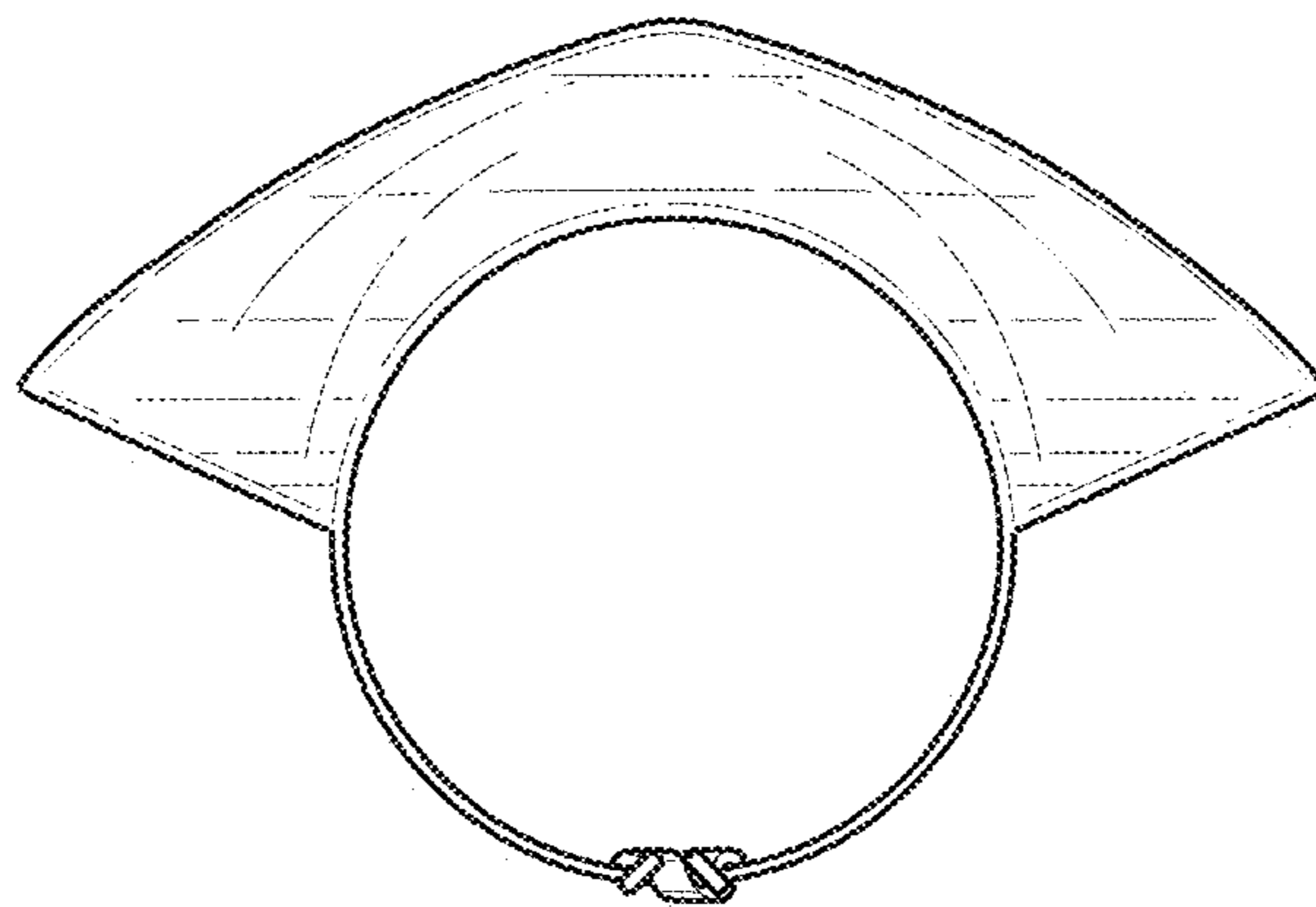

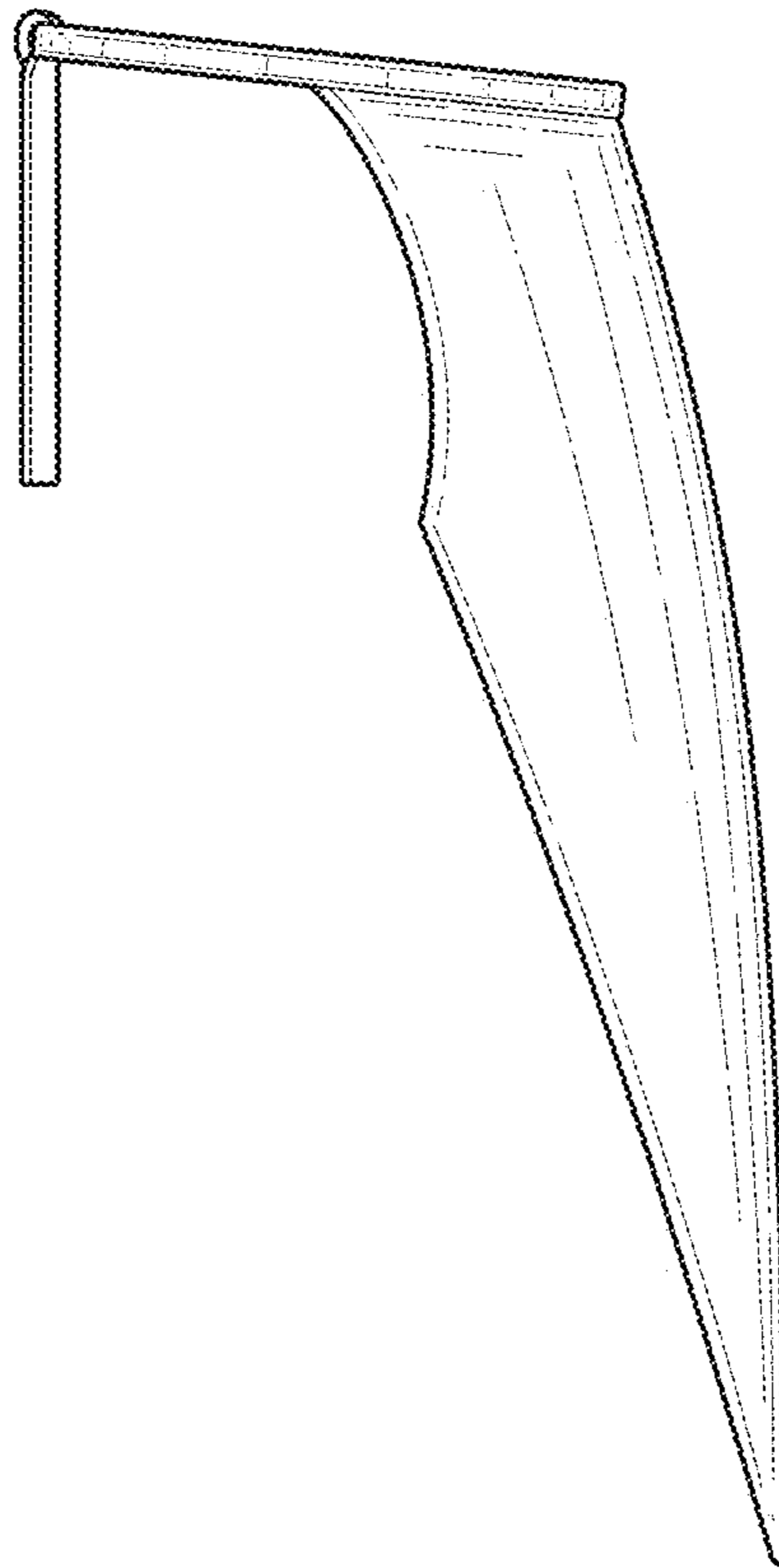

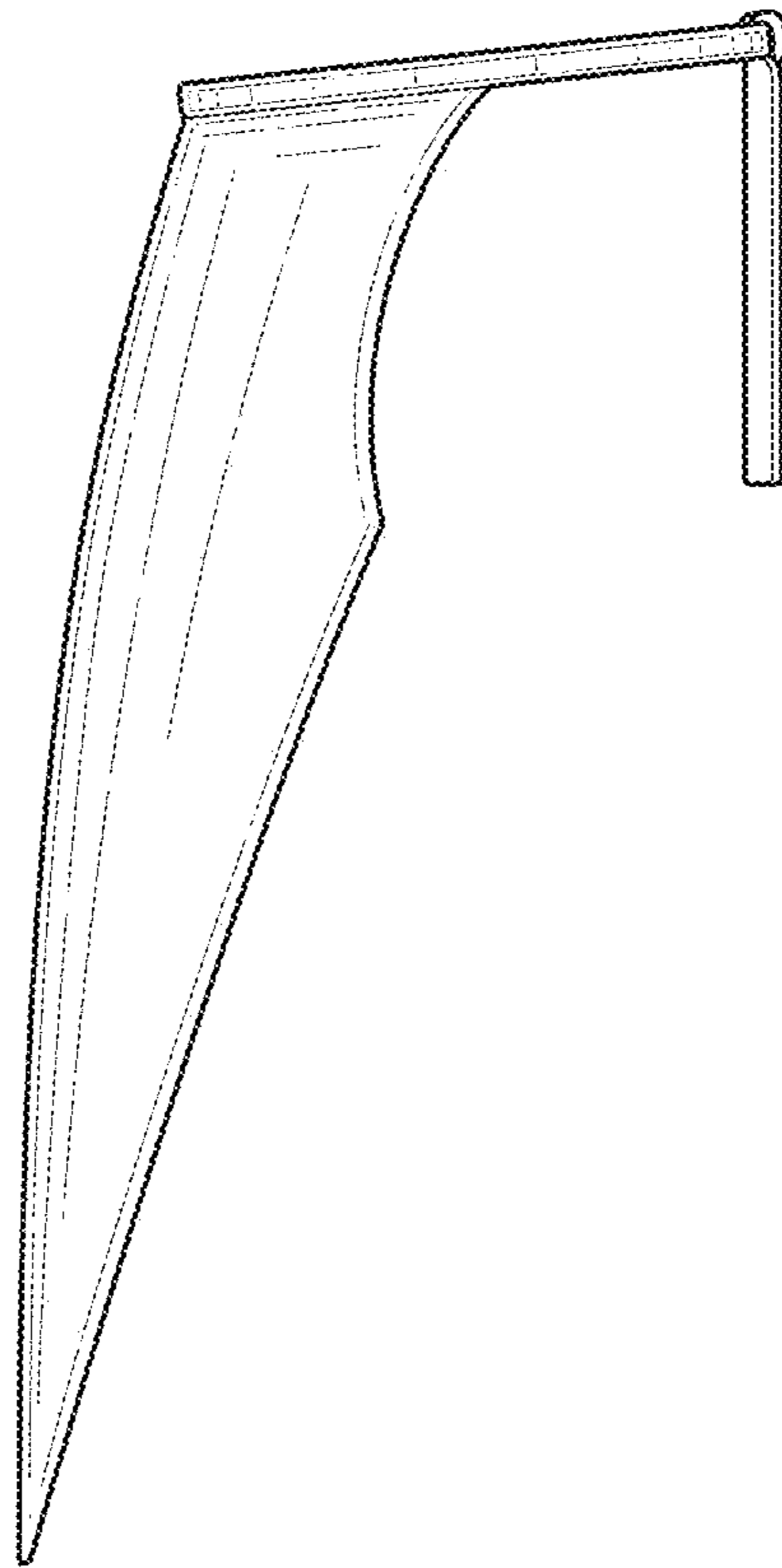
