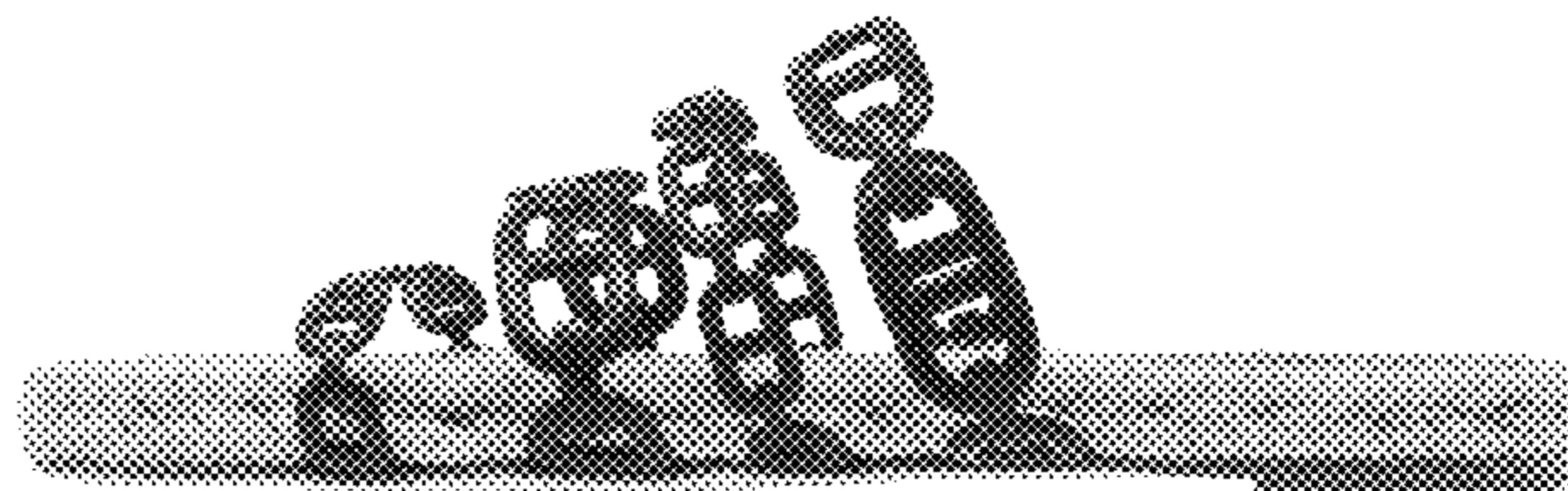
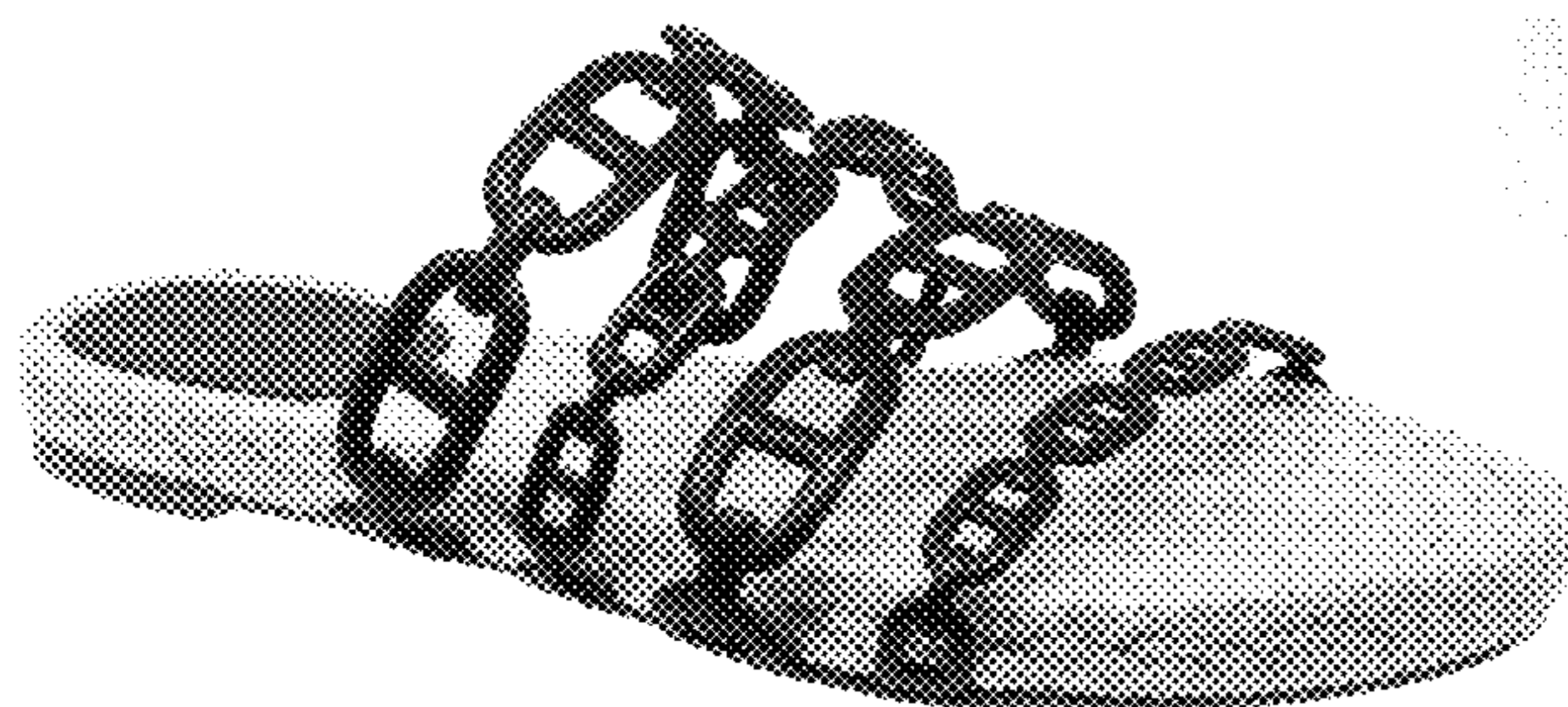
(57) **CLAIM**

The ornamental design for a sandal, as shown and described.

DESCRIPTION

1. Sandal
FIG. 1.1 is a perspective view of a sandal of the claimed design;
FIG. 1.2 is a front elevational view of the sandal shown in FIG. 1.1;
FIG. 1.3 is a back elevational view of the sandal shown in FIG. 1.1;
FIG. 1.4 is a right side elevational view of the sandal shown in FIG. 1.1;
FIG. 1.5 is a left side elevational view of the sandal shown in FIG. 1.1;
FIG. 1.6 is a top plan view of the sandal shown in FIG. 1.1; and
FIG. 1.7 is a bottom plan view of the sandal shown in FIG. 1.1.
The second embodiment of a sandal is a left sandal and is a mirror image of the right sandal.

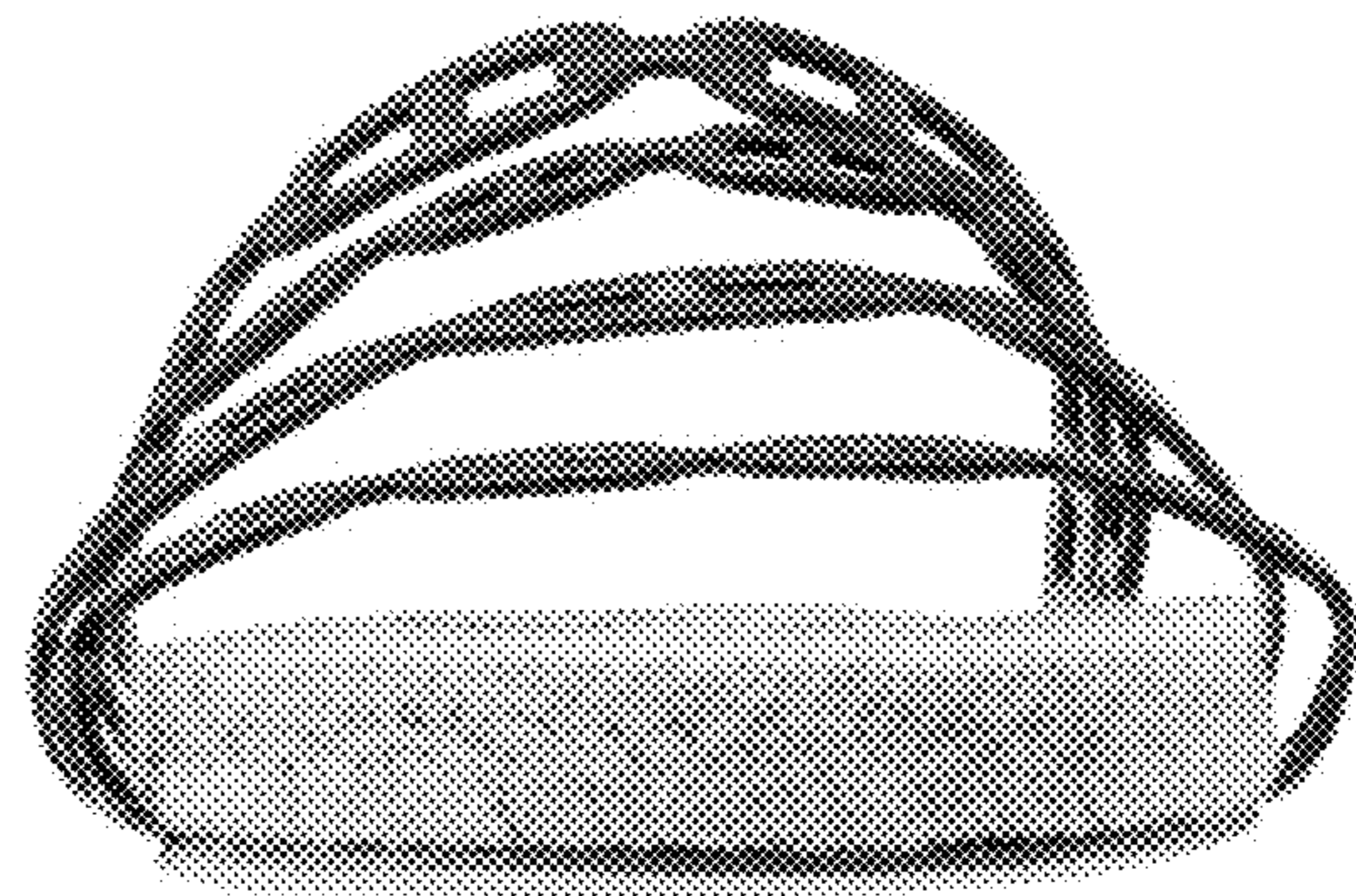

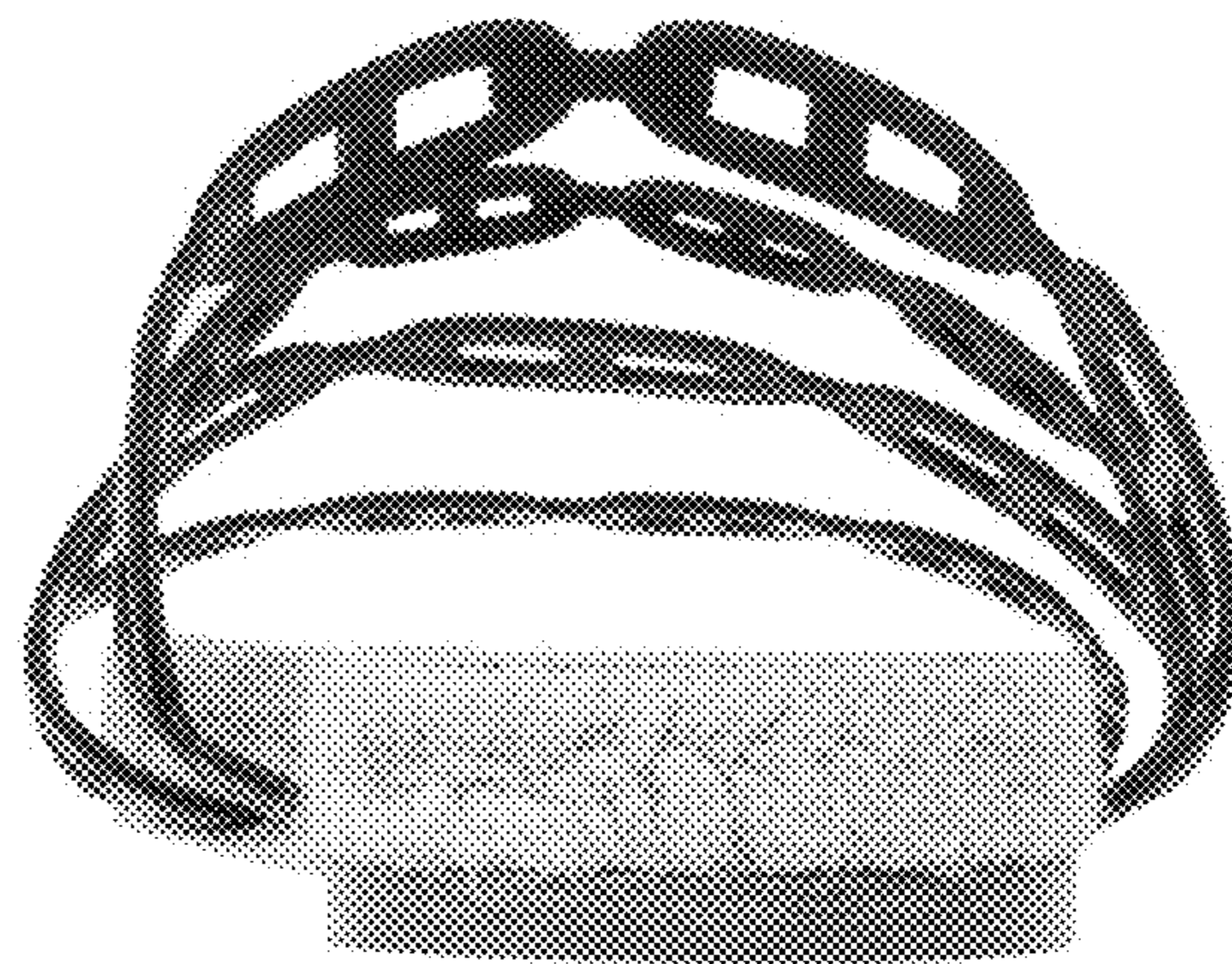

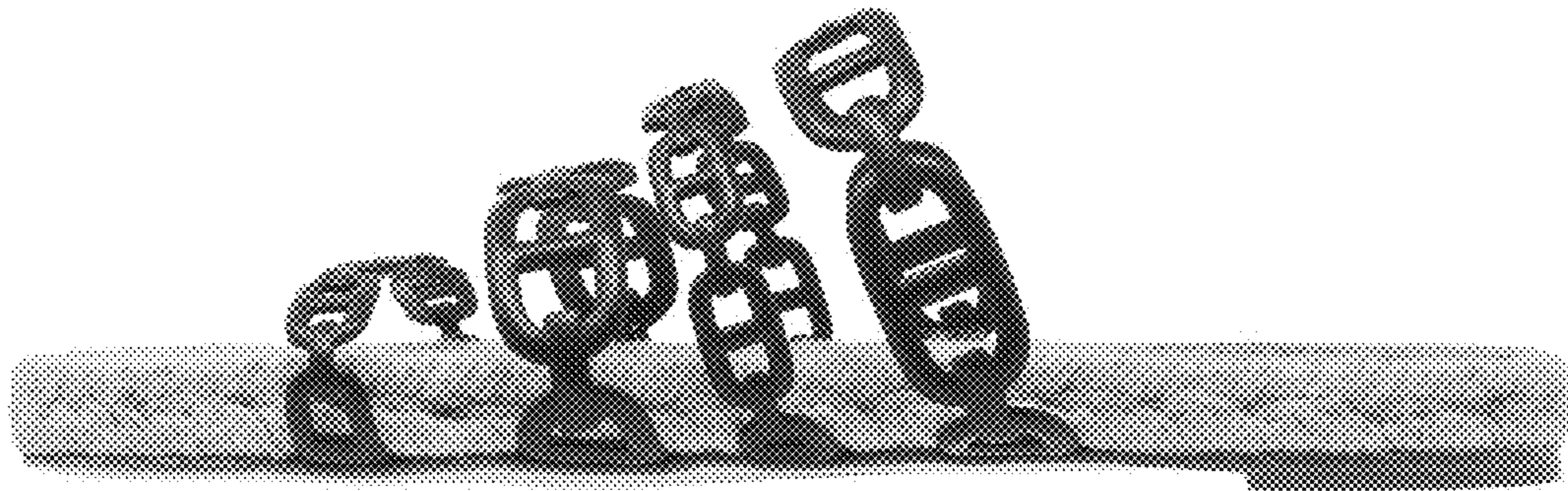

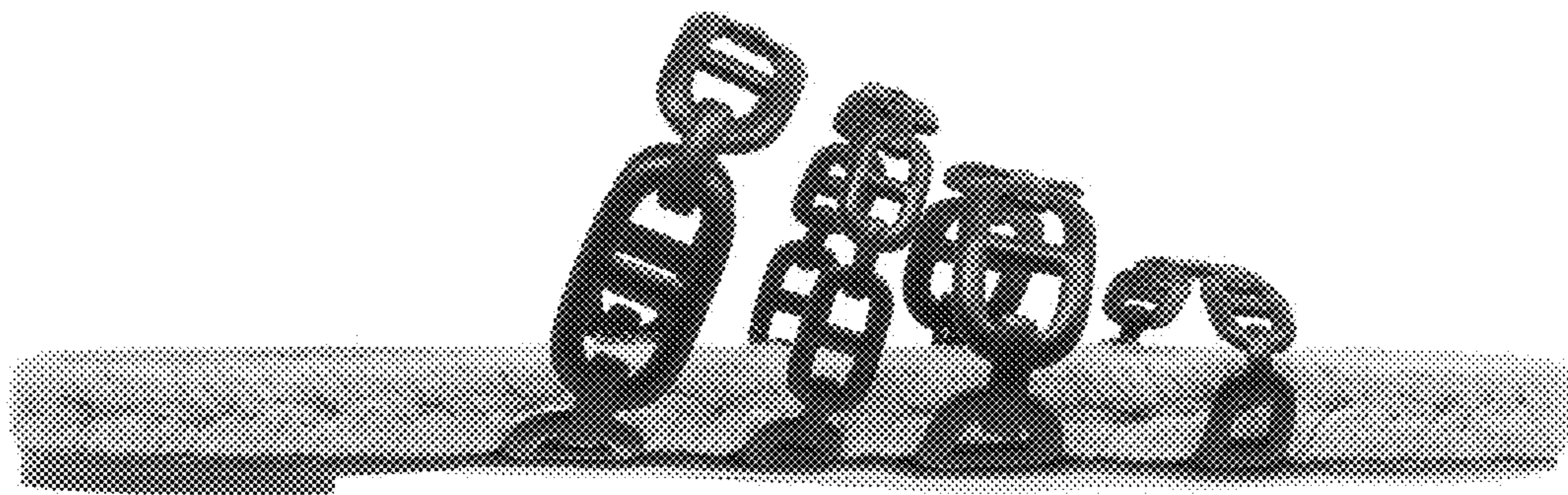

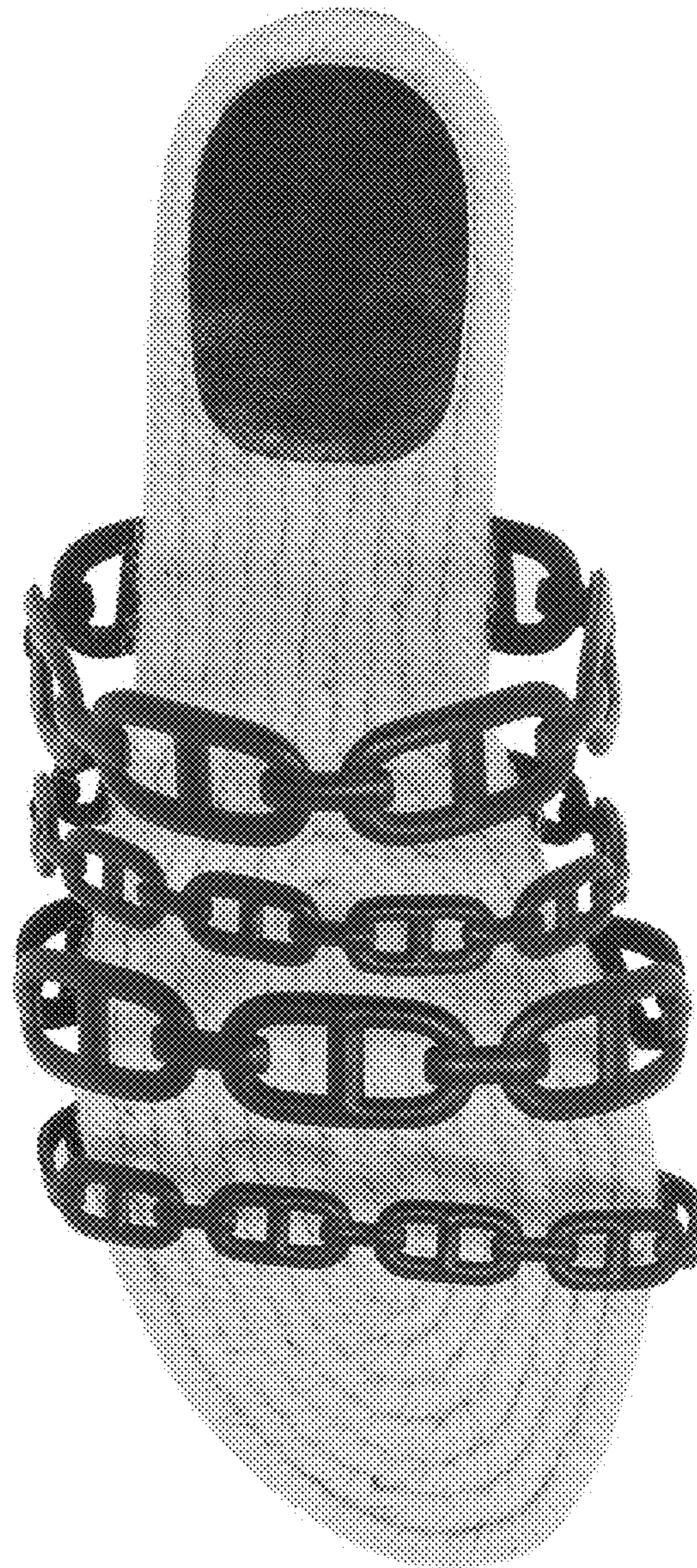
