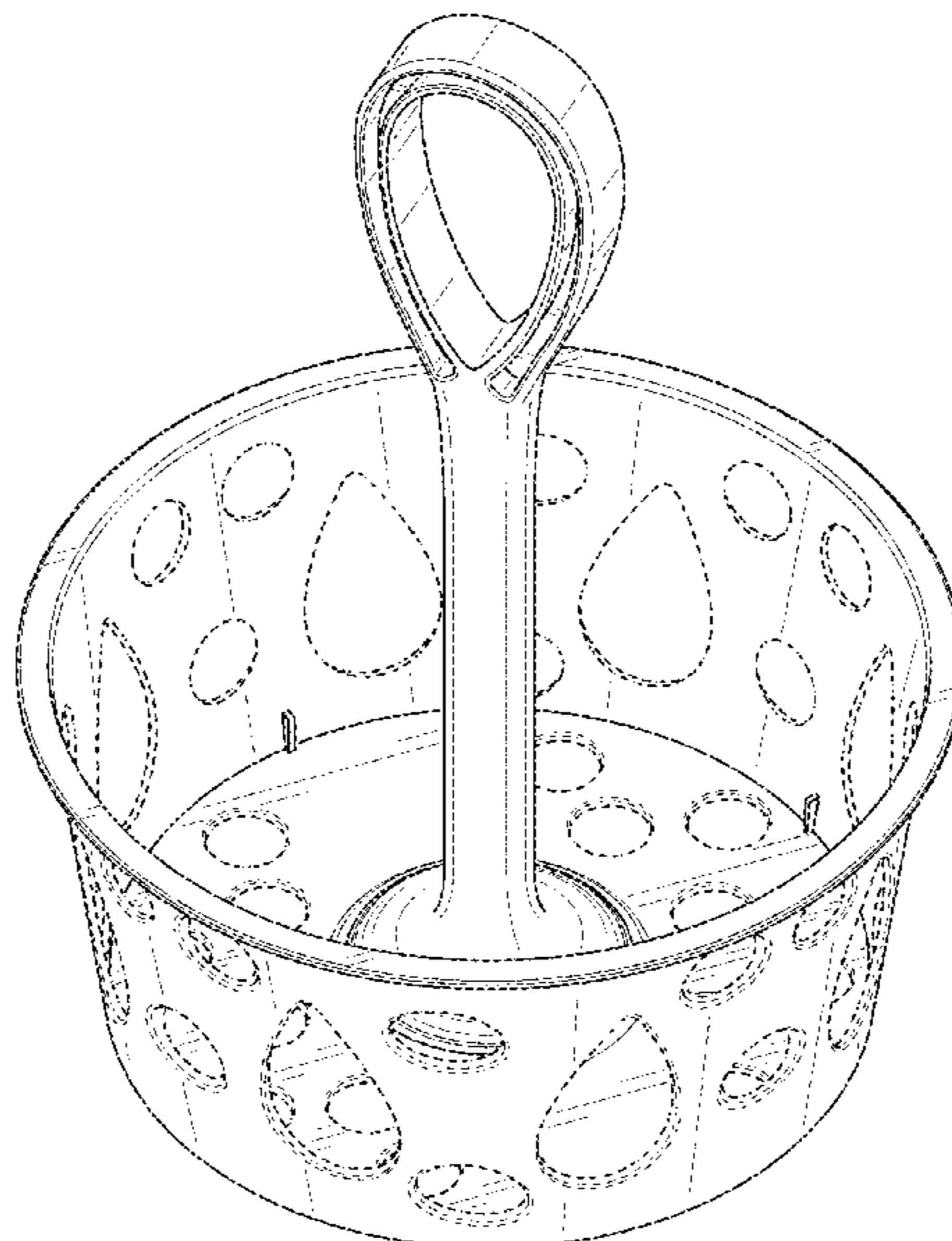
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a top perspective view of my new design for a basket;  
FIG. 2 is a bottom perspective view thereof;  
FIG. 3 is a front elevation view thereof;  
FIG. 4 is a rear elevation view thereof;  
FIG. 5 is a side elevation view thereof;  
FIG. 6 is the other side elevation view thereof;  
FIG. 7 is a bottom plan view thereof; and,  
FIG. 8 is a depiction of the basket of FIG. 1 with the handle portion shown separate from the basket portion.

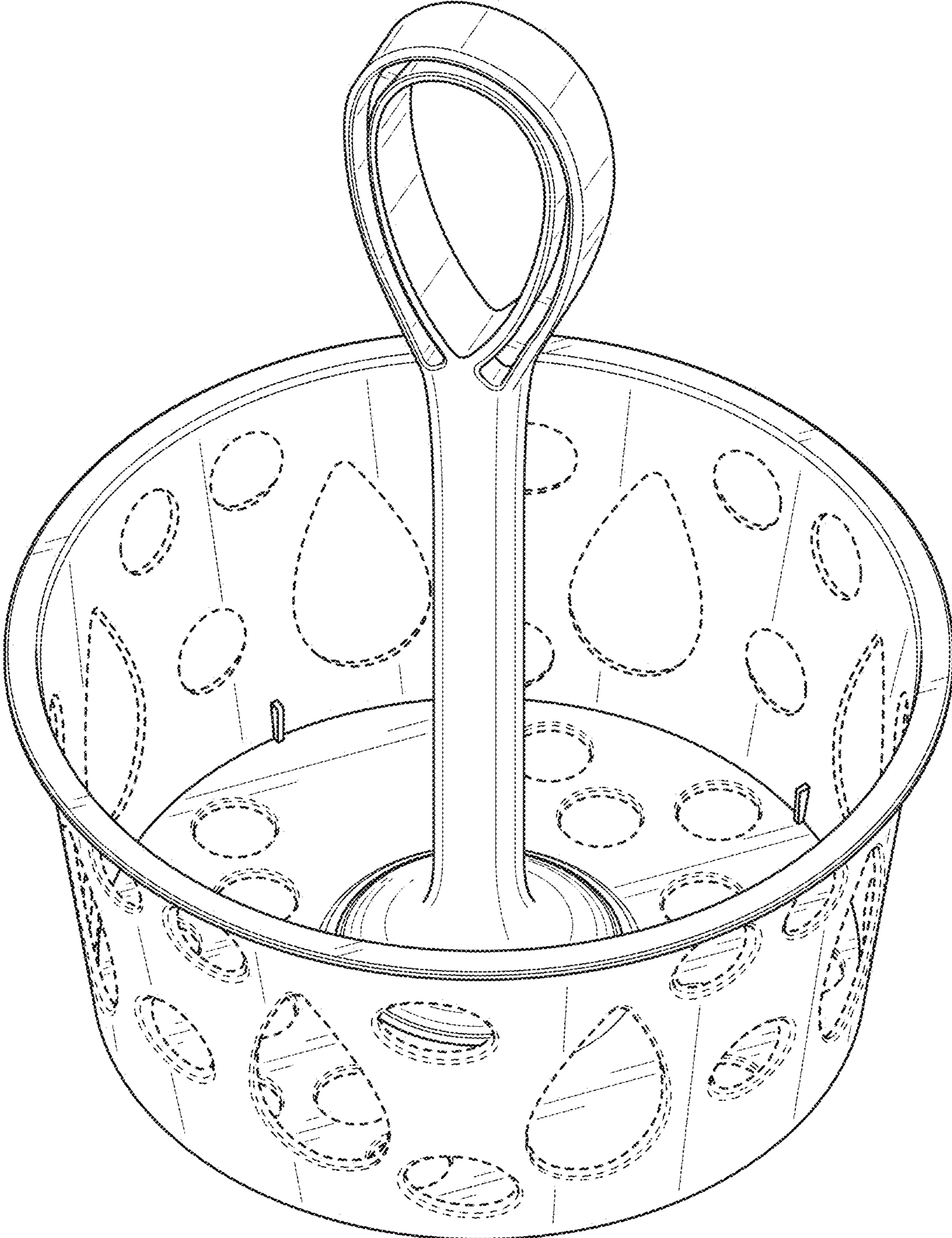

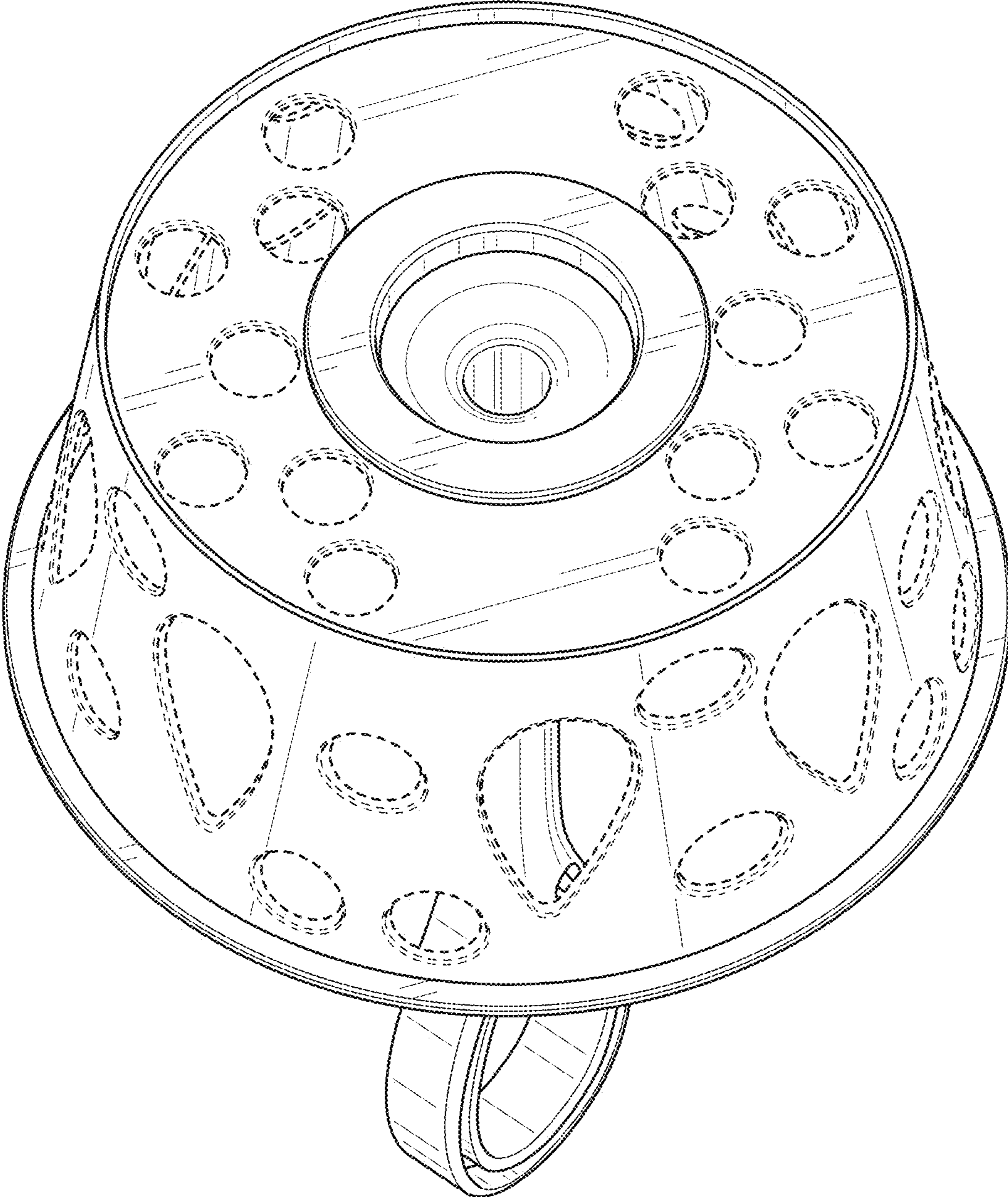

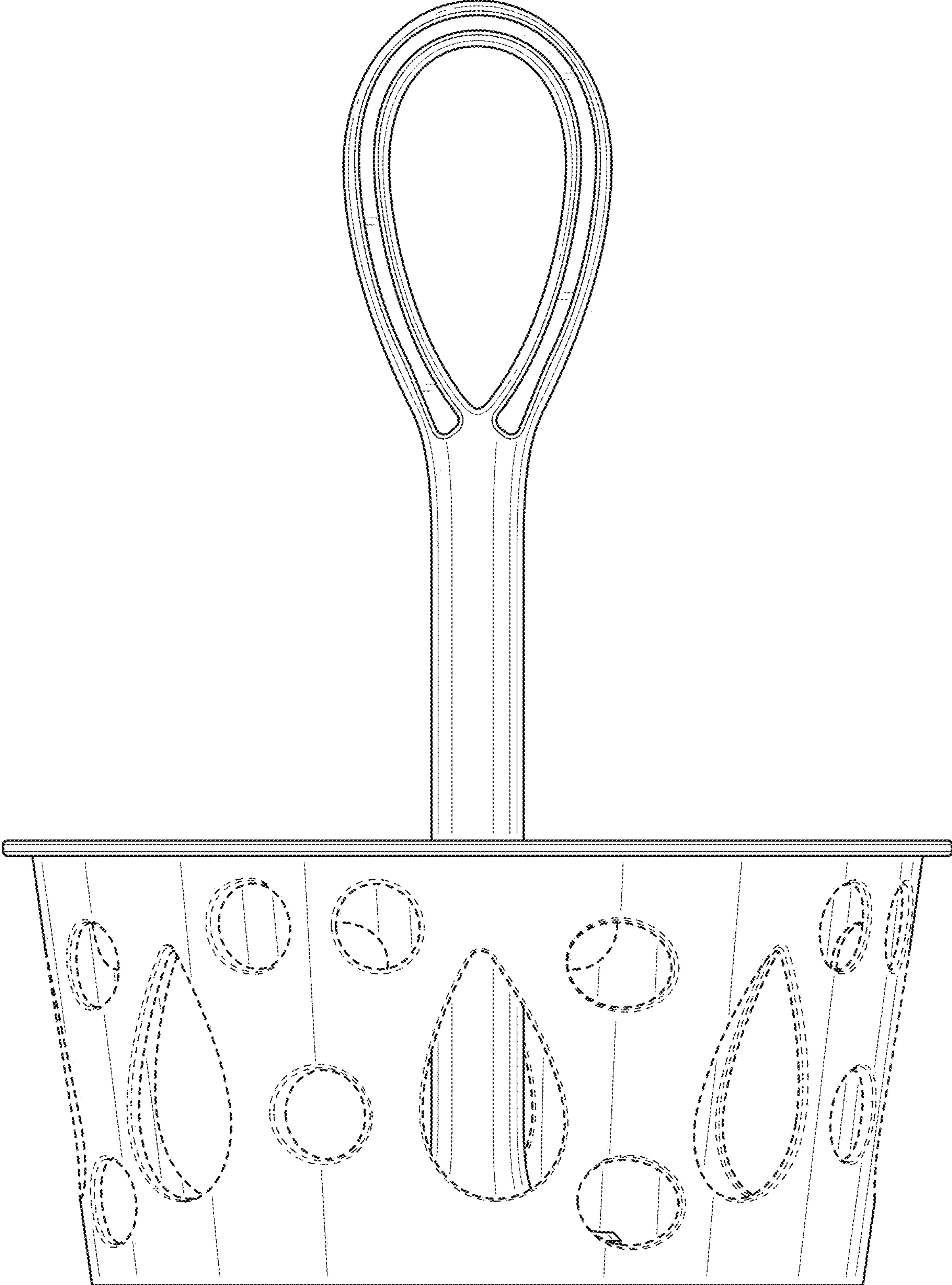

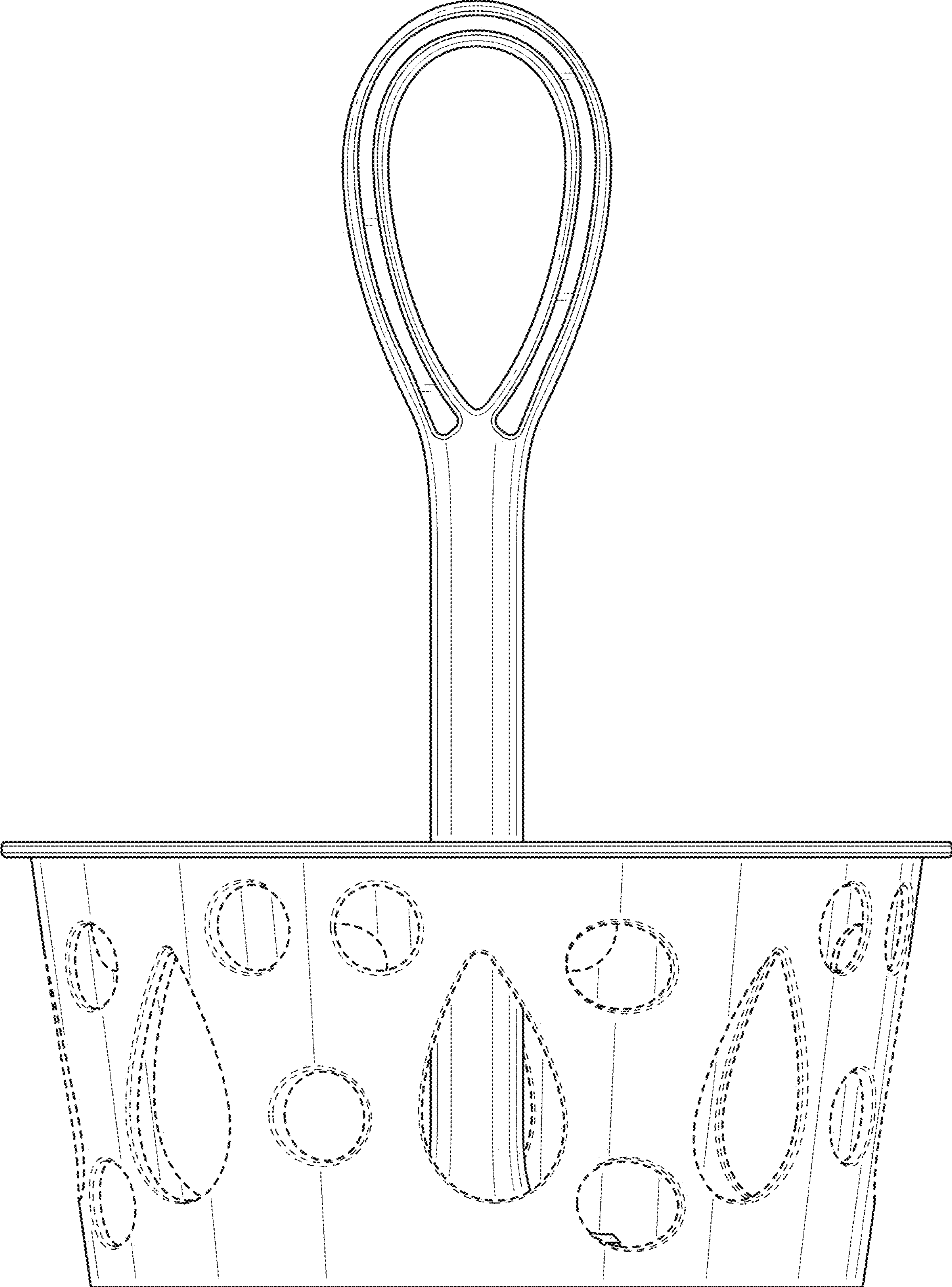

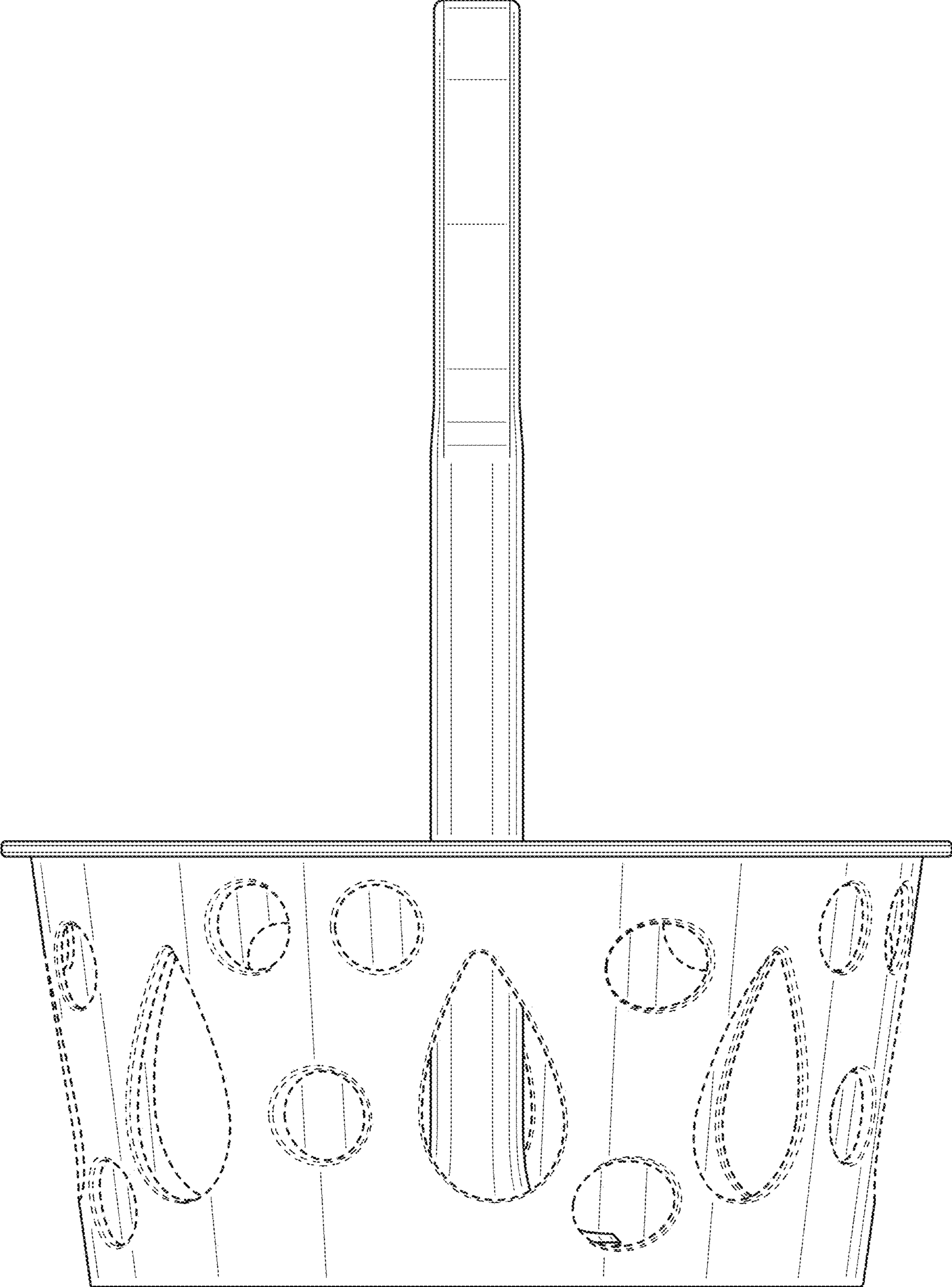

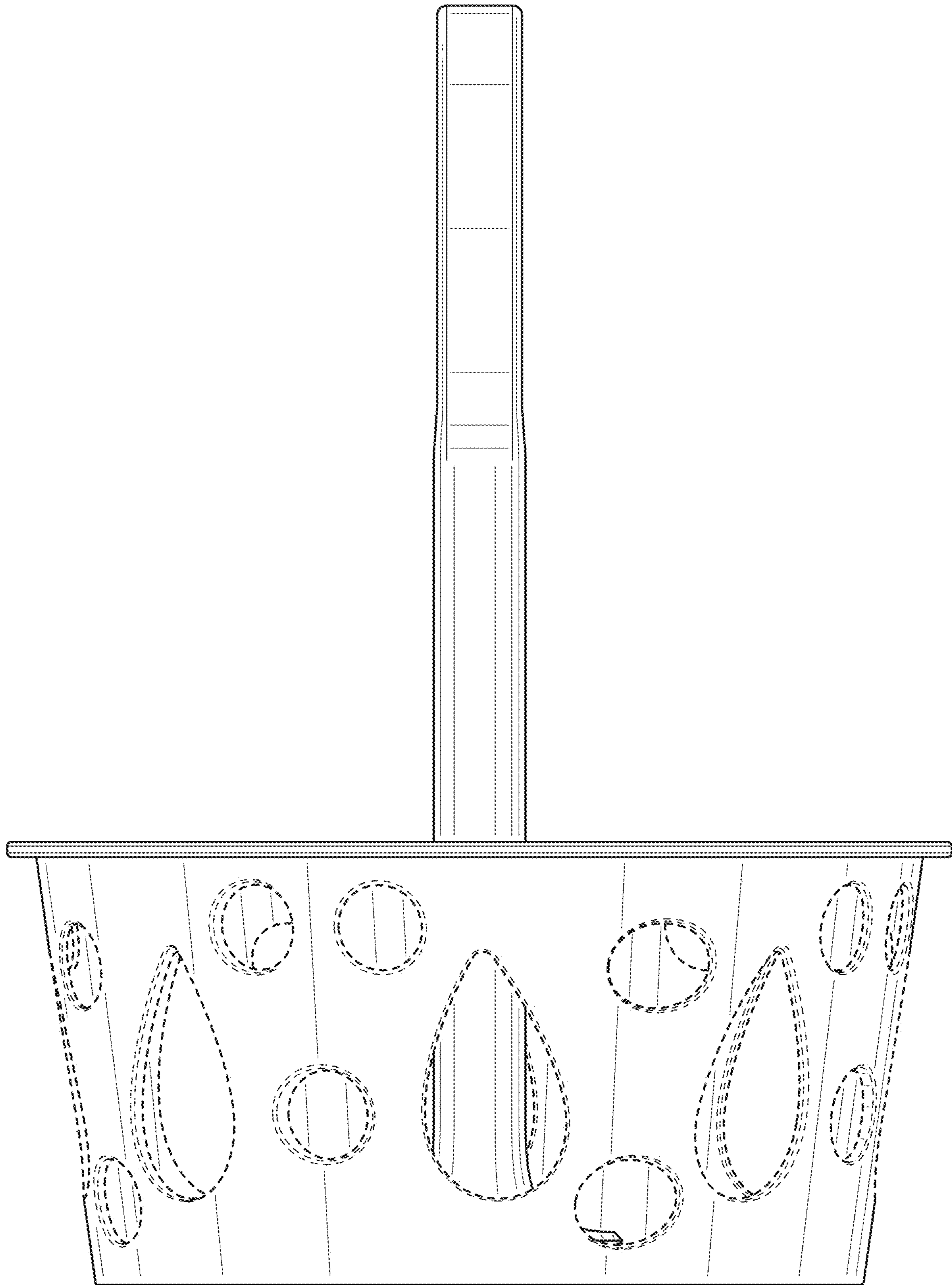

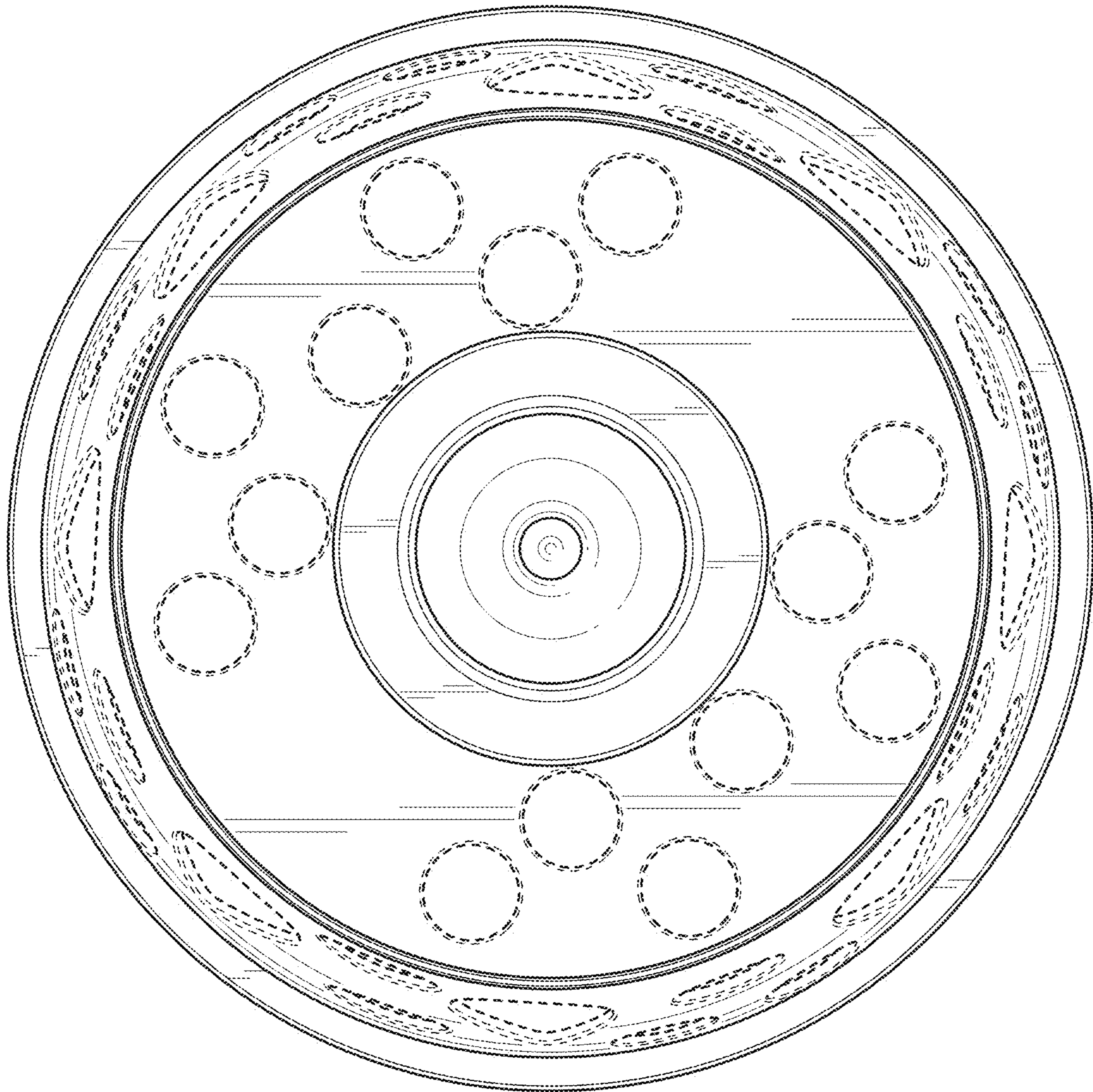

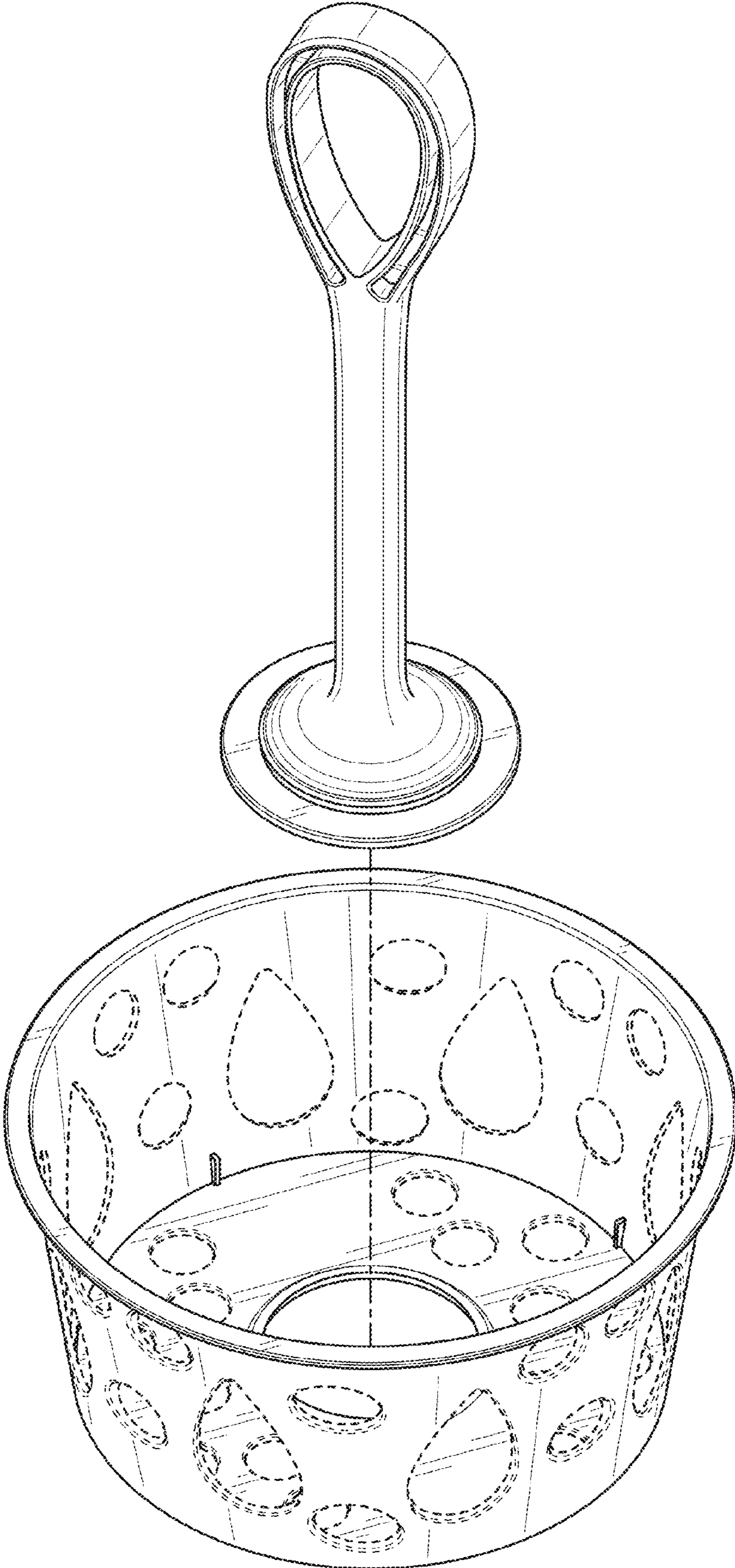
