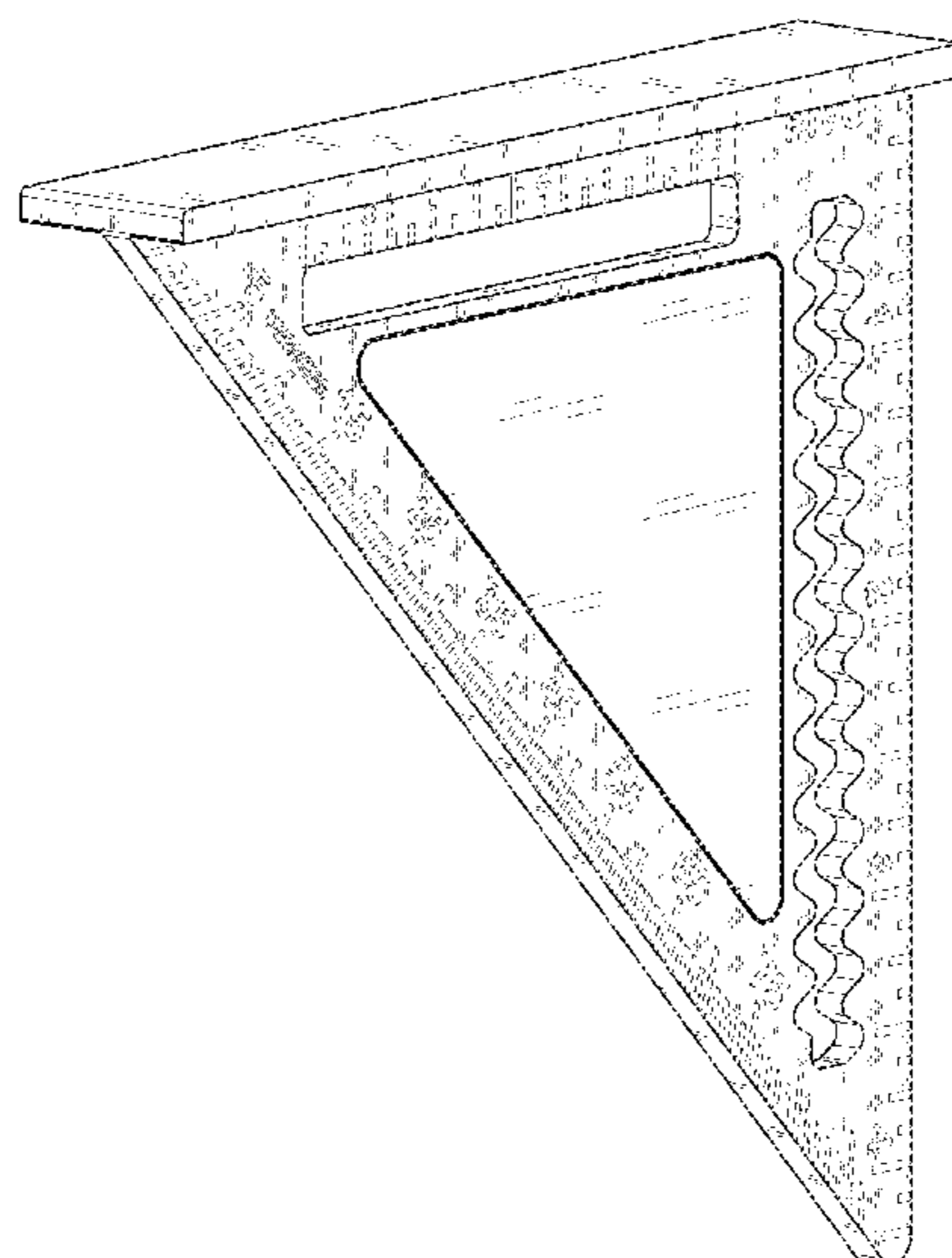
(57) **CLAIM**

DESCRIPTION

FIG. 1 is an isometric view of a square incorporating our new design, wherein the portions in phantom form no part of the claimed design;
FIG. 2 is a first side elevation view thereof;
FIG. 3 is a second side elevation view thereof;
FIG. 4 is a first end elevation view thereof;
FIG. 5 is a second end elevation view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a top plan view thereof.
The broken lines depict portions of the square that form no part of the claimed design.

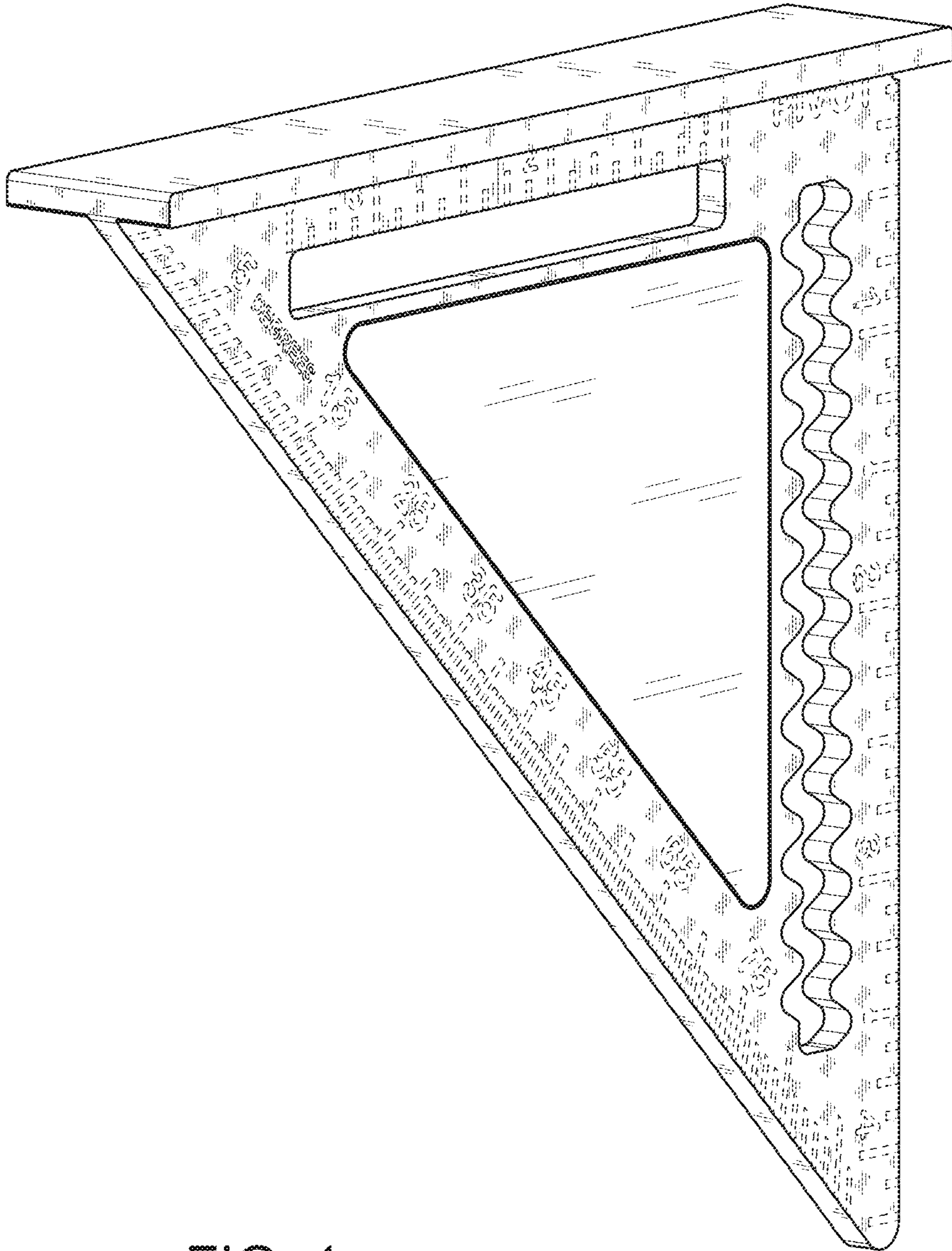

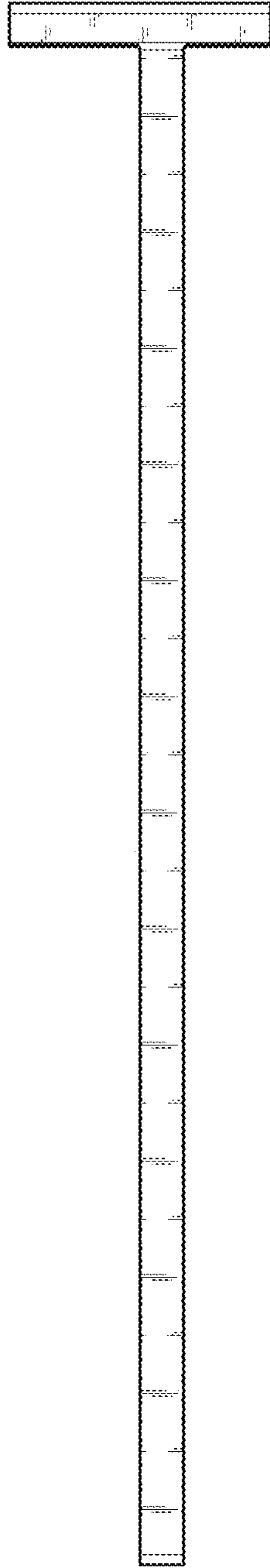

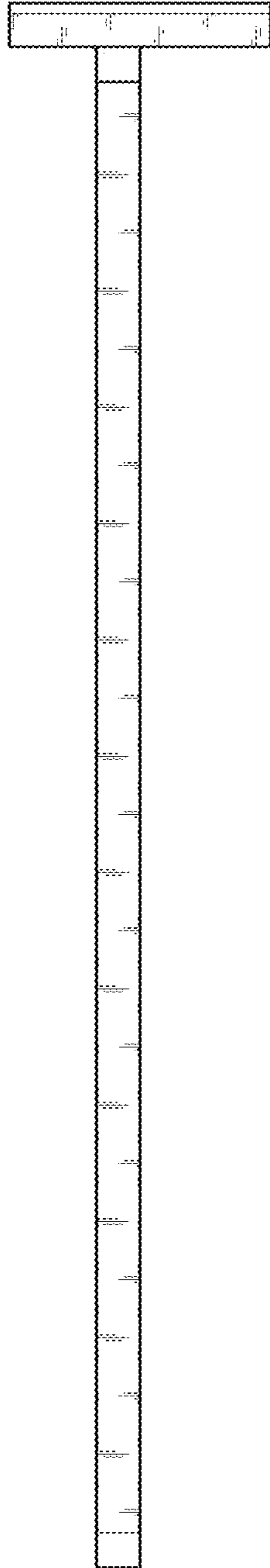

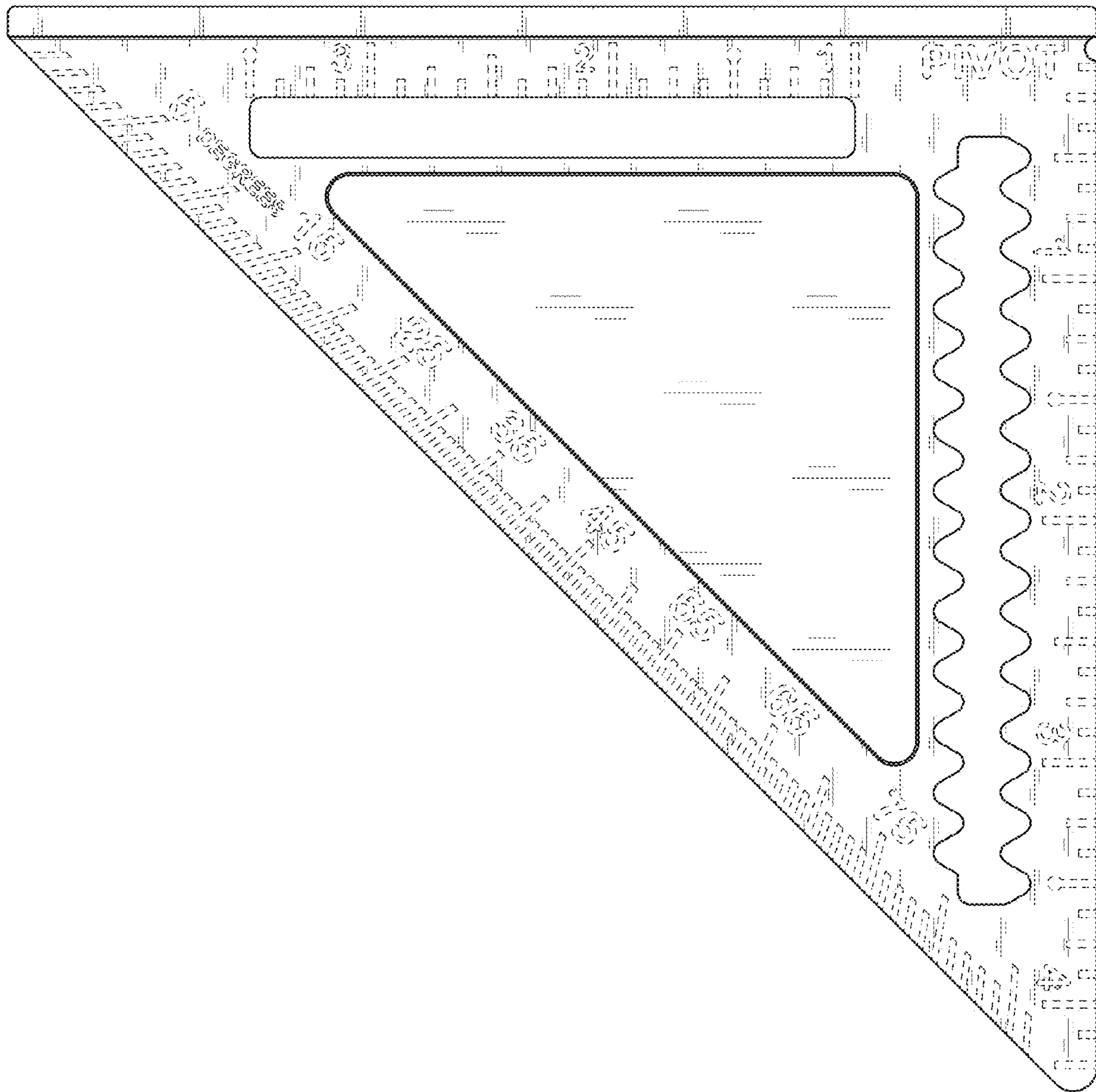

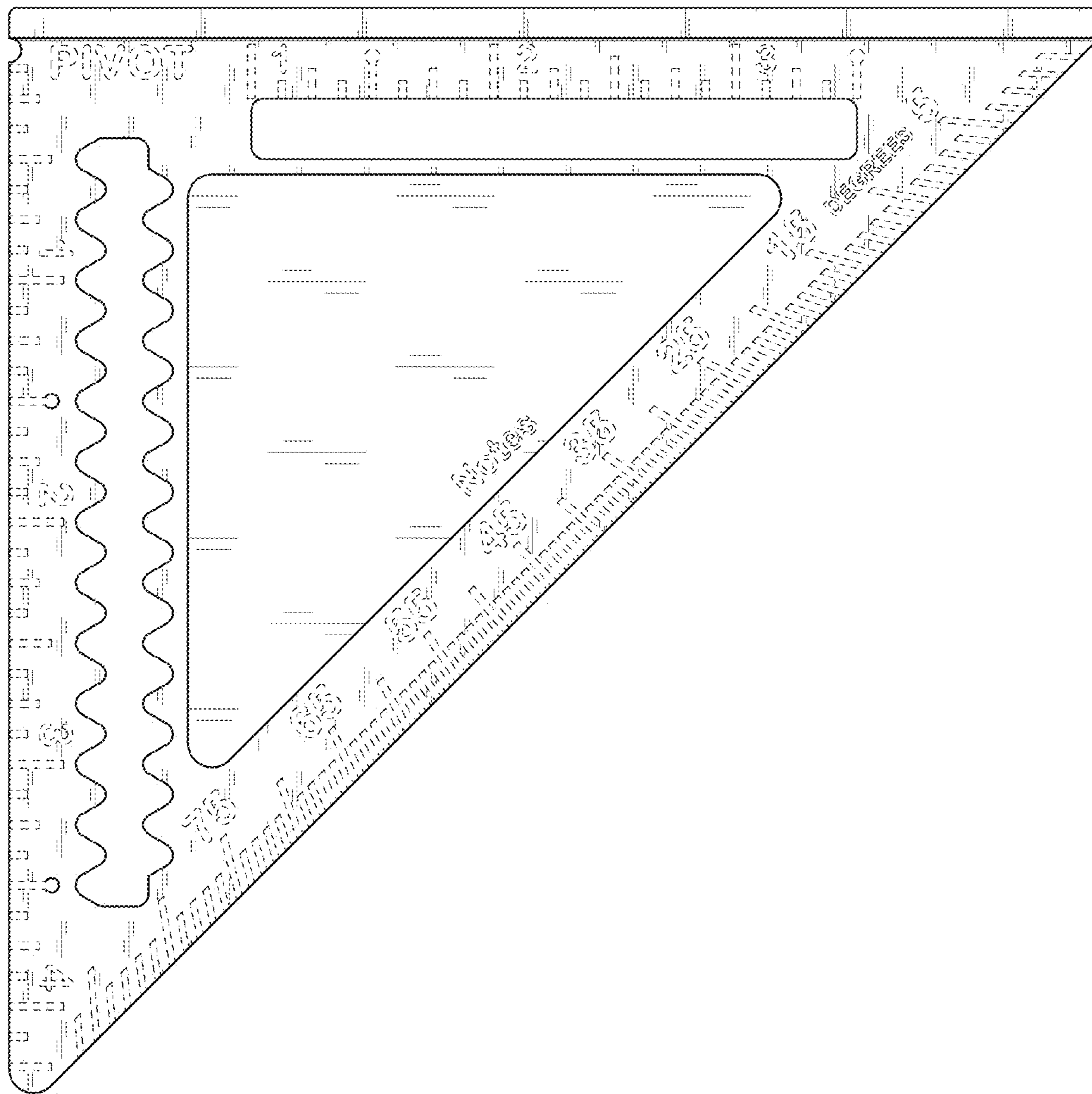

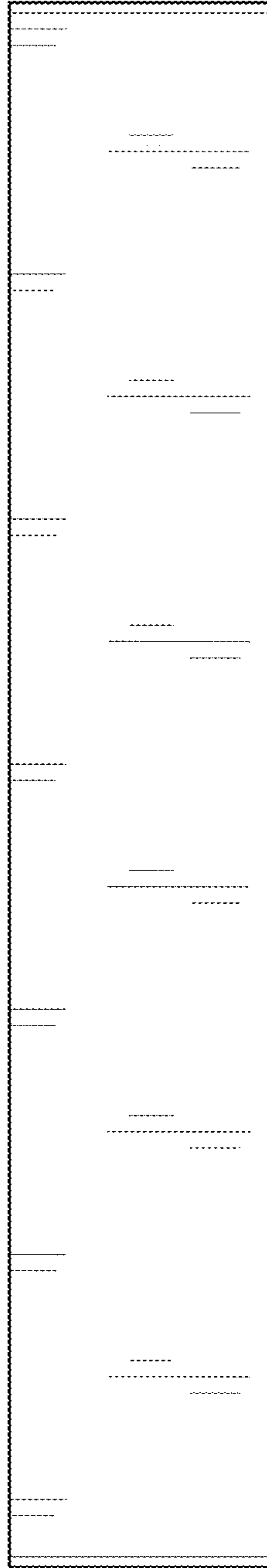

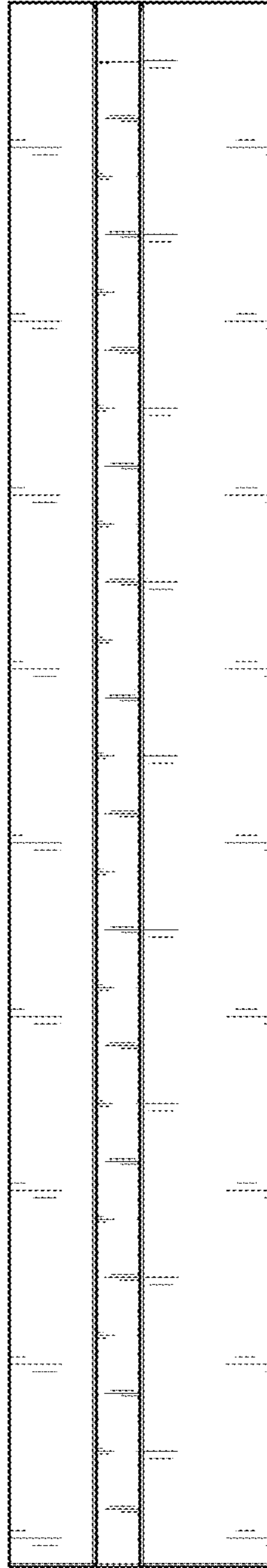
