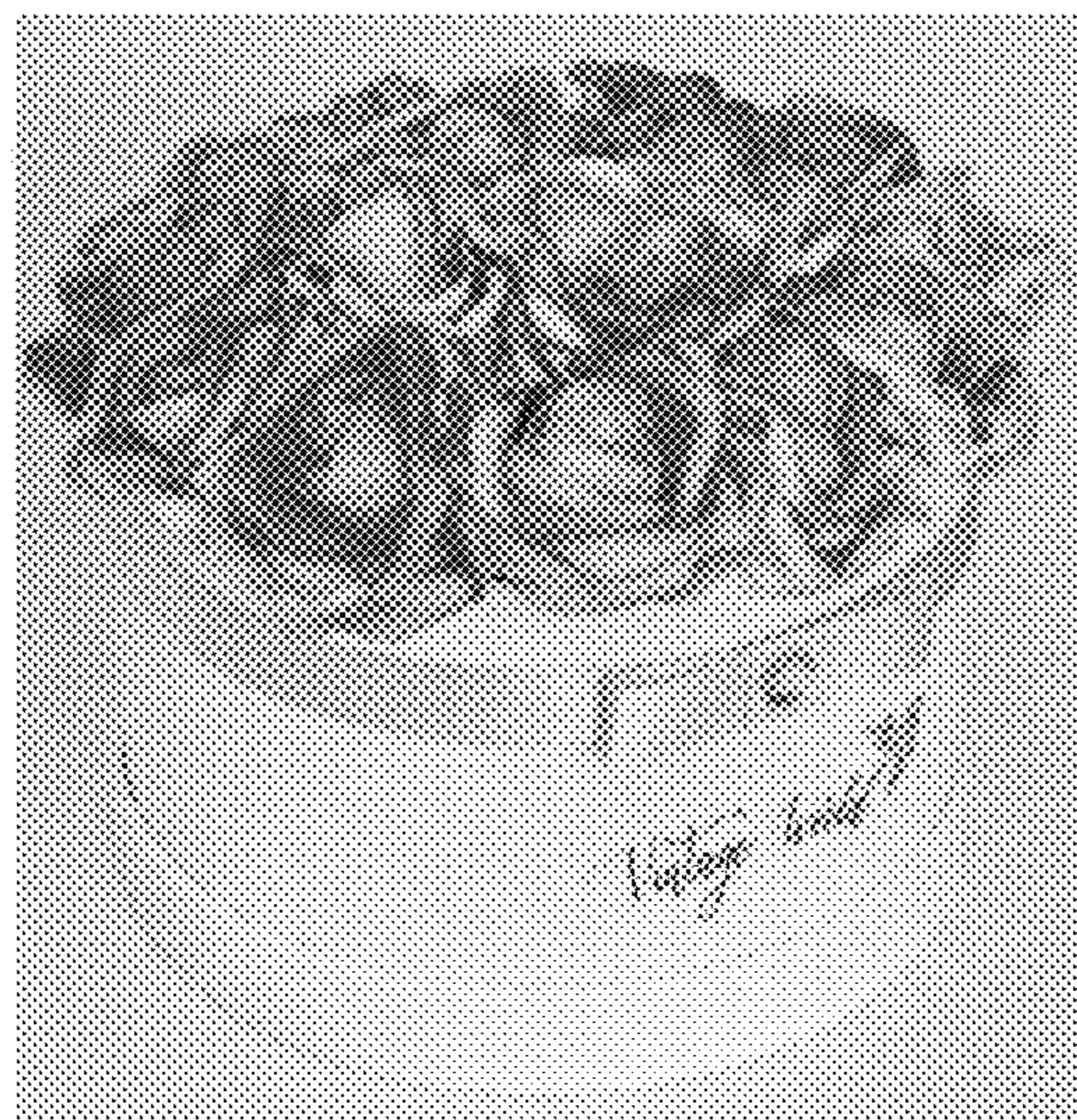
The ornamental design for an artificial flower decoration with a box, as shown and described.
