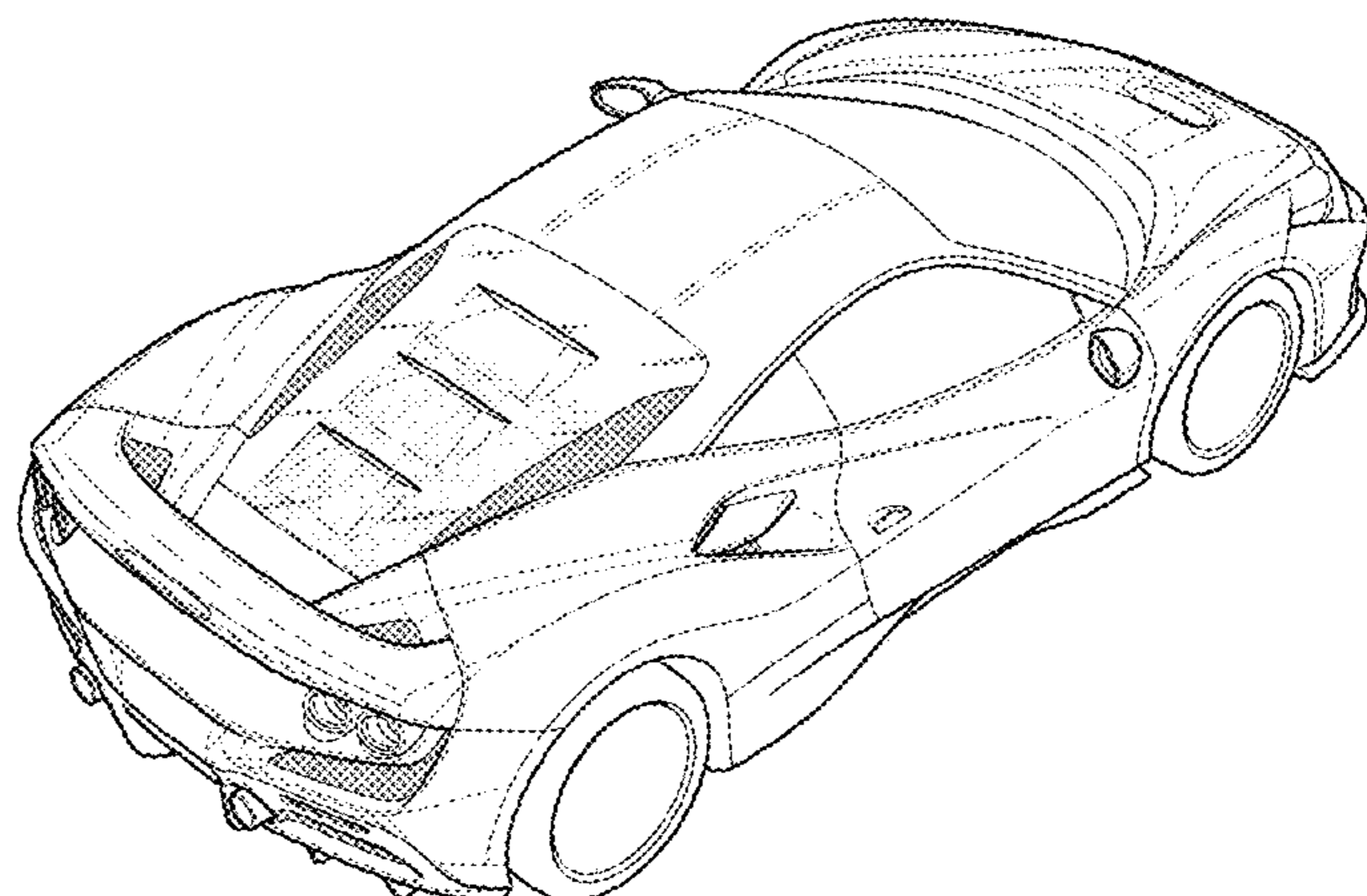
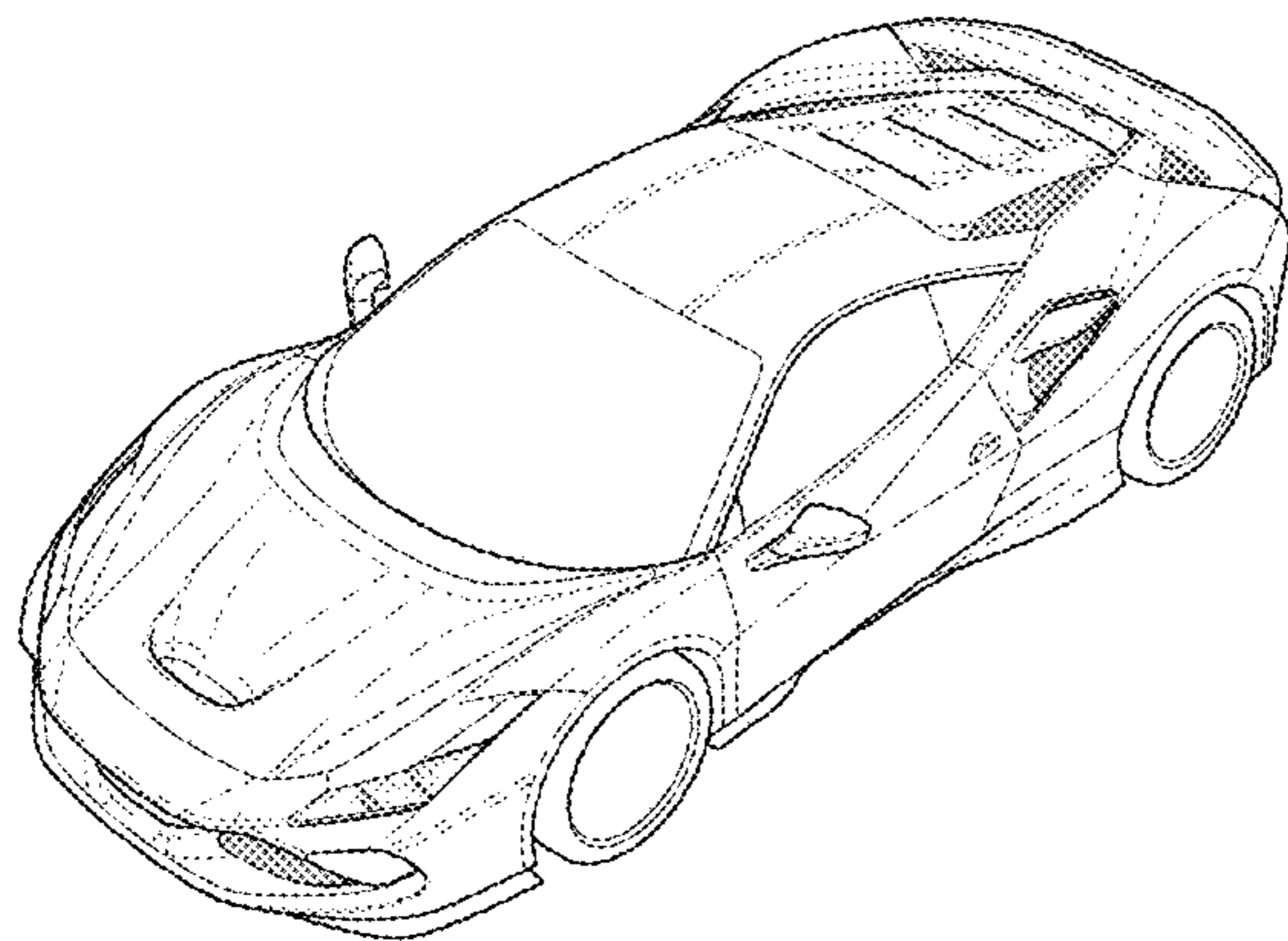

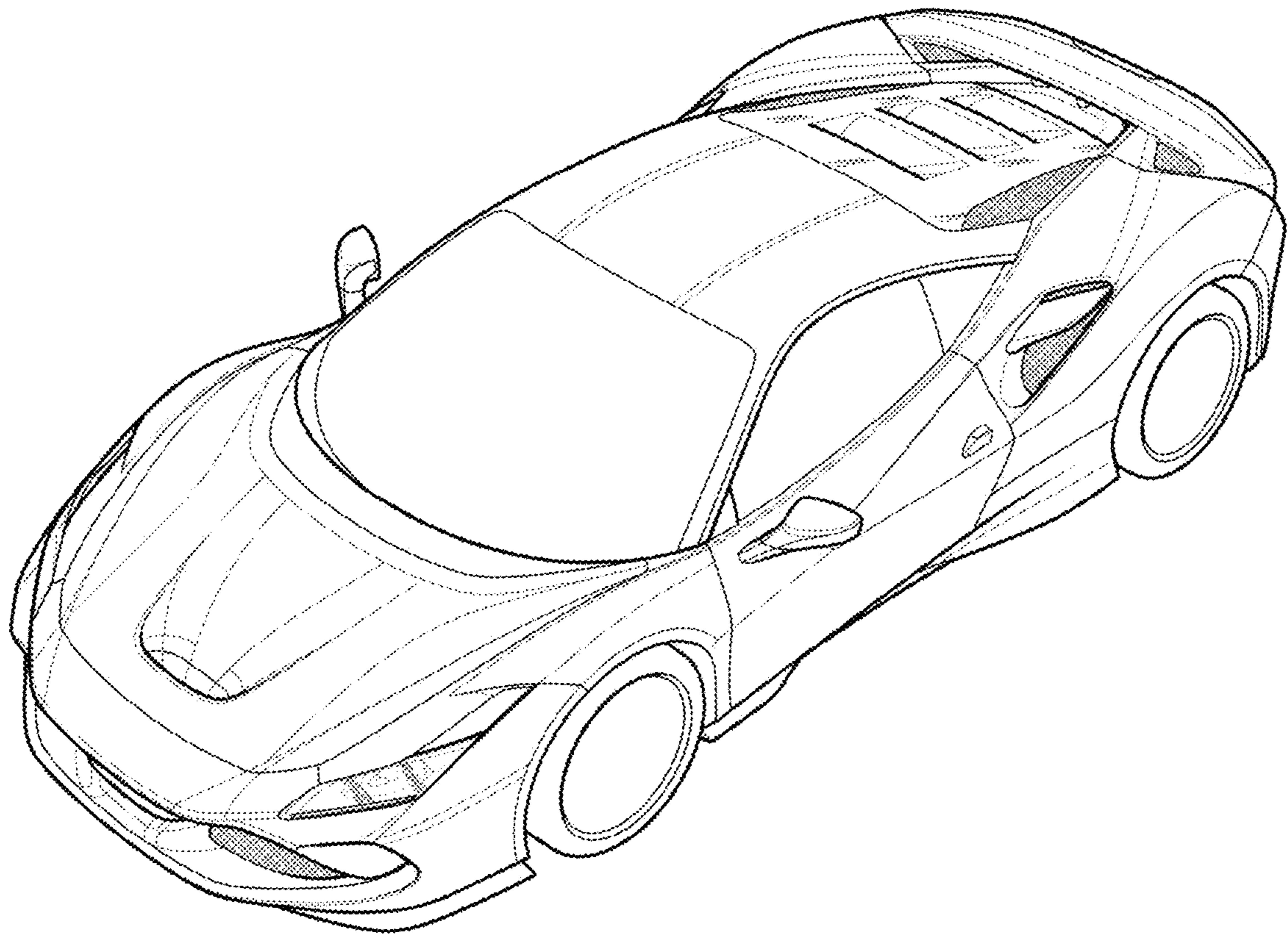

The broken lines depict portions of the automobile that form no part of the claimed design.

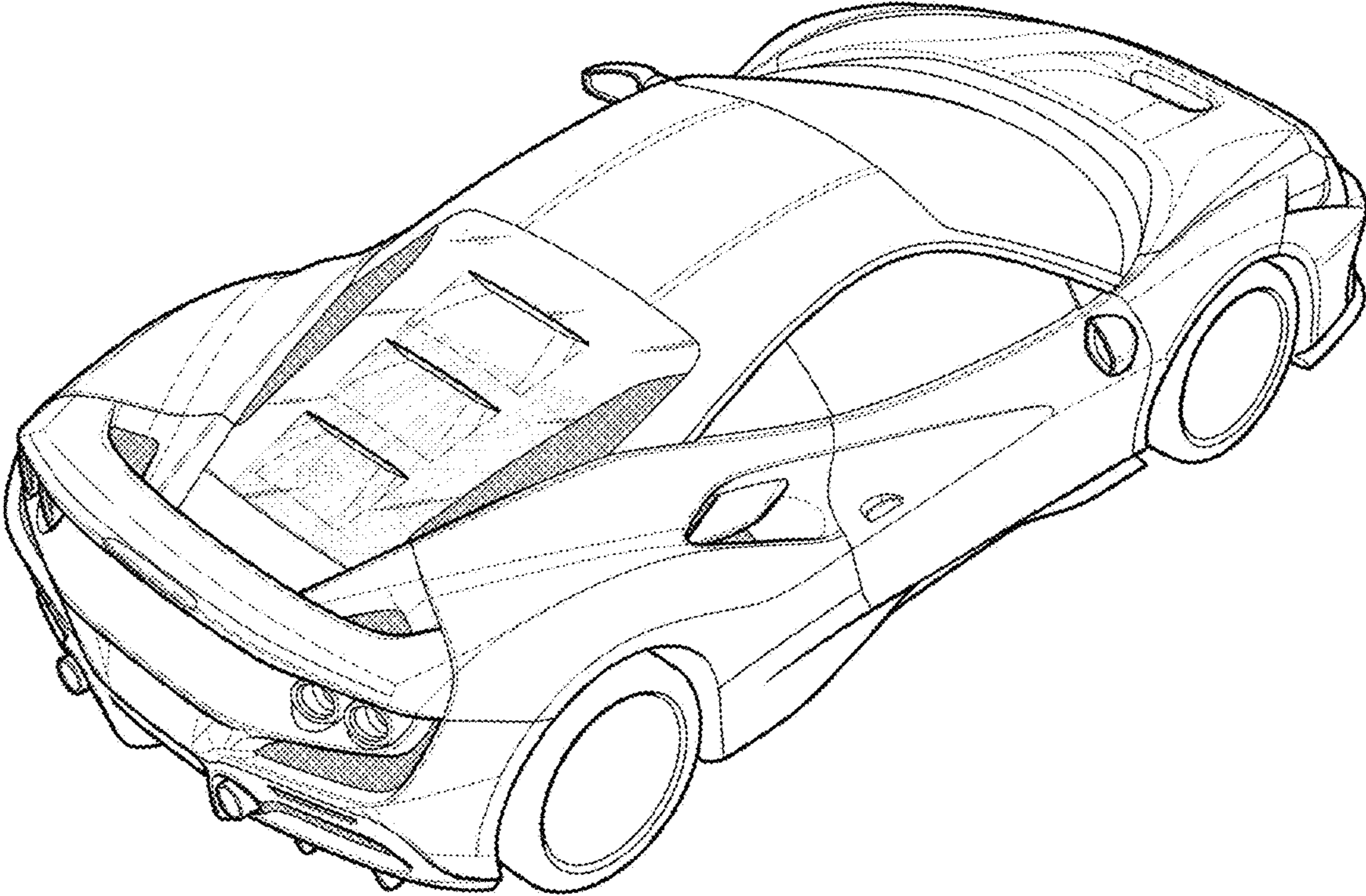

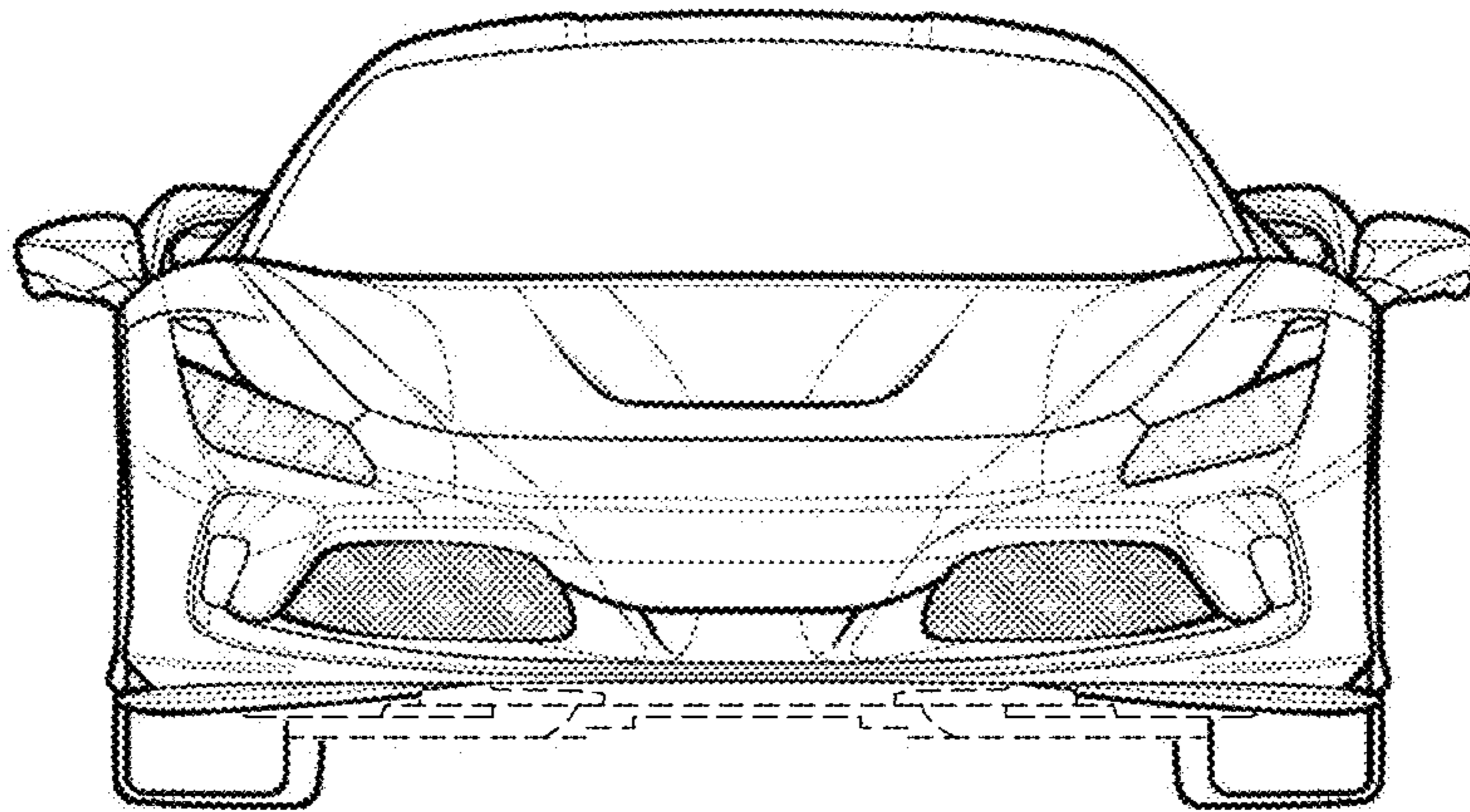

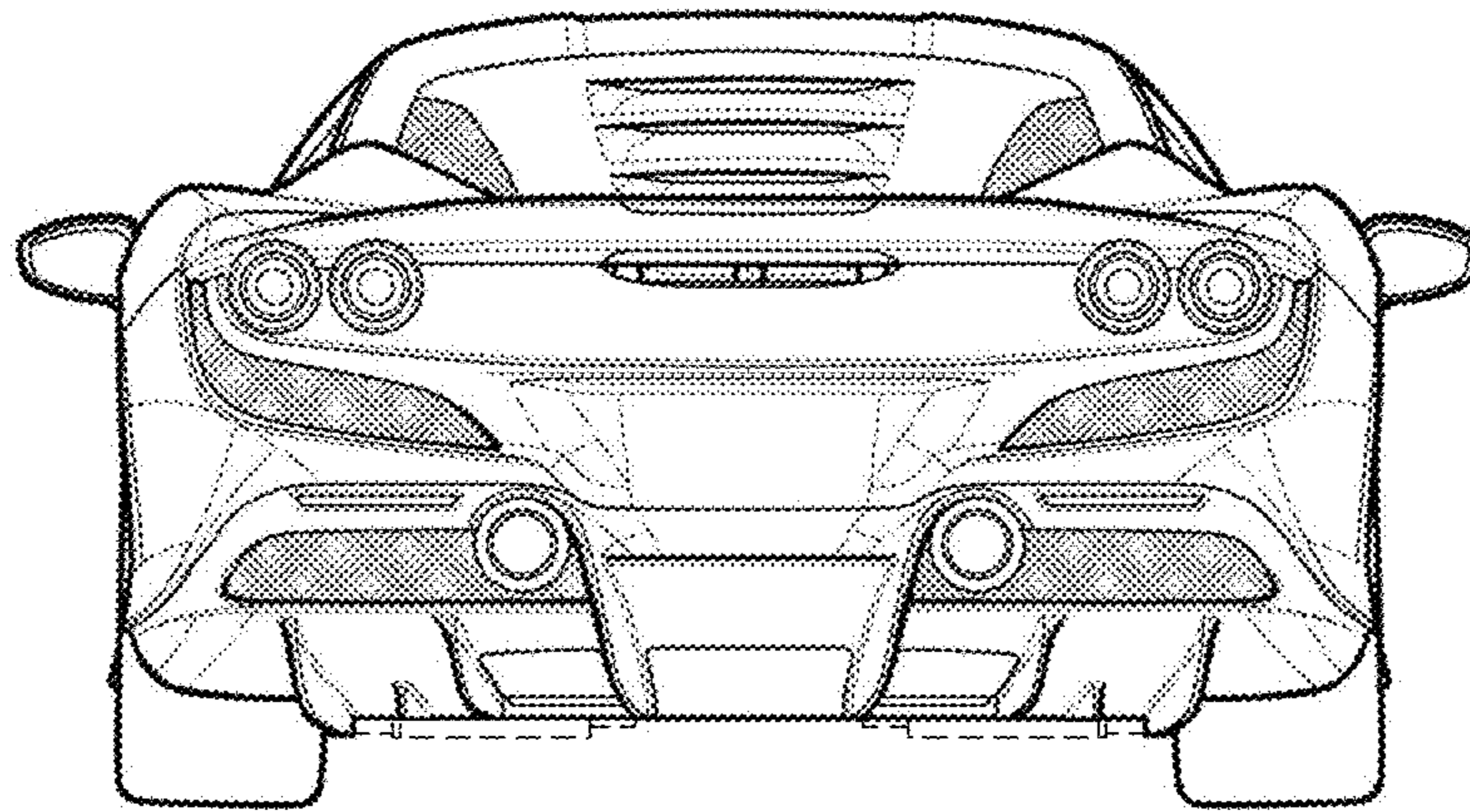

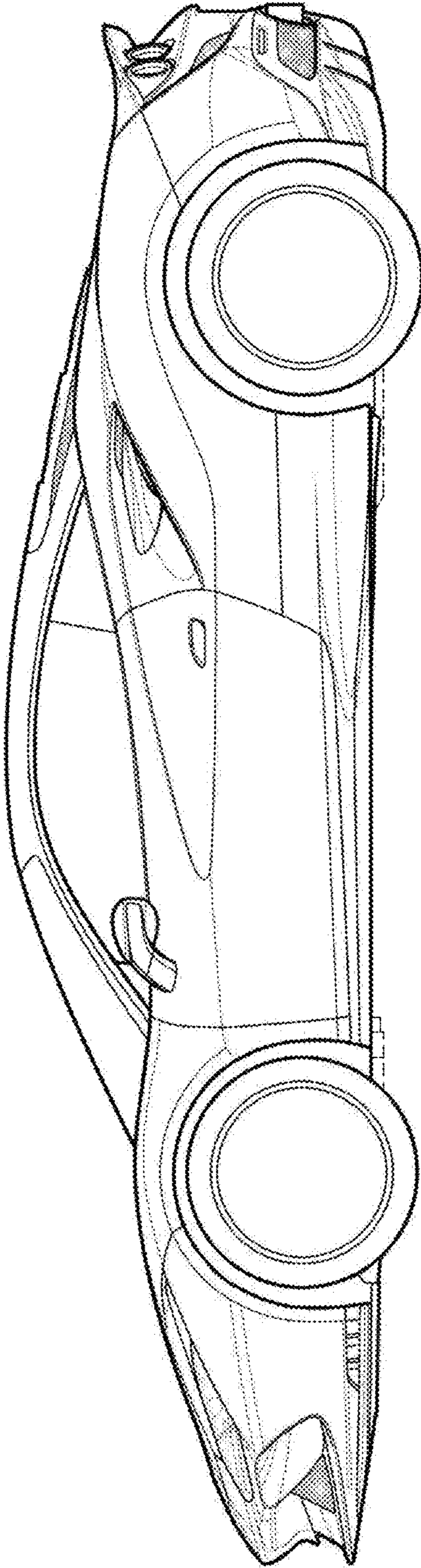
