DESCRIPTION

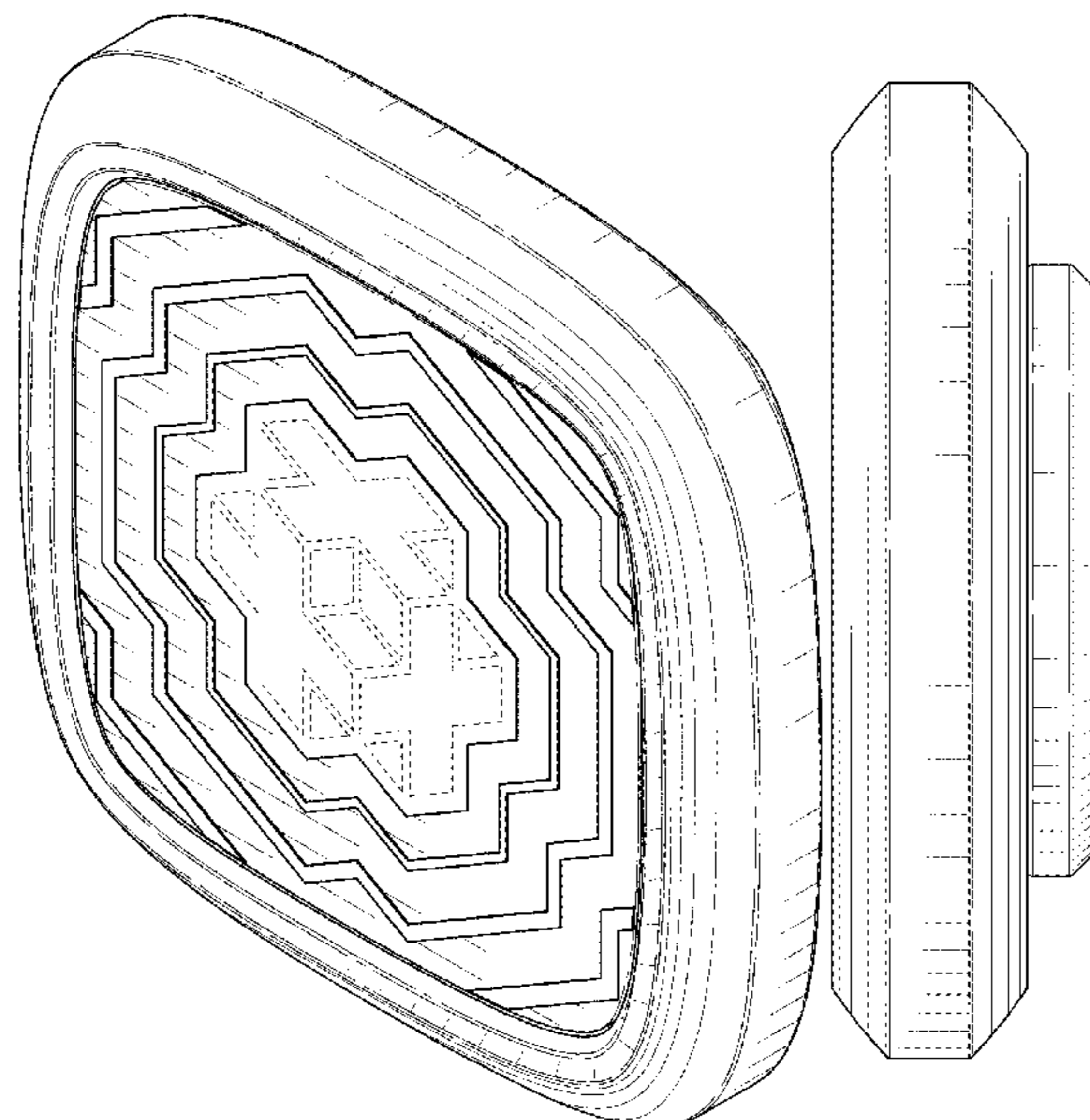
FIG. 1 is a perspective view of a first embodiment of a pin, showing my new design;

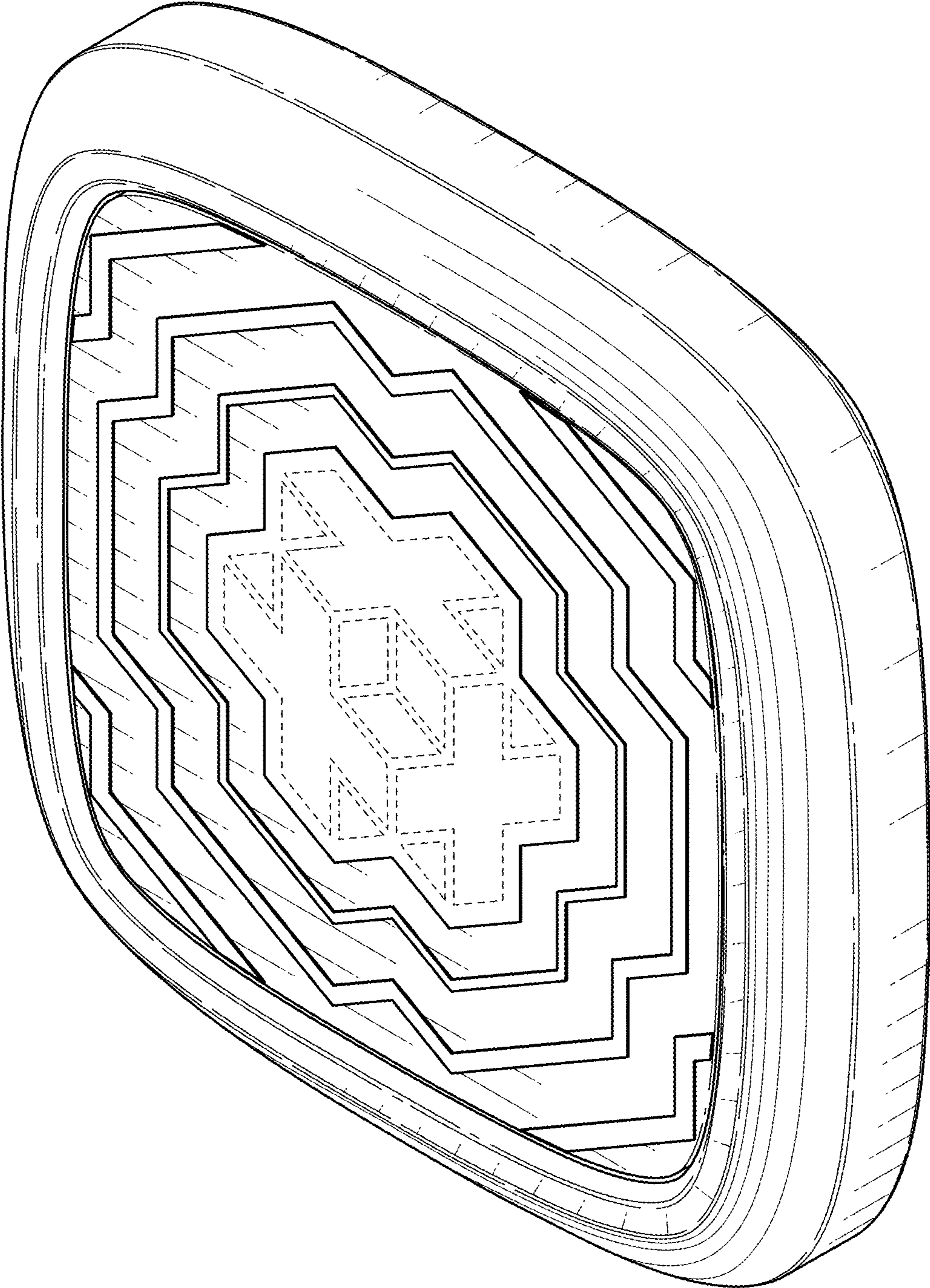

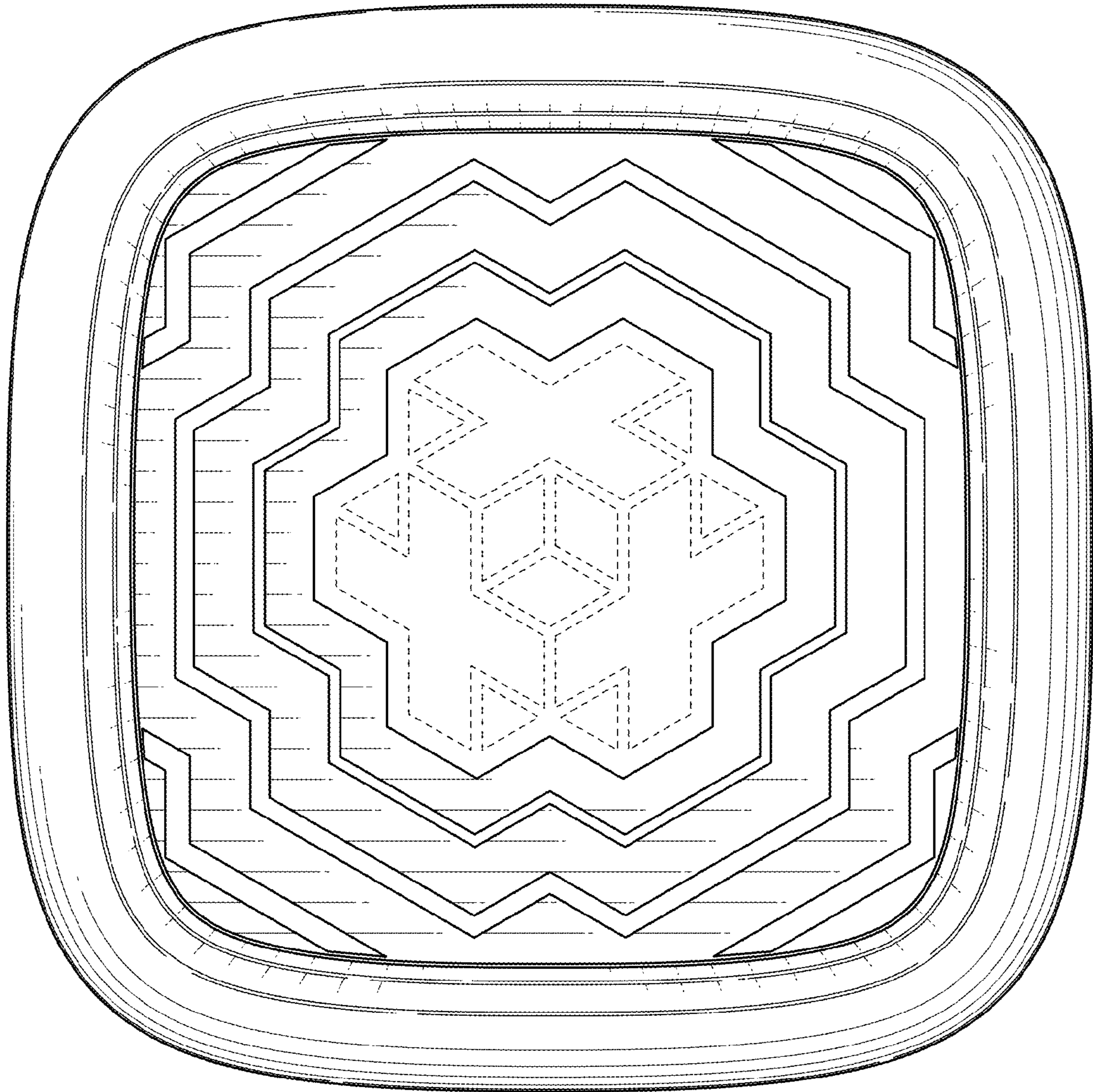

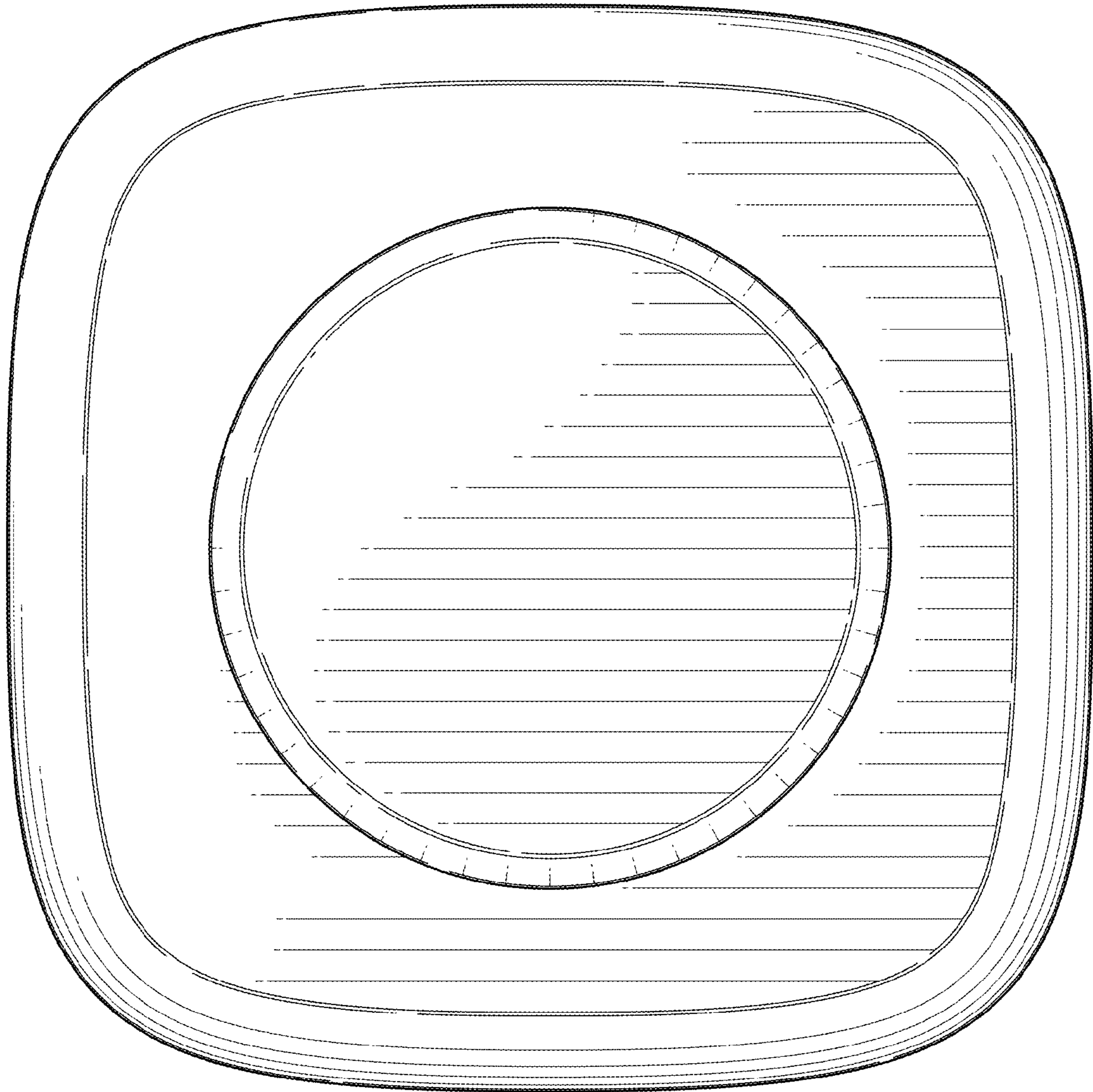

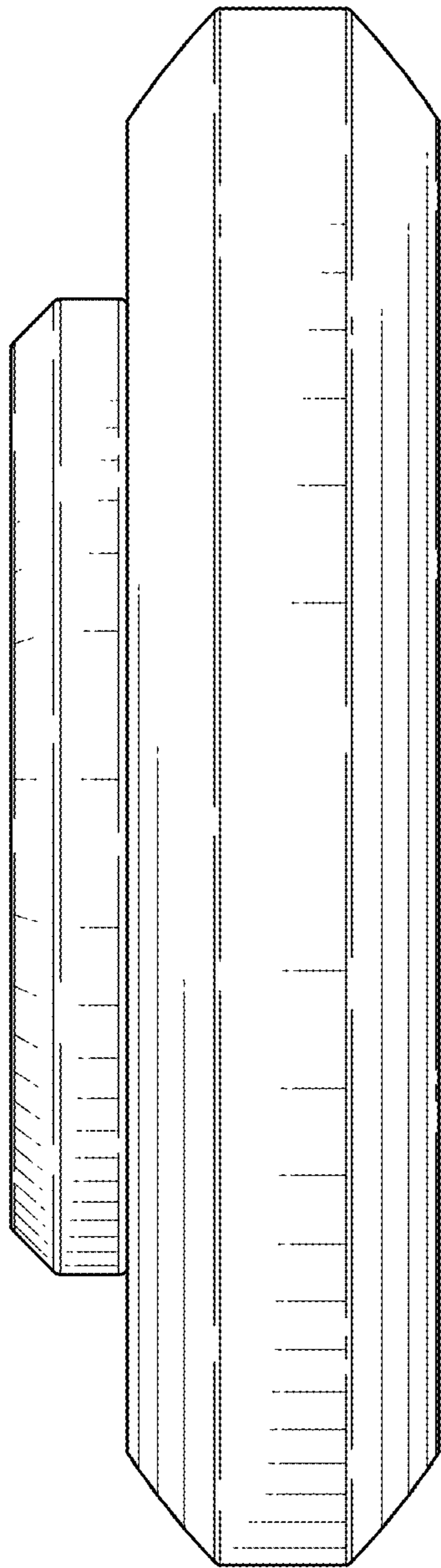

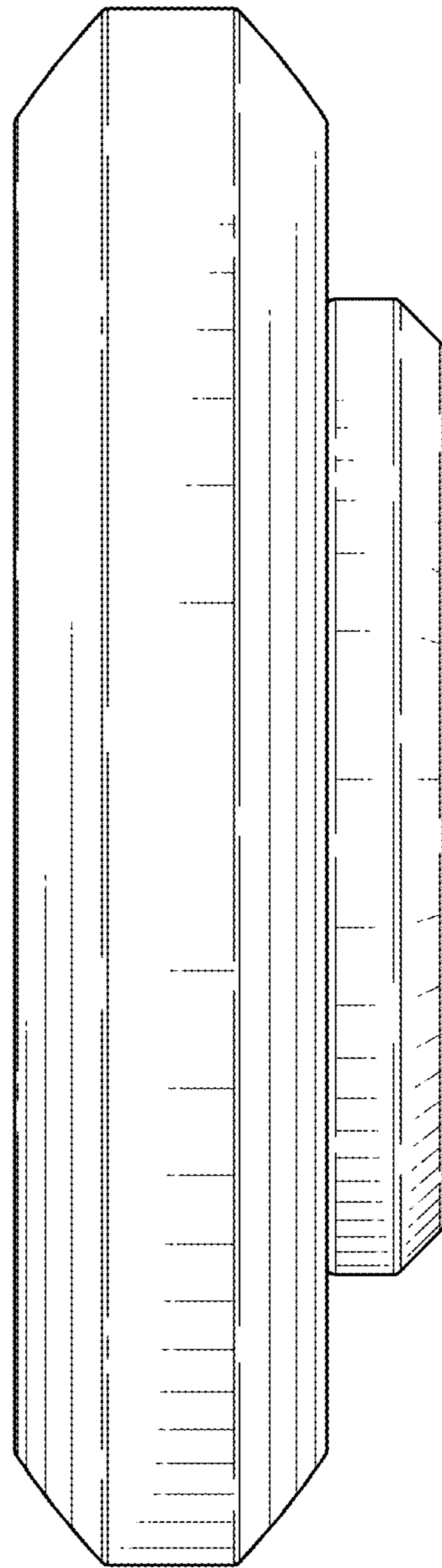

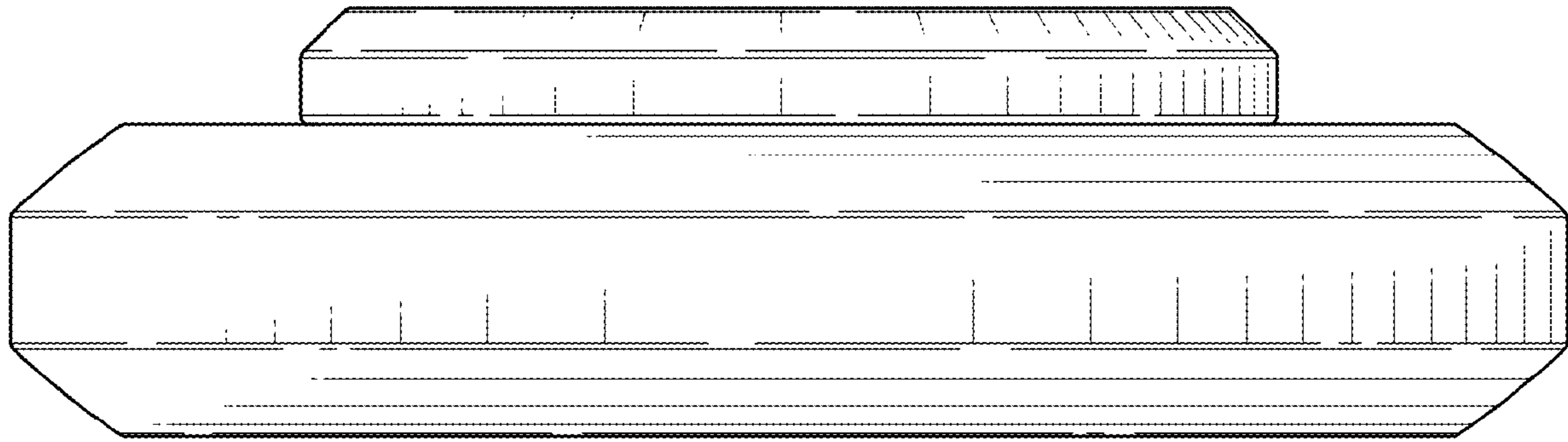

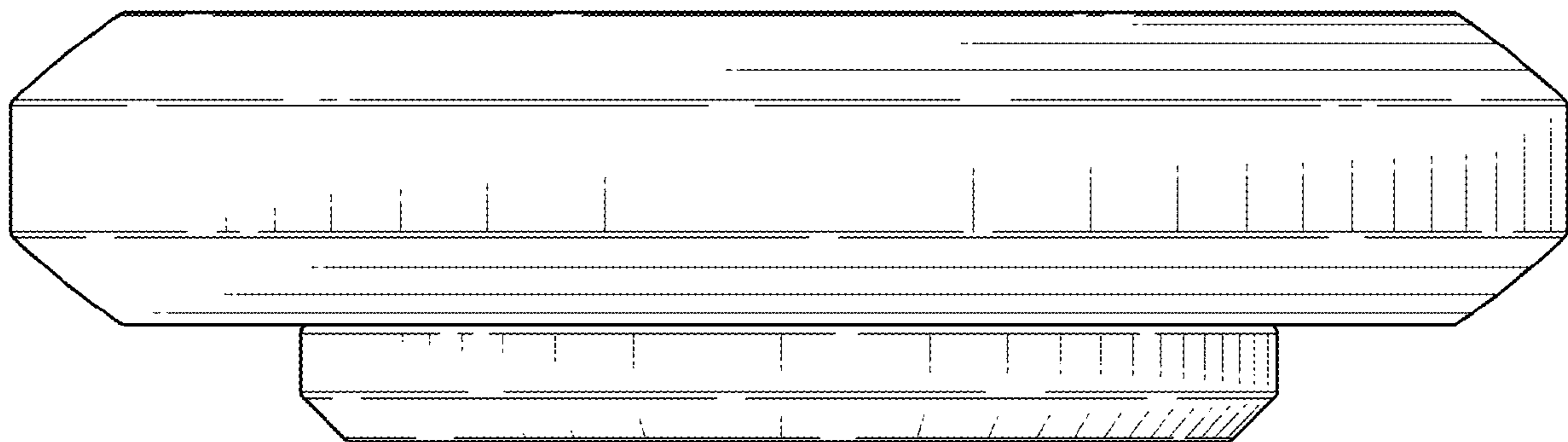

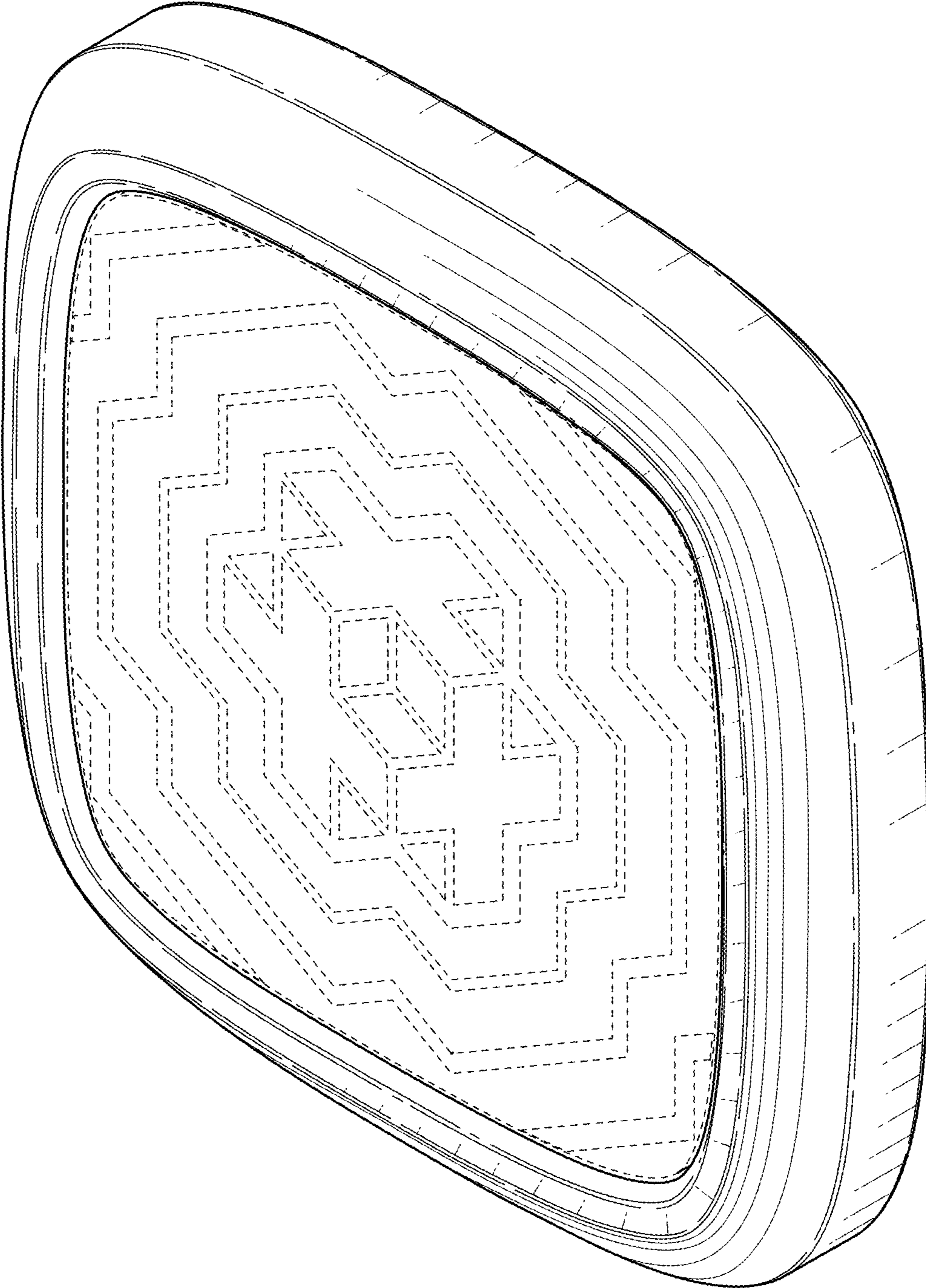

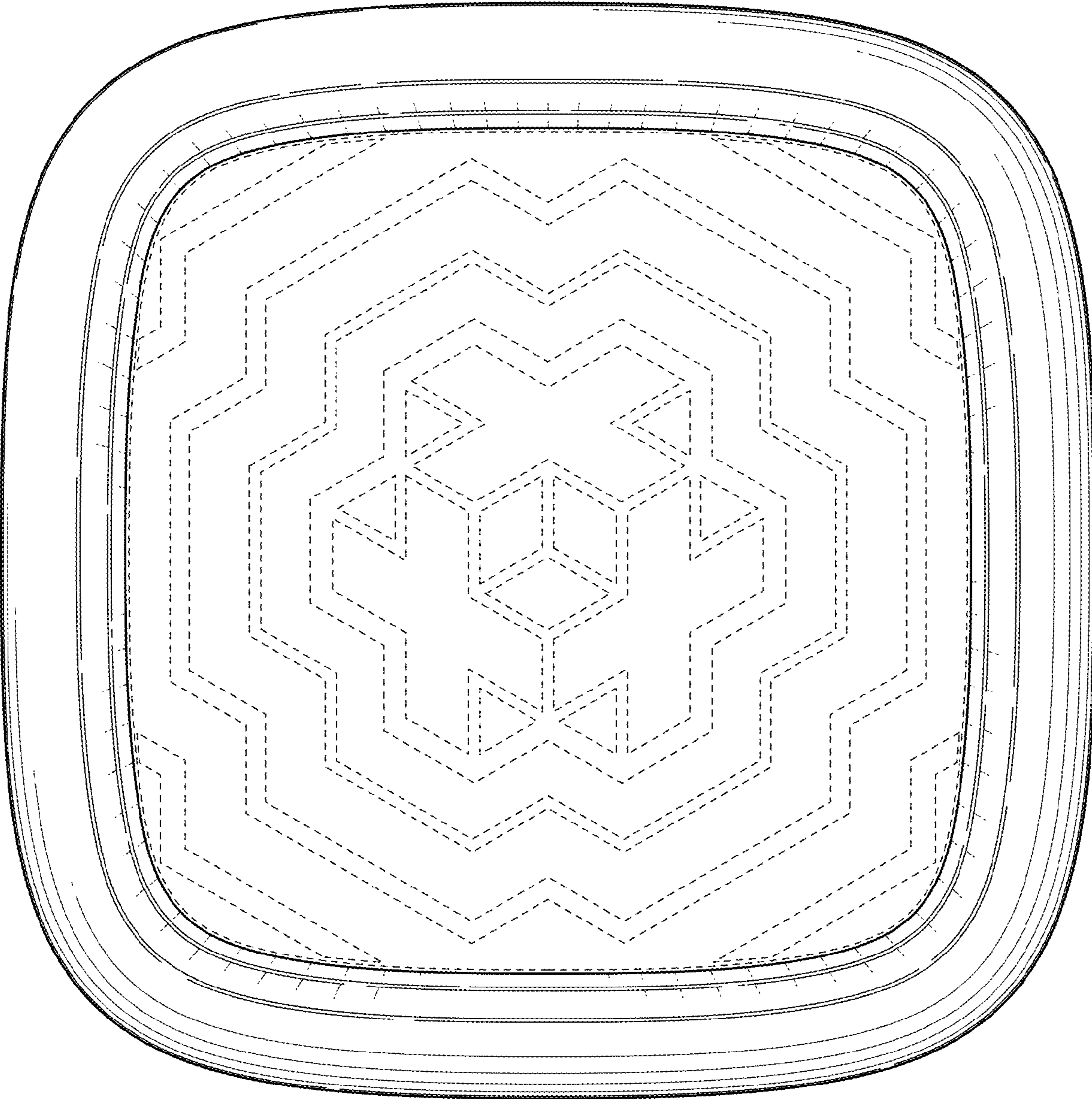

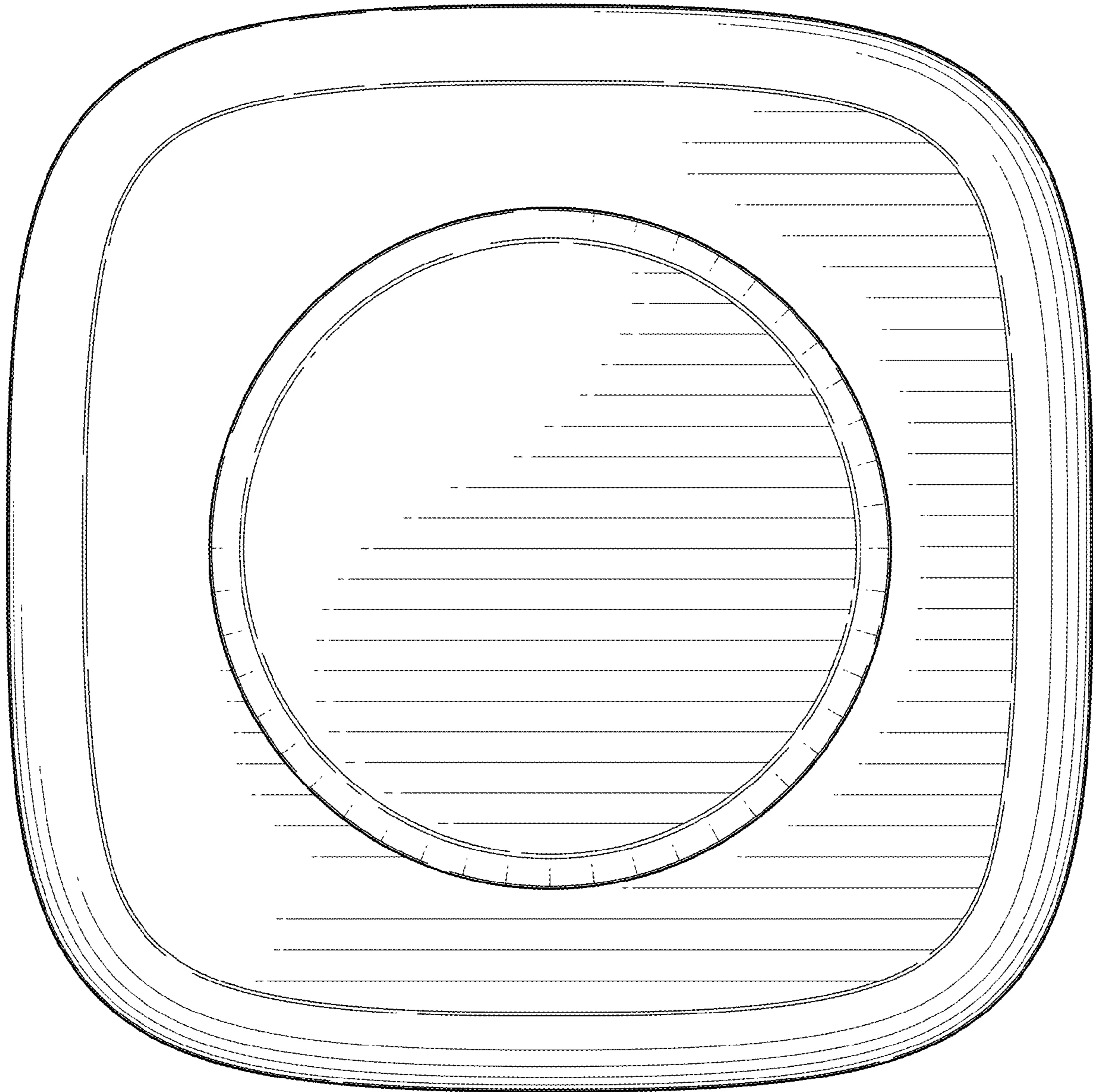

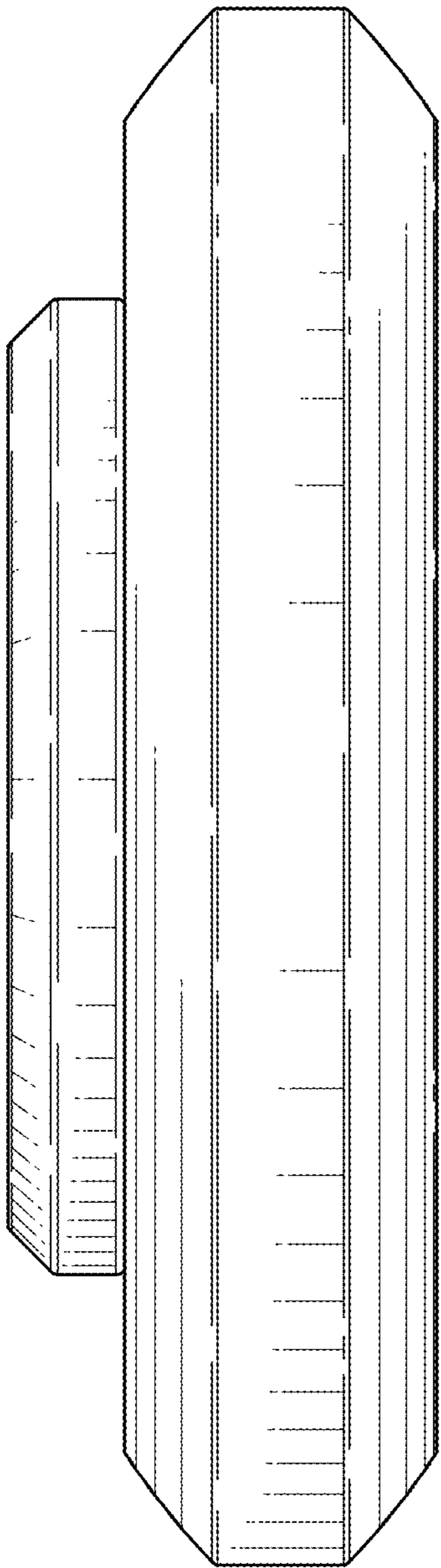

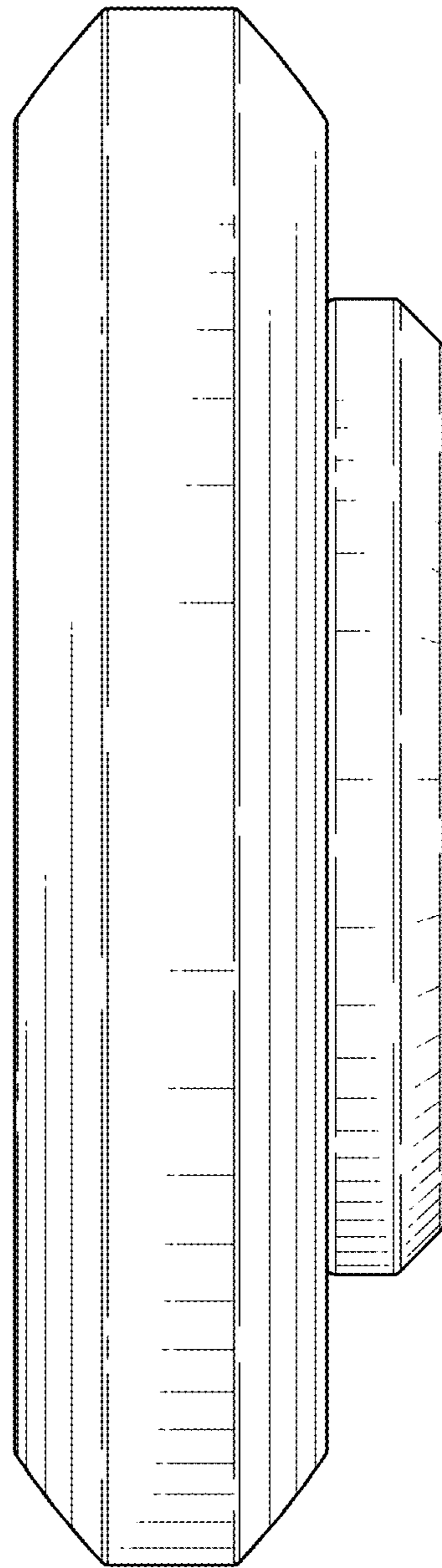

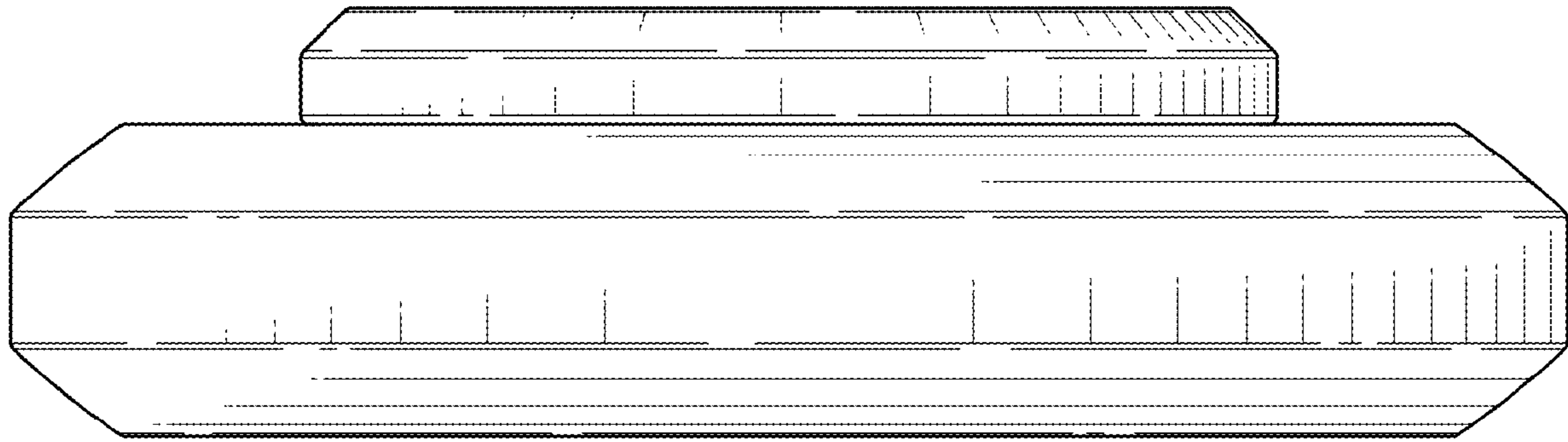

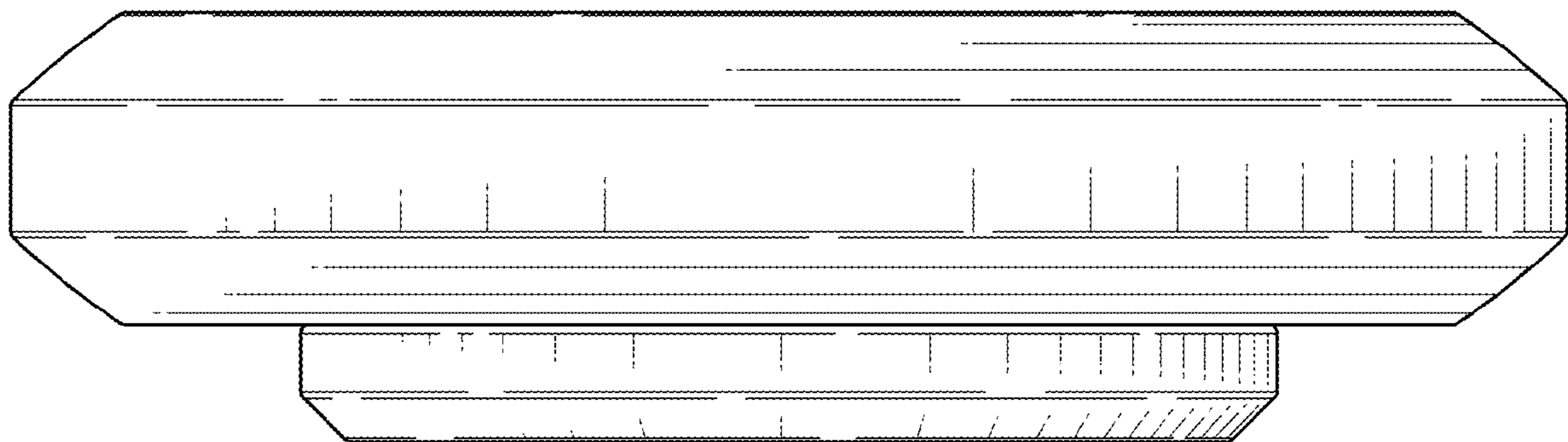
