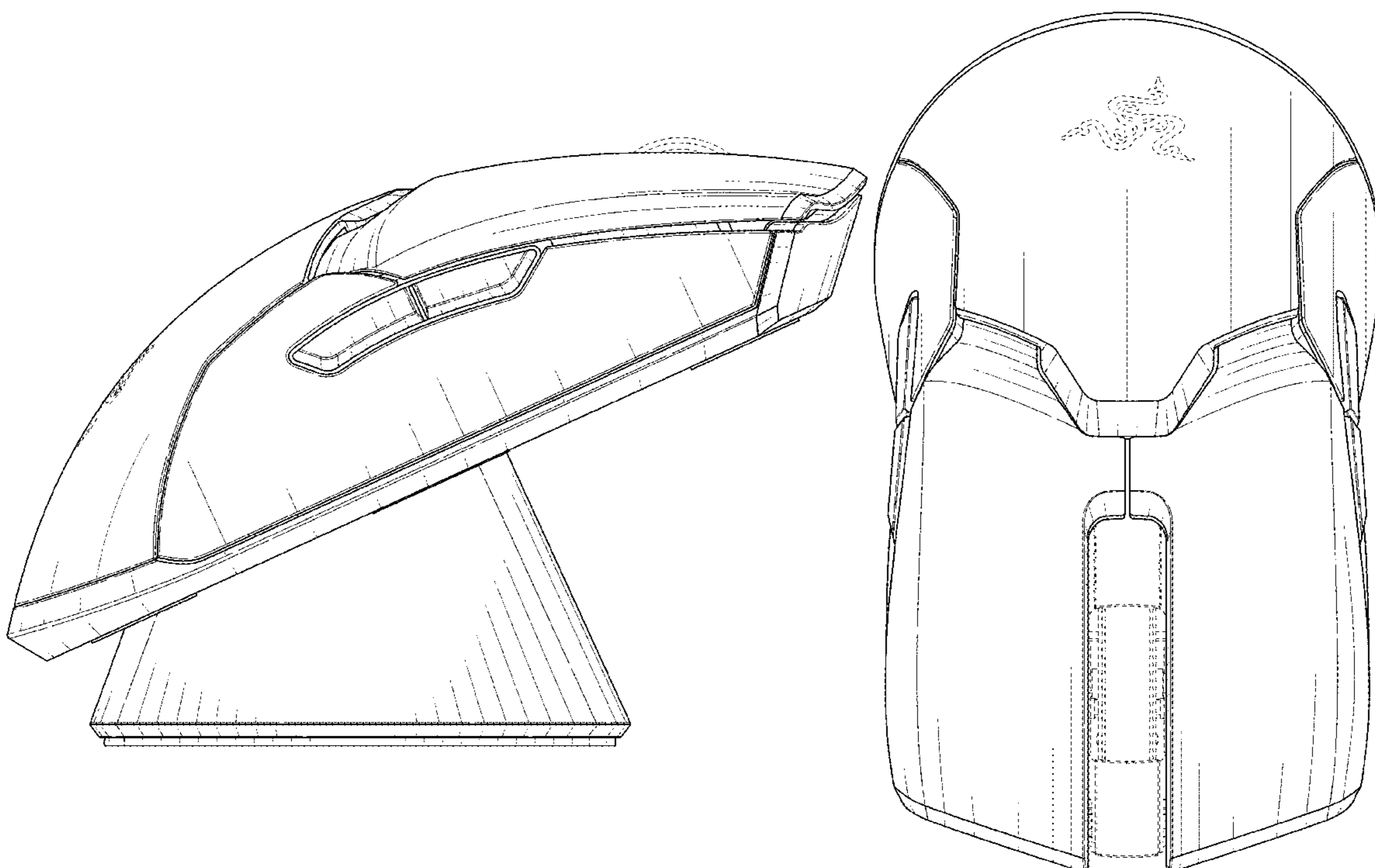
(57) **CLAIM**

I claim the ornamental design for a mouse and dock, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a mouse and dock, showing my new design;  
FIG. 2 is a front elevational view thereof;

FIG. 4 is a left side elevational view thereof;

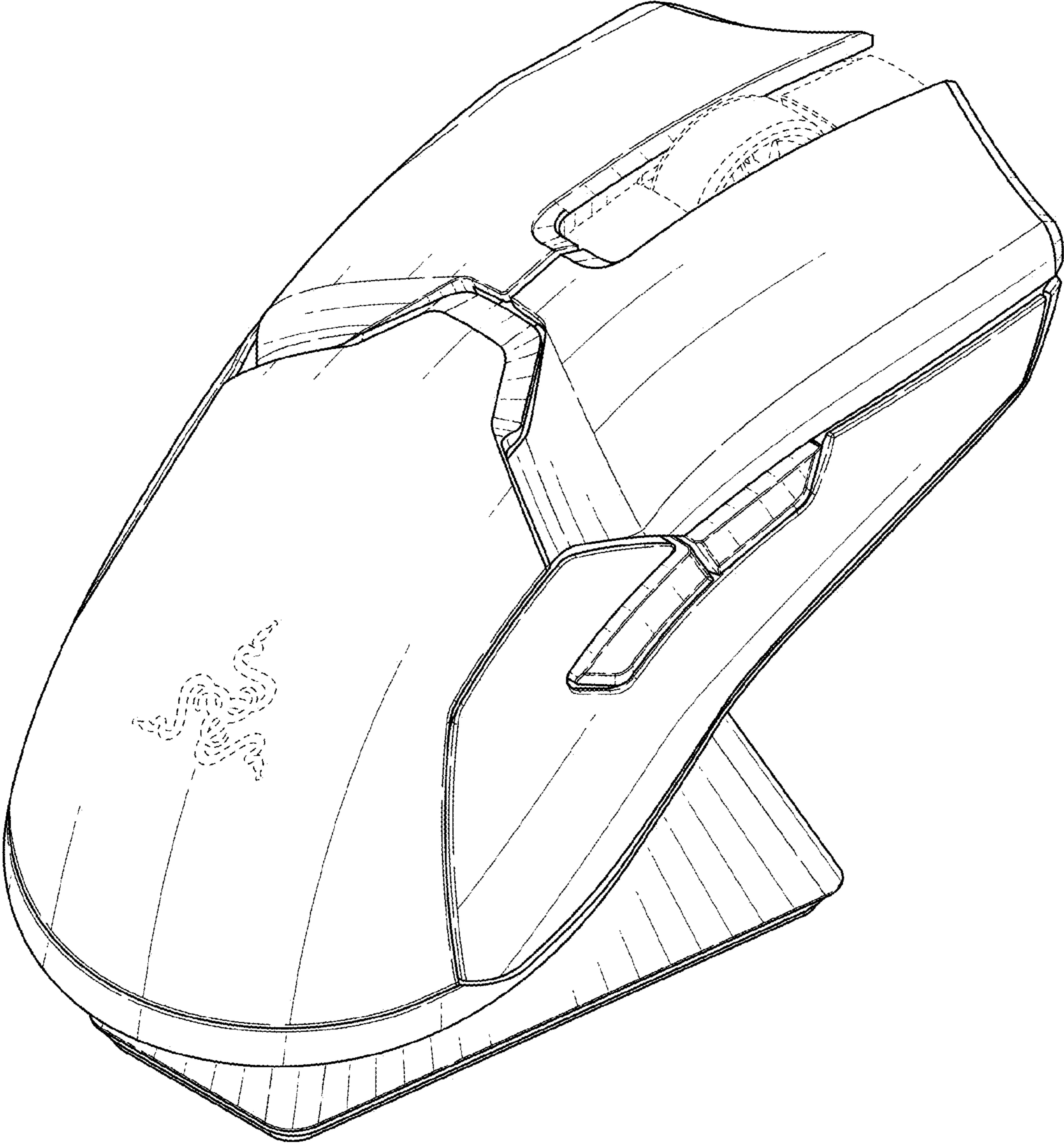

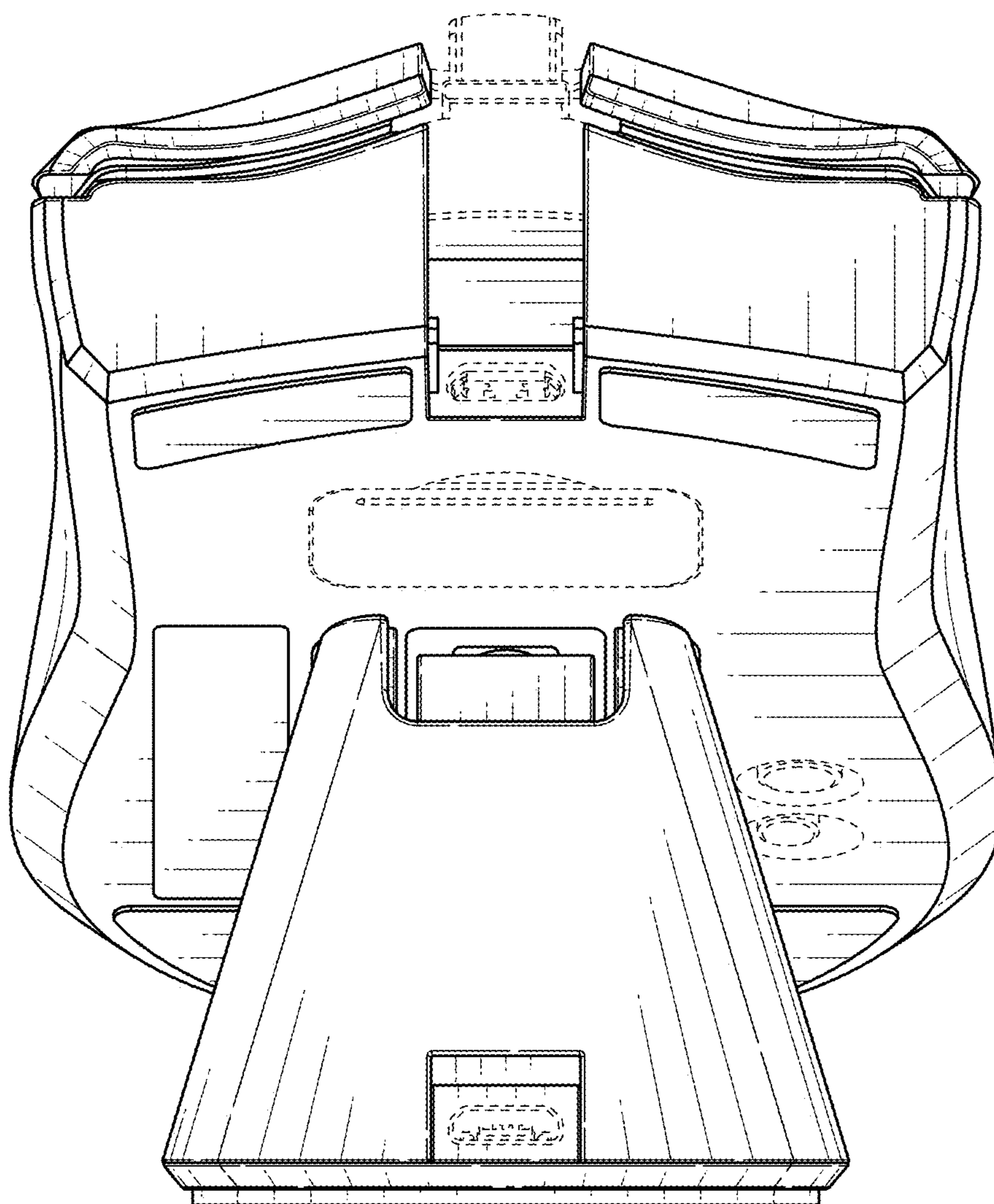

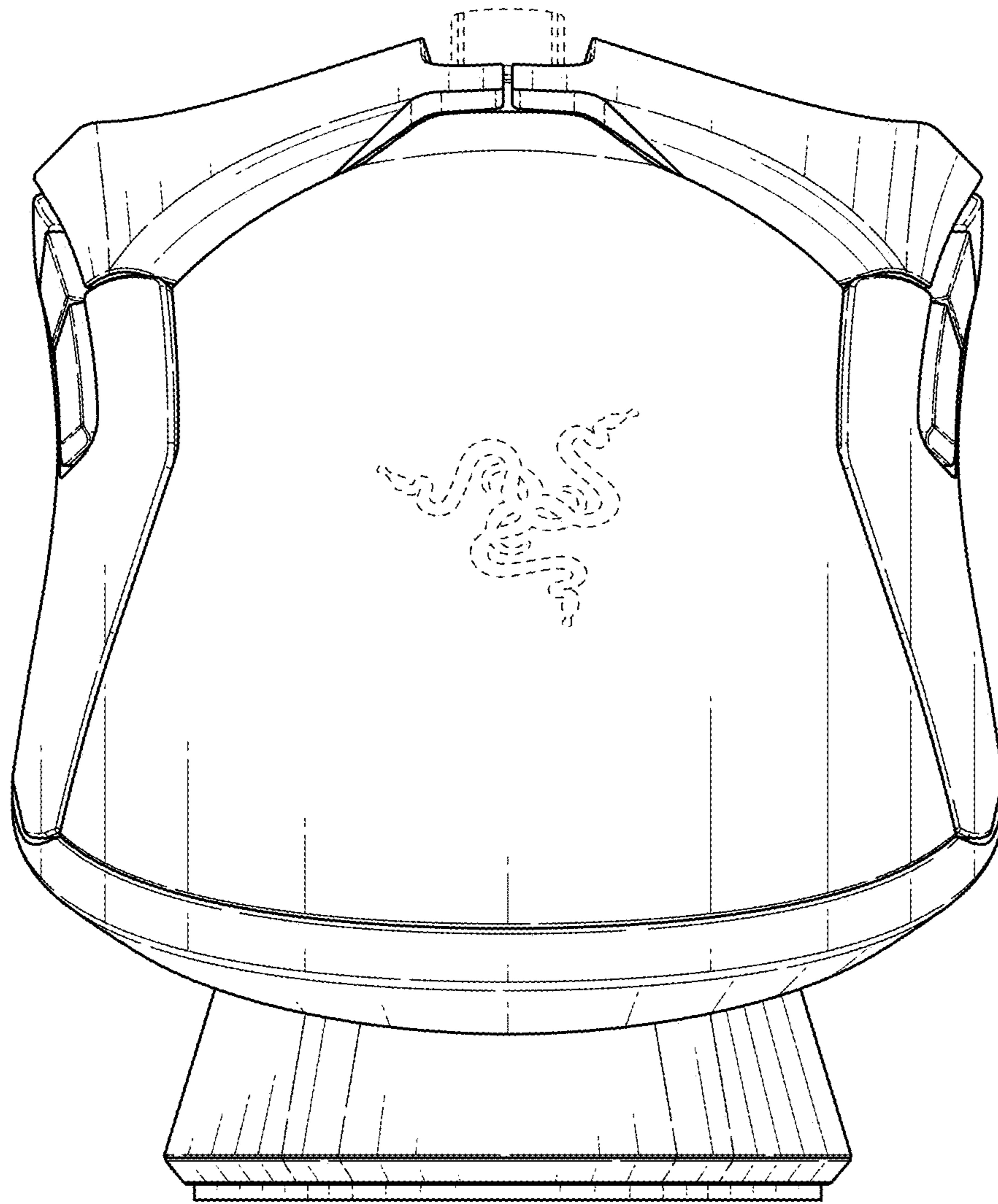

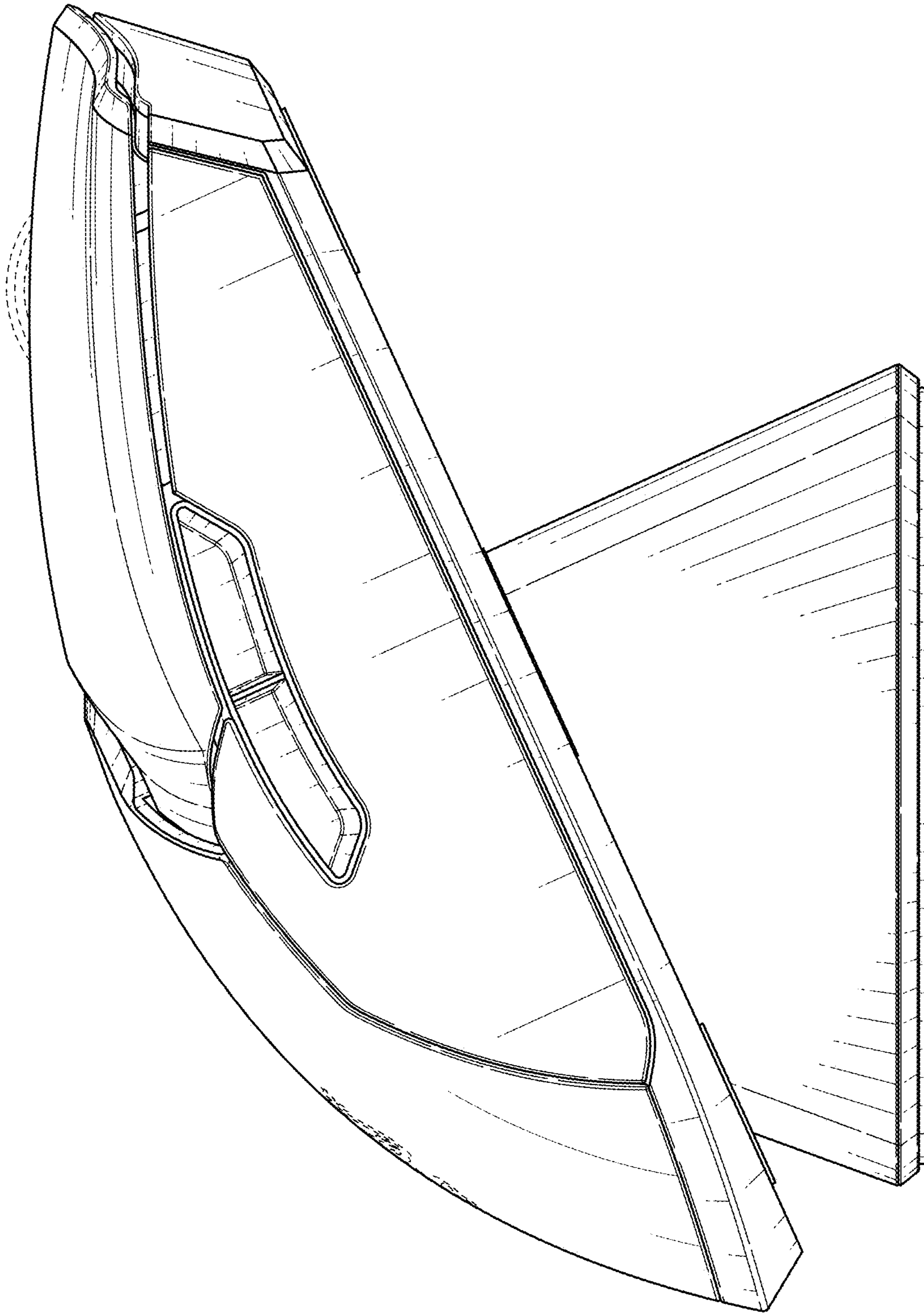

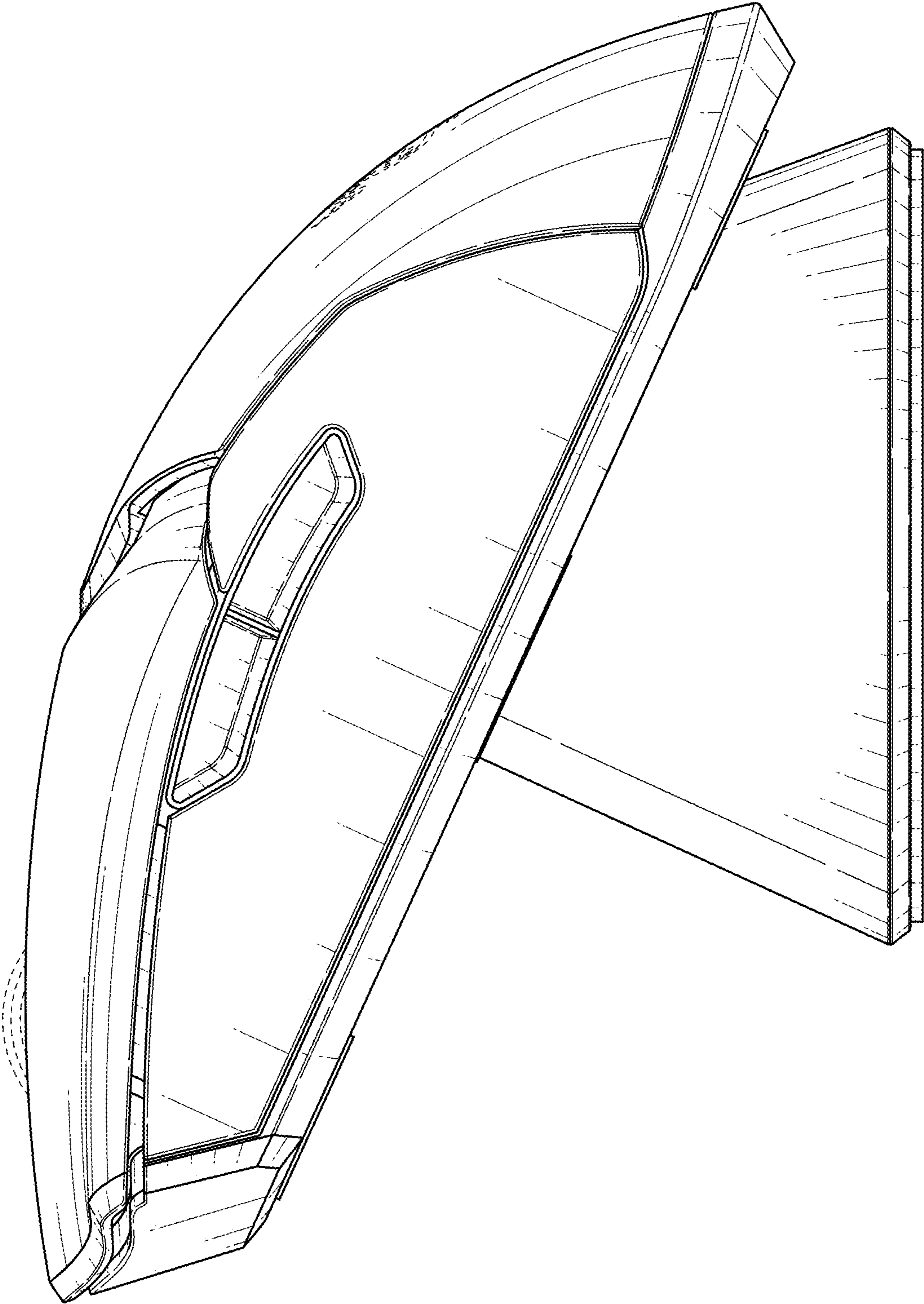

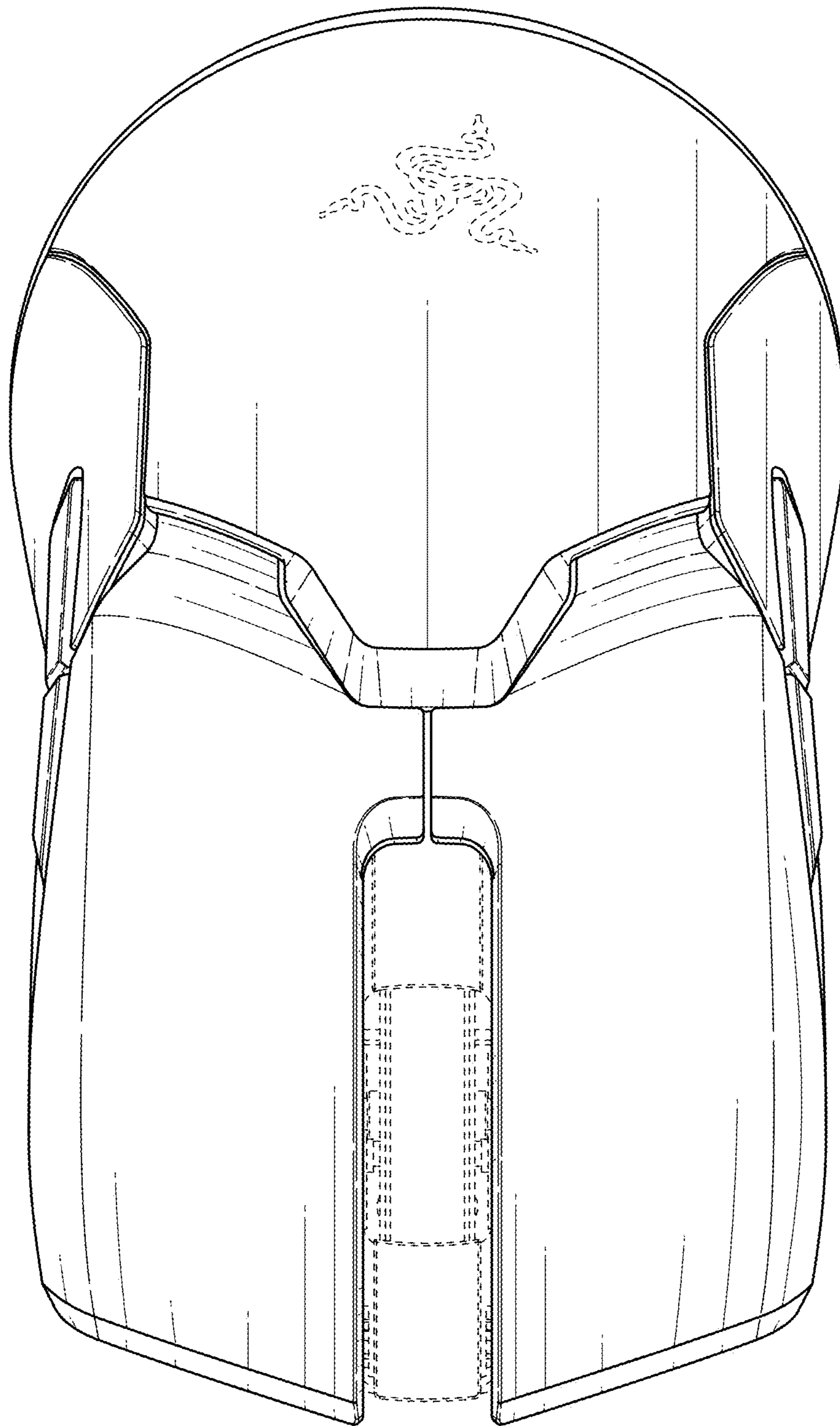

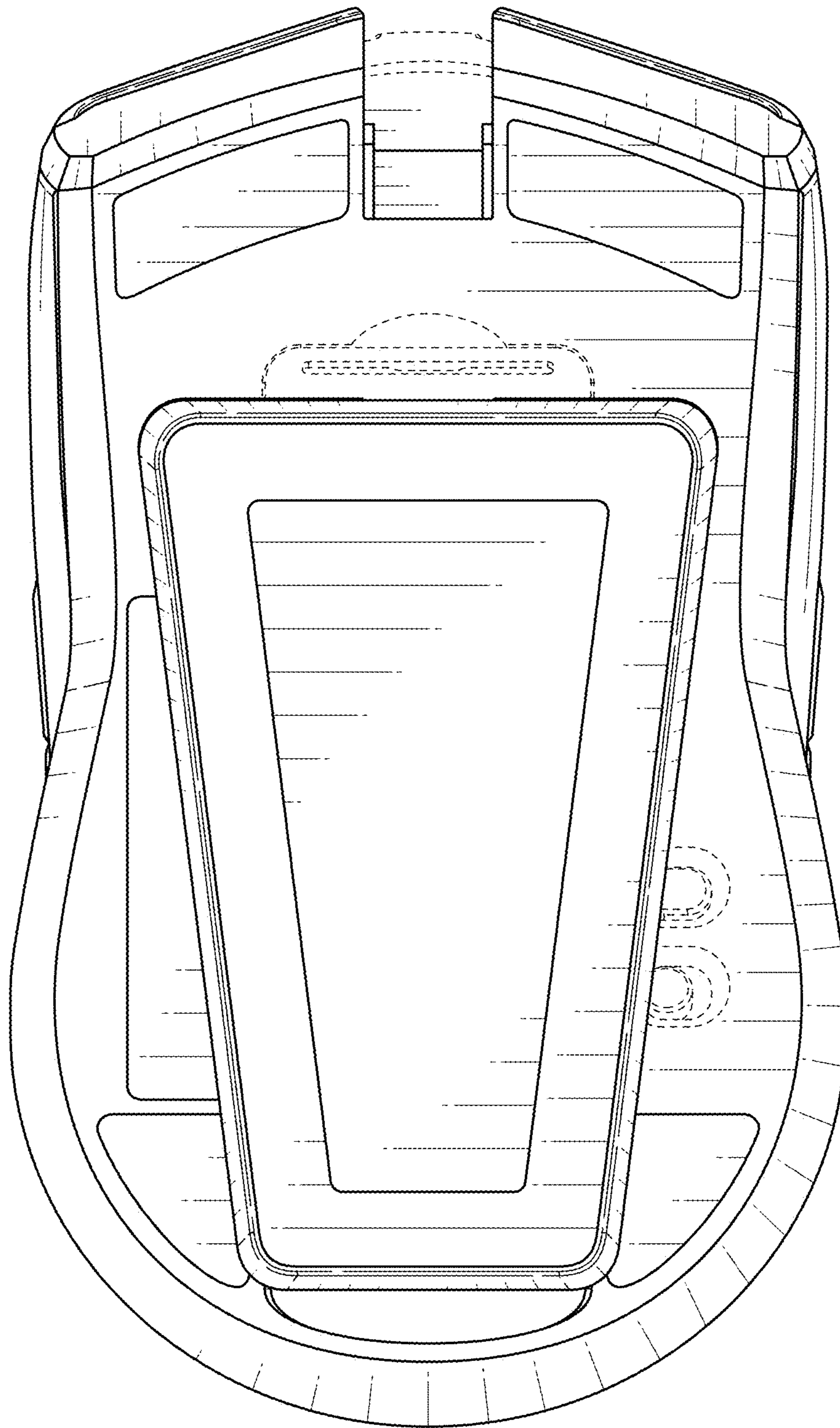
