(57) **CLAIM**

The ornamental design for a display screen or portion thereof with transitional graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the first image in a sequence of a display screen or portion thereof with transitional graphical user interface showing our new design according to a first embodiment;

FIG. 2 is the second image thereof;

FIG. 4 is a front view of the first image in a sequence of a display screen or portion thereof with transitional graphical user interface showing our new design according to a second embodiment;

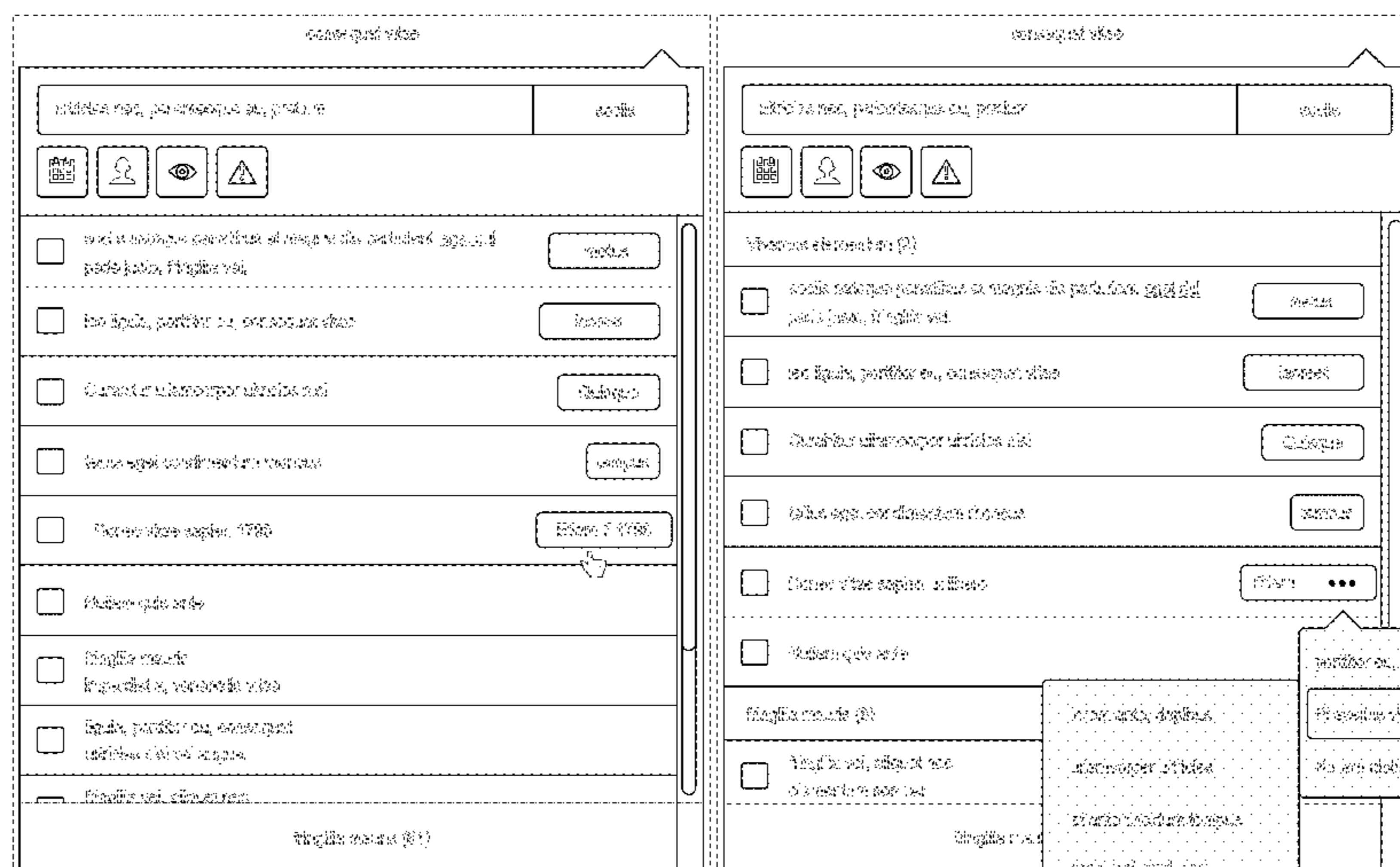
FIG. 5 is the second image thereof; and,

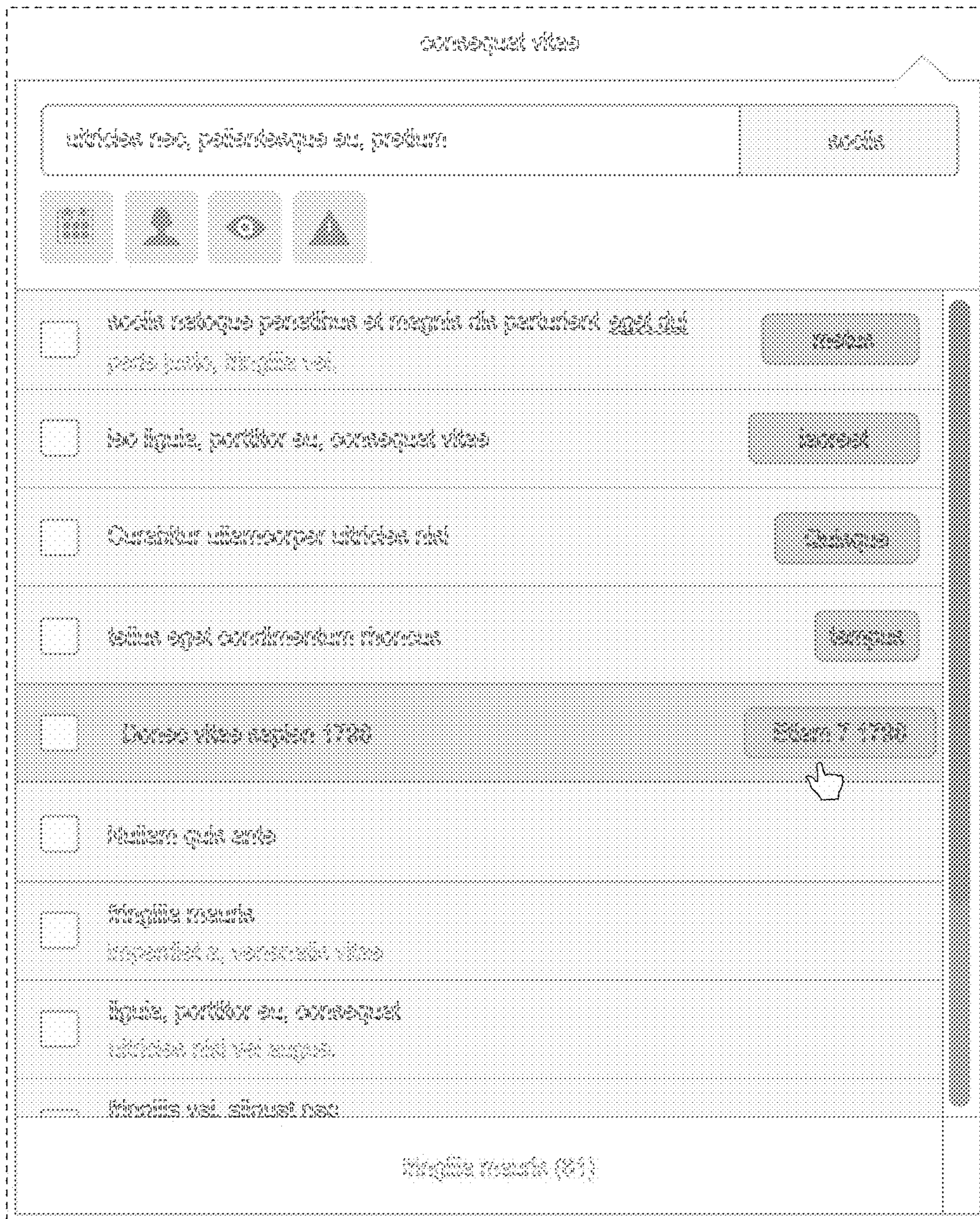

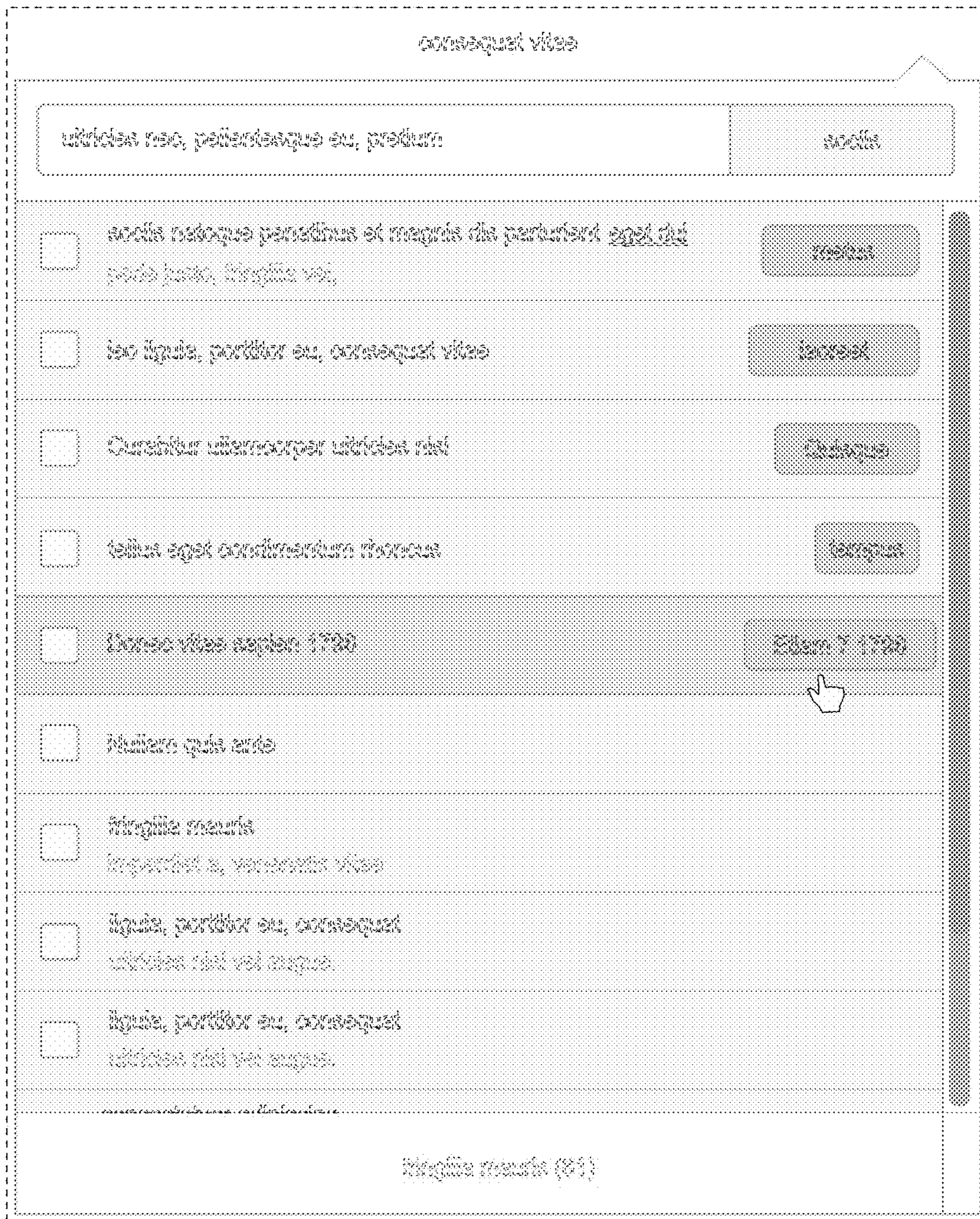

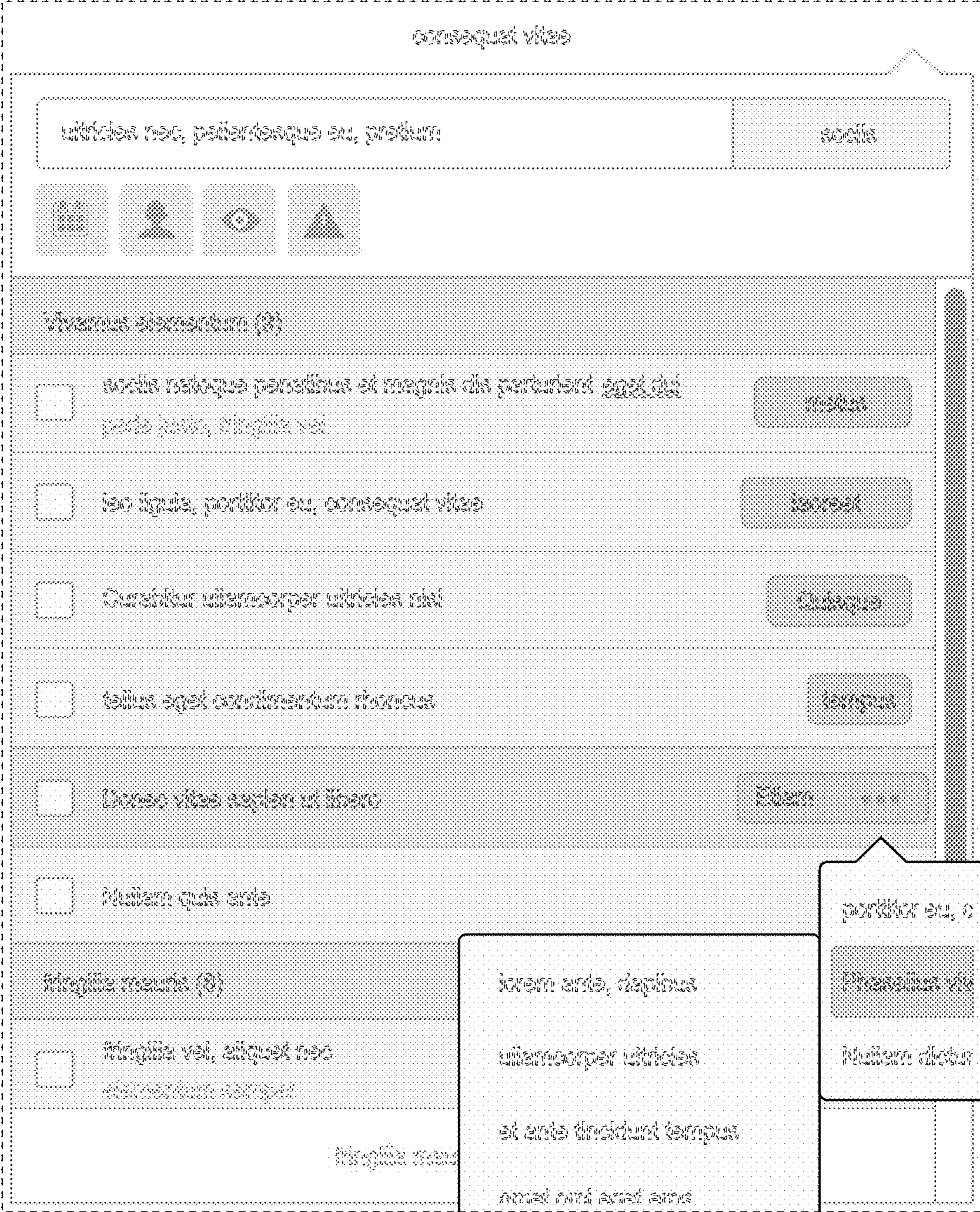

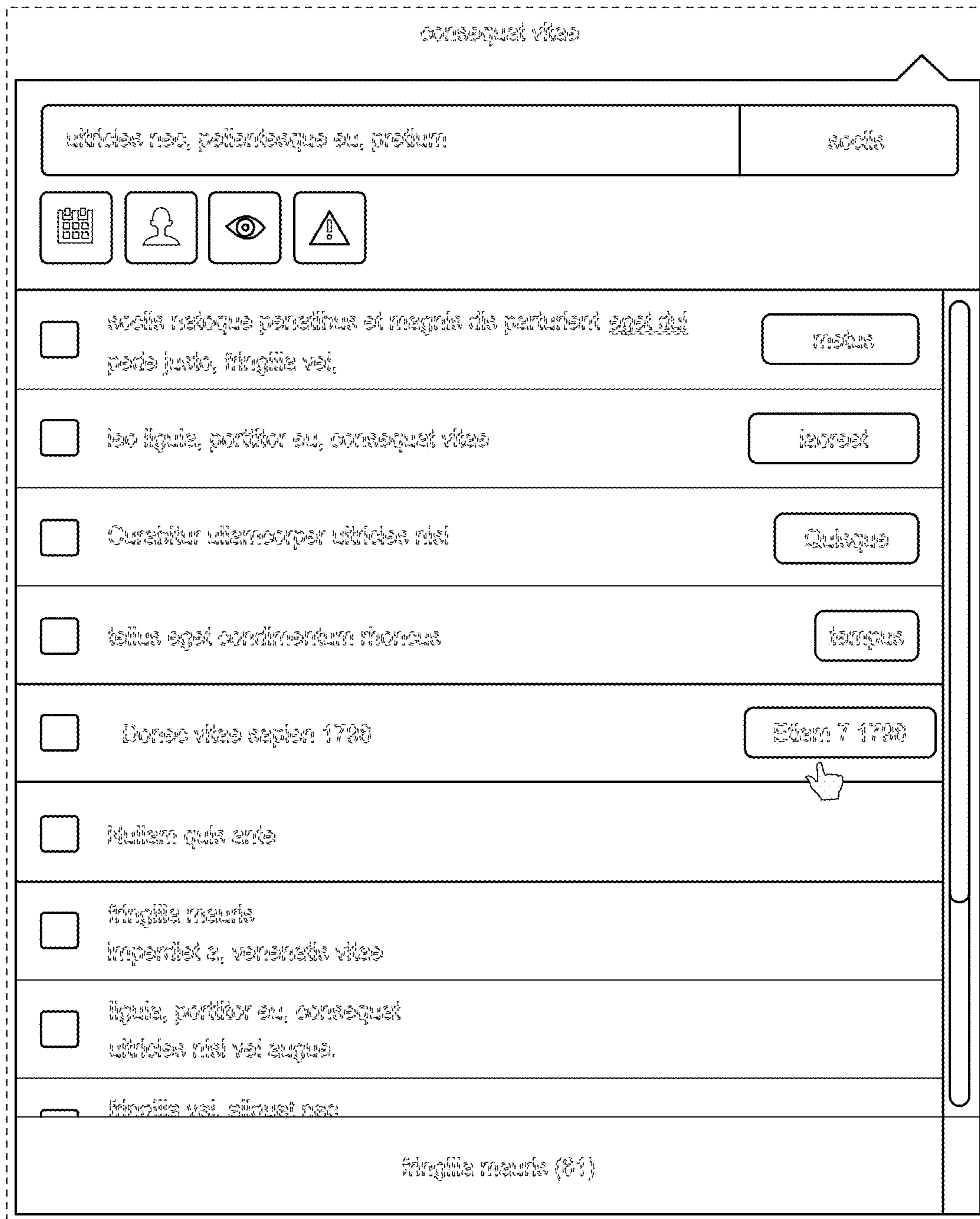

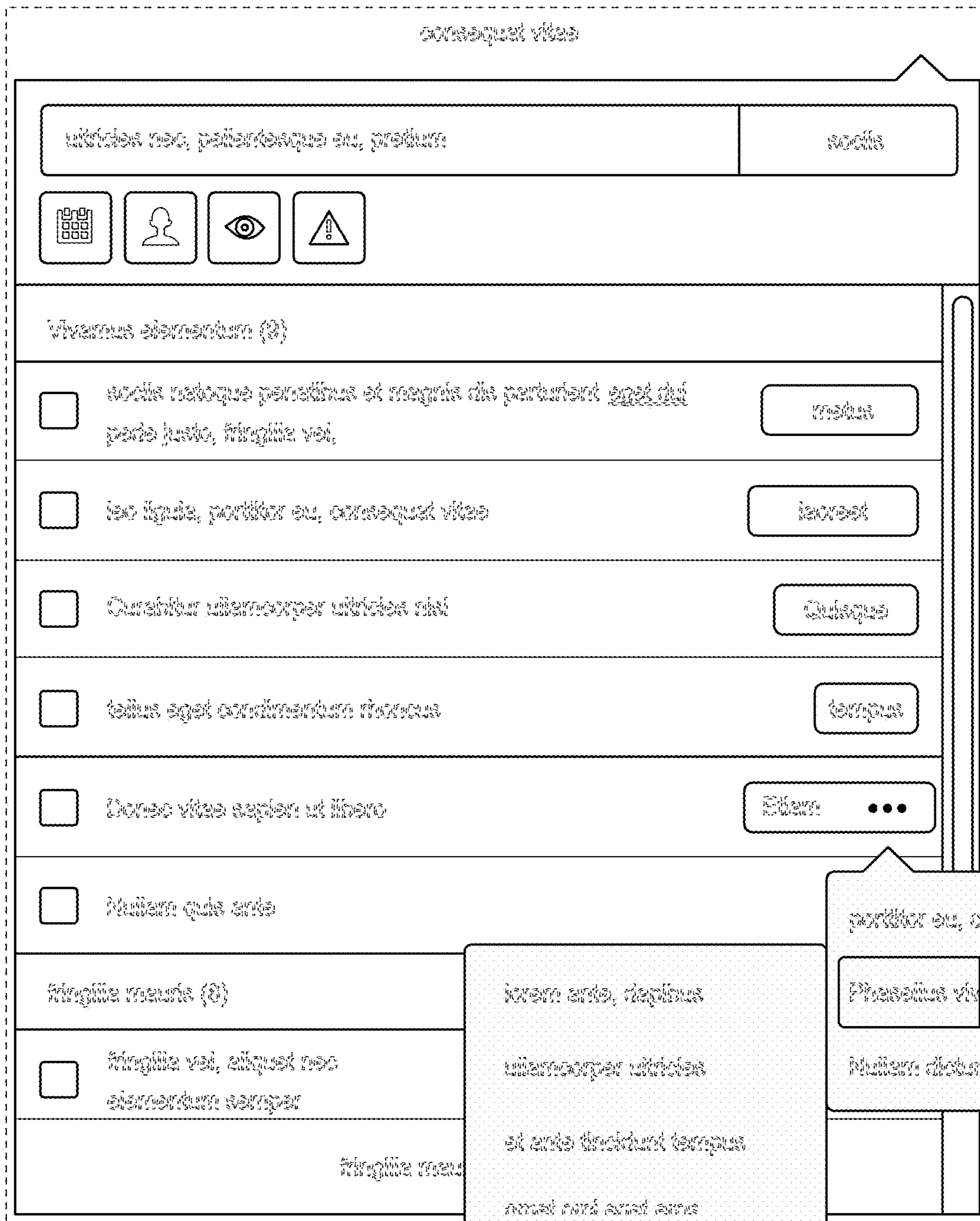
