(57) **CLAIM**

The ornamental design for a display screen with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of one embodiment of a display screen with graphical user interface; and, FIG. 2 is a front view of a second embodiment thereof. The outer broken-line perimeter illustrates a display screen and forms no part of the claimed design. The remaining broken lines illustrate portions of the graphical user interface and form no part of the claimed design.

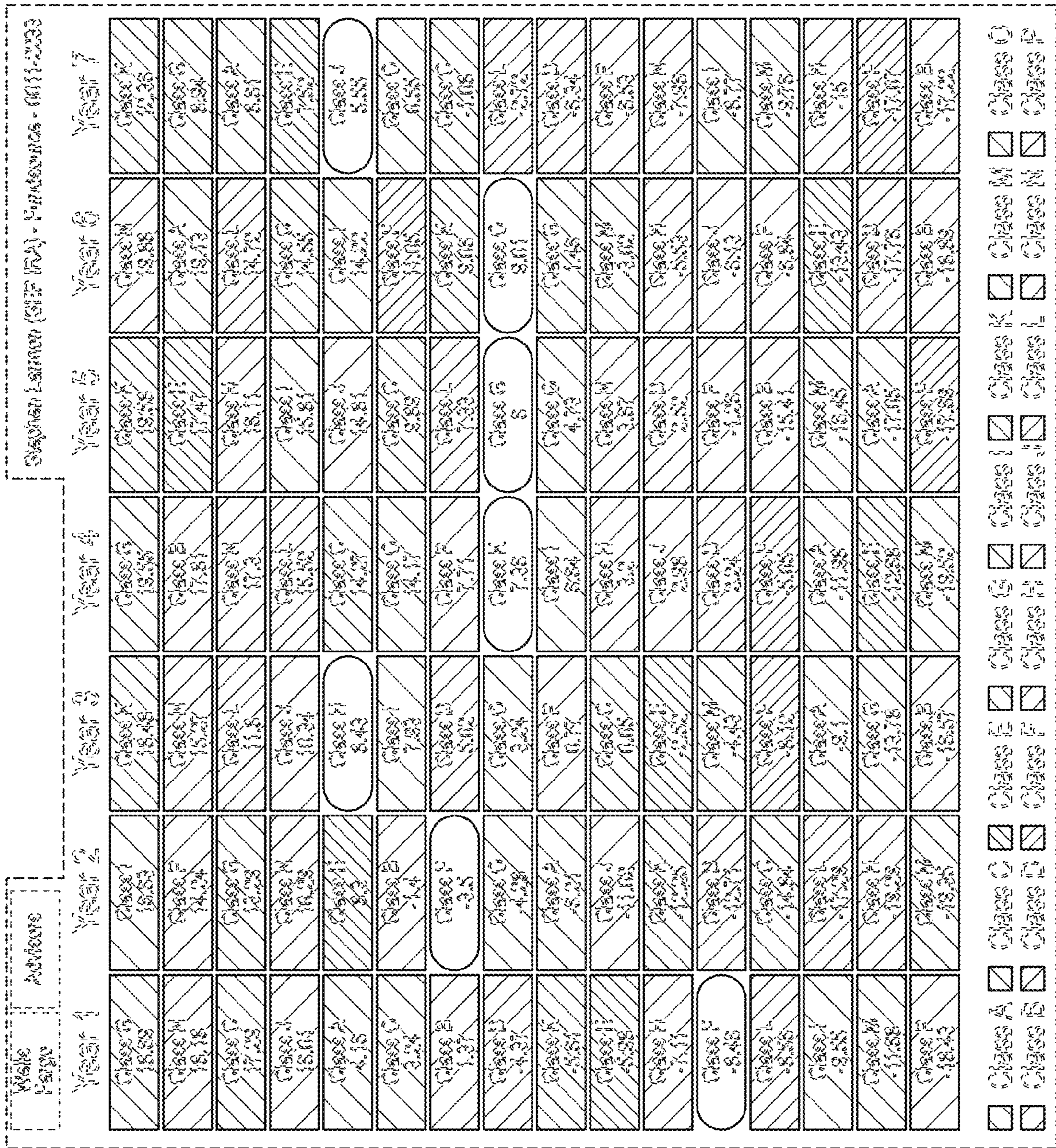

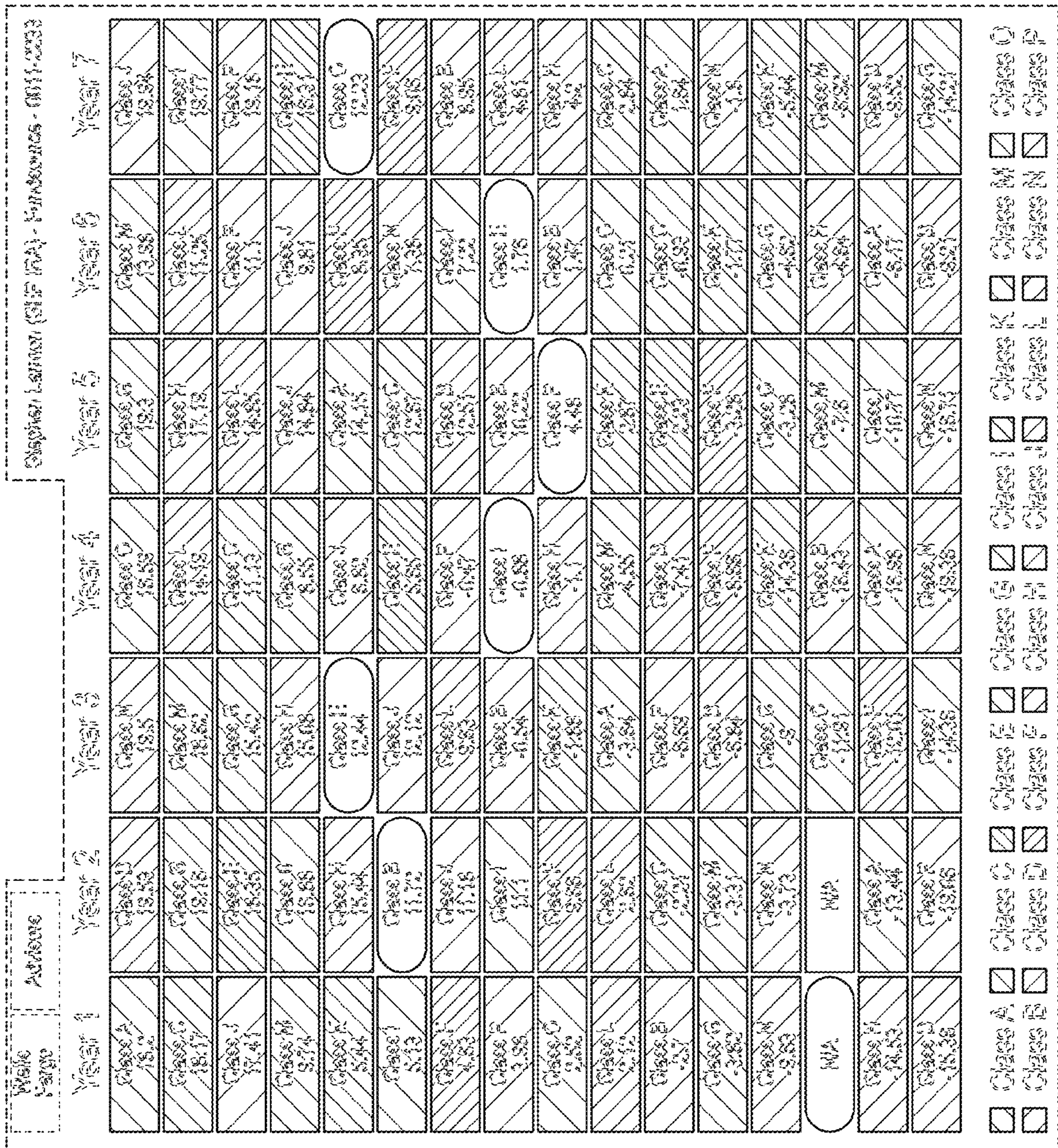
