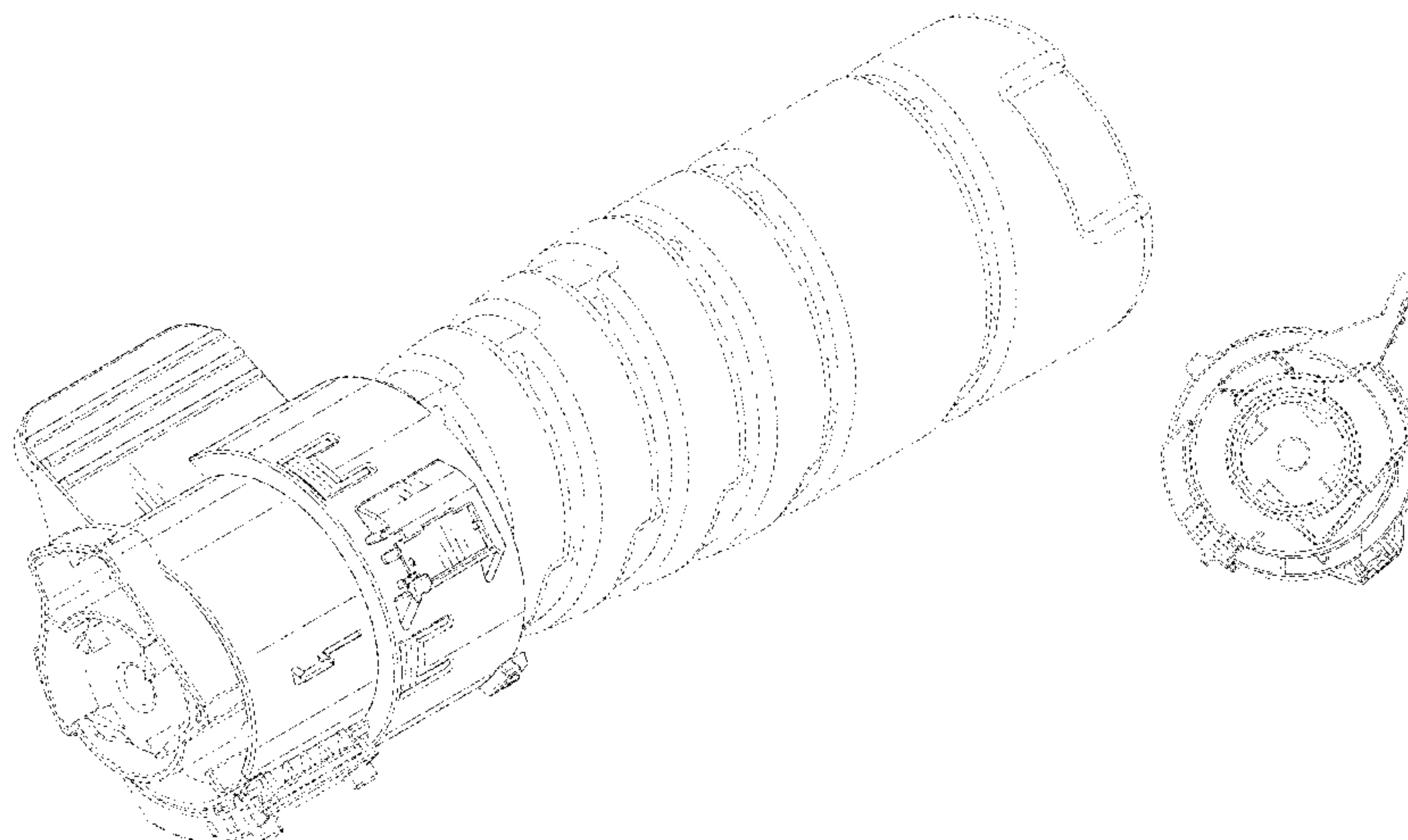
(57) **CLAIM**

The ornamental design for a toner cartridge, as shown and described.

DESCRIPTION

FIG. 1 is a front, left bottom perspective view of a toner cartridge showing an embodiment of our new design; FIG. 2 is a rear, left, top perspective view thereof; FIG. 3 is a front view thereof; FIG. 4 is a rear side view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a right side view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. The broken lines shown in the drawings depict portions of the toner cartridge that form no part of the claimed design. The dashed-dotted lines define the bounds of the claimed design and form no part thereof.

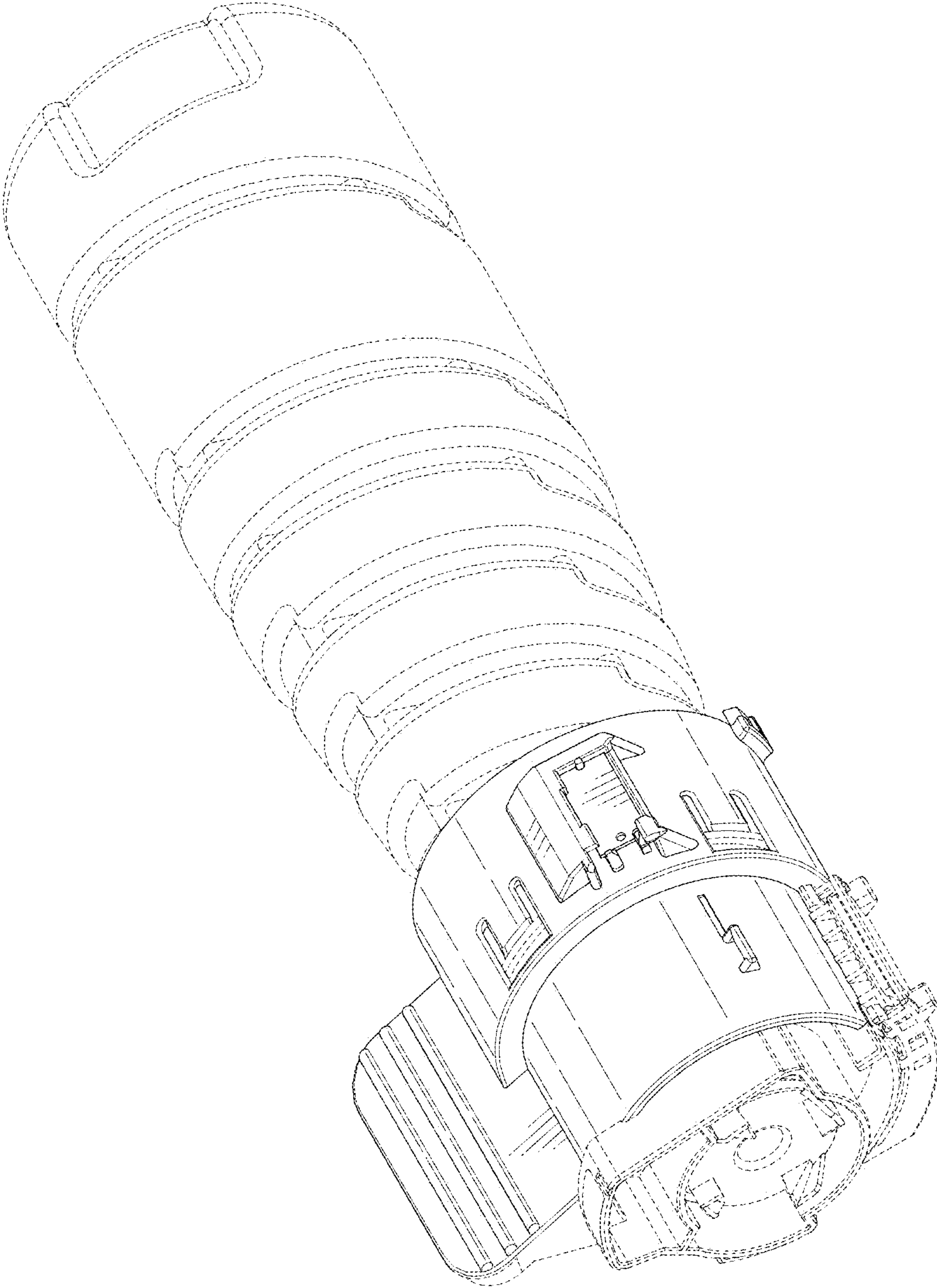

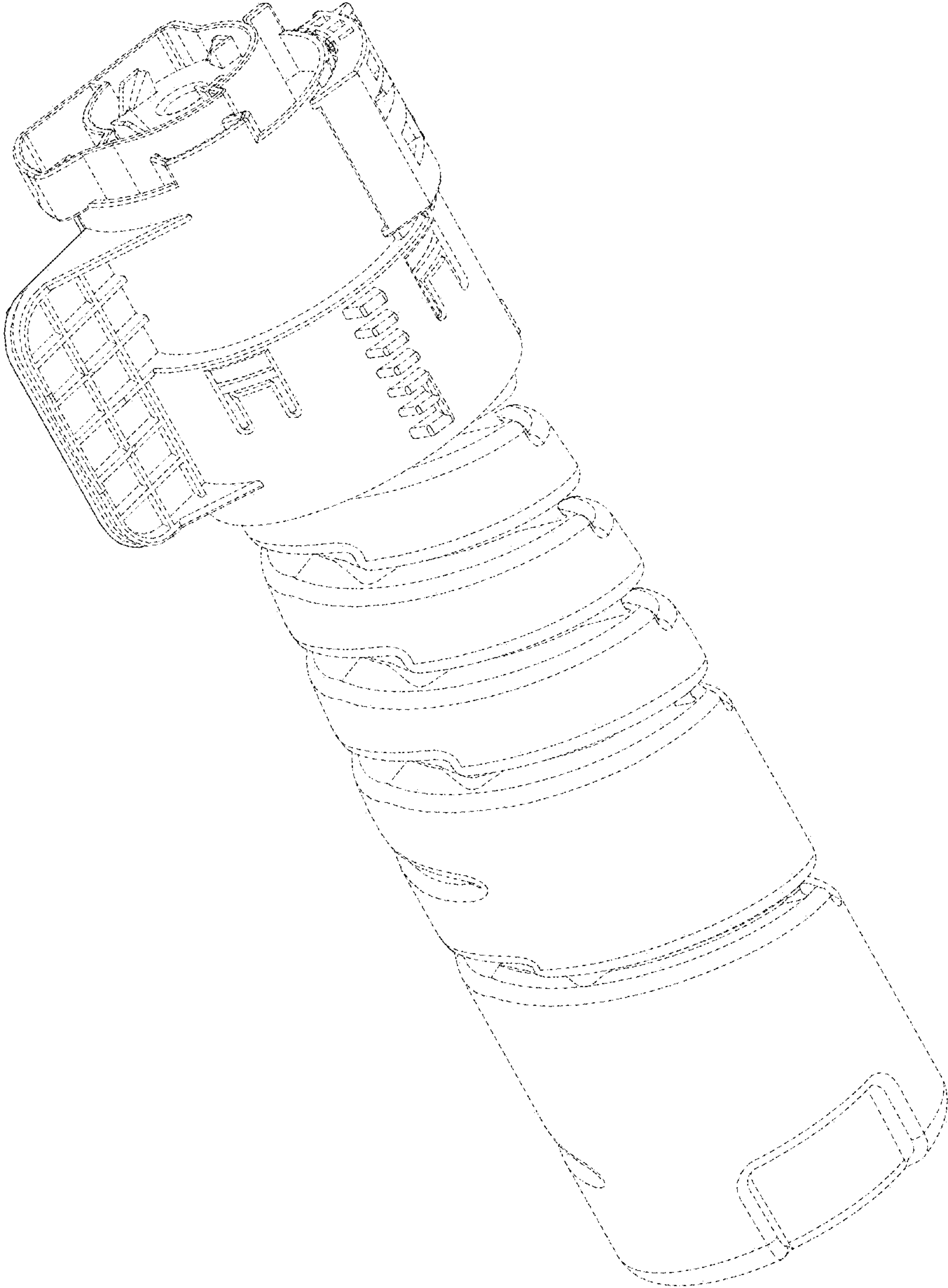

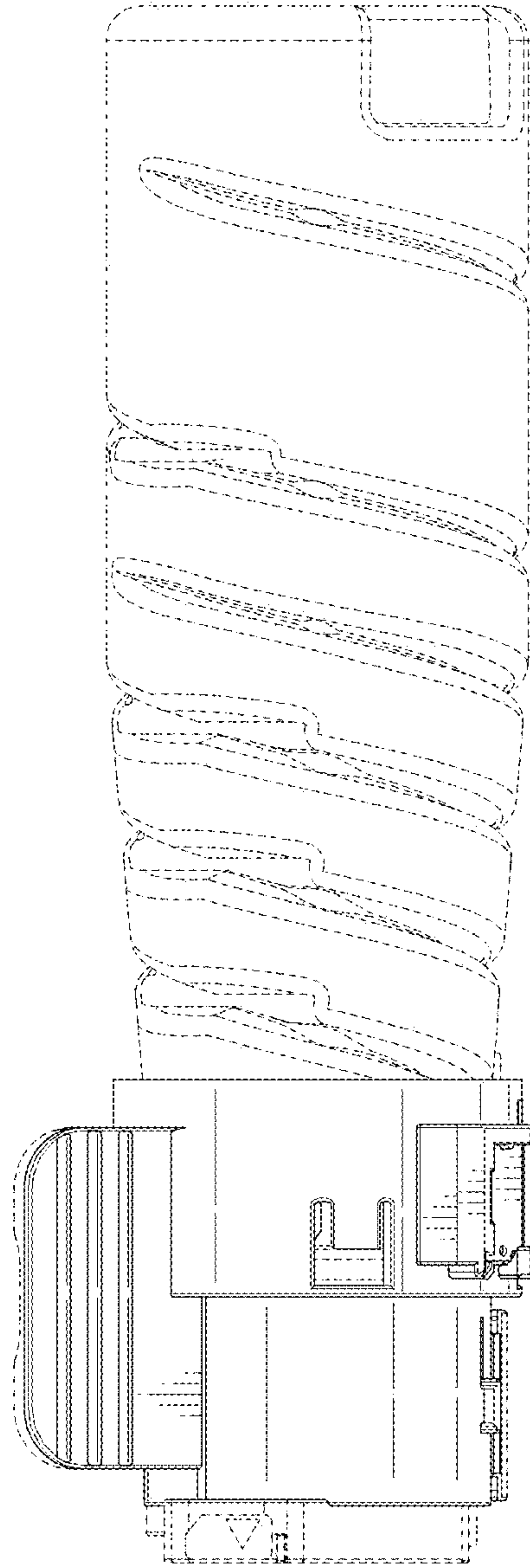

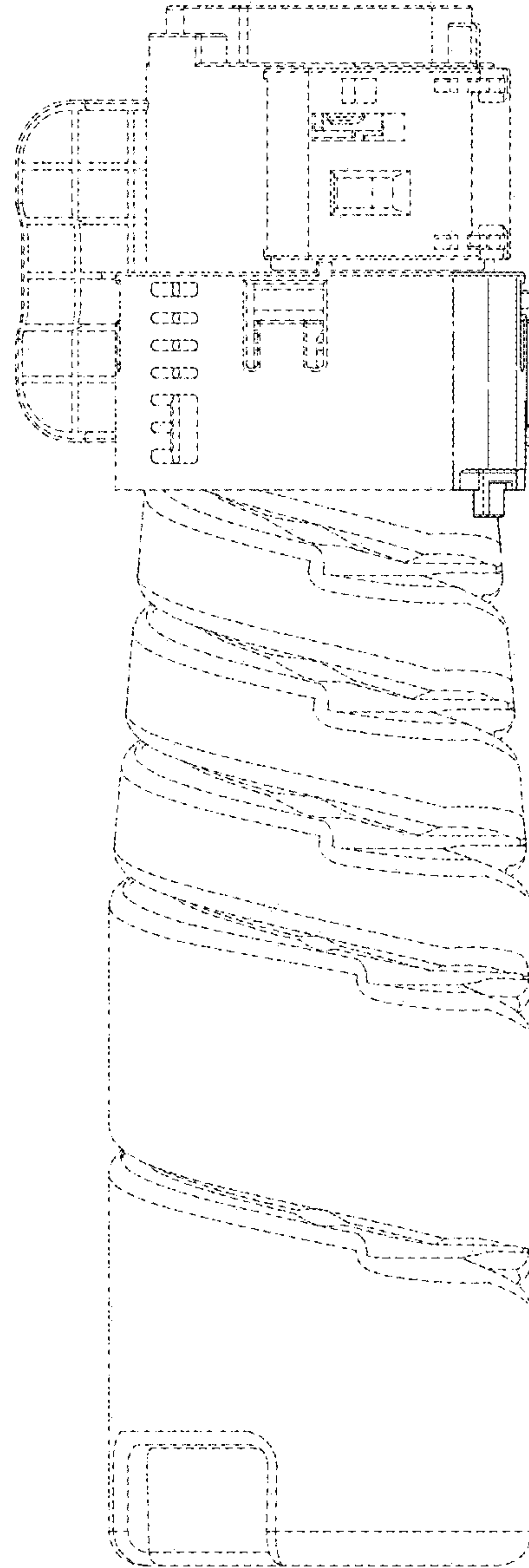

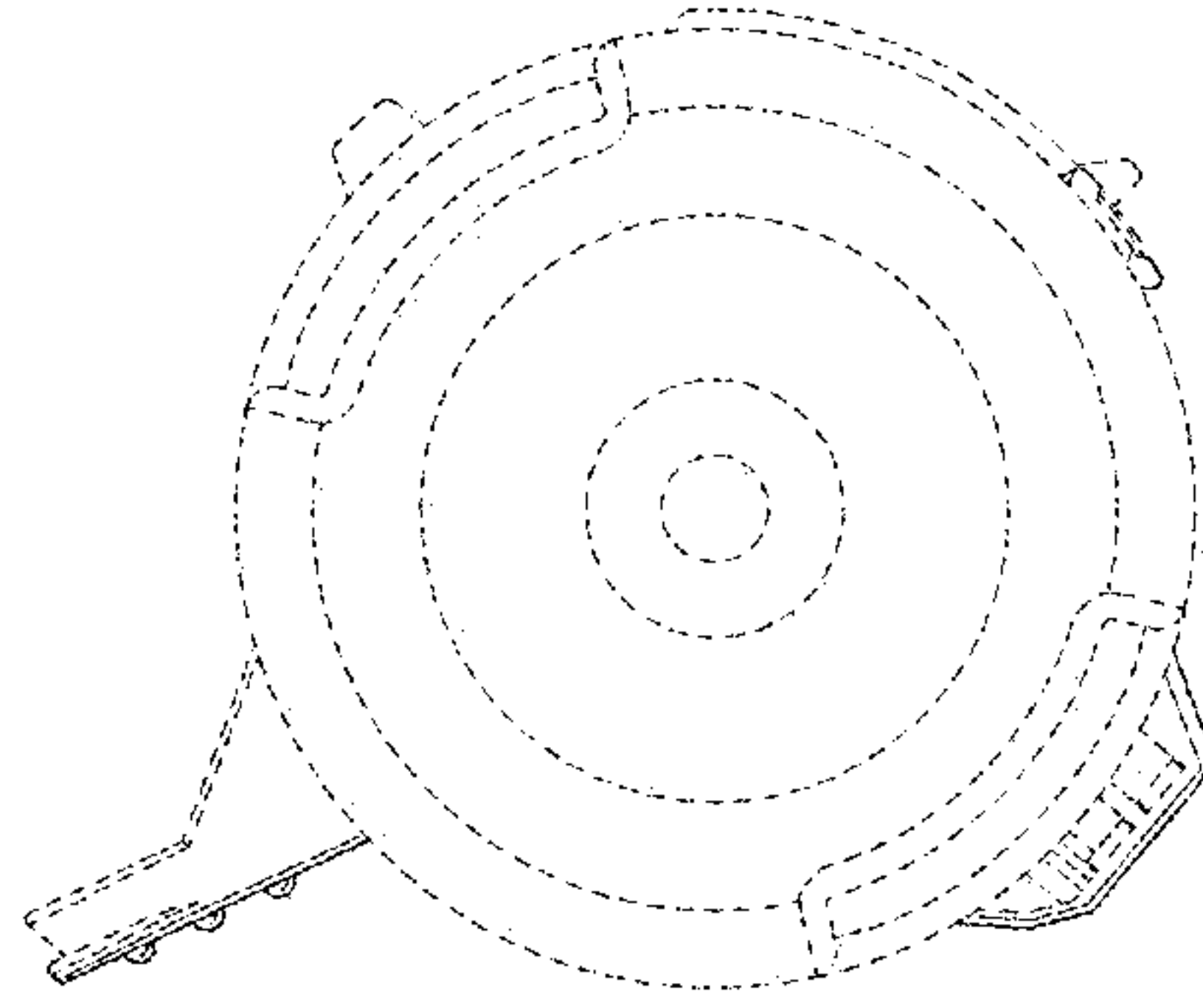

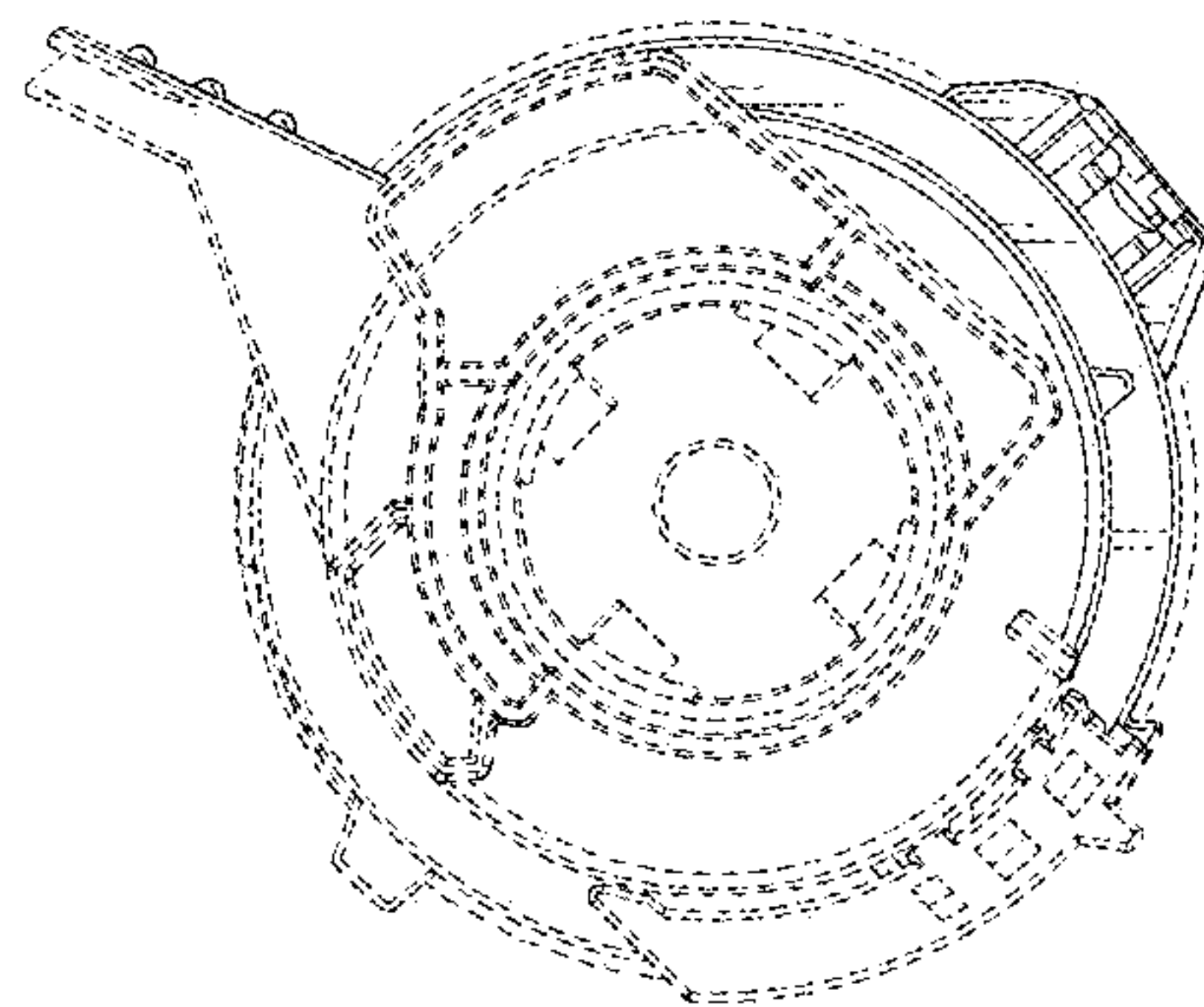

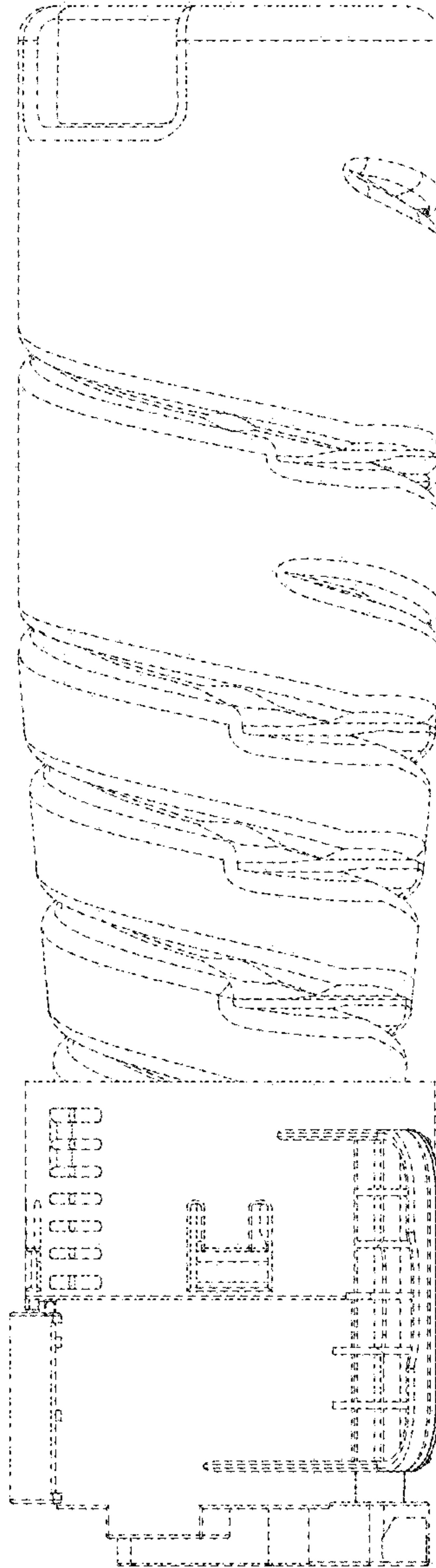
