The ornamental design for an electronic gaming console, as shown and described.

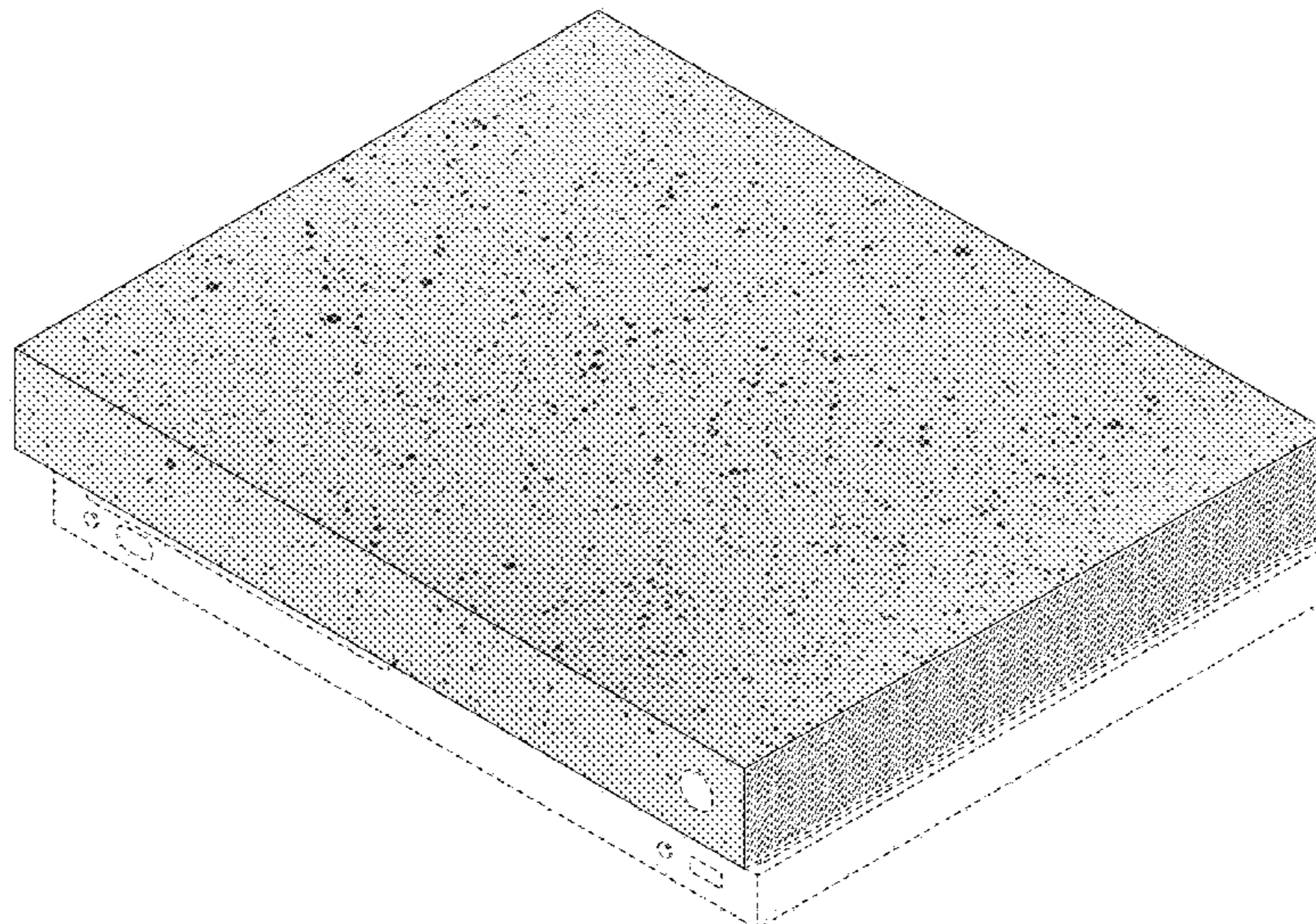
DESCRIPTION

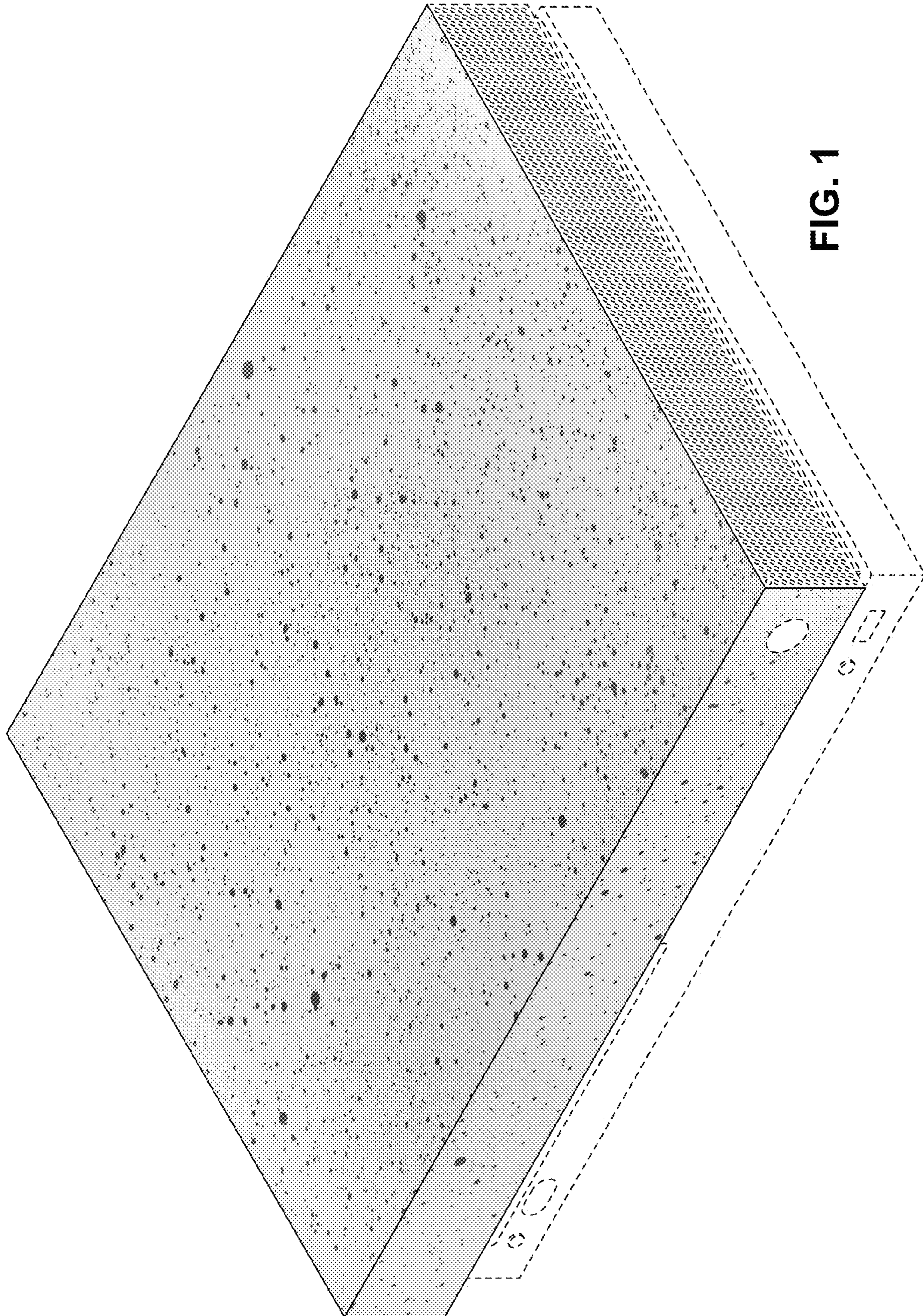

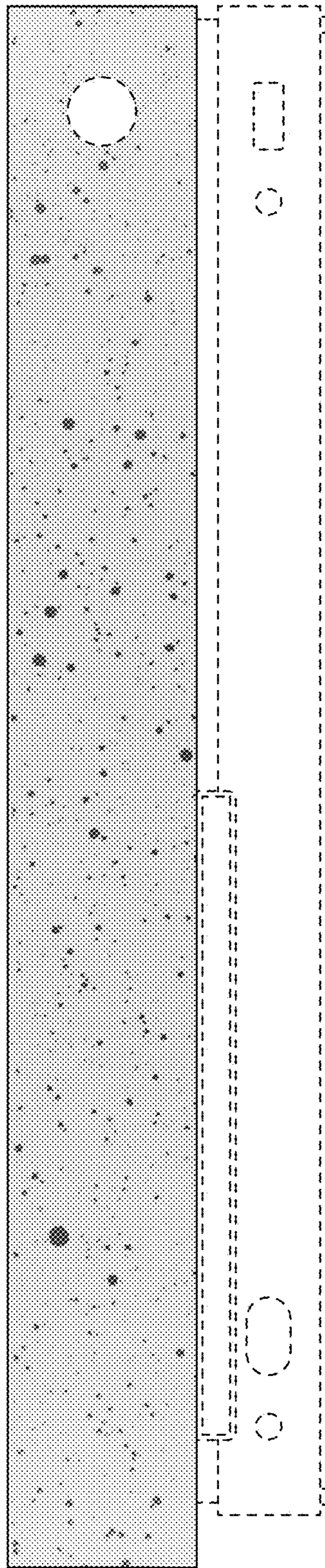

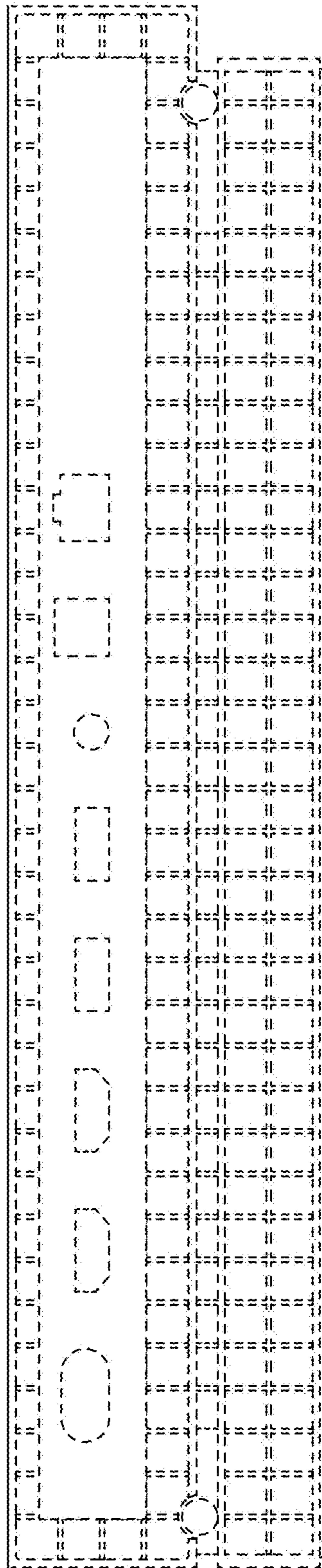

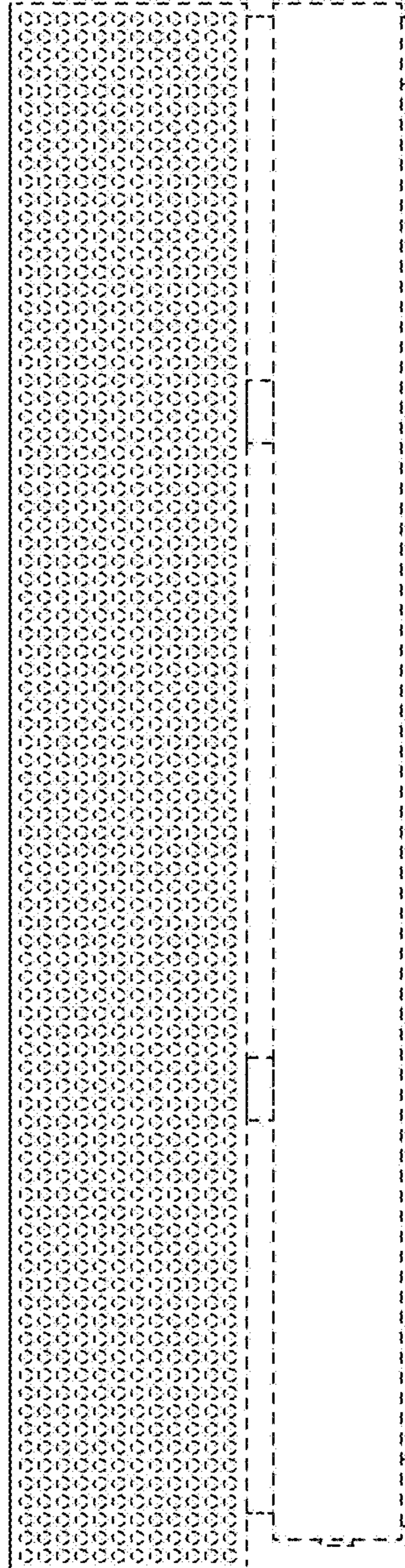

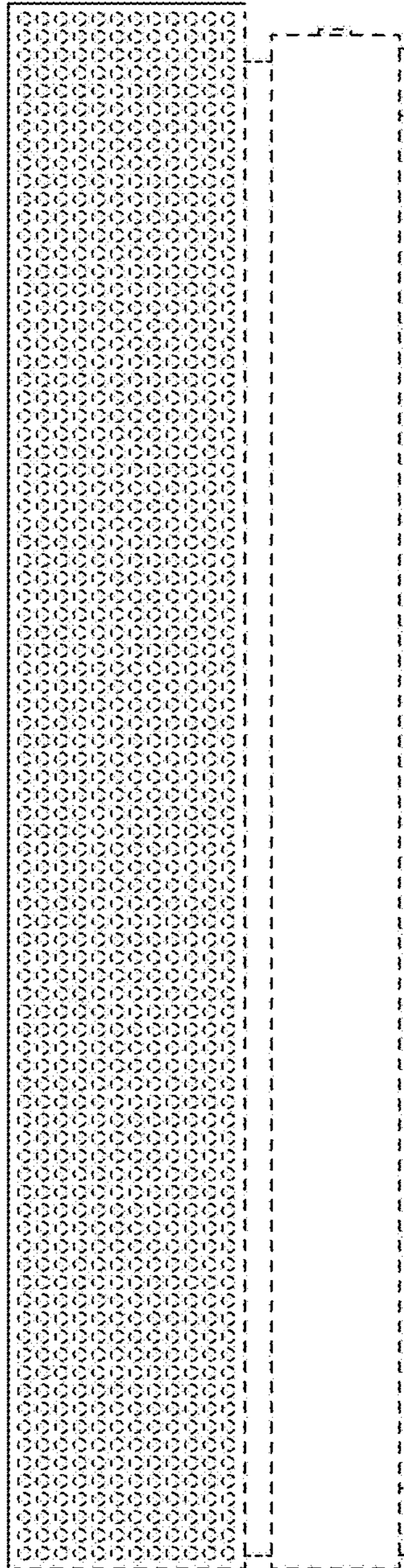

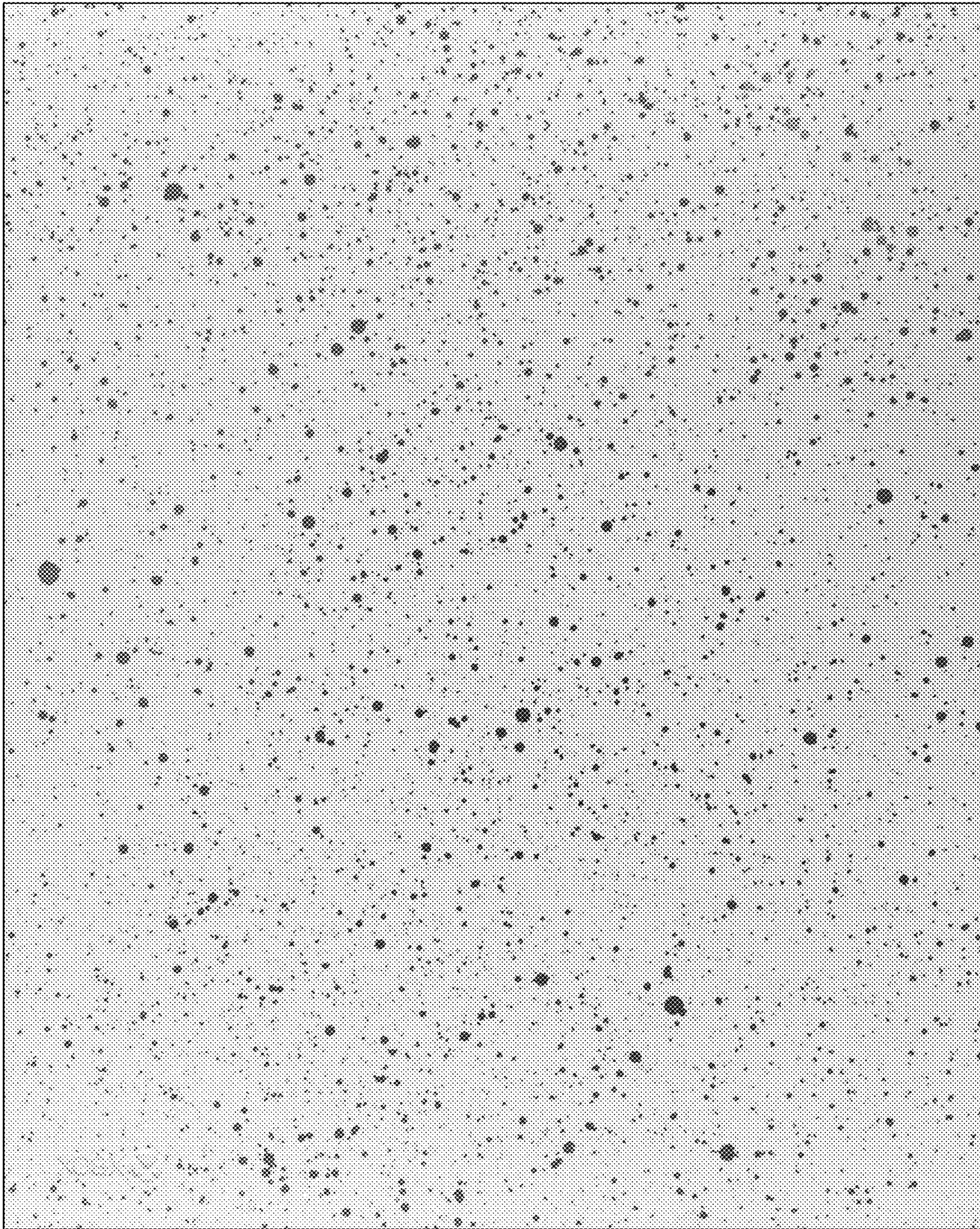

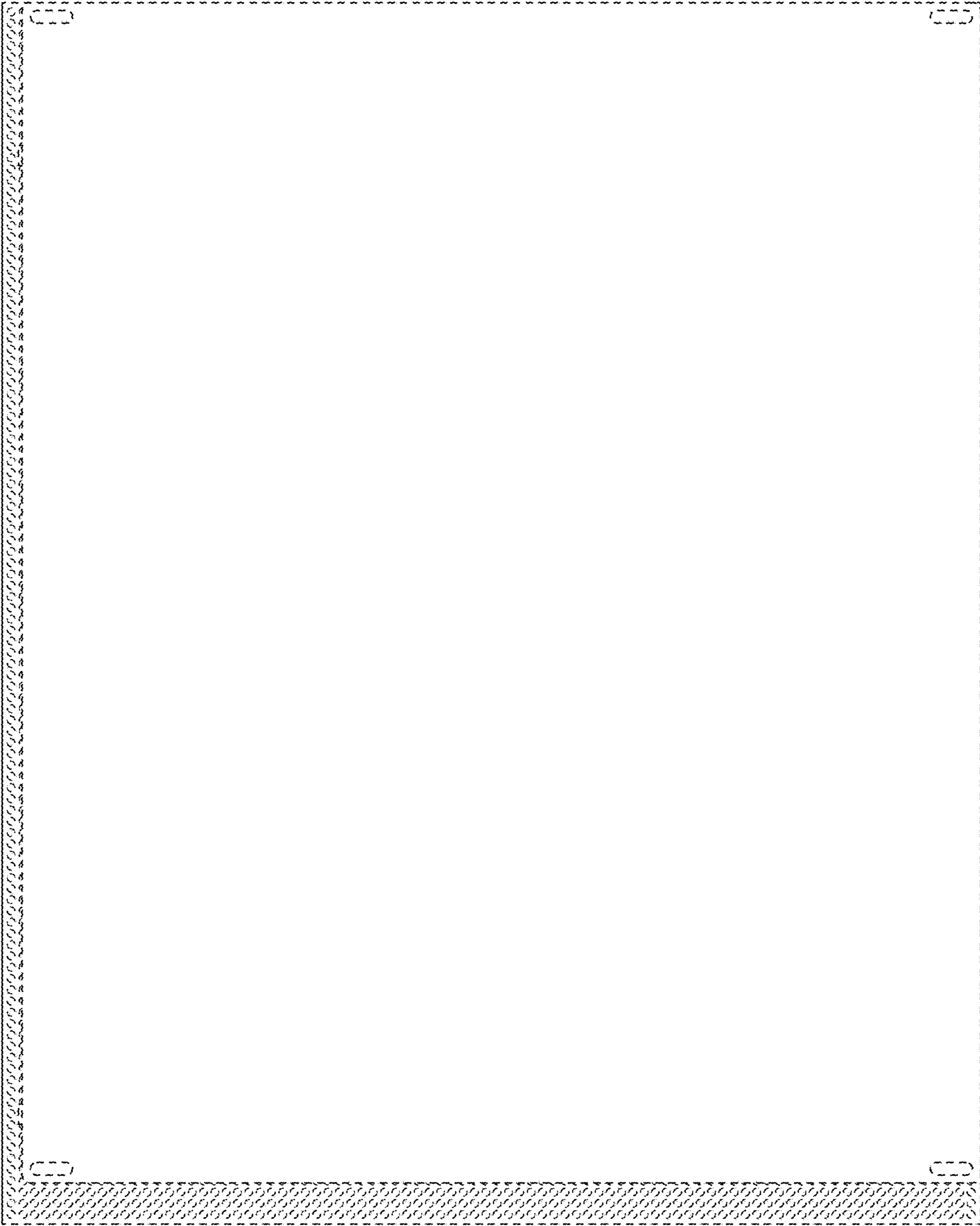

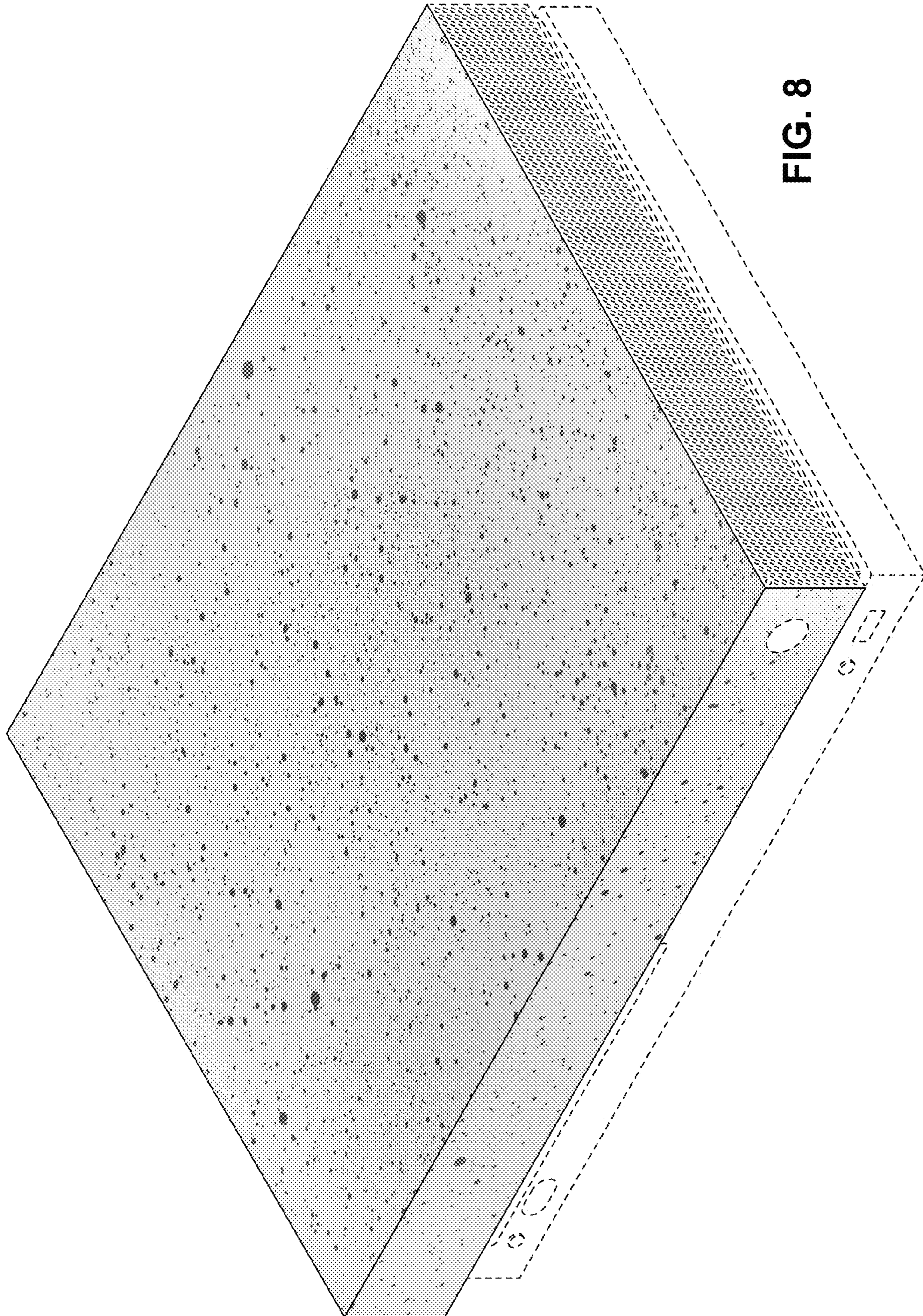

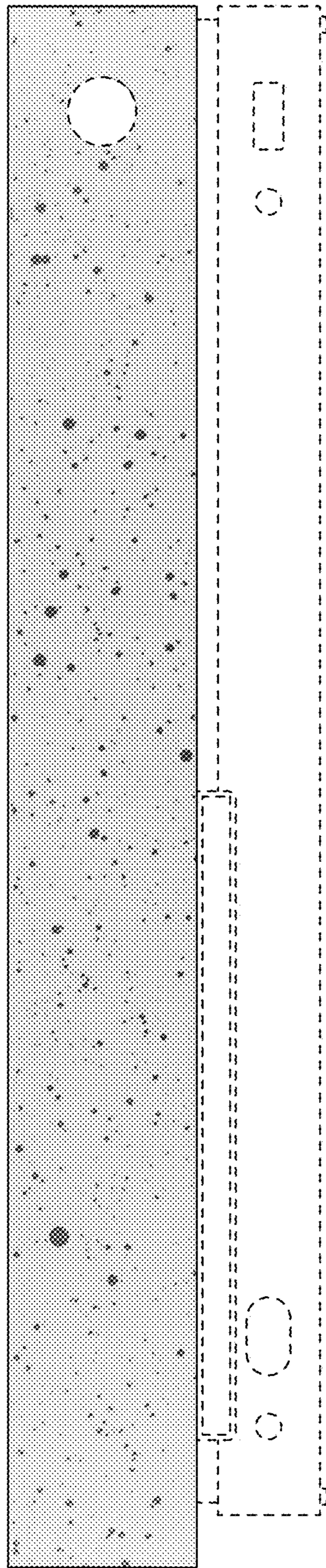

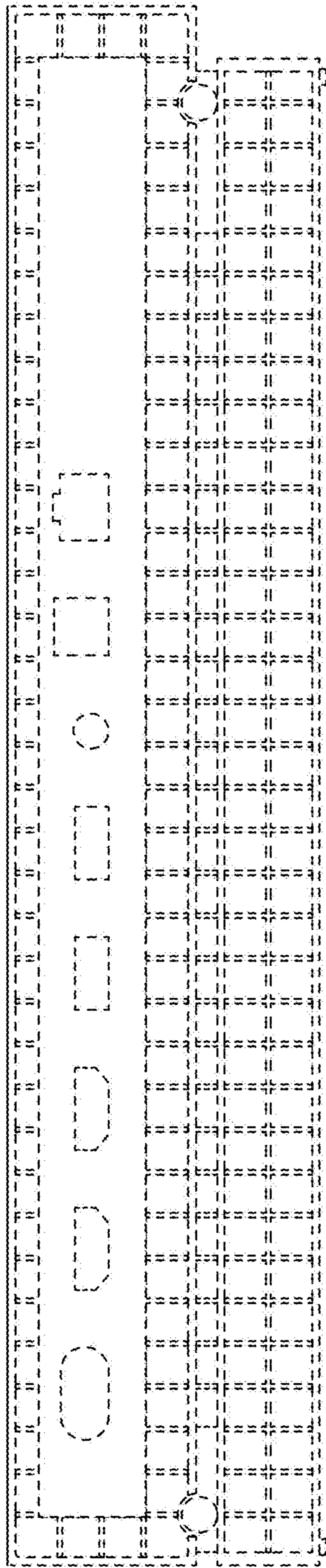

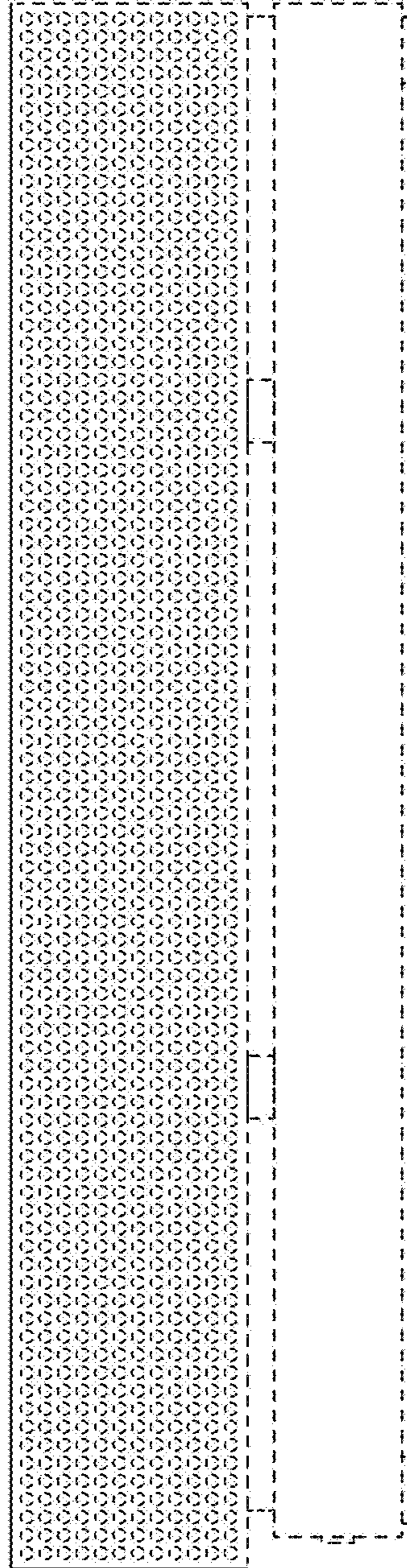

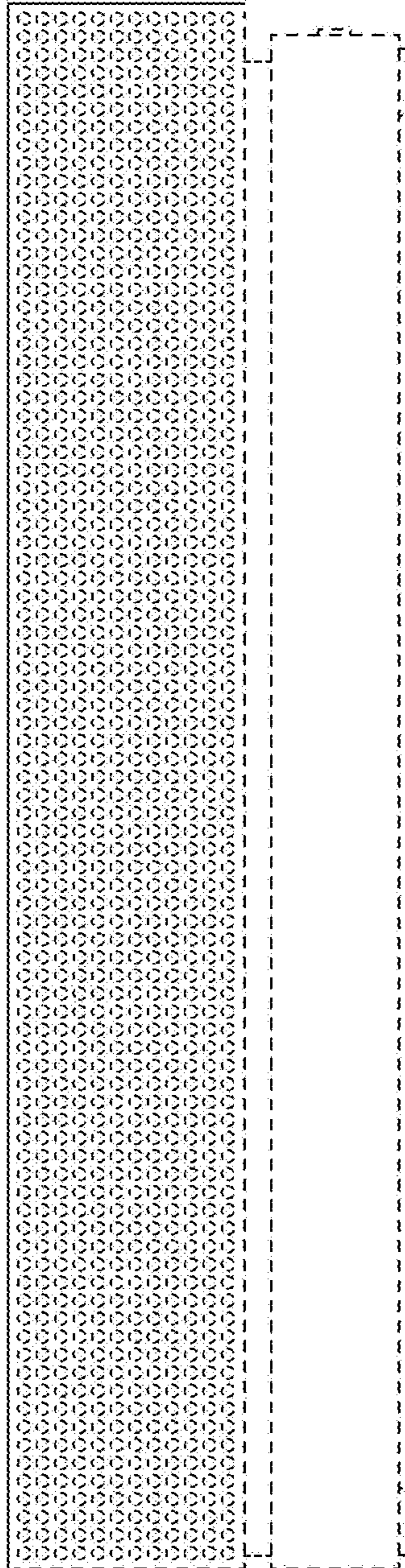

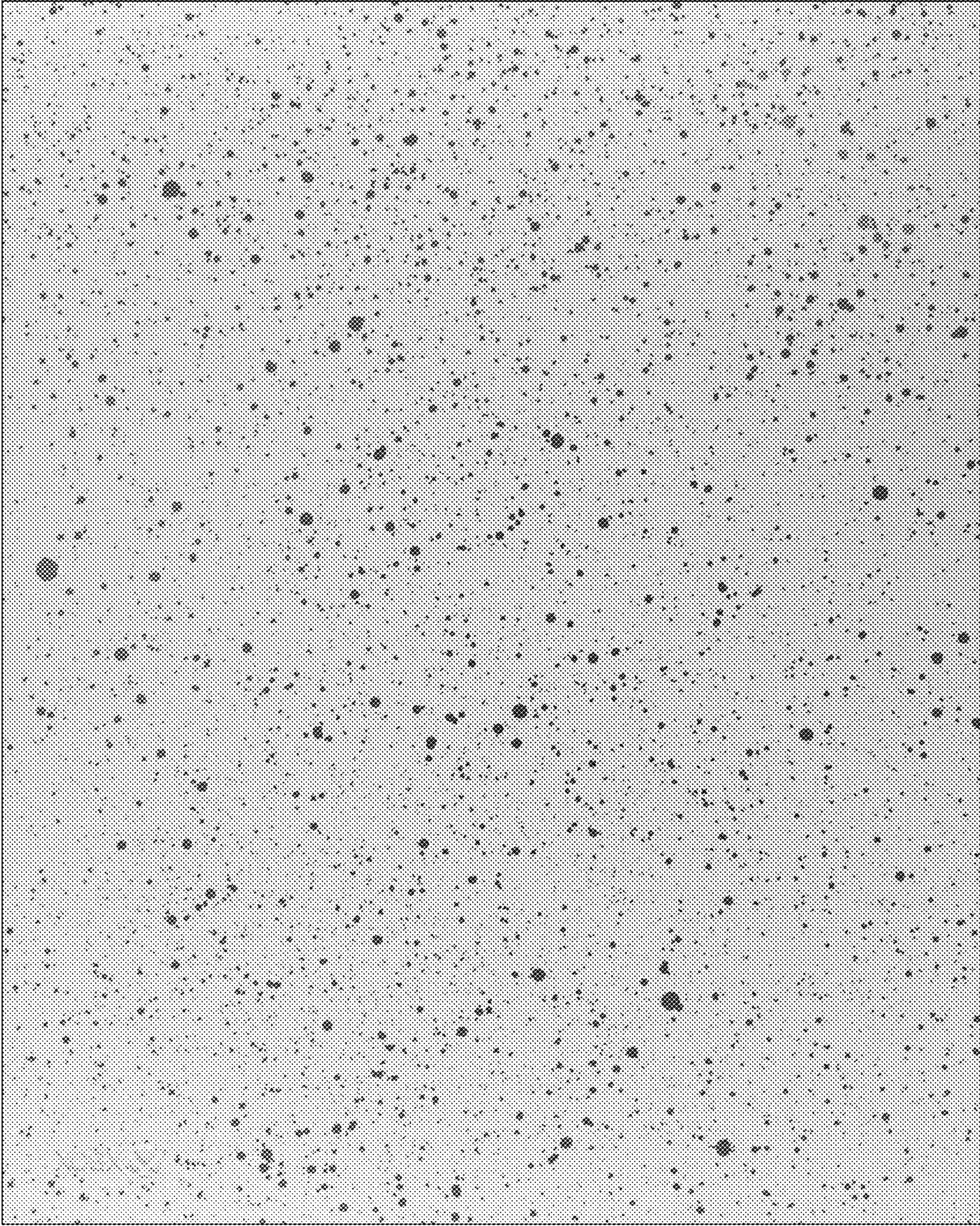

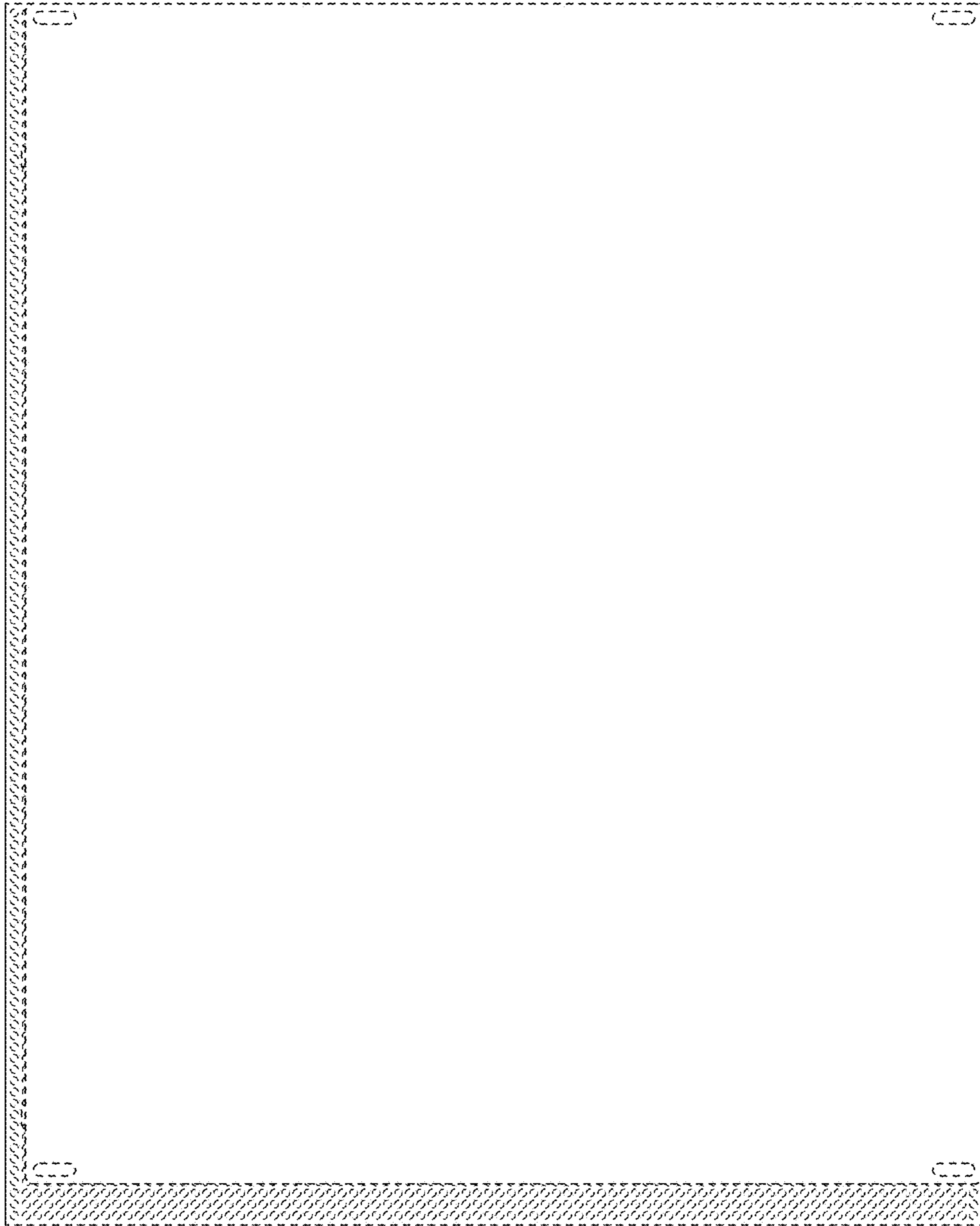
