DESCRIPTION

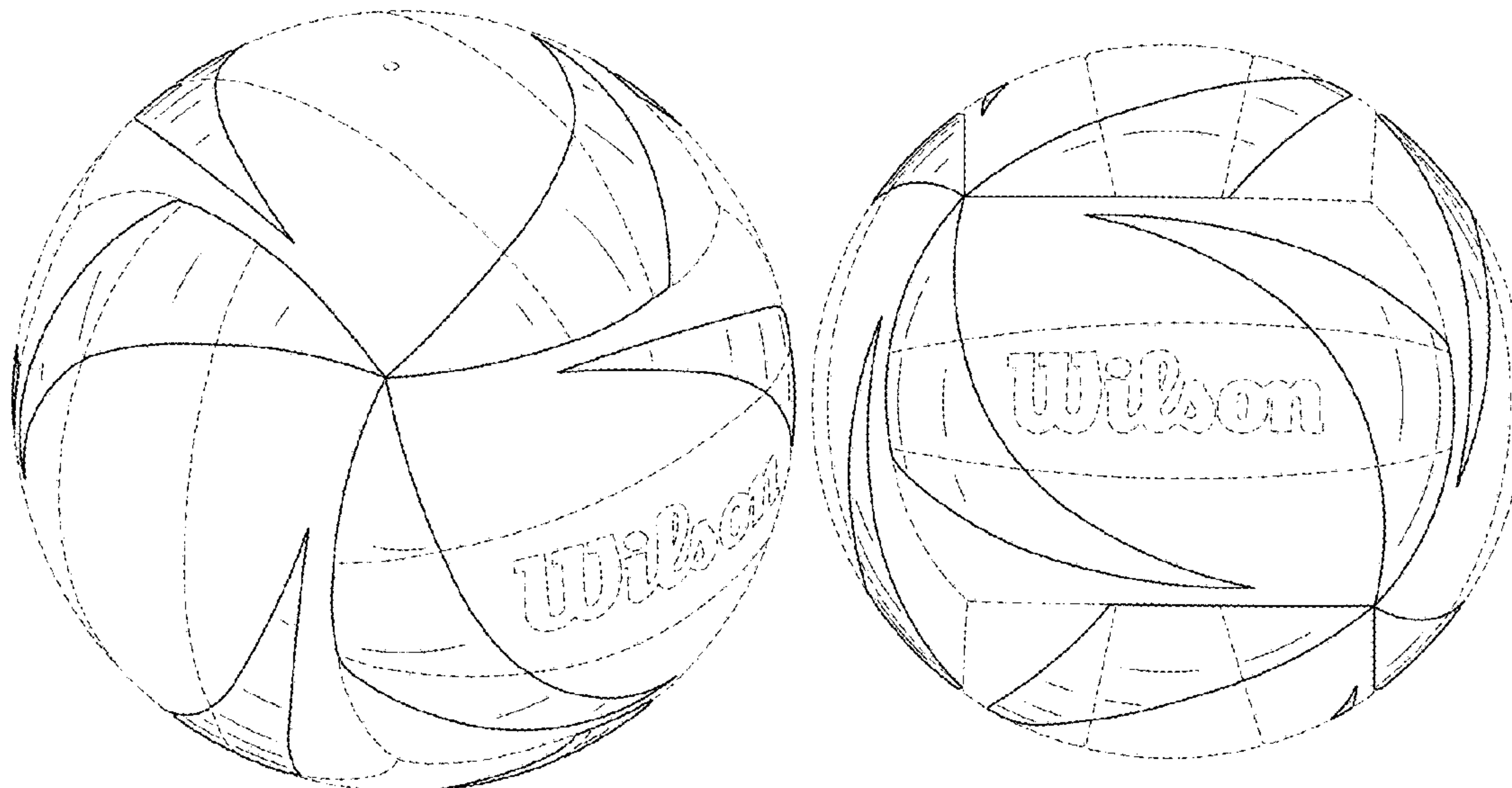
FIG. 1 is a front and top perspective view of a volleyball showing our new design;

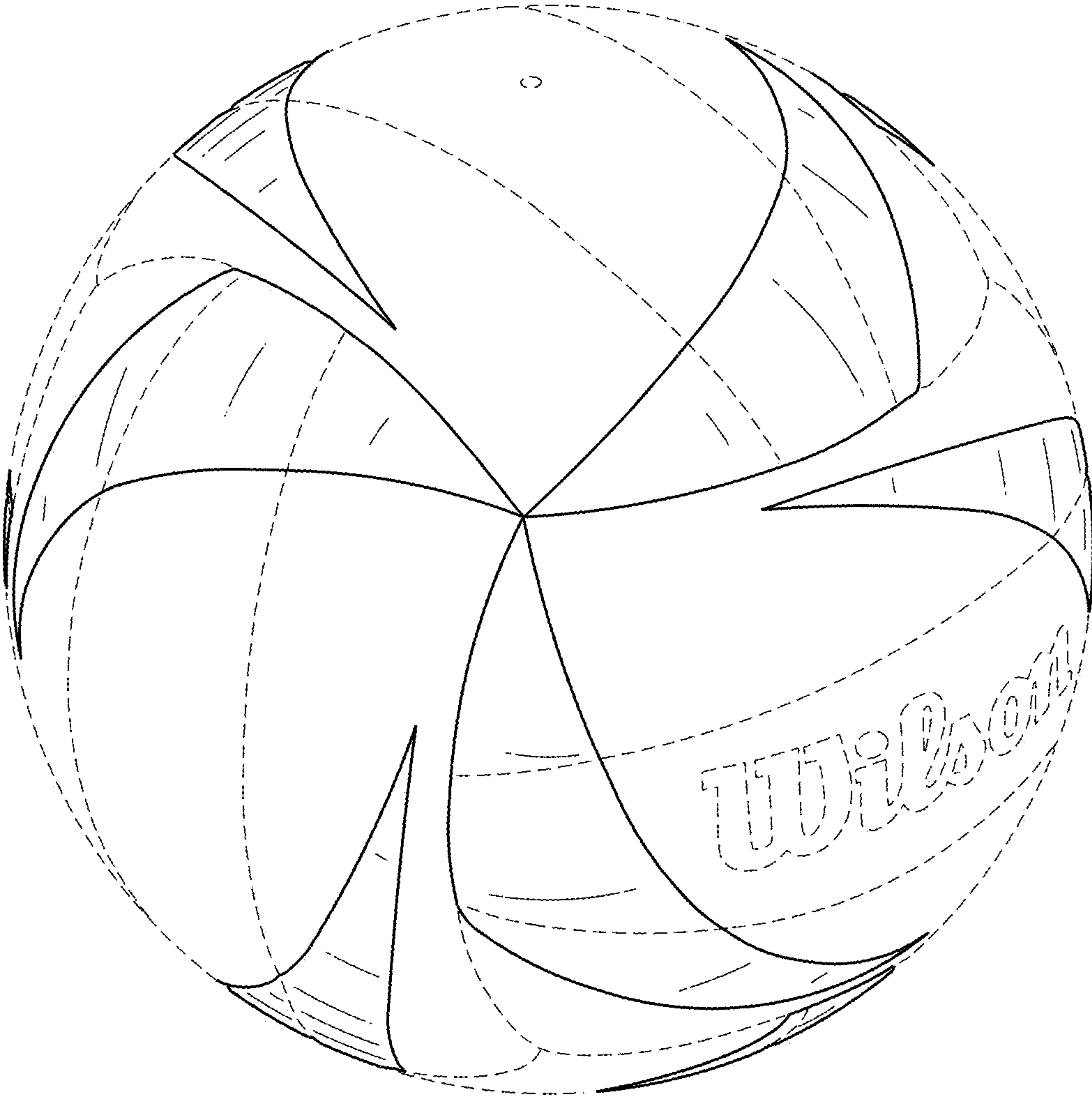

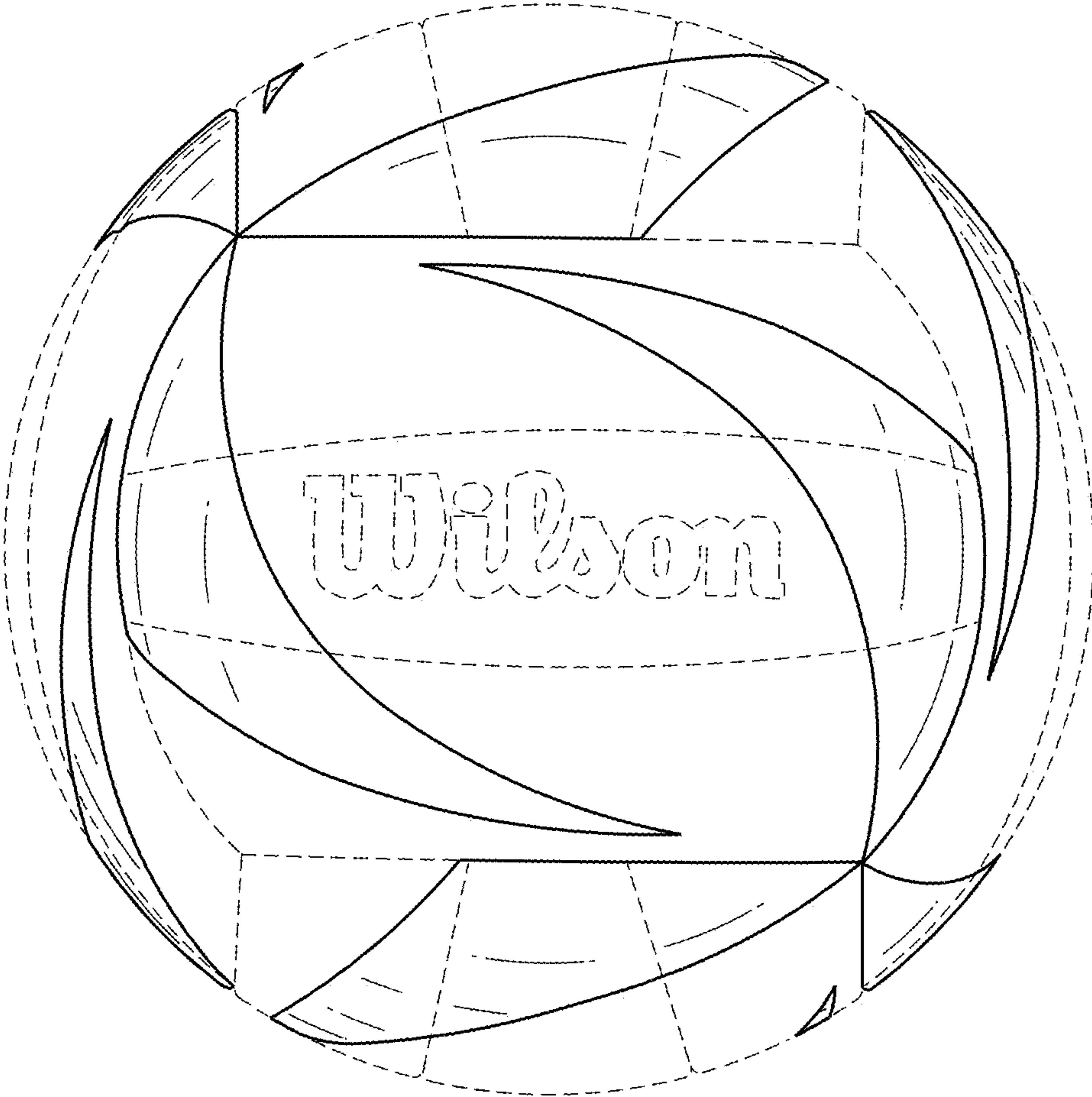

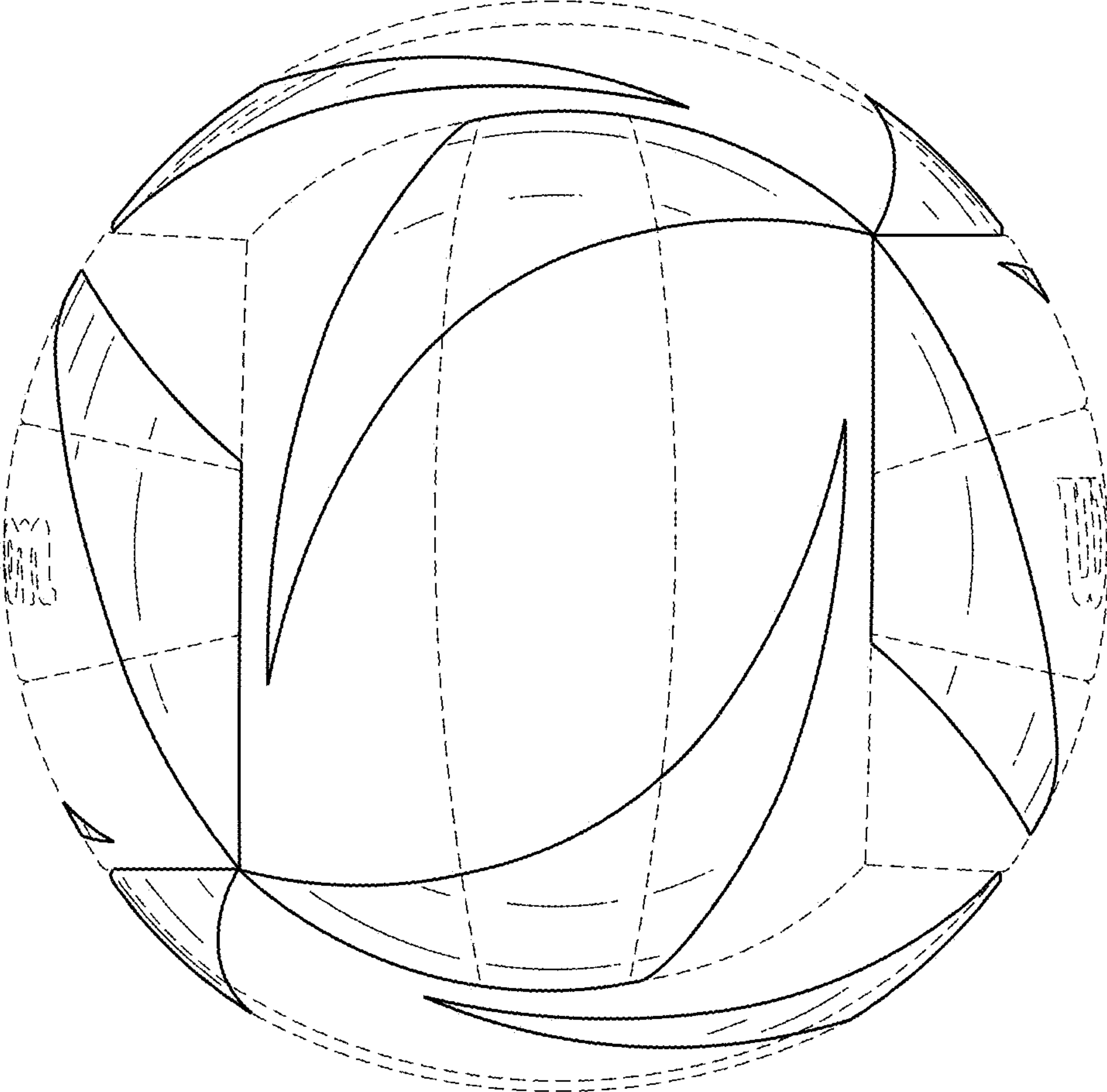

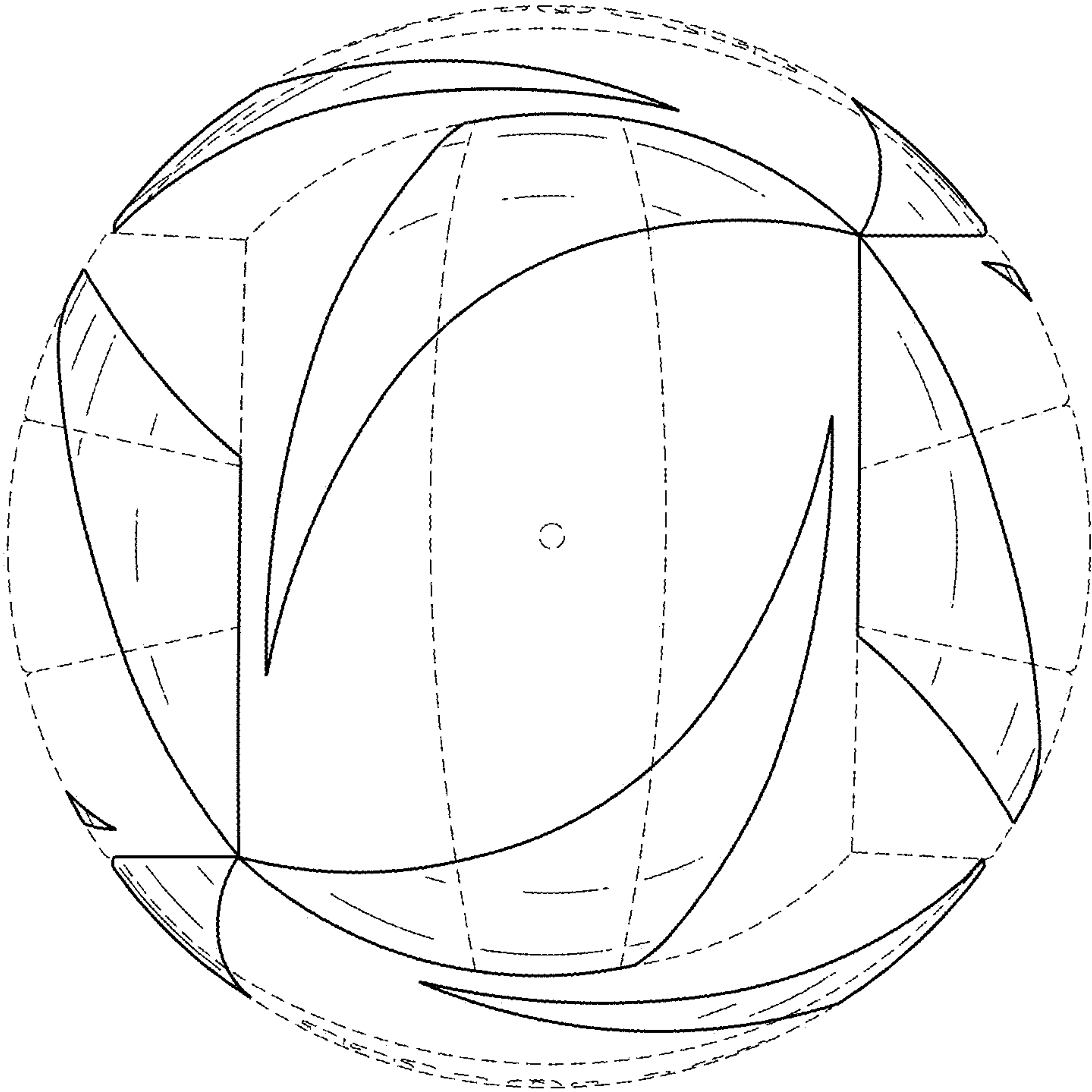

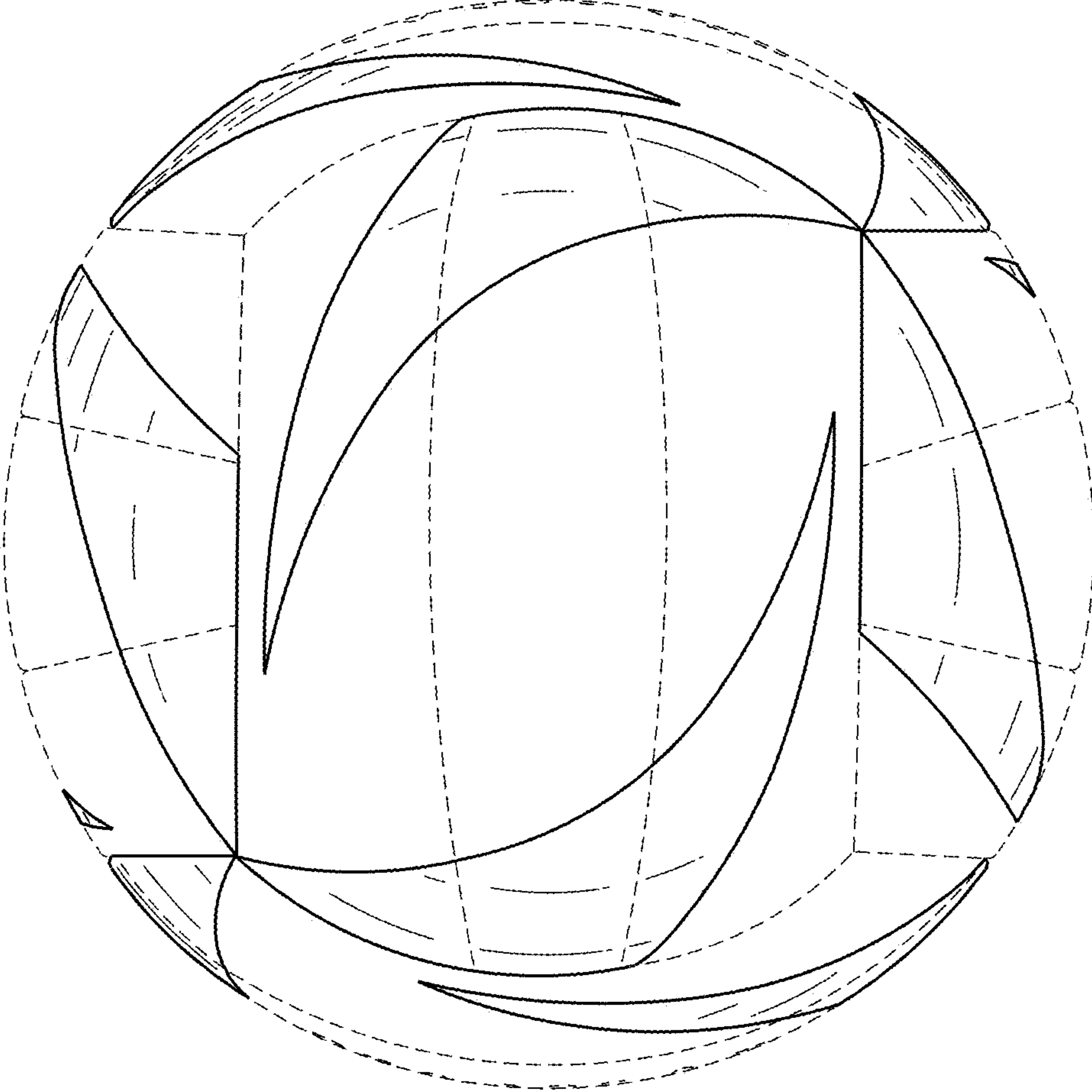
