(57) **CLAIM**

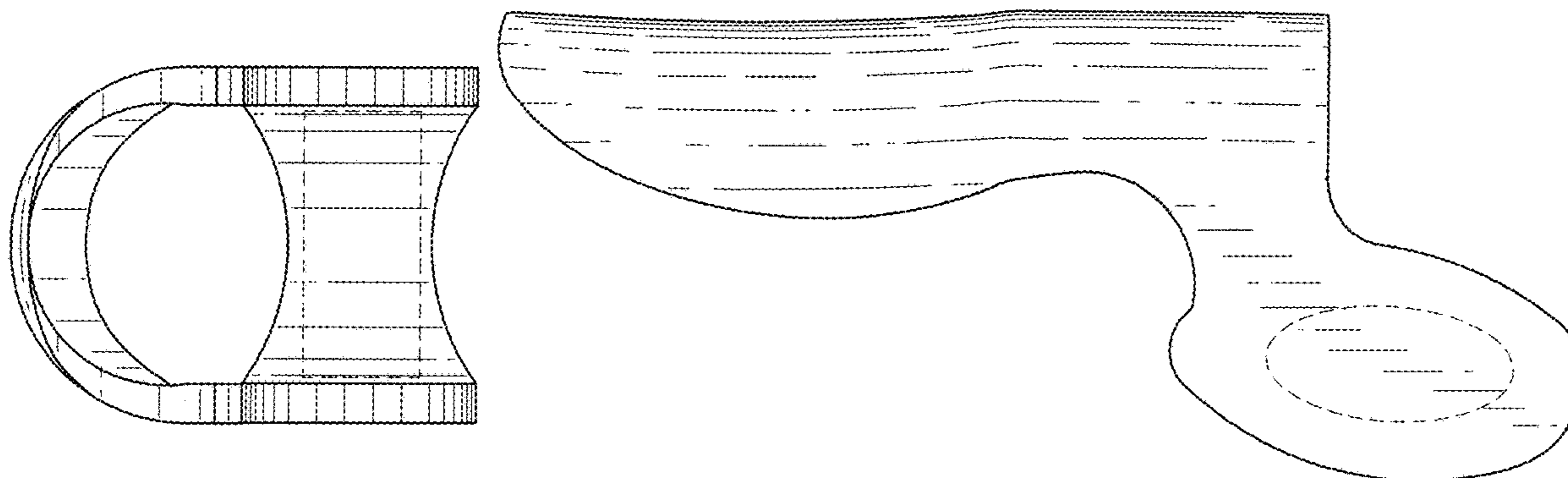
The ornamental design for a bunion spreader, as shown and described.

DESCRIPTION

FIG. 1 is a front orthographic view of the bunion spreader of the present design;
FIG. 2 is a left view of the bunion spreader of the design of FIG. 1;
FIG. 3 is a right side view of the bunion spreader of the design of FIG. 1;
FIG. 4 is a top view of the bunion spreader of the design of FIG. 1; and,
FIG. 5 is a bottom side view of bunion spreader of the design of FIG. 1.
The broken lines shown in the drawing denotes a removable insert for the bunion spreader of the present design.

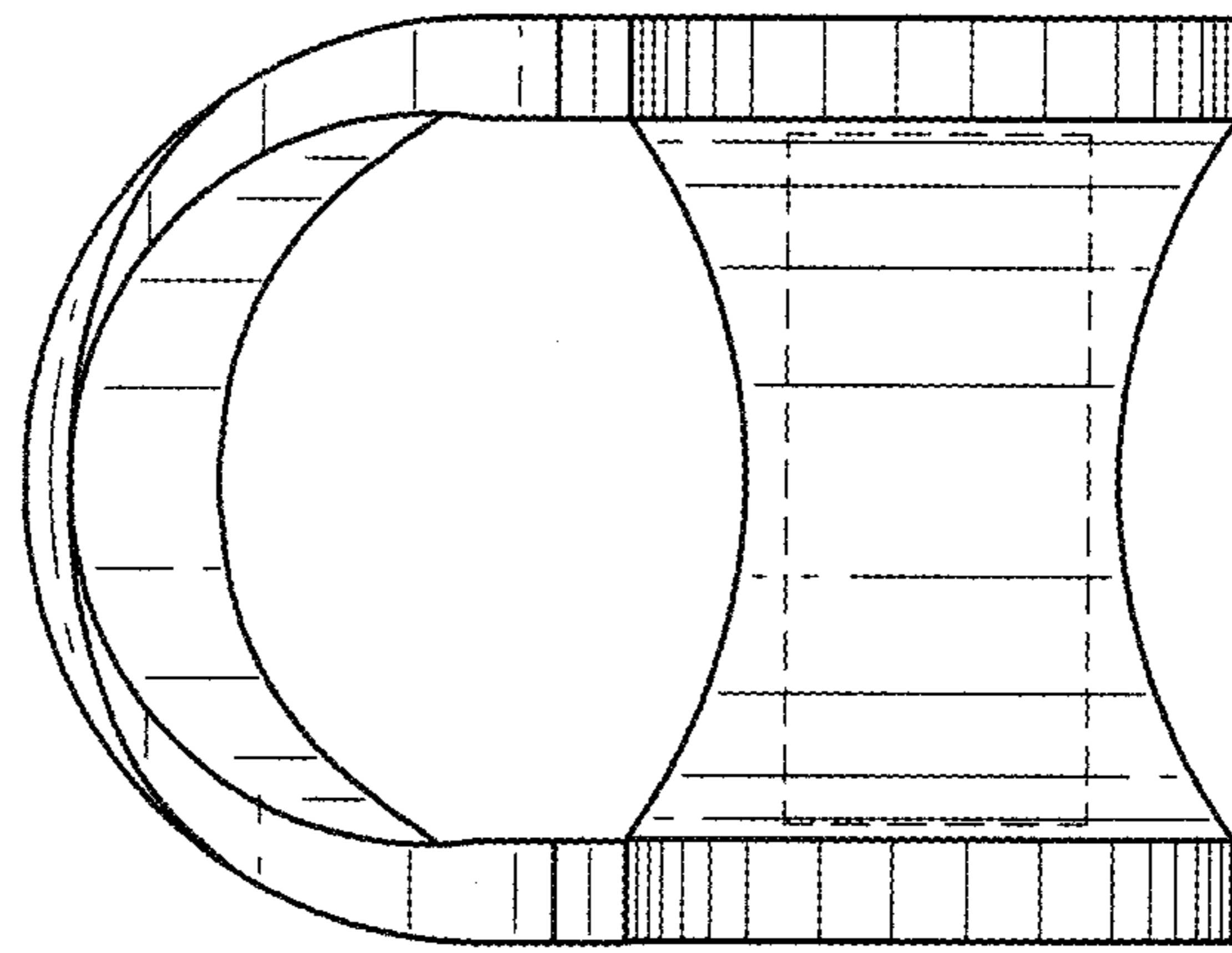

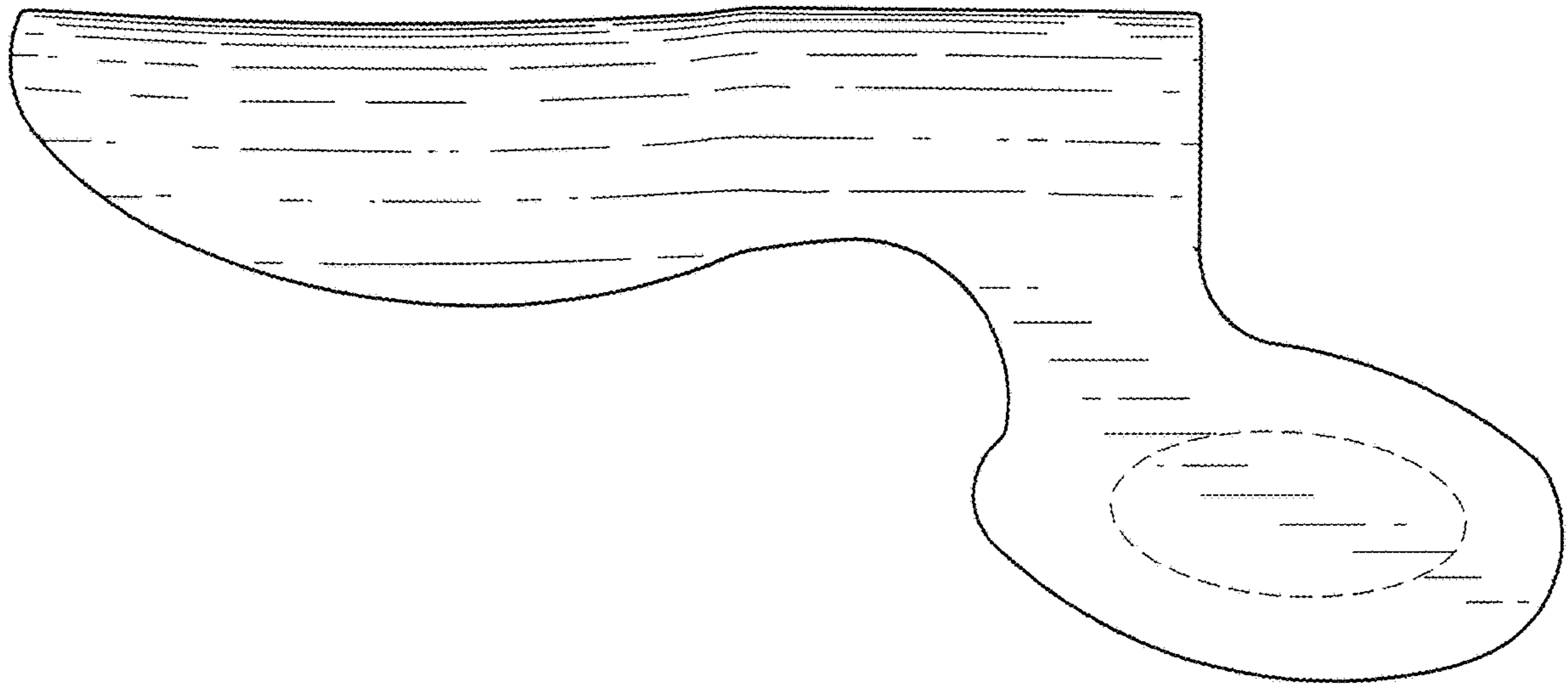

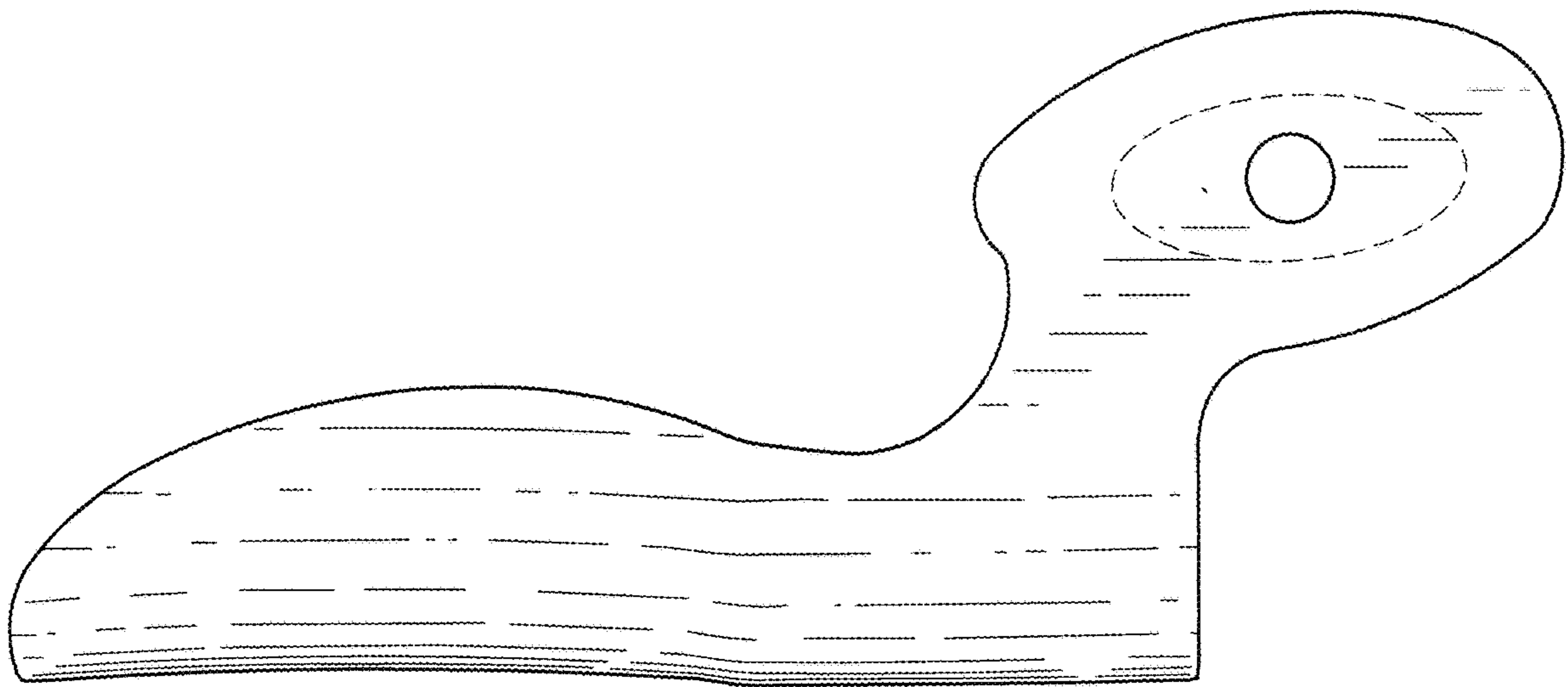

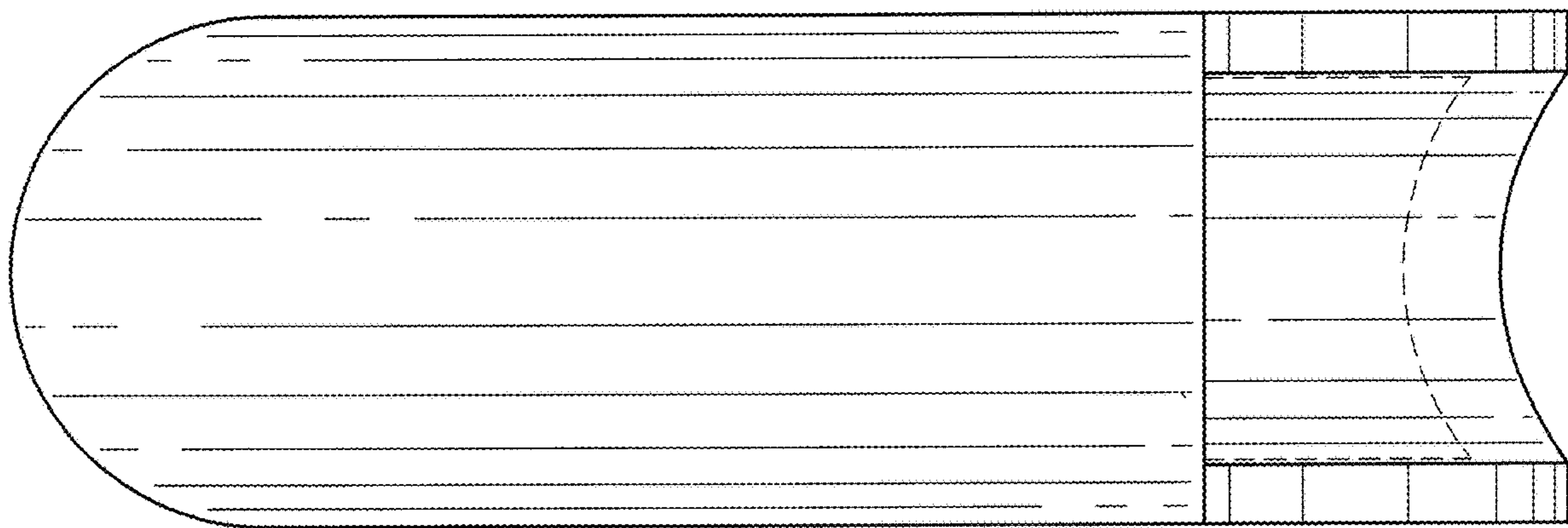

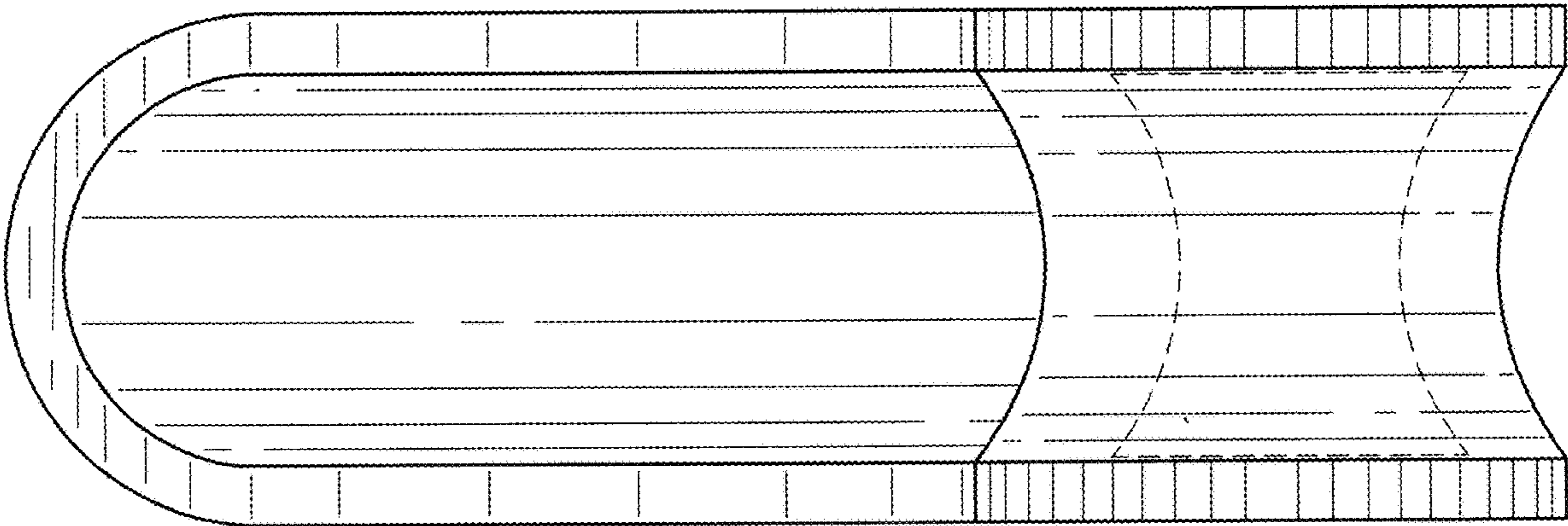
