(57) **CLAIM**

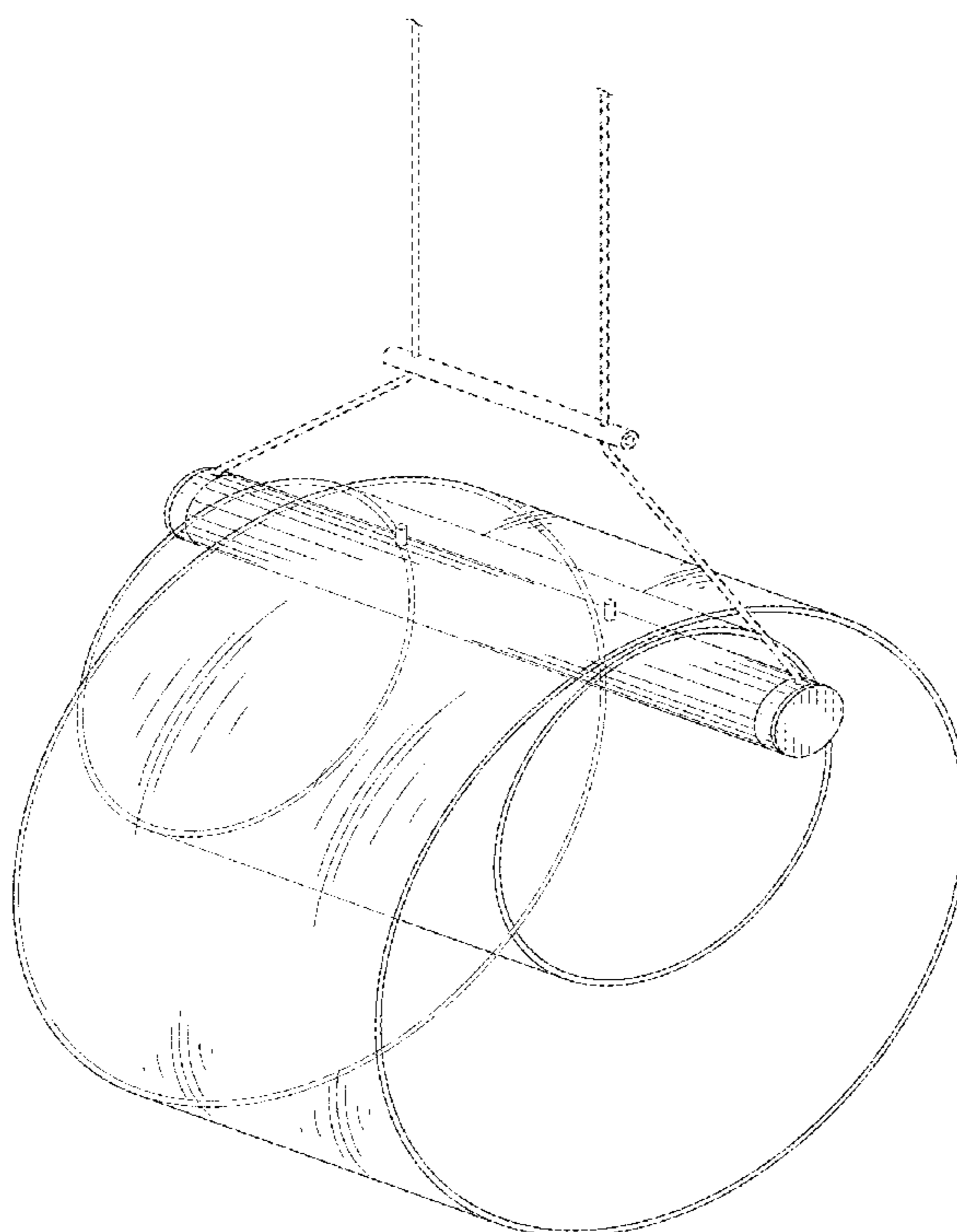
The ornamental design of a lighting device, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a lighting device in accordance with the present invention; FIG. 2 is a front side view thereof; FIG. 3 is a right side view thereof, a left side view being a mirror image thereof; FIG. 4 is a rear side view thereof; FIG. 5 is a top view thereof; and, FIG. 6 is a bottom view thereof.

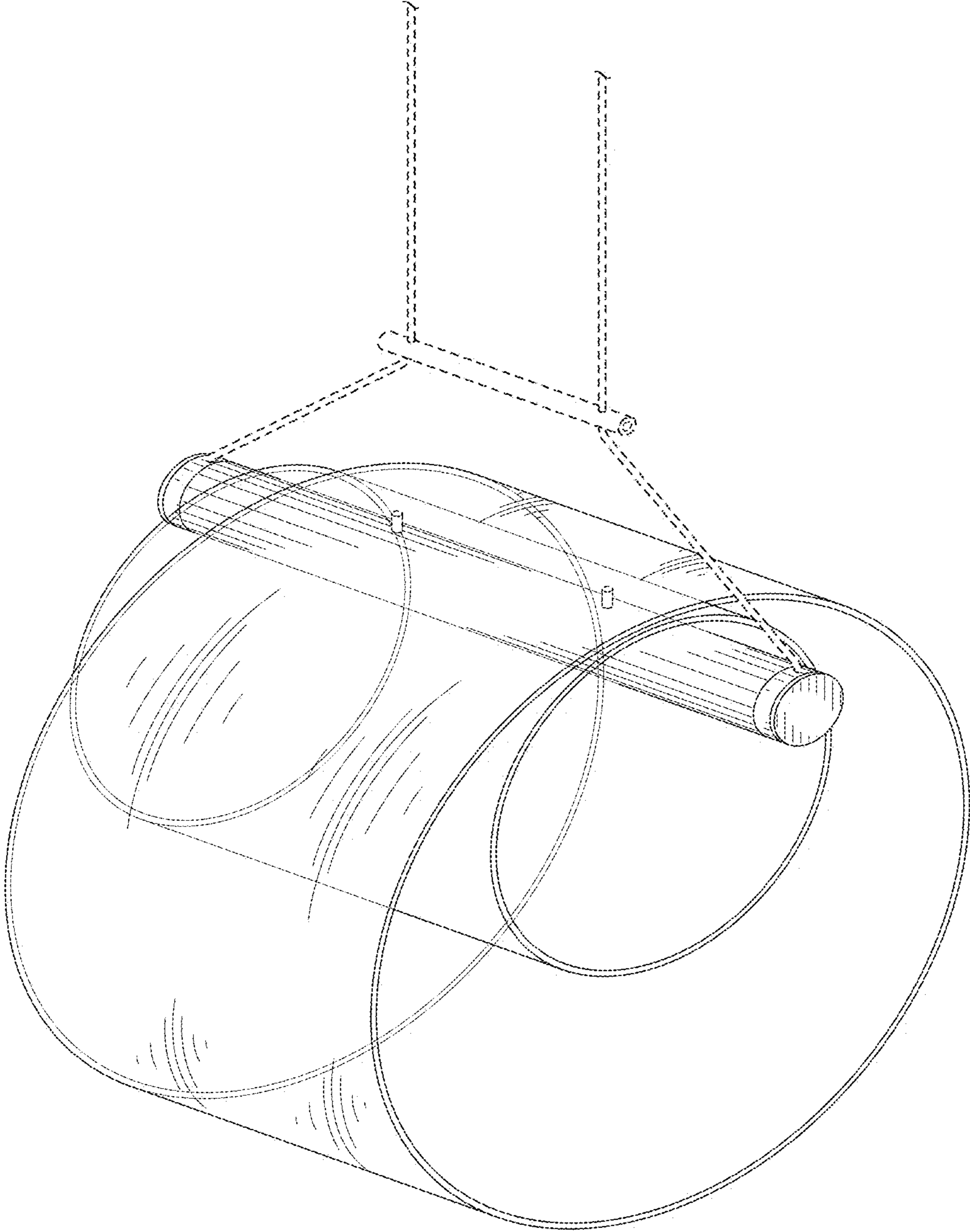

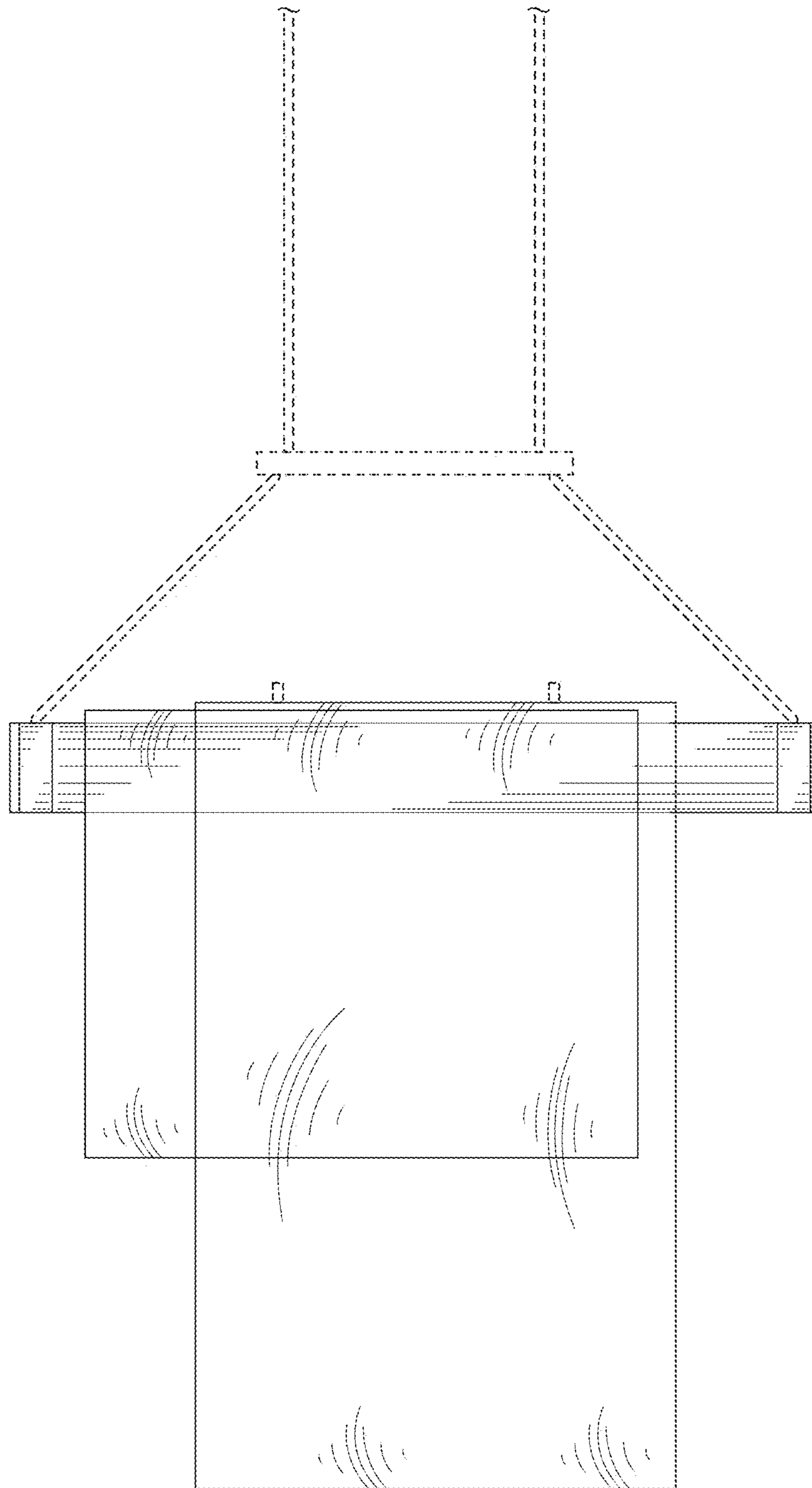

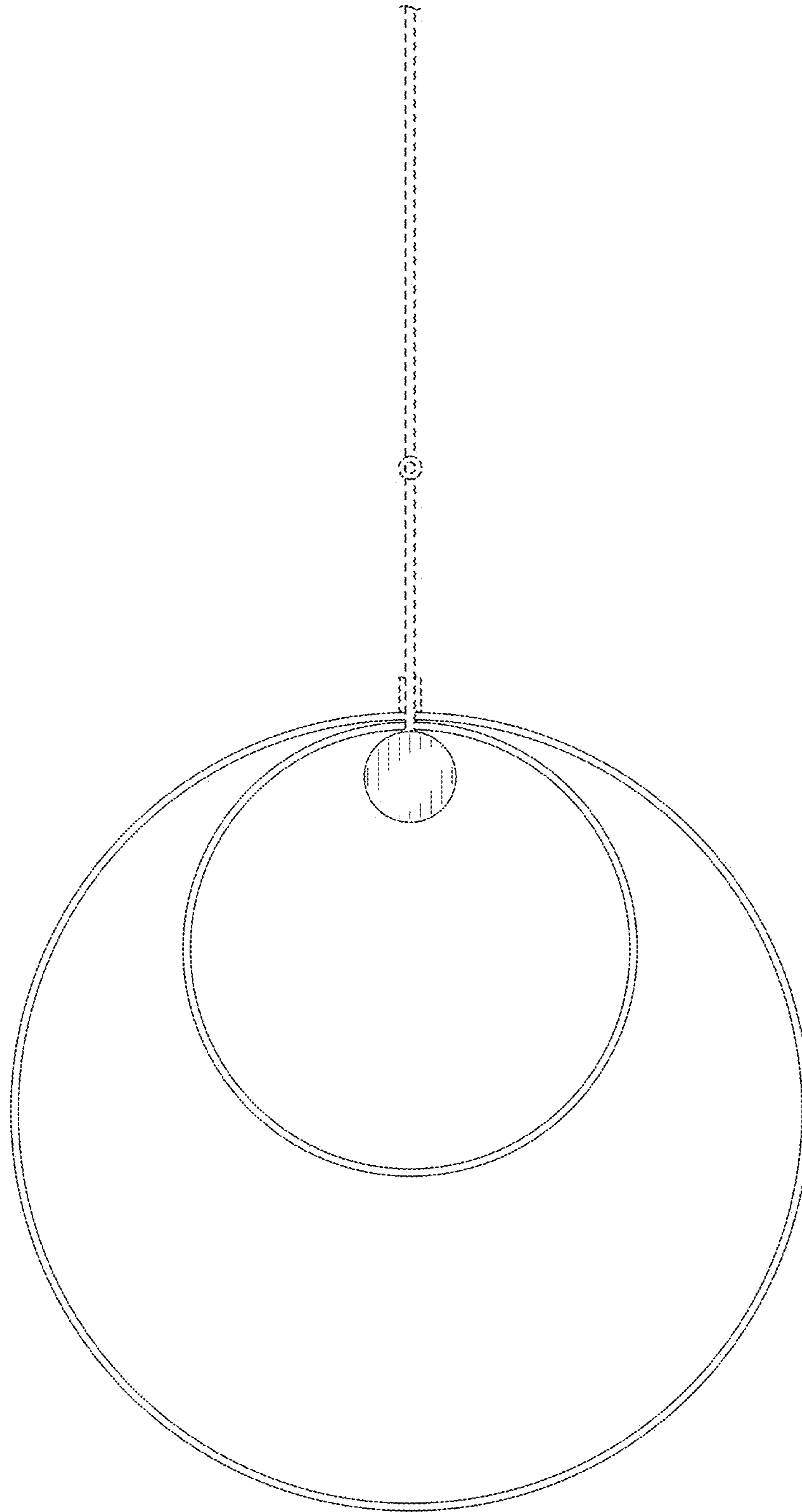

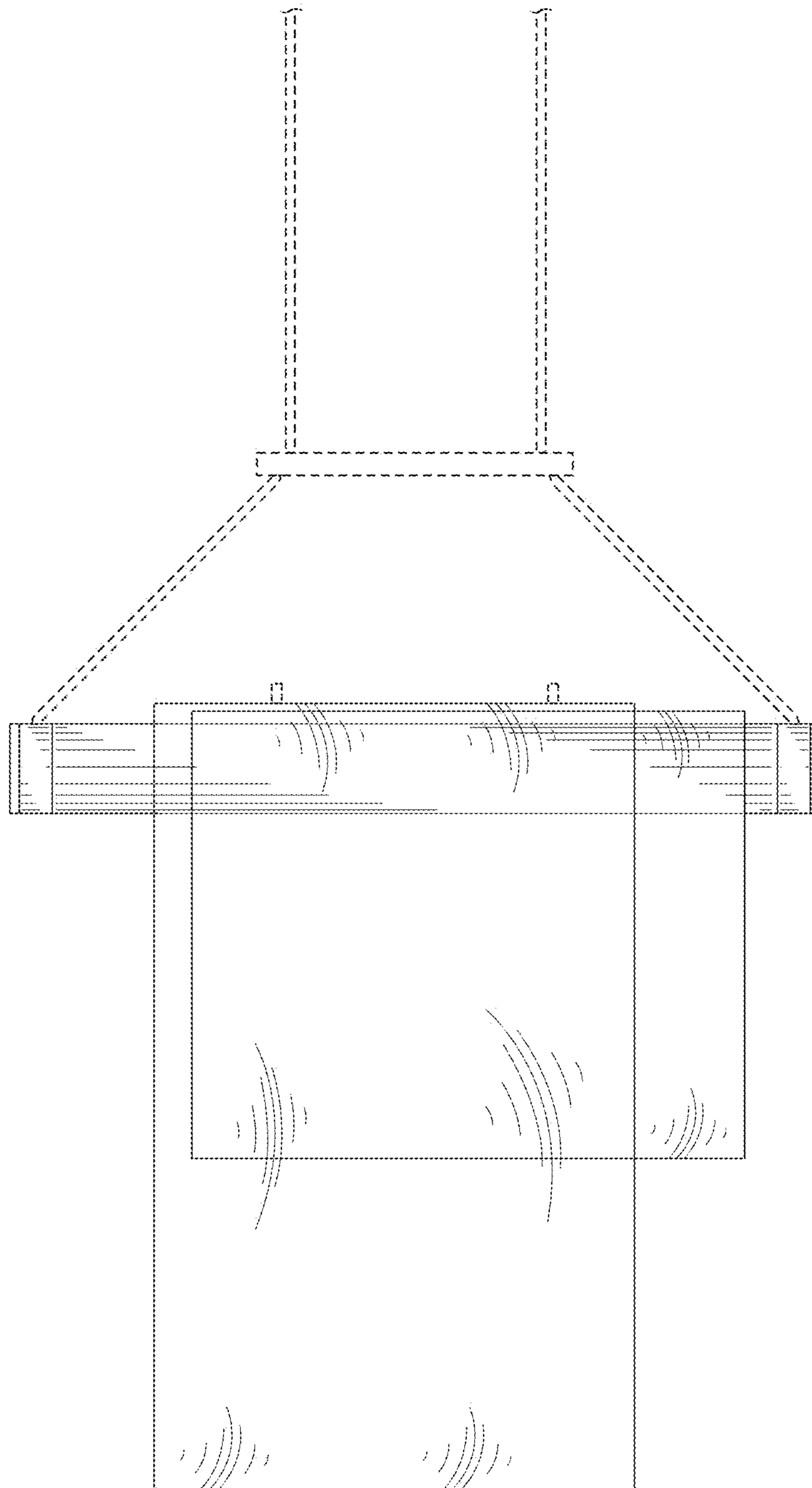

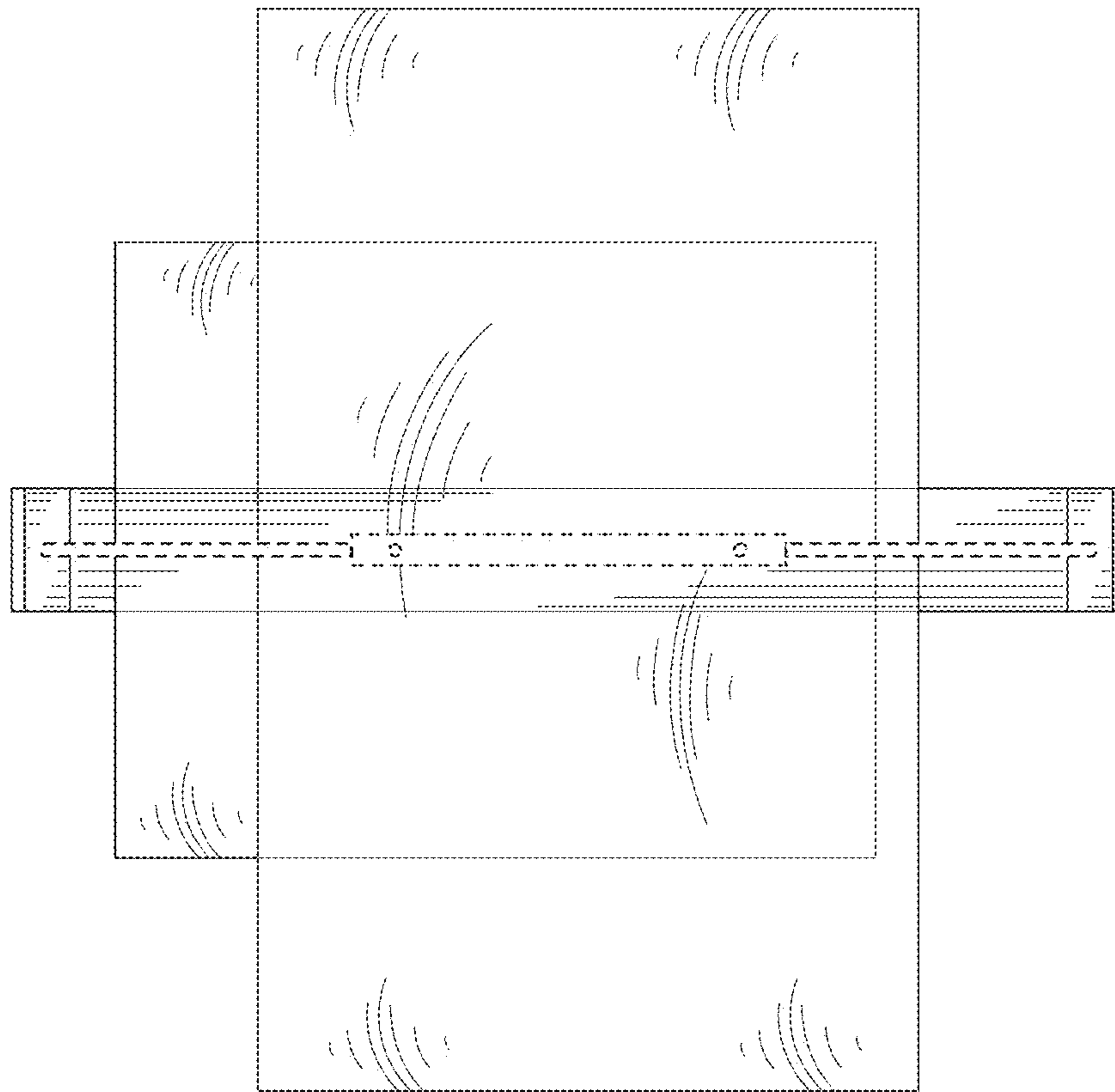

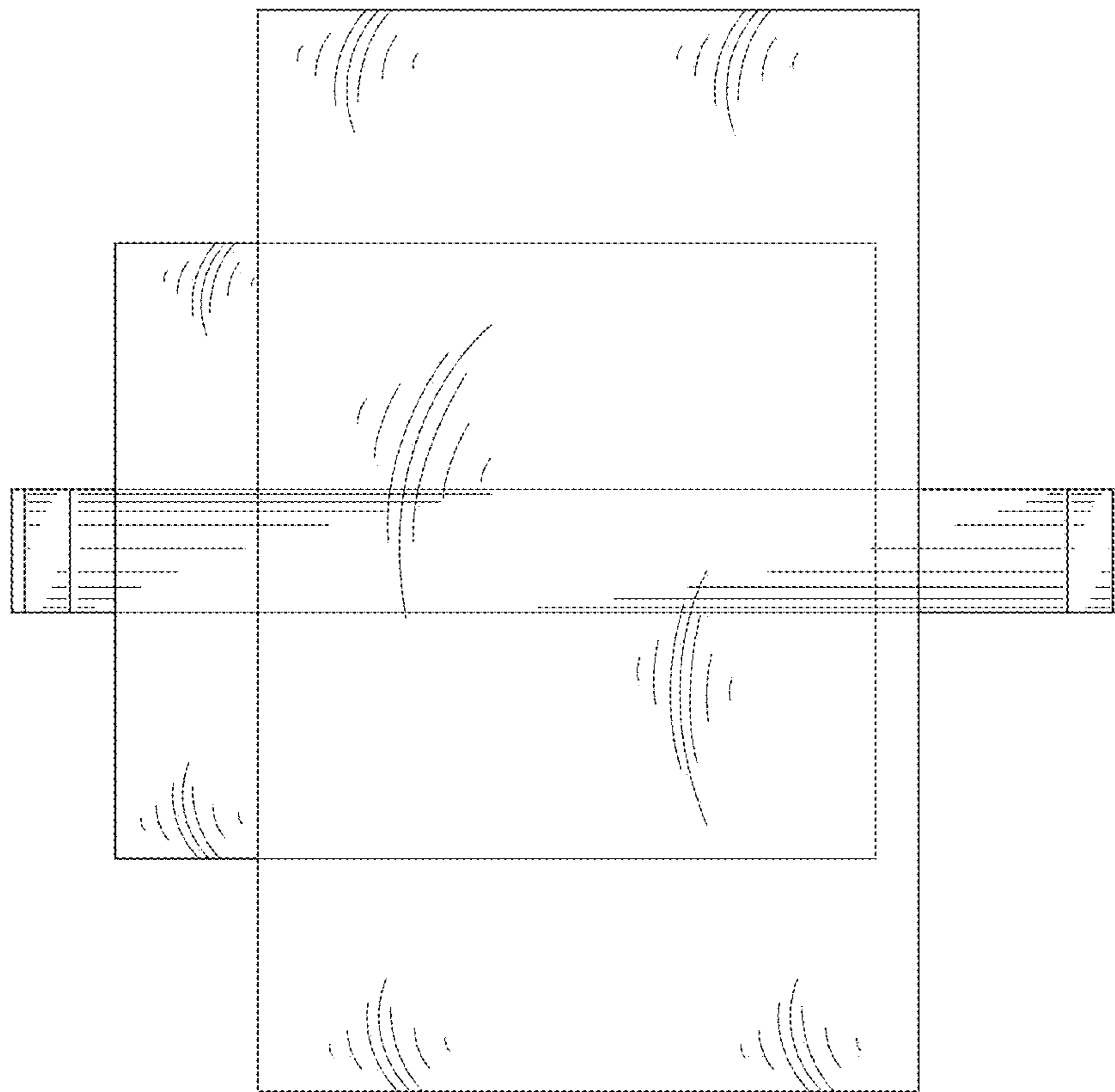
