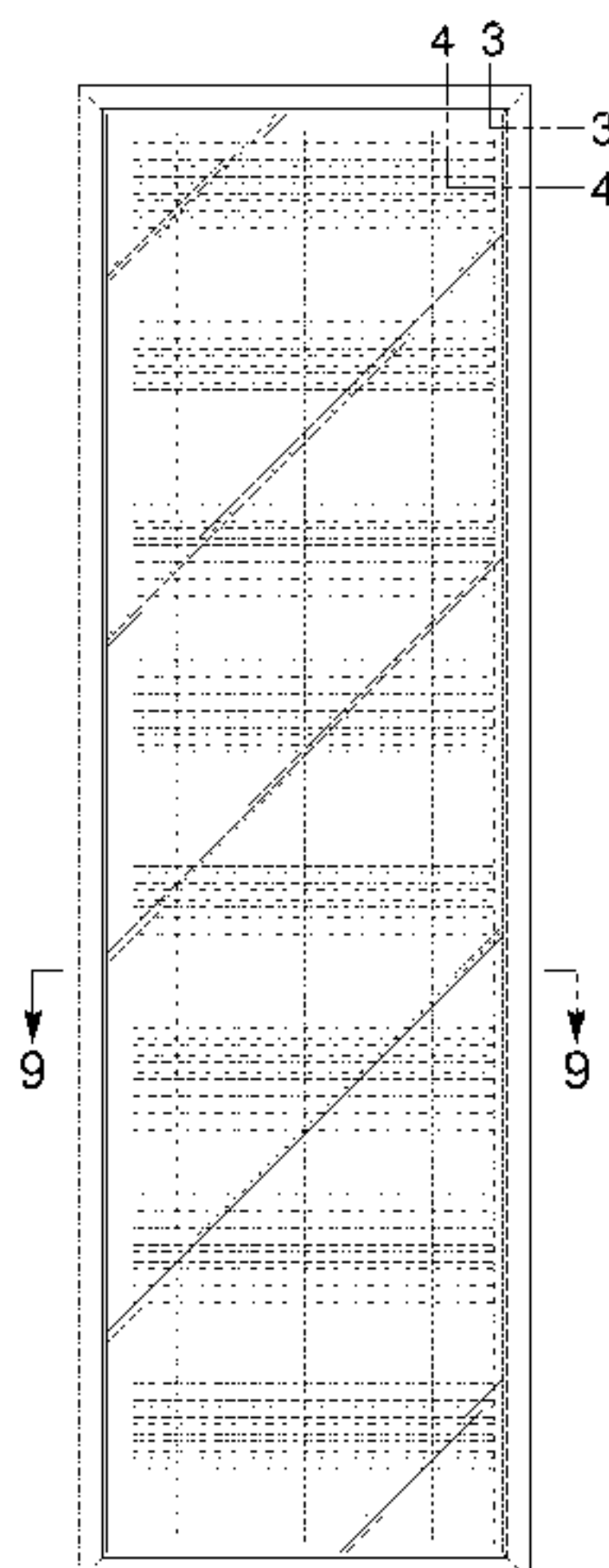


FIG. 33 is an enlarged fragmentary elevational view taken along the line 33-33 of FIG. 31;

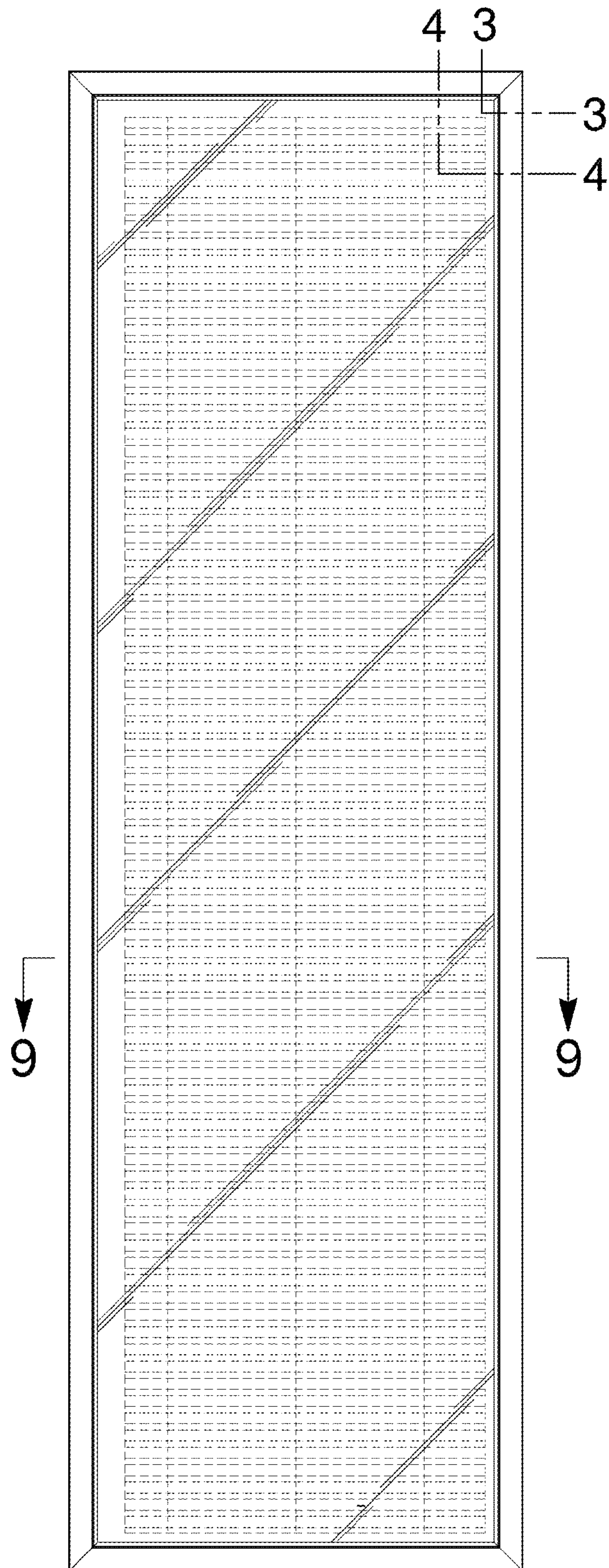

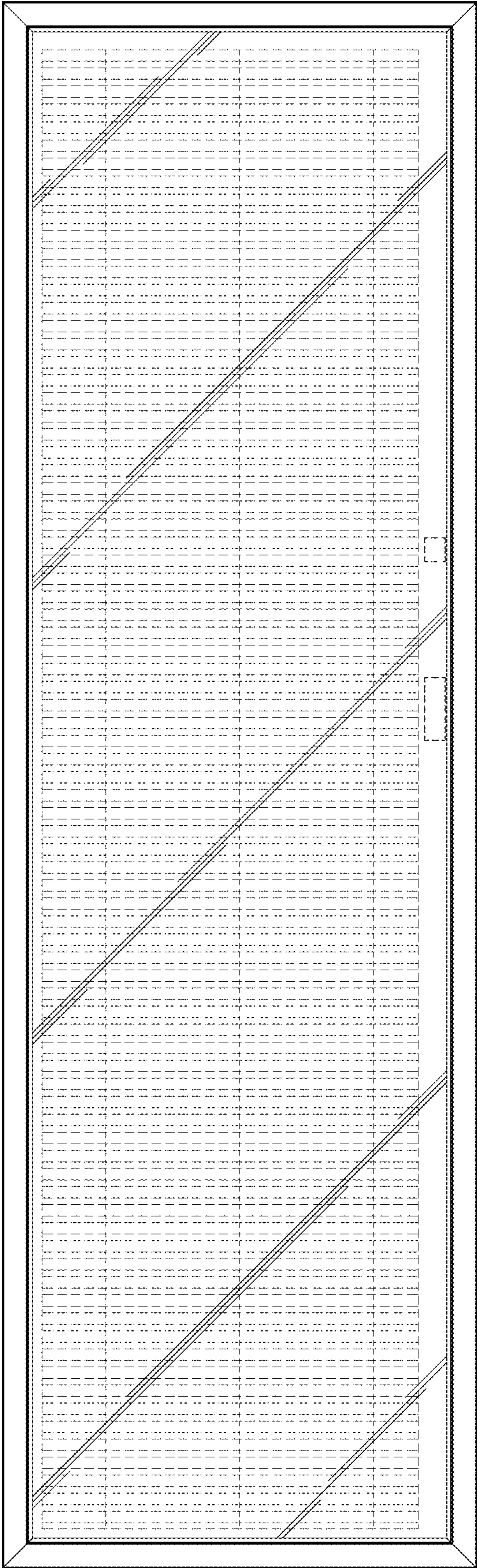
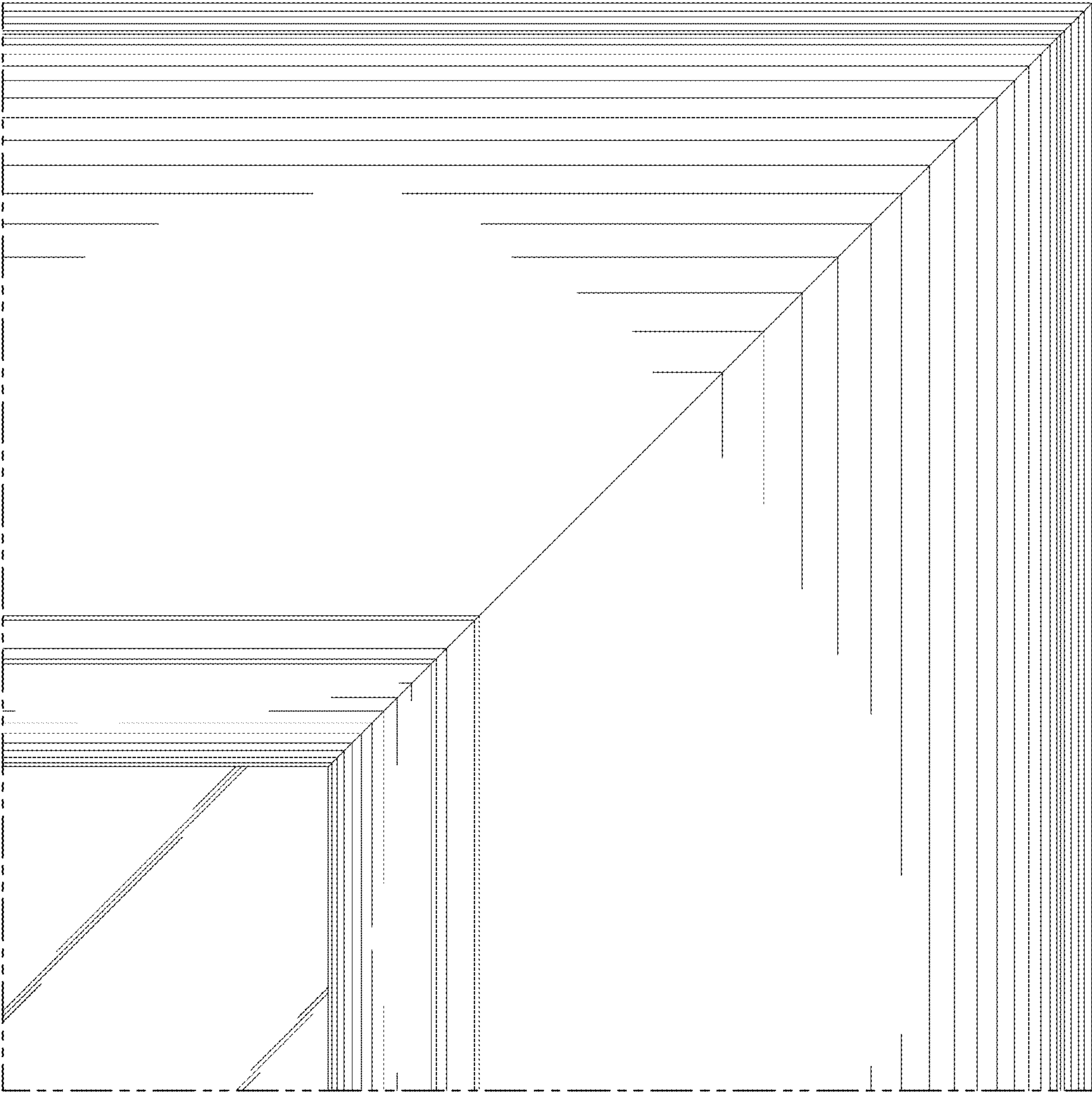

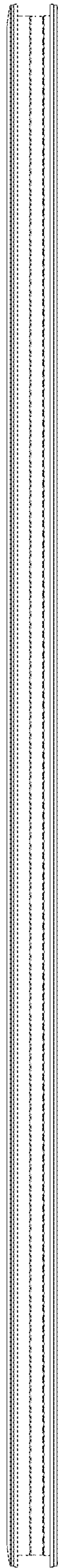

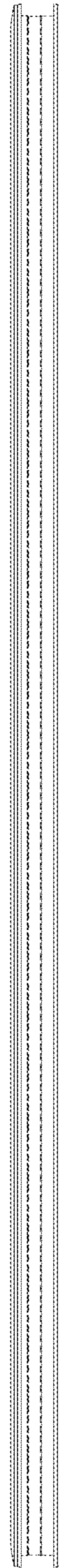

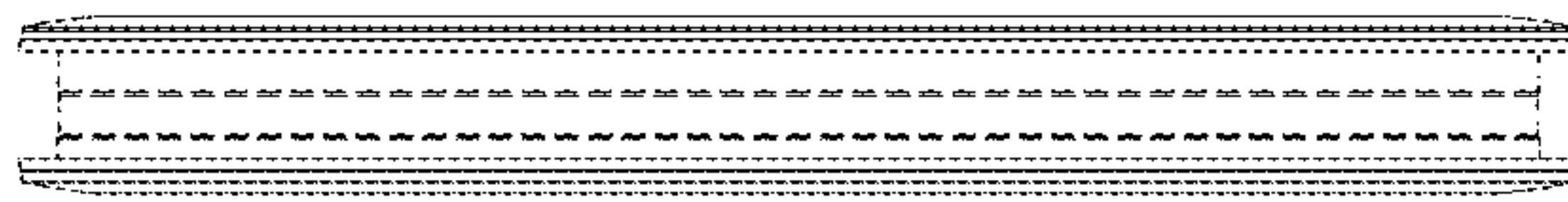

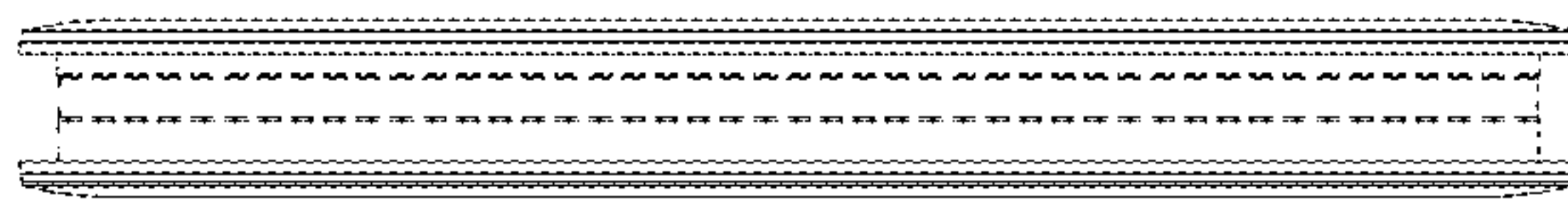
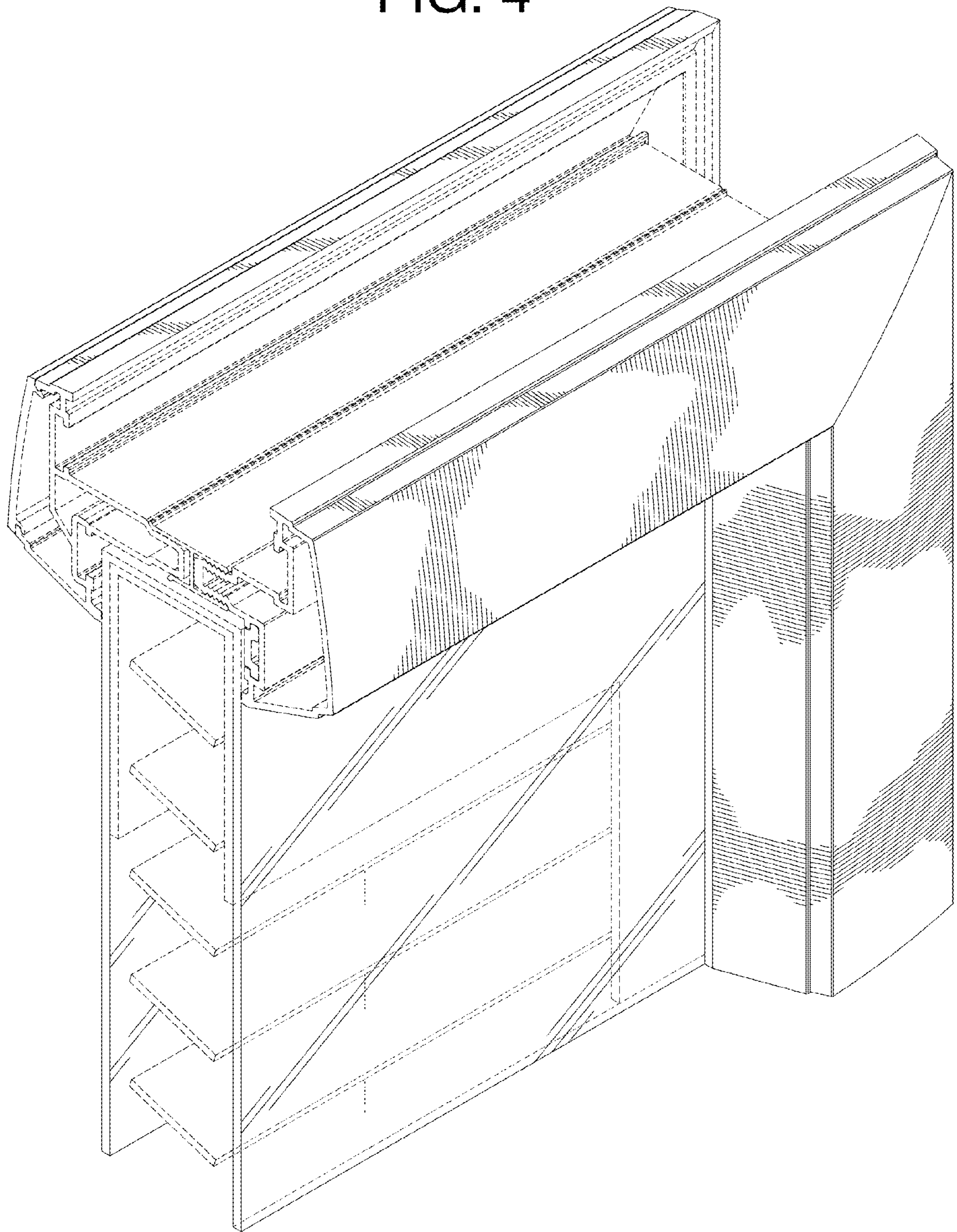

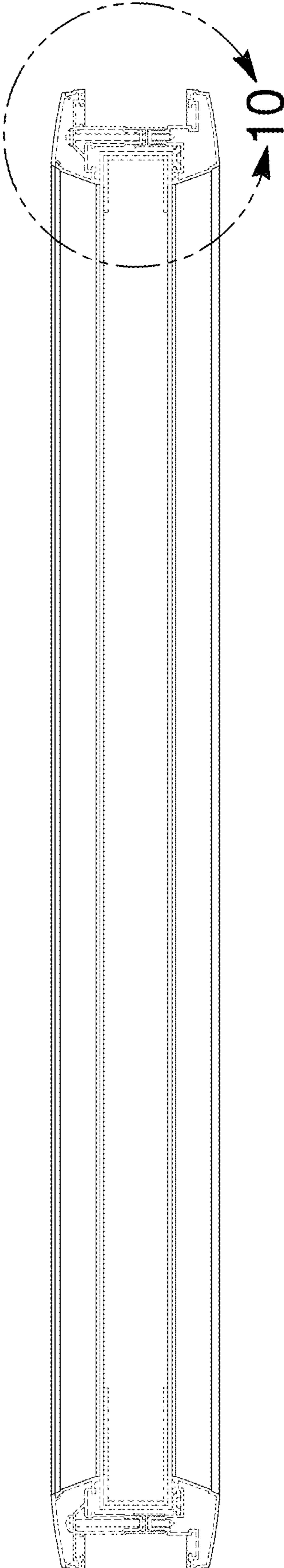

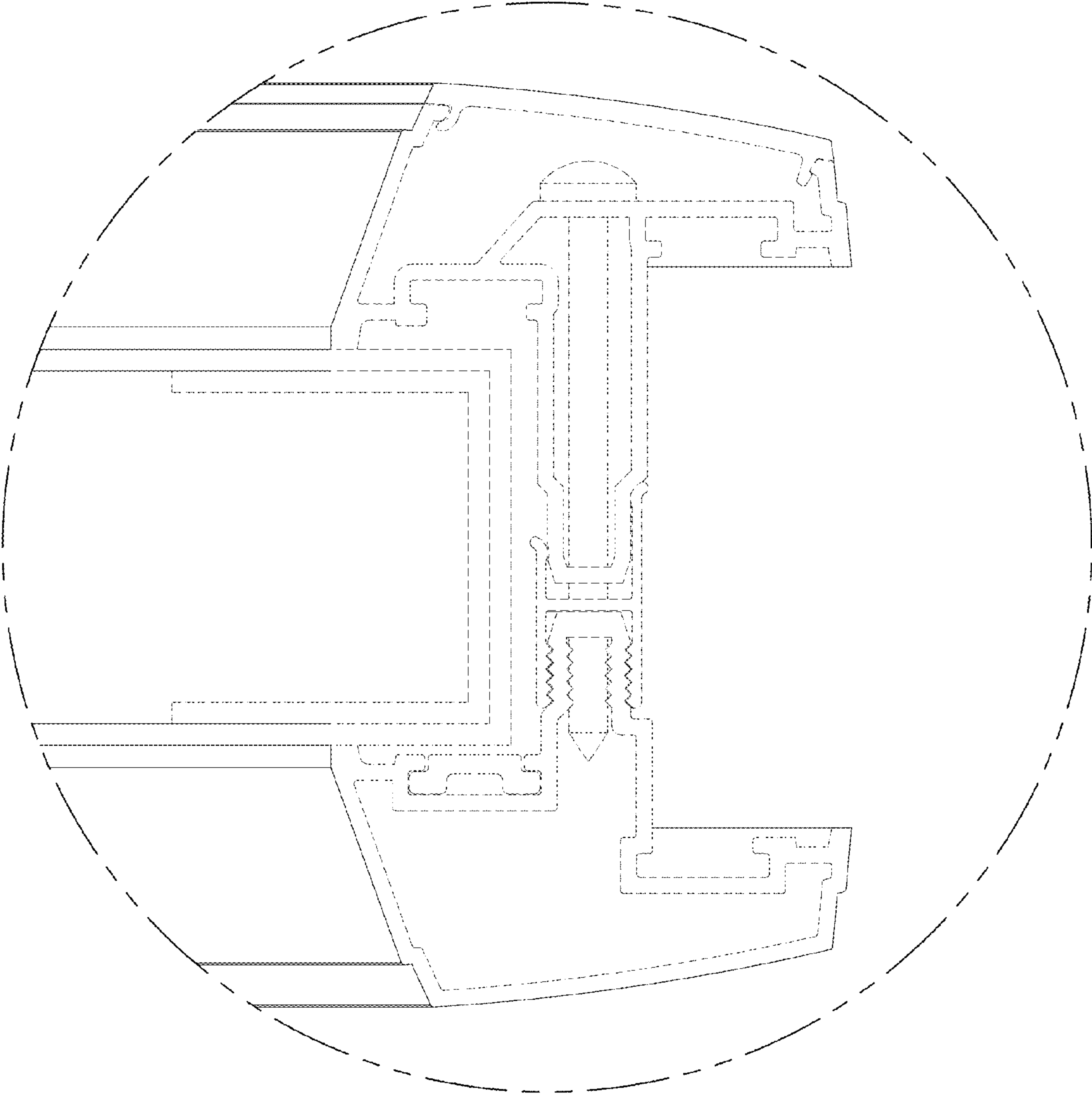

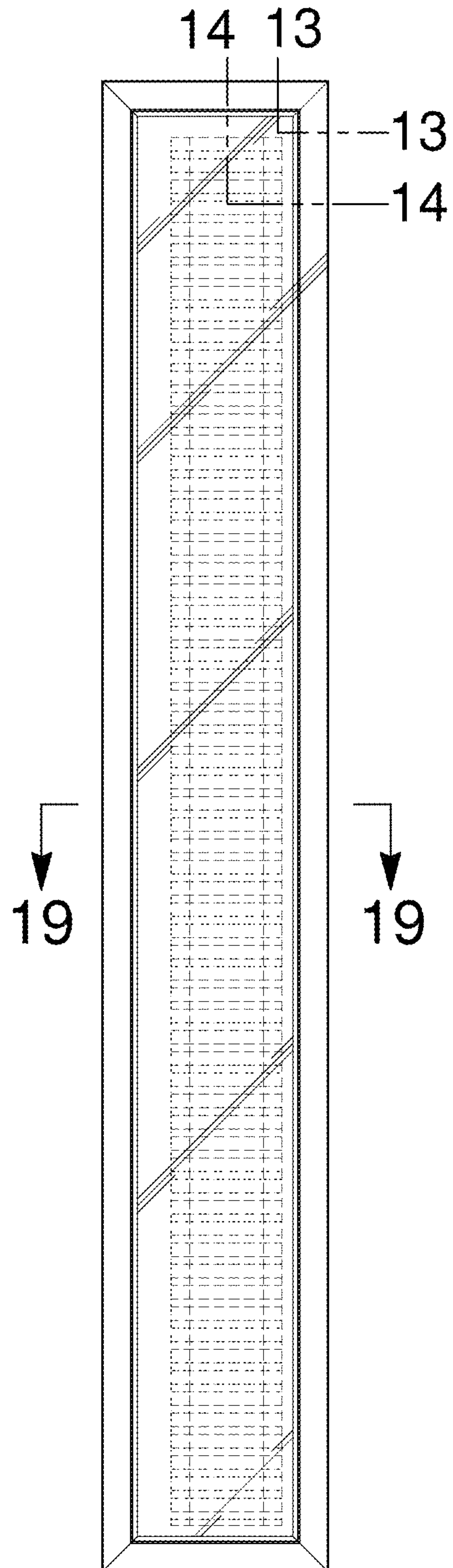

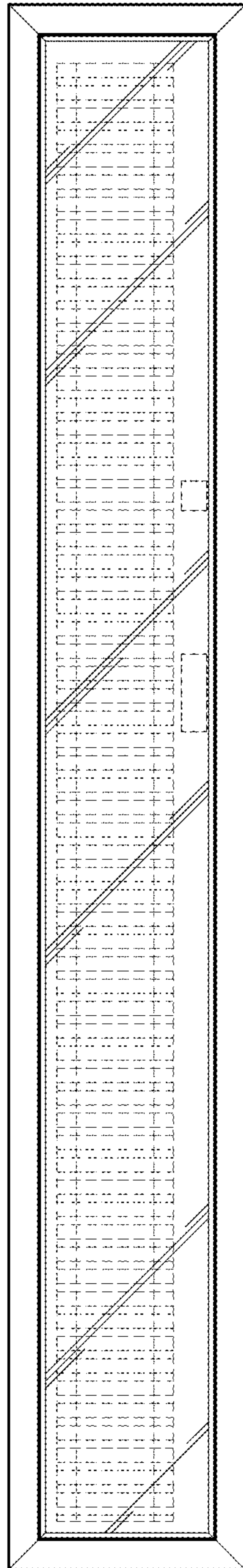

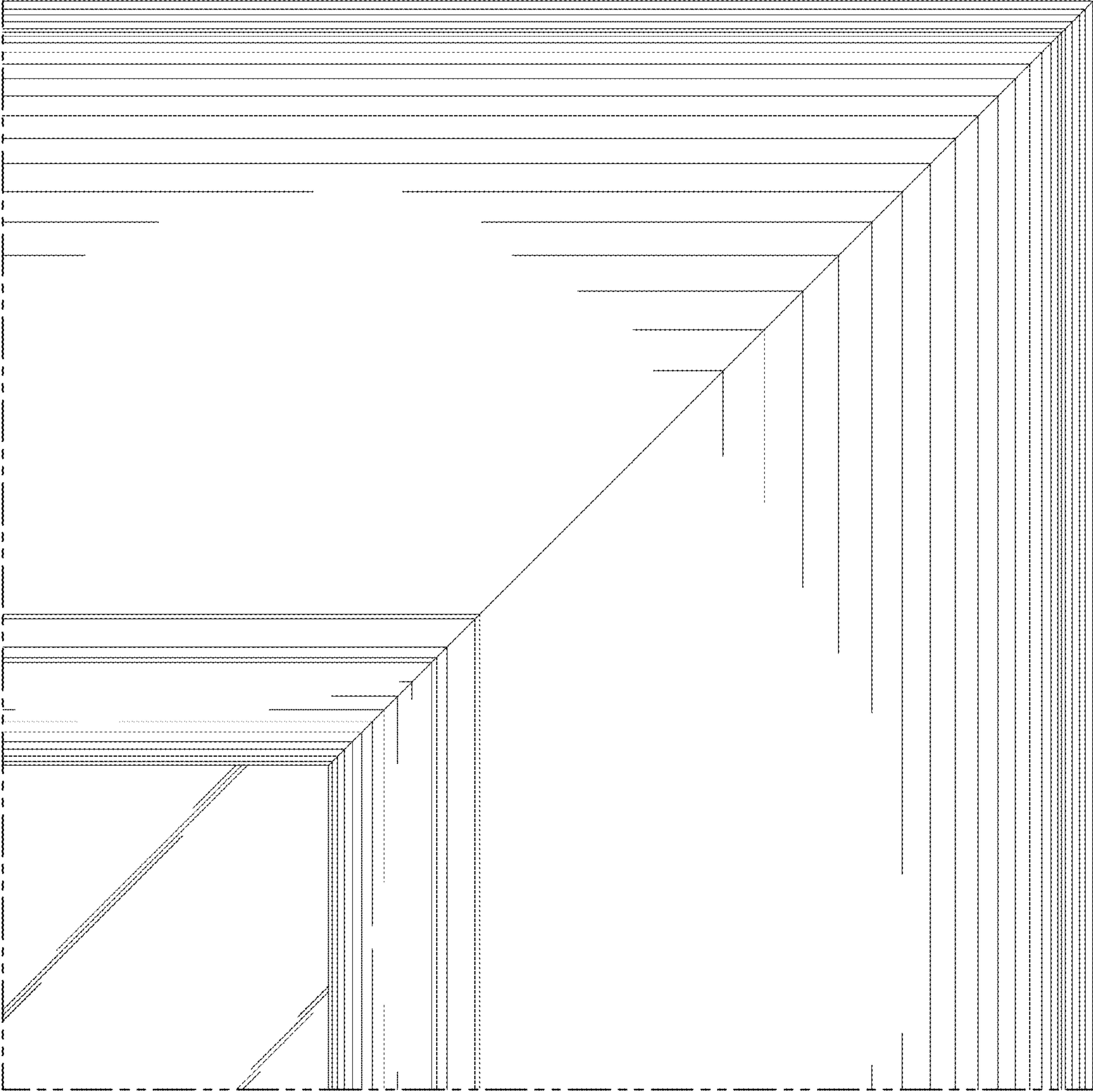

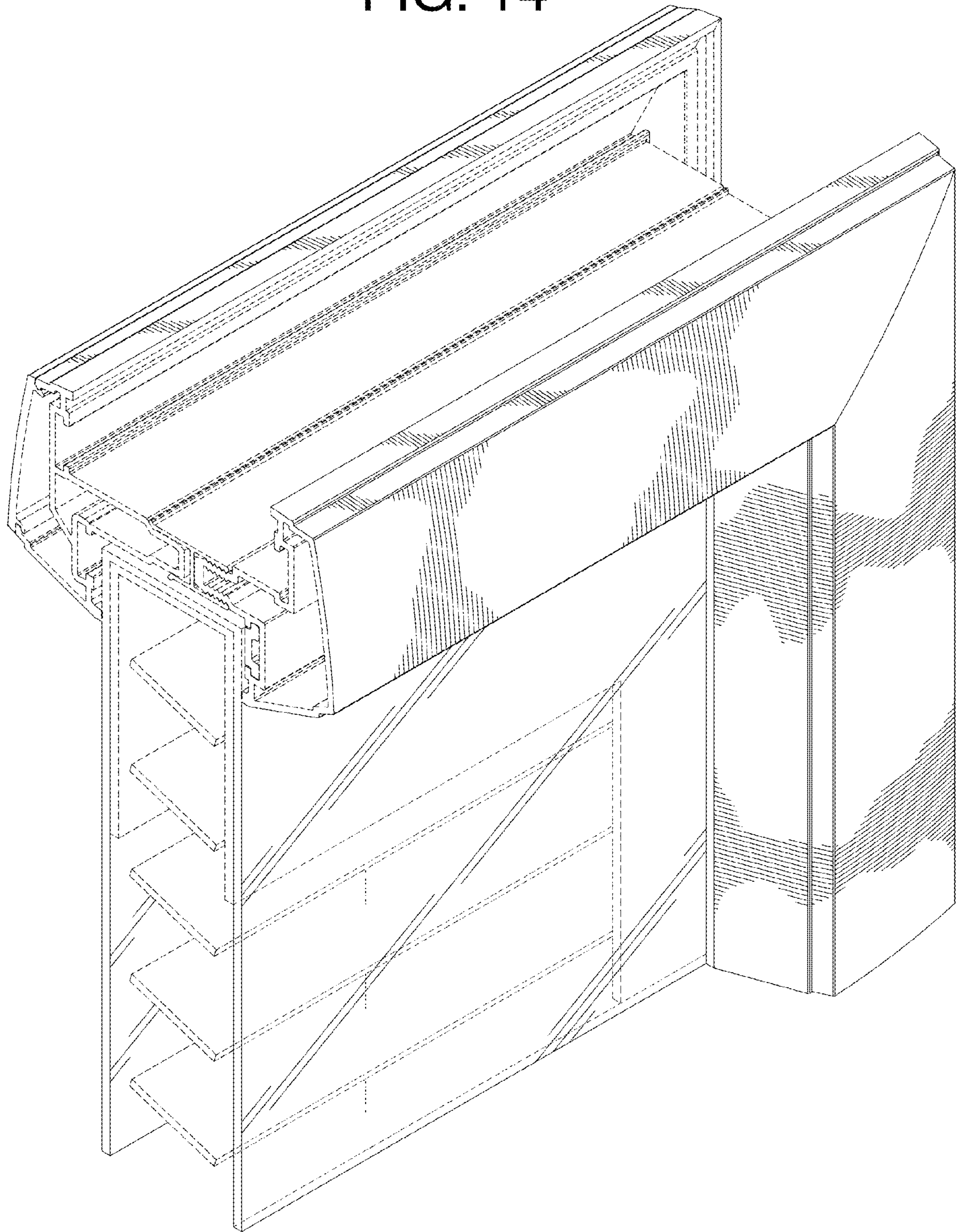

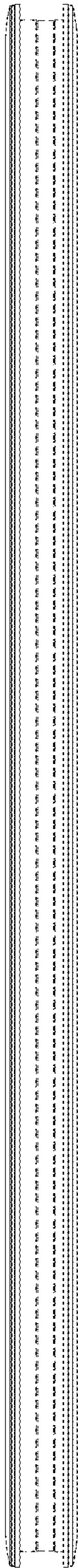

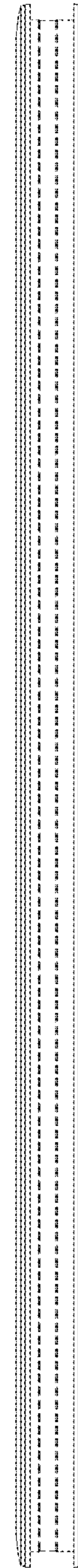

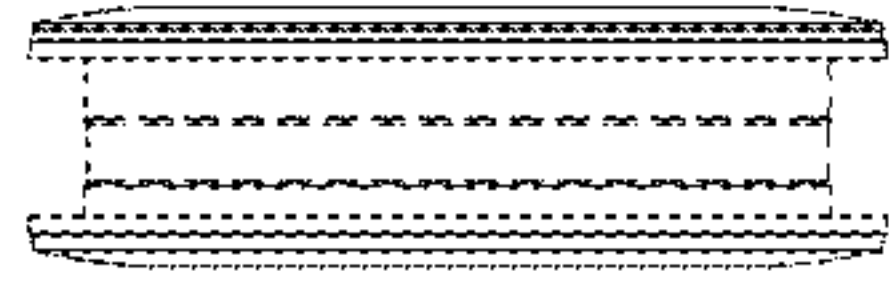

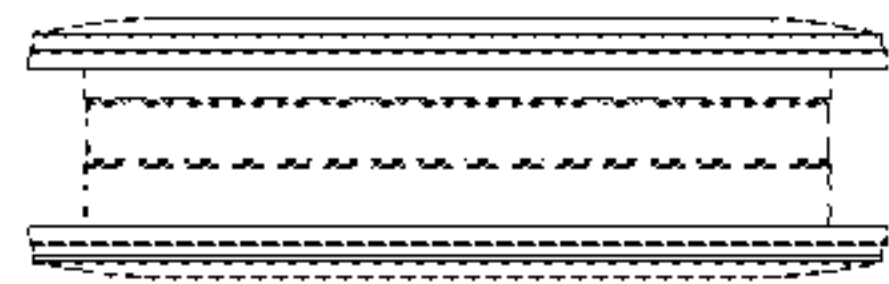

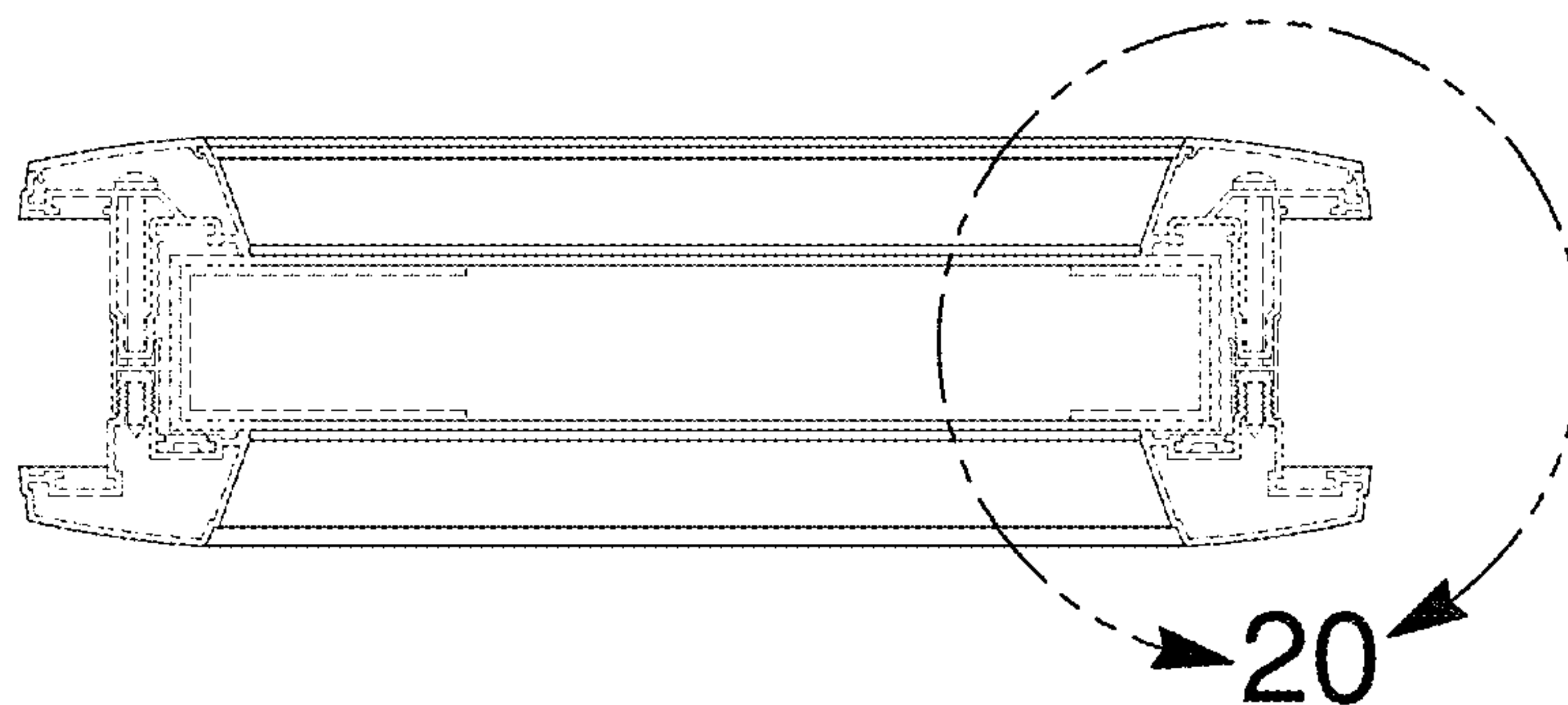

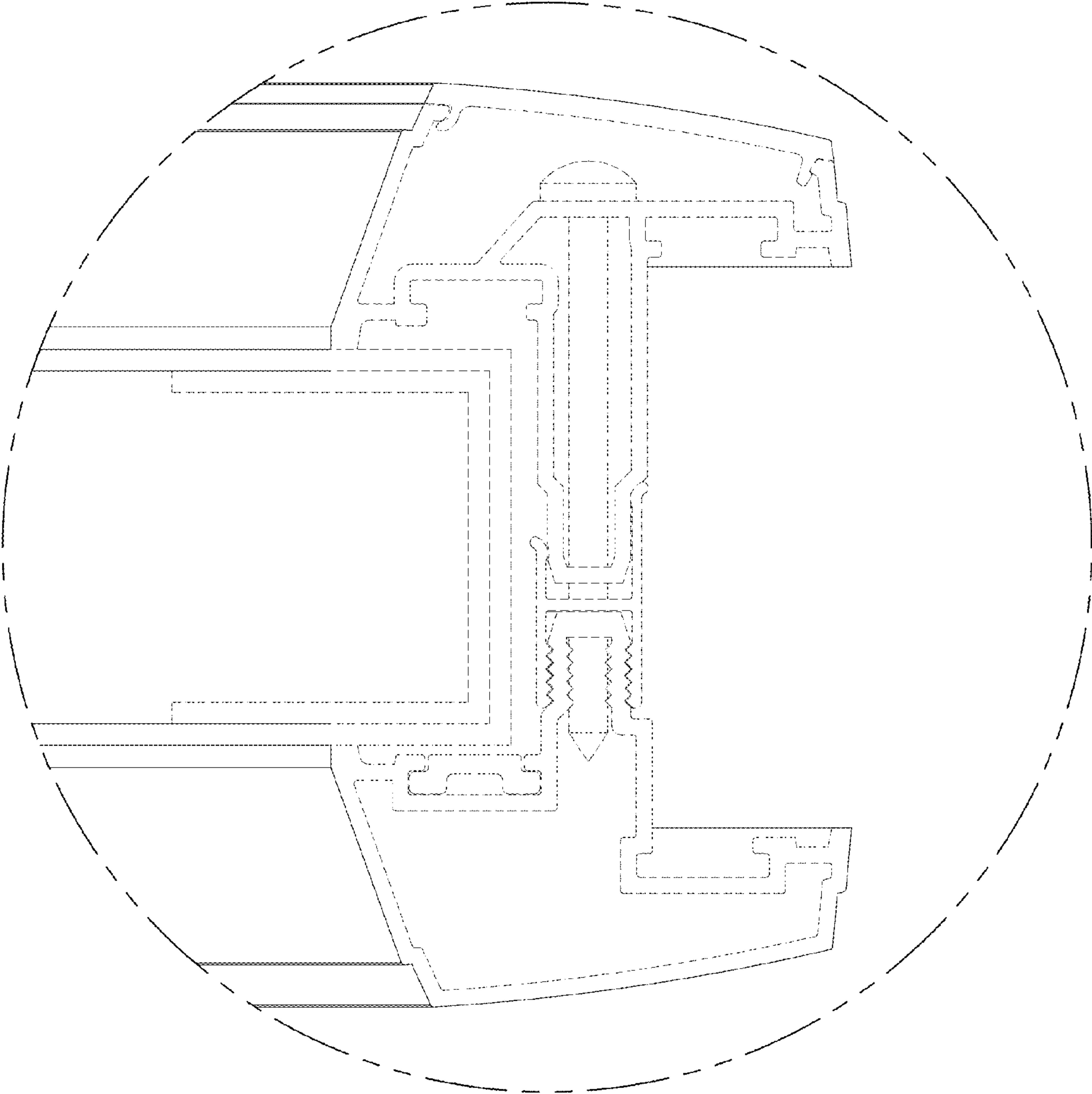

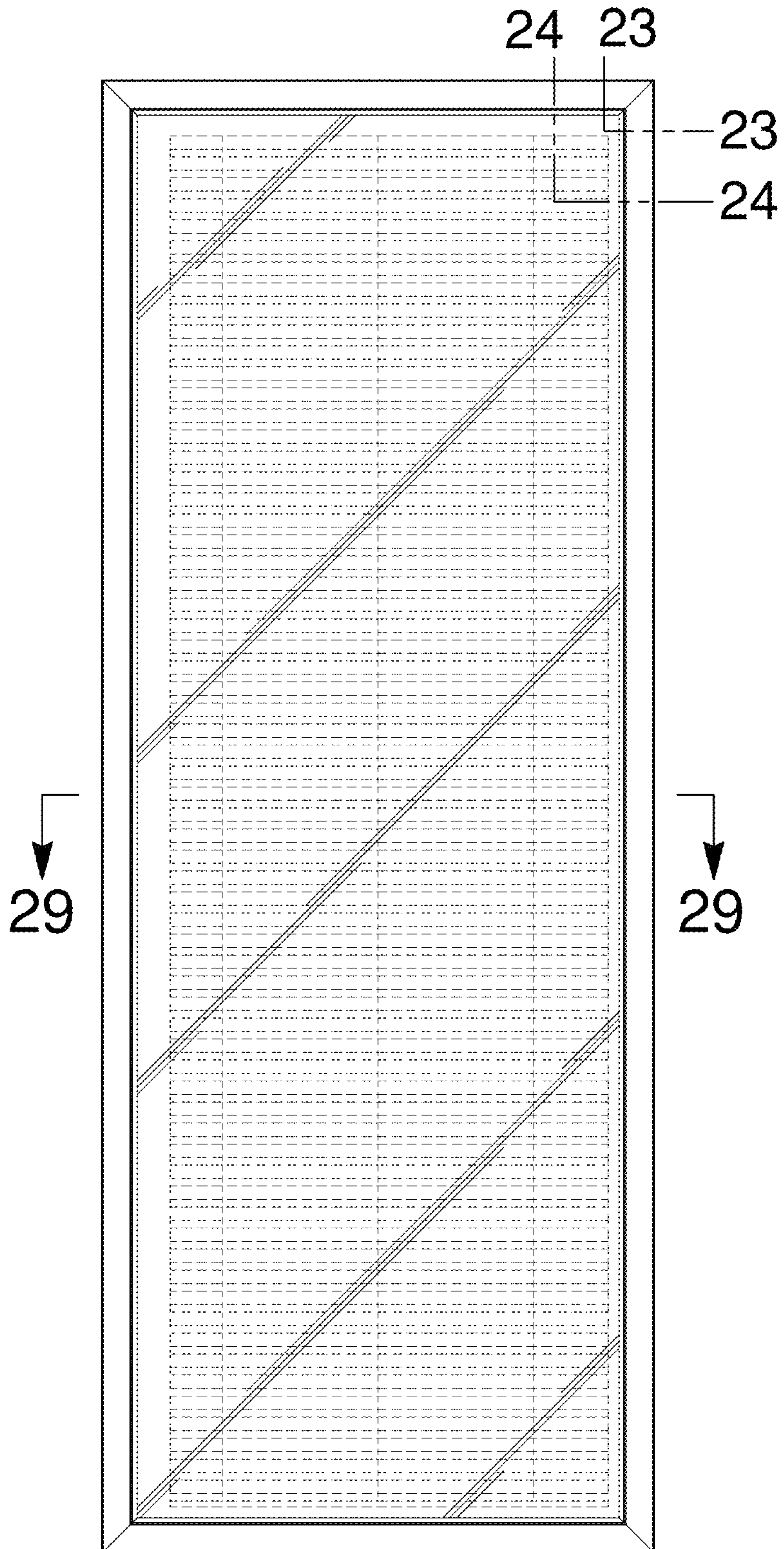

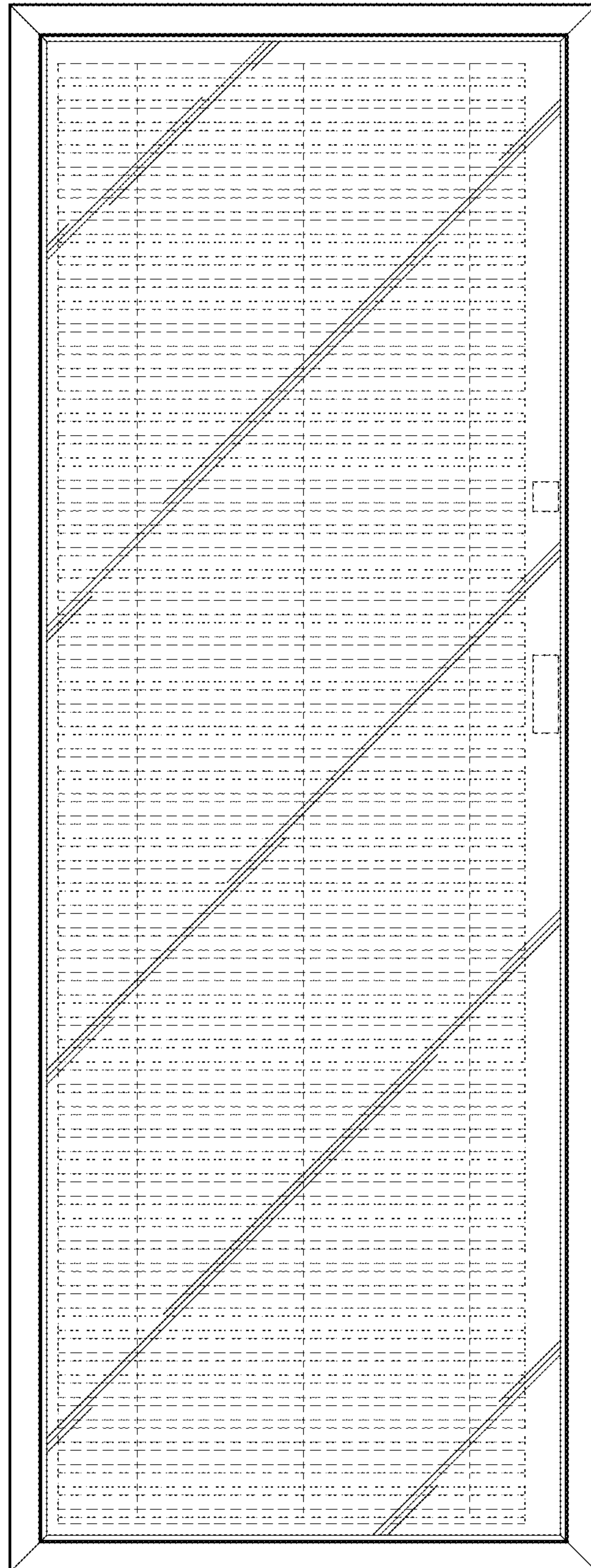

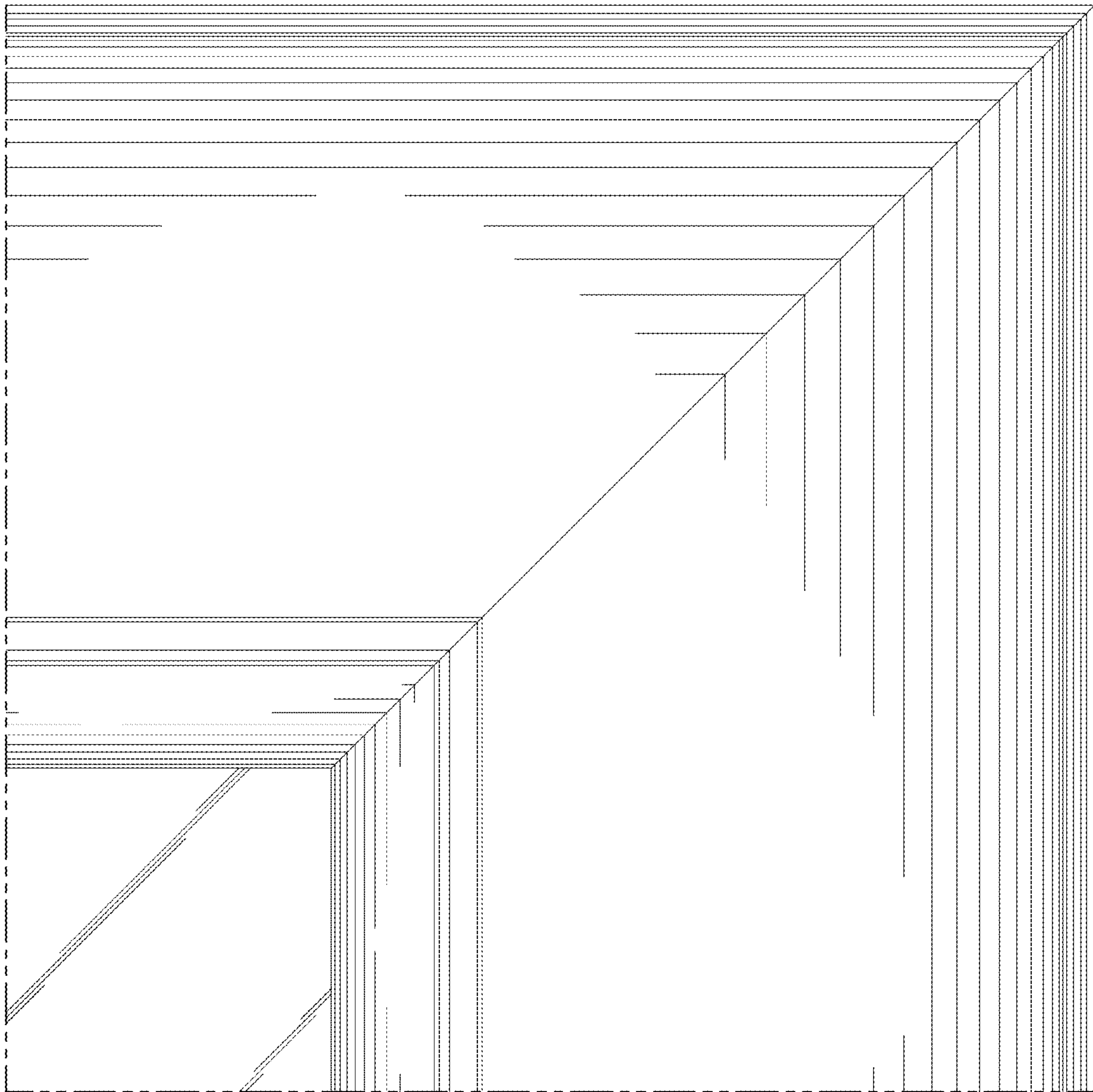

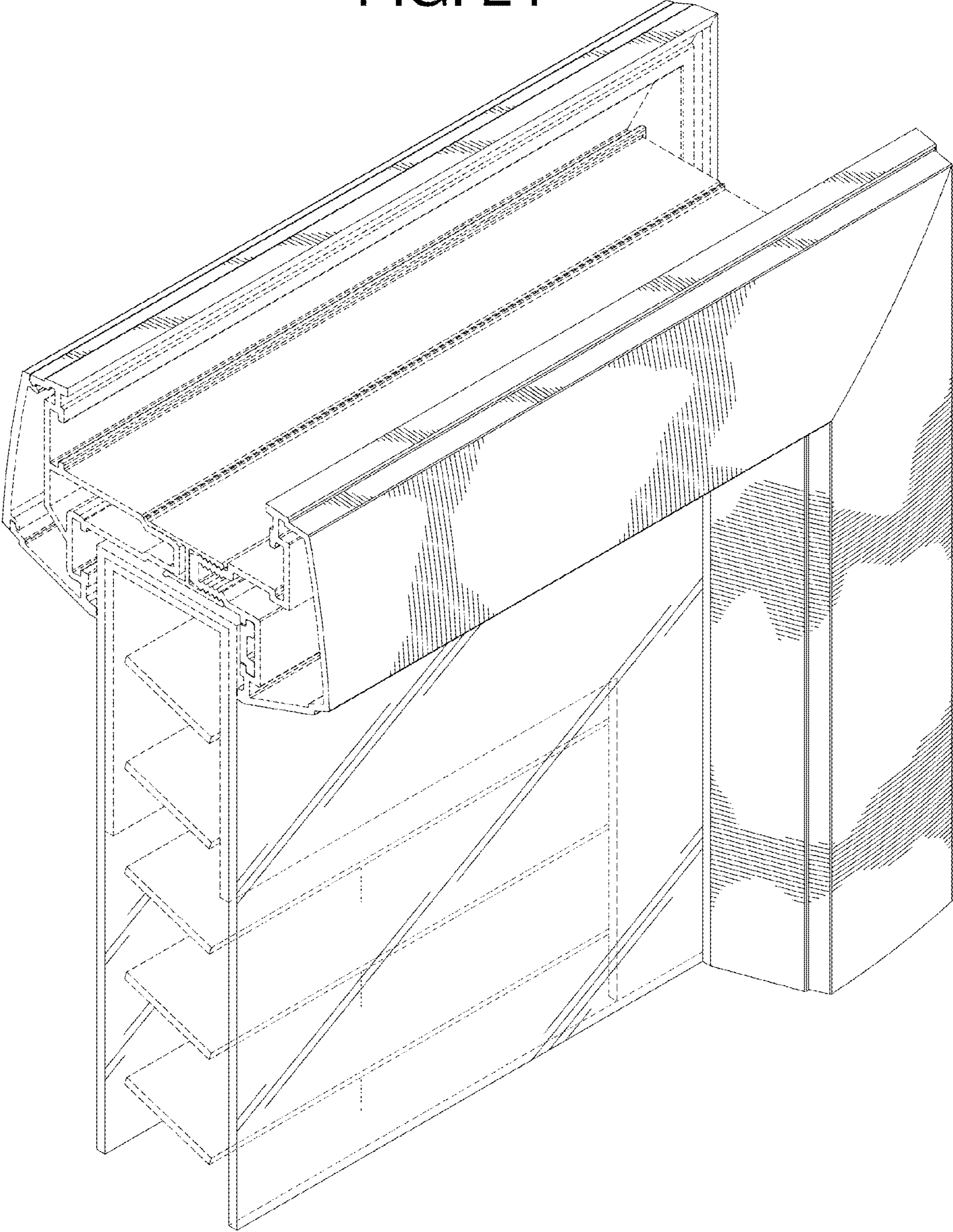

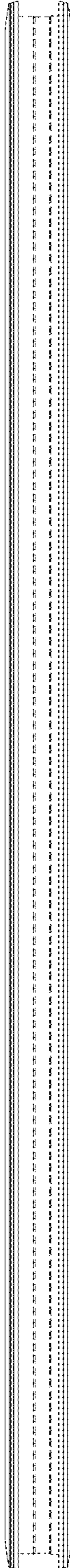

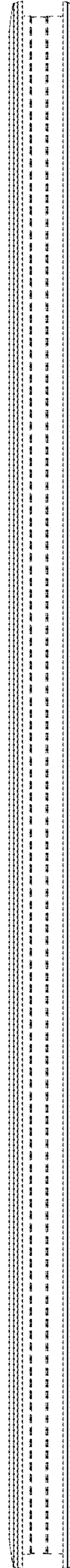

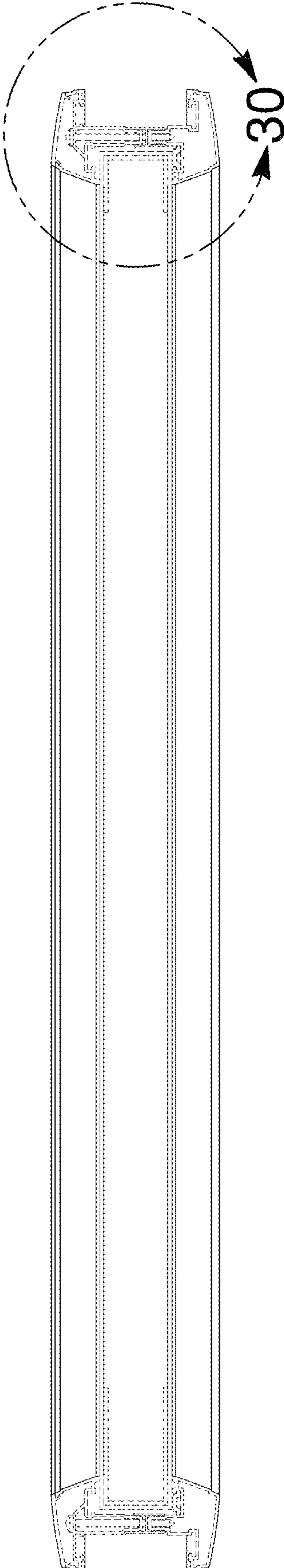

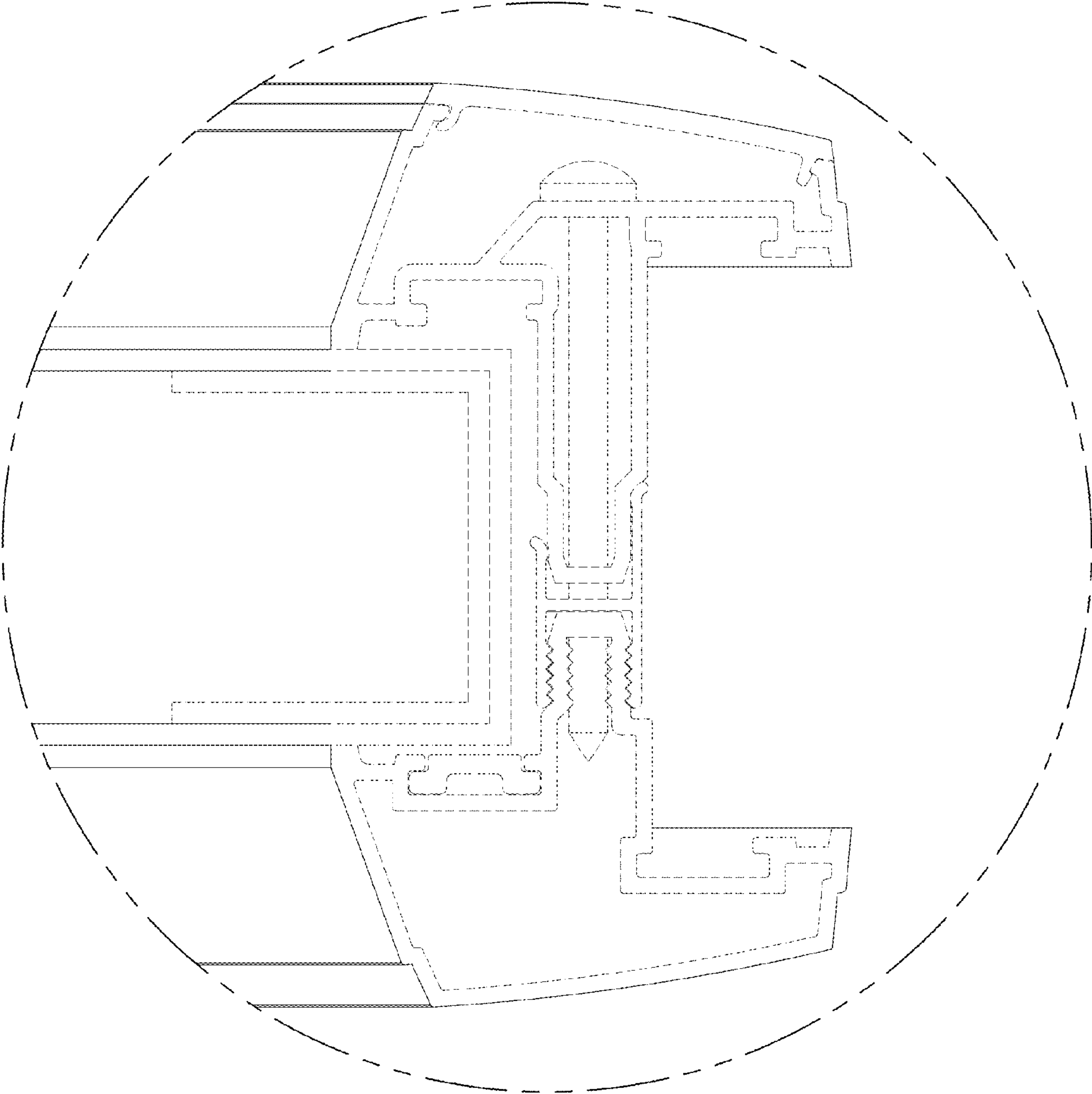

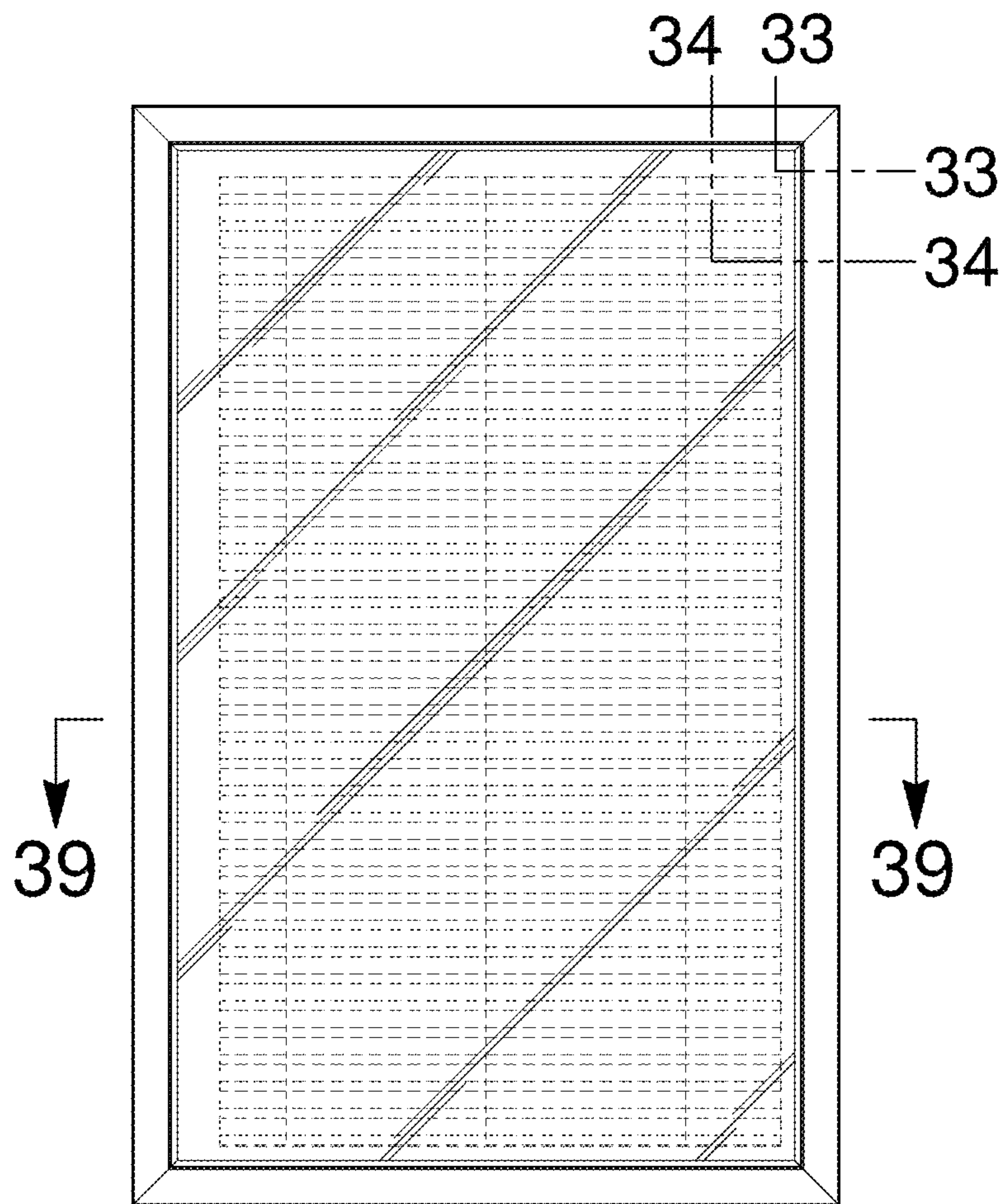

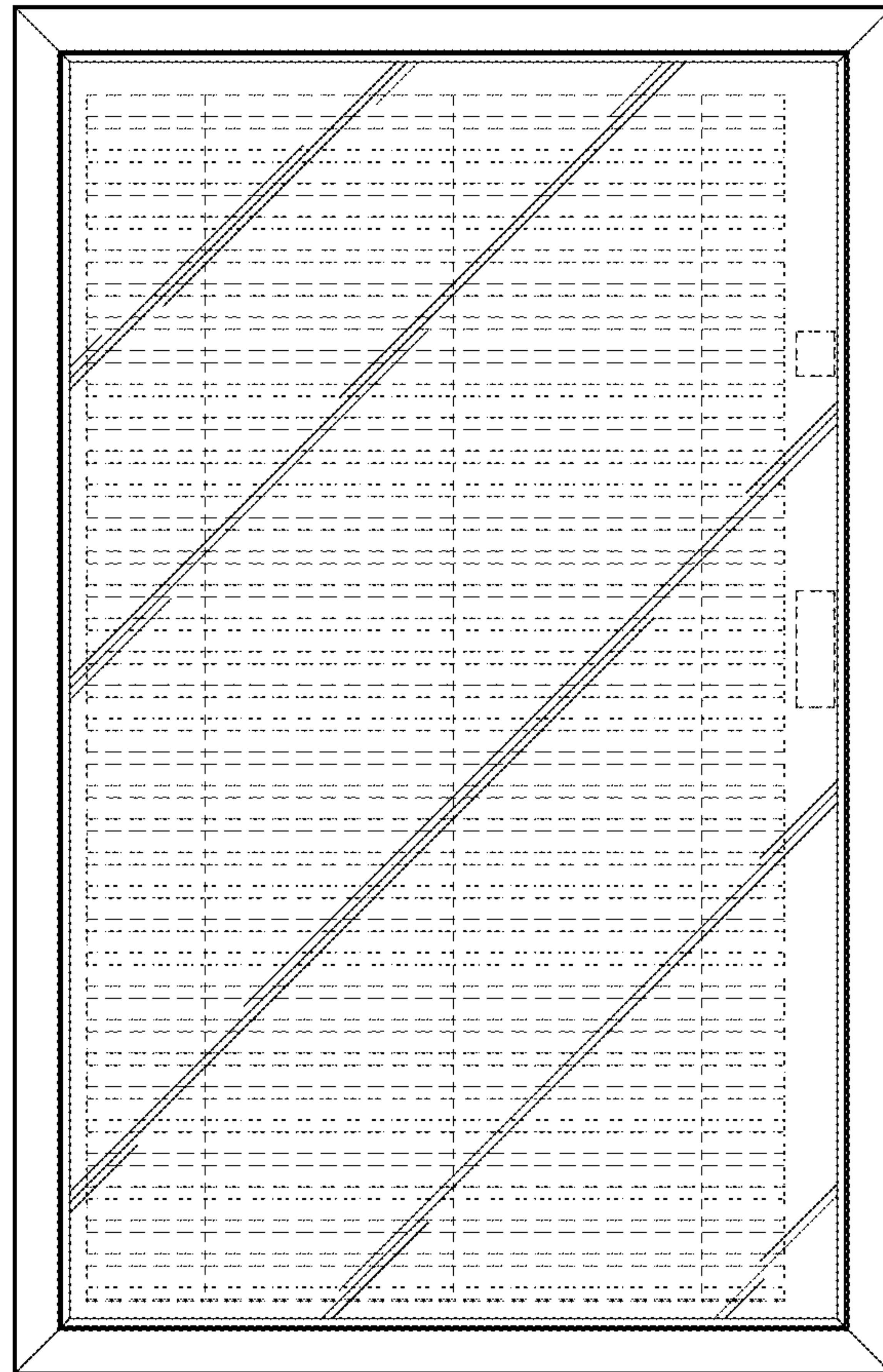

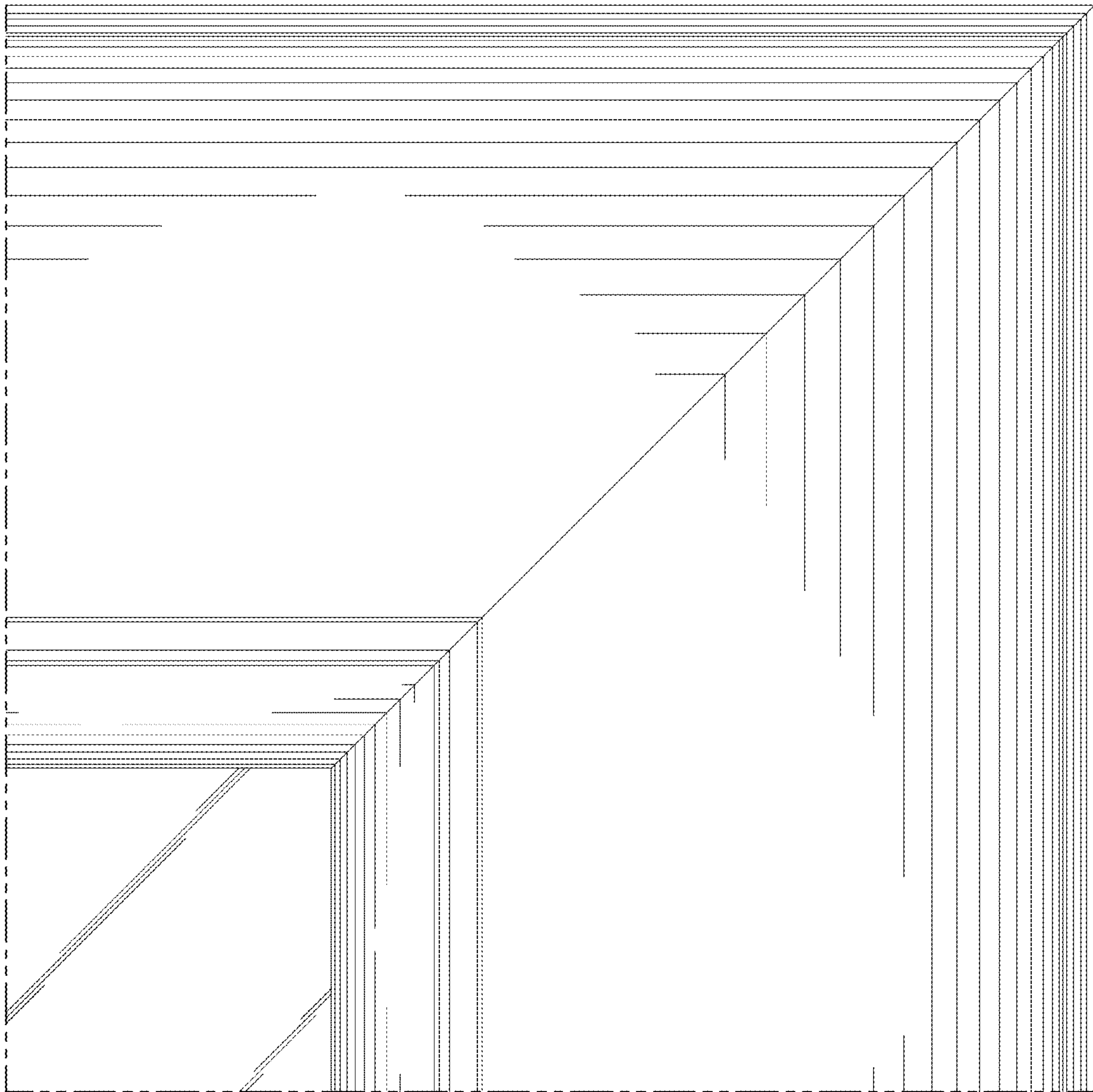

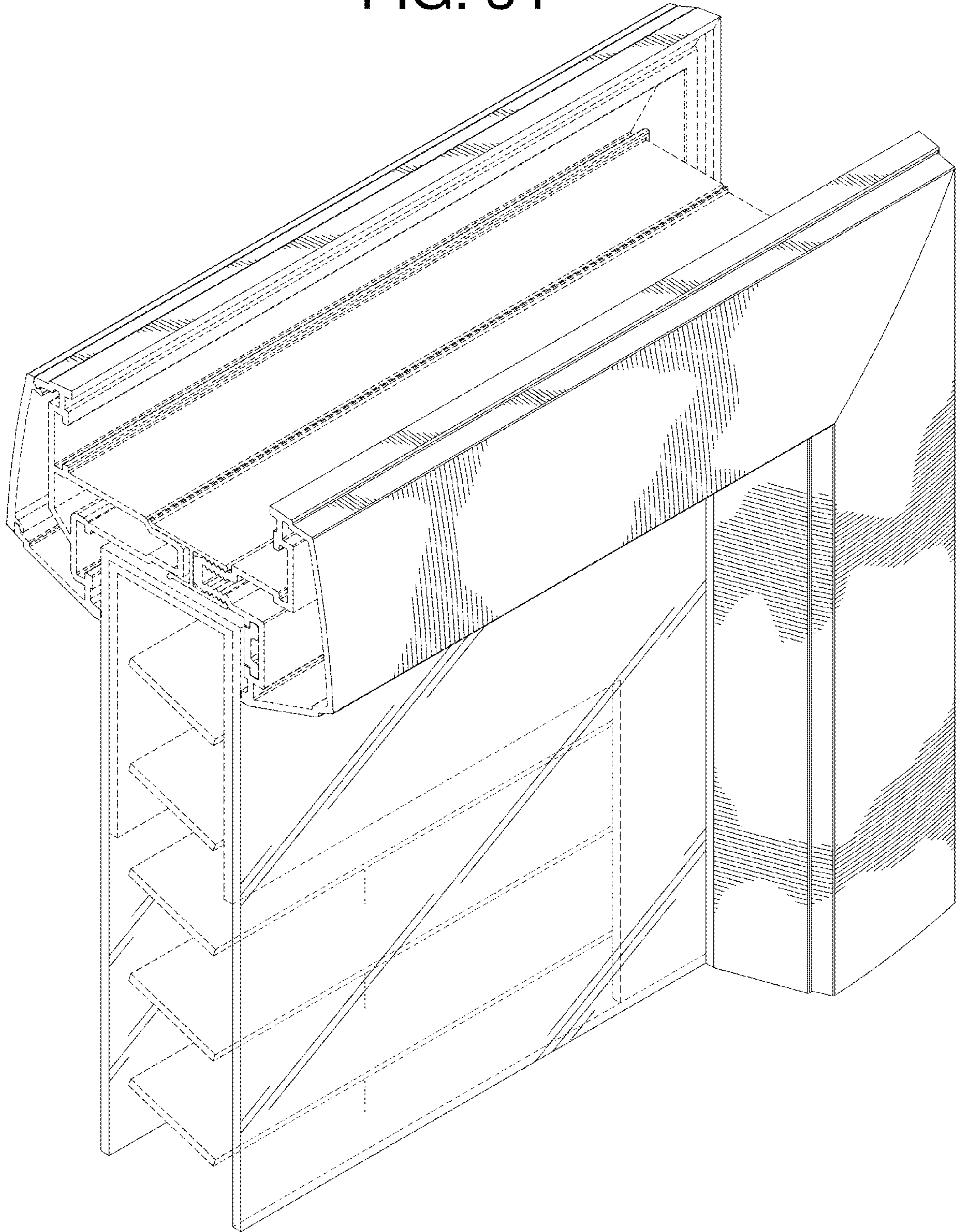

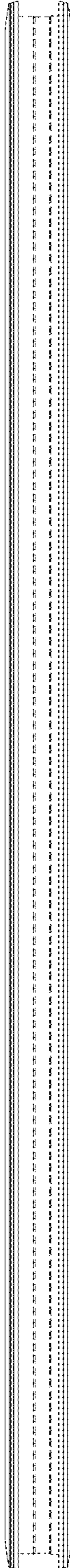

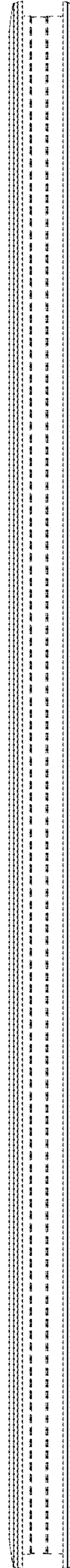

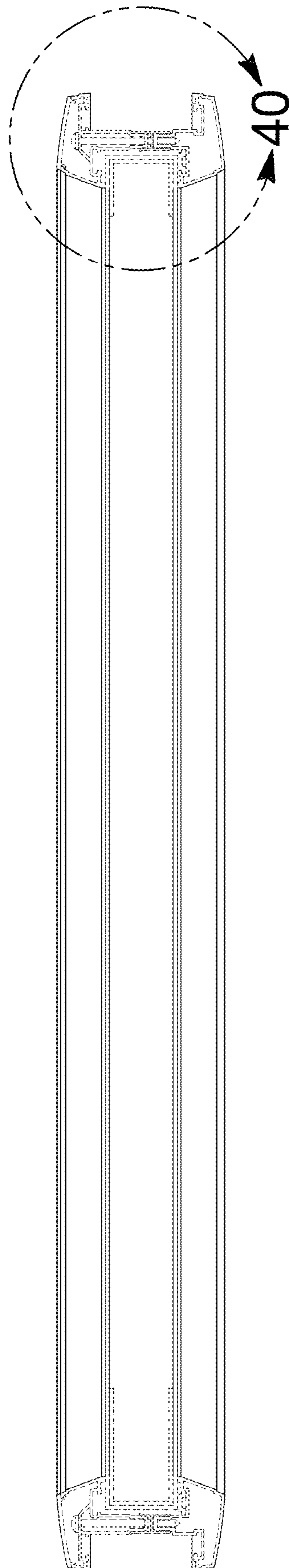

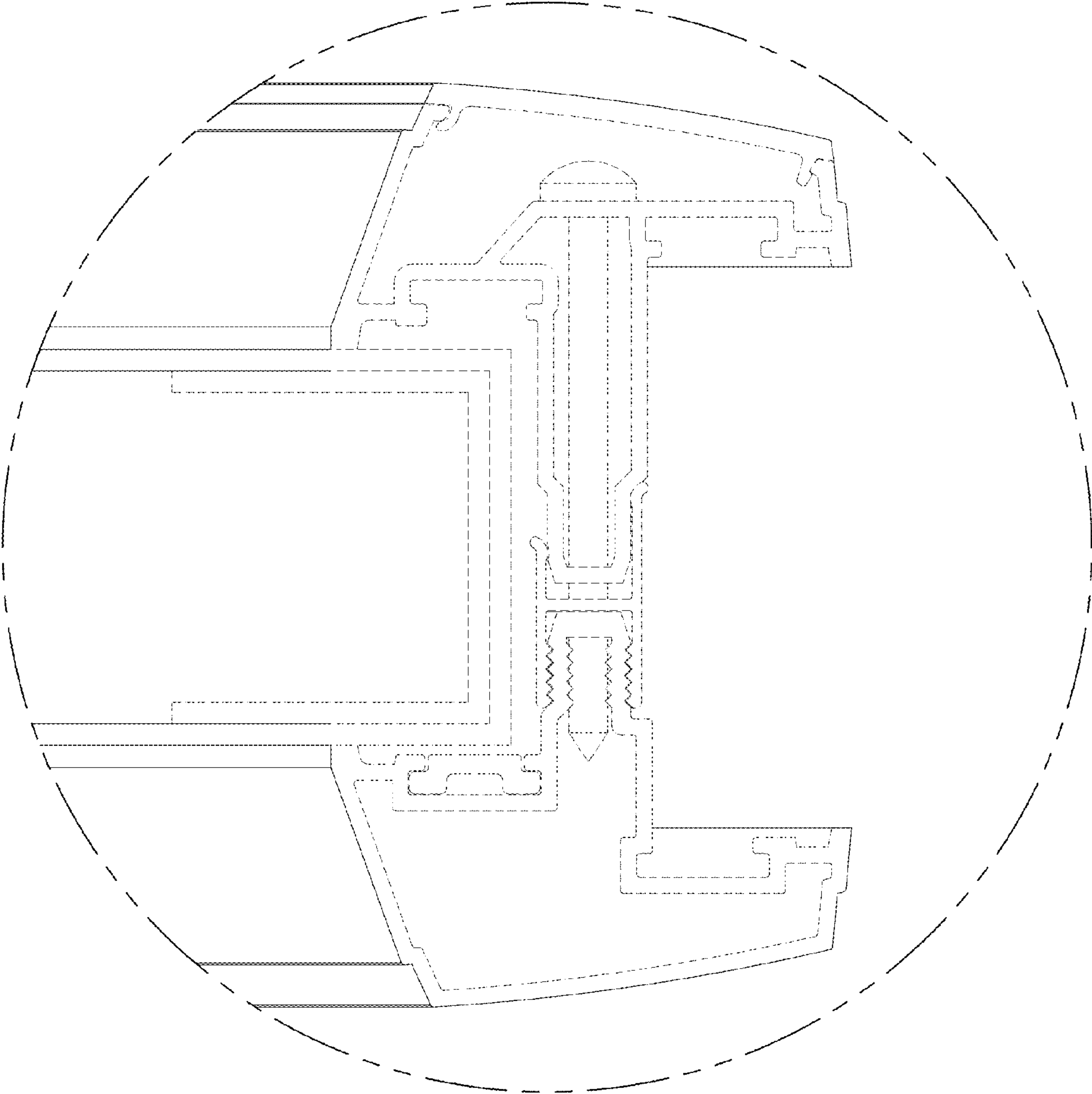

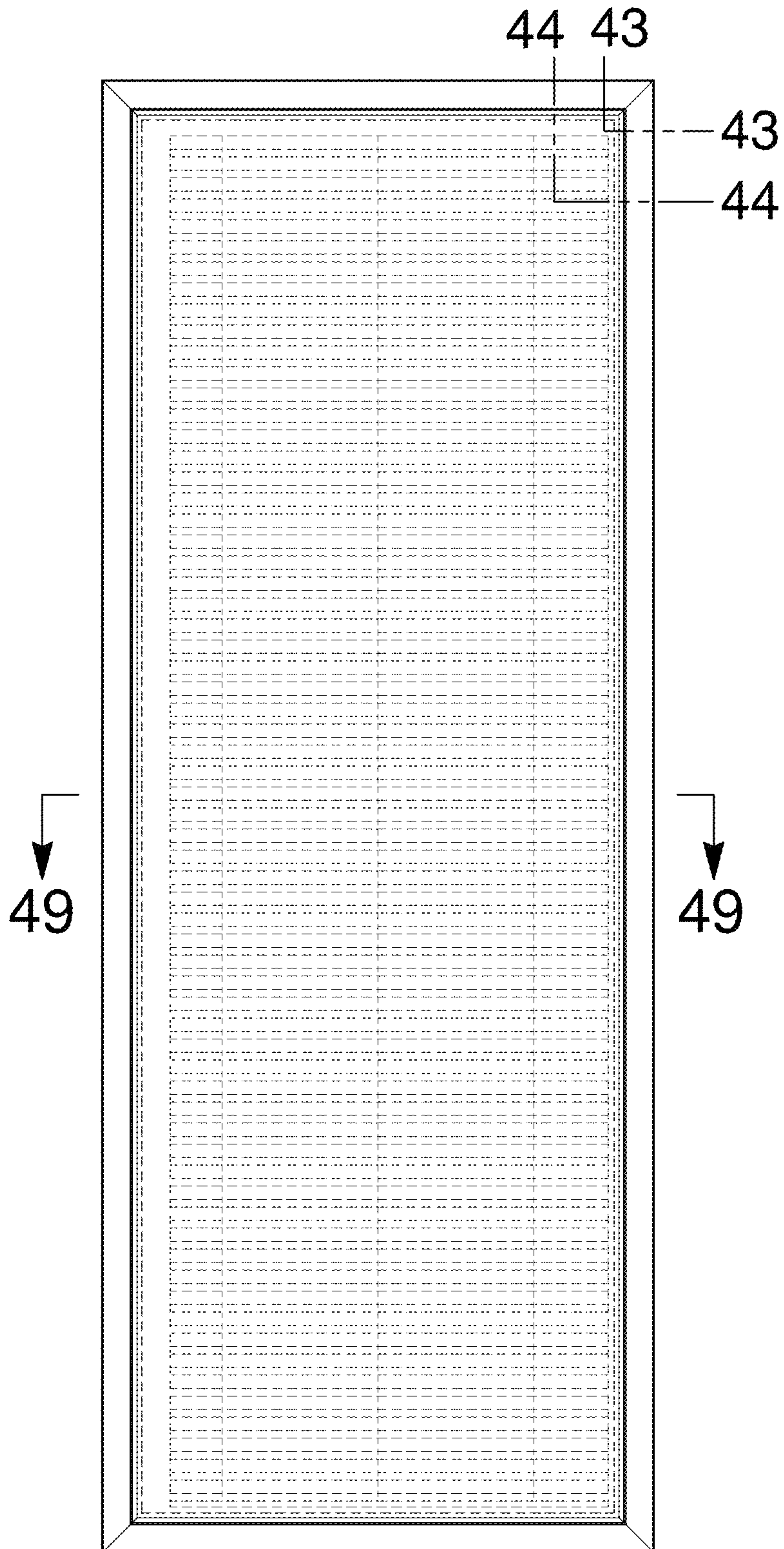

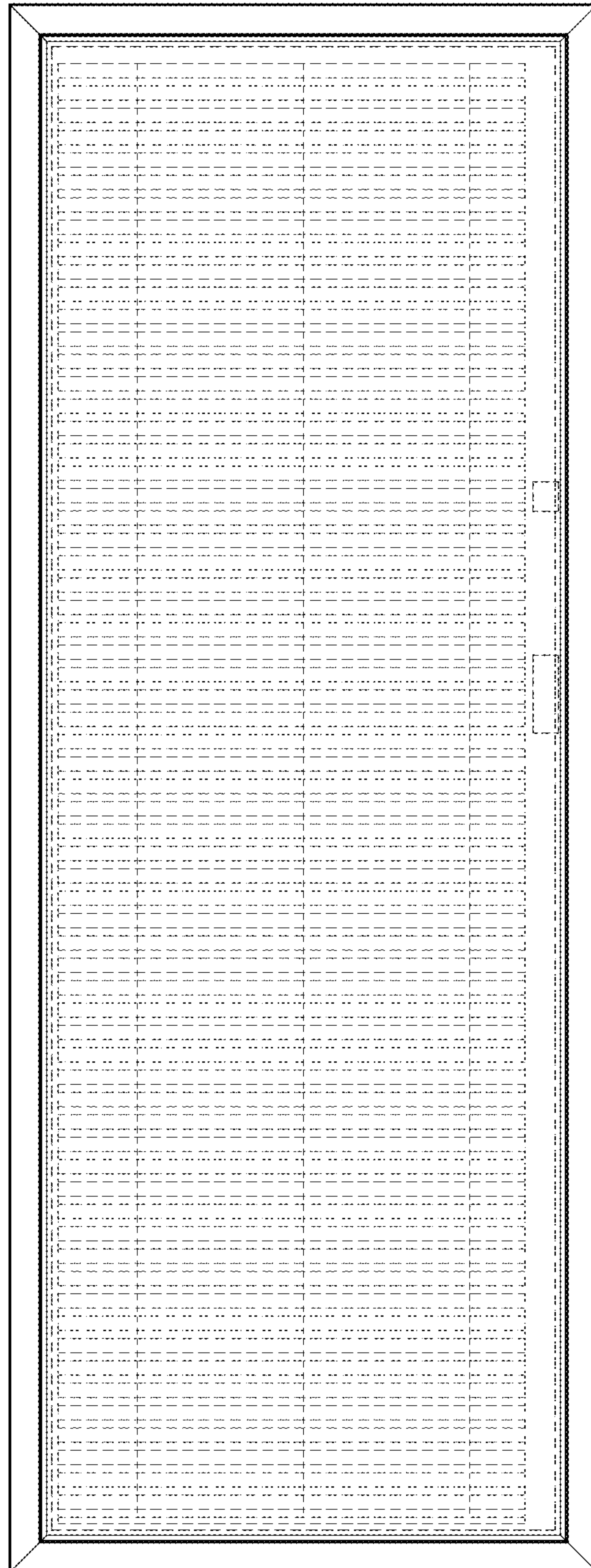

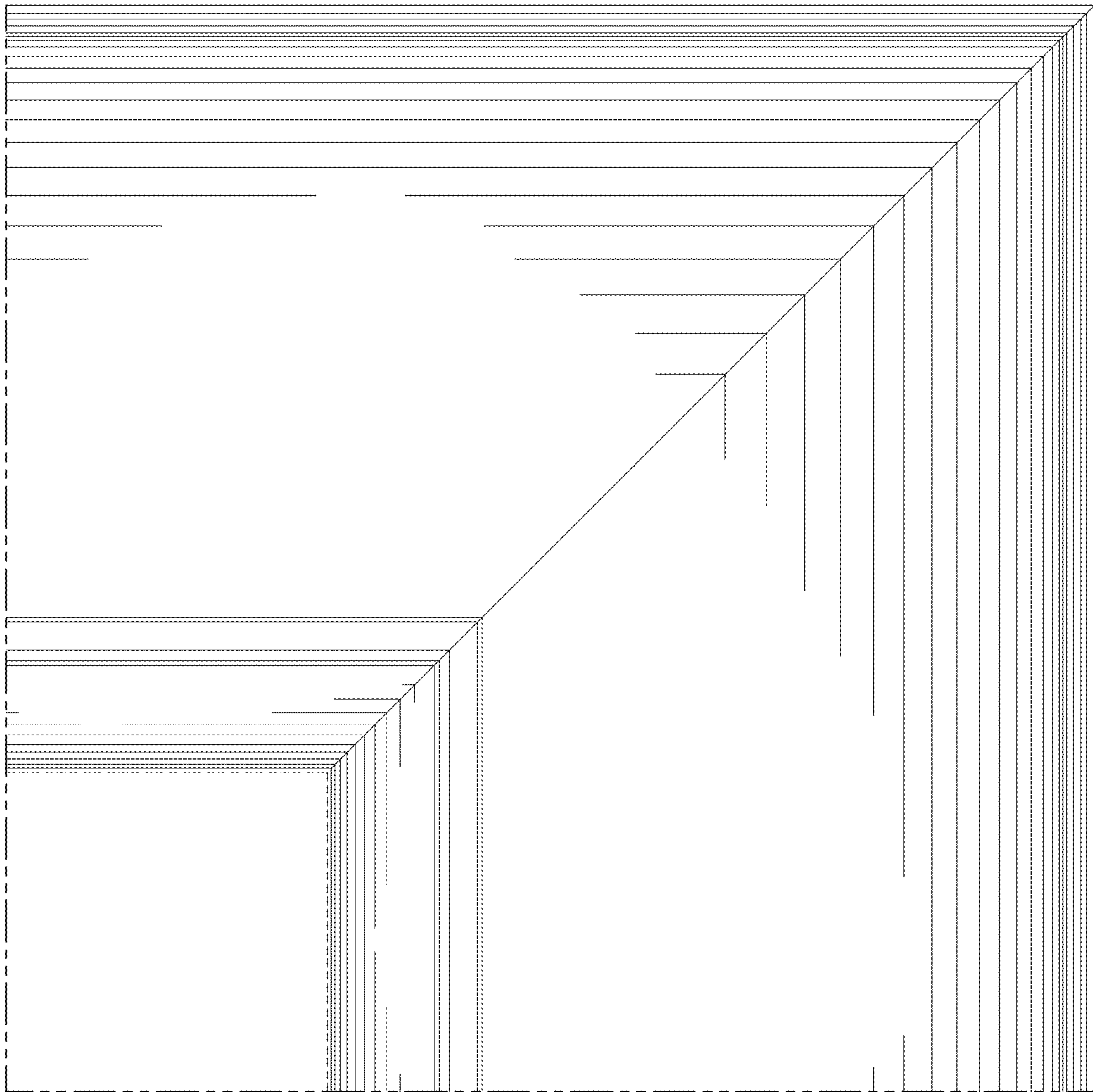

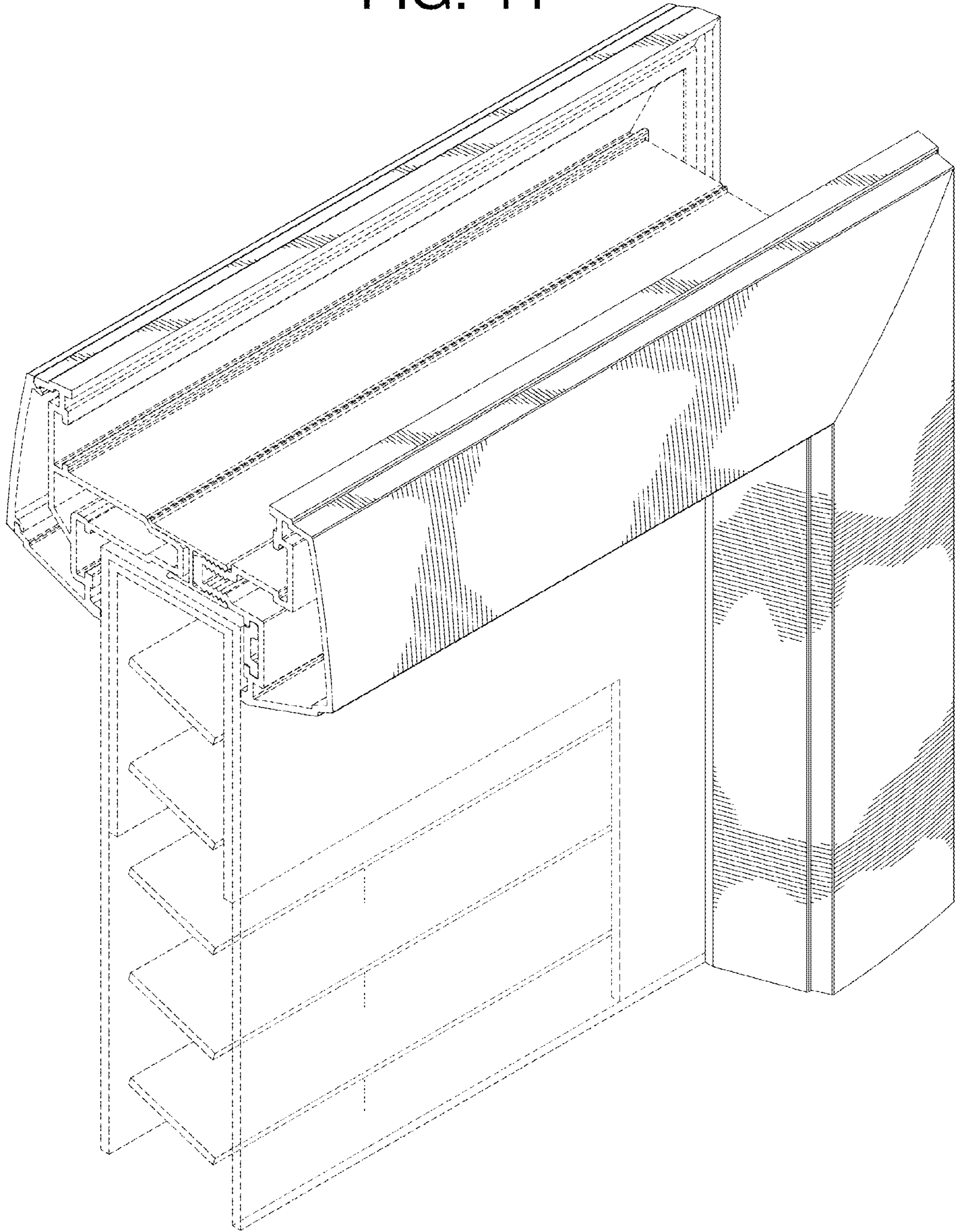

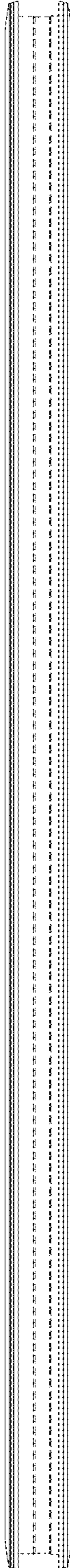

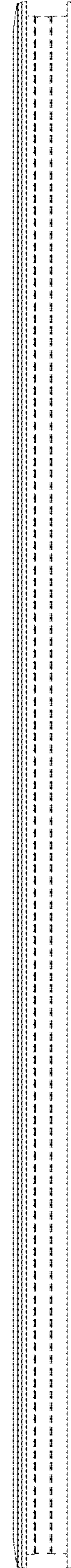

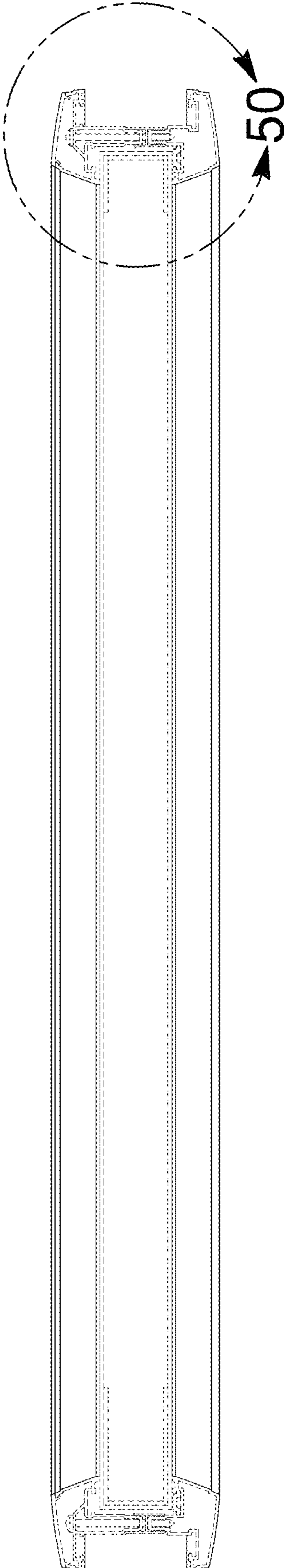

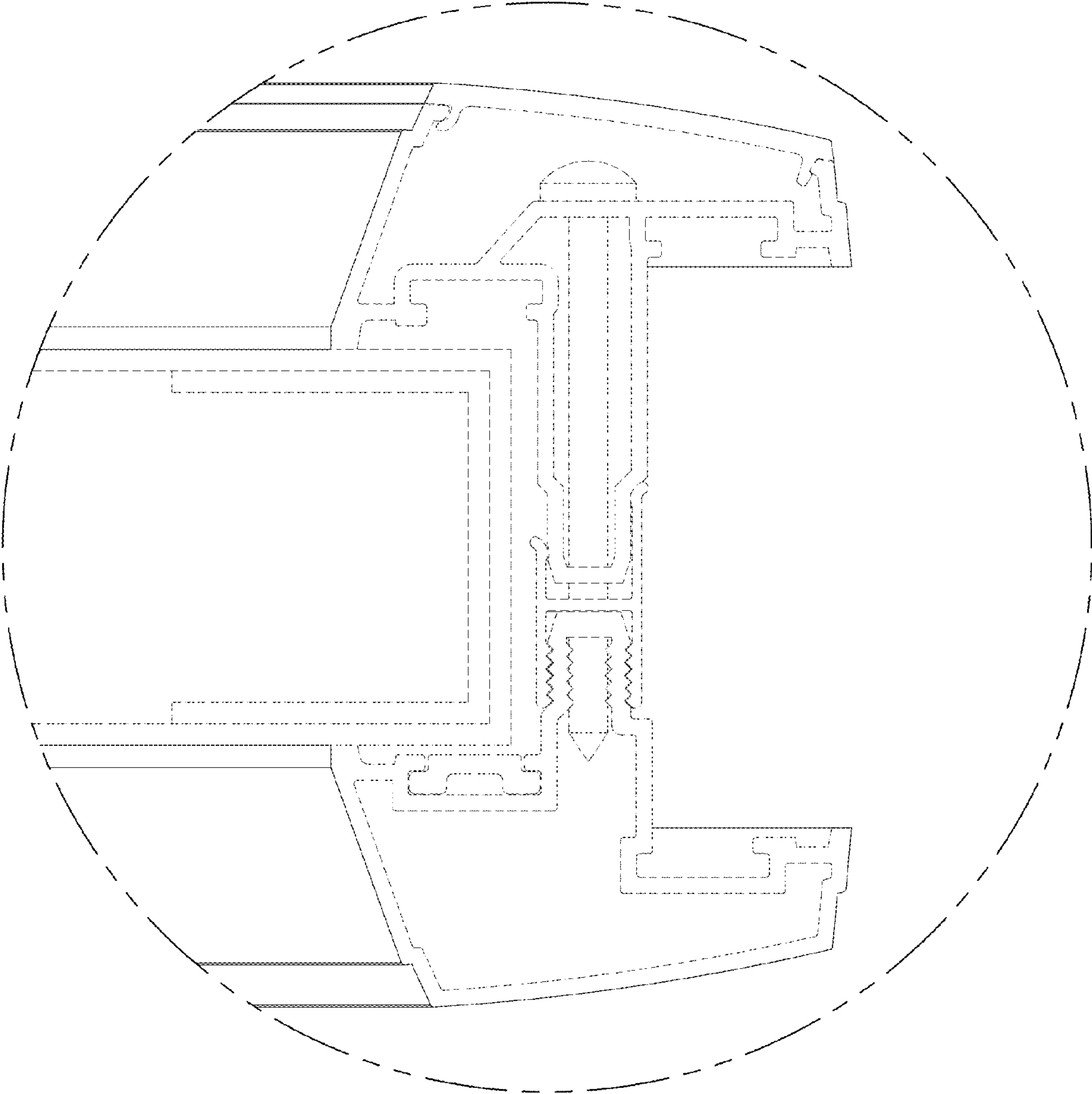

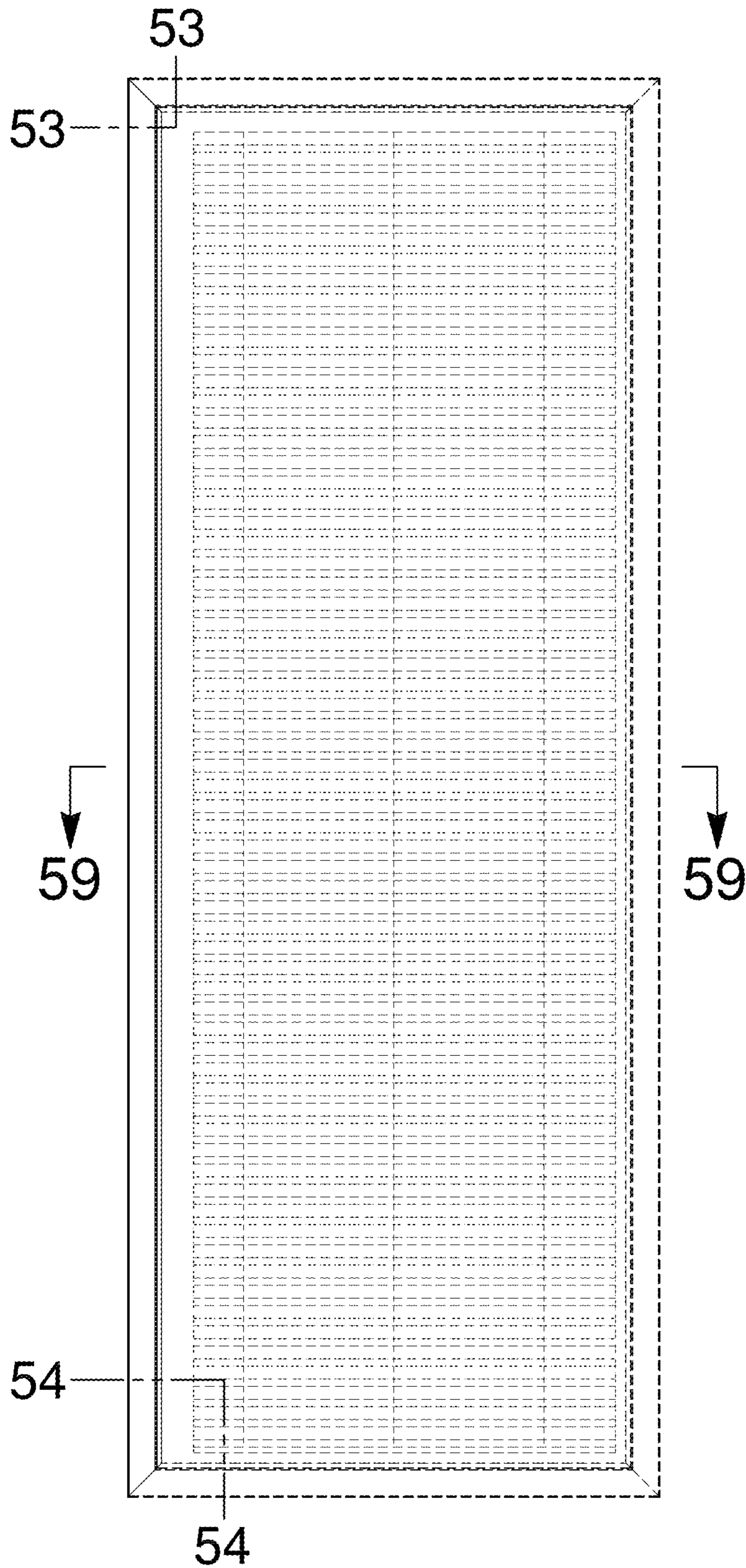

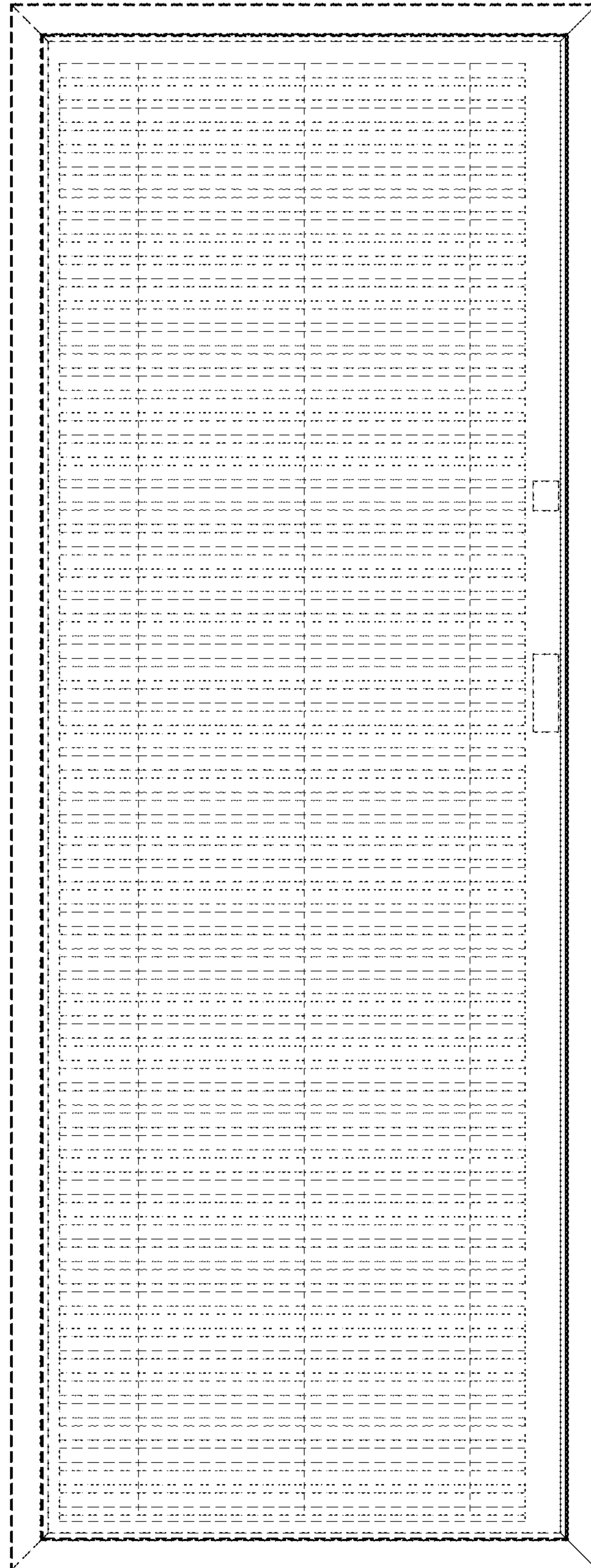

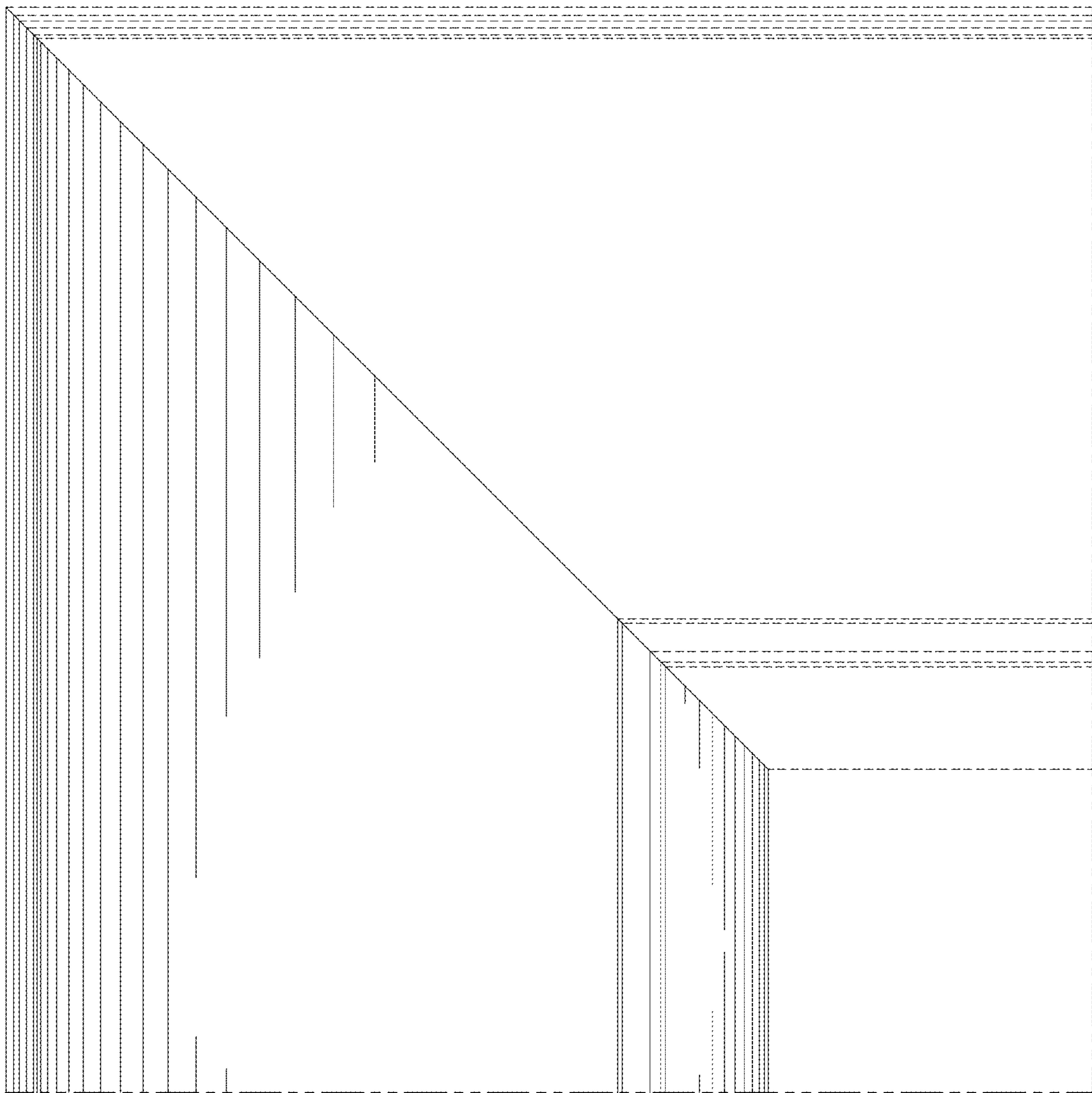

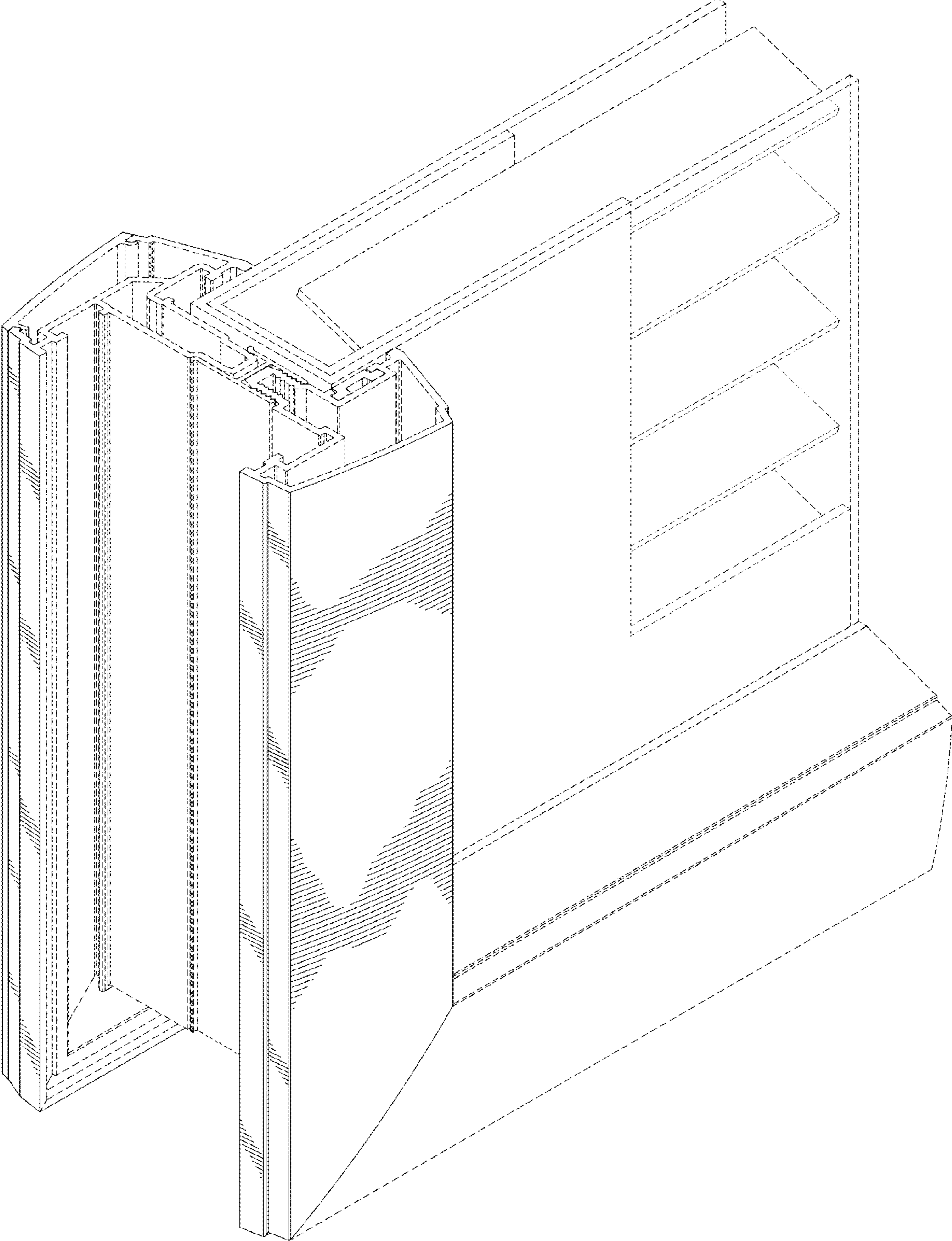

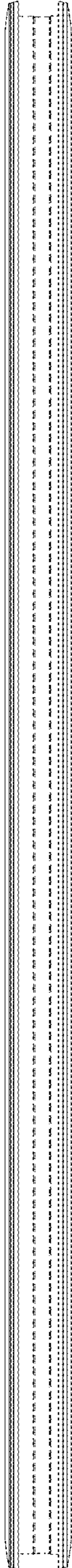

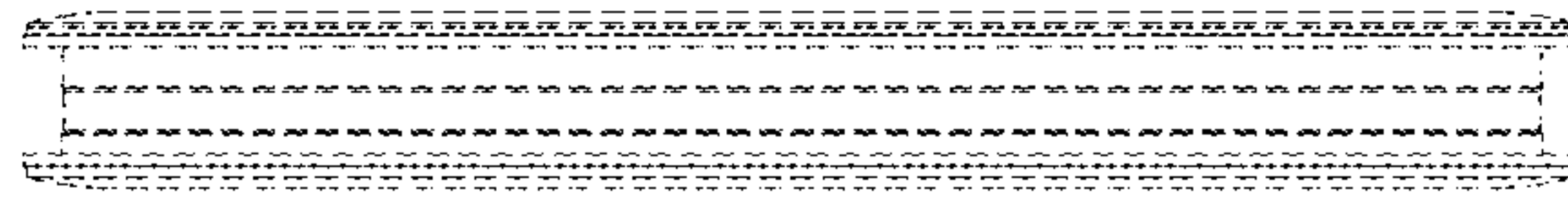

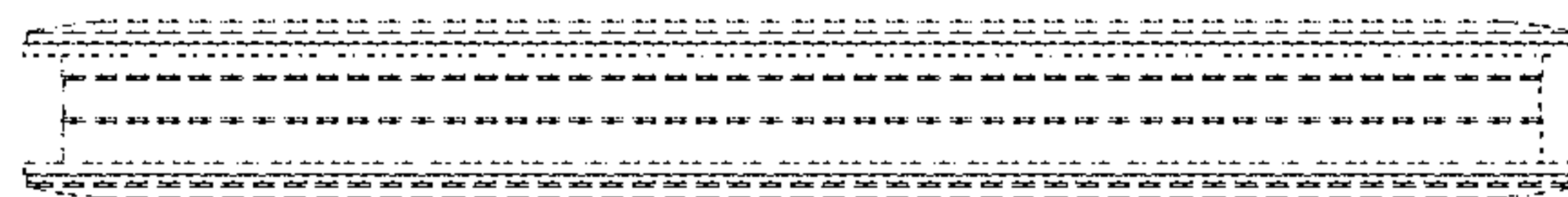

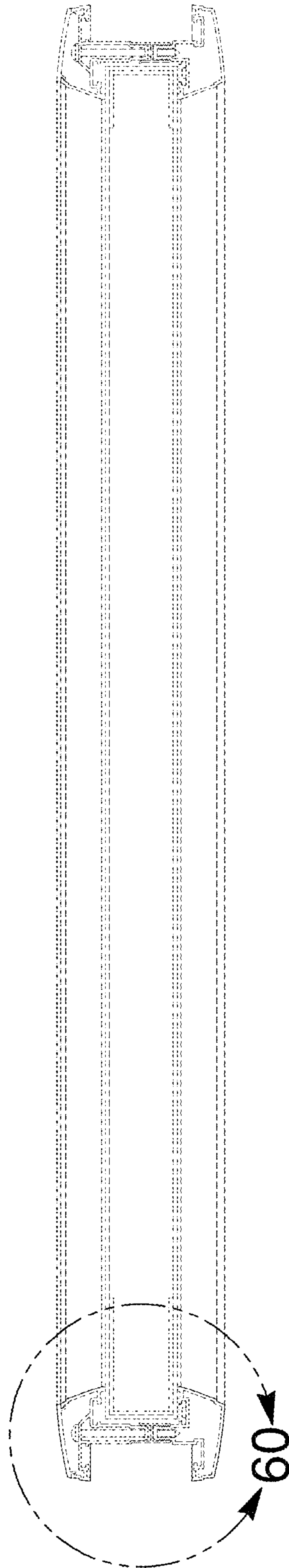
