(57) **CLAIM**

The ornamental design for a pair of magnetic gloves, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a pair of magnetic gloves, shown detached for ease of illustration.

FIG. 2 is a front perspective view of the right side thereof, the left side being a mirror image thereof;

FIG. 3 is a rear view of the right side thereof, the left side being a mirror image thereof; shown detached for ease of illustration;

FIG. 4 is a top view of the right side thereof, the left side being a mirror image thereof; shown detached for ease of illustration;

FIG. 5 is a front view of the right side thereof, the left side being a mirror image thereof; shown detached for ease of illustration;

FIG. 6 is an end view of the right side thereof, the left side being a mirror image thereof; shown detached for ease of illustration;

FIG. 7 is an opposite end view of the right side thereof, the left side being a mirror image thereof; shown detached for ease of illustration;

FIG. 8 is a bottom view of the right side thereof, the left side being a mirror image of thereof; shown detached for ease of illustration;

FIG. 9 is an end view of the right side thereof, the left side being a mirror image of thereof;

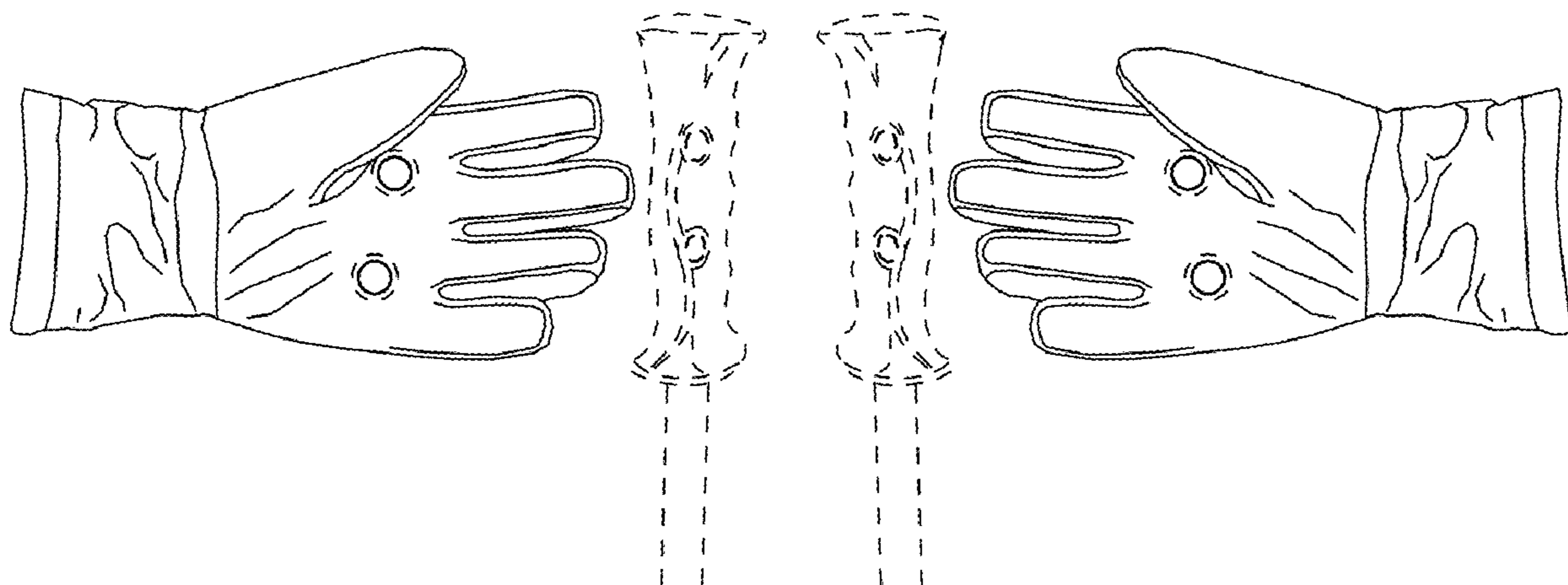
FIG. 10 is an opposite end view of the right side thereof, the left side being a mirror image thereof;

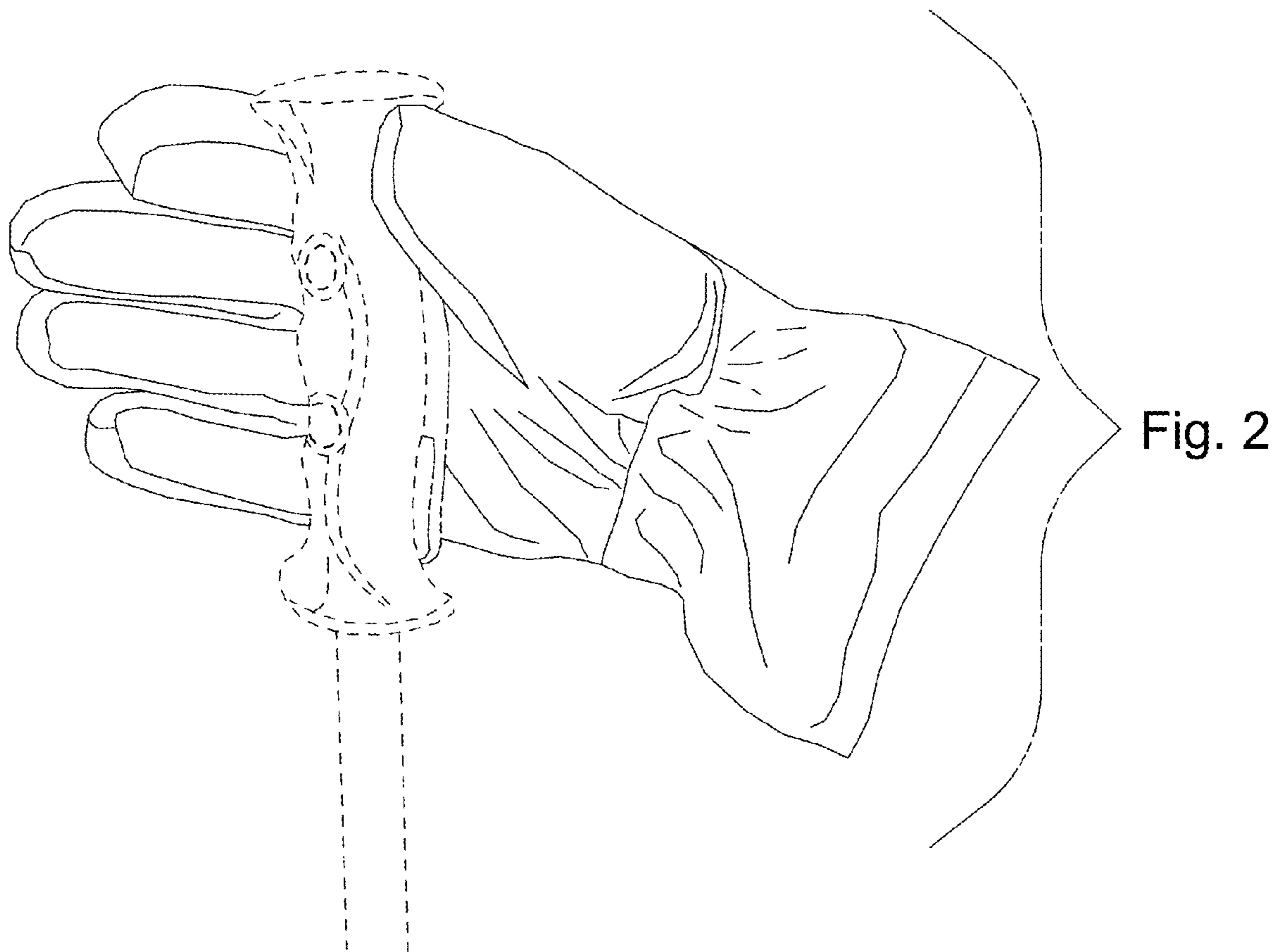
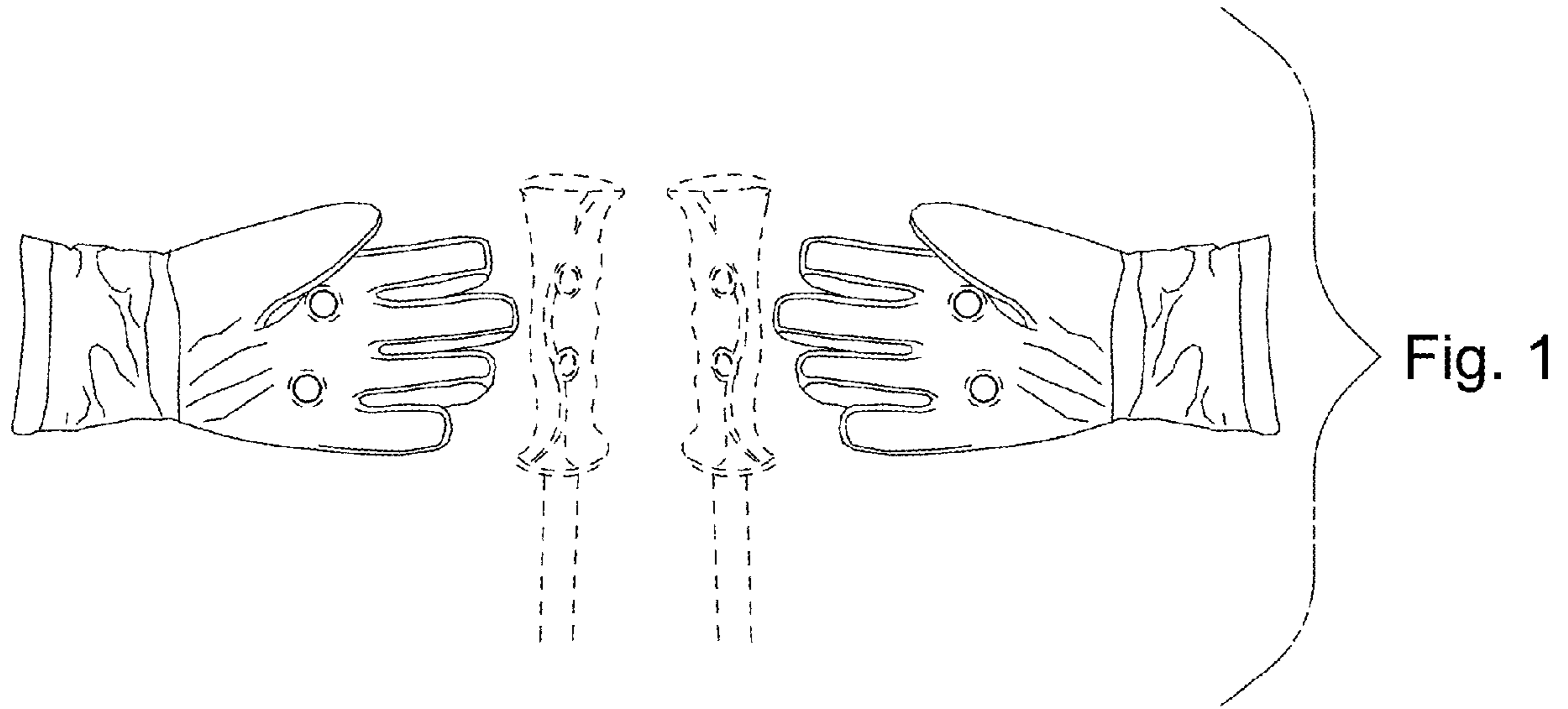

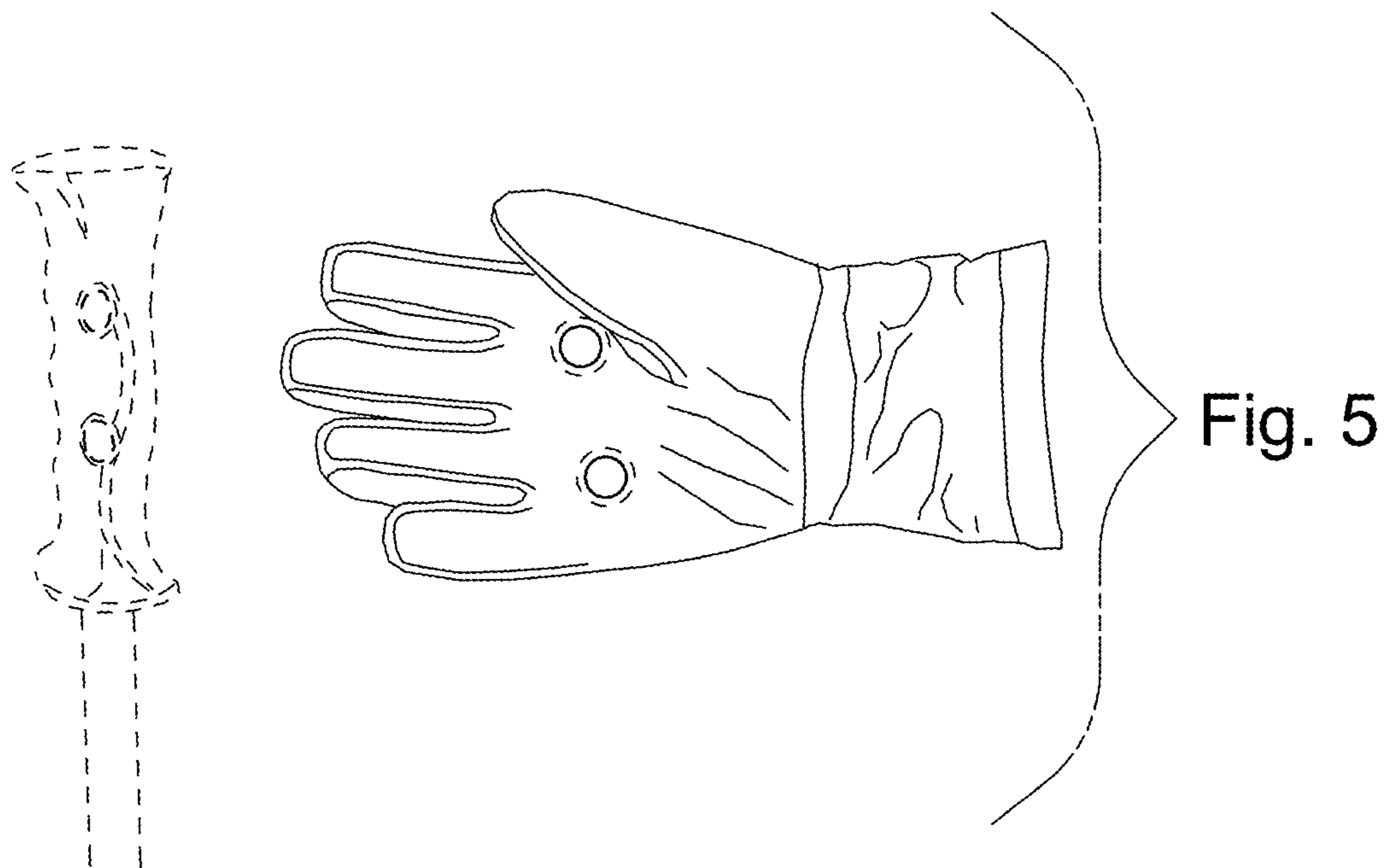
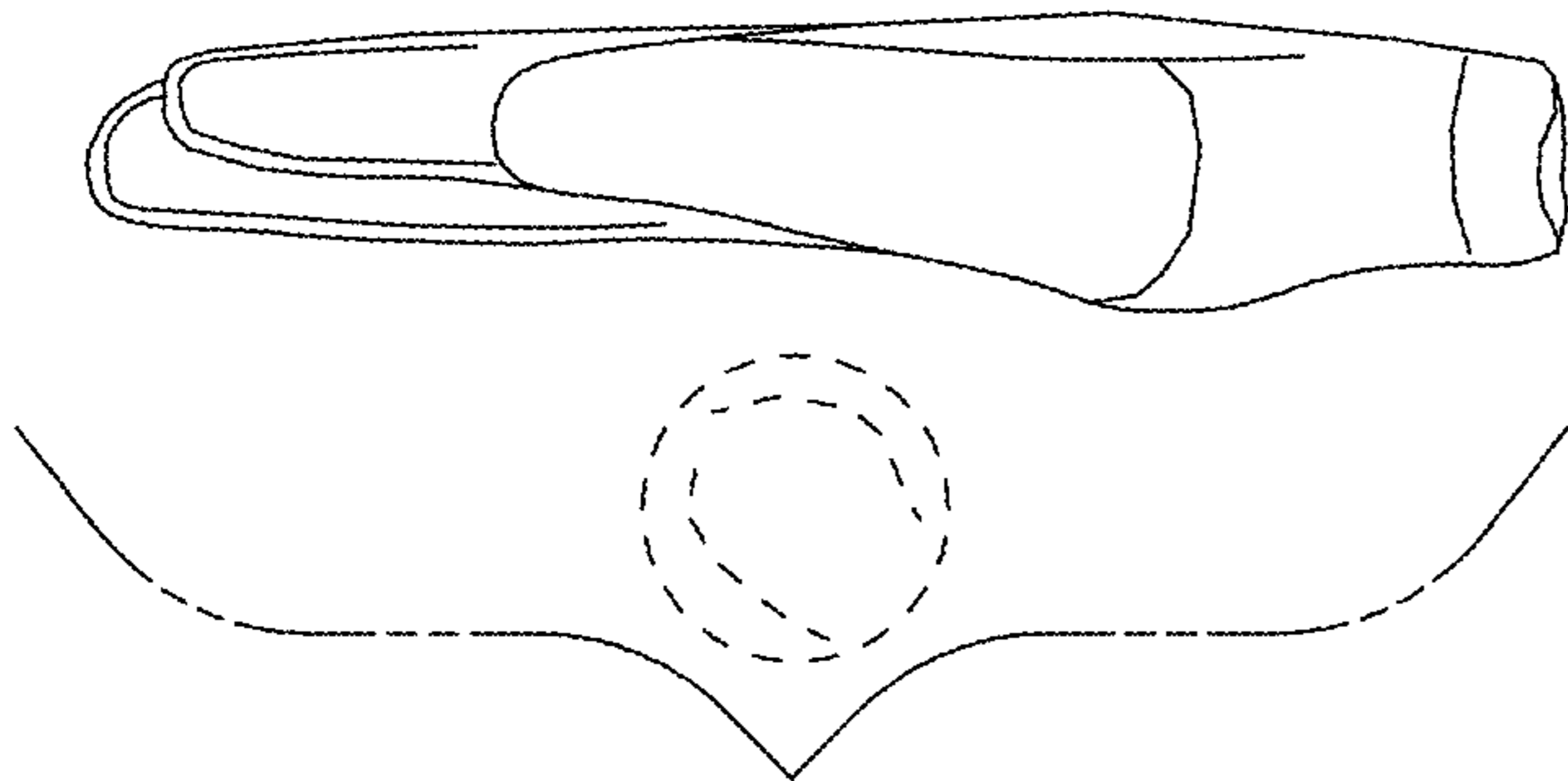
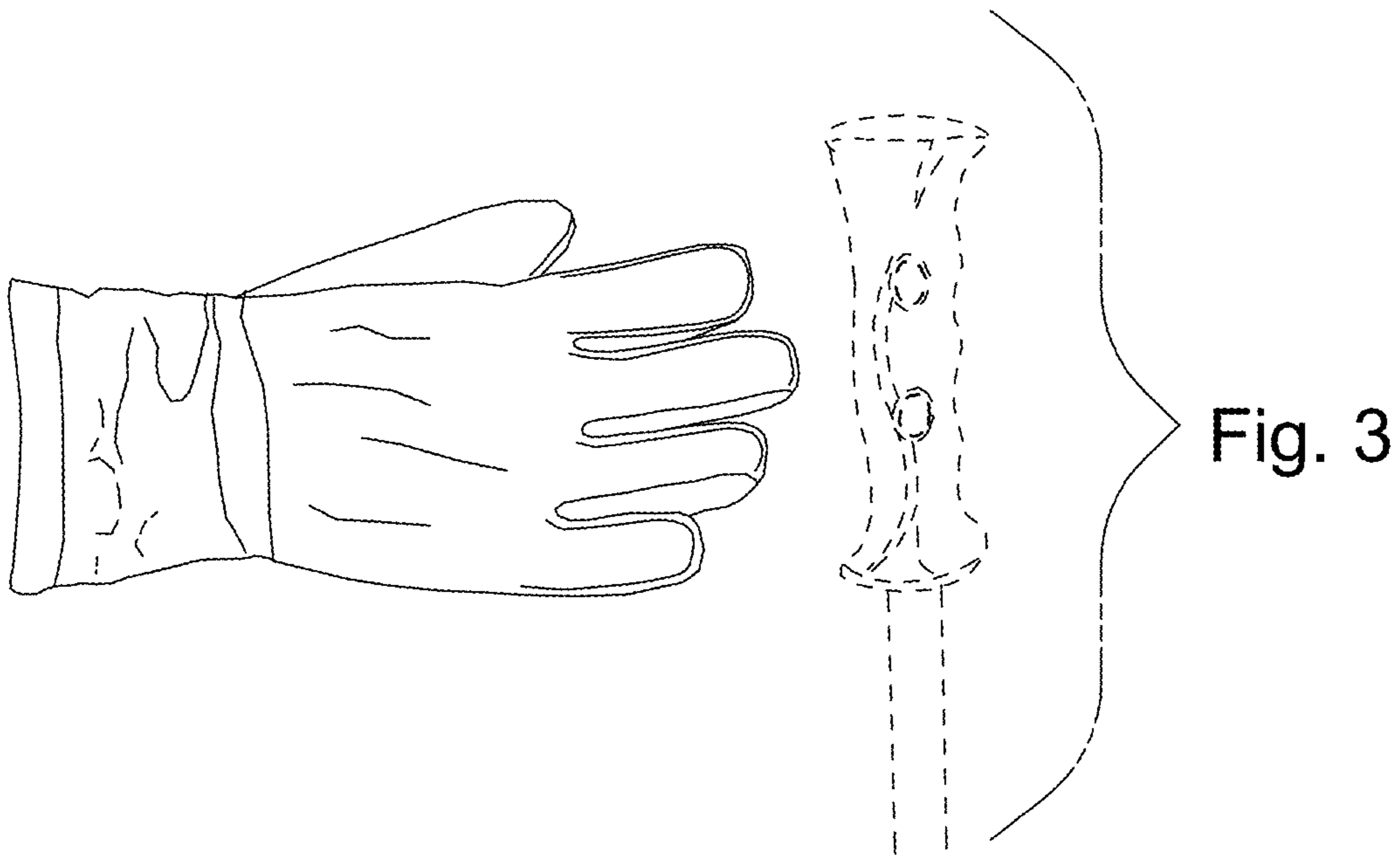

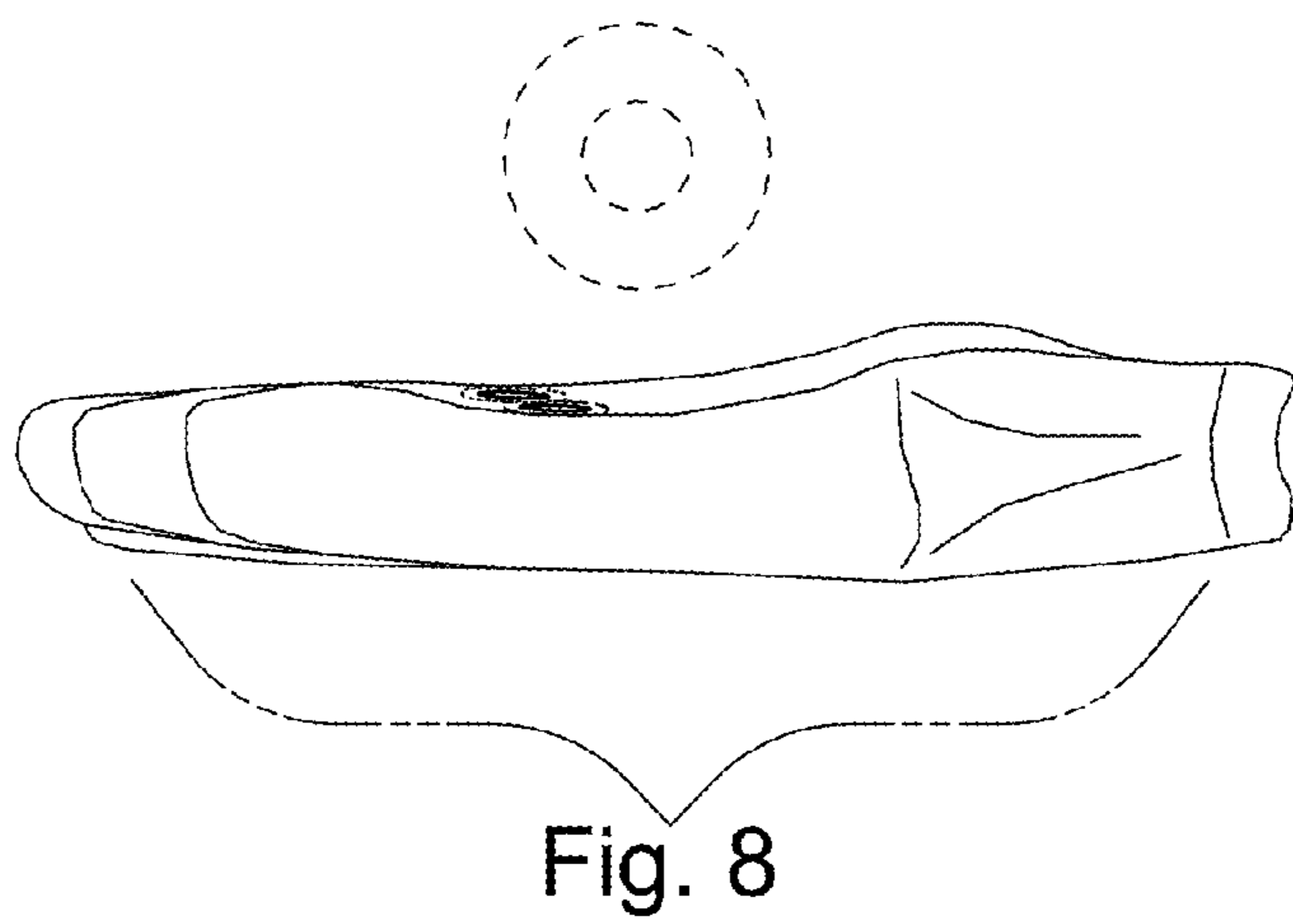
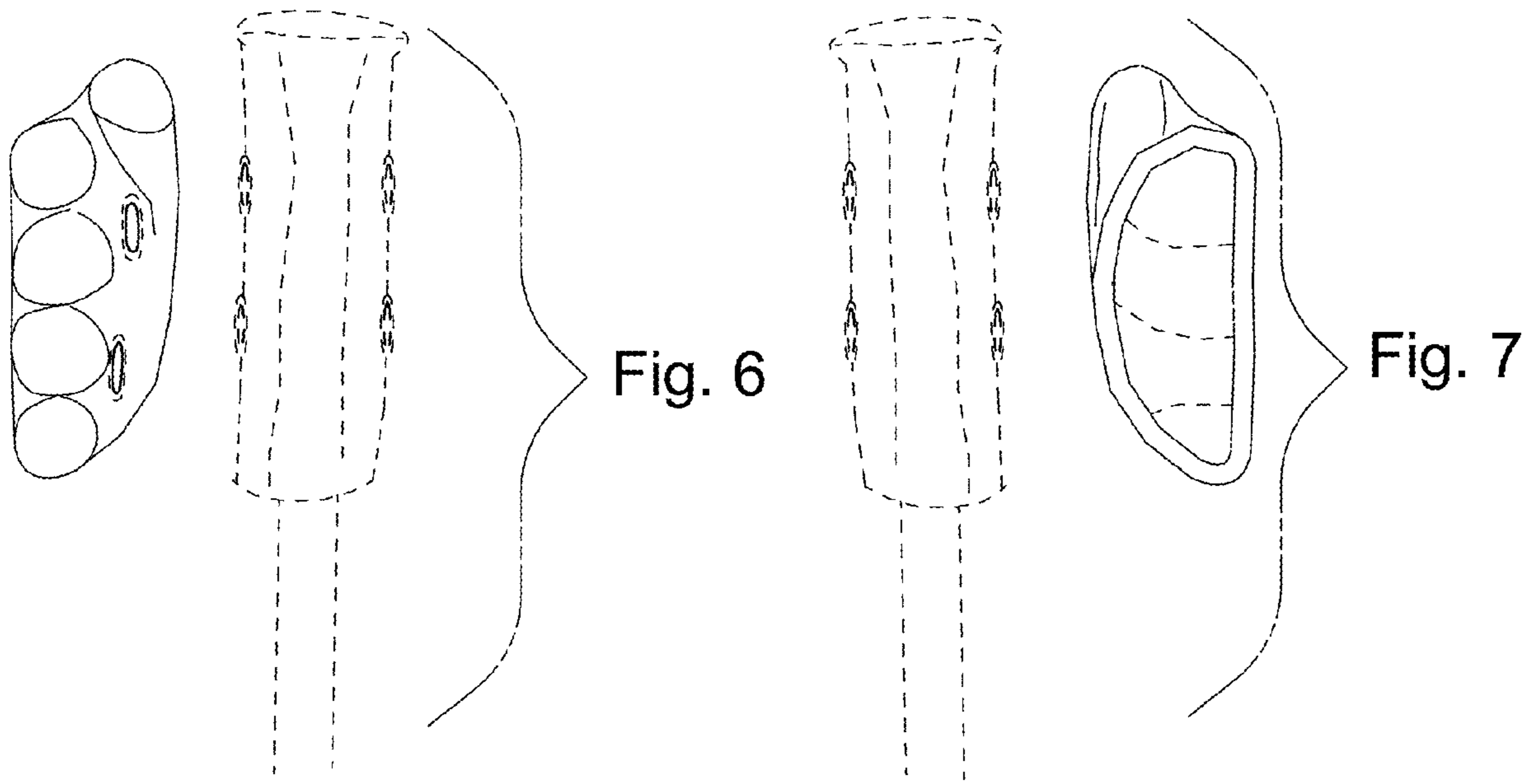

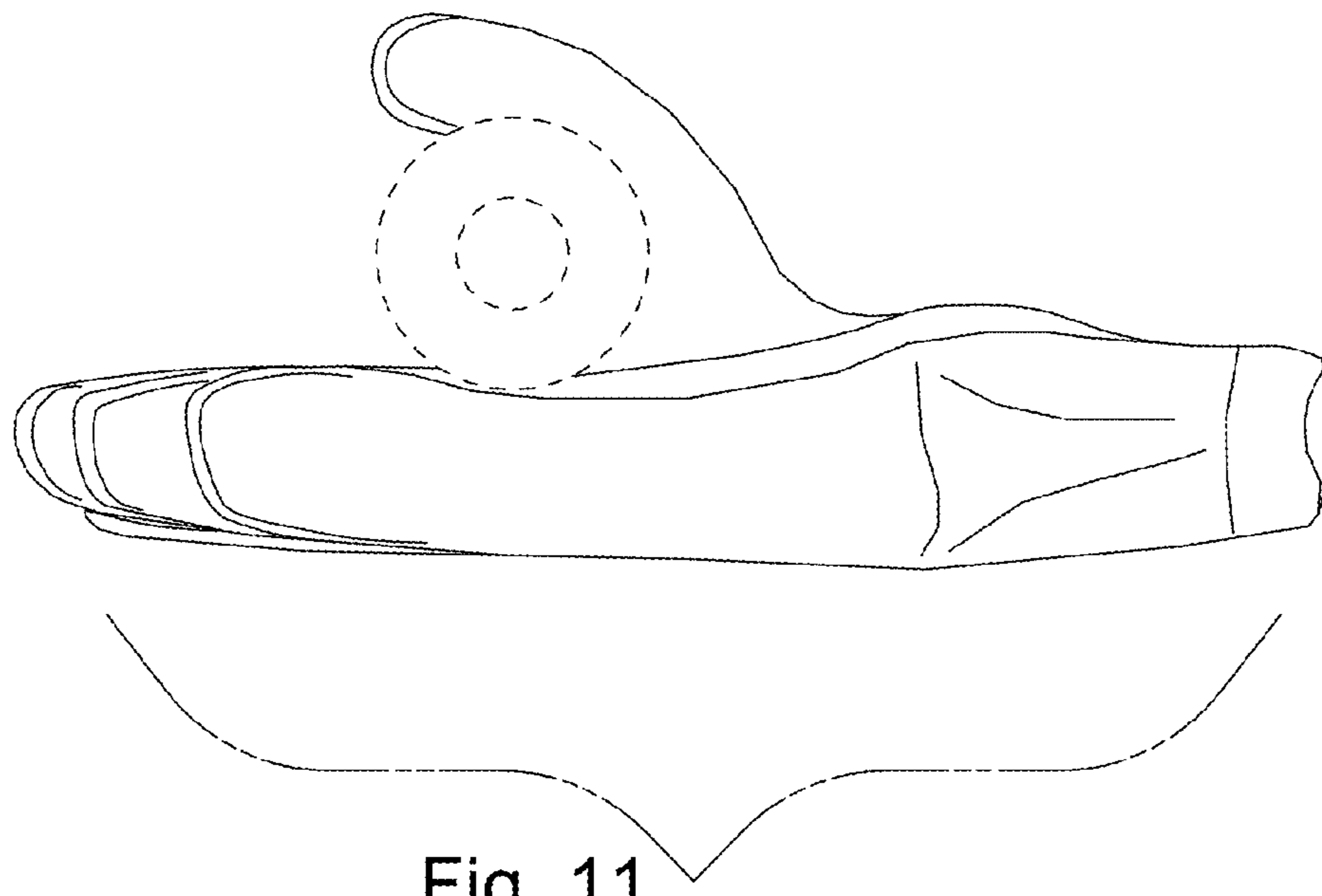
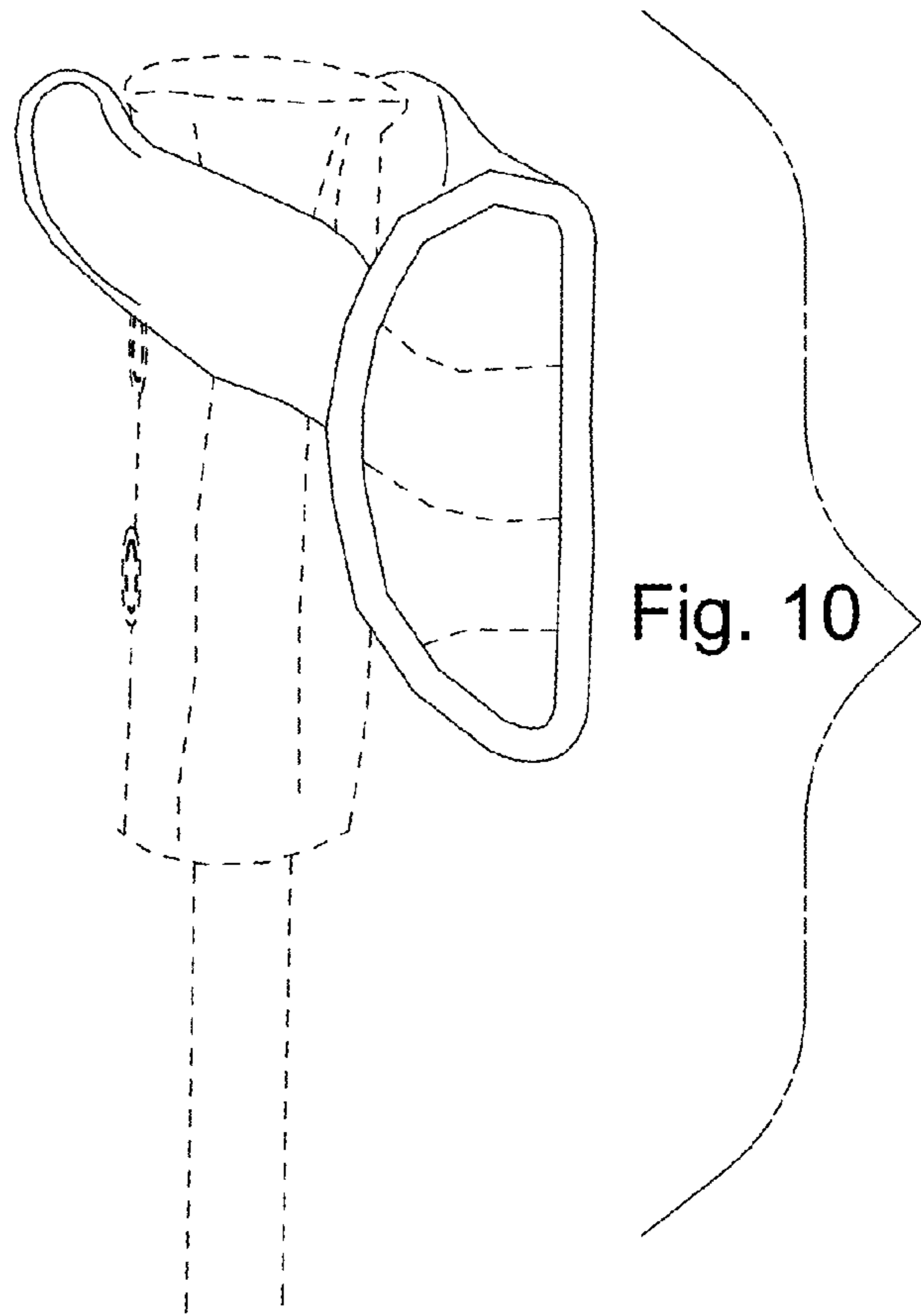
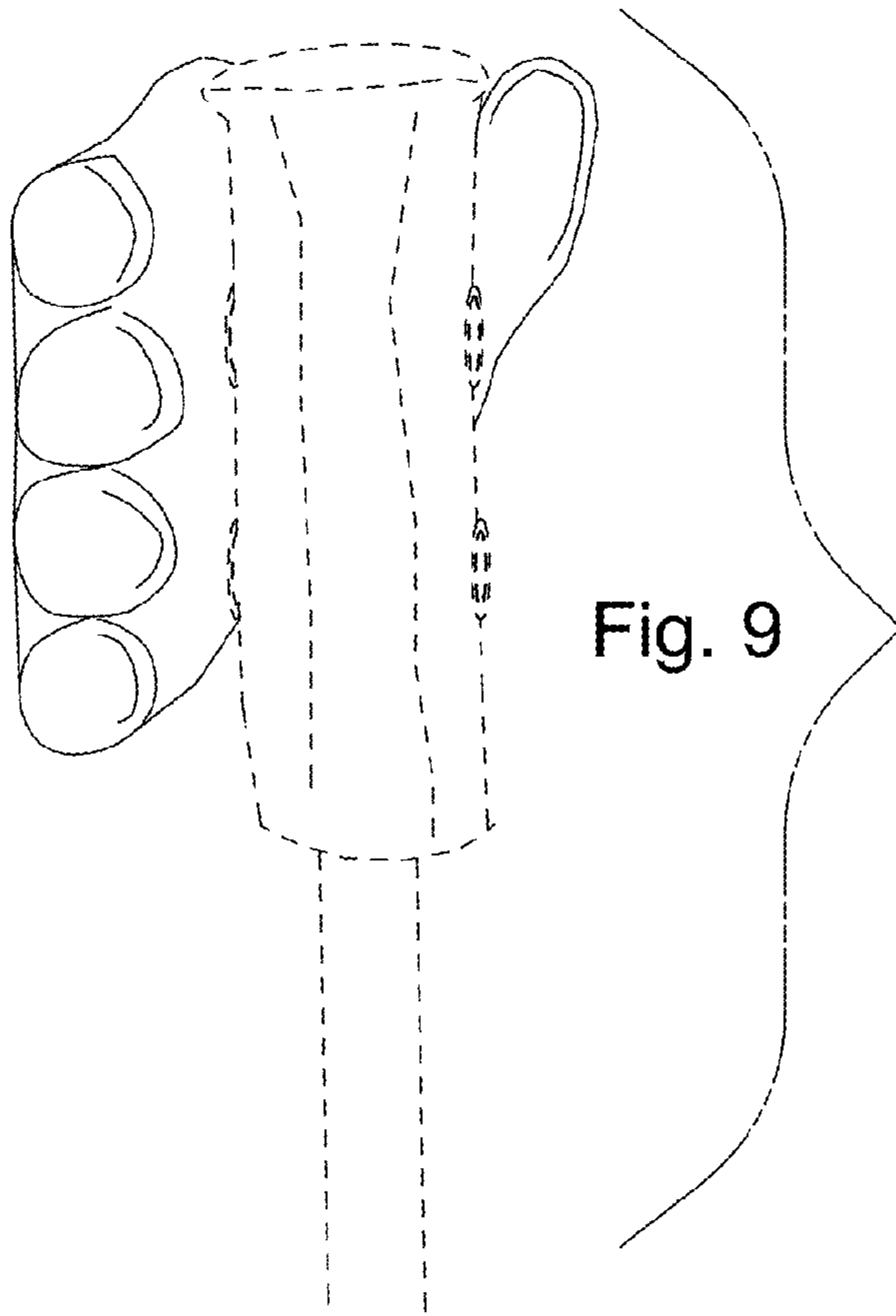

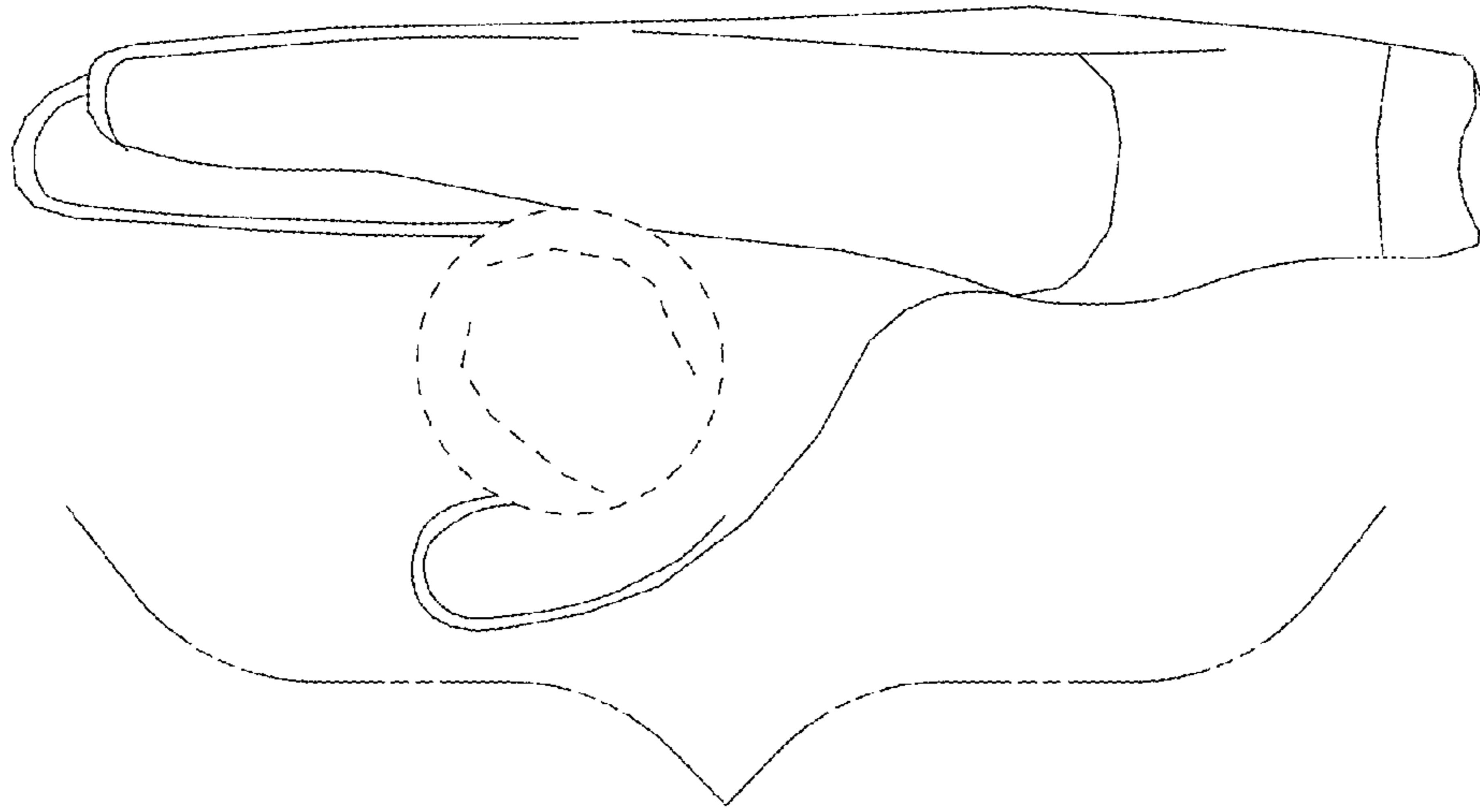

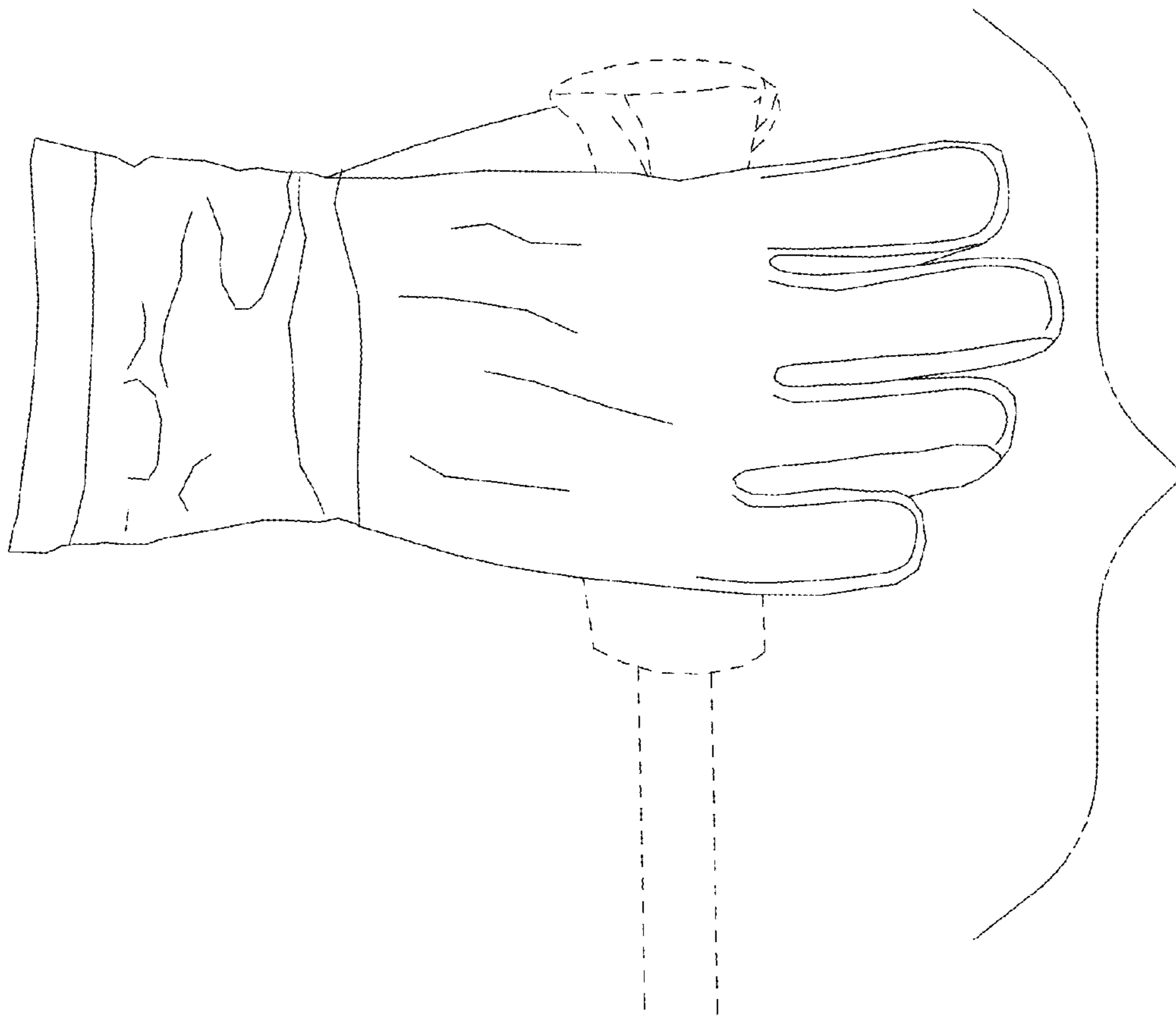
