(57) **CLAIM**

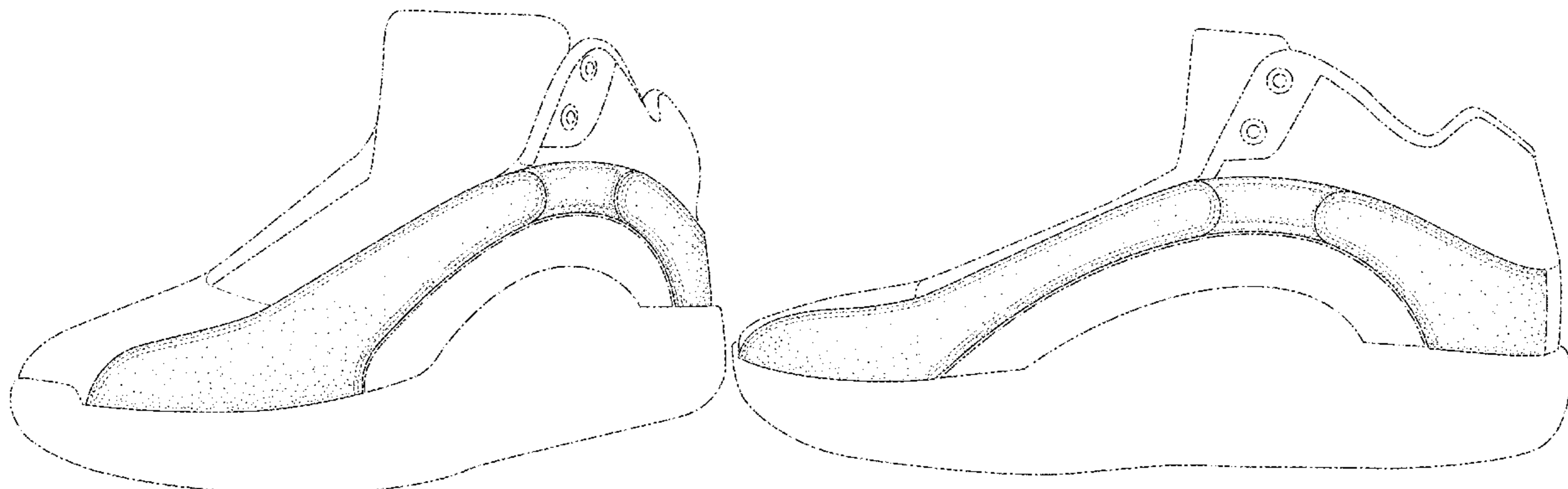
The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
 FIG. 2 is a side view thereof; and,
 FIG. 3 is a rear perspective view thereof.
 The broken line immediately adjacent to the shaded area defines the lower bound of the claimed design and forms no part thereof. The even-length broken lines within the shaded area forms no part of the claimed design. The broken lines depicting the remainder of the shoe show forms no part of the claimed design.

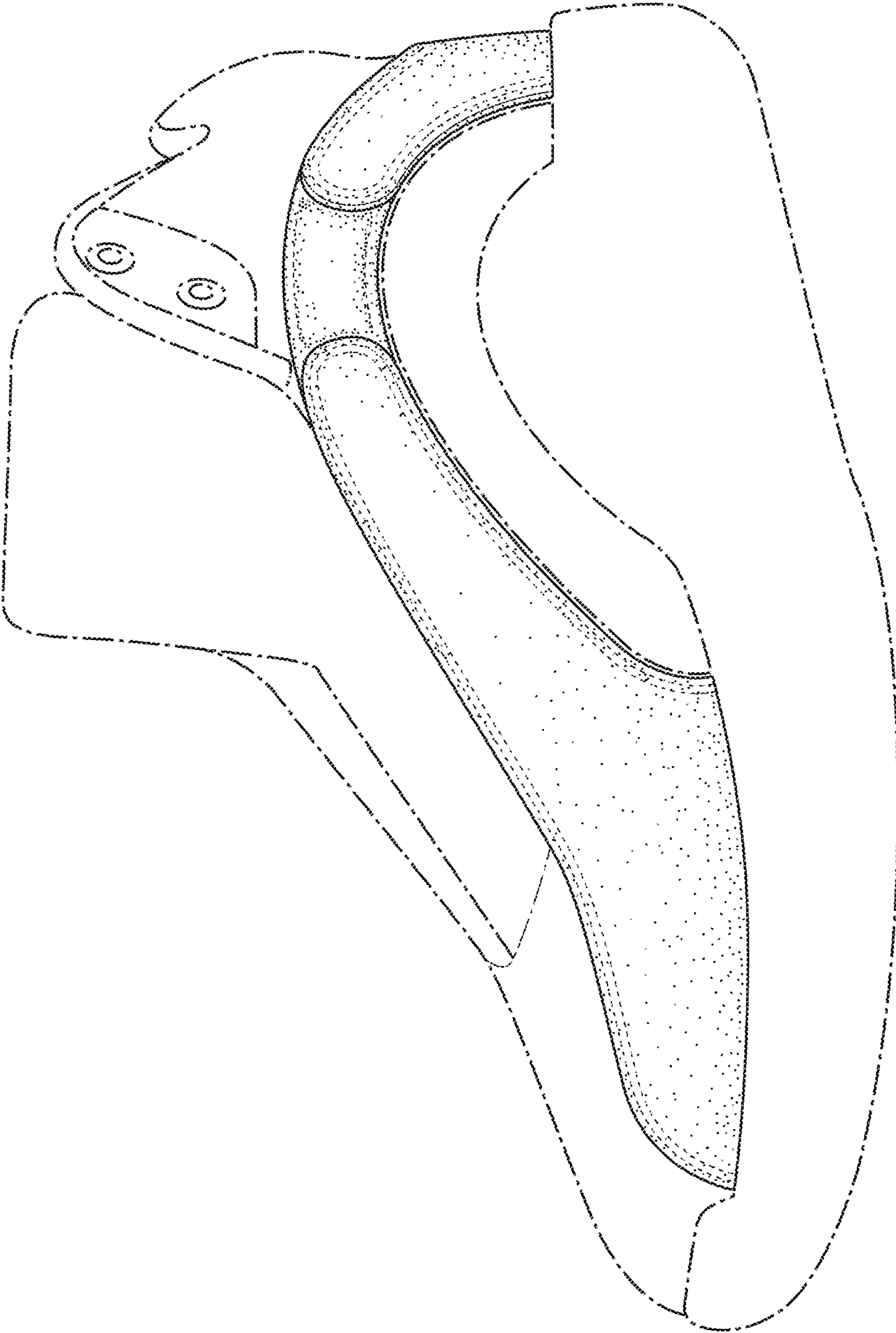

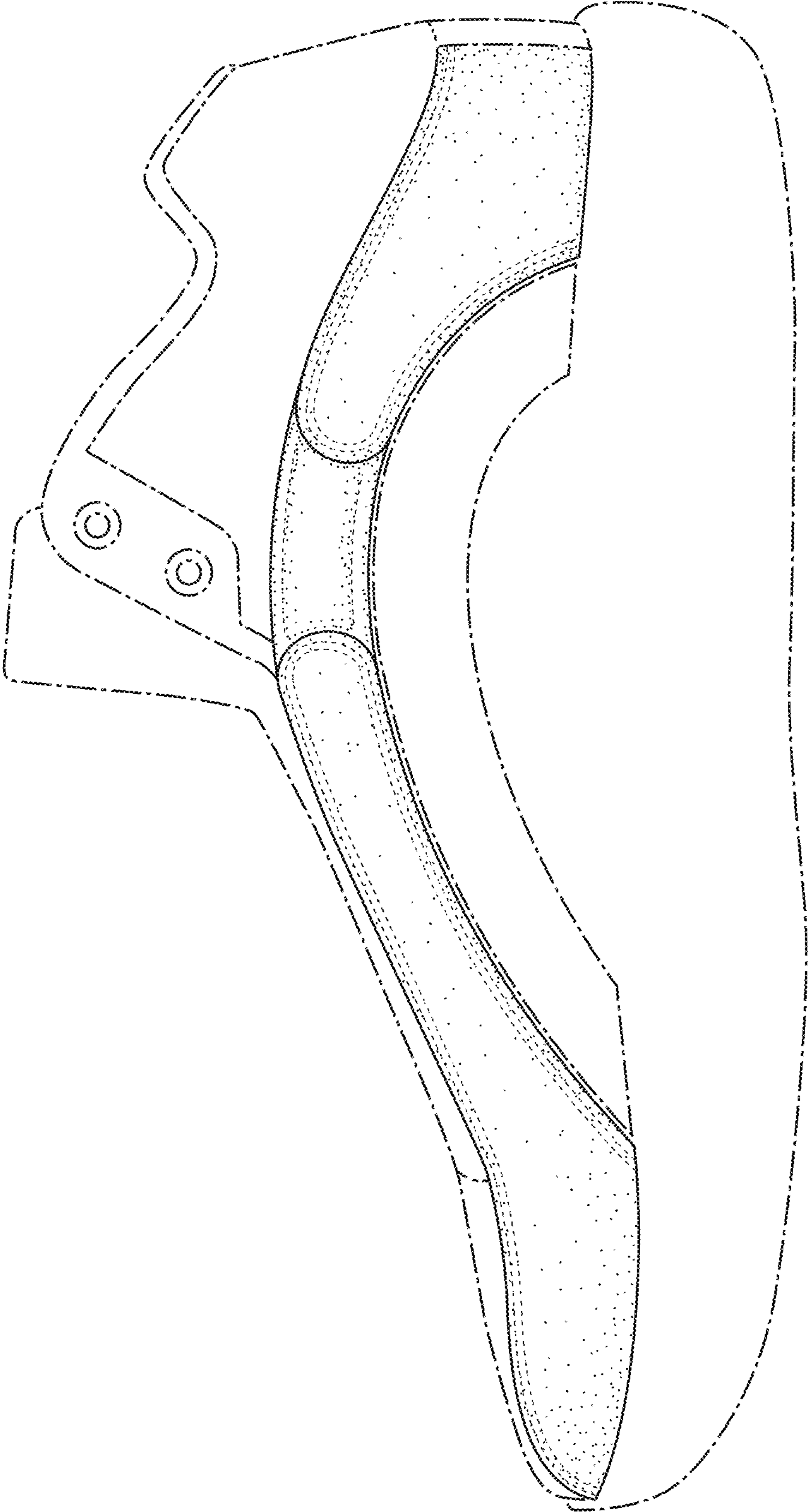

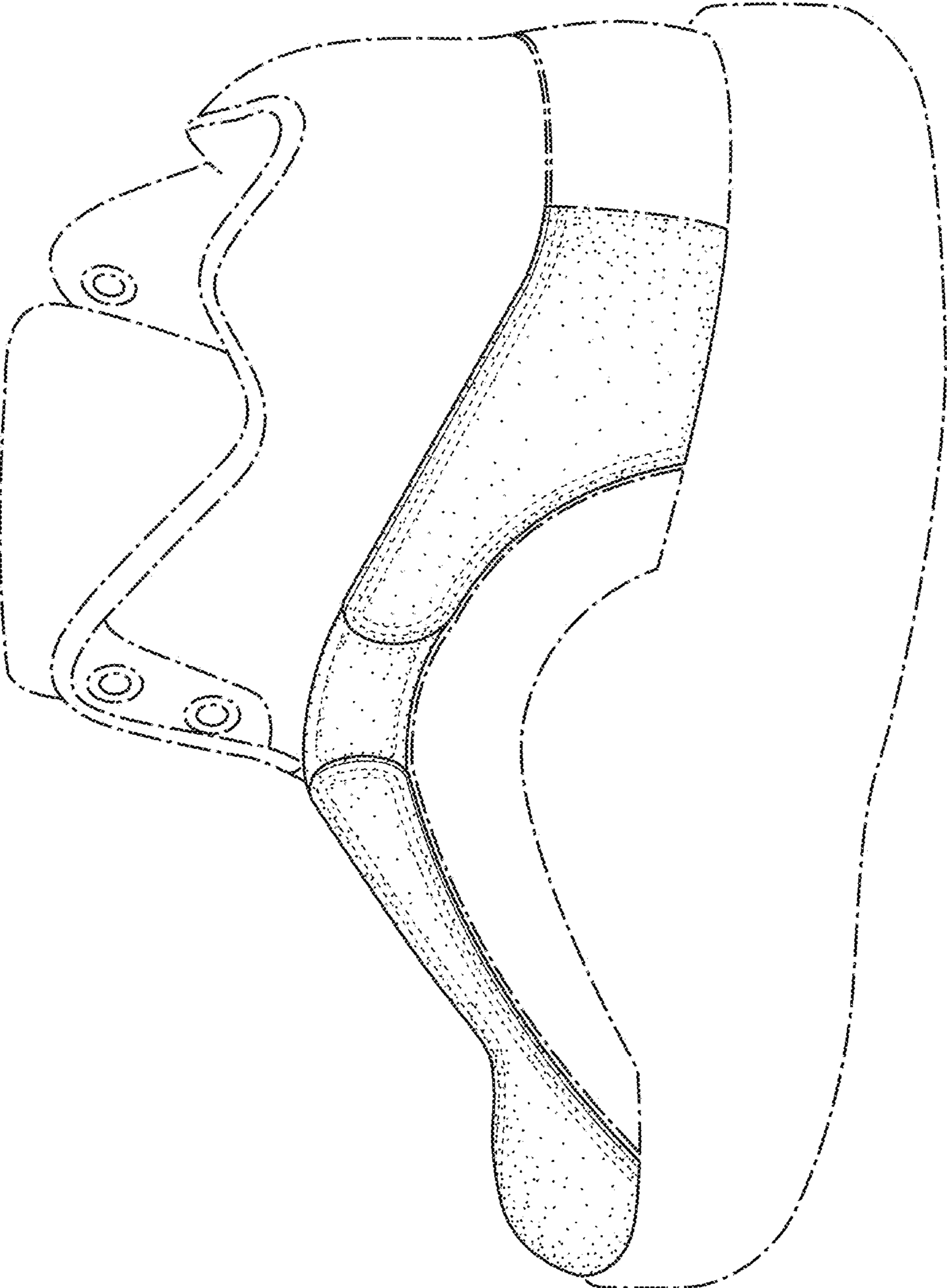
