The ornamental design for a stand packaging, as shown and described.

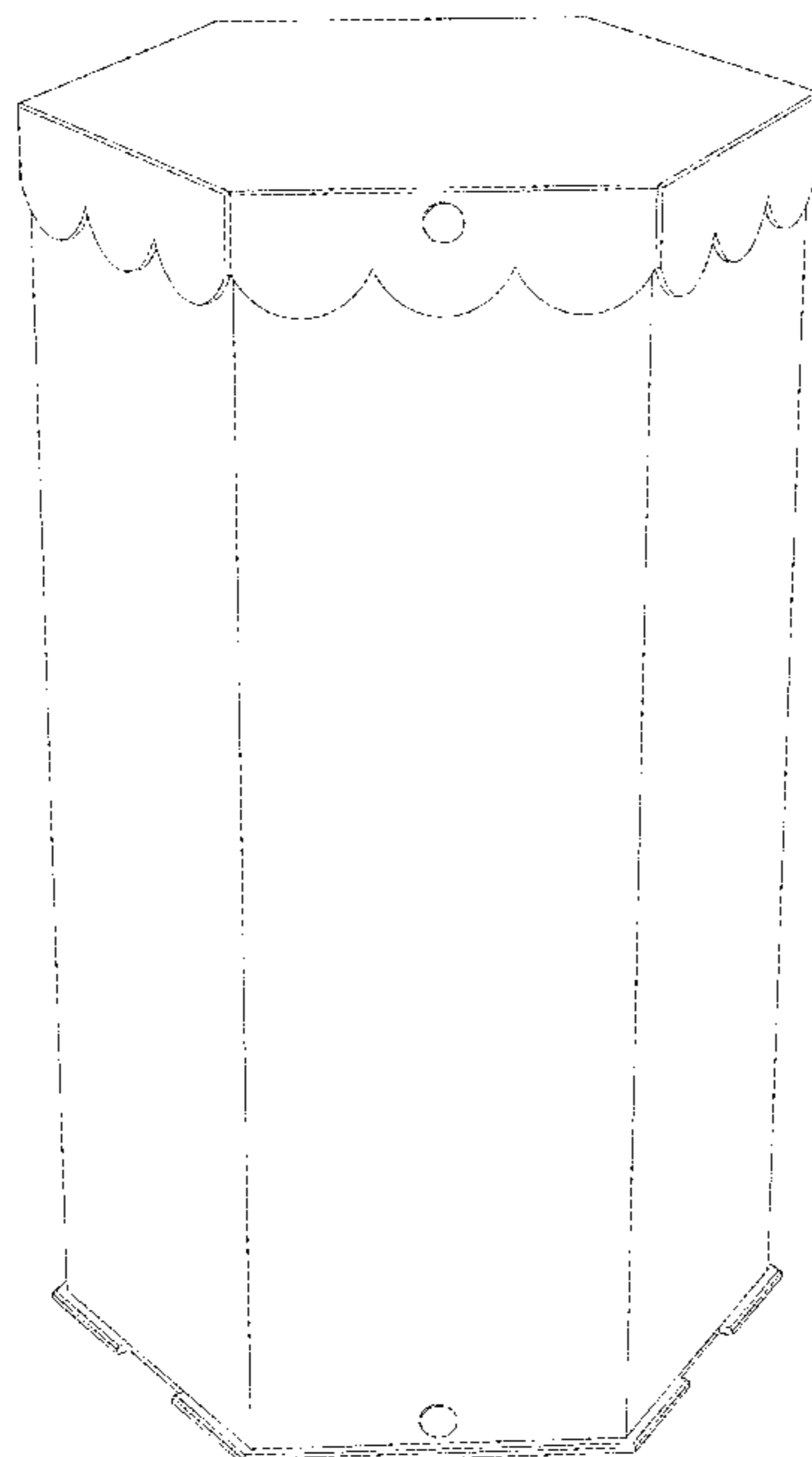
DESCRIPTION

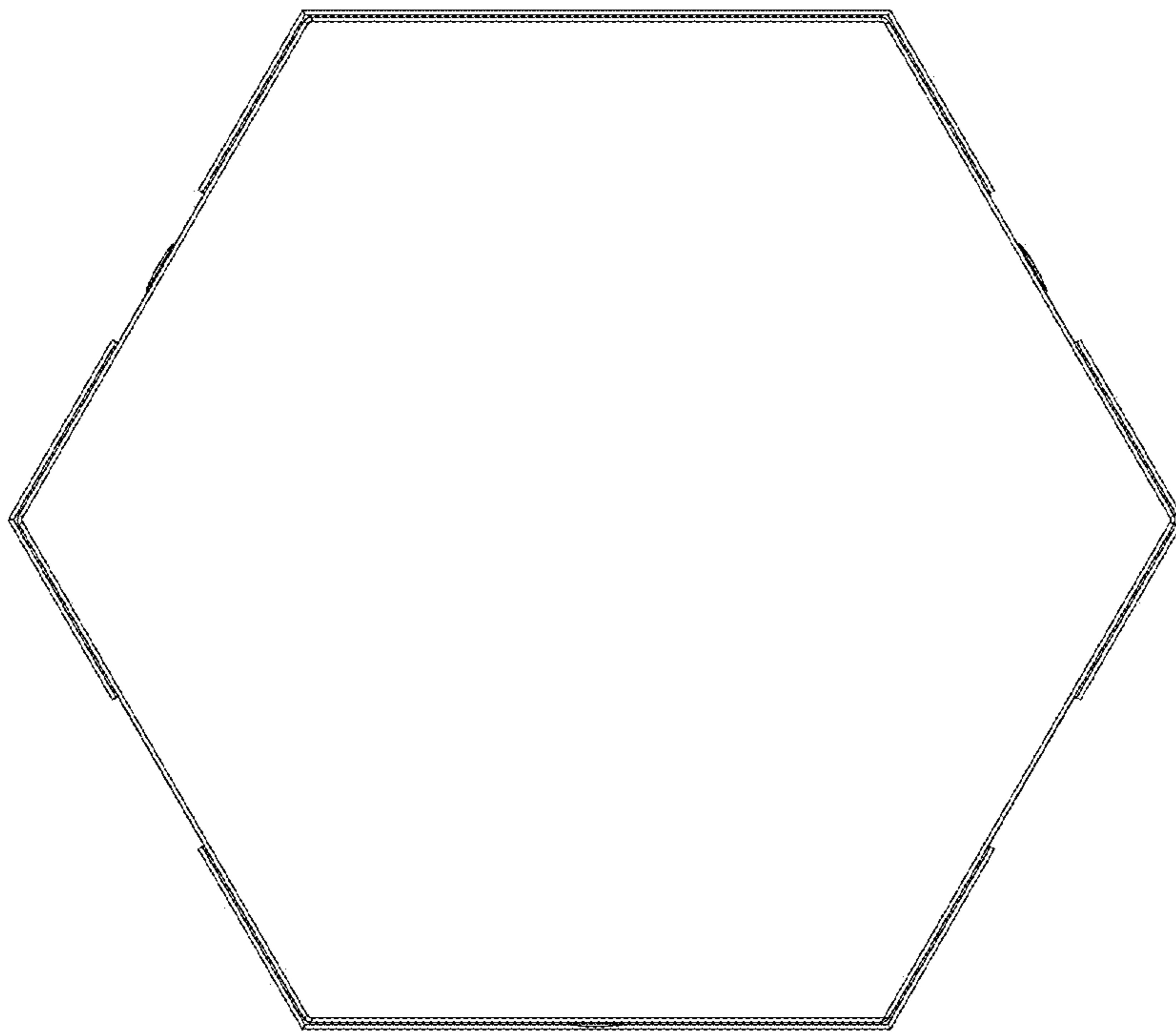

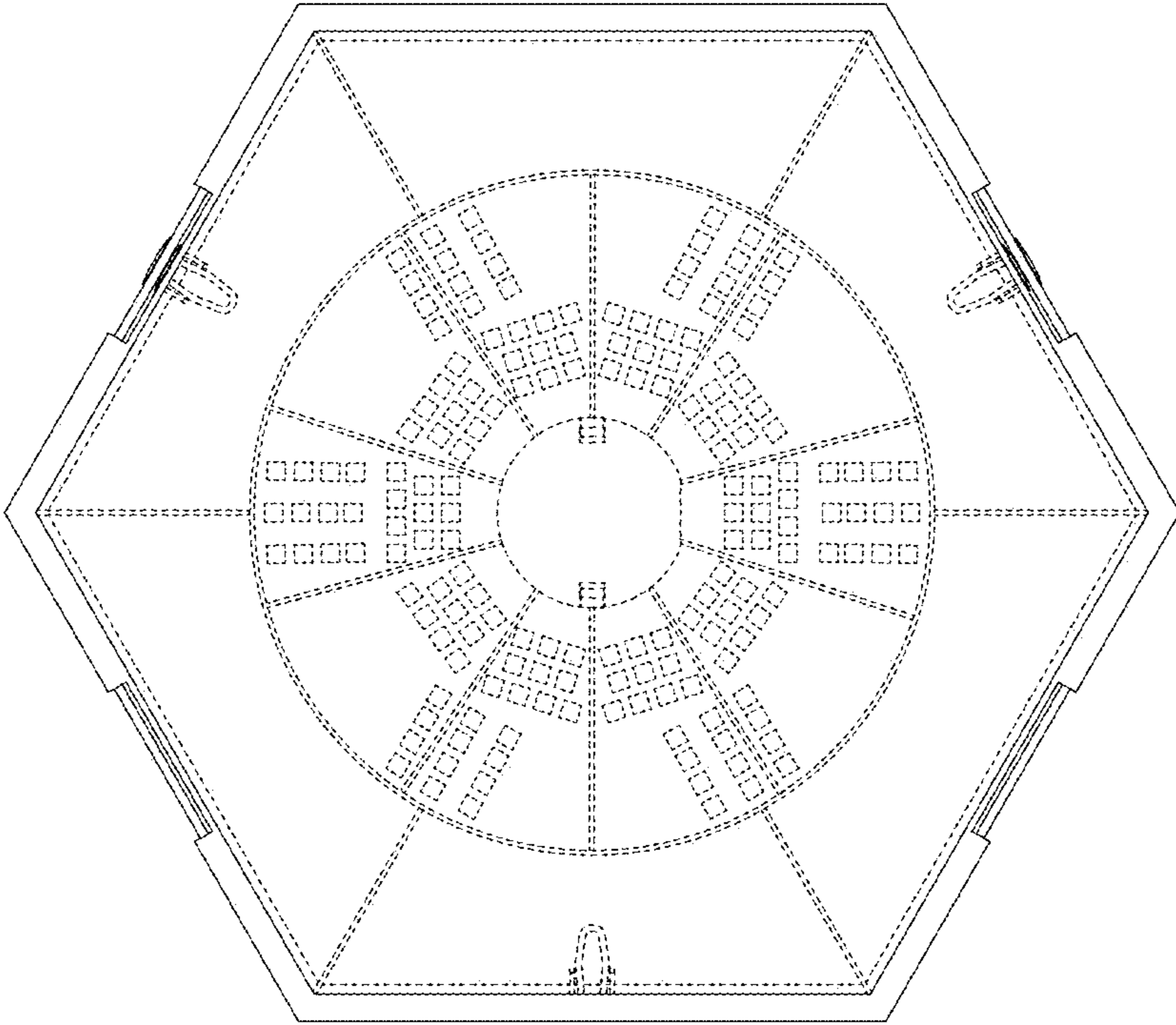

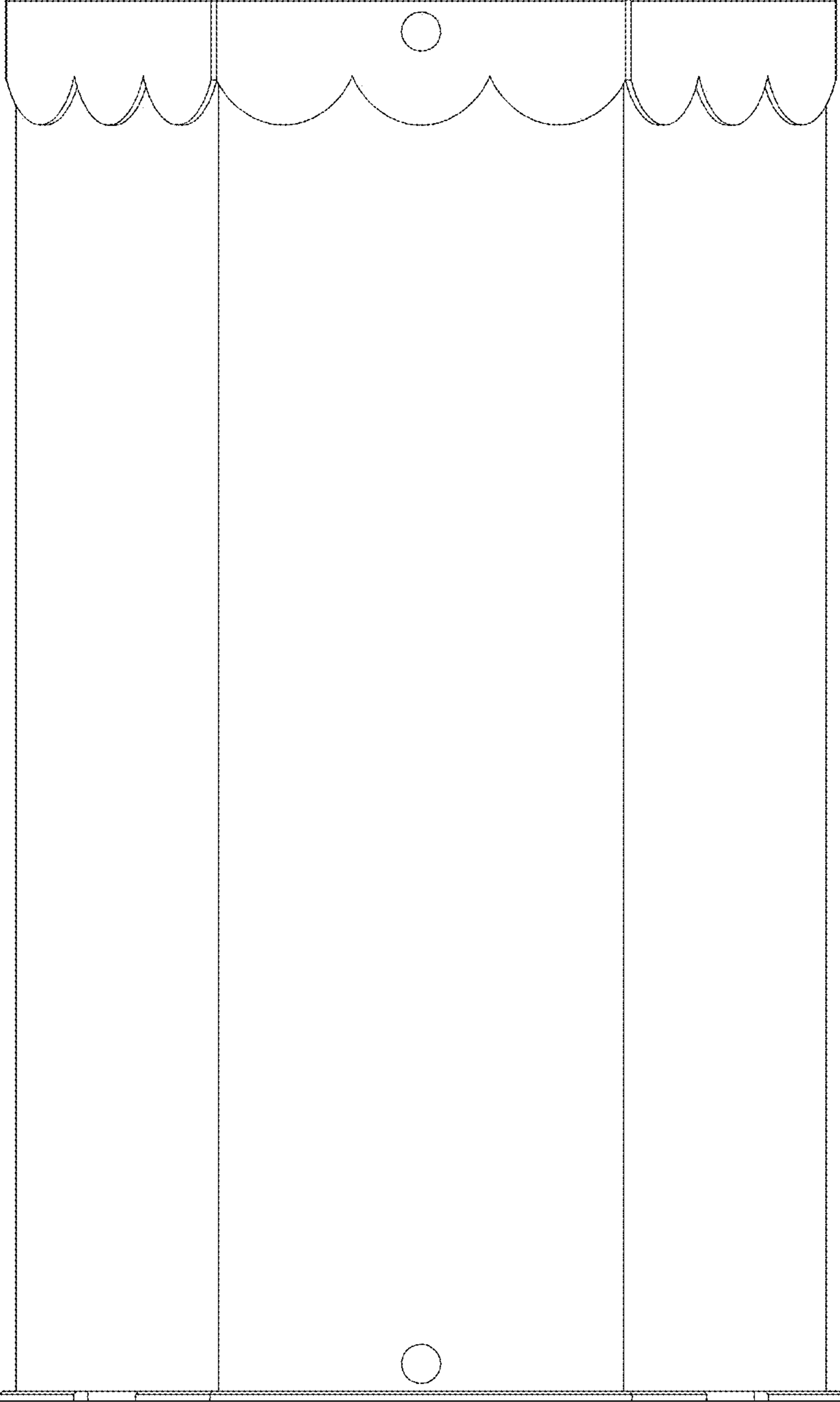

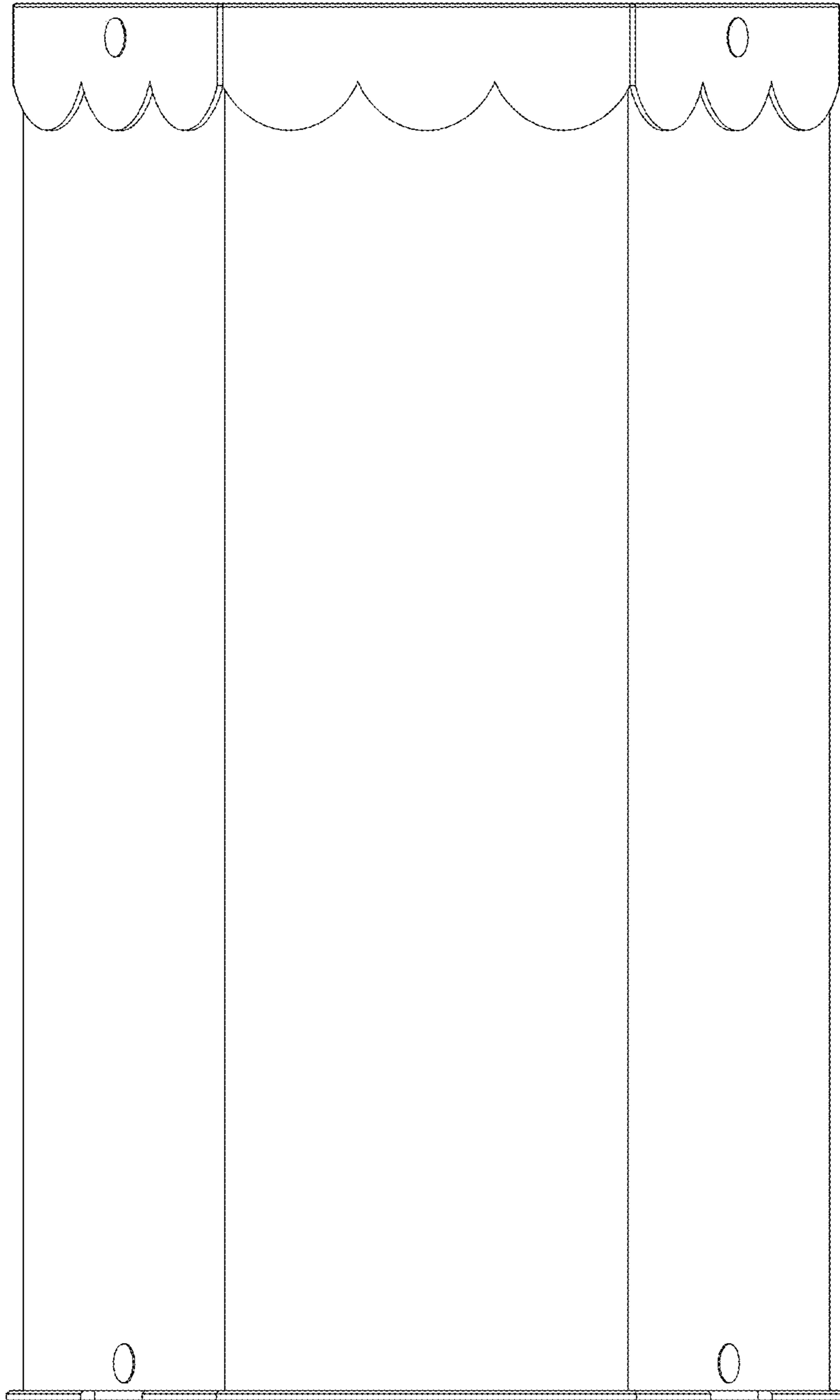

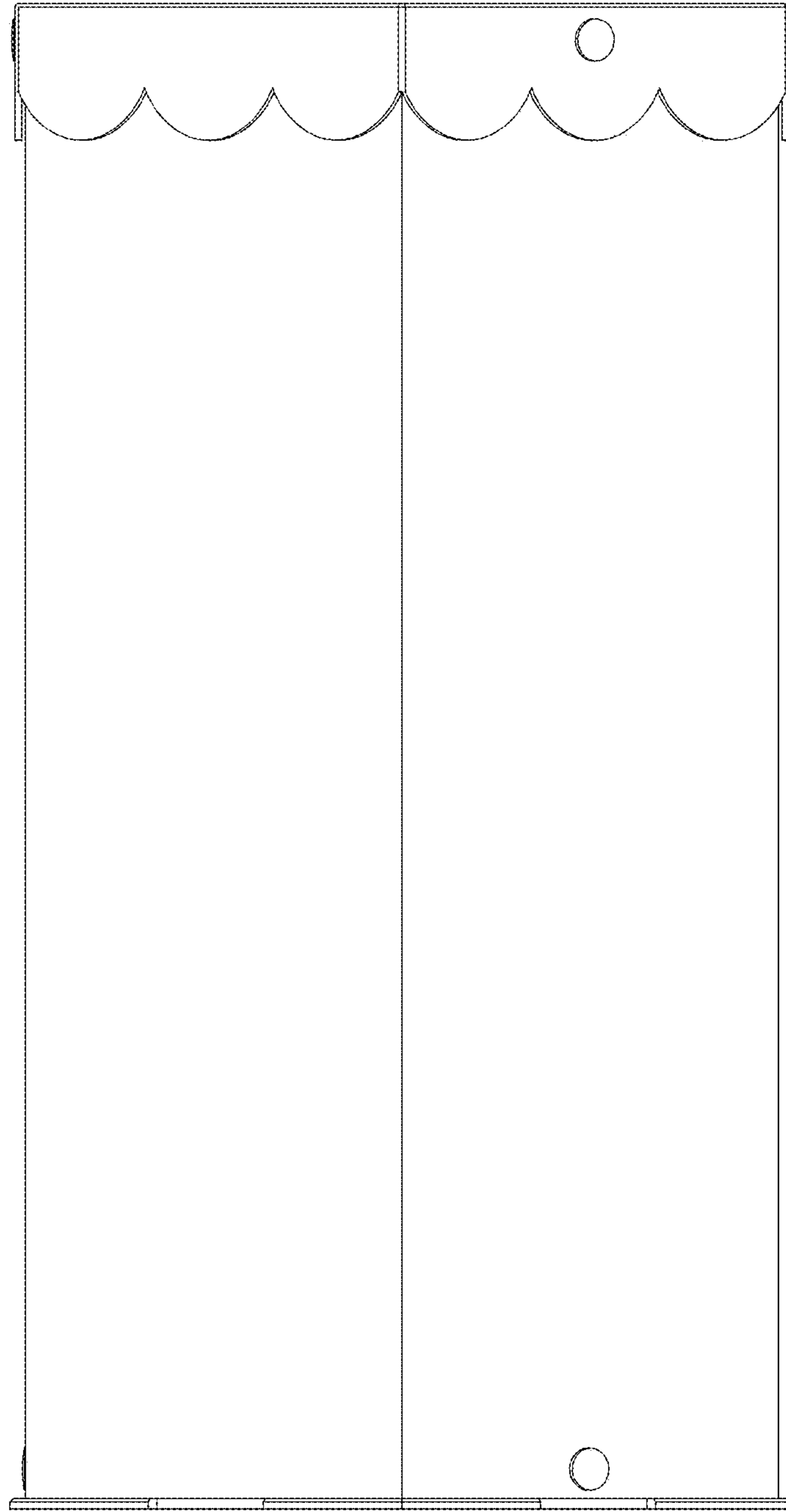

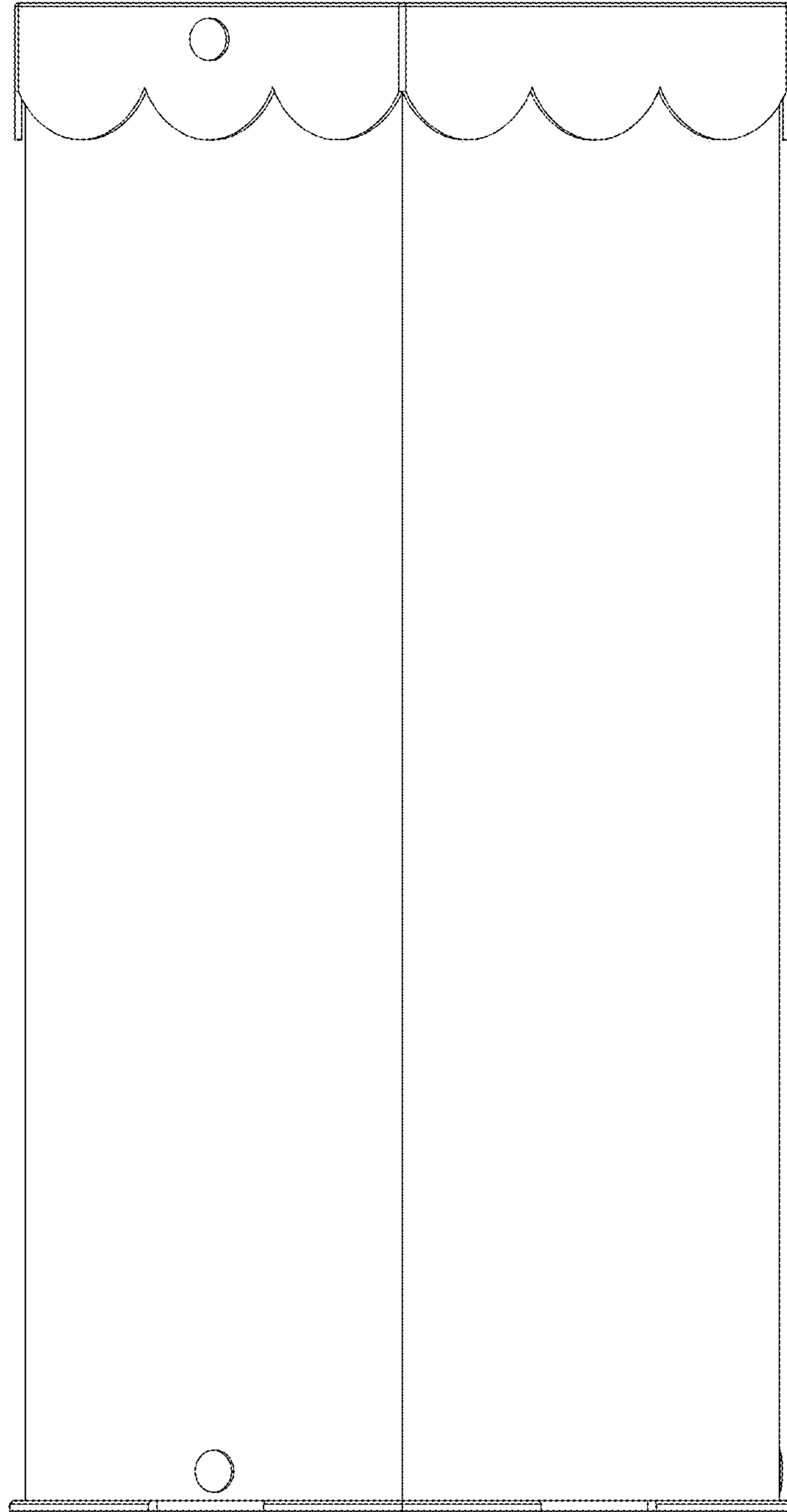

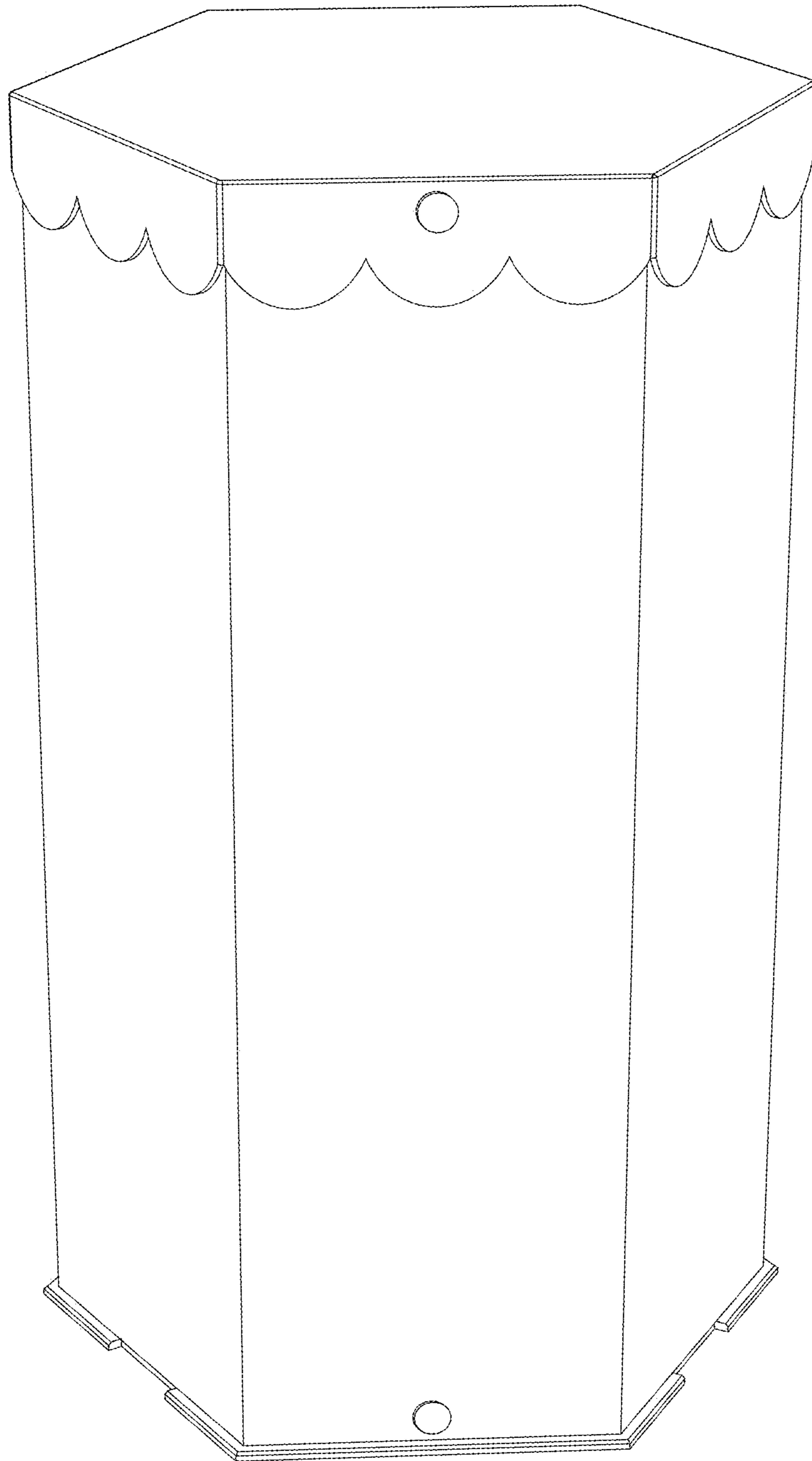
