(57) **CLAIM**

The ornamental design for a spray can actuator, as shown and described.

**DESCRIPTION**

FIG. 1 is a left side rear bird's eye perspective view of a spray can actuator of our new design, and with a movable straw shown in a down position;

FIG. 2 is a left side front ant's eye perspective view the design of FIG. 1;

FIG. 3 is a rear view of the design of FIG. 1;

FIG. 4 is a front view of the design of FIG. 1;

FIG. 5 is a right side view of the design shown in FIG. 4;

FIG. 6 is a left side view of the design of FIG. 4;

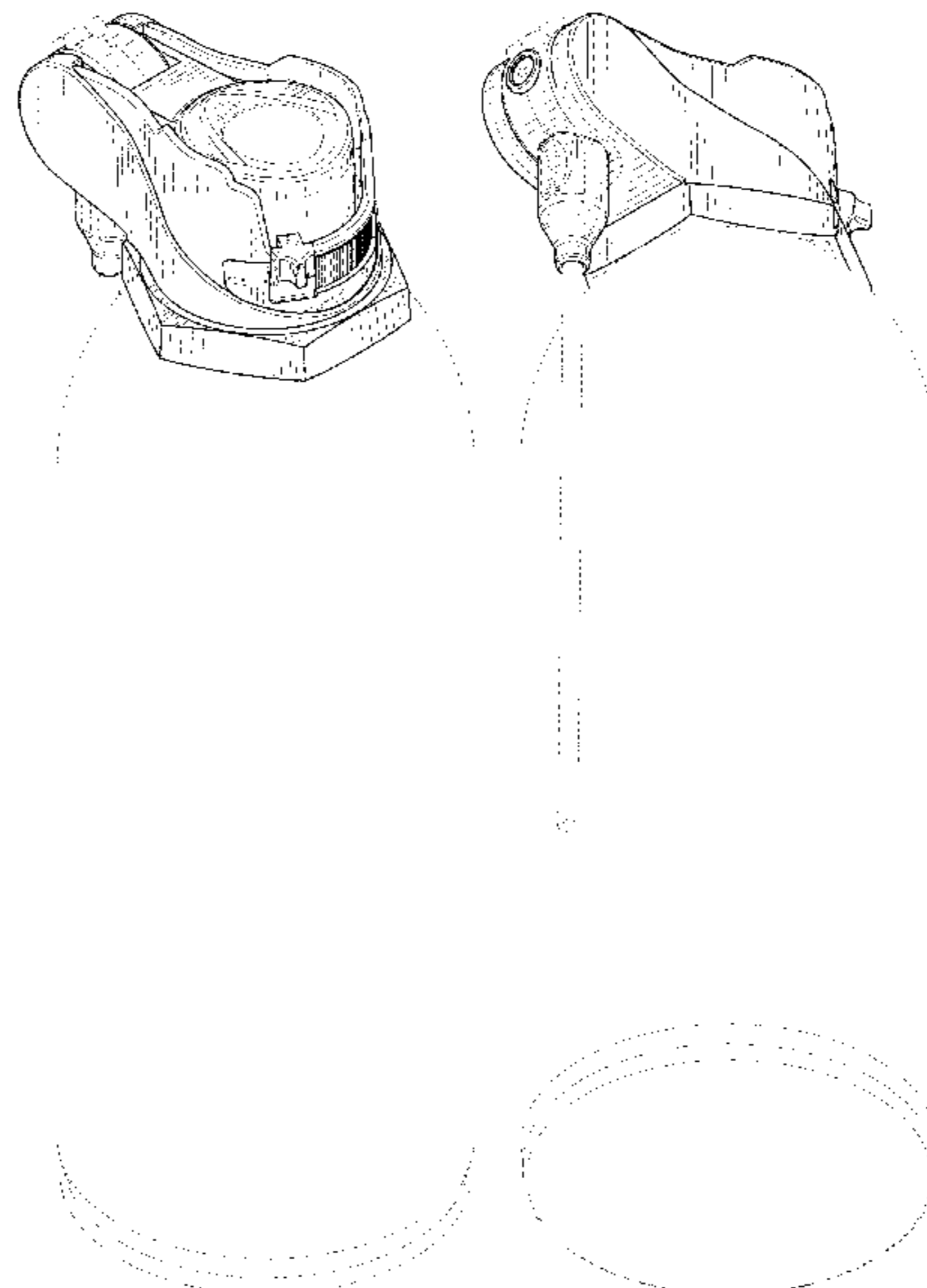
FIG. 7 is a top view of the design of FIG. 4;

FIG. 8 is a bottom view of the design of FIGS. 6 and 7; and,

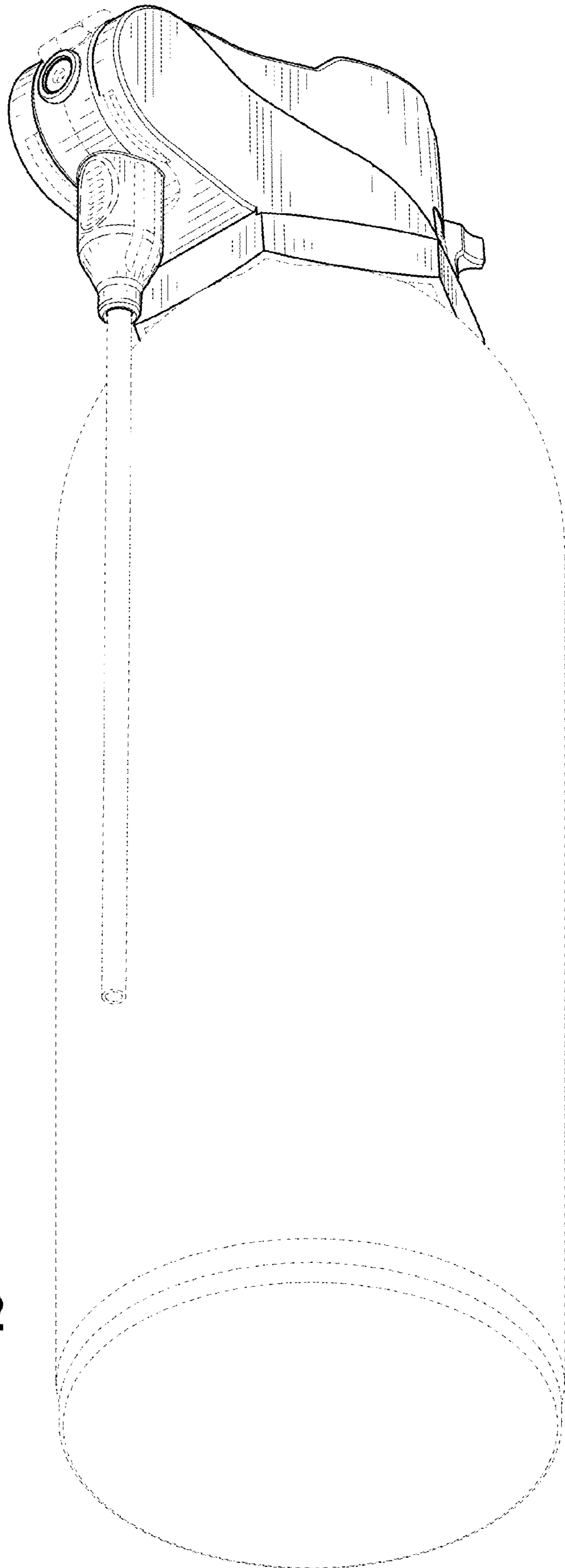

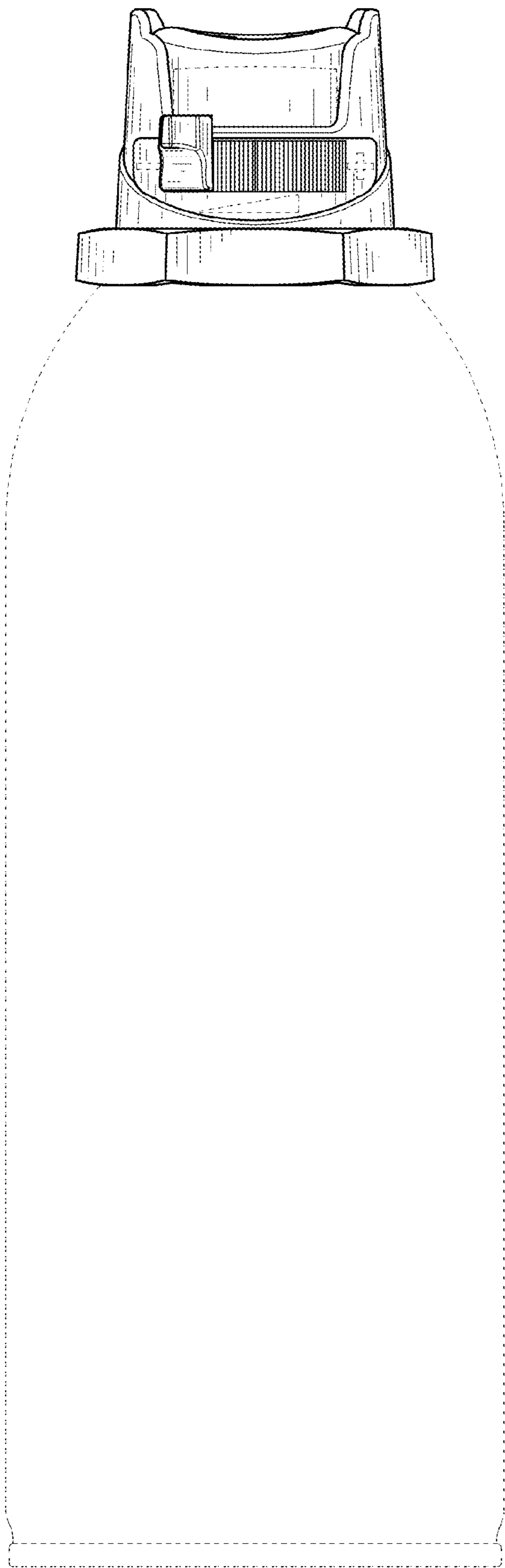

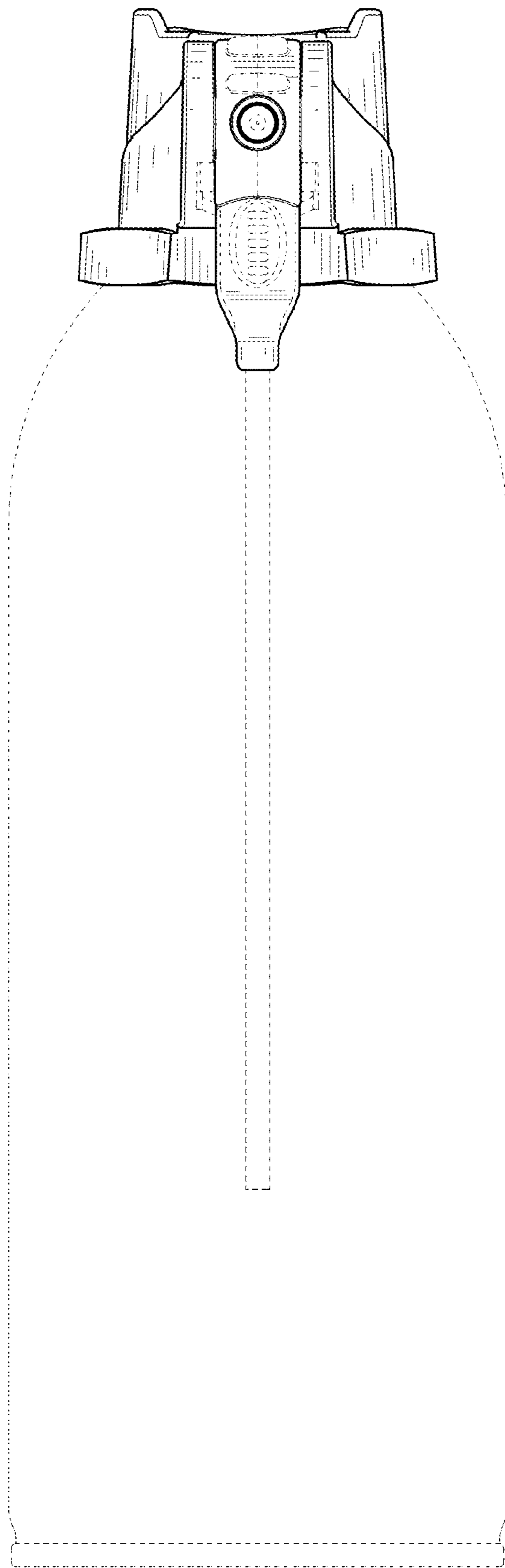

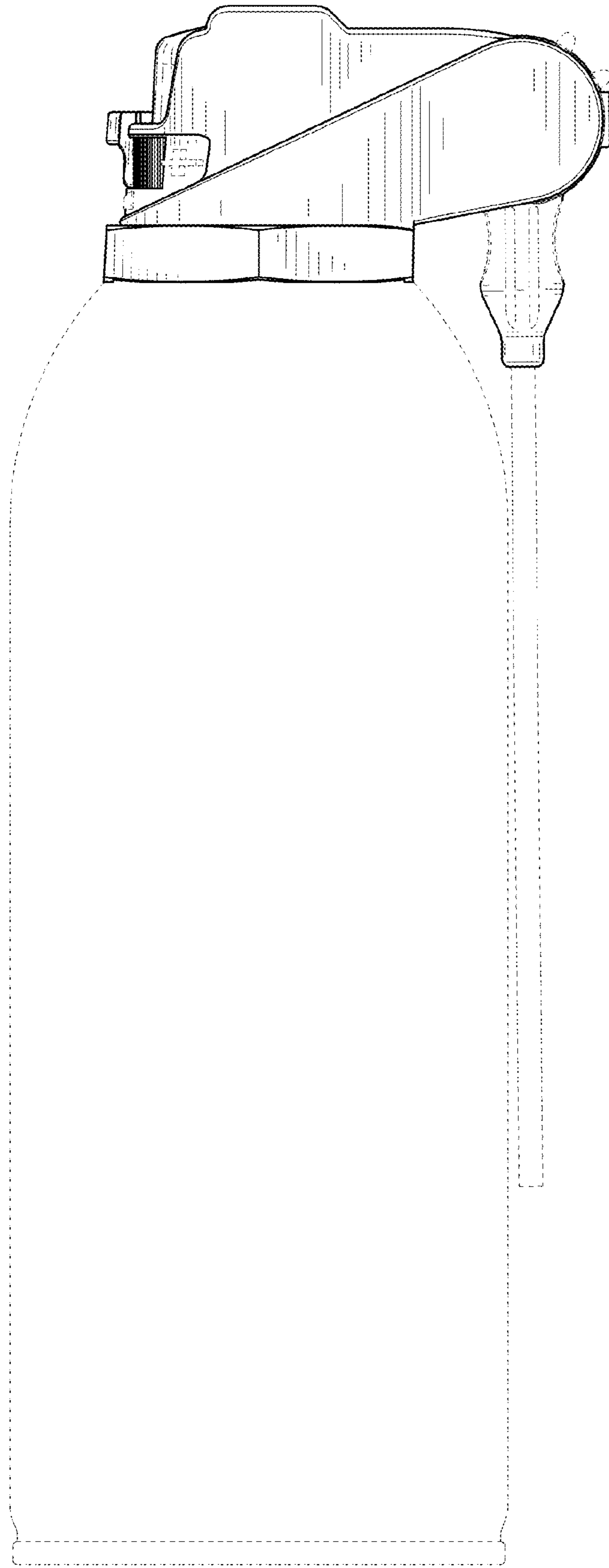
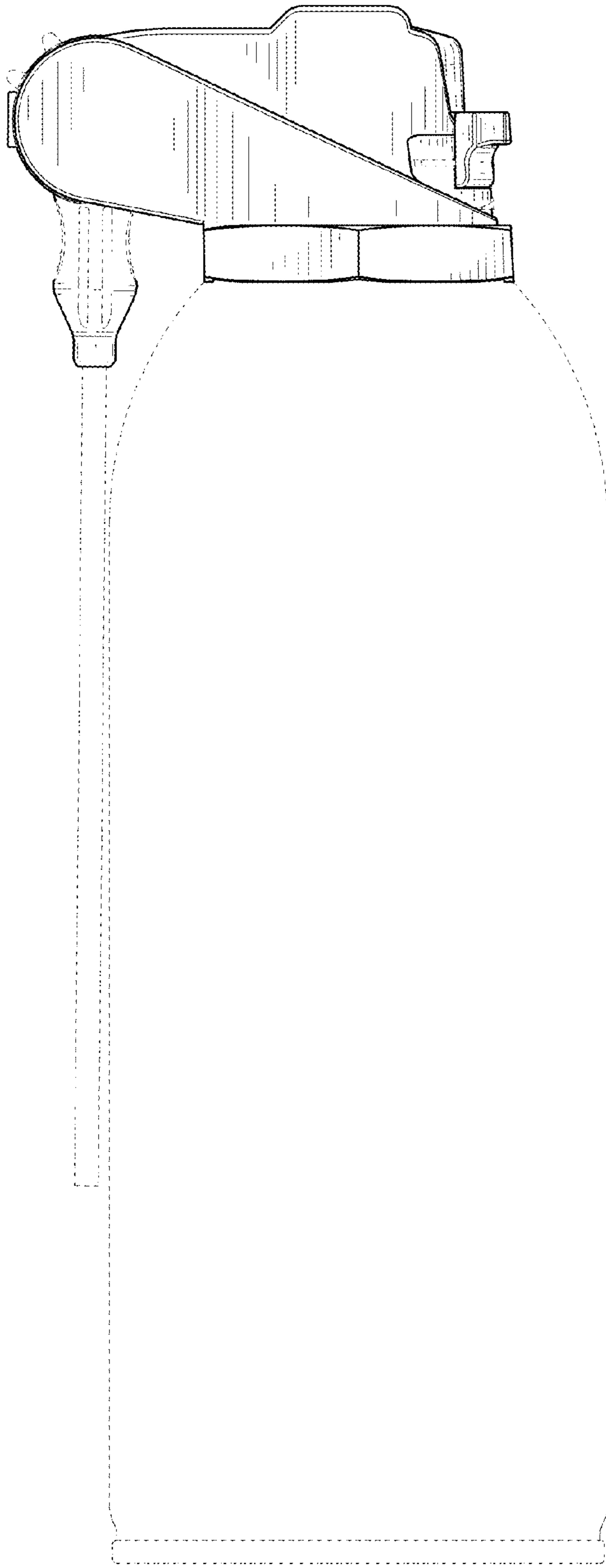
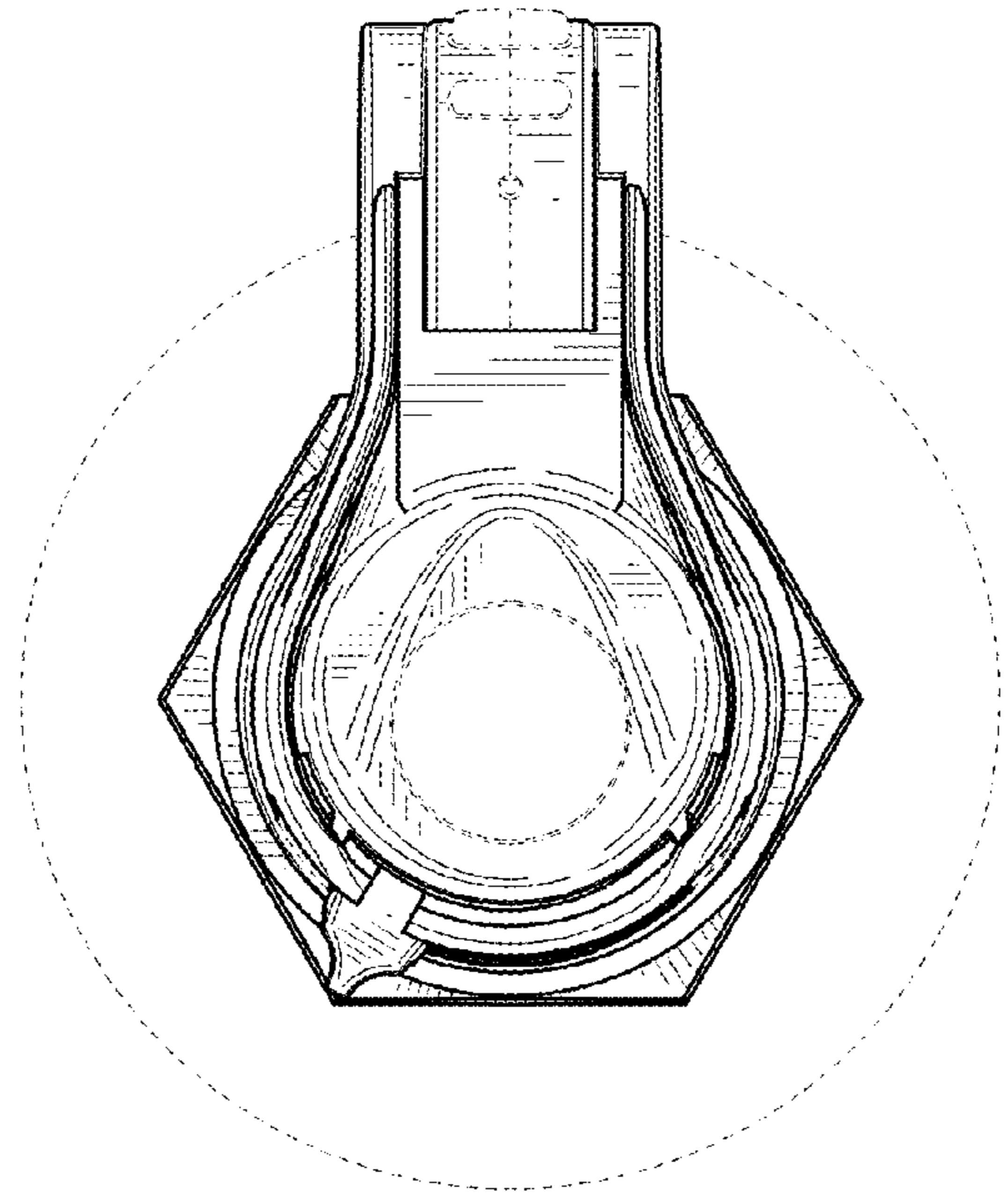


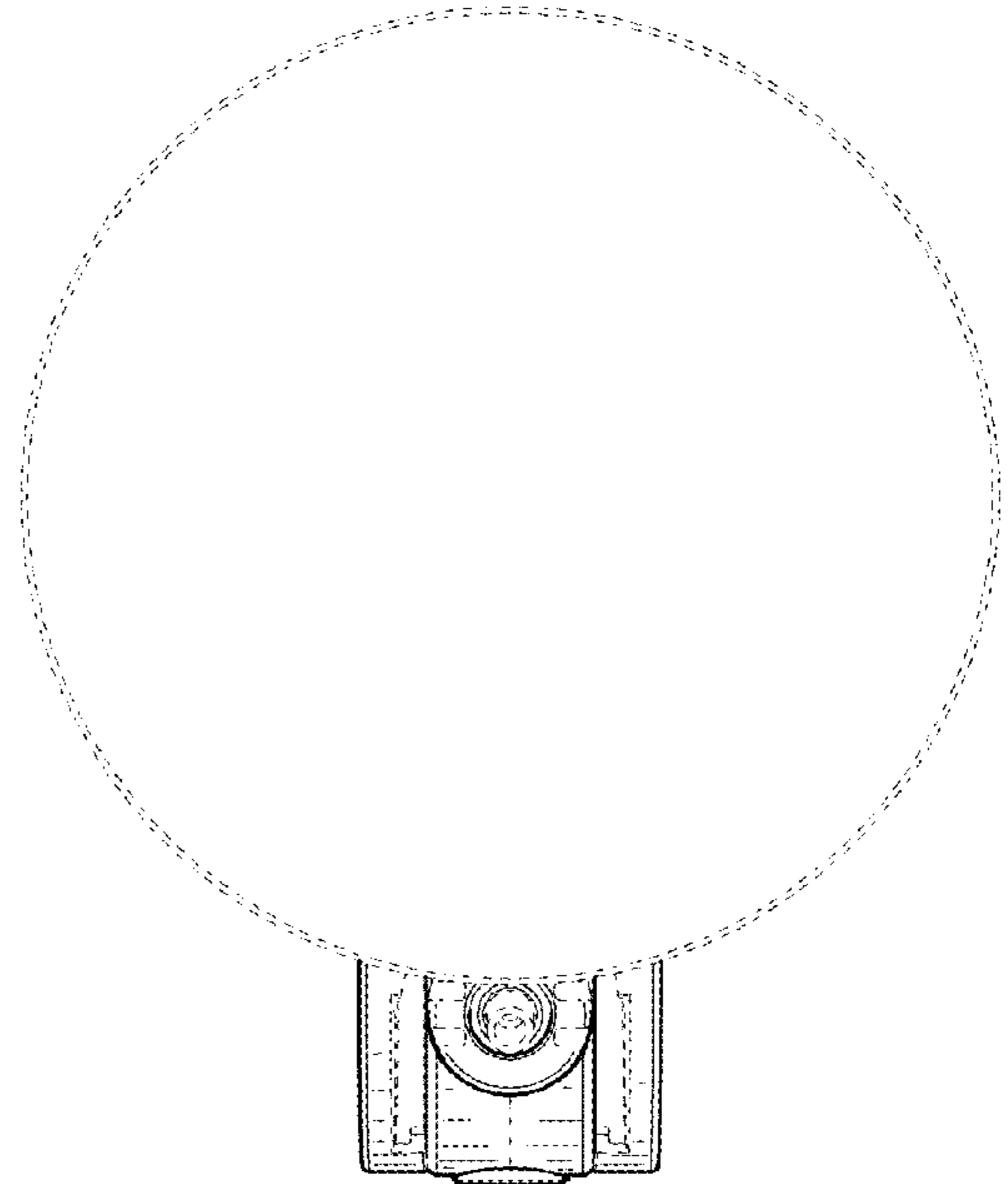

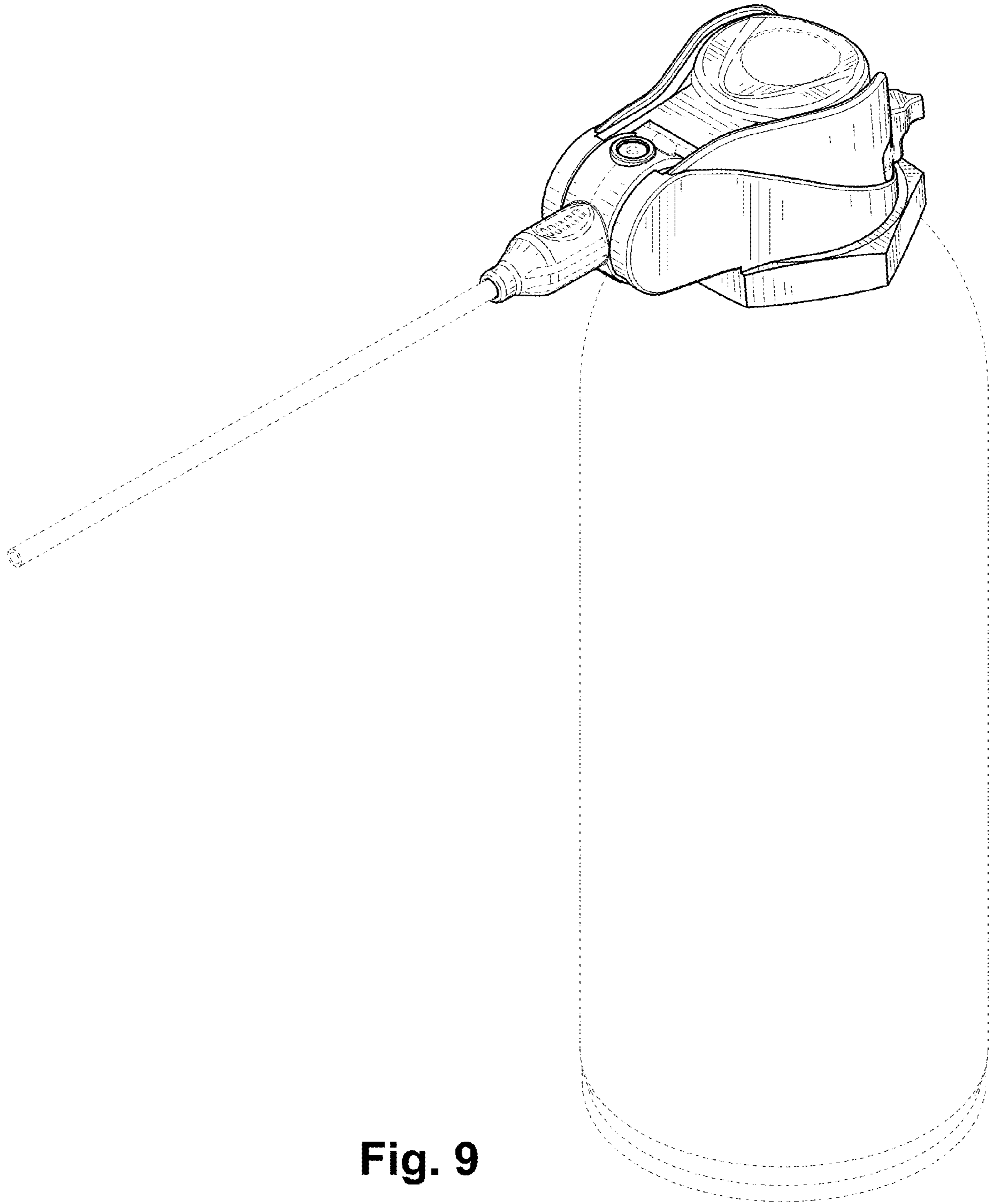
