**DESCRIPTION**

Fig. 1.6 is an enlarged view of Fig. 1.1;

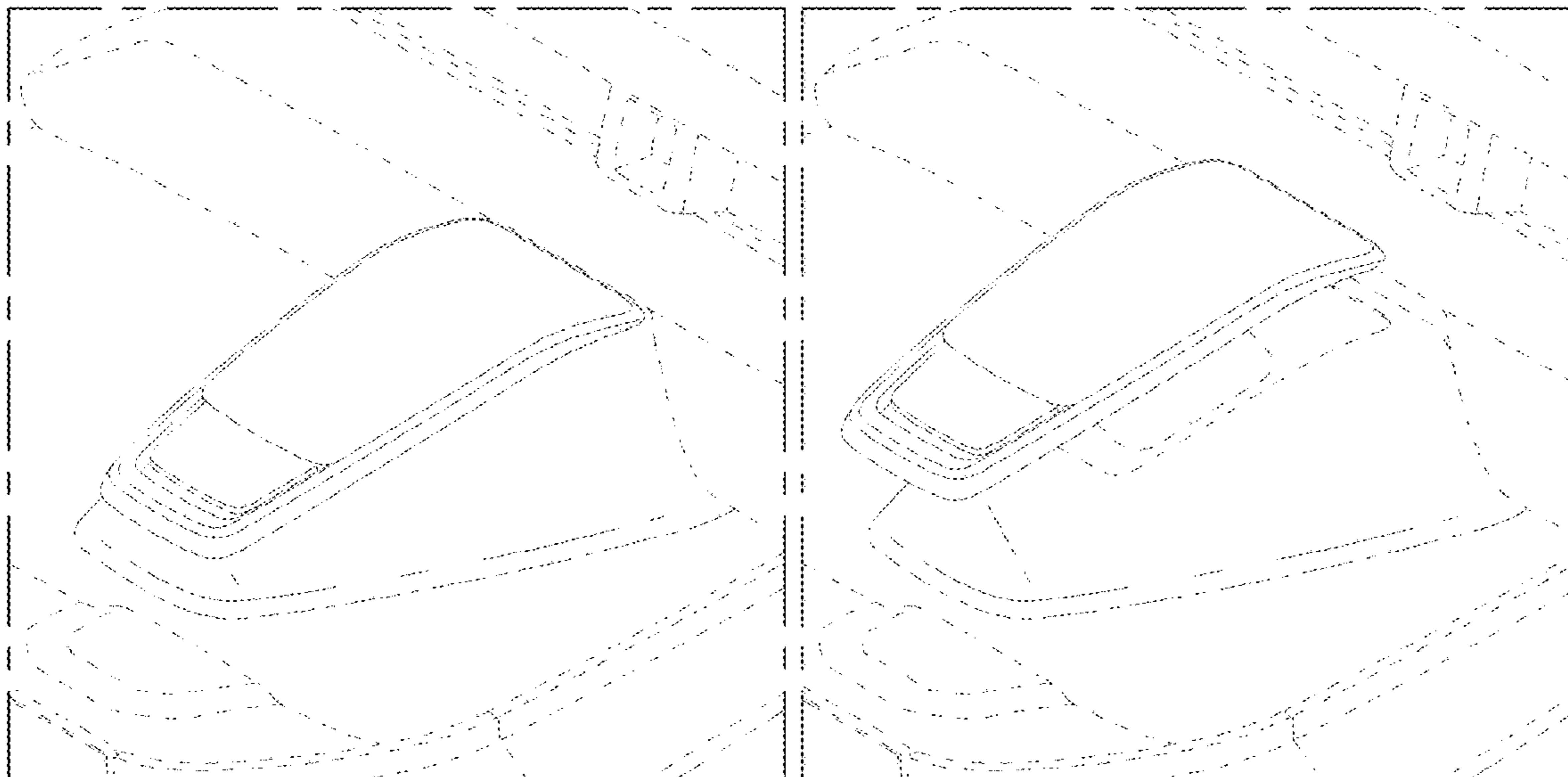
Fig. 1.7 is an enlarged view of Fig. 1.5;

Fig. 1.8 shows the article in an alternate position;

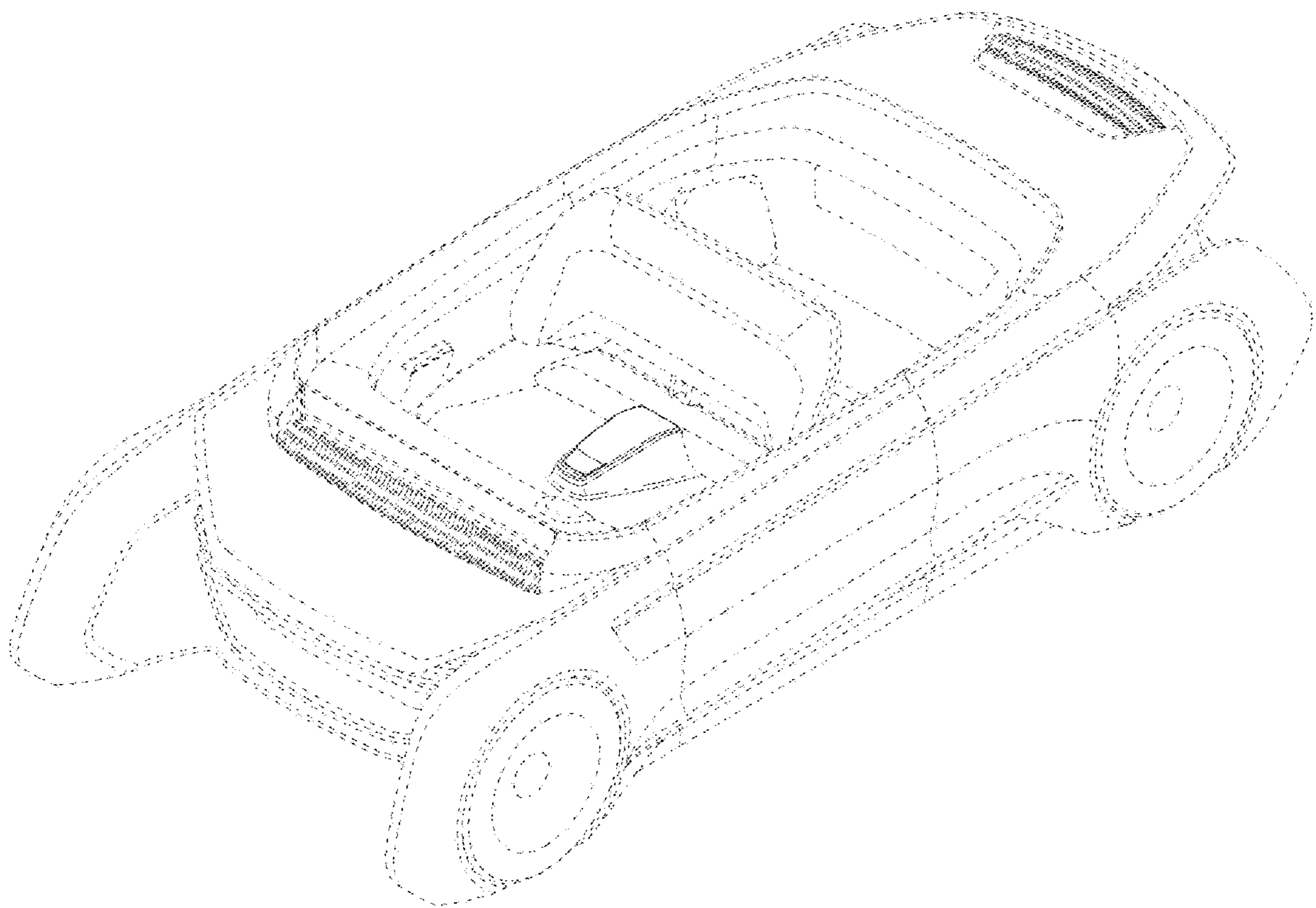
Fig. 1.9 is an enlarged view of Fig. 1.8; the bottom views are omitted since they cannot be seen in use and form no part of the claimed design.

The dash-dash broken lines depict portions of the automobile that form no part of the claimed design; the dash-dot broken lines define the boundary of the claimed design and form no part thereof.

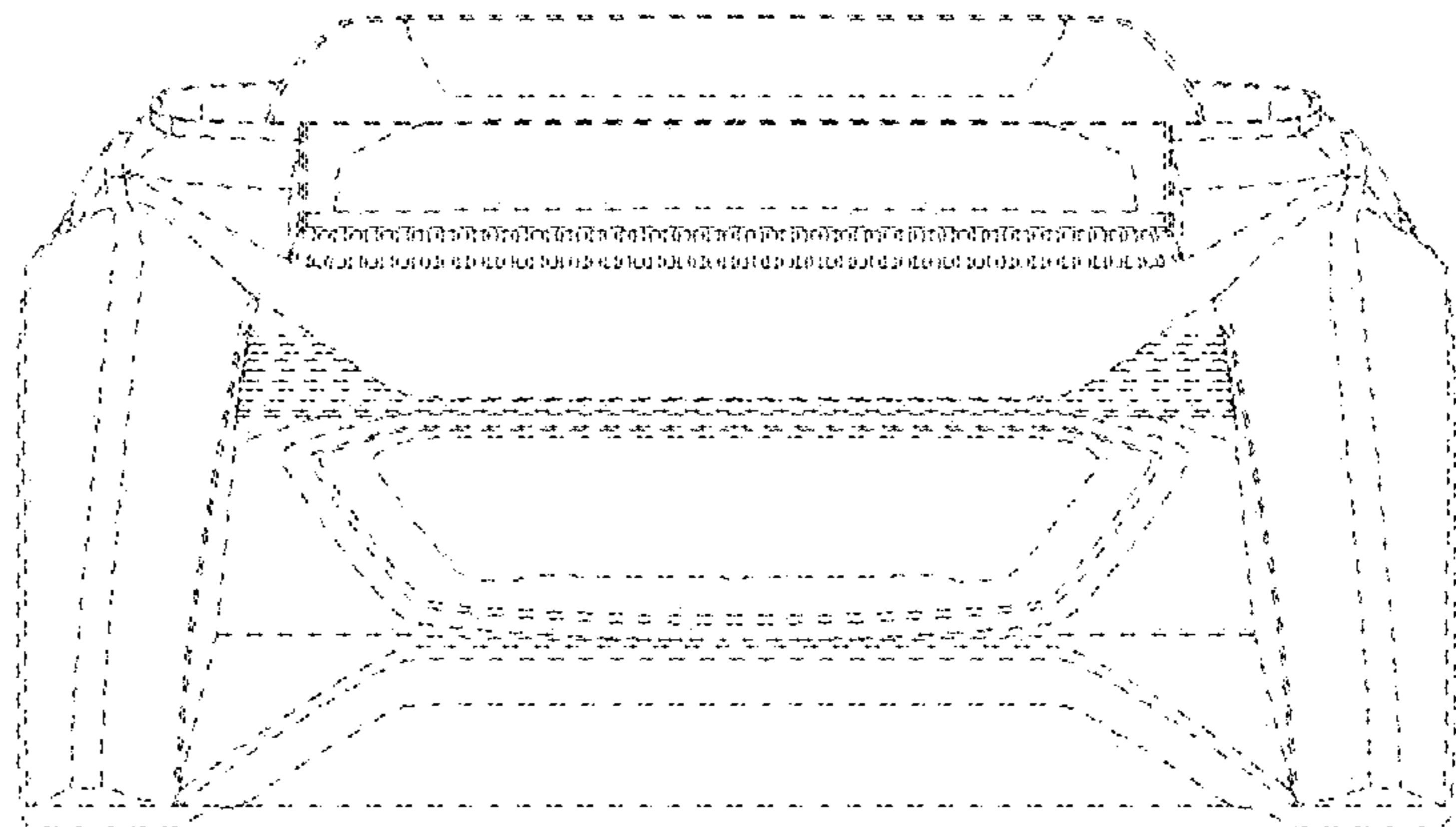

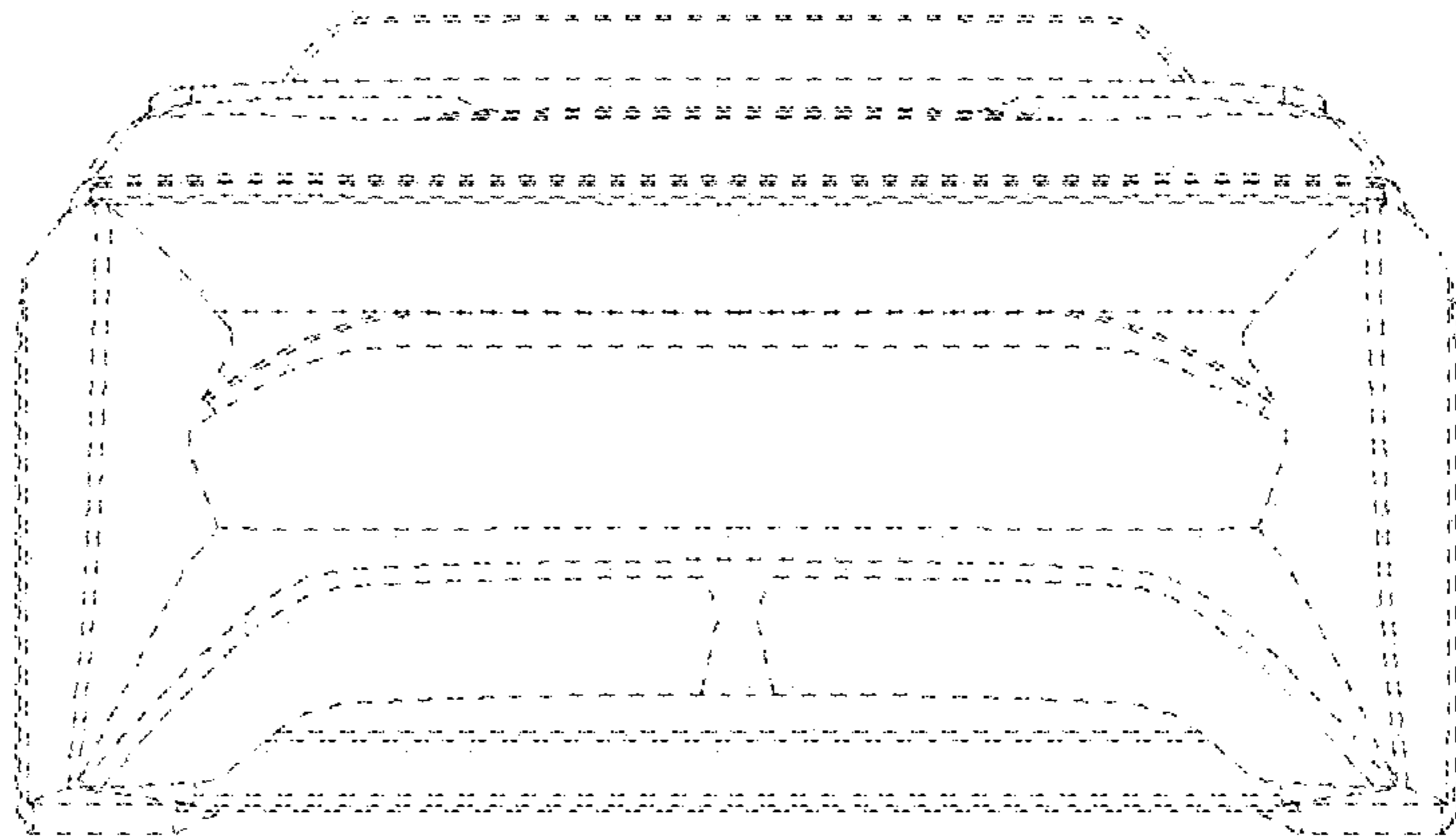

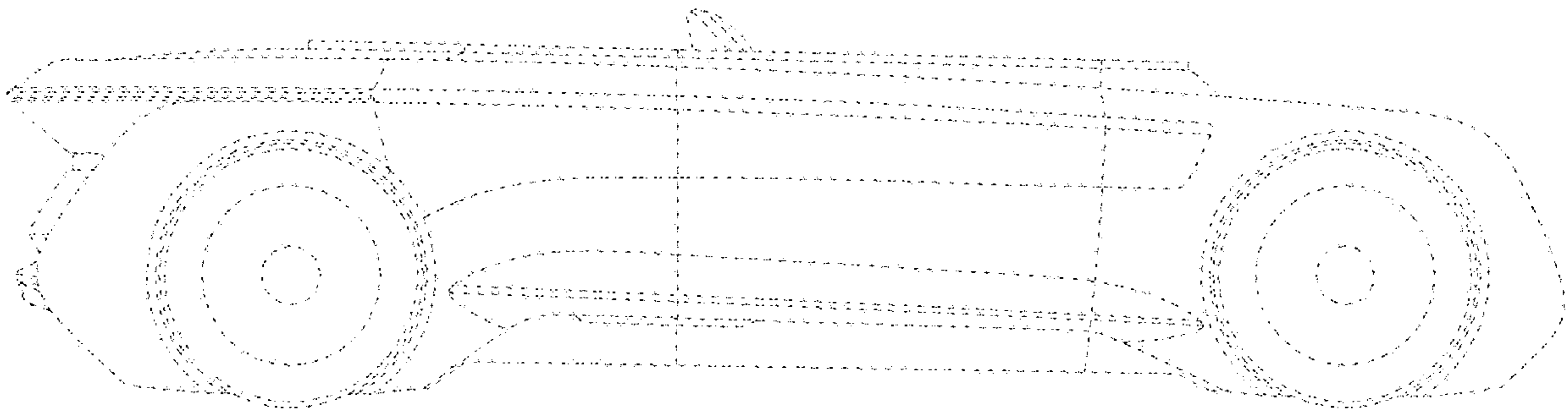

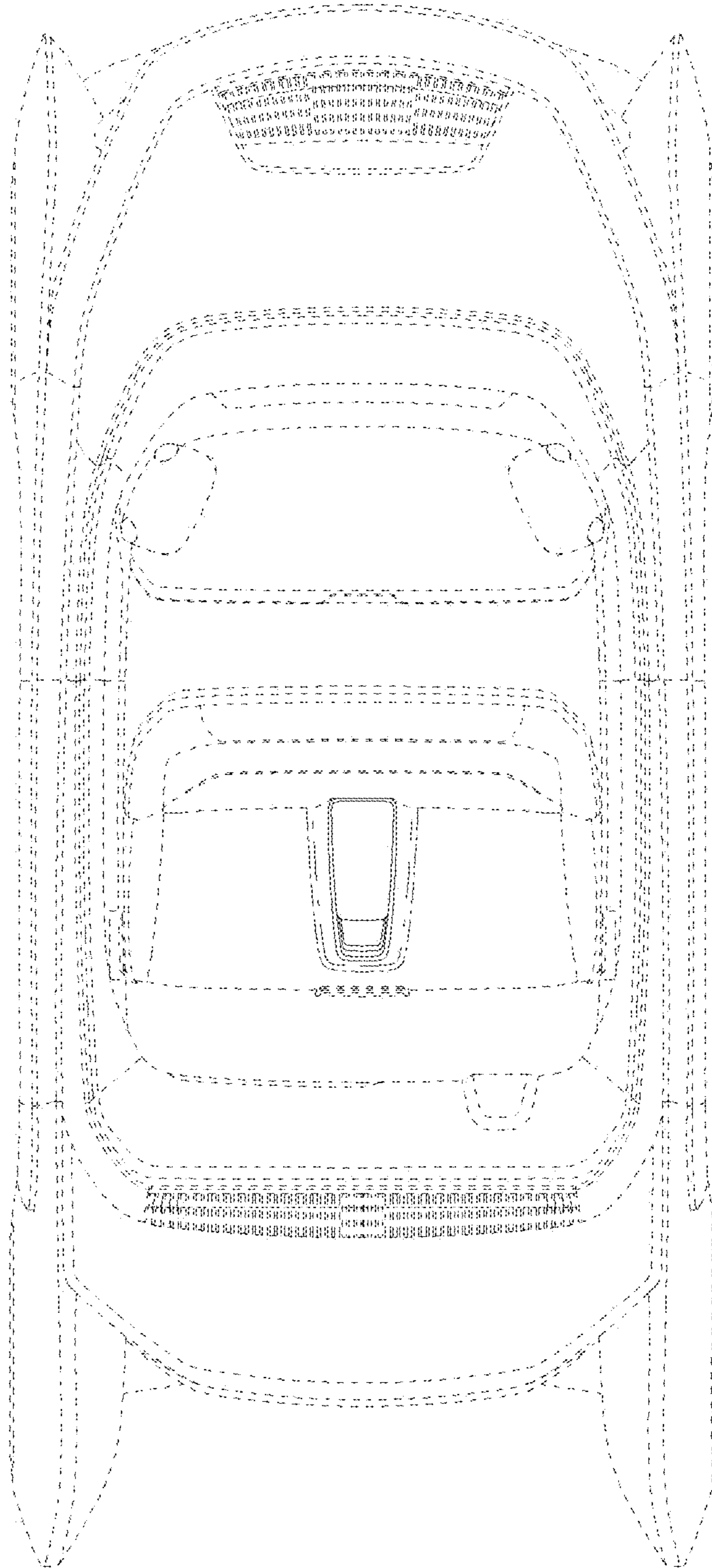

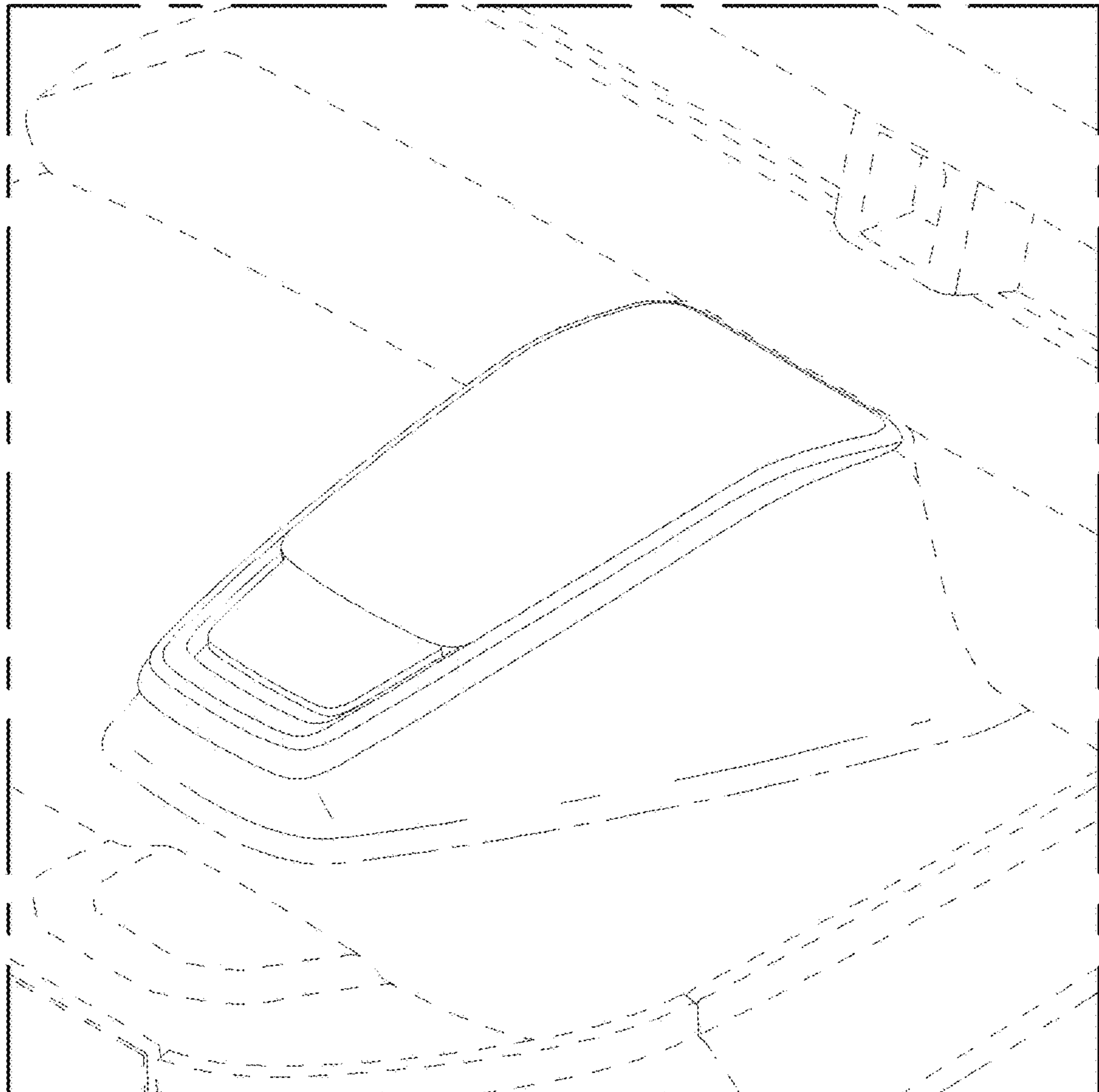

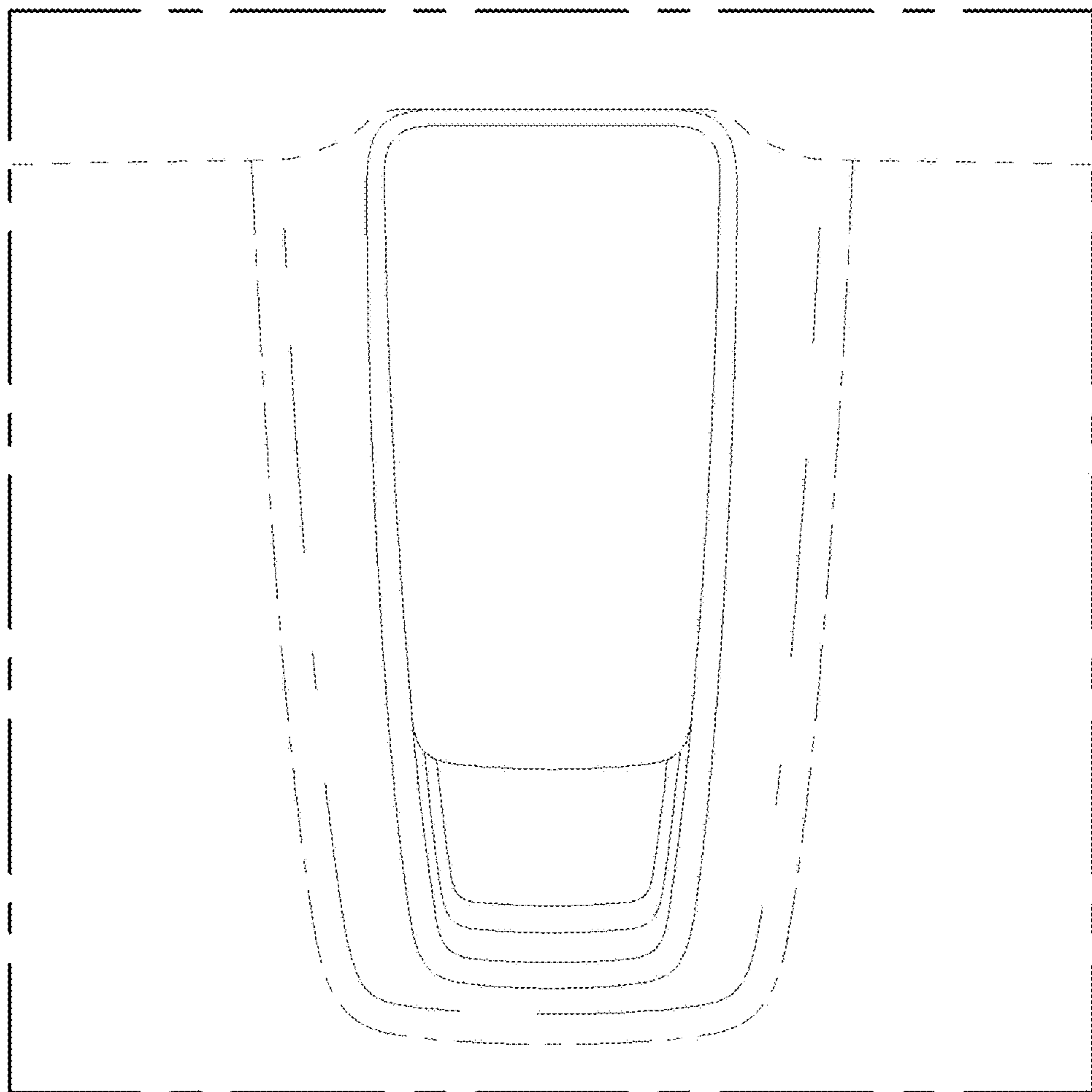

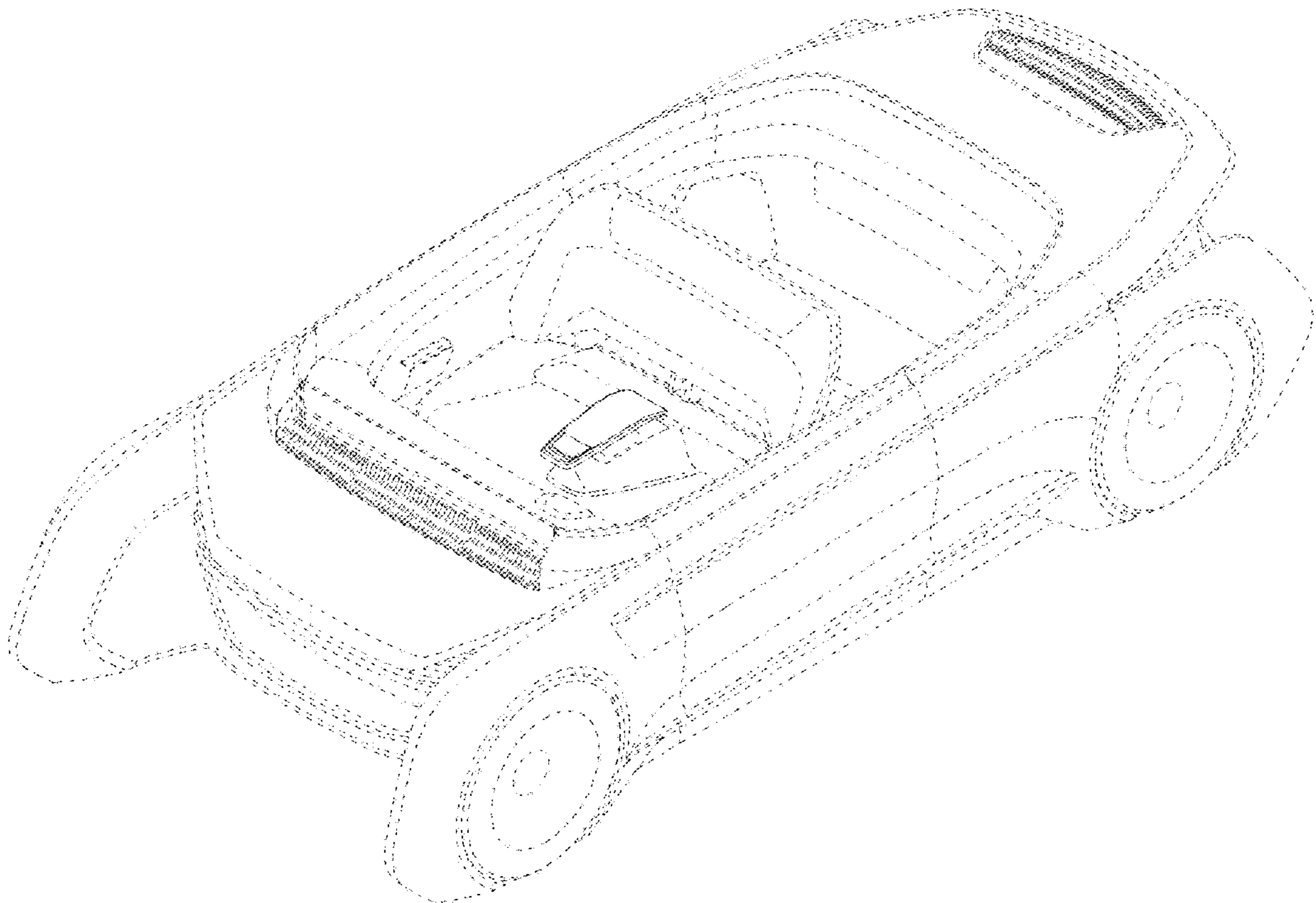
