(57) **CLAIM**

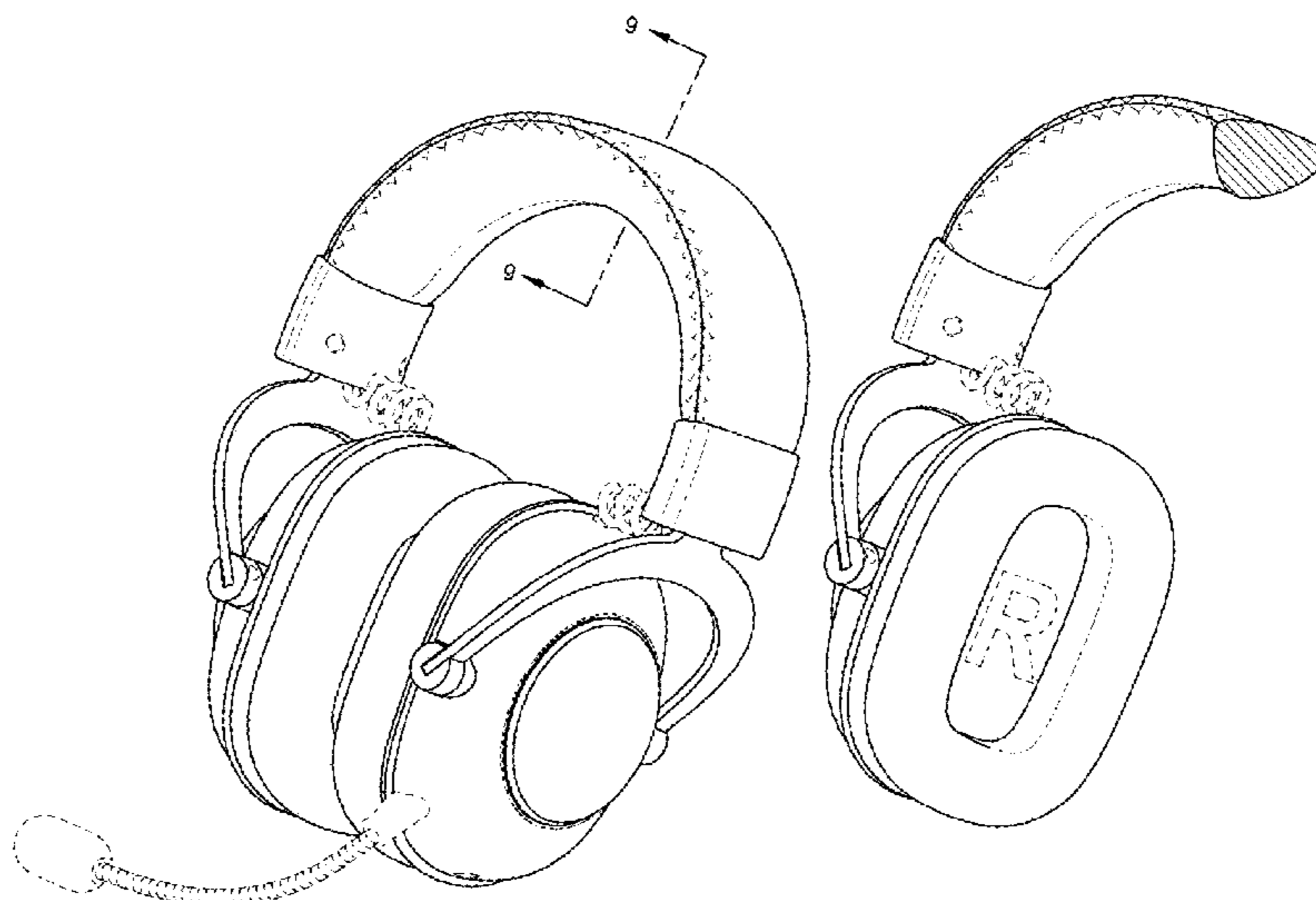
The ornamental design for headphones, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side perspective view of headphones showing our new design;
 FIG. 2 is a front, right side perspective view thereof;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a top plan view thereof;
 FIG. 6 is a bottom plan view thereof;
 FIG. 7 is a left side elevational view thereof;
 FIG. 8 is a right side elevational view thereof;
 FIG. 9 is a right side sectional view taken along line 9-9 of FIG. 1; and,
 FIG. 10 is a left side sectional view taken along line 10-10 of FIG. 2.

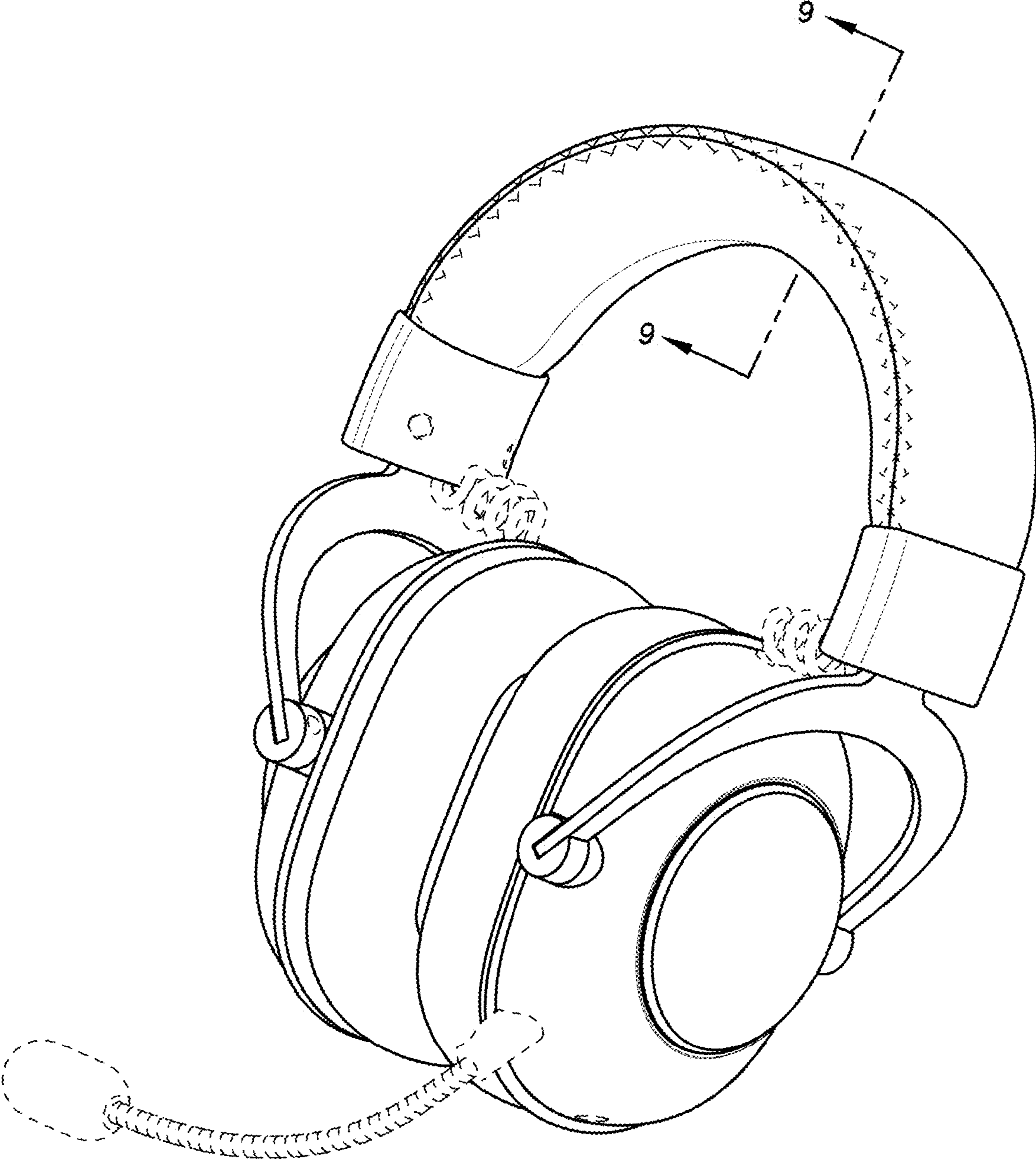

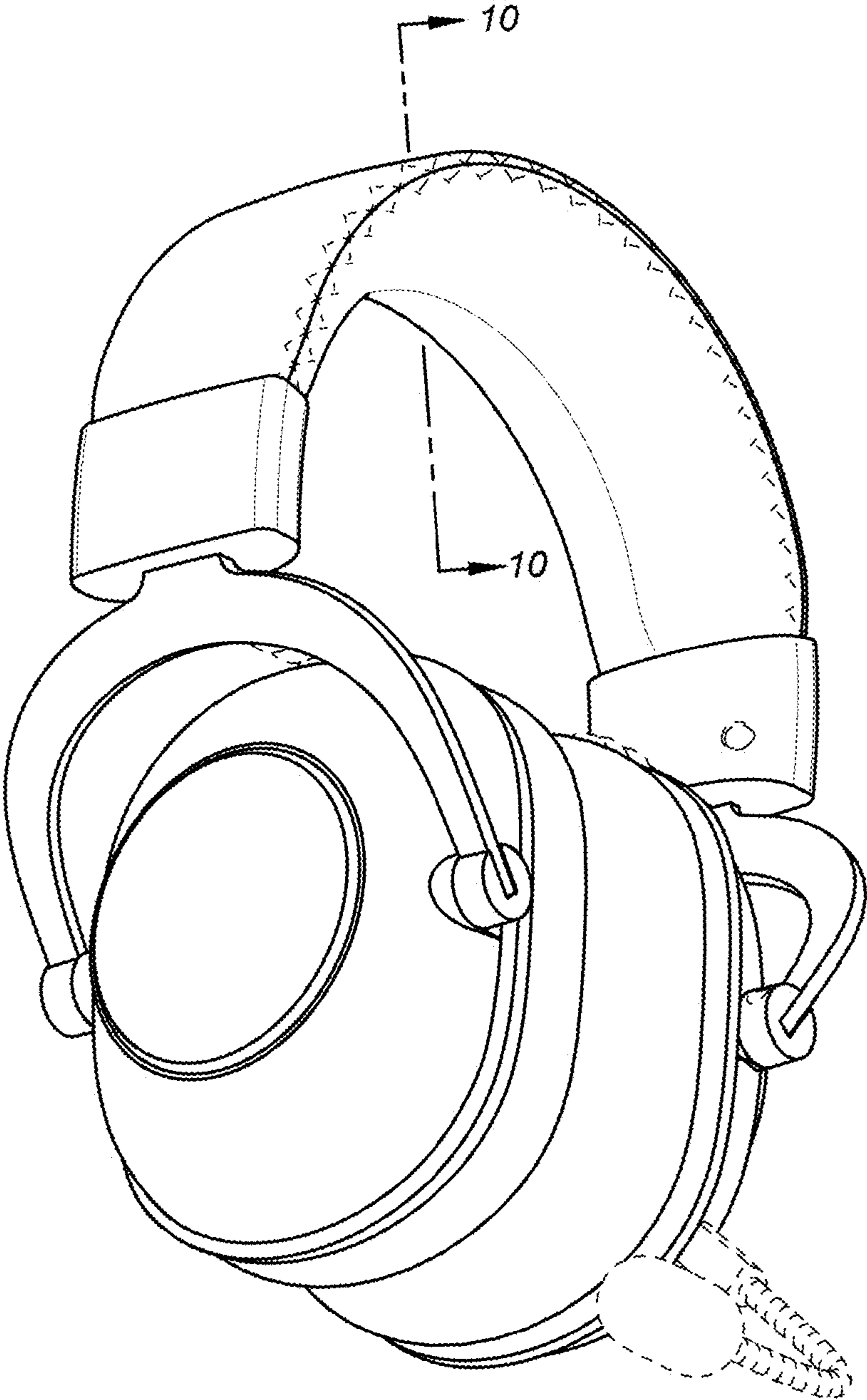

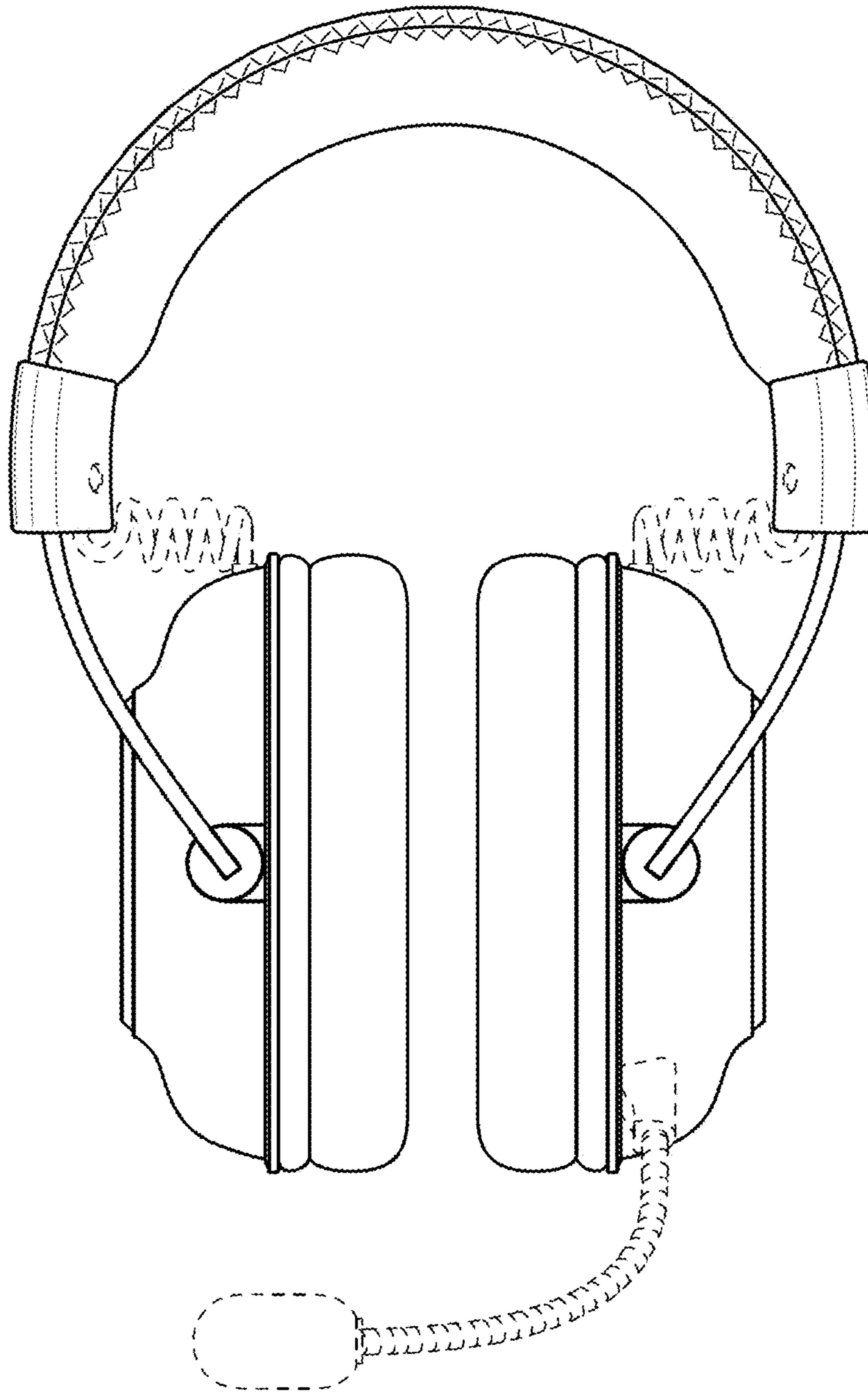

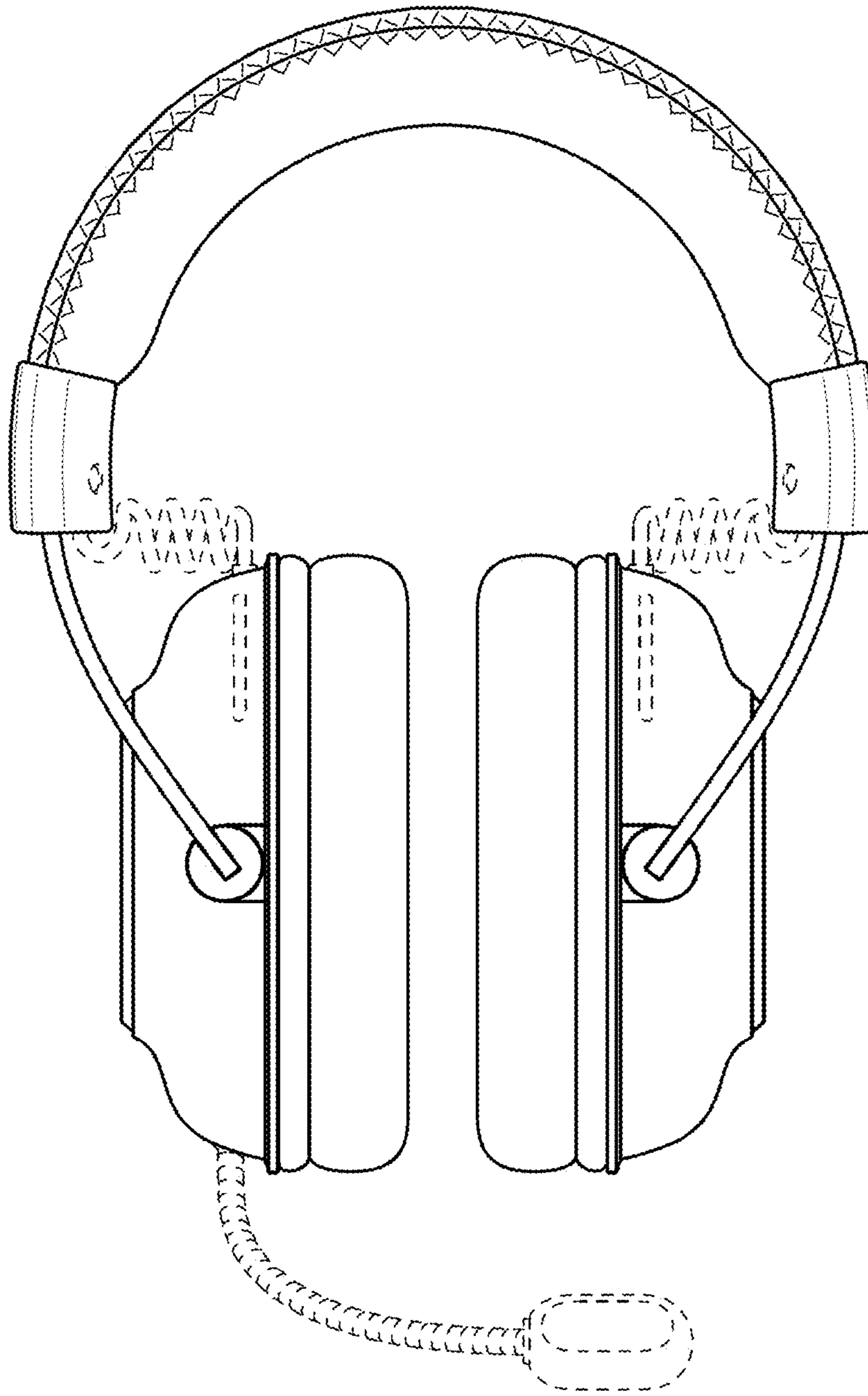

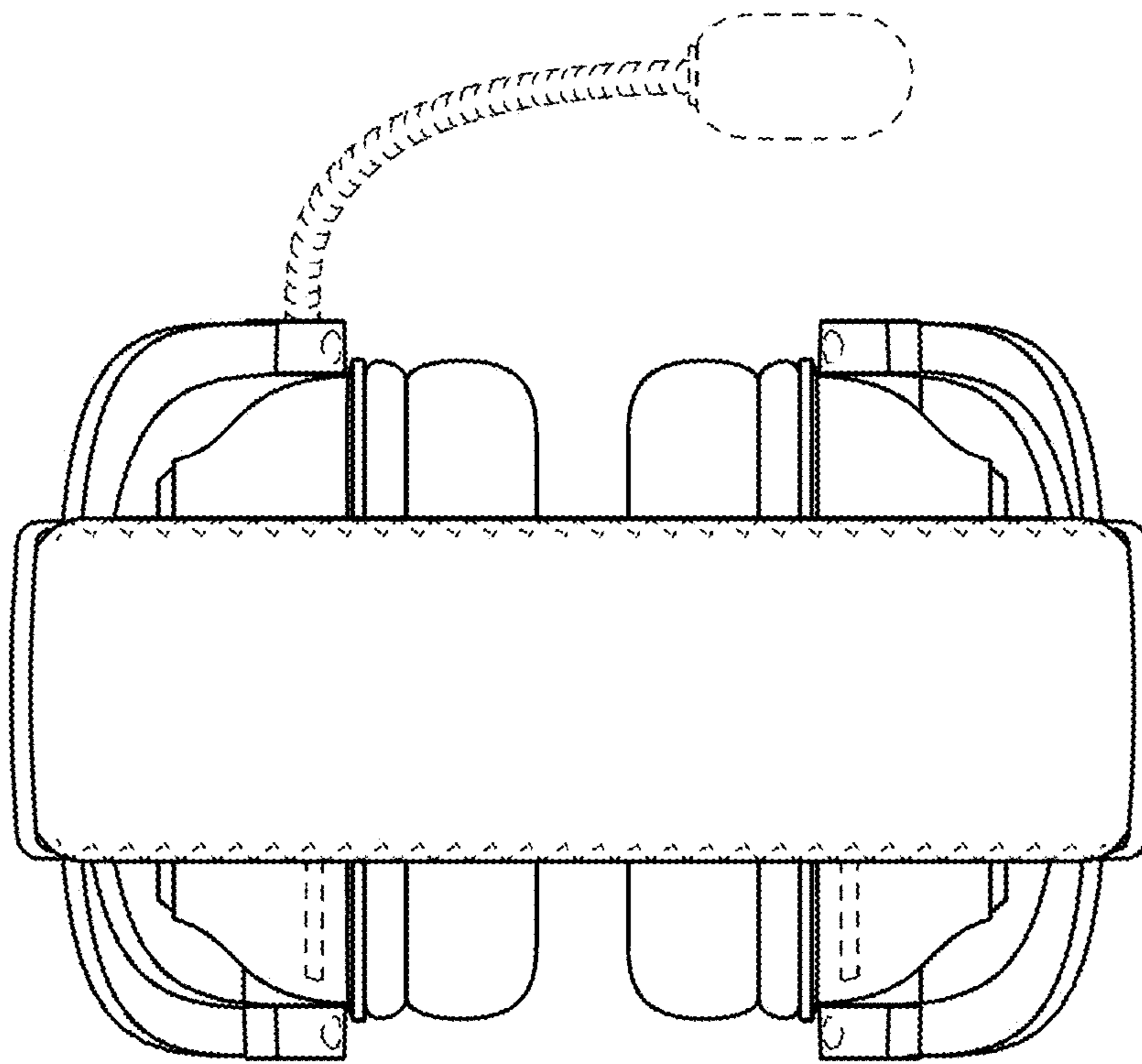

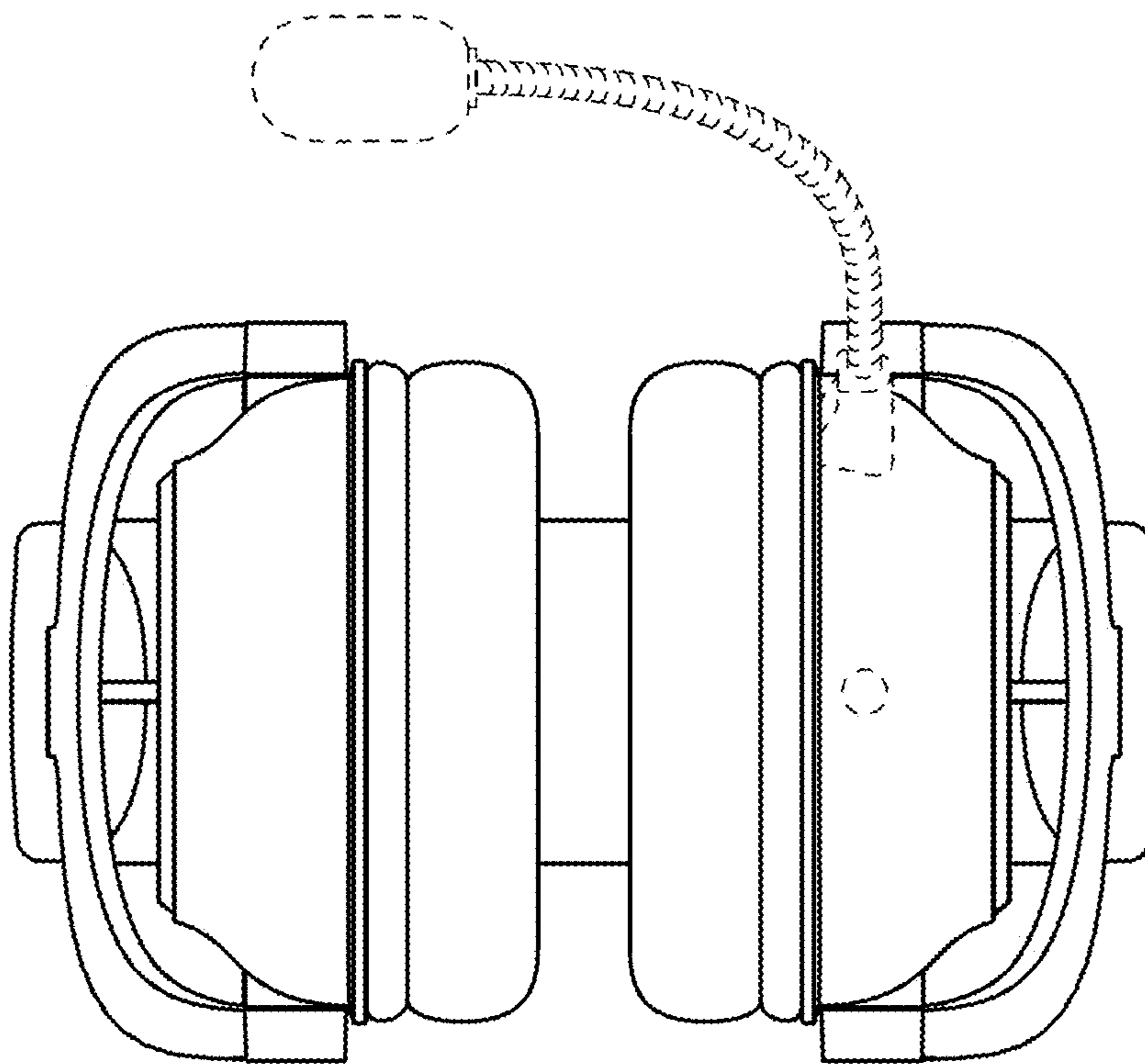

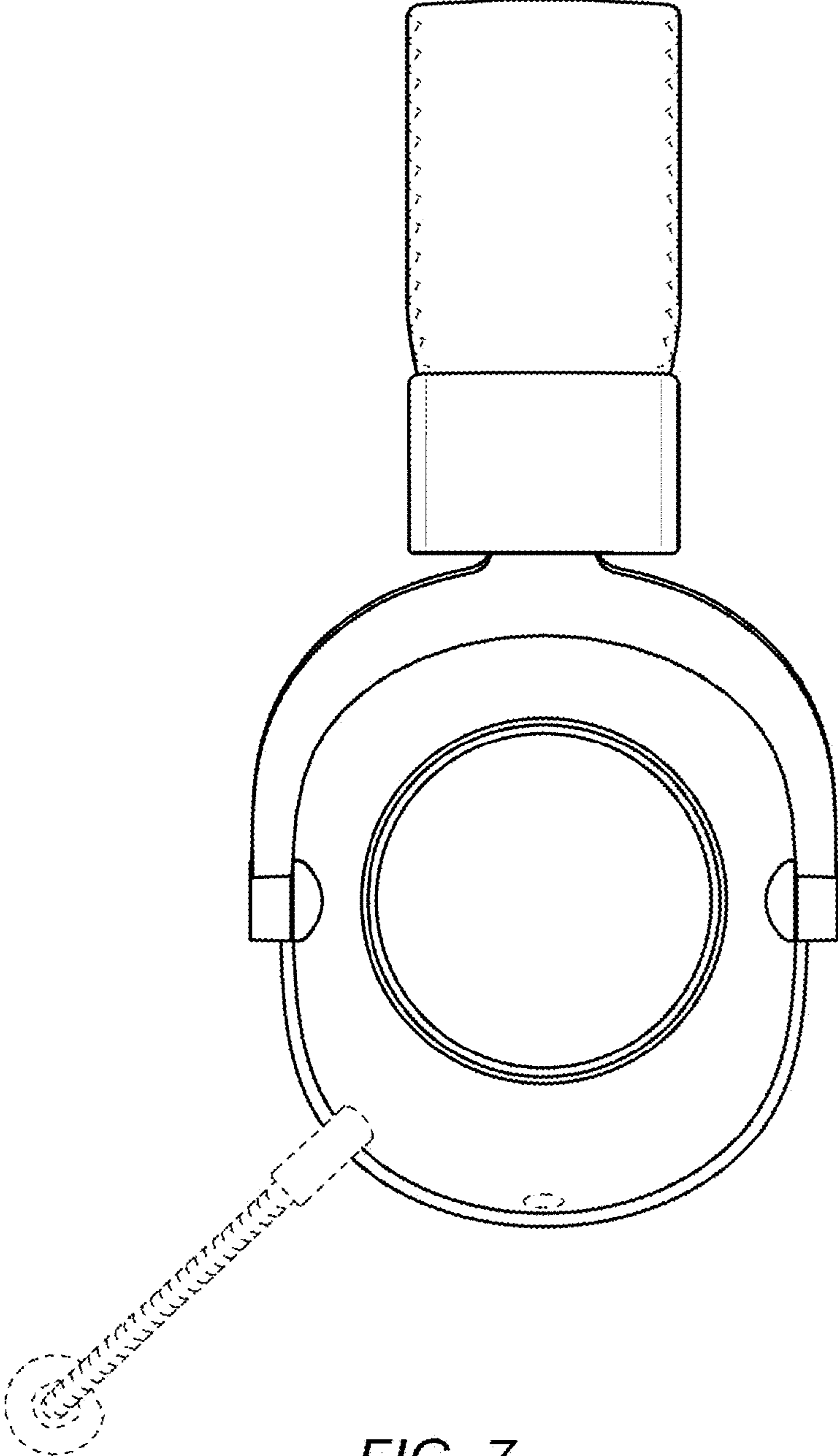

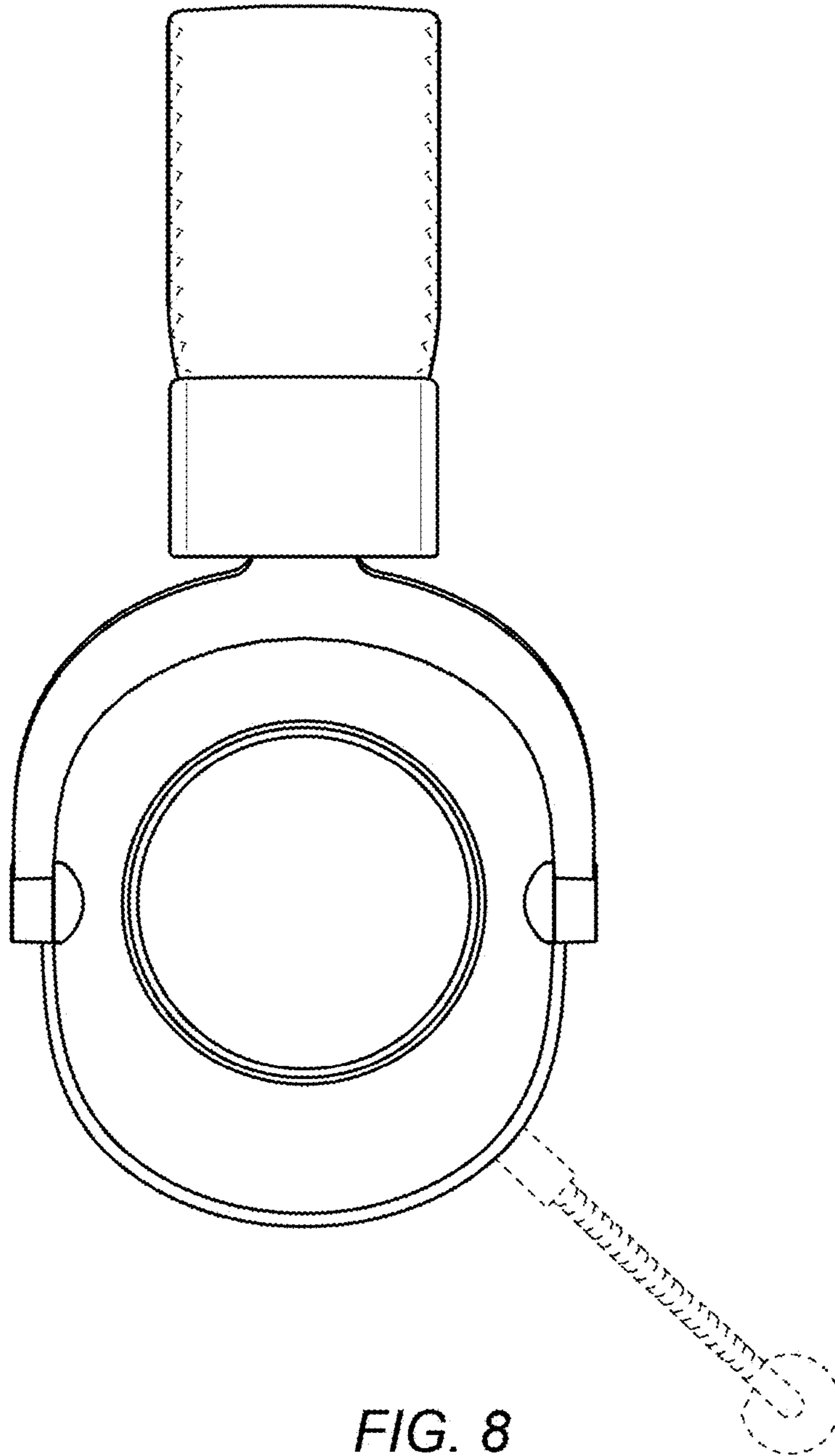

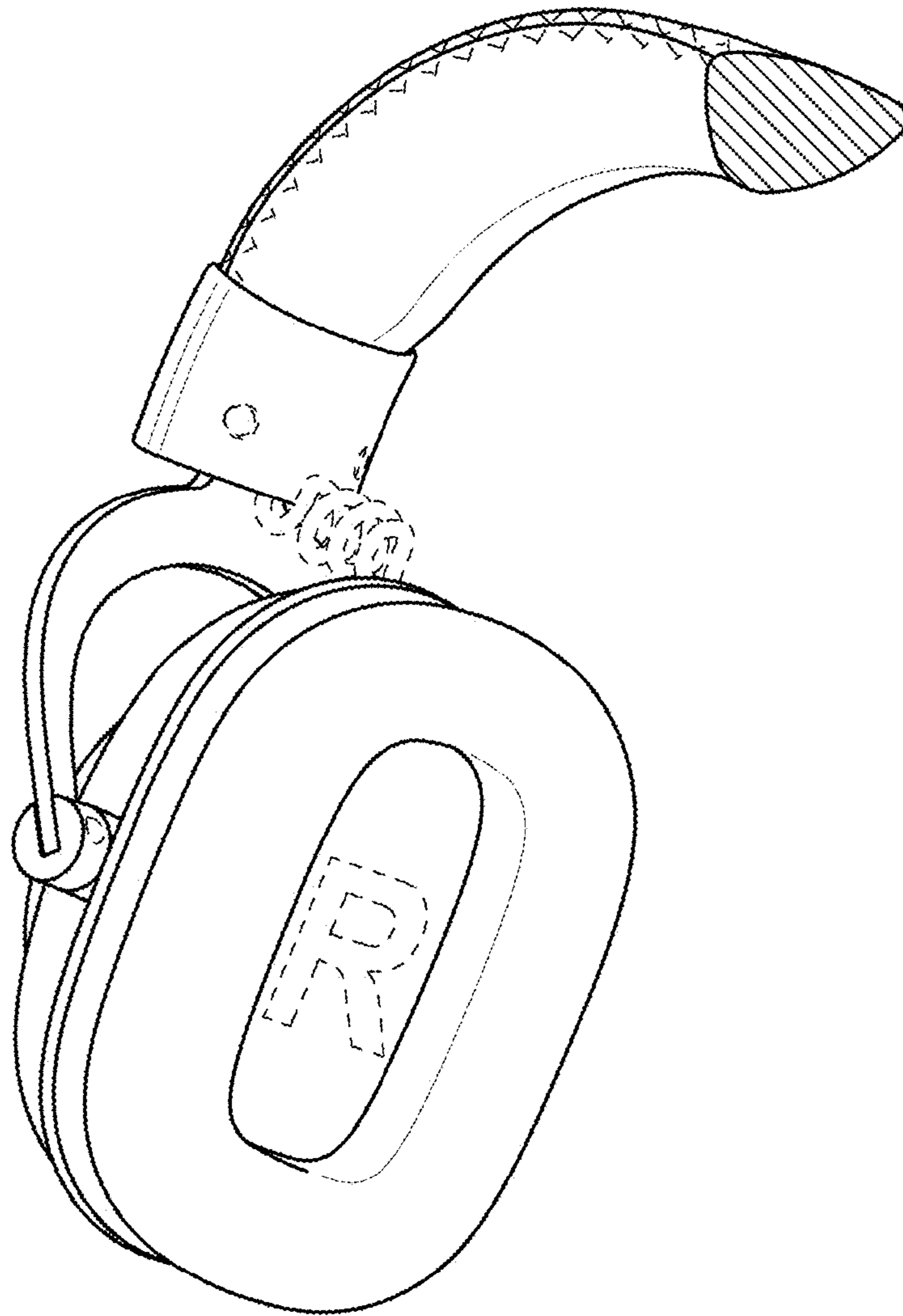

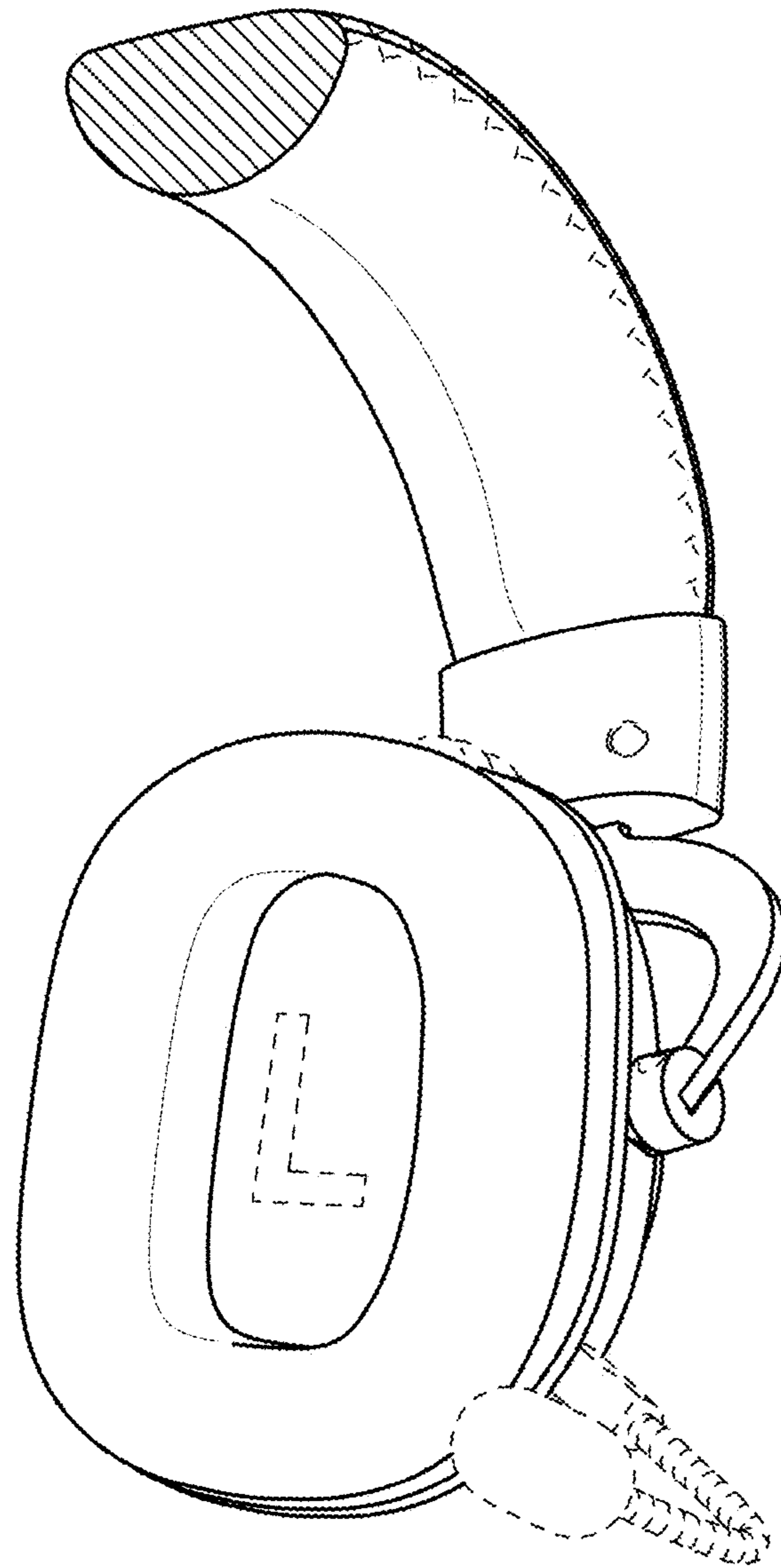
