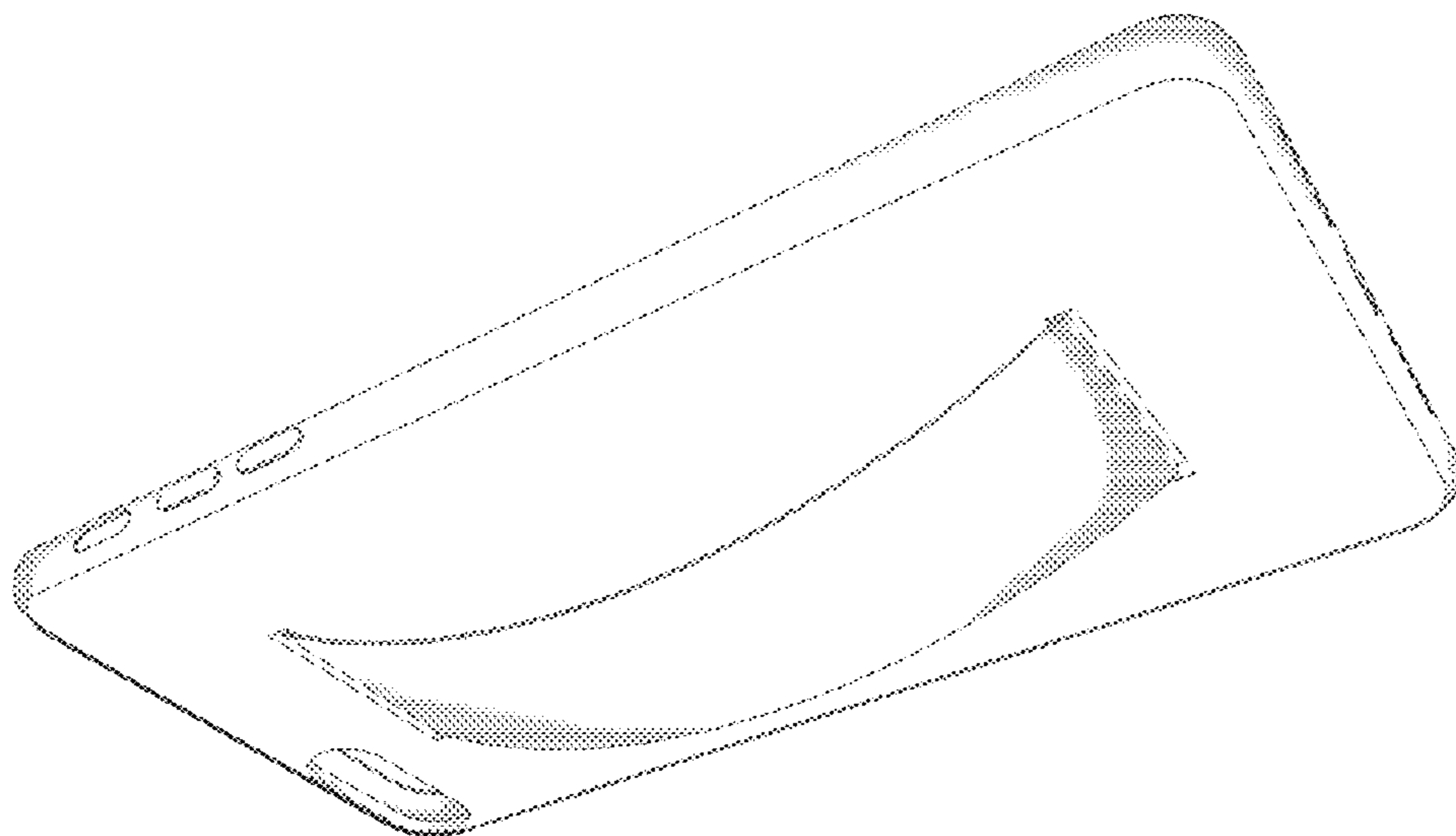
(57) **CLAIM**

The ornamental design for a smart phone case with removable strap, as shown.

DESCRIPTION

FIG. 1 is a top plan view of a smart phone case with removable strap, with the strap attached;
 FIG. 2 is a bottom plan view of a smart phone case with removable strap, with the strap attached;
 FIG. 3 is front perspective view of a smart phone case with removable strap, with the strap attached;
 FIG. 4 is a rear perspective view of a smart phone case with removable strap, with the strap attached;
 FIG. 5 is a left side perspective view of a smart phone case with removable strap, with the strap removed;

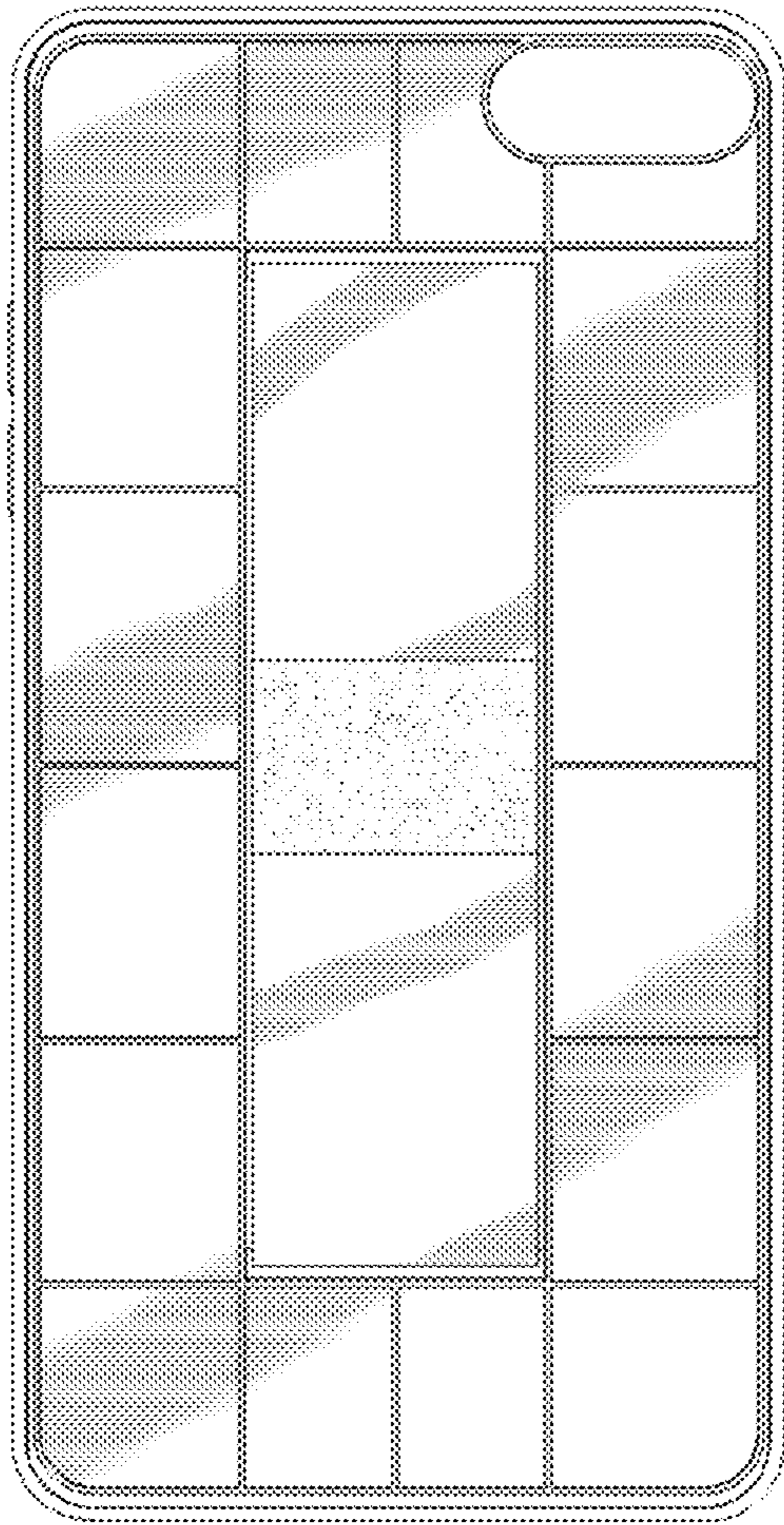

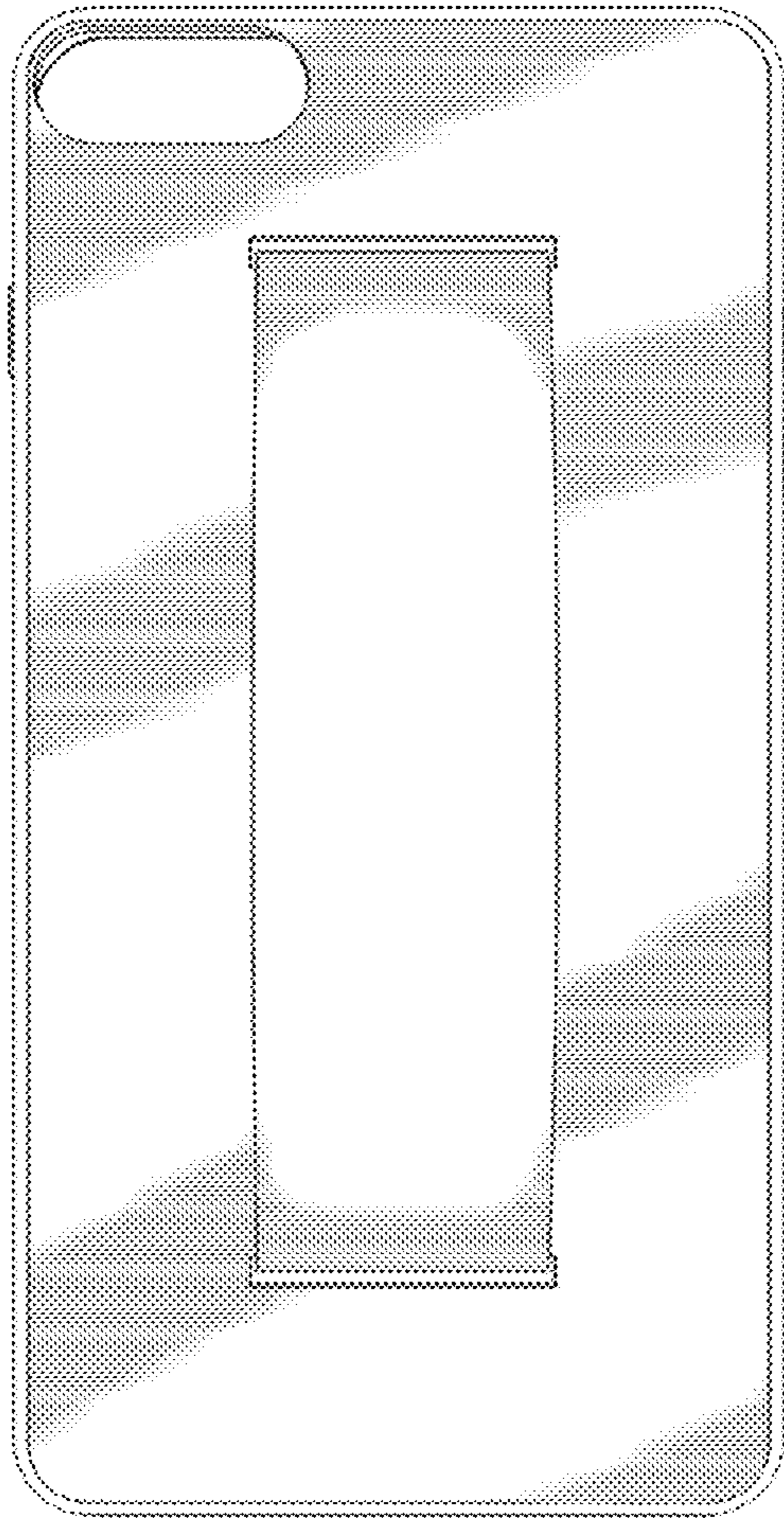

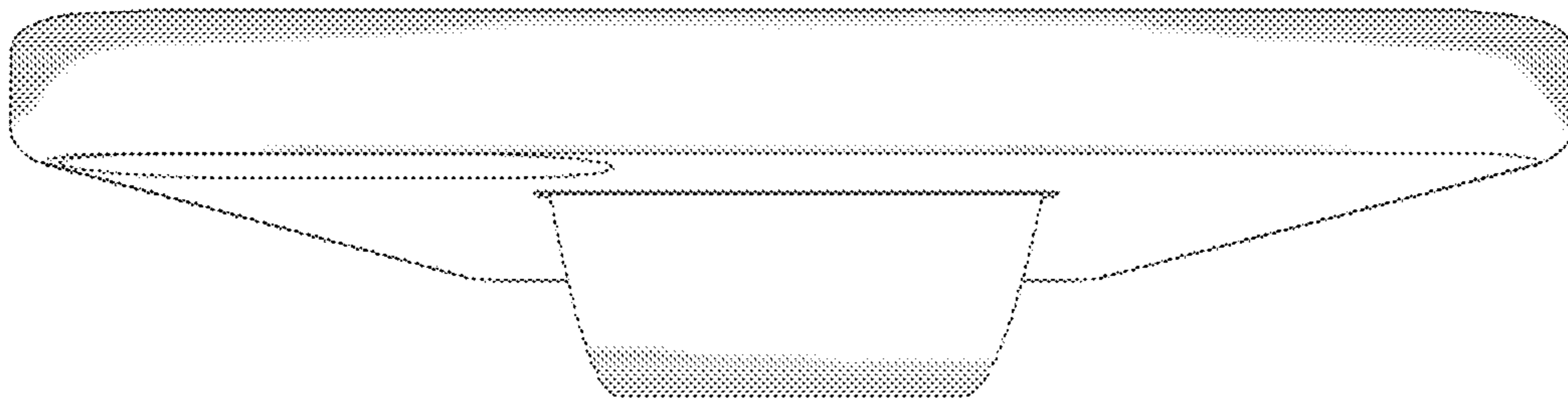

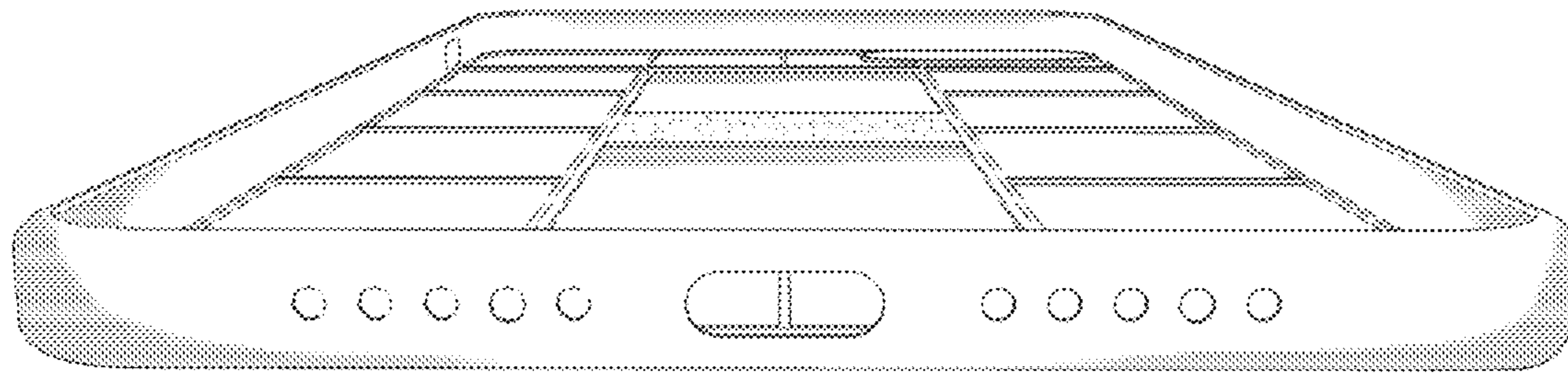

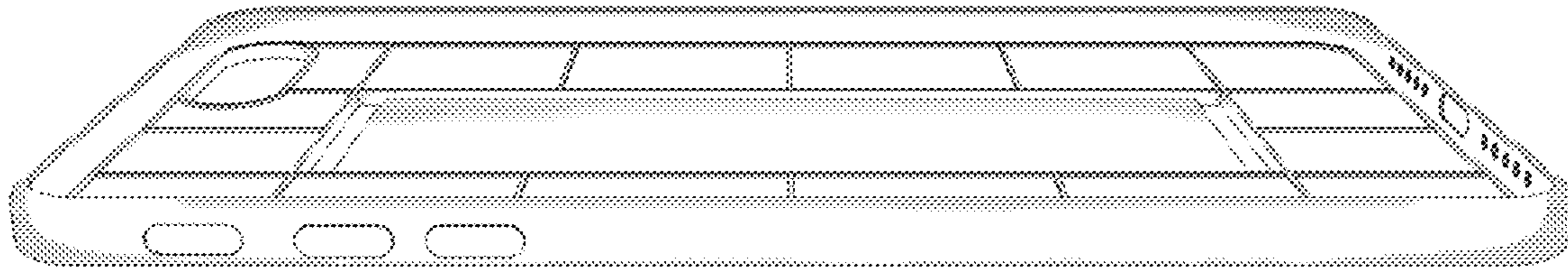

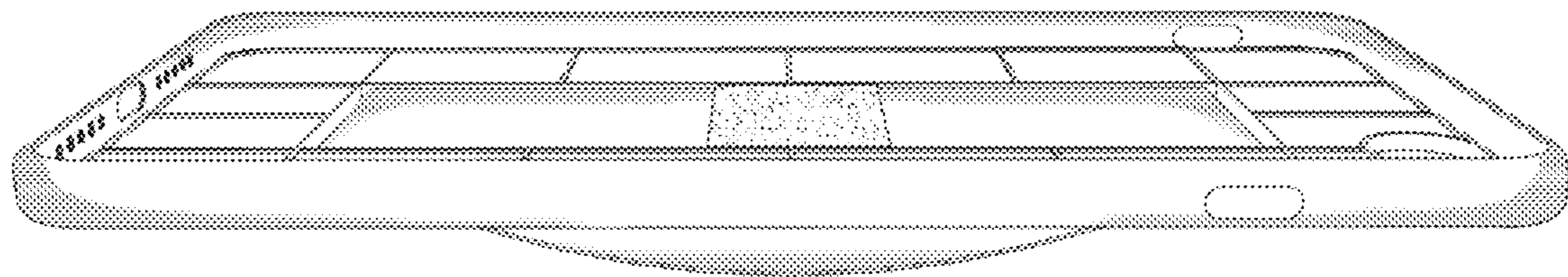

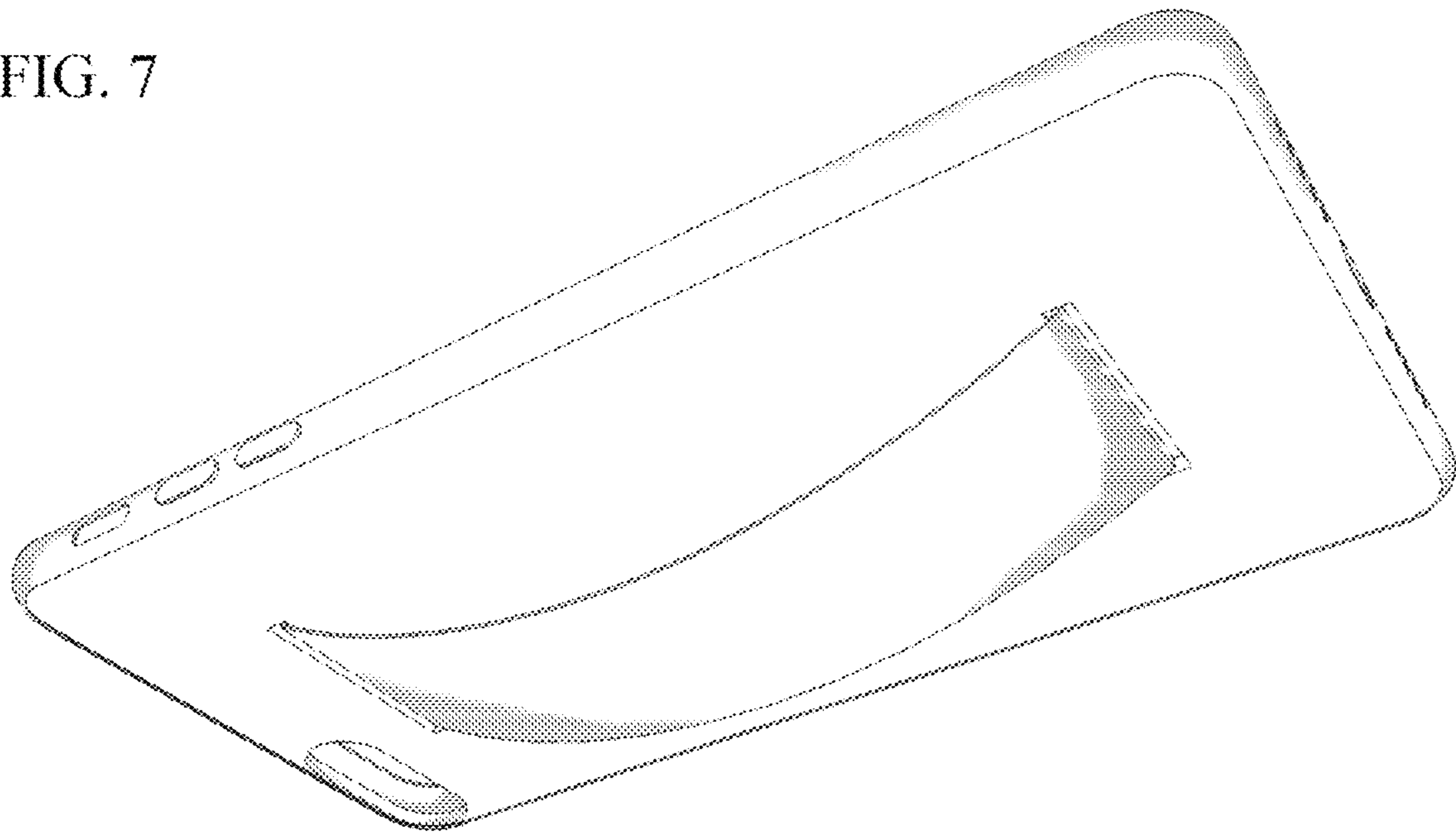
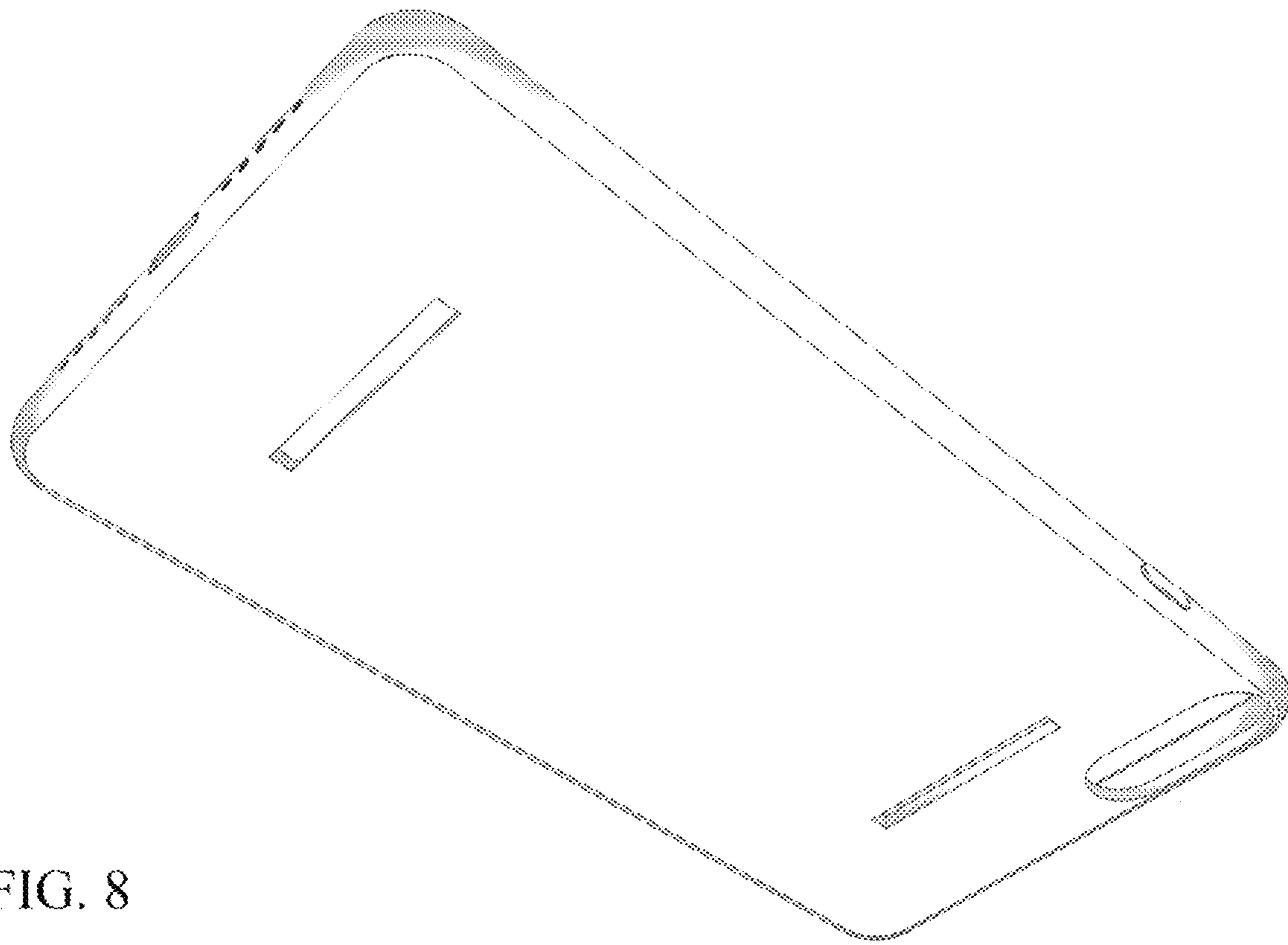

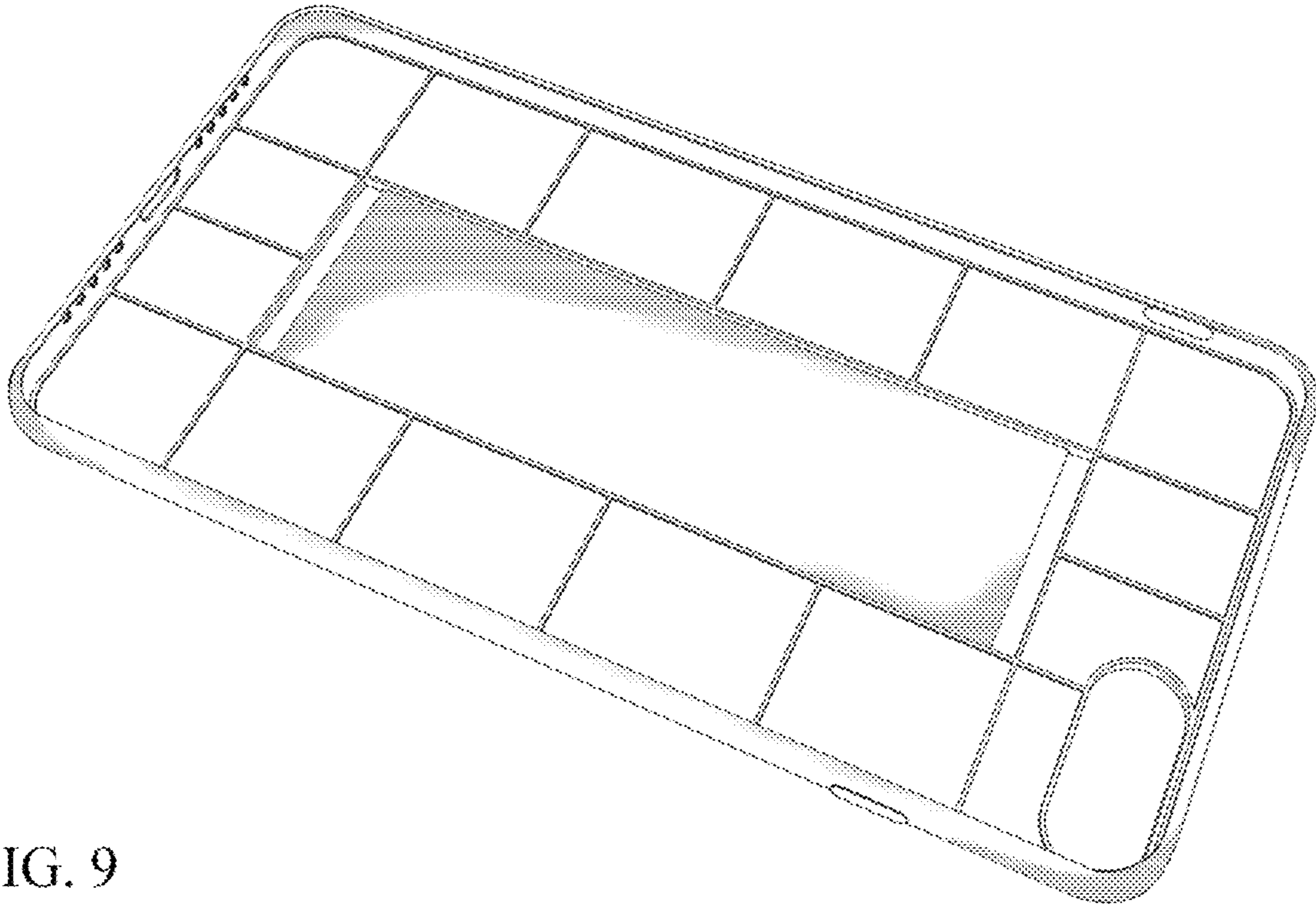

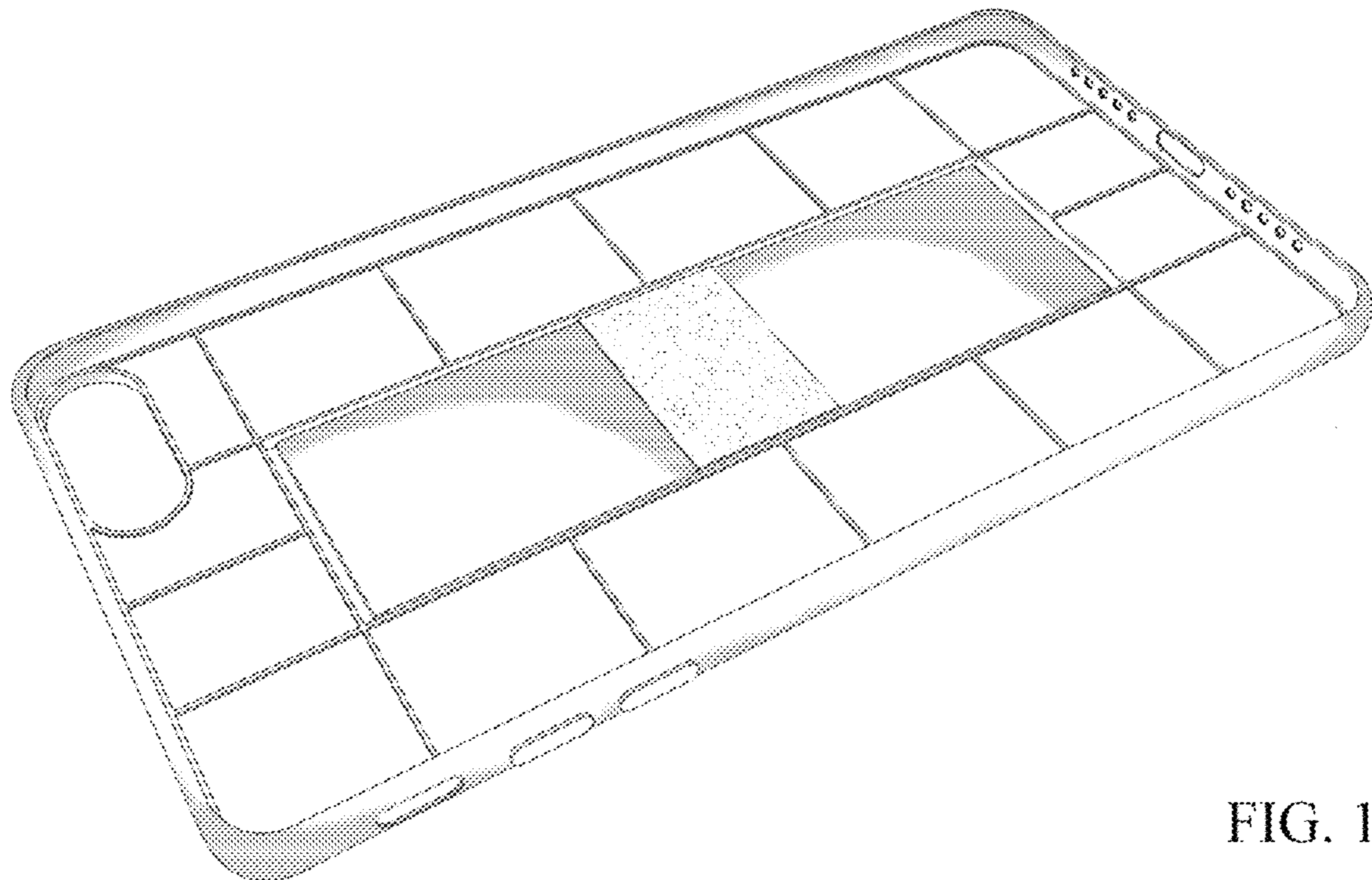
