FIG. 13 is a right-side view thereof;

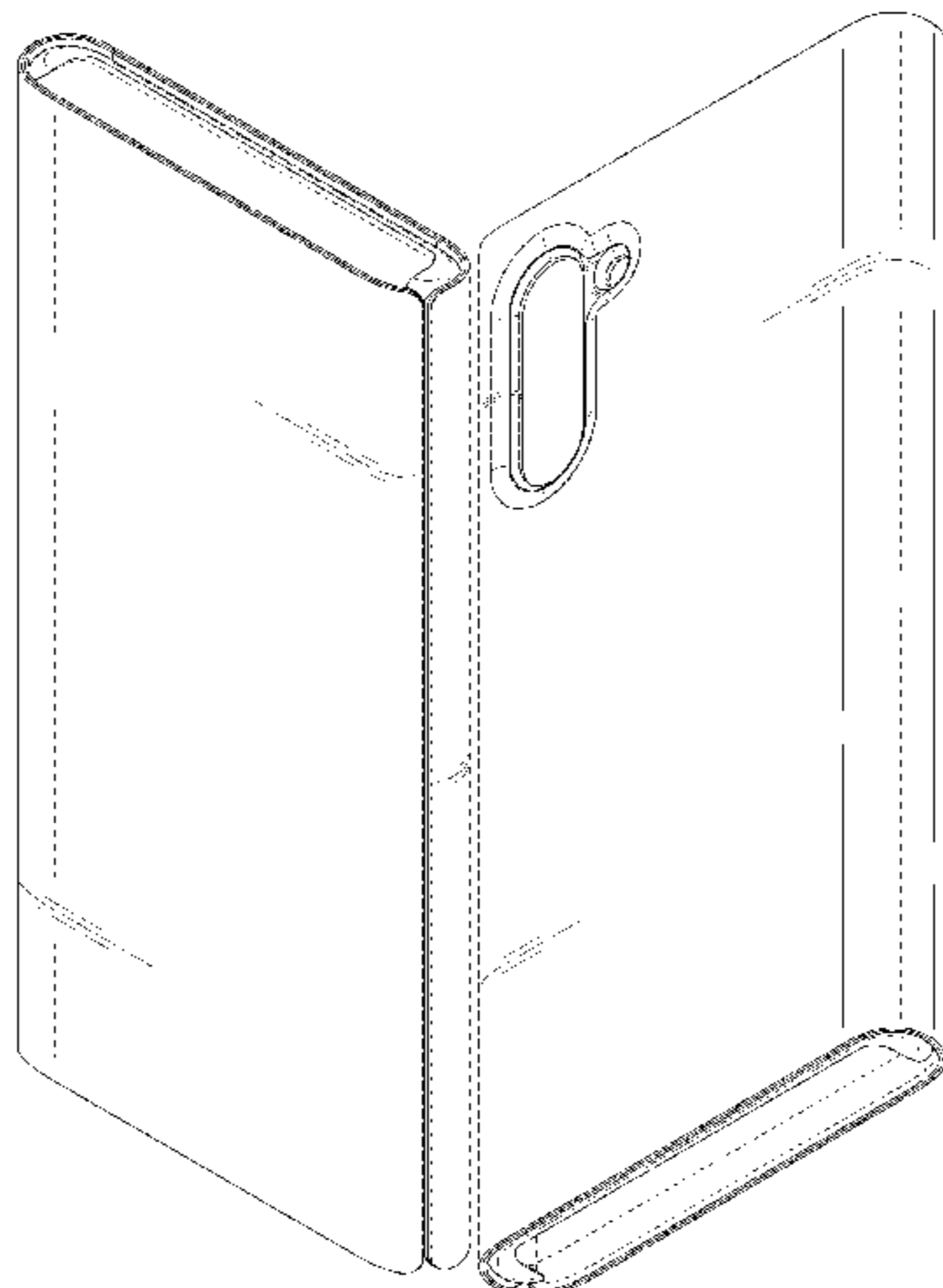
FIG. 14 is a top view thereof;

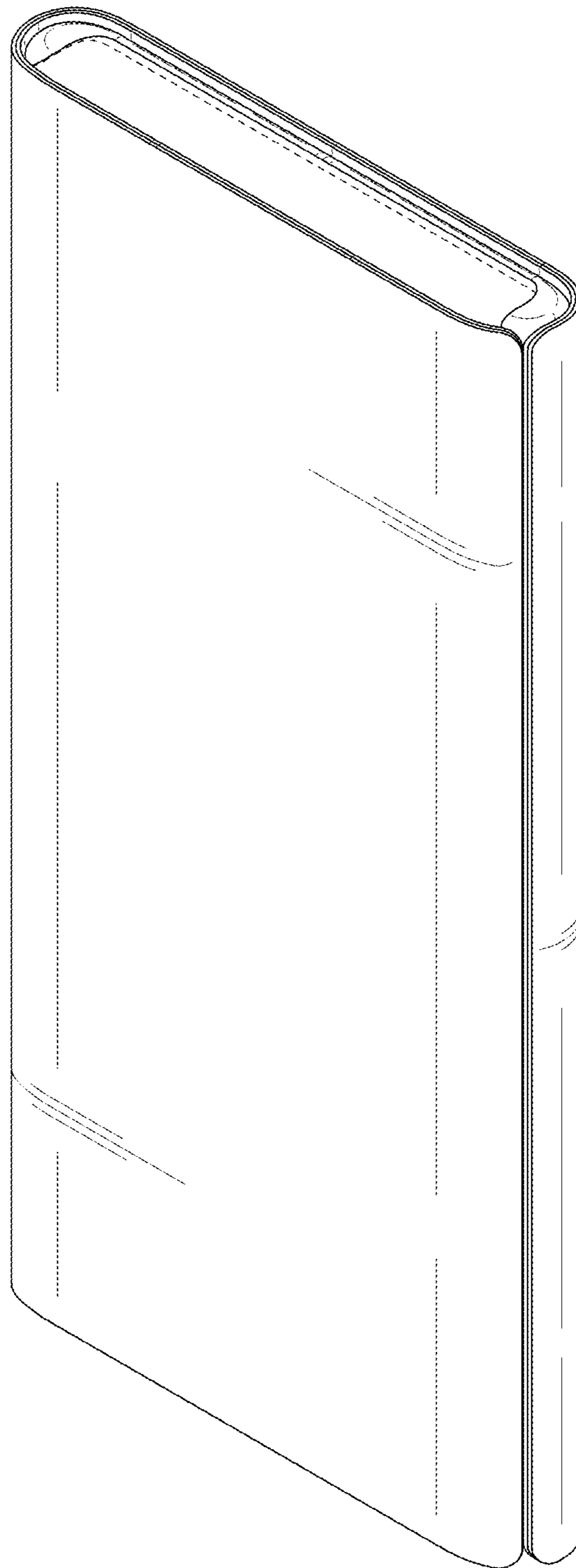

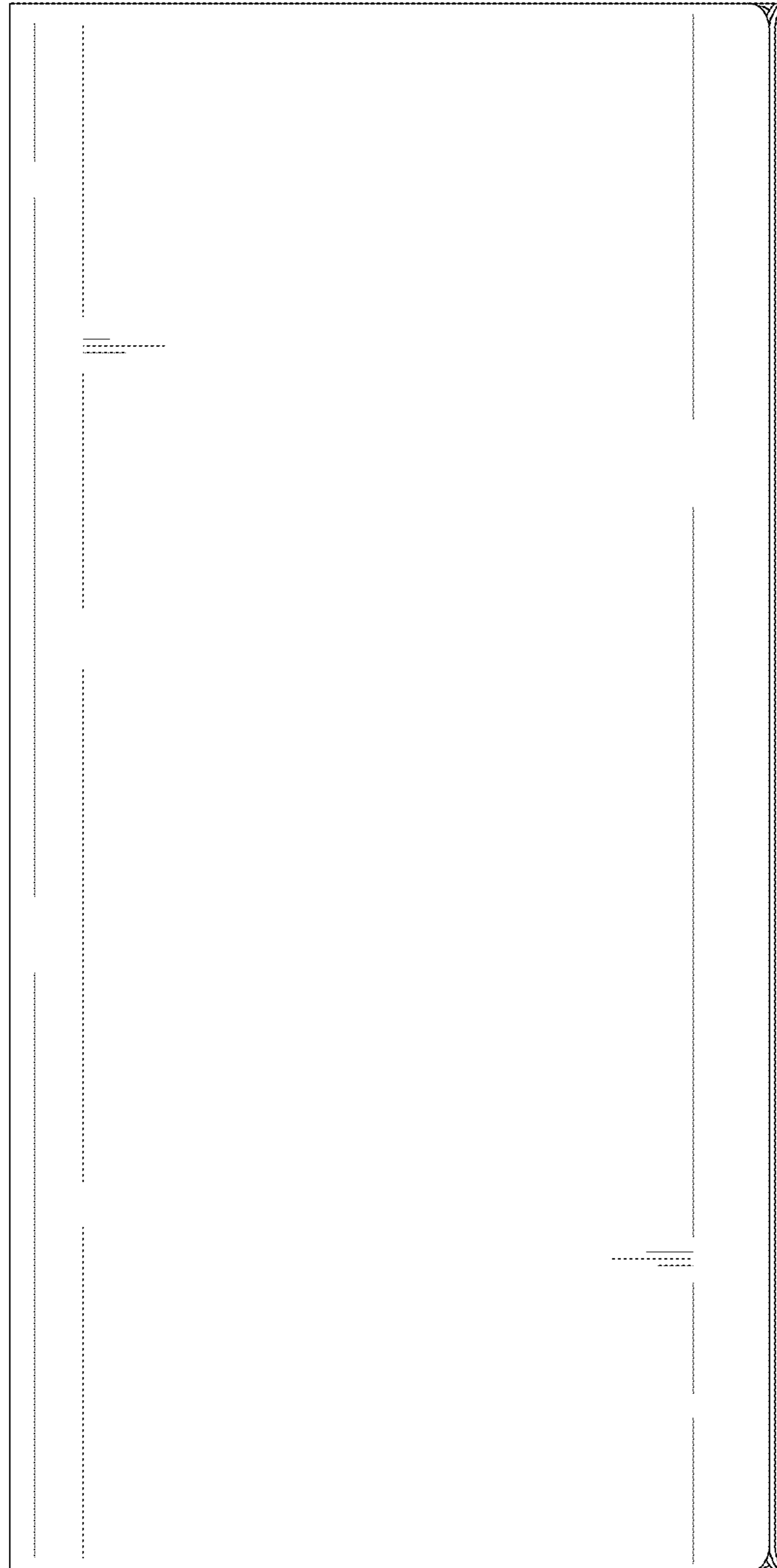

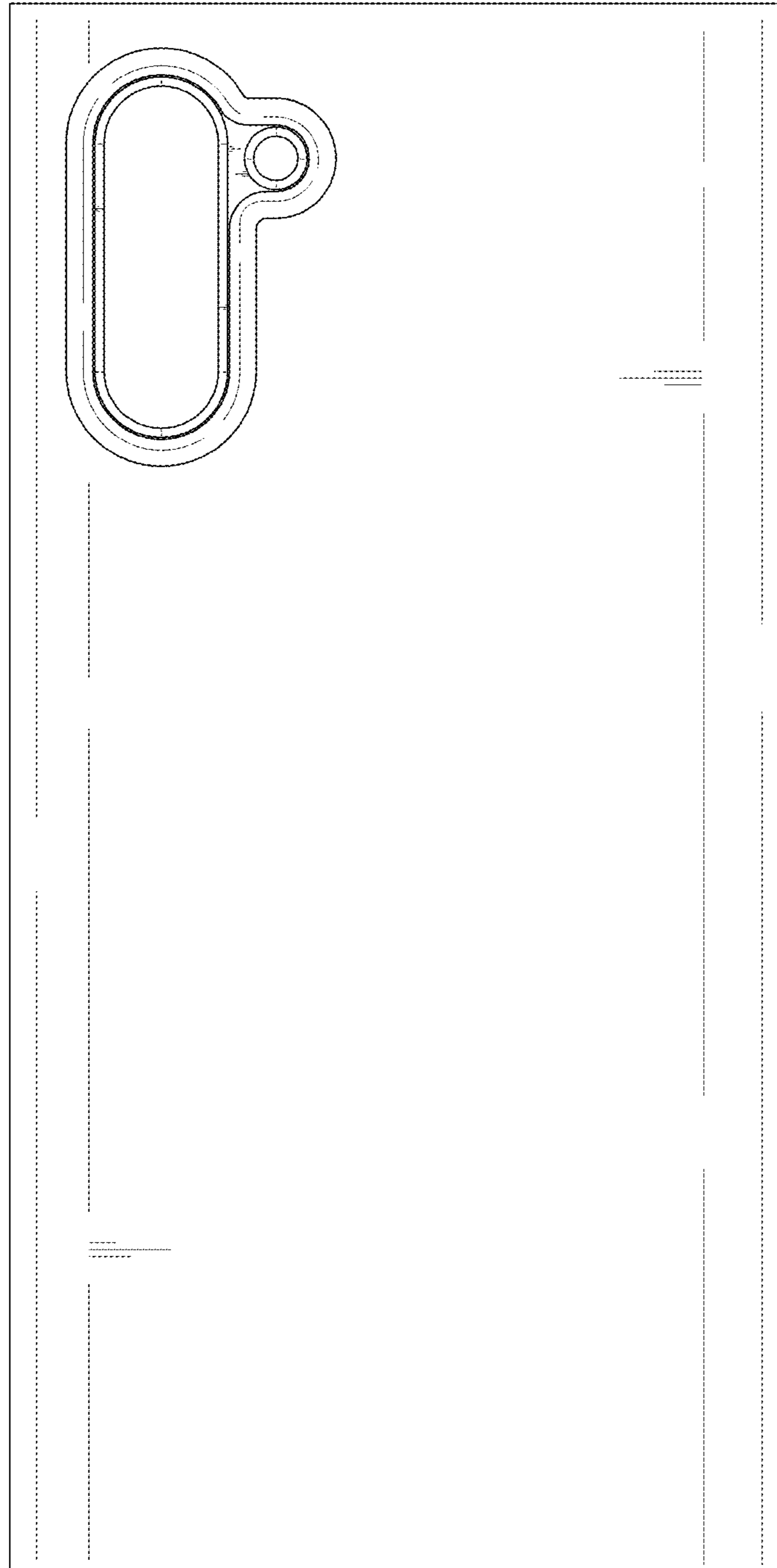

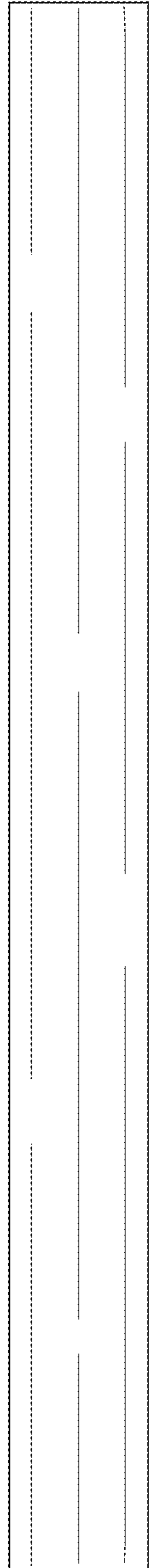

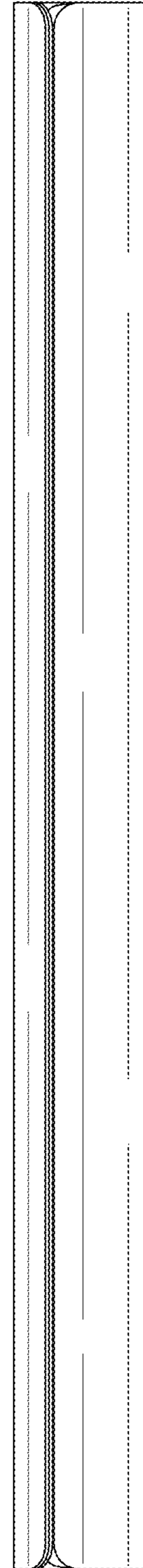

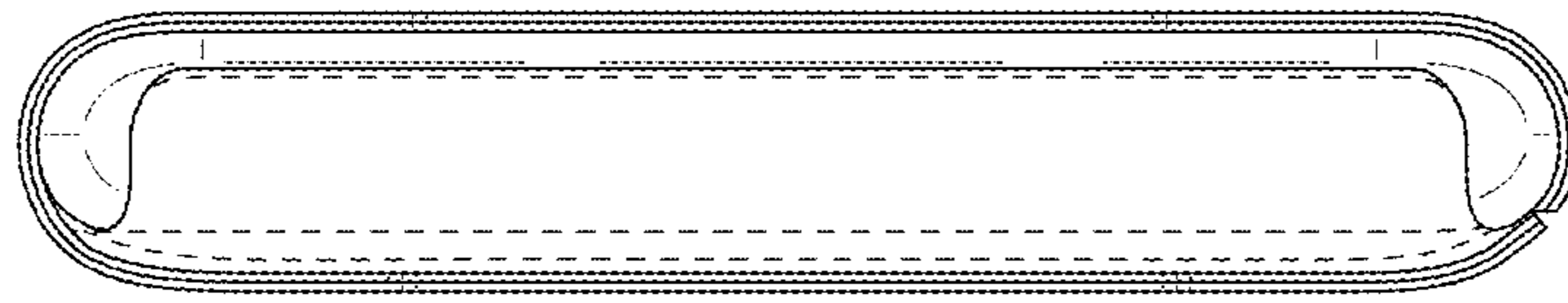

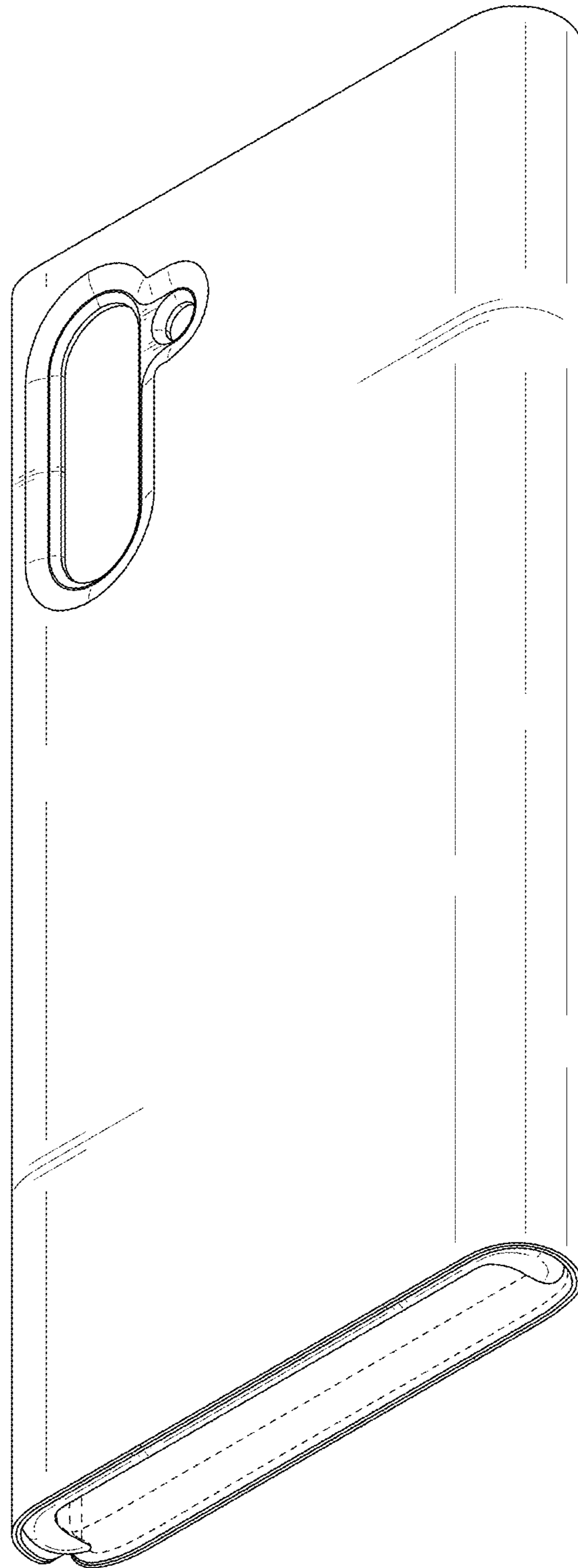

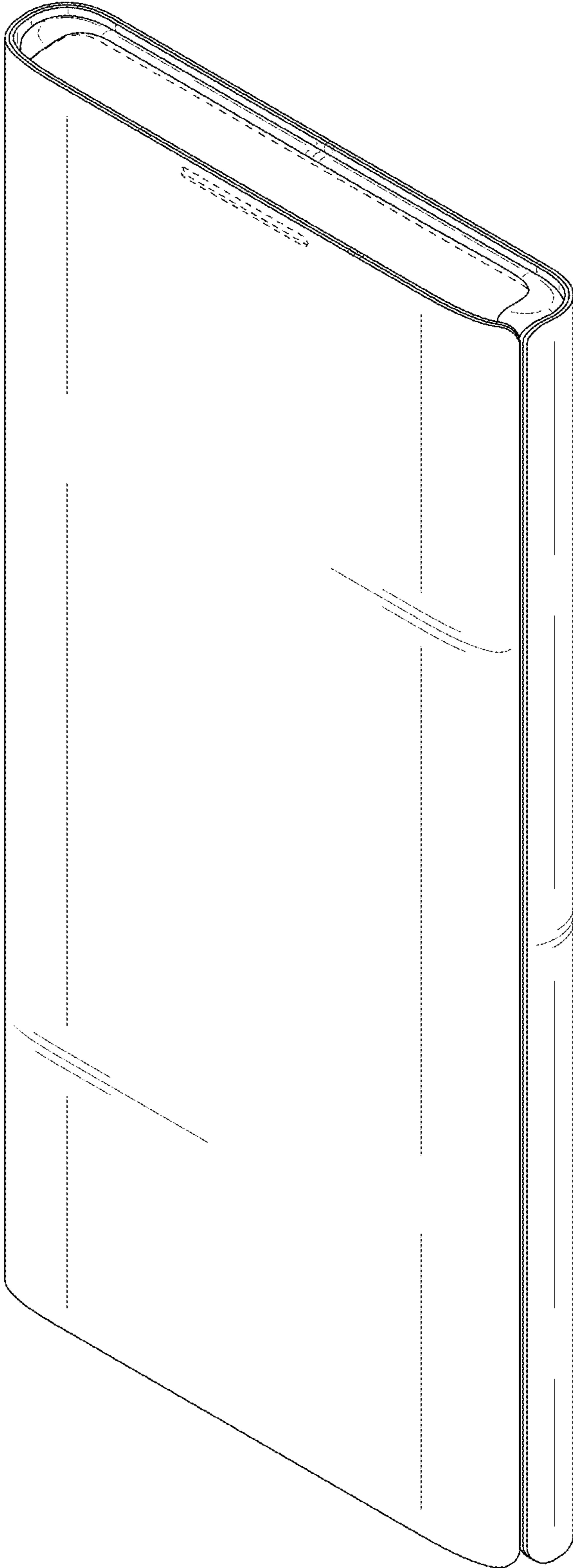

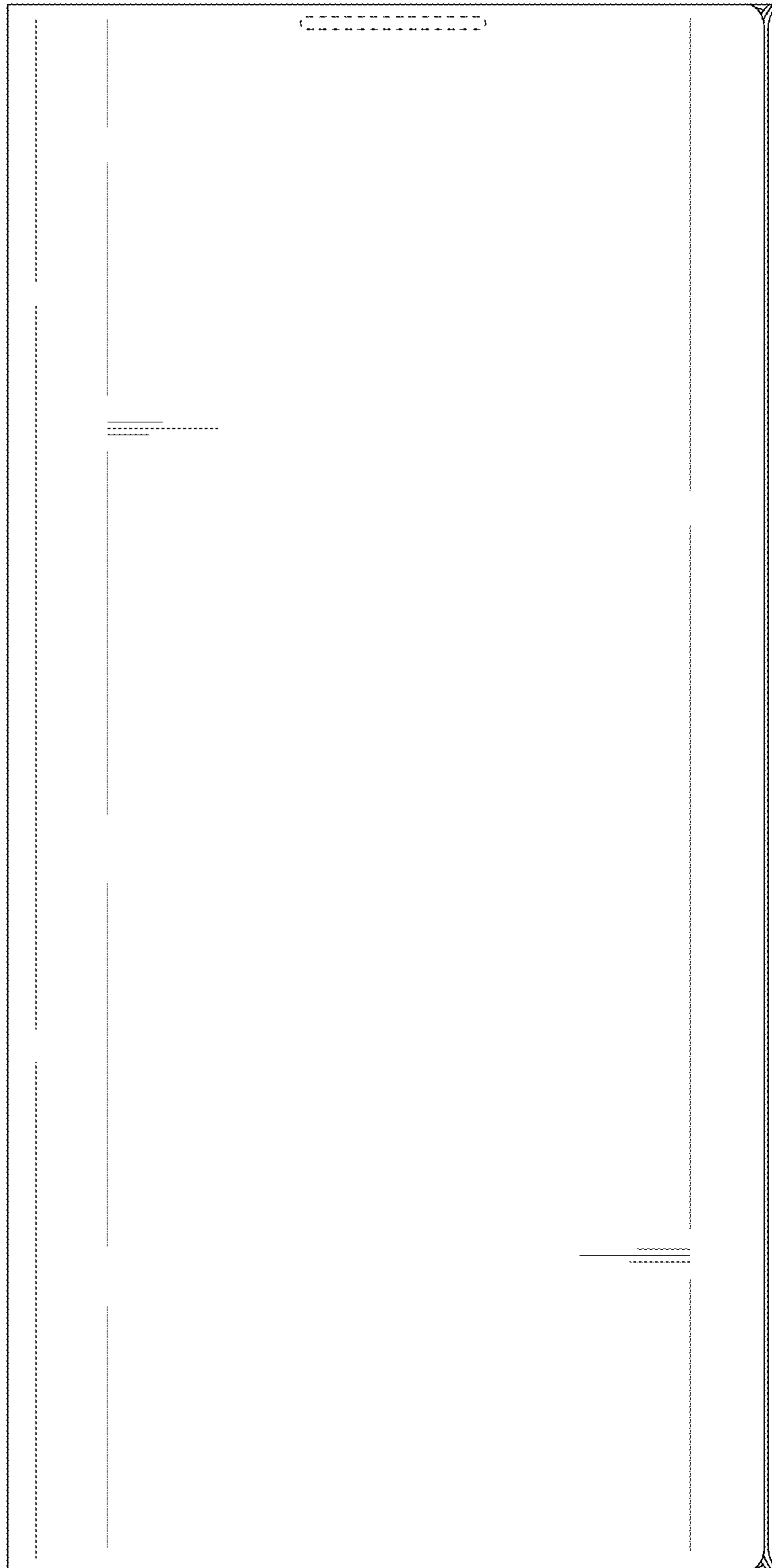

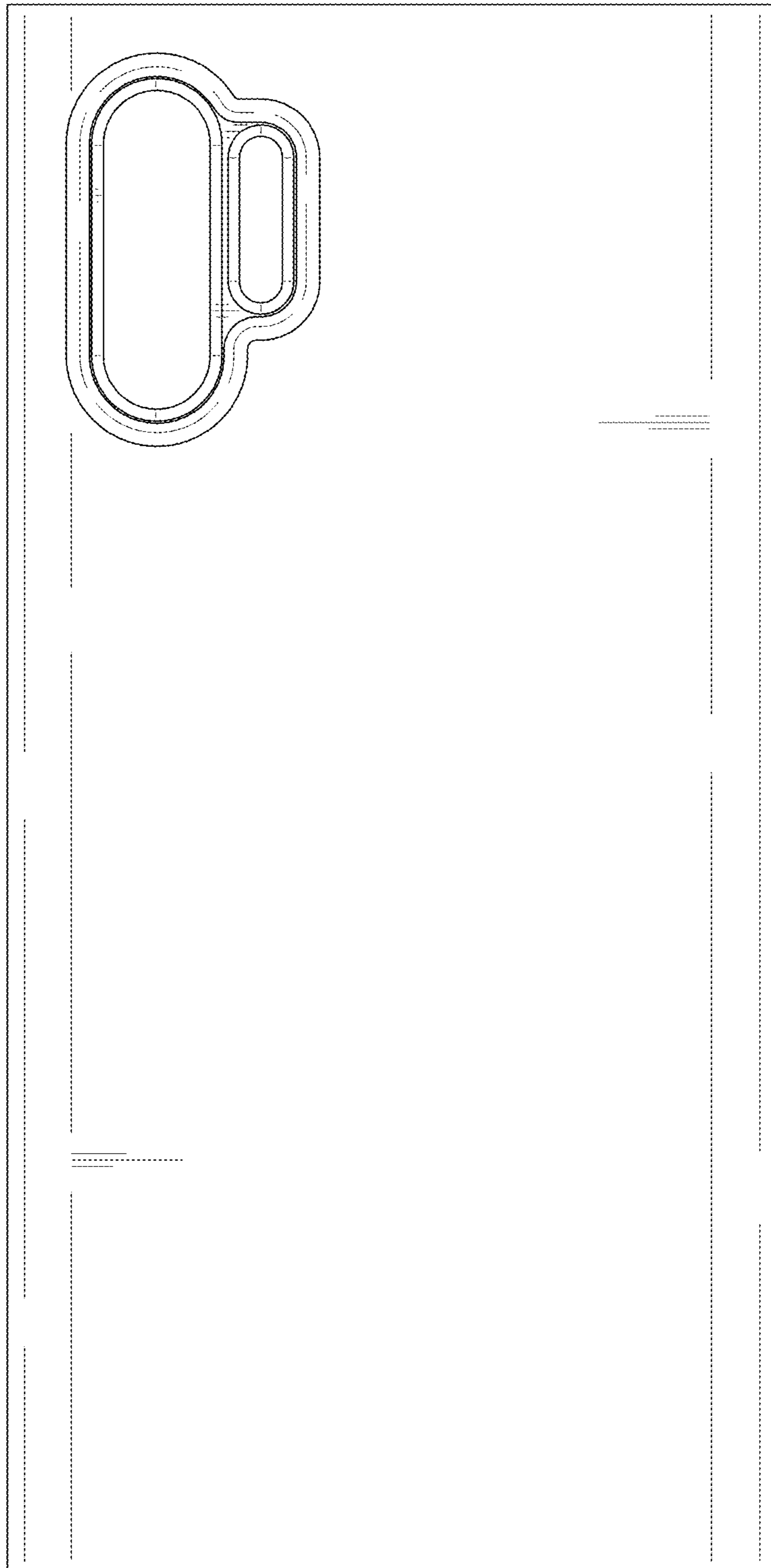

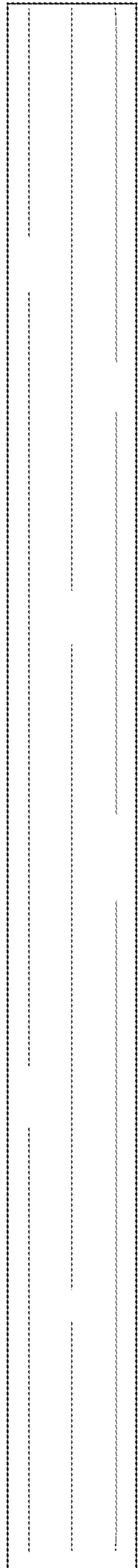

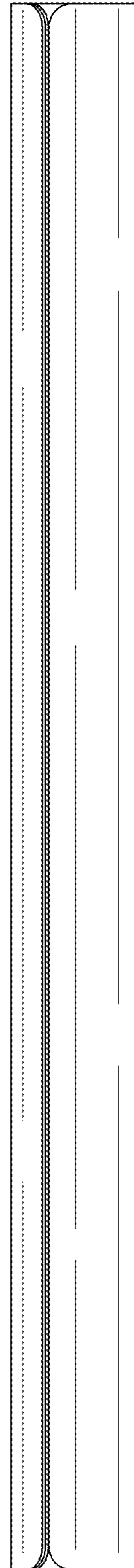

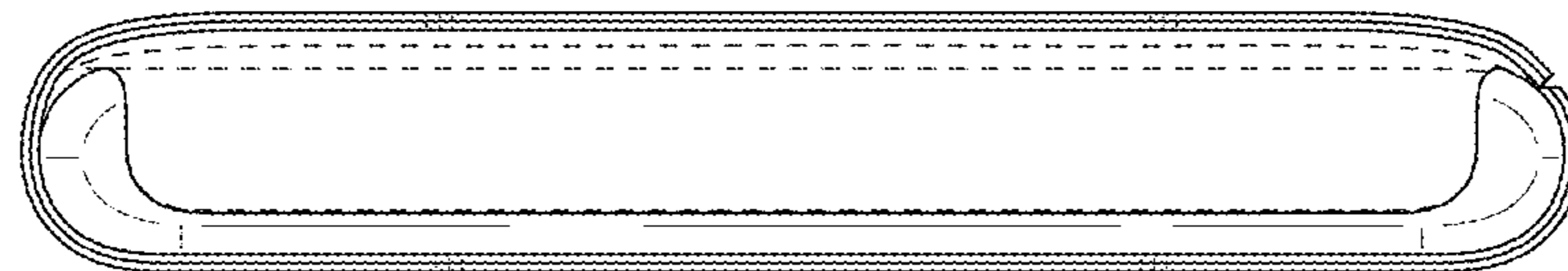
