(57) **CLAIM**

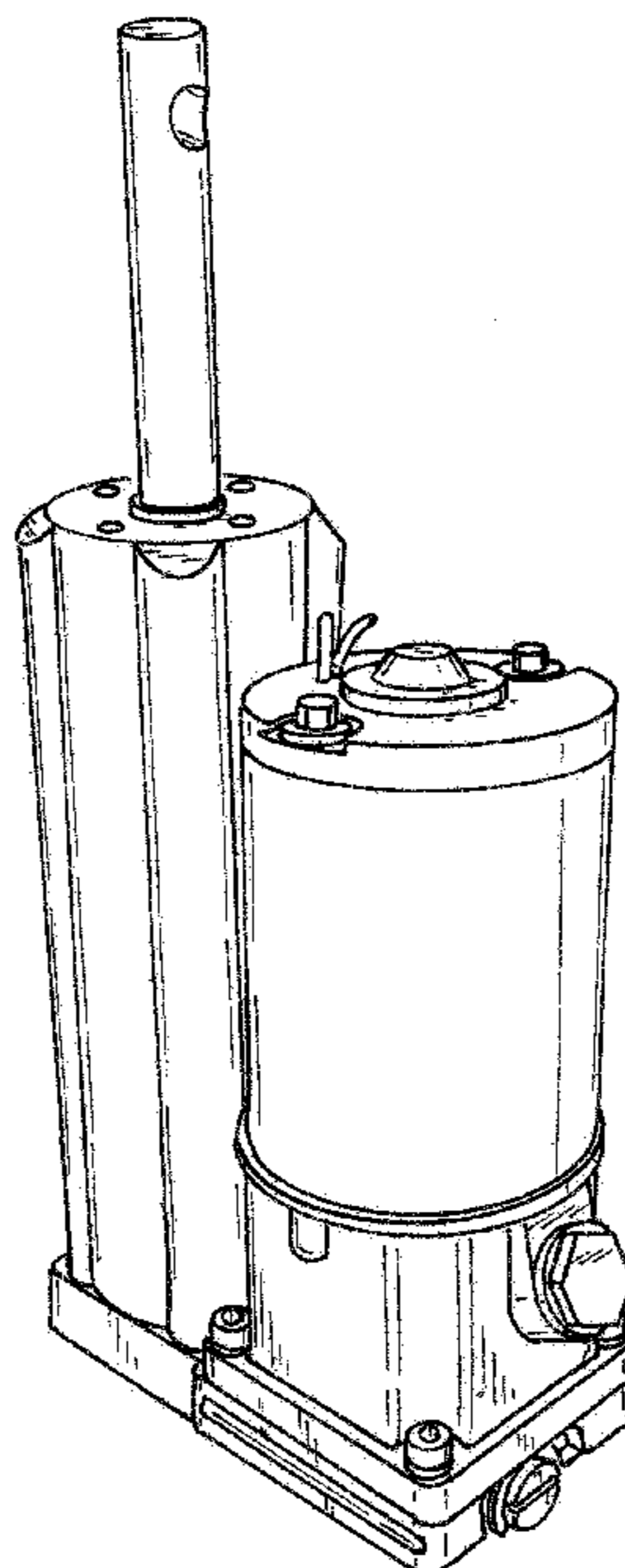
The ornamental design for a hydraulic cylinder with free-floating pump and reservoir, as shown and described.

DESCRIPTION

This application also claims the priority of utility patent application 15/954,393, filed on Apr. 16, 2018, and currently pending.

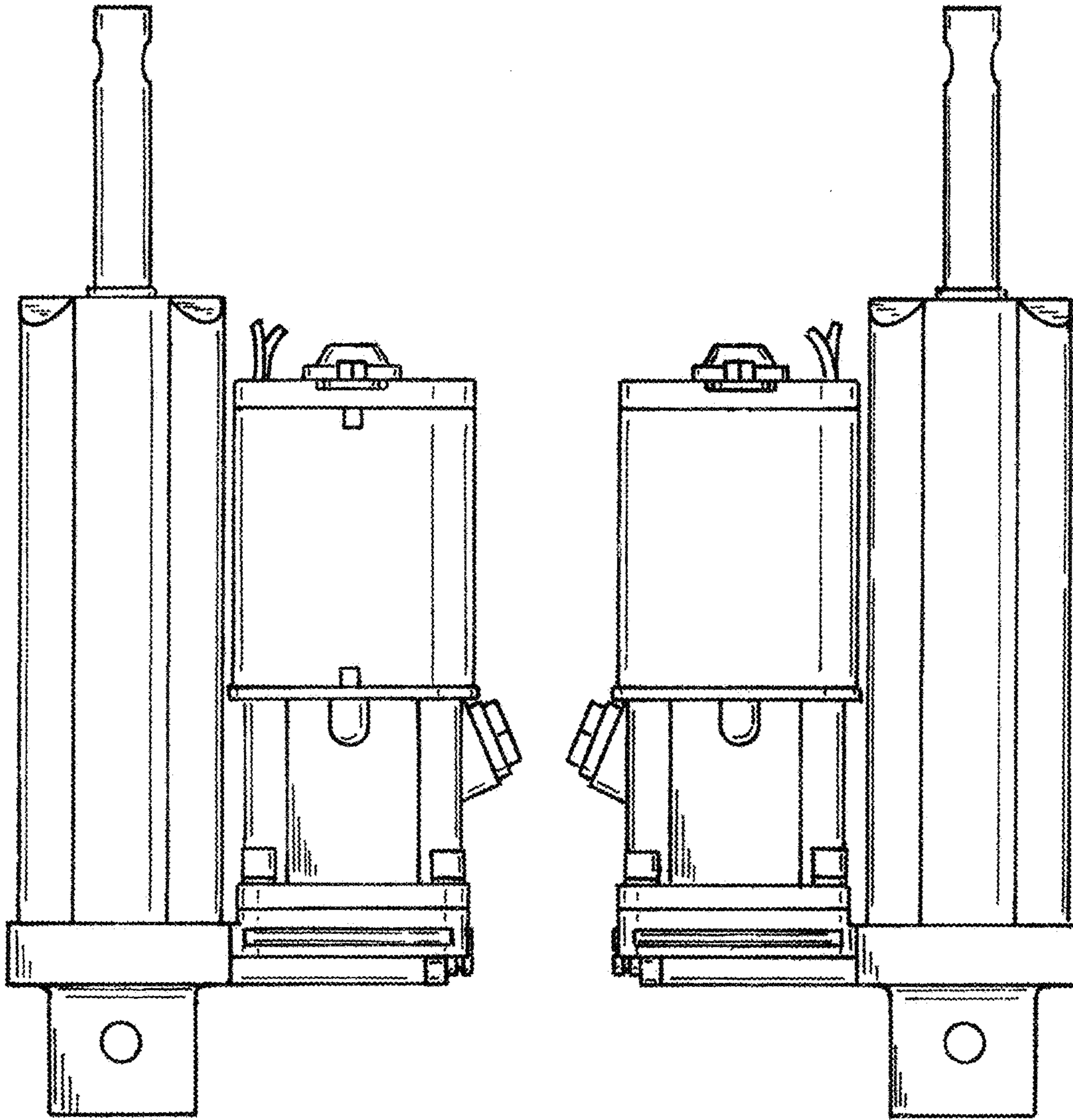

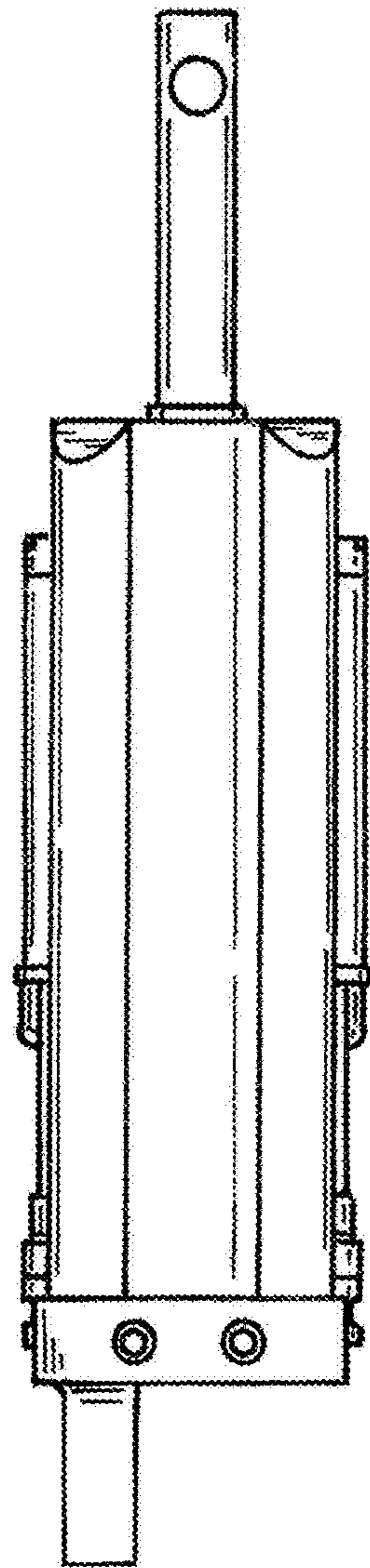

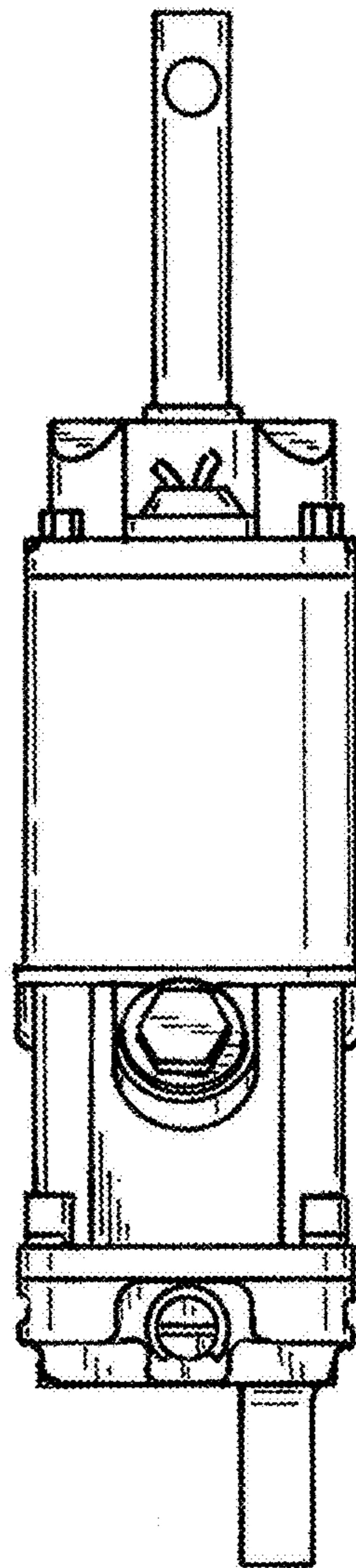

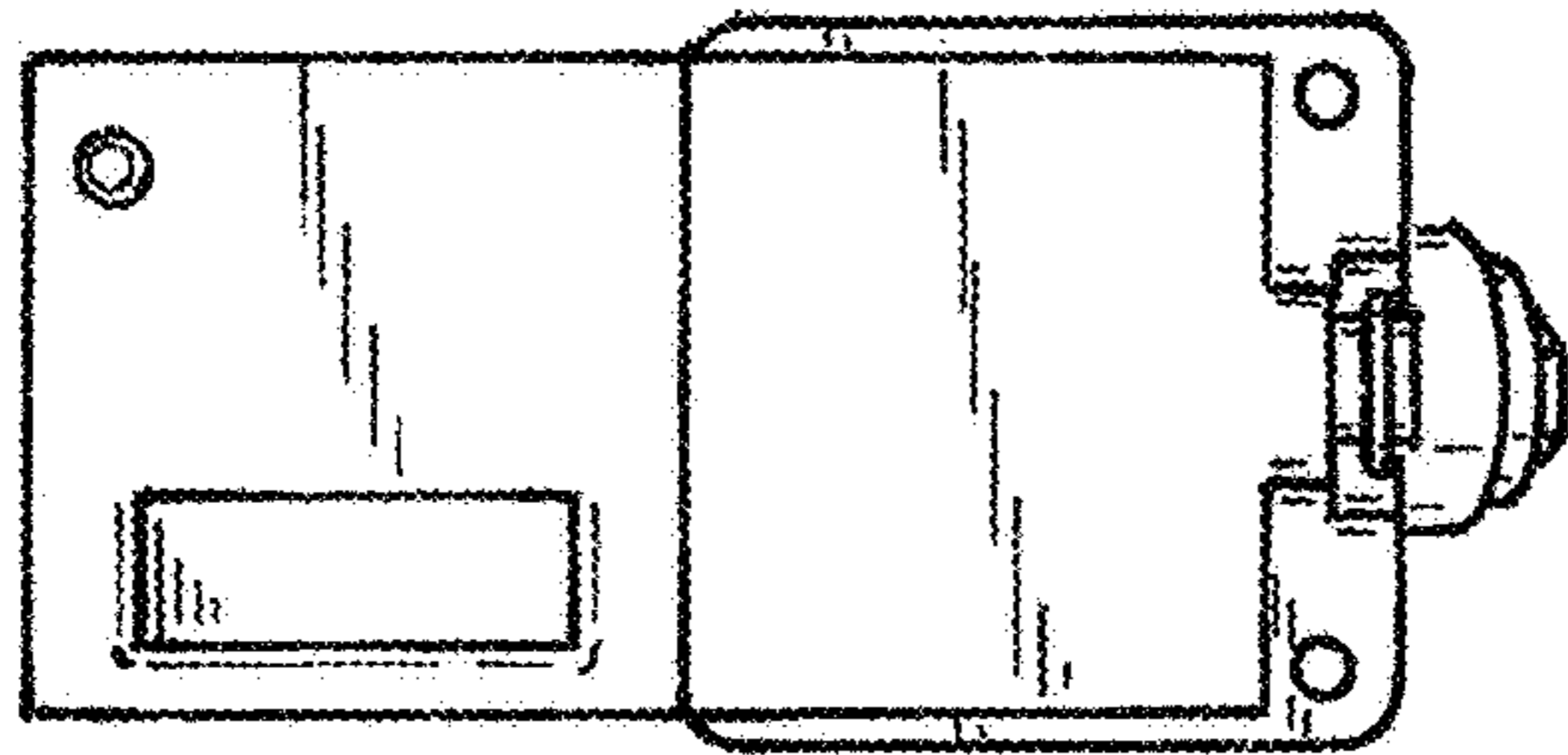
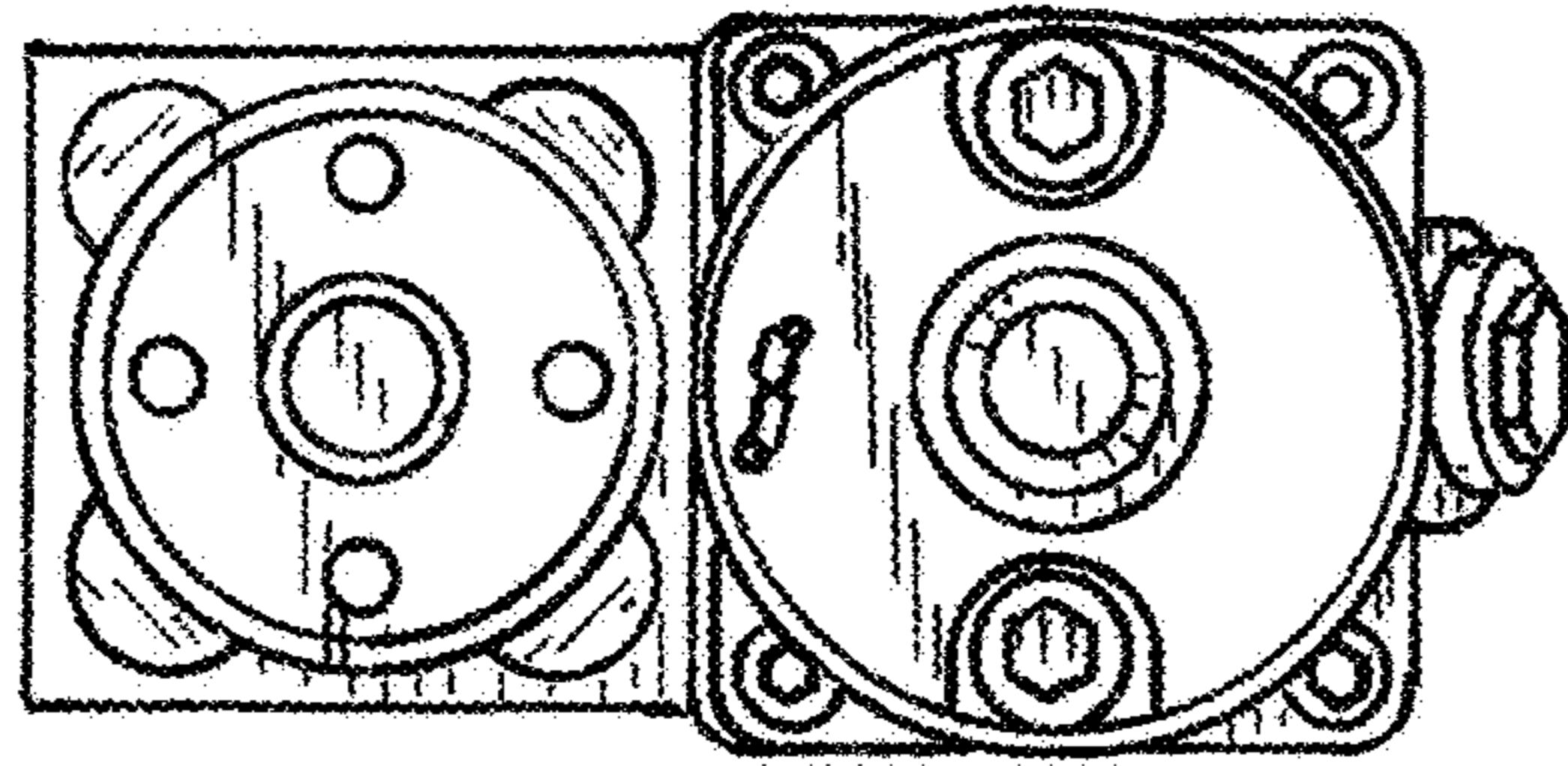

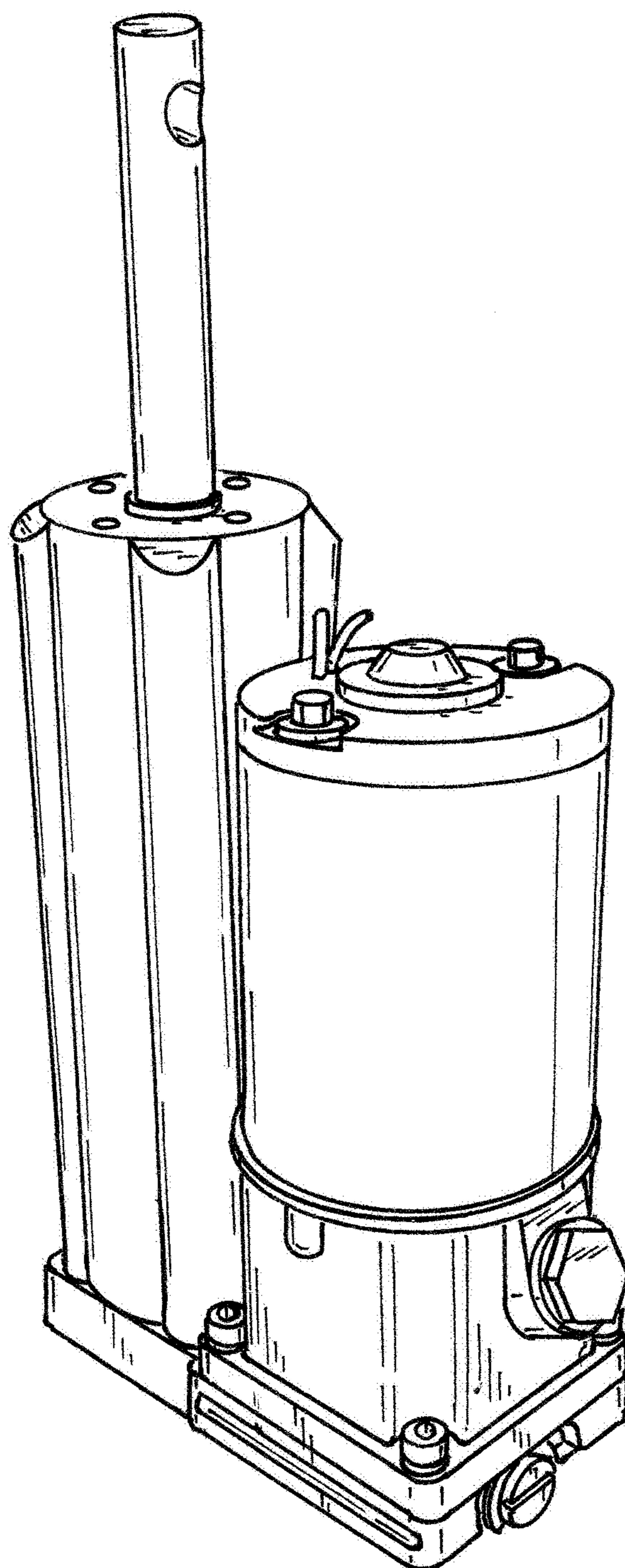
