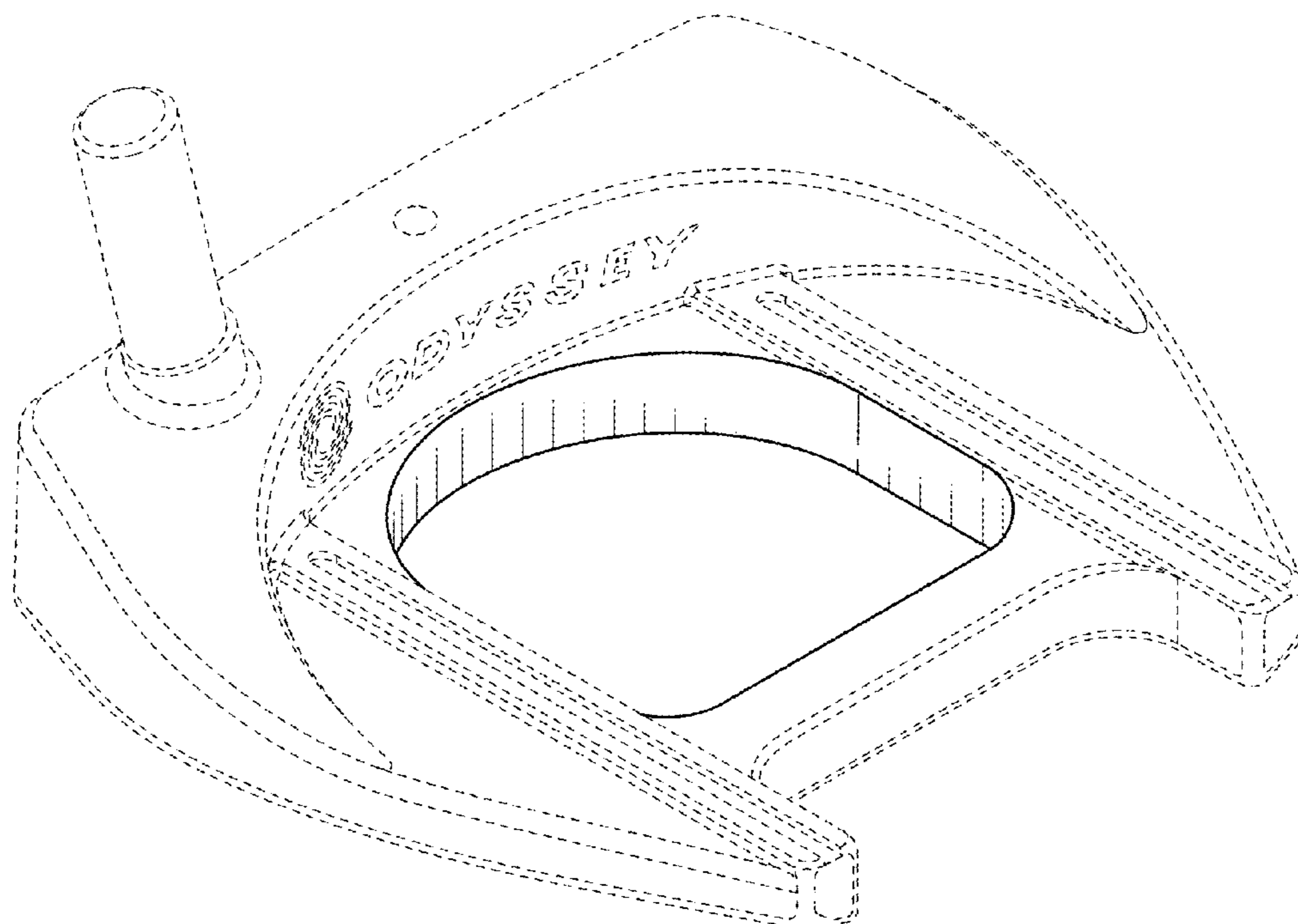
The ornamental design for a putter head, as shown and described.

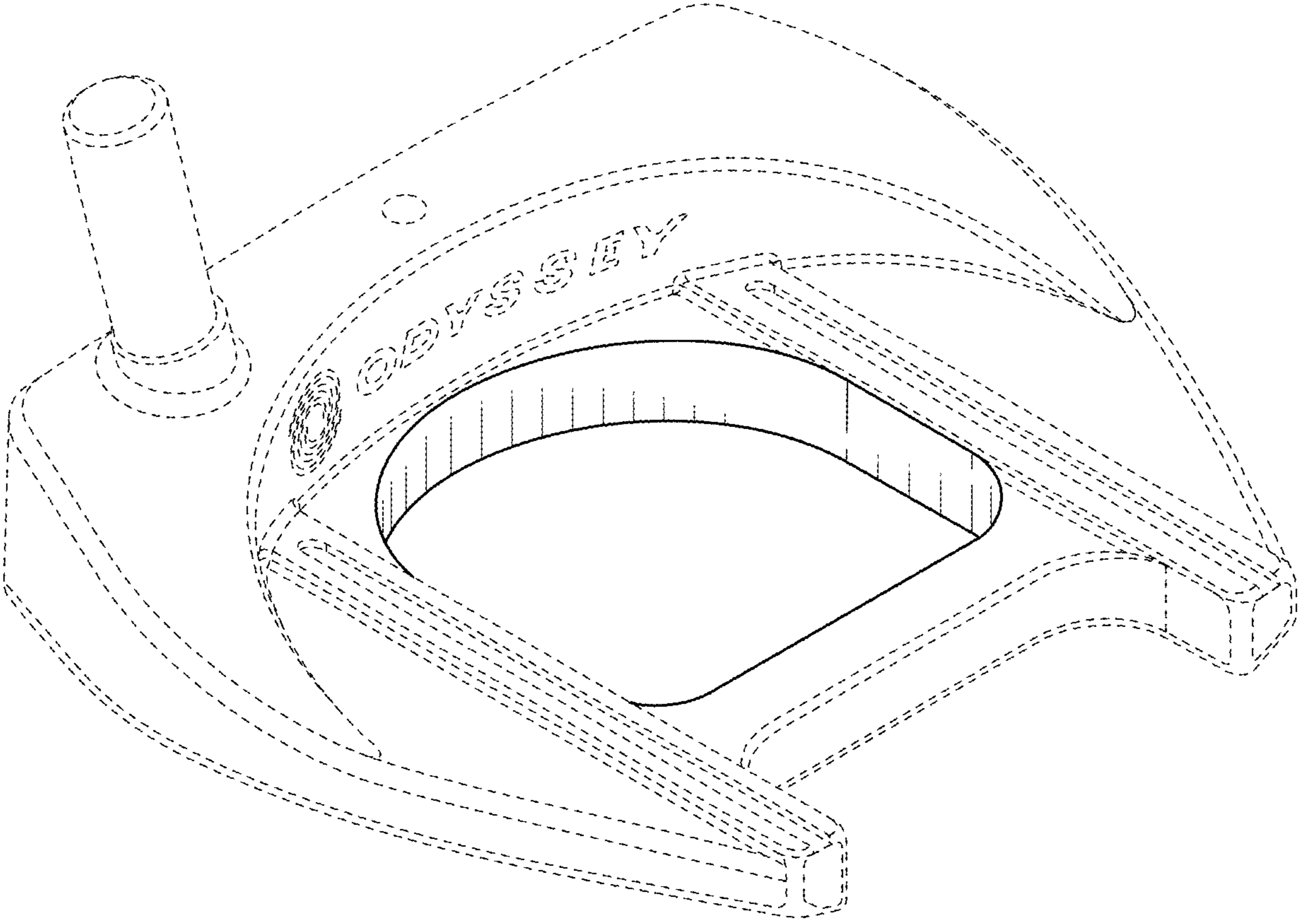

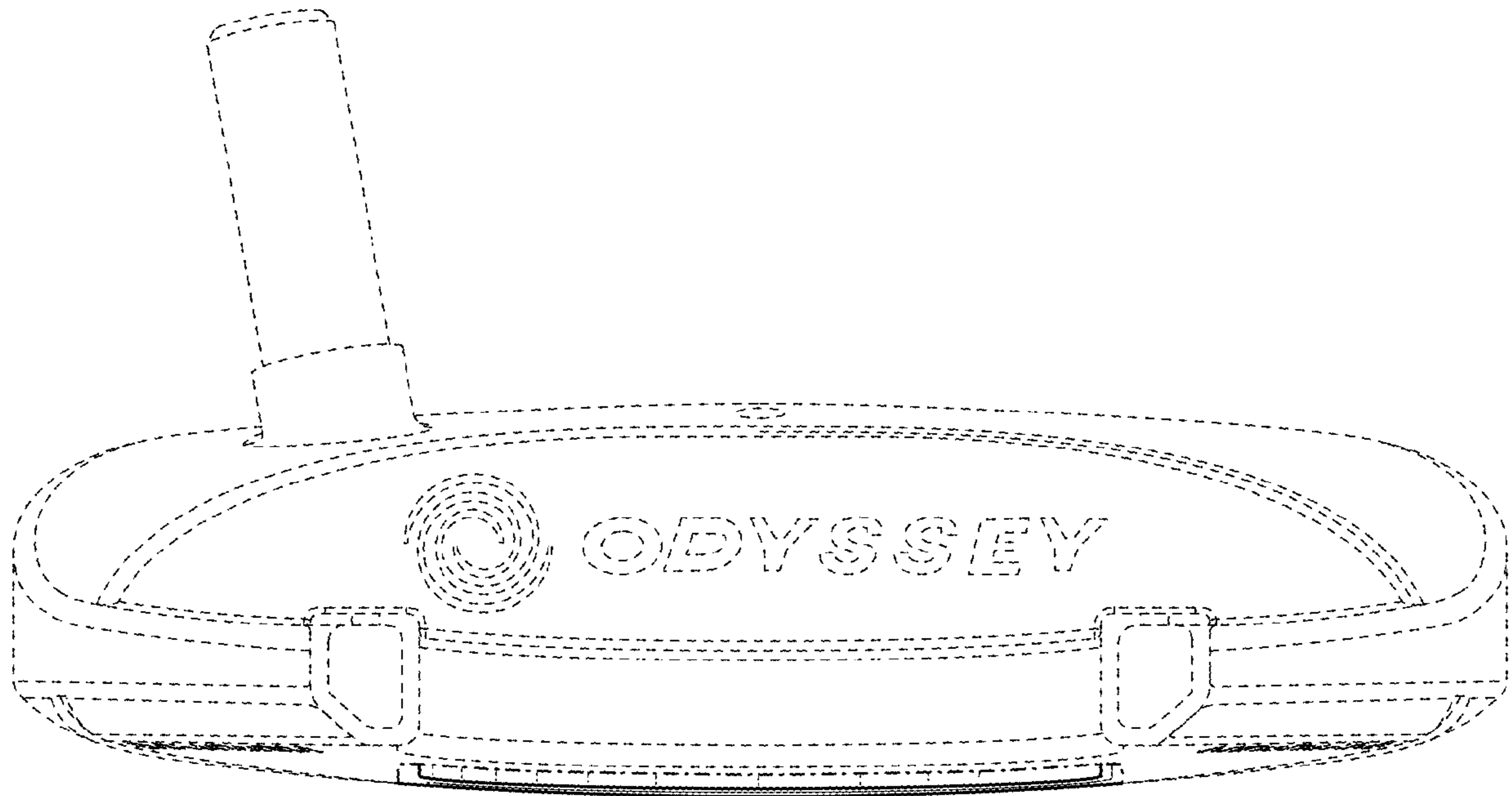

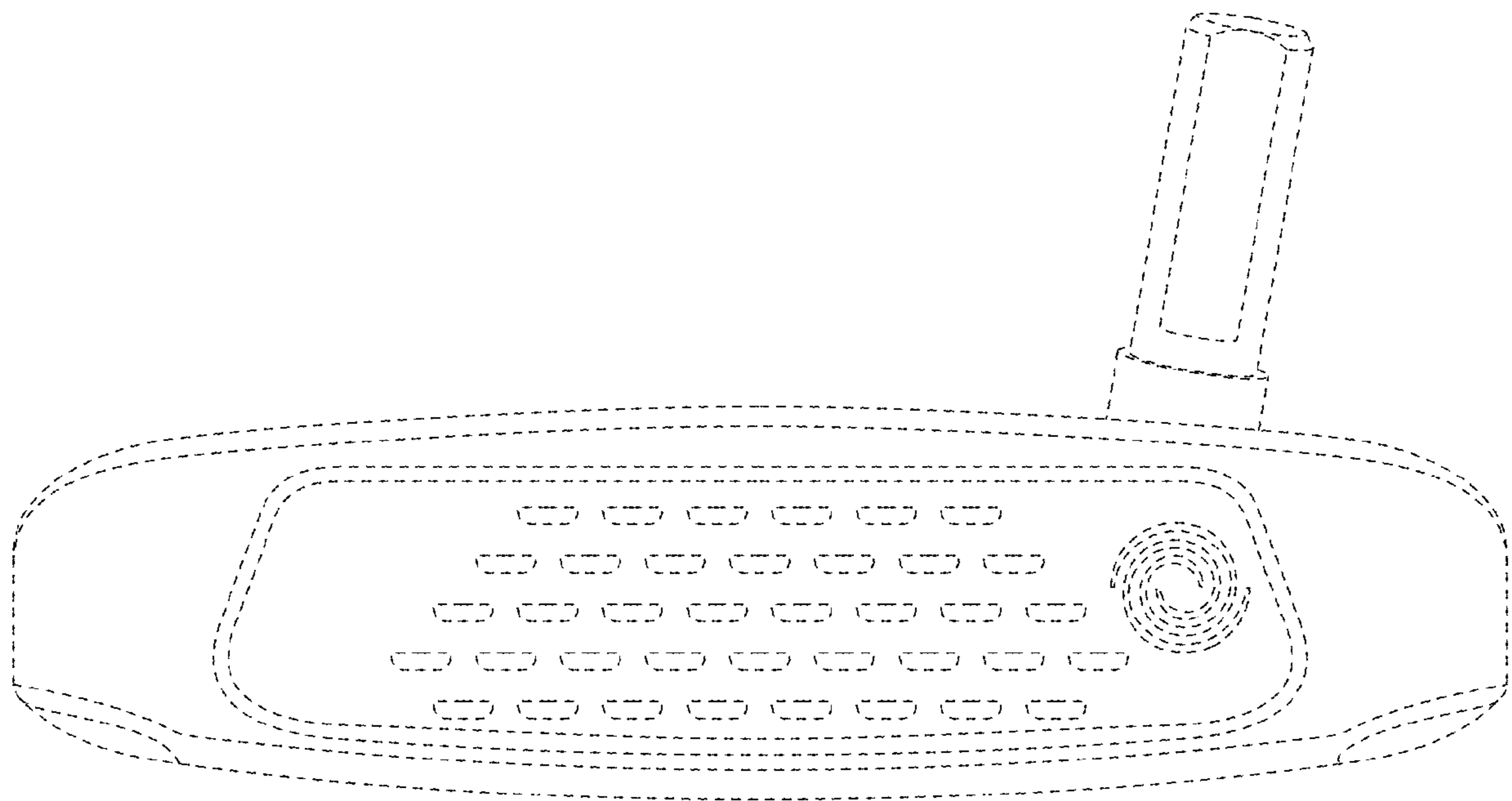

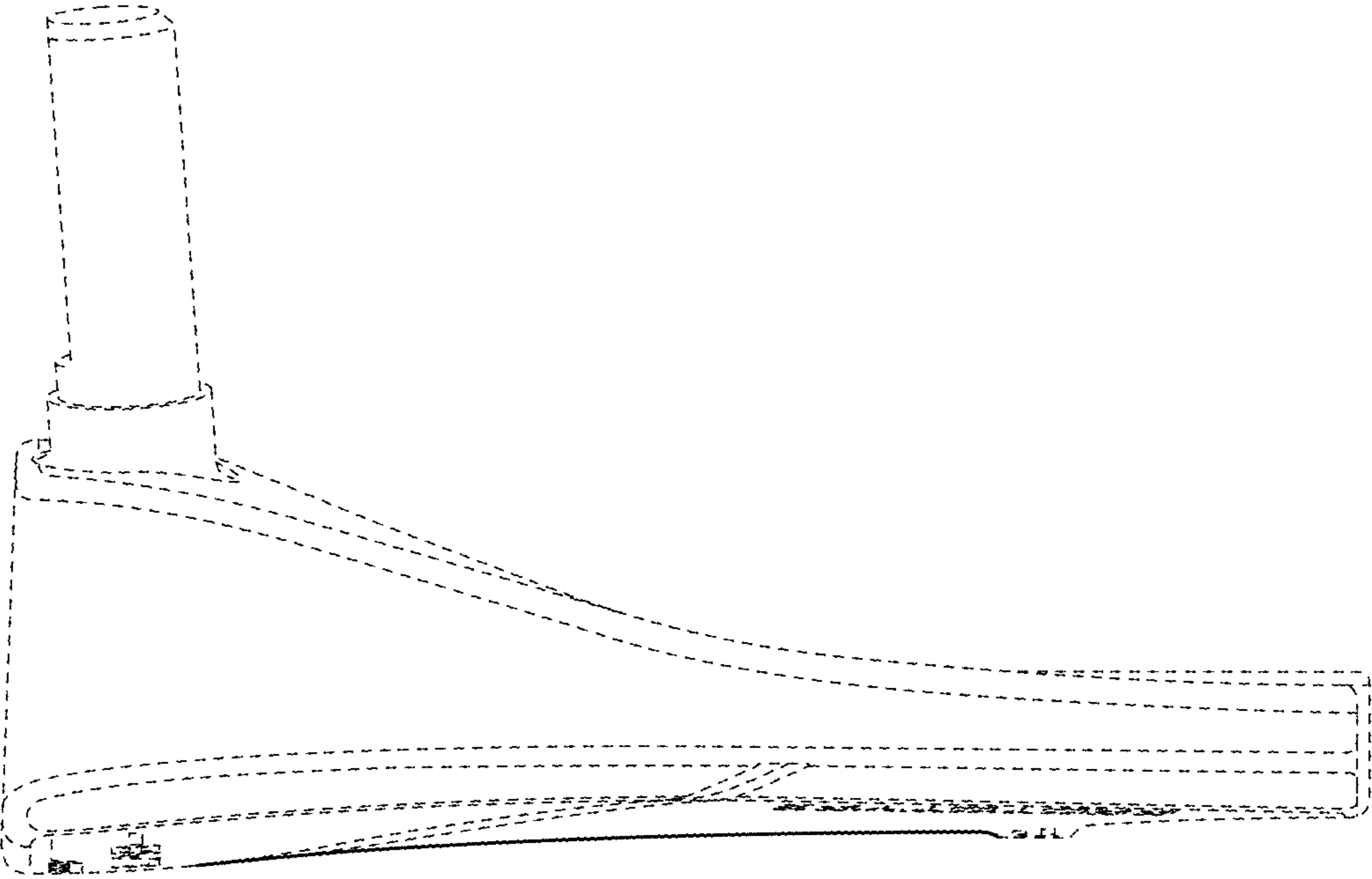

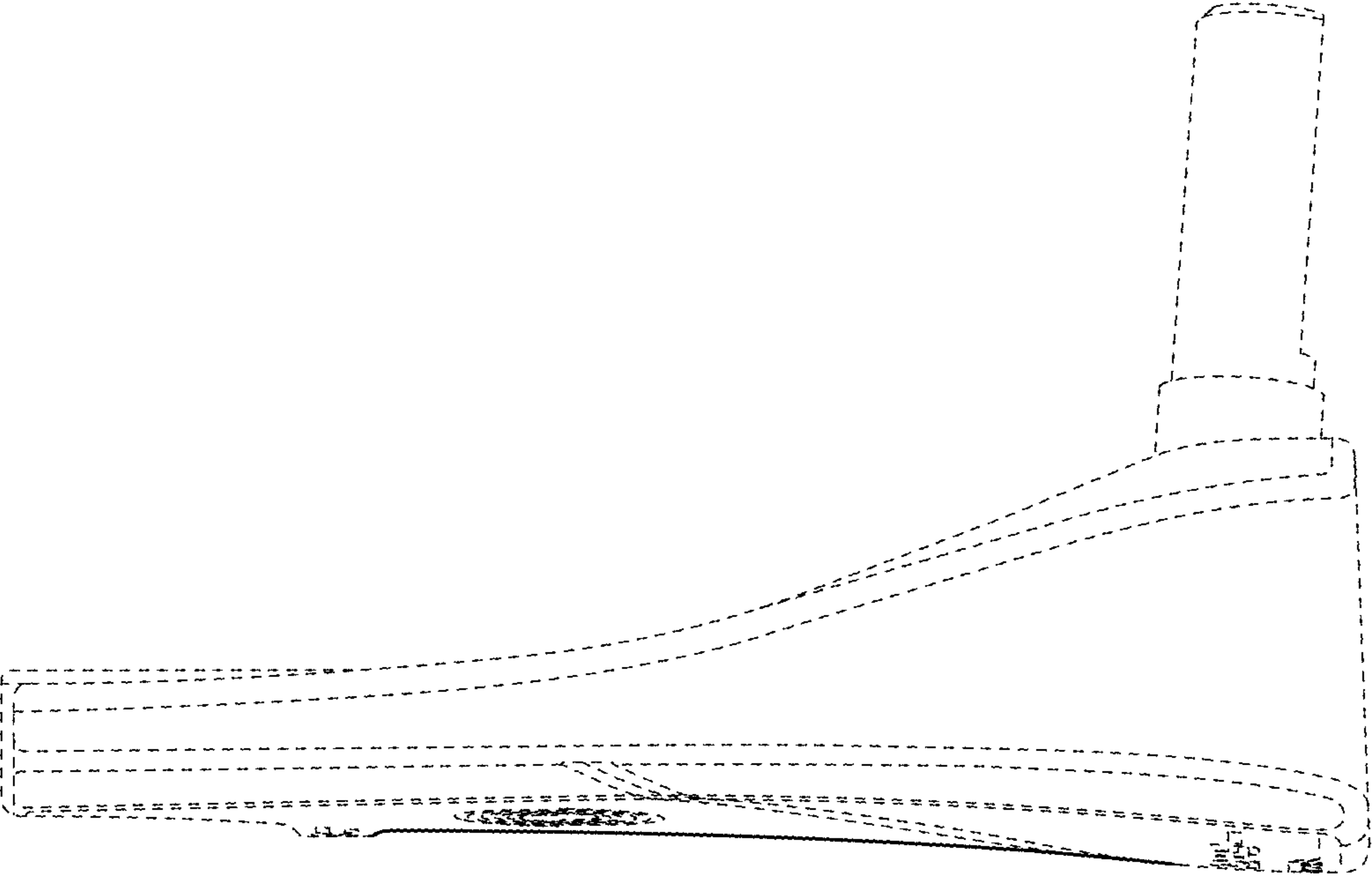

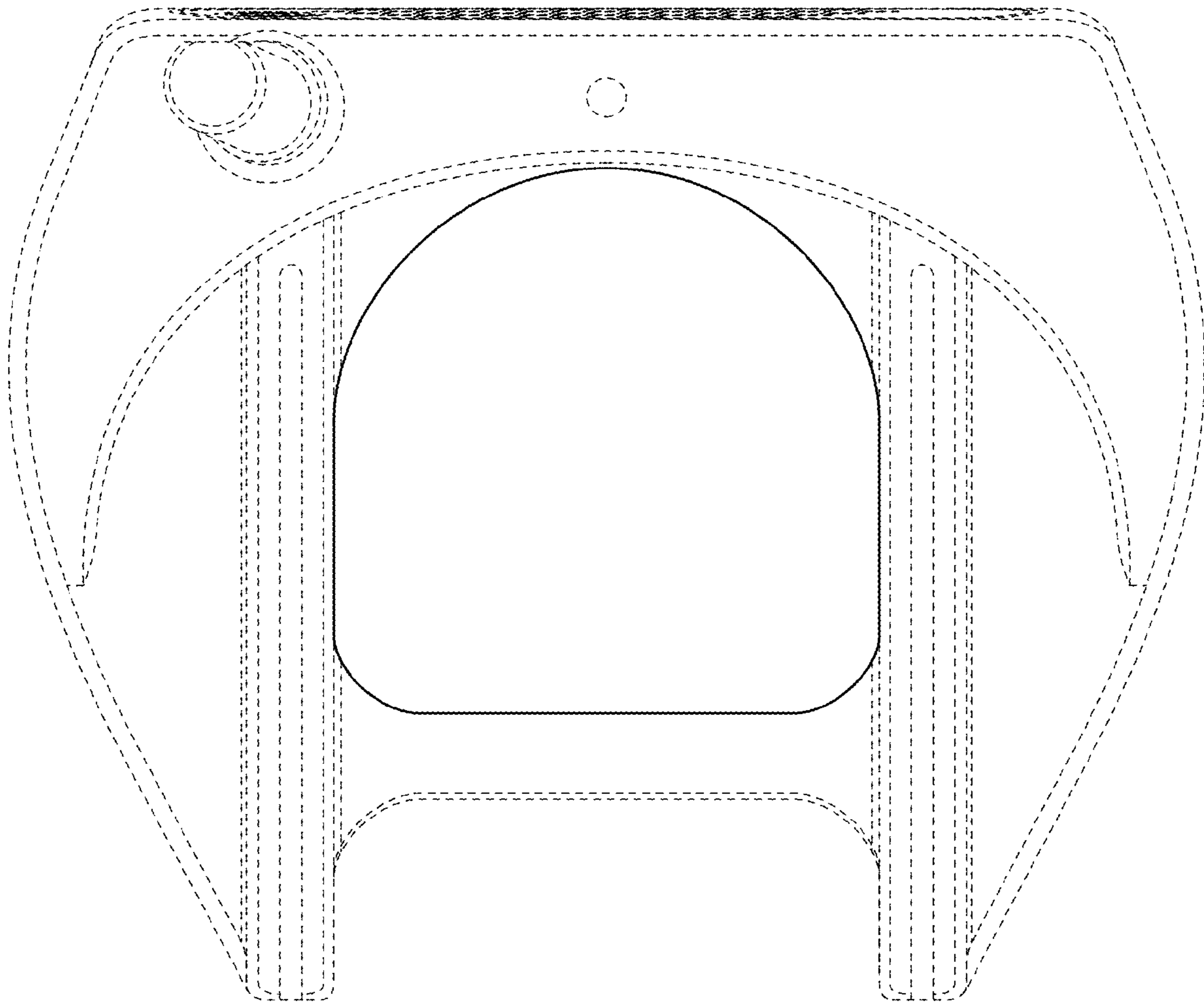

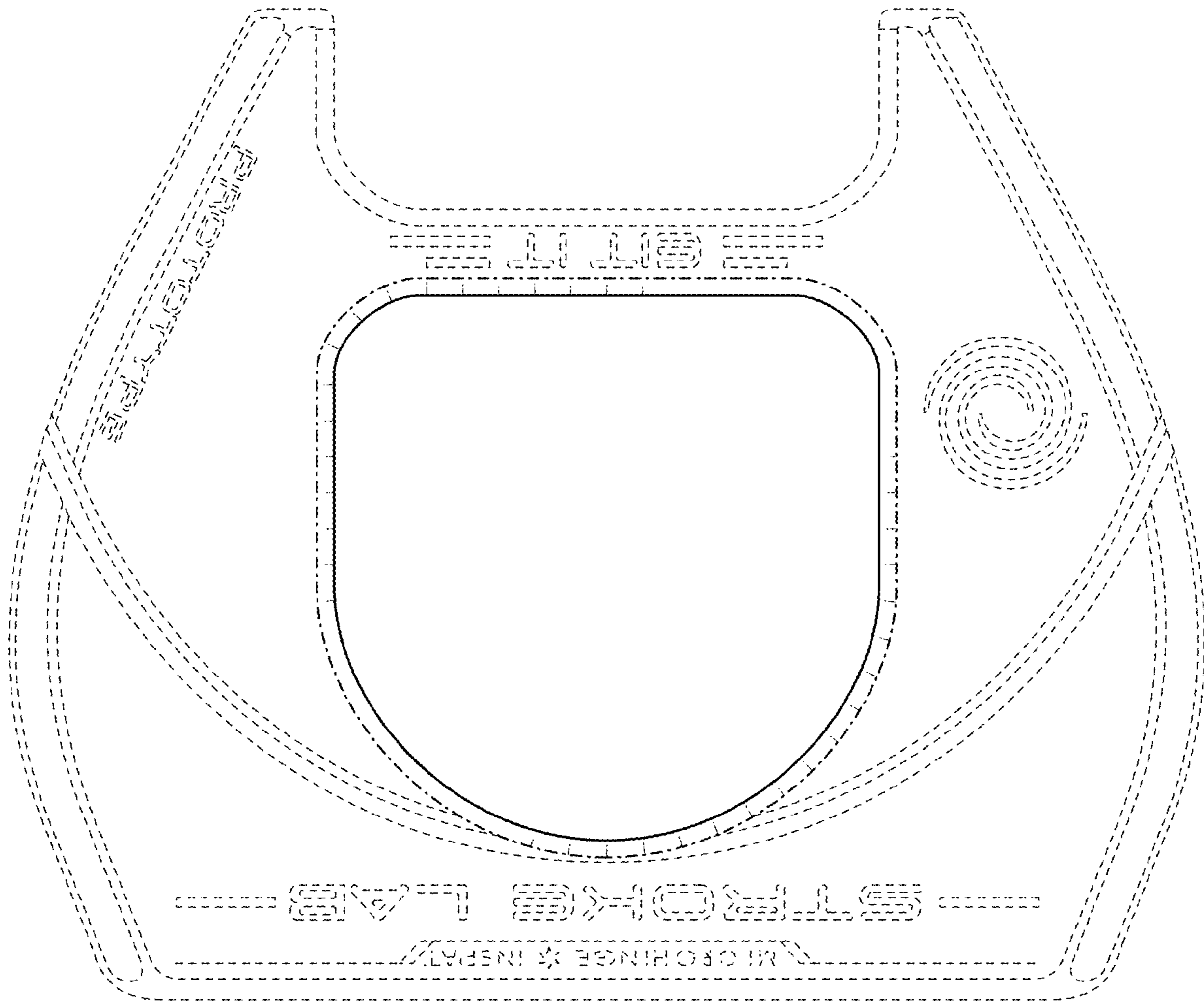
