(57) **CLAIM**

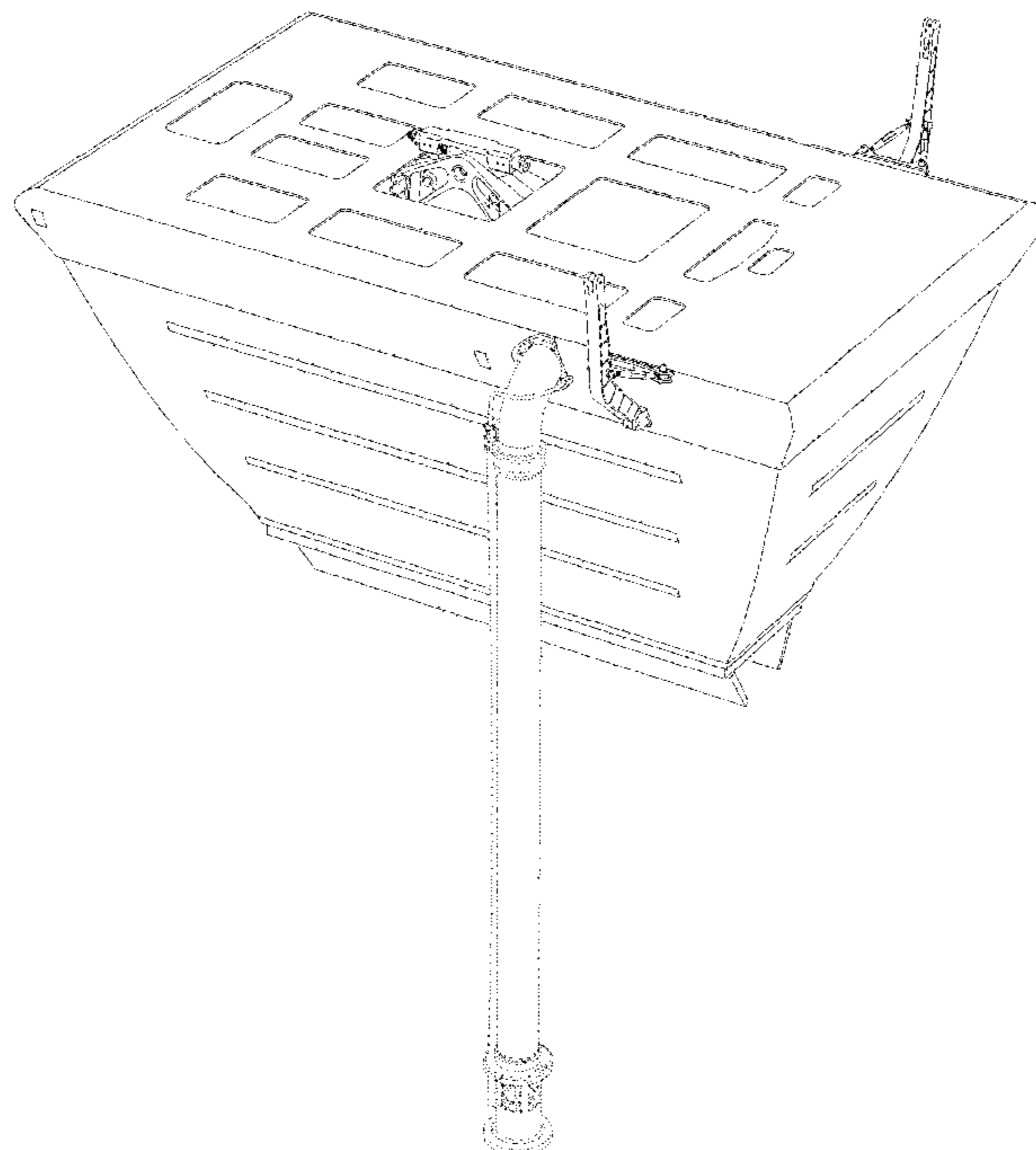
The ornamental design for a tank assembly for fire suppression, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a tank assembly for fire suppression, showing my new design; FIG. 2 is a front elevation view; FIG. 3 is left side elevation view; FIG. 4 is a right side elevation view; FIG. 5 is a top elevation view; and, FIG. 6 is a bottom elevation view.

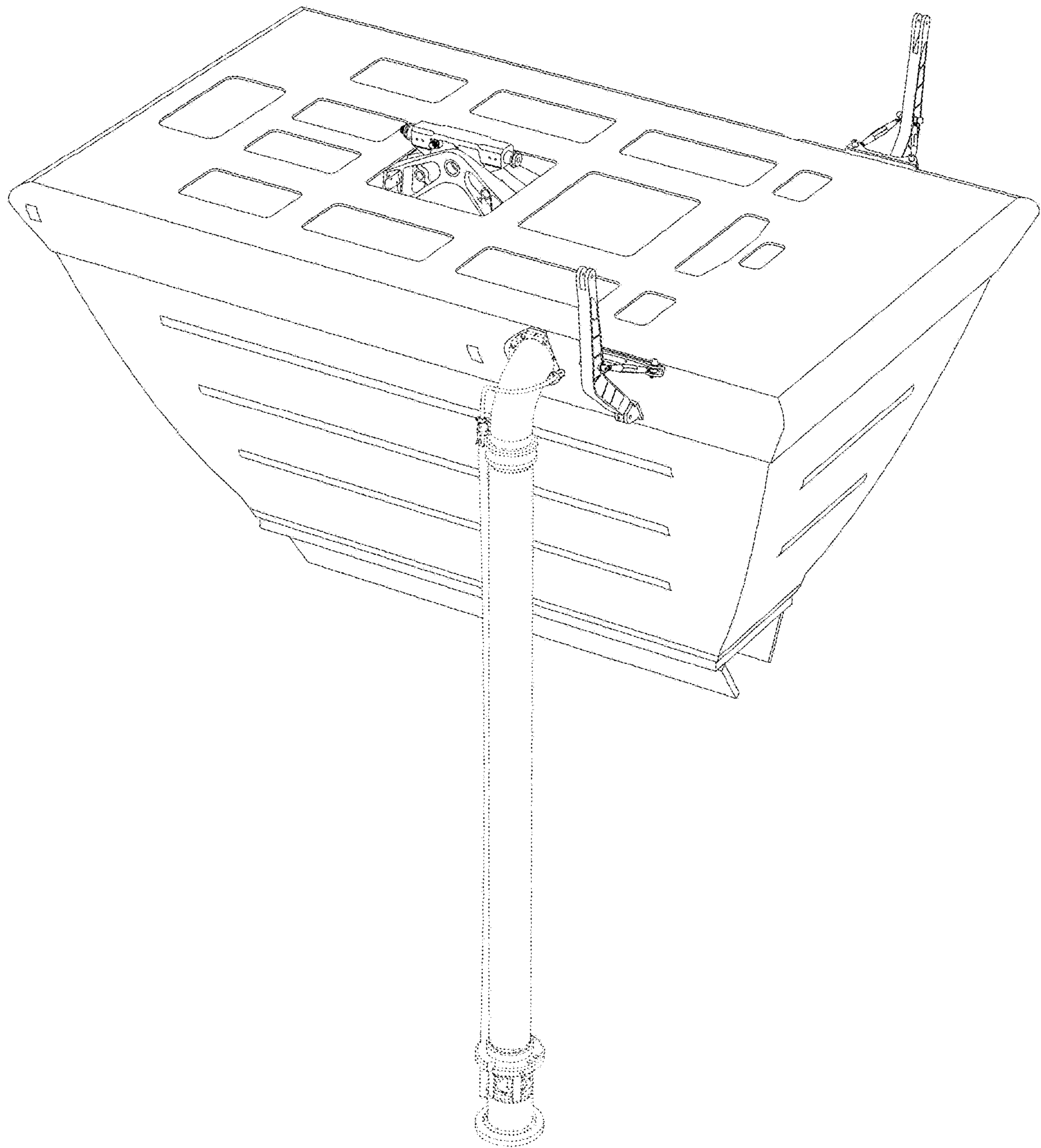

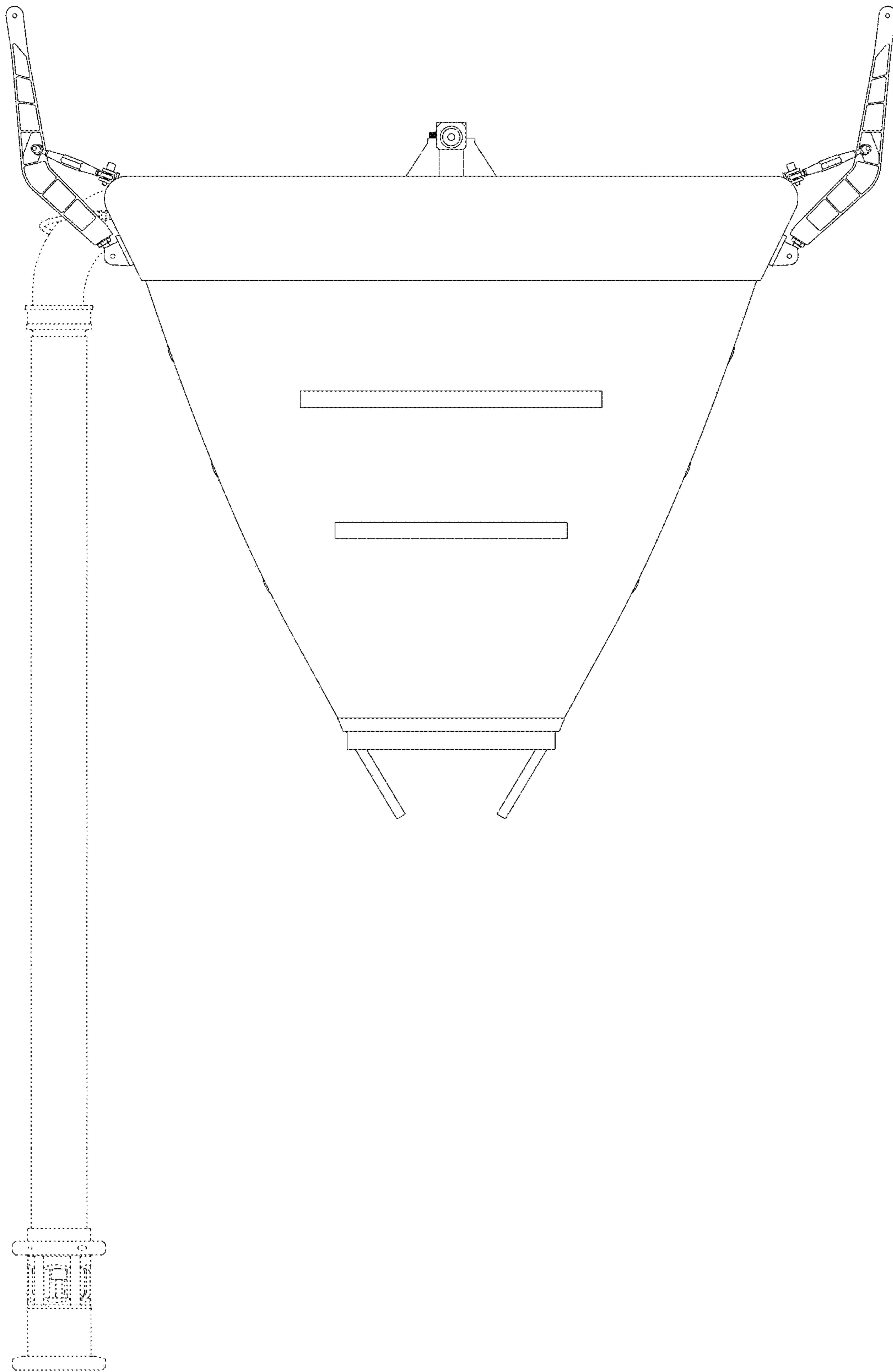

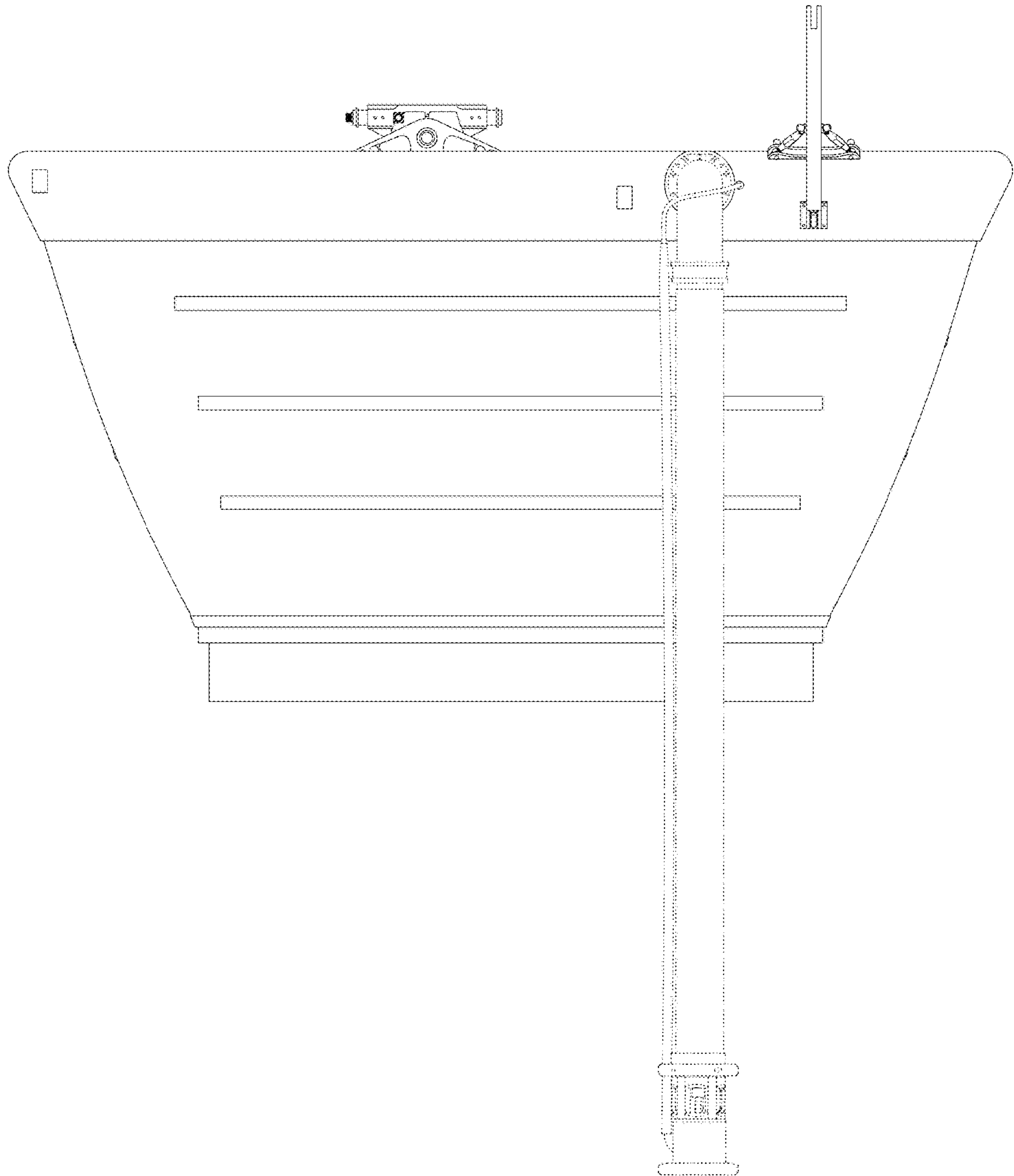

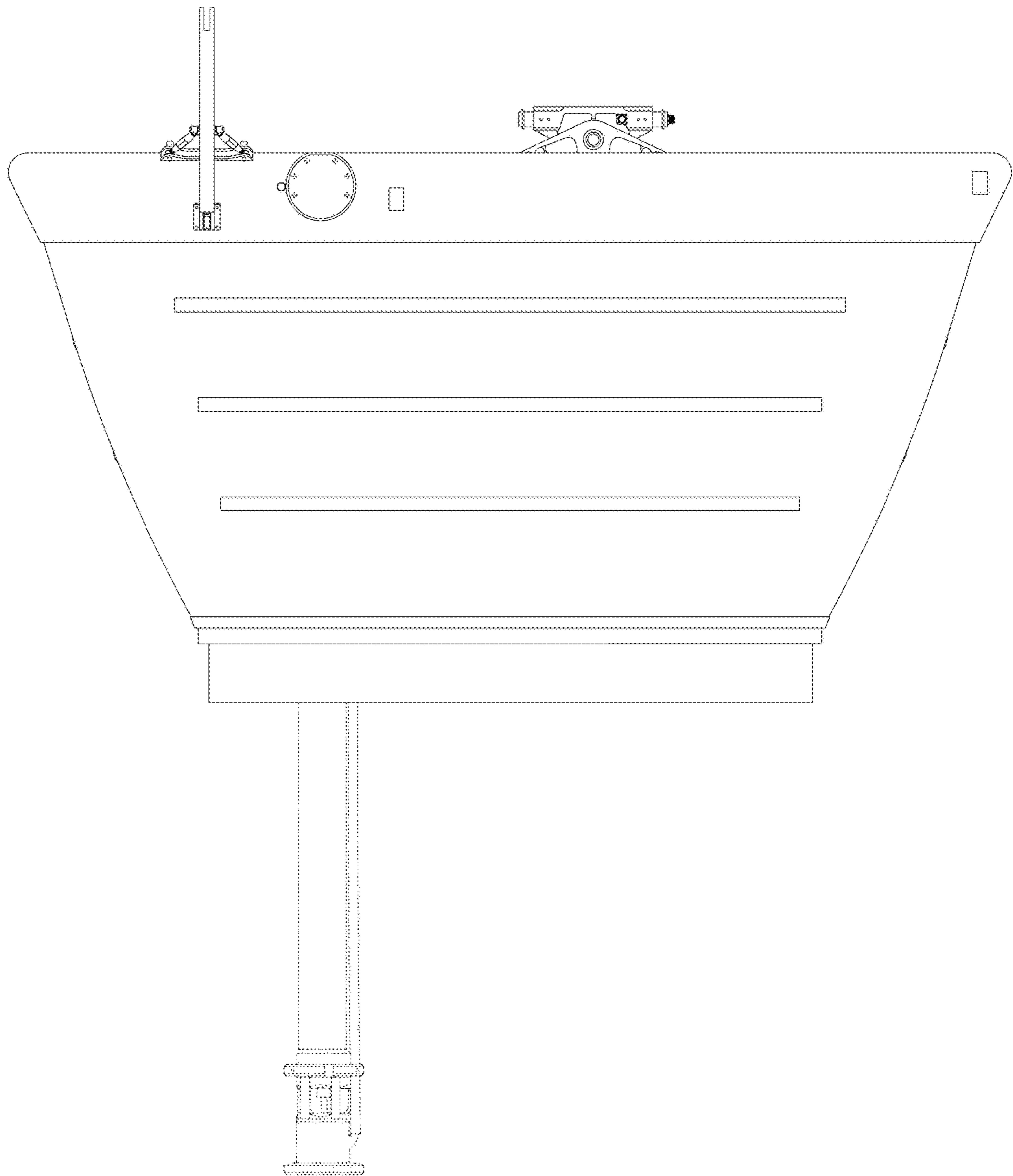

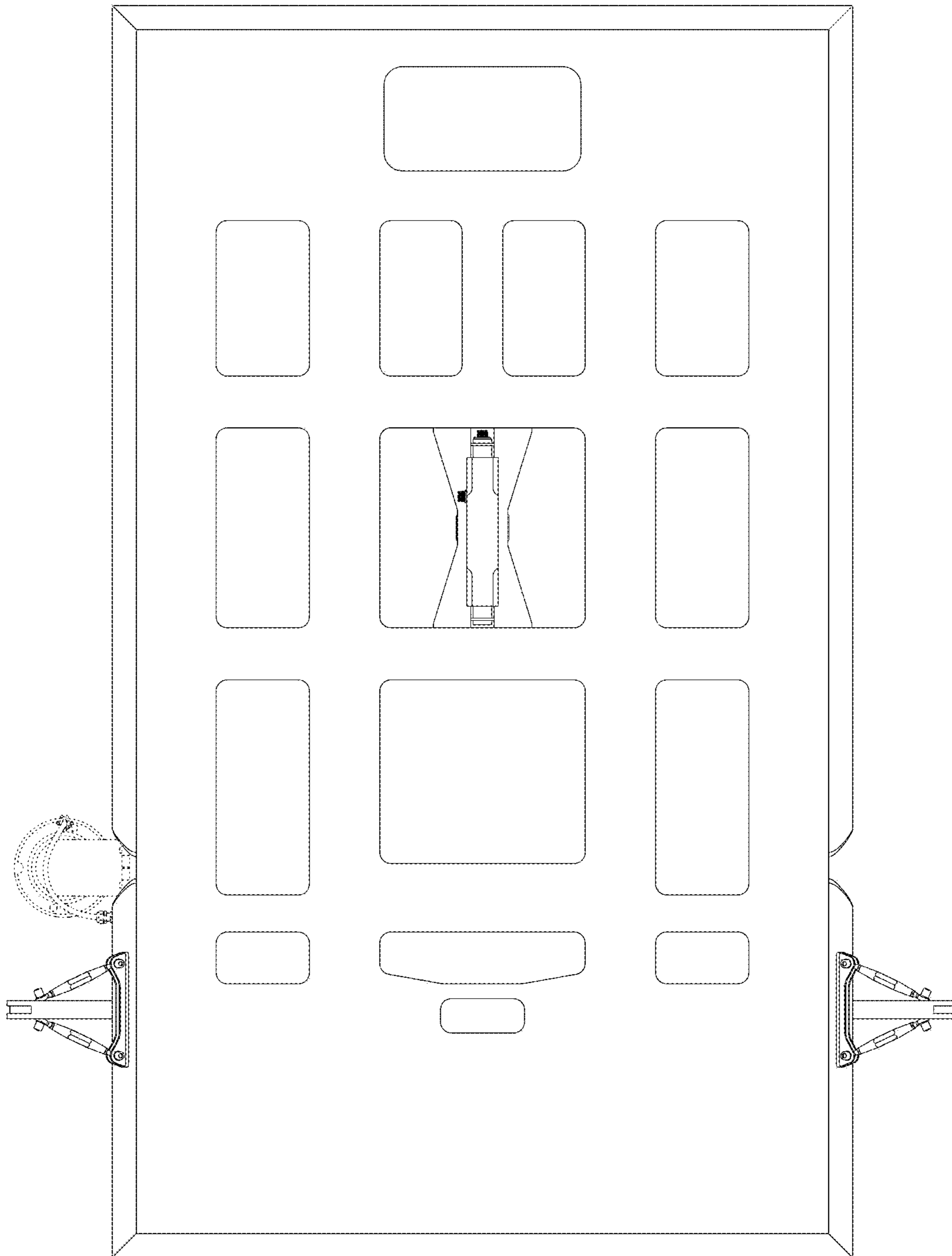

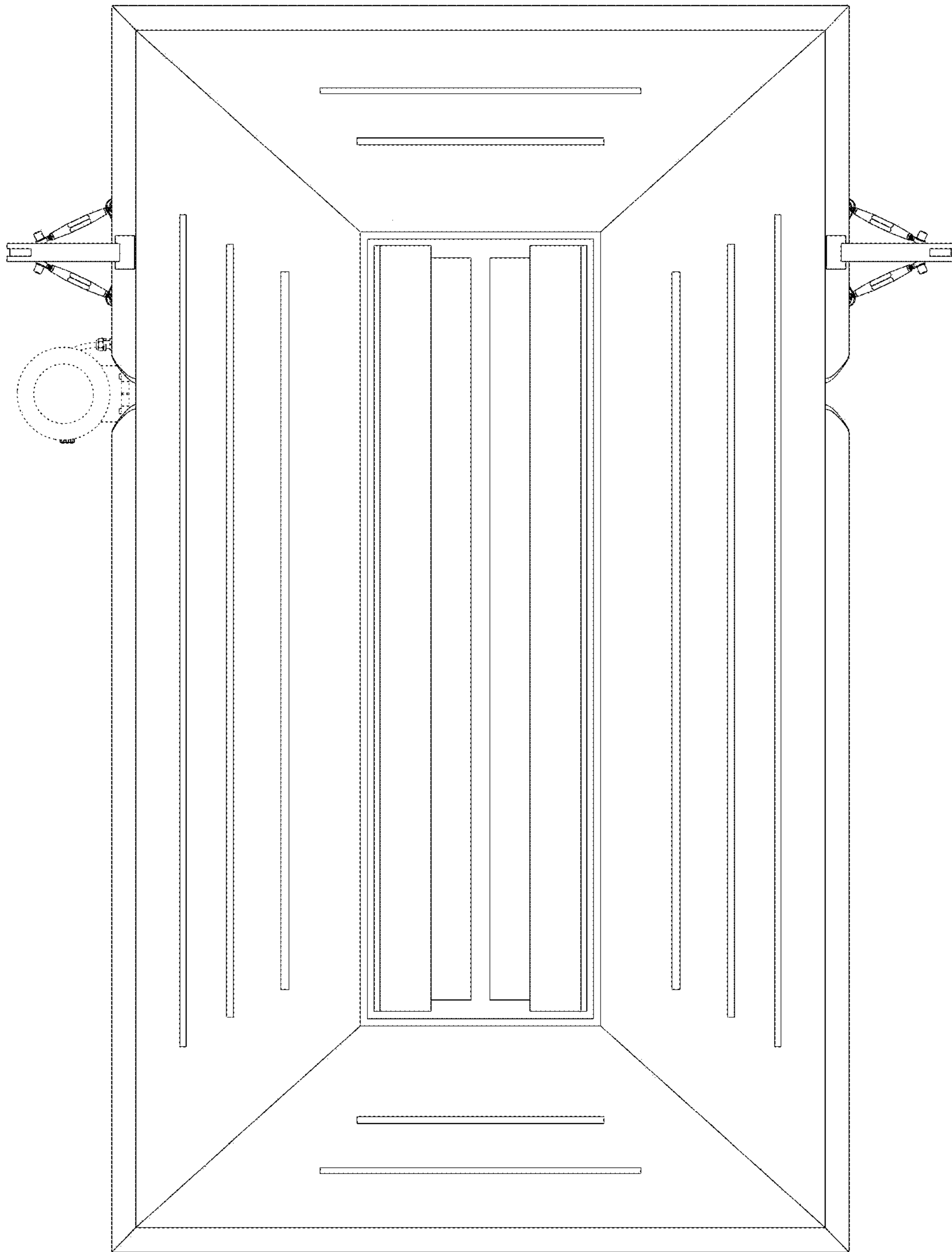
