FIG. 7 is a right side view thereof.

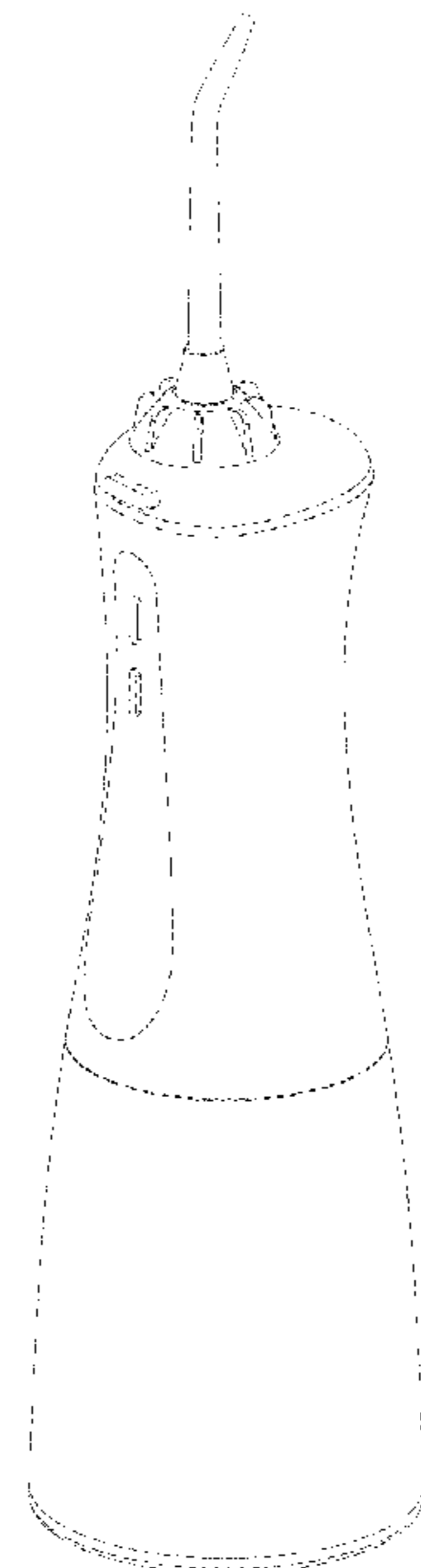
The broken lines illustrate portions of the oral waterjet that form no part of the claimed design.

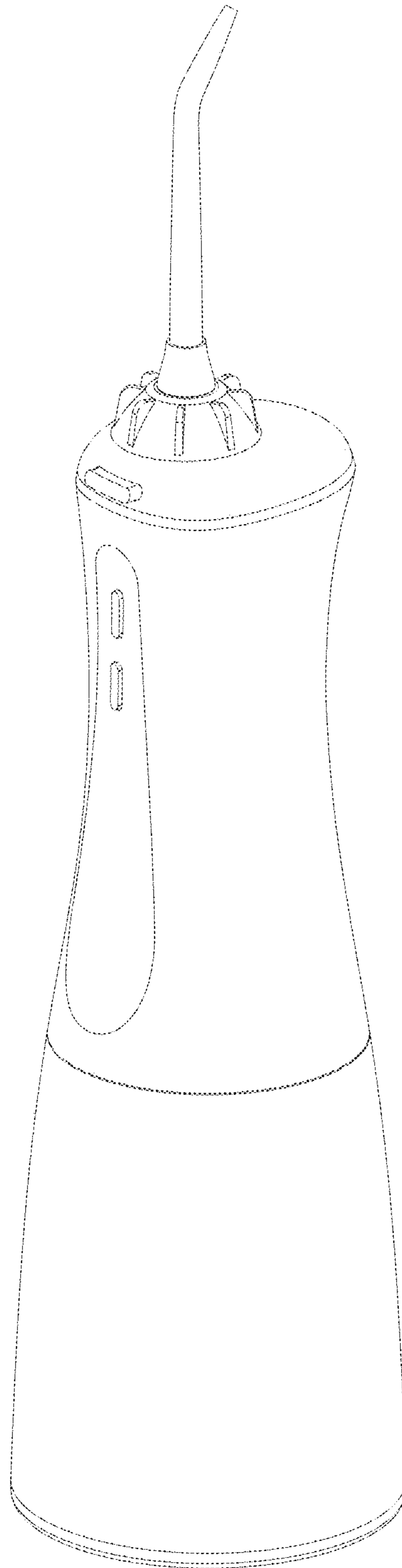

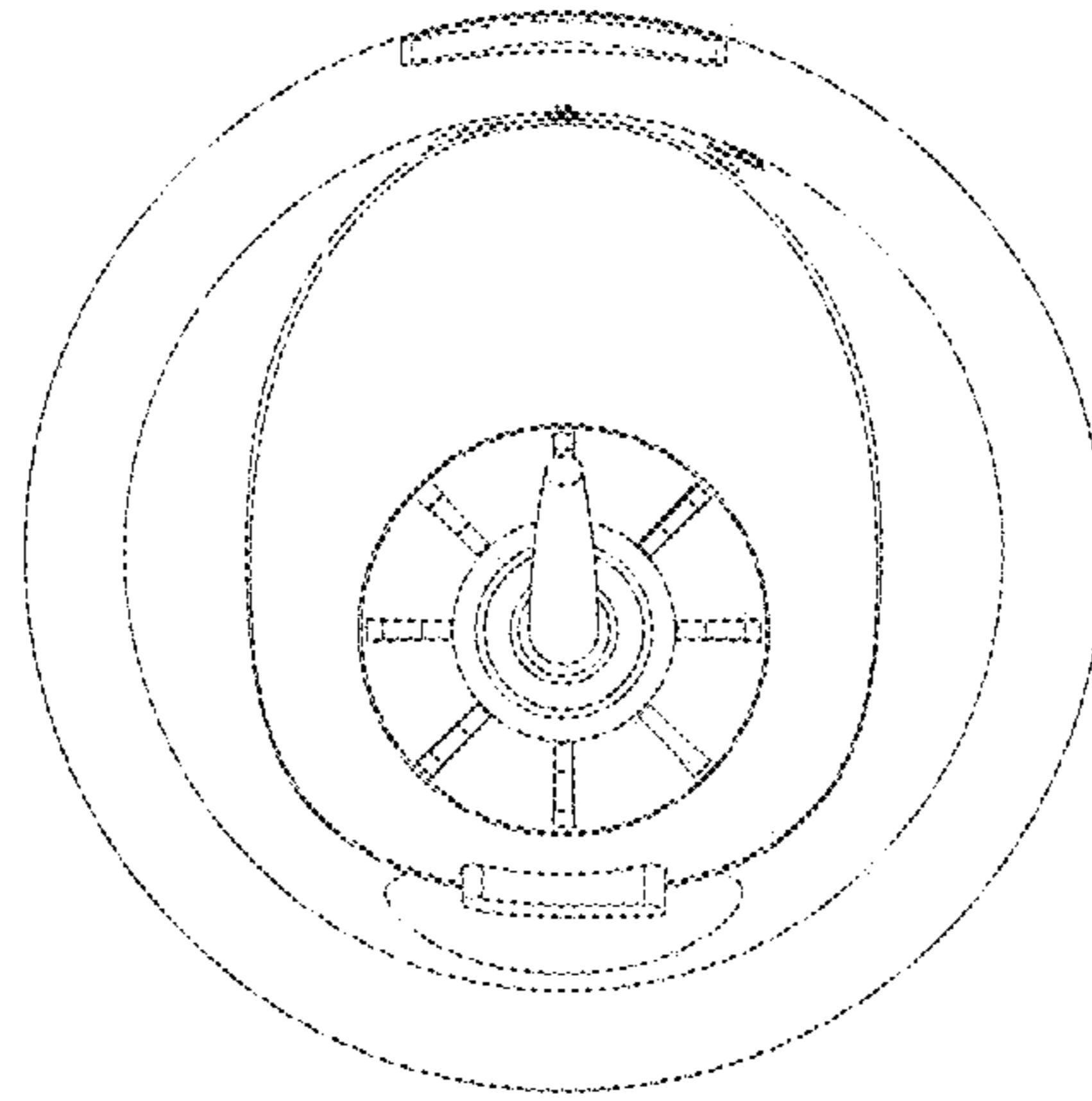

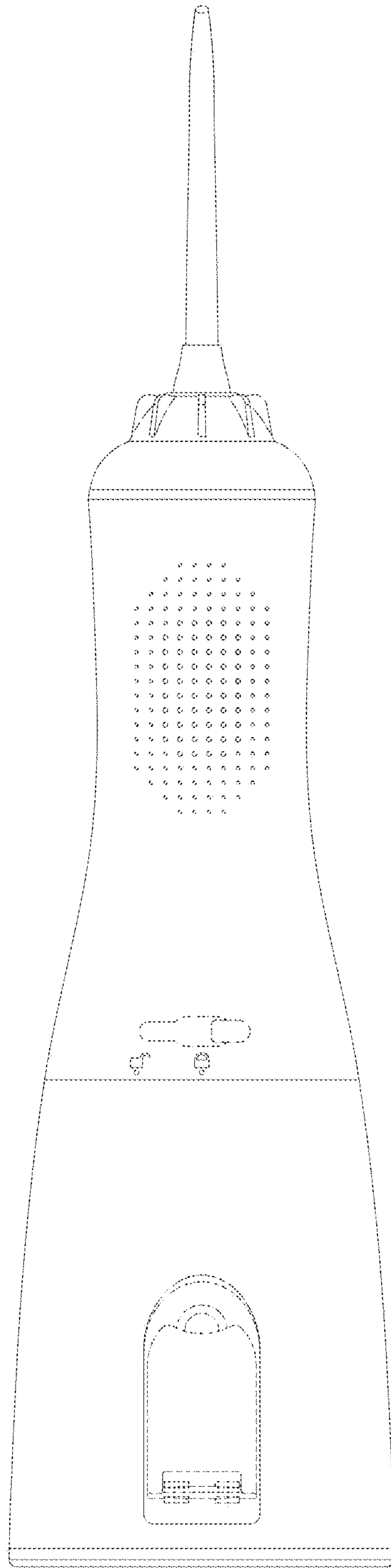

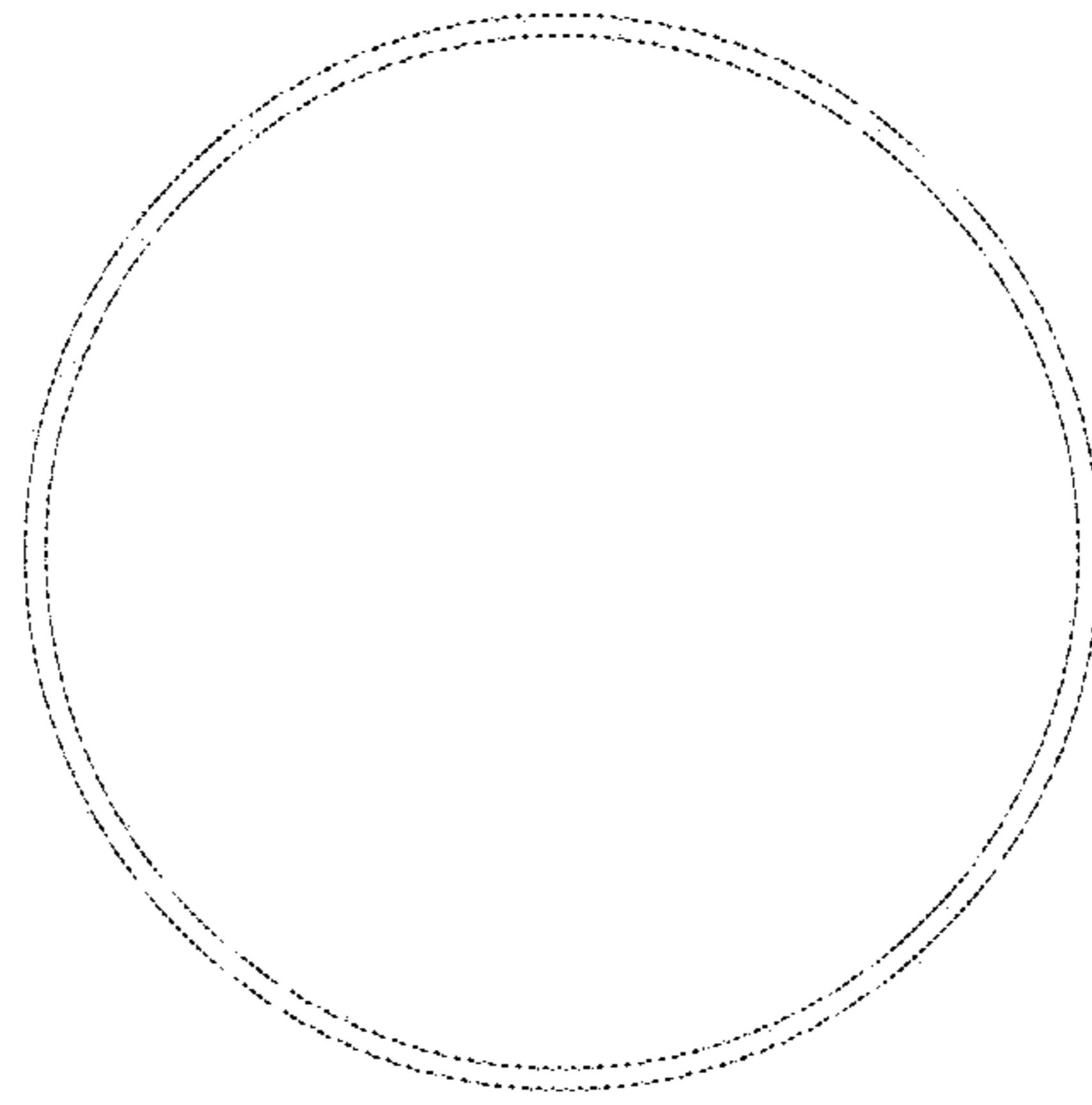

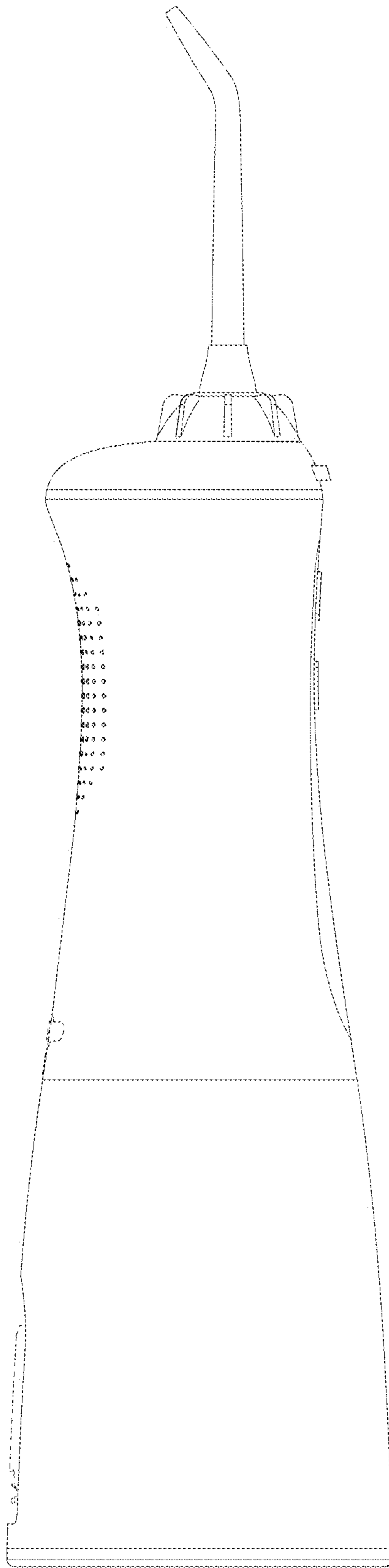

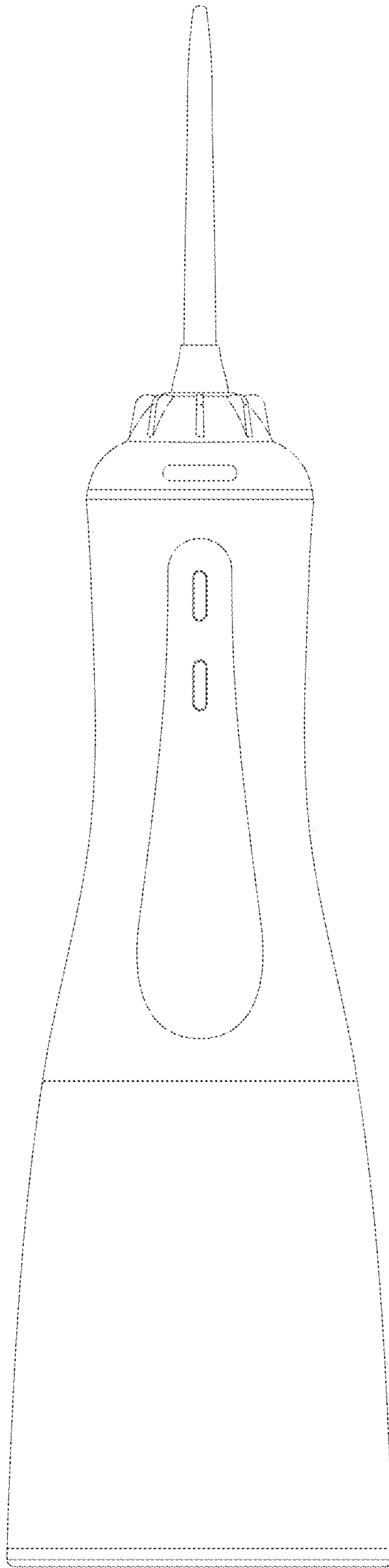

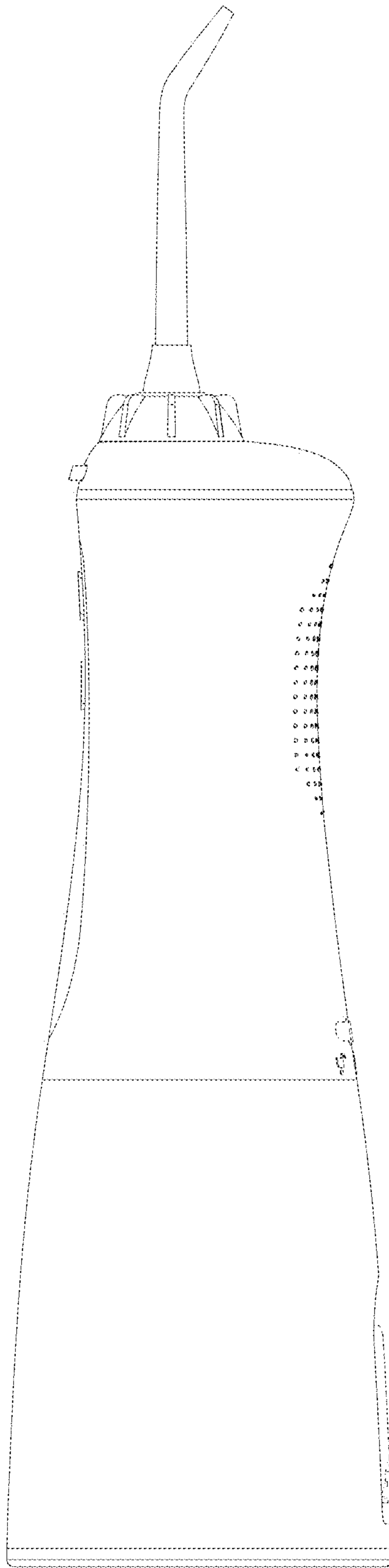
