DESCRIPTION

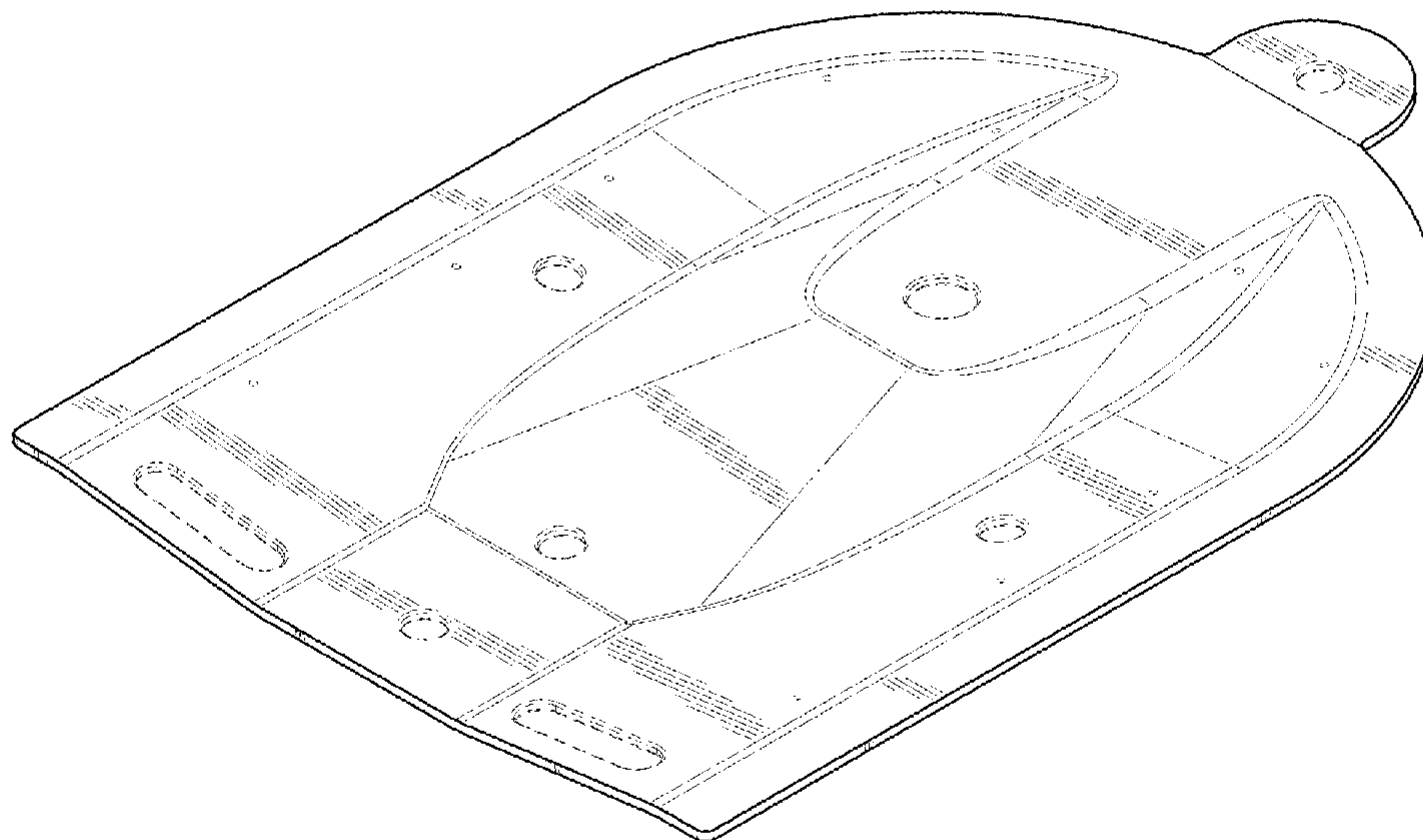
FIG. 1 is a front-perspective view of a tube management assembly showing our new design;

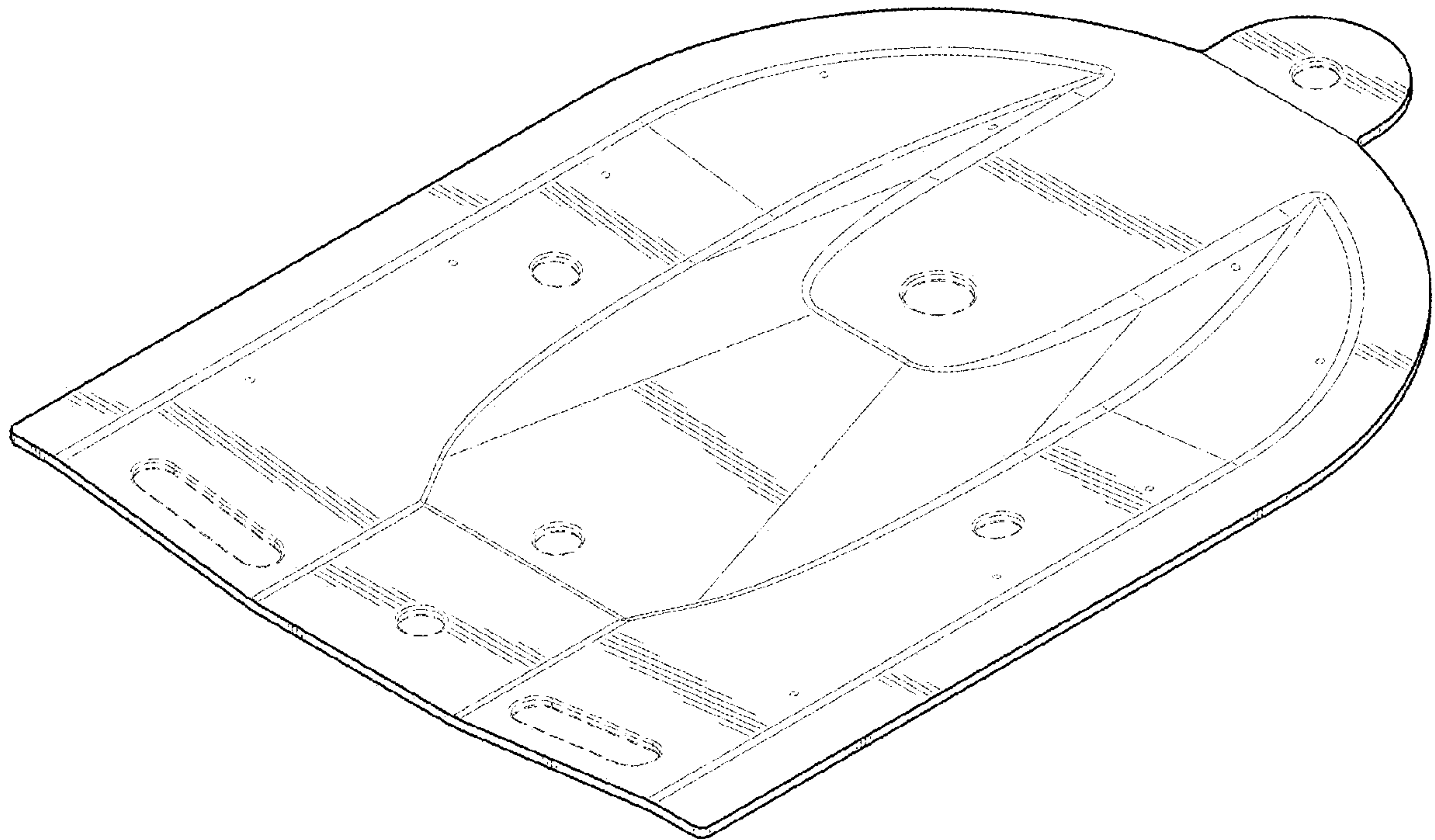

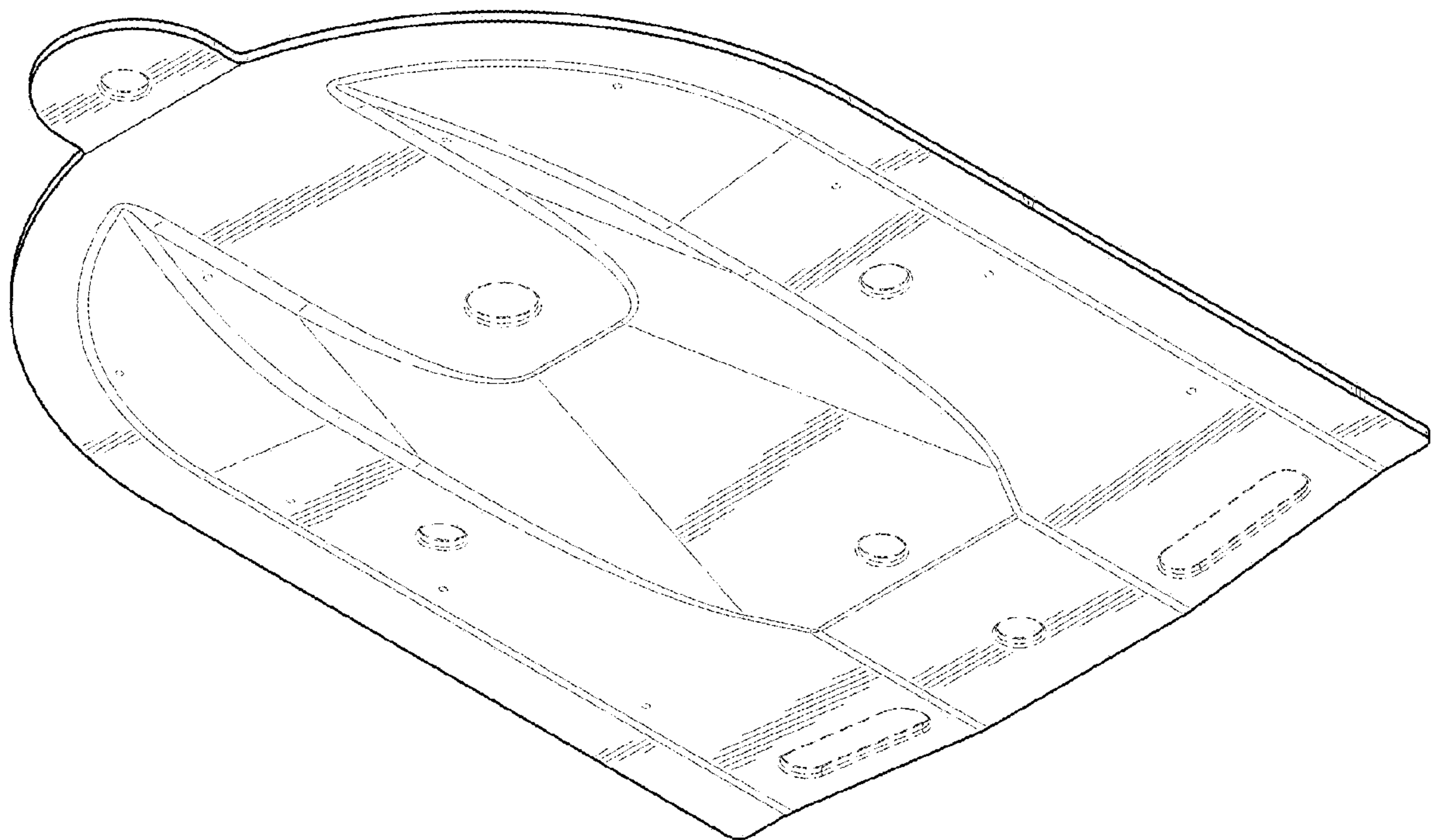

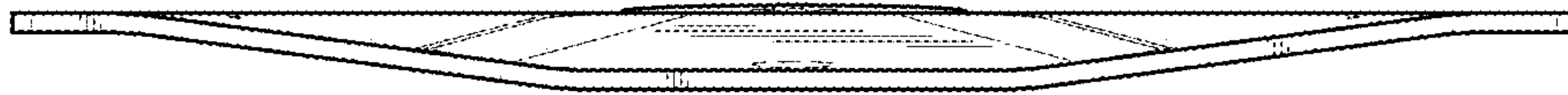

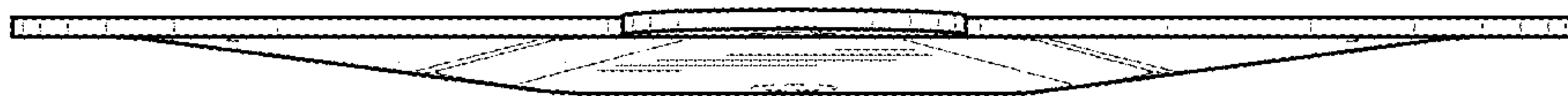

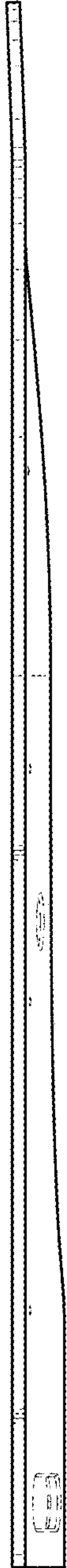

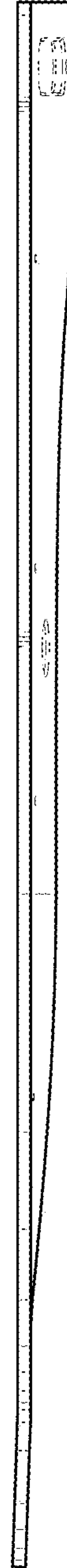

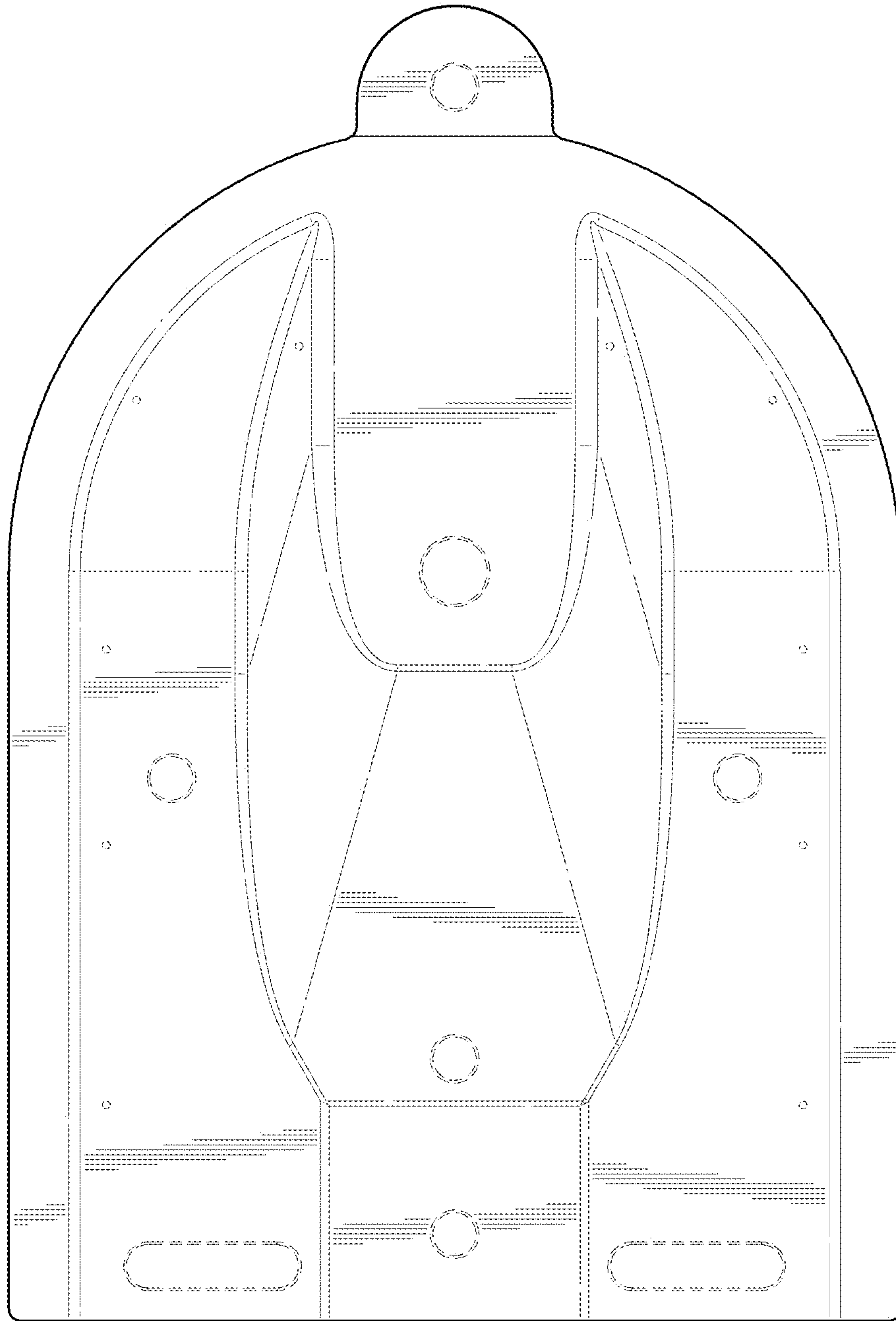

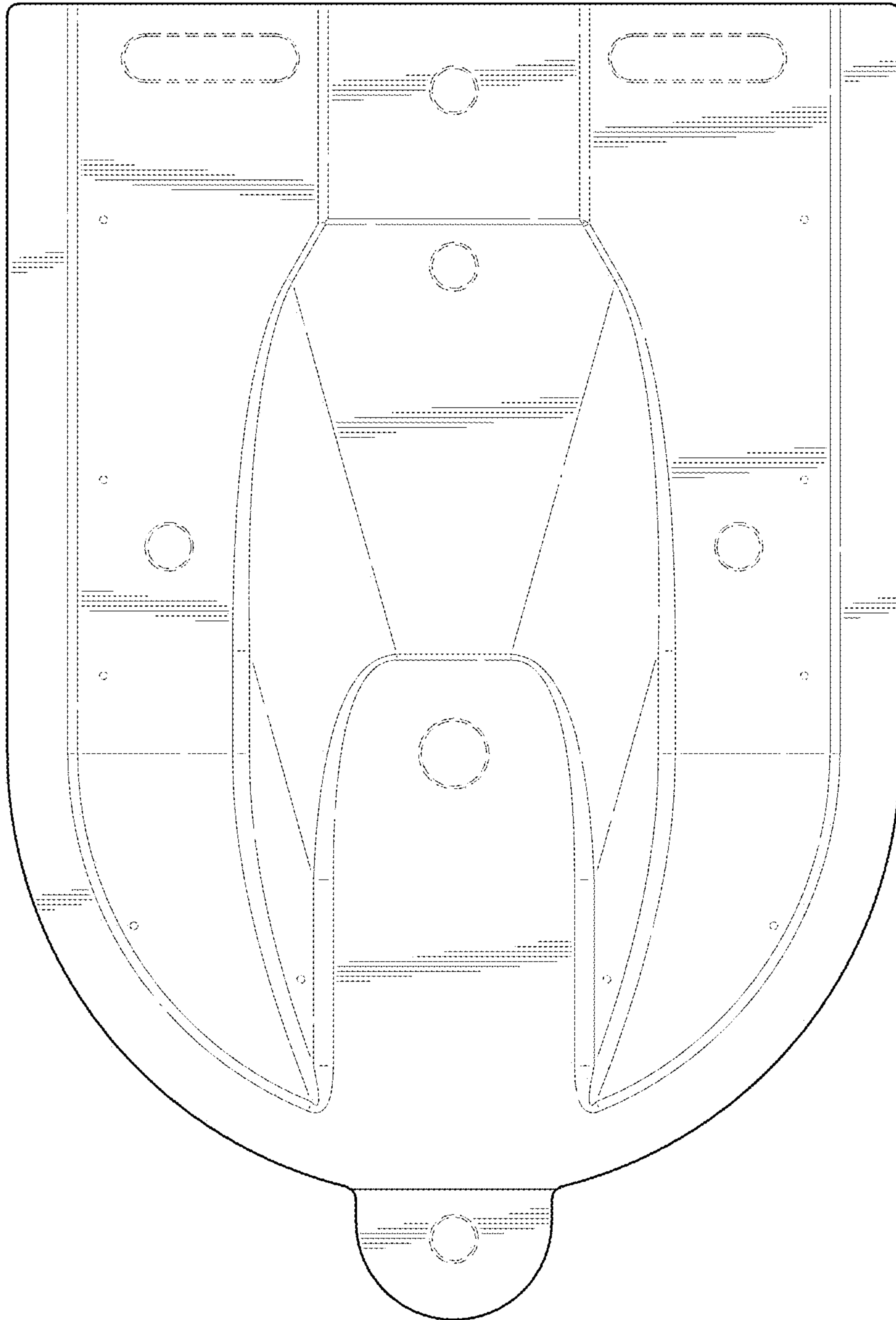
