FIG. 4 is a rear elevation view of the cosmetic container of FIG. 1.

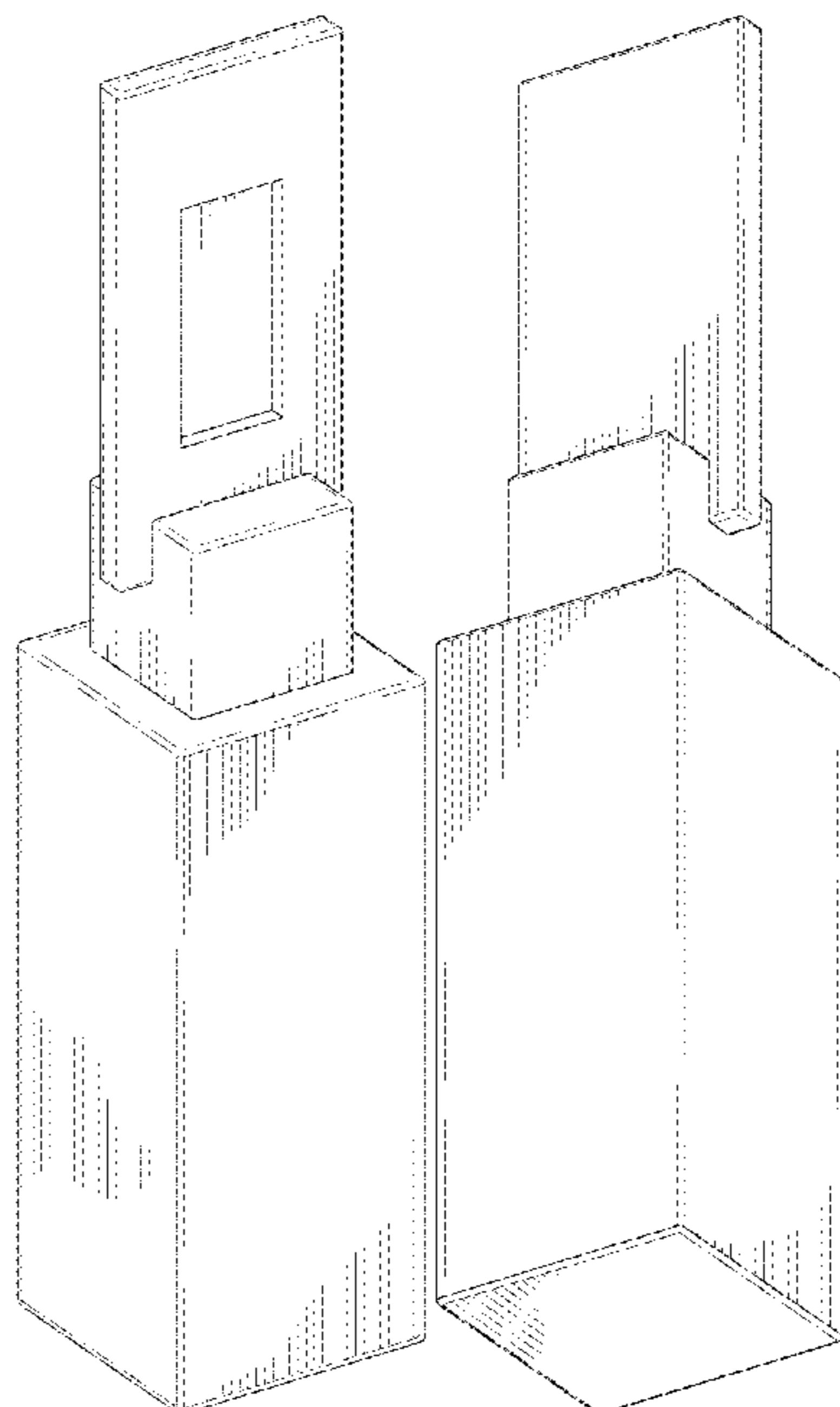
FIG. 5 is a left side elevation view of the cosmetic container of FIG. 1.

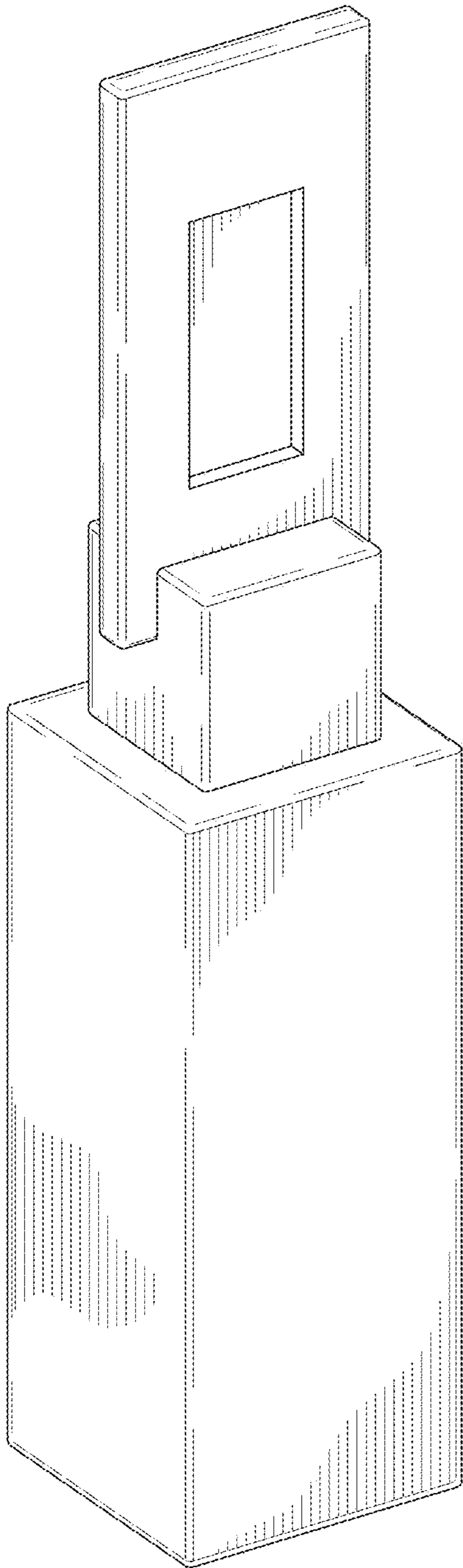

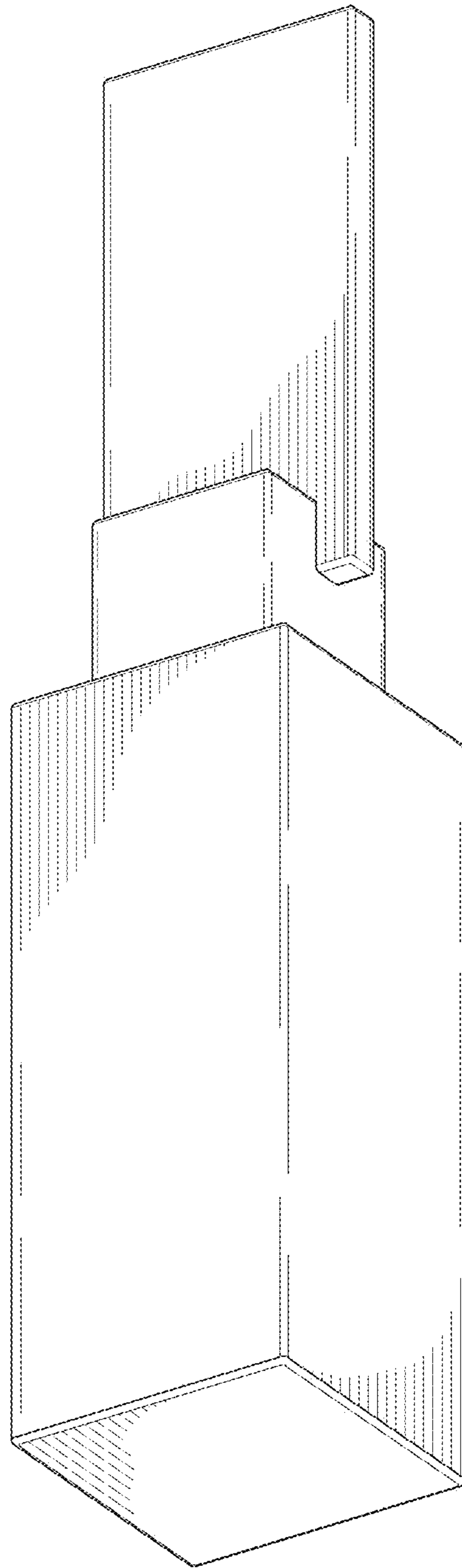

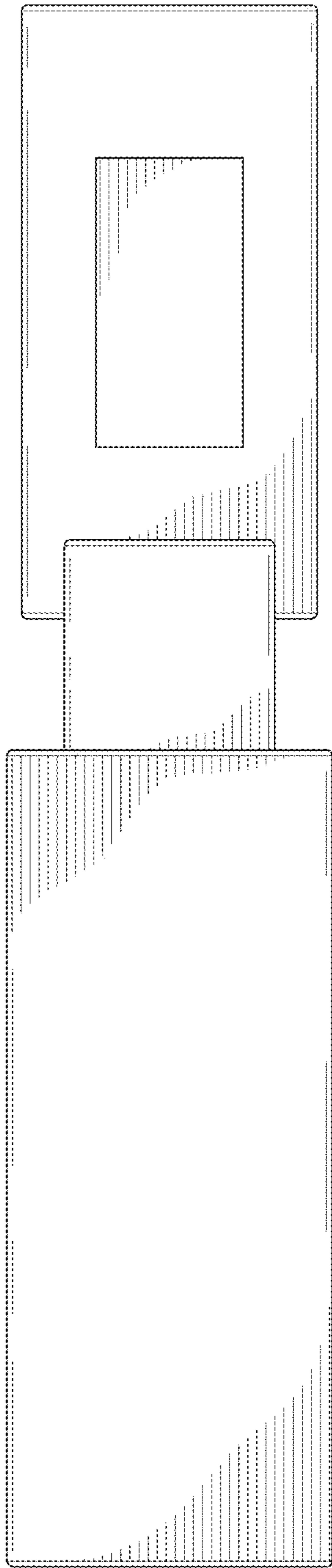

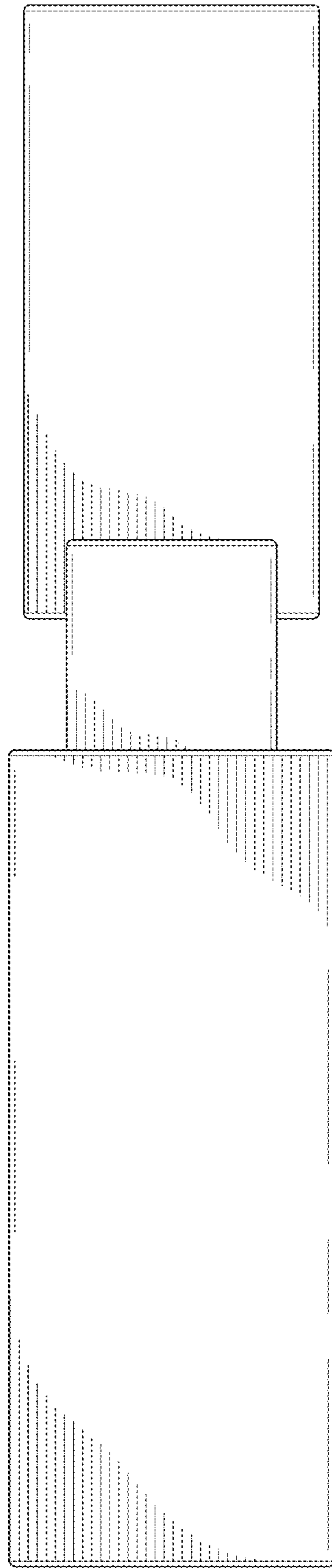

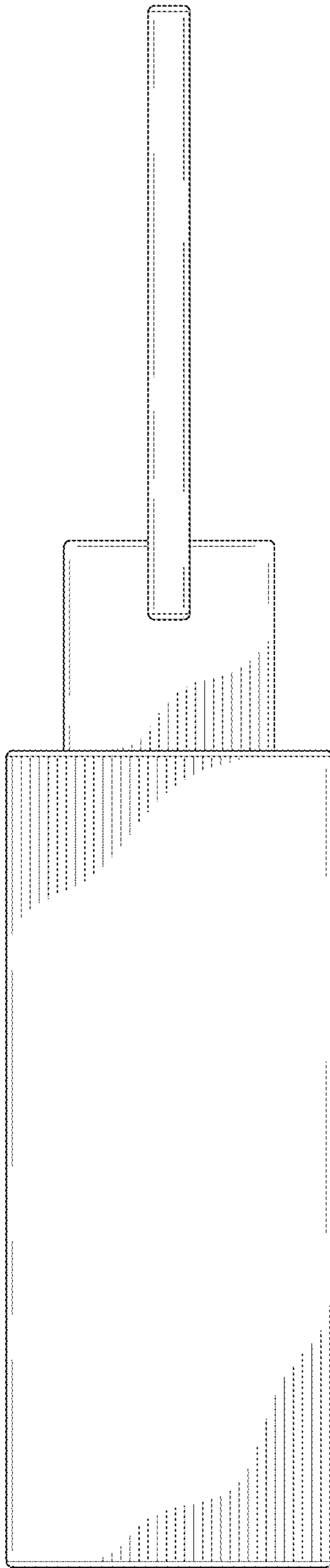

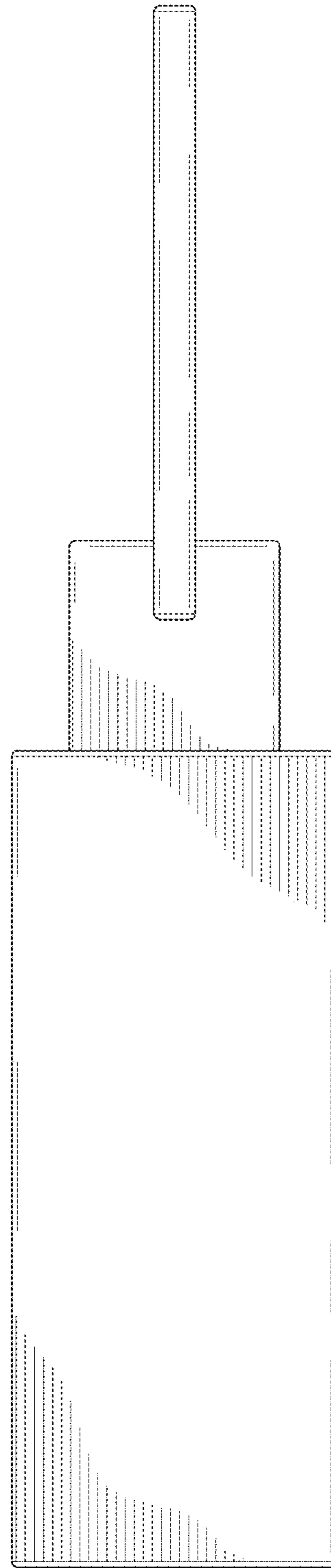

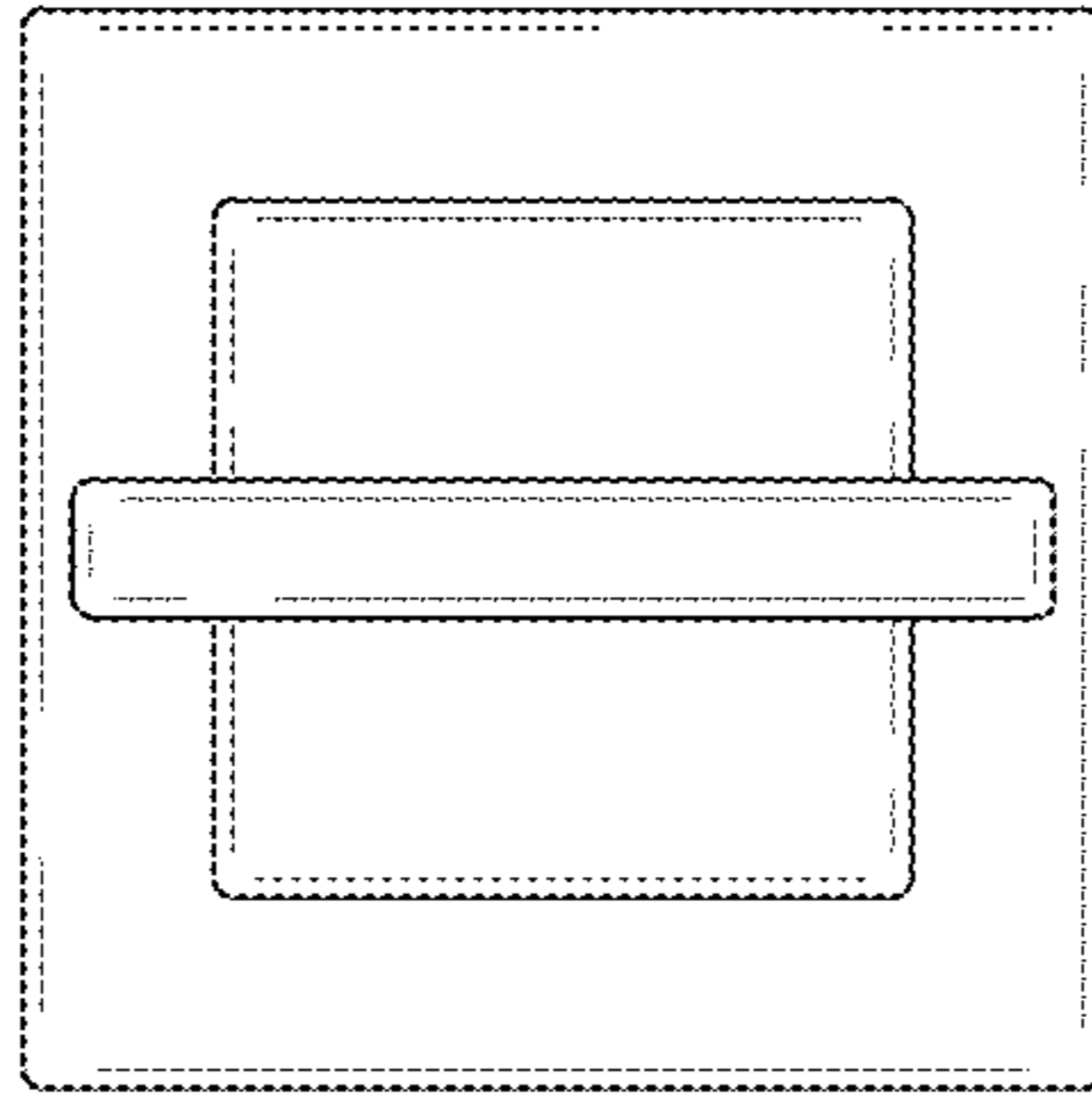

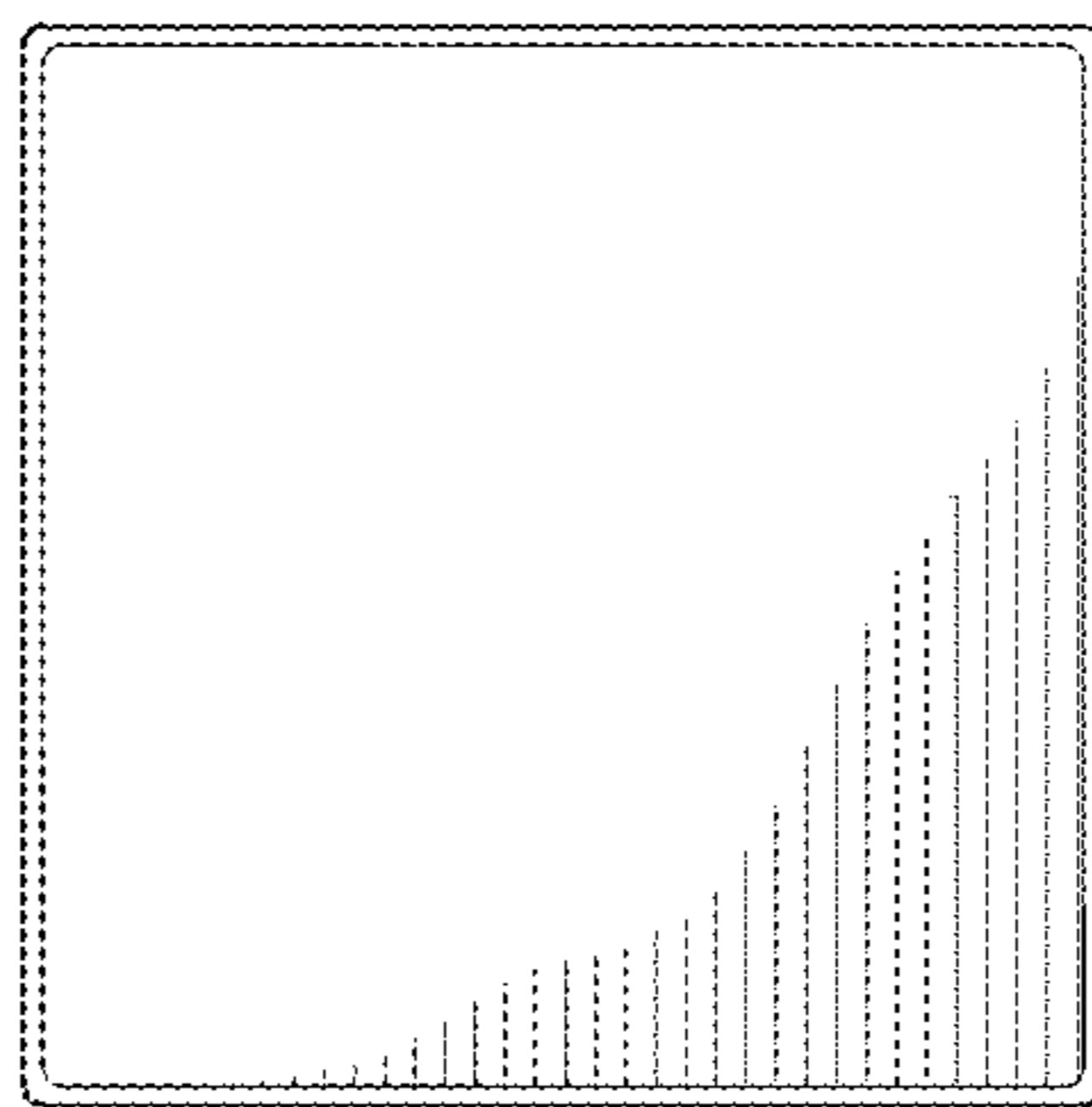
