(57) **CLAIM**

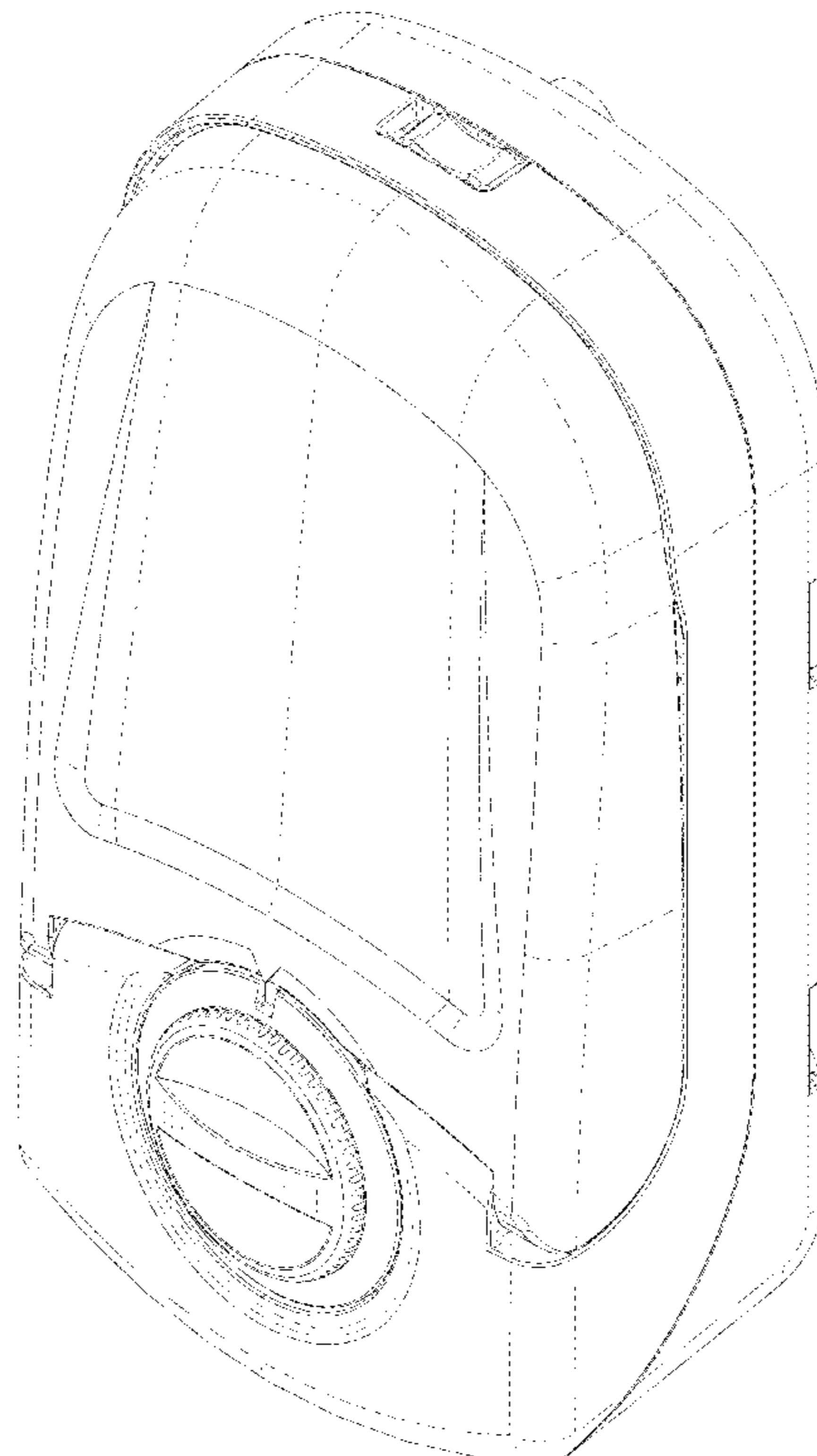
A new, original, ornamental design for a pet feeder, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a pet feeder showing my new design;  
FIG. 2 is another perspective view thereof;  
FIG. 3 is a front elevation view thereof;  
FIG. 4 is a rear elevation view thereof;  
FIG. 5 is a right side elevation view thereof;  
FIG. 6 is a left side elevation view thereof;

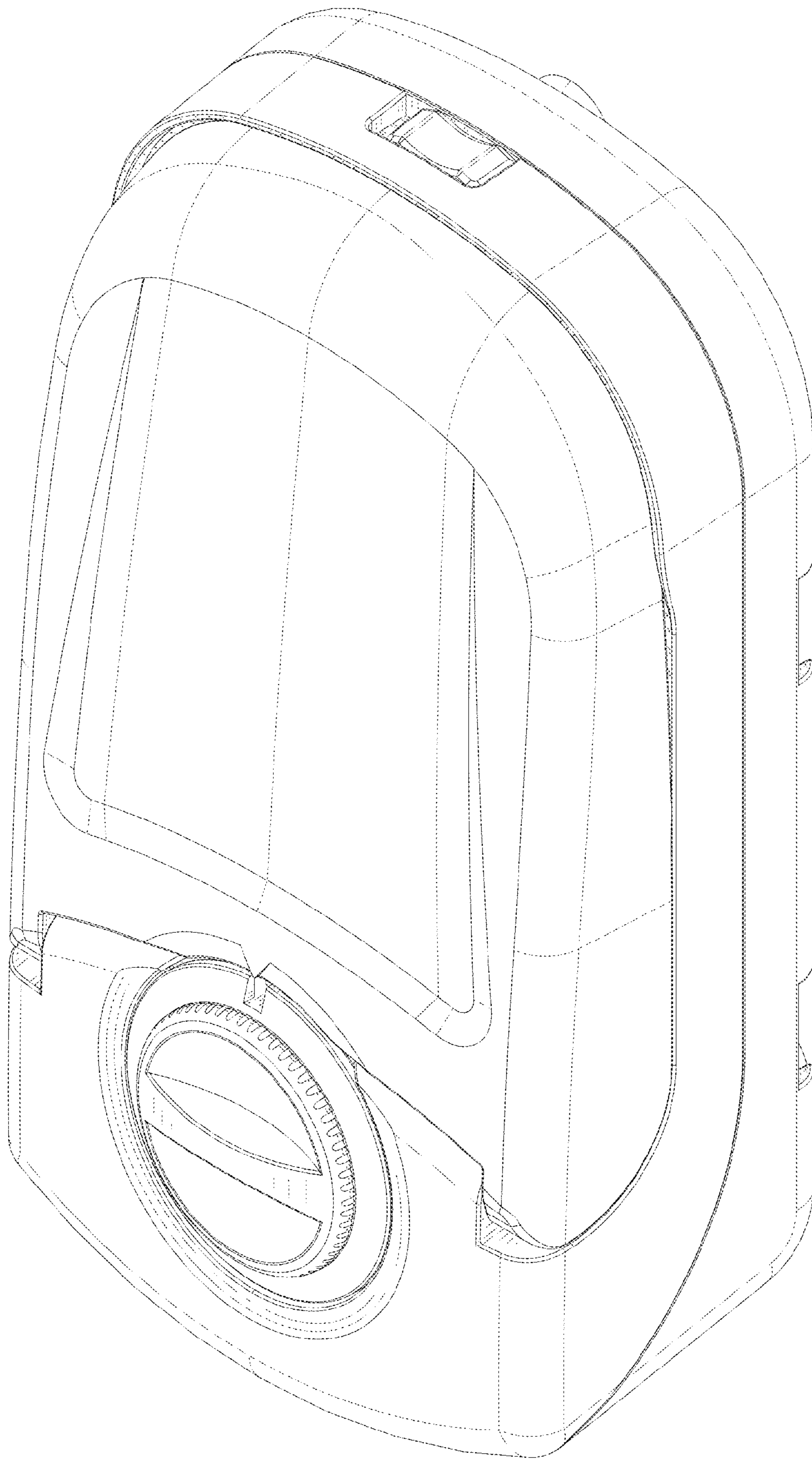

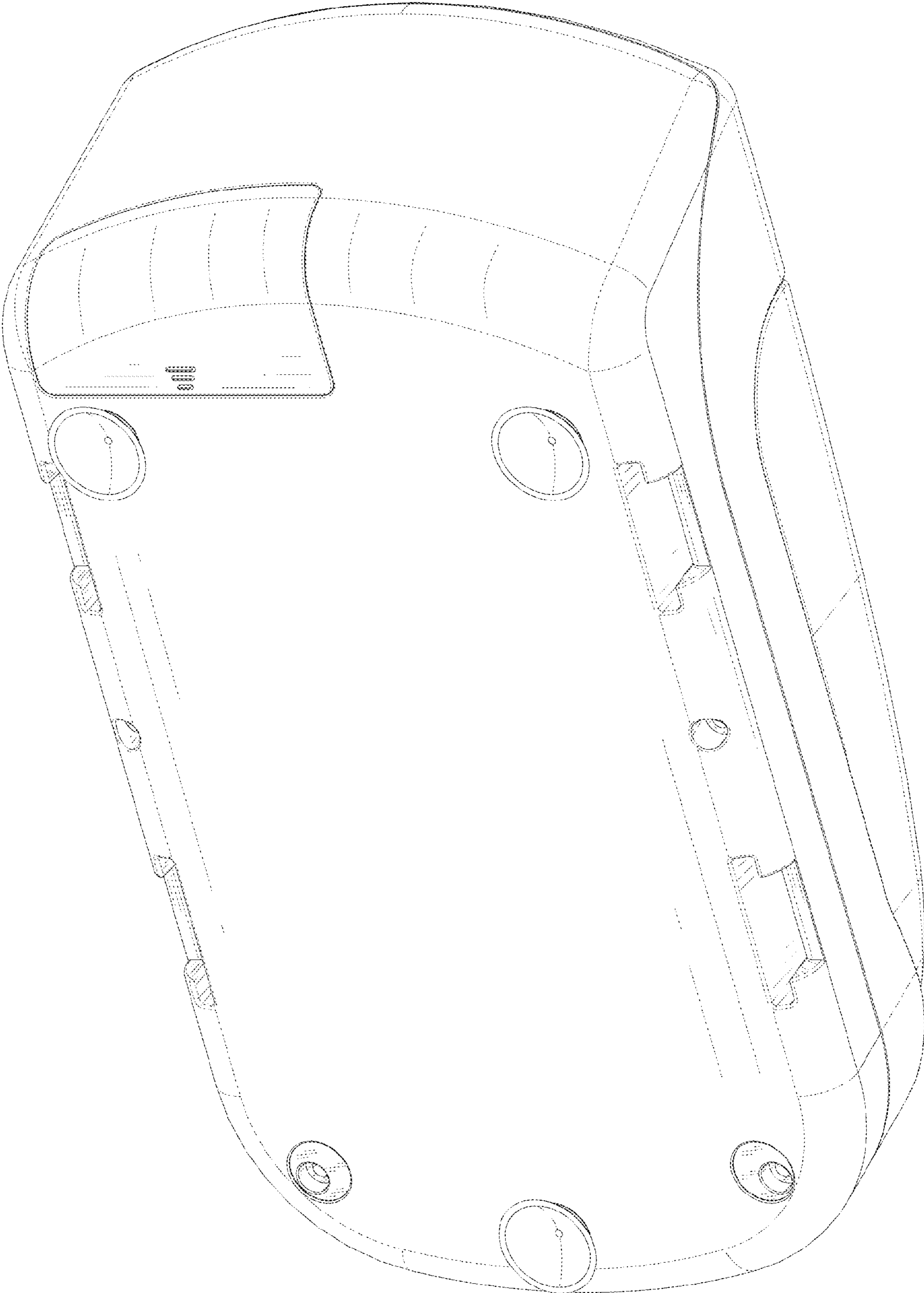

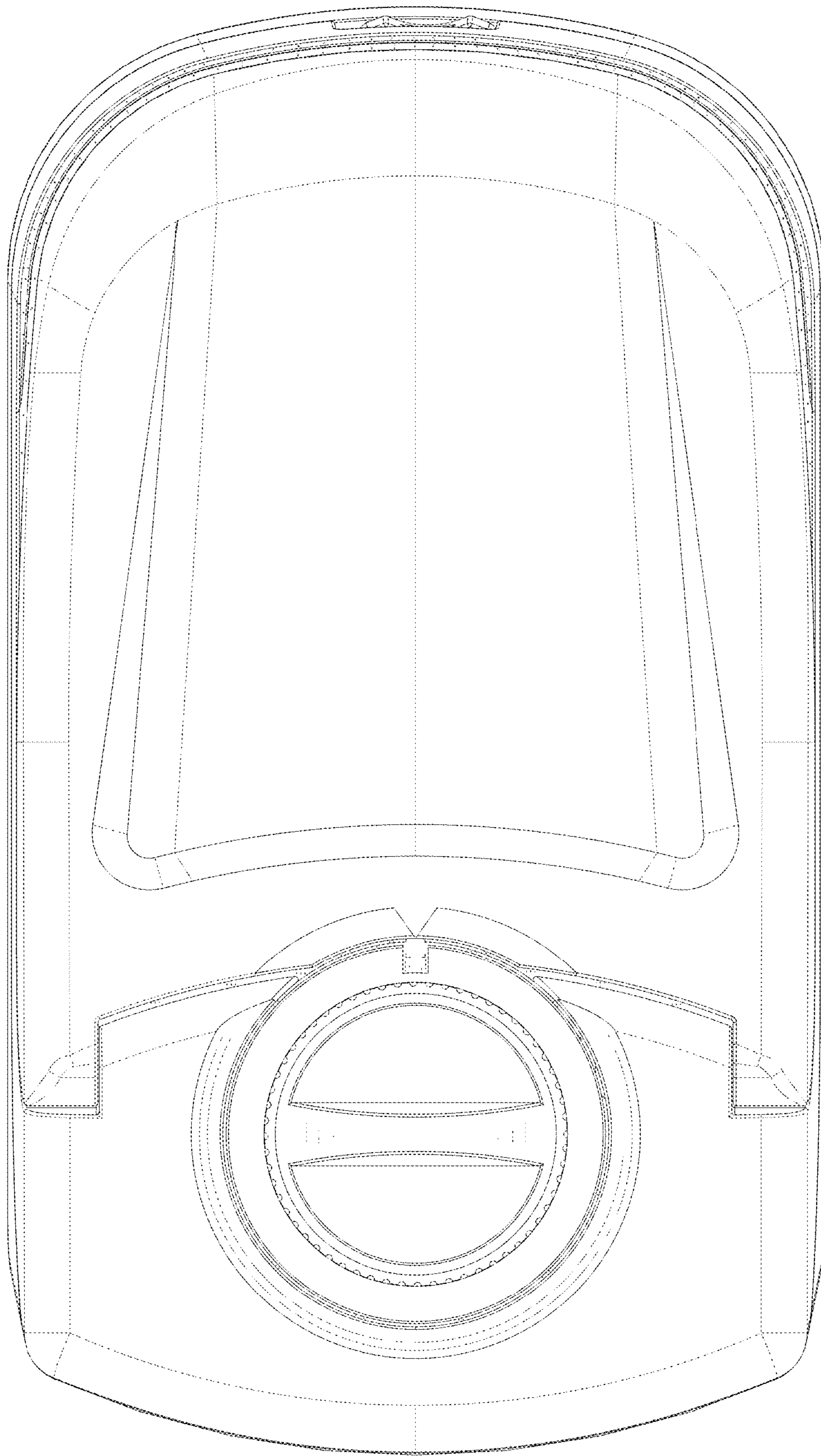

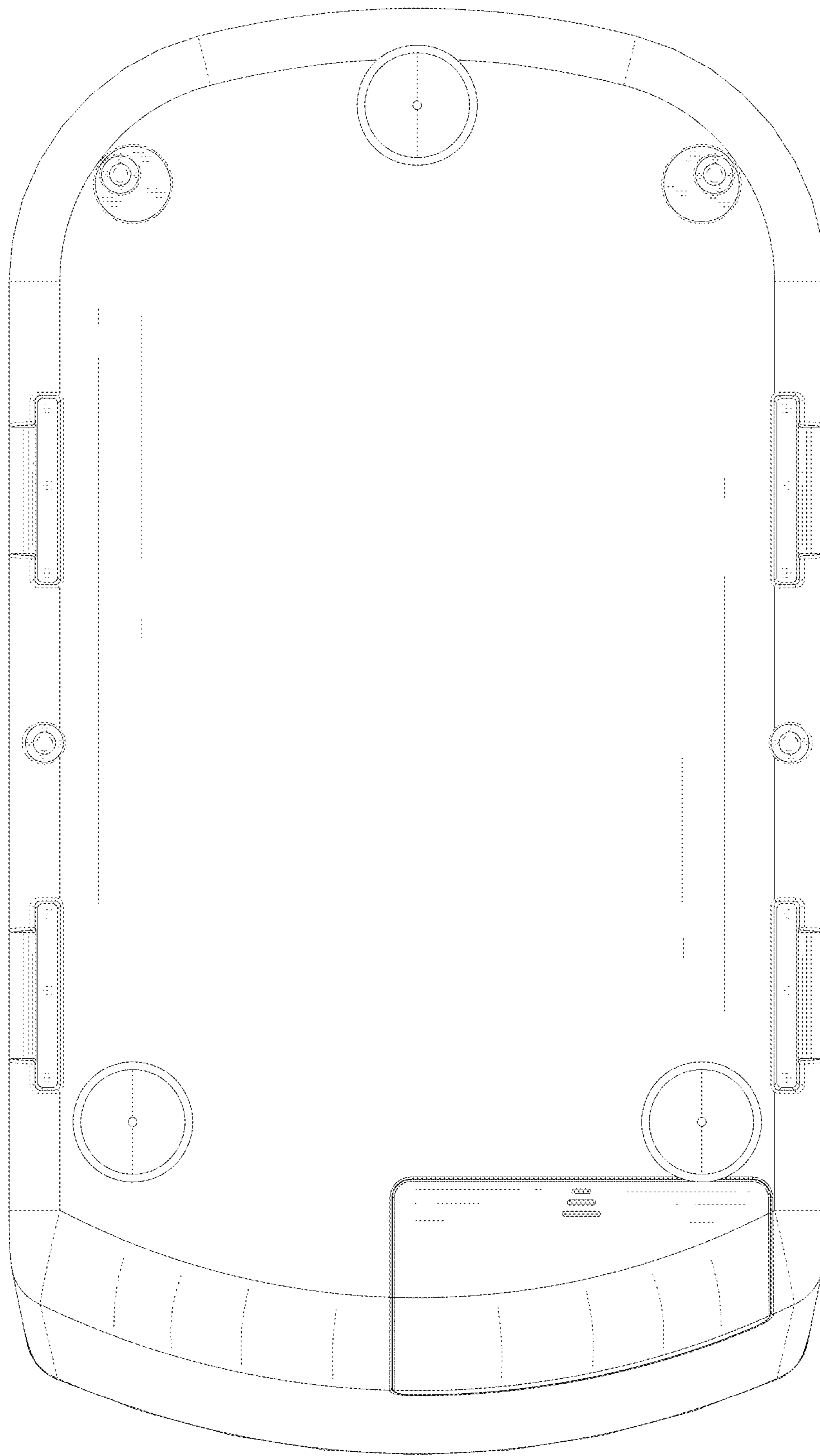

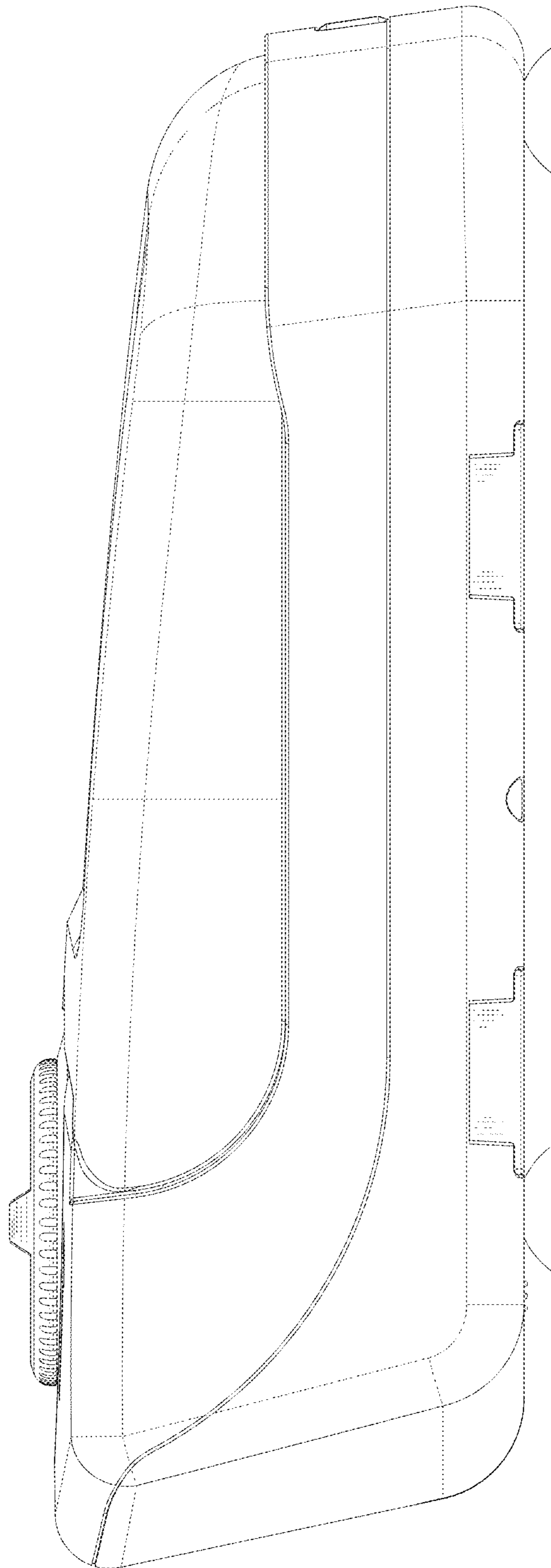

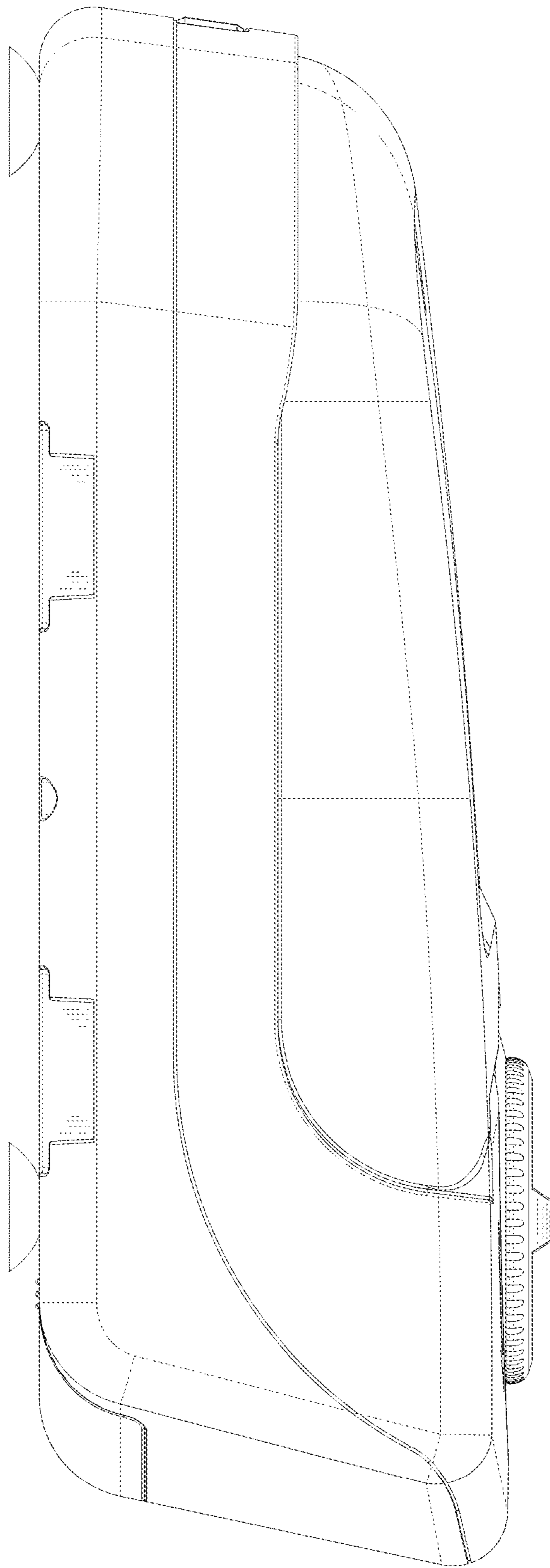

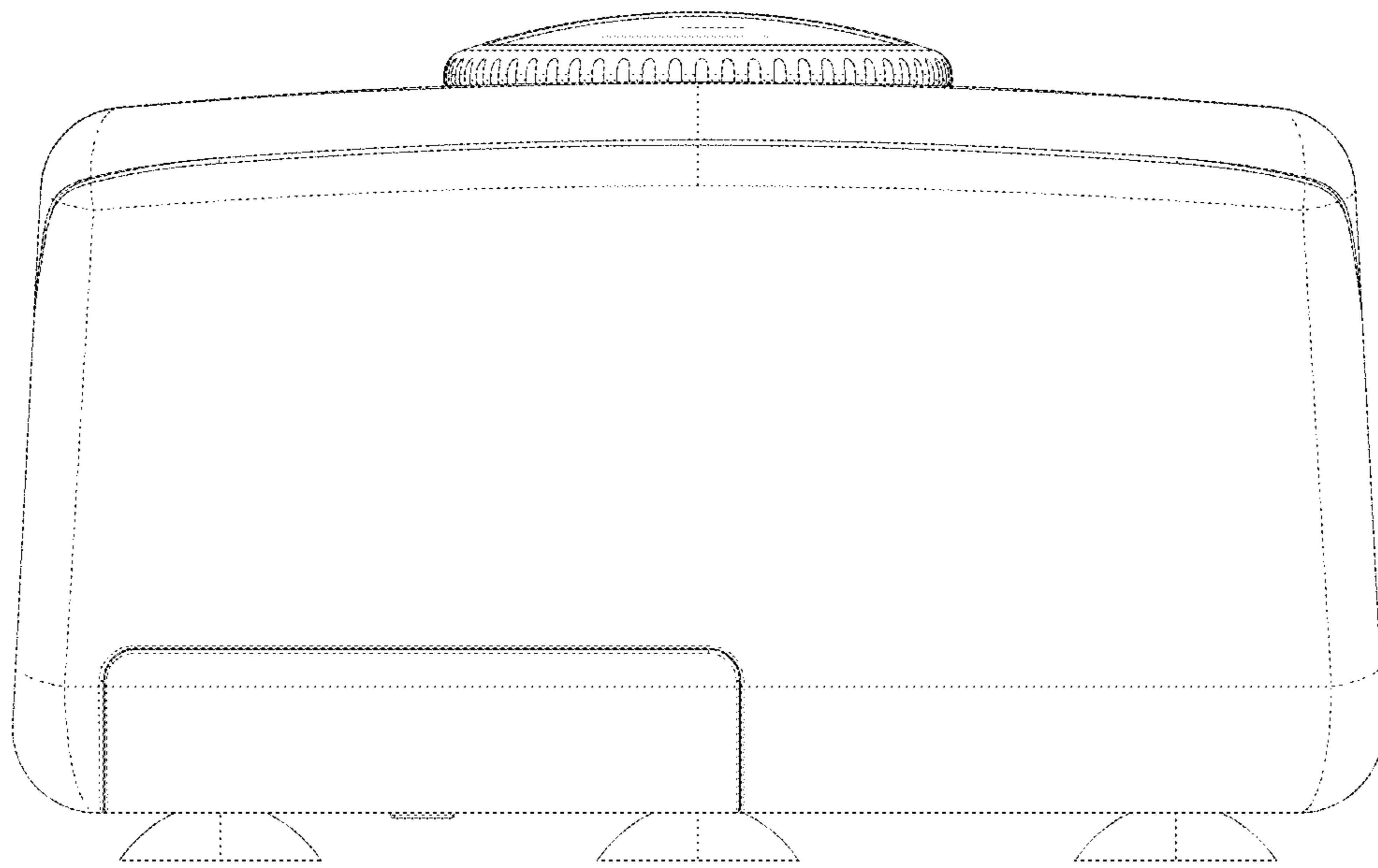

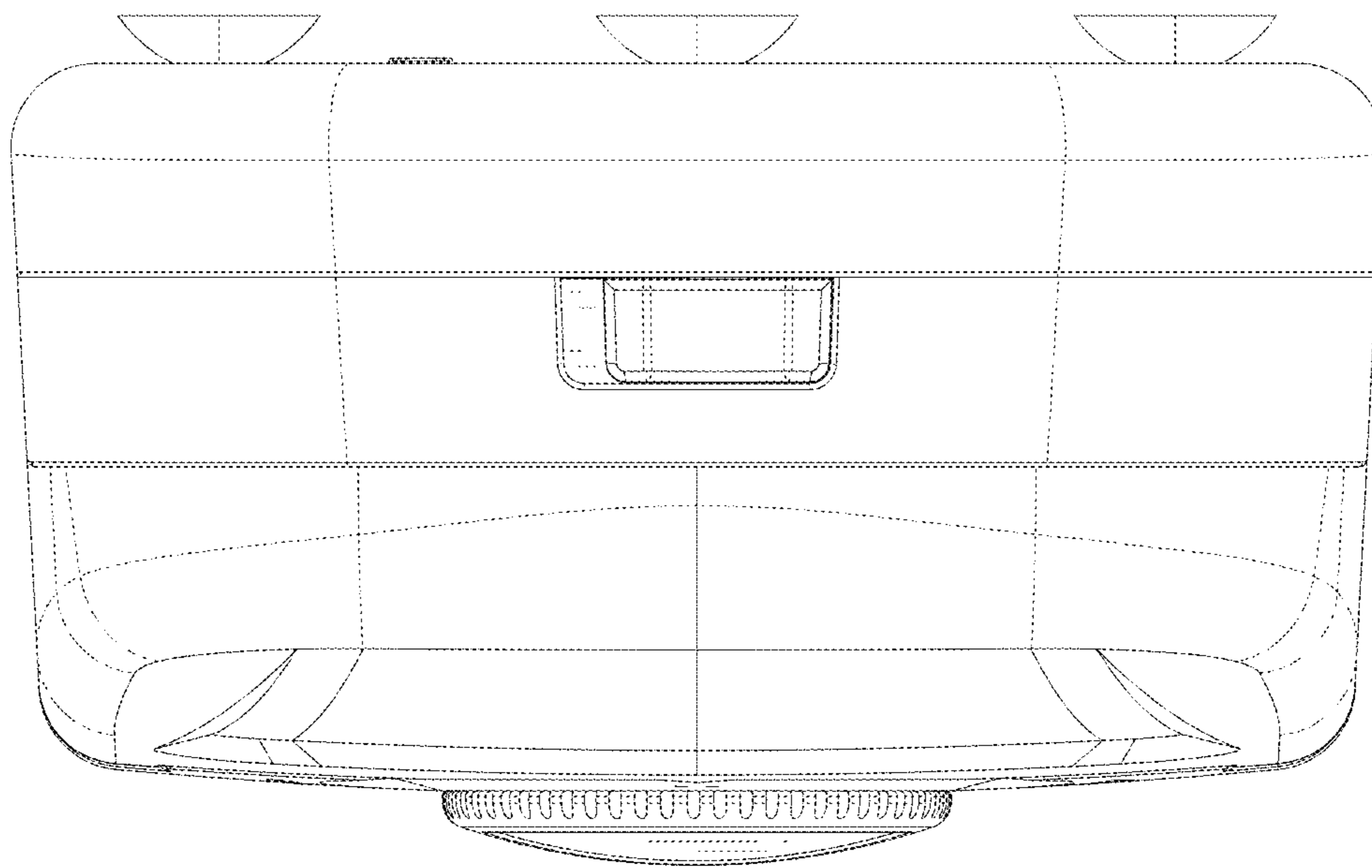
