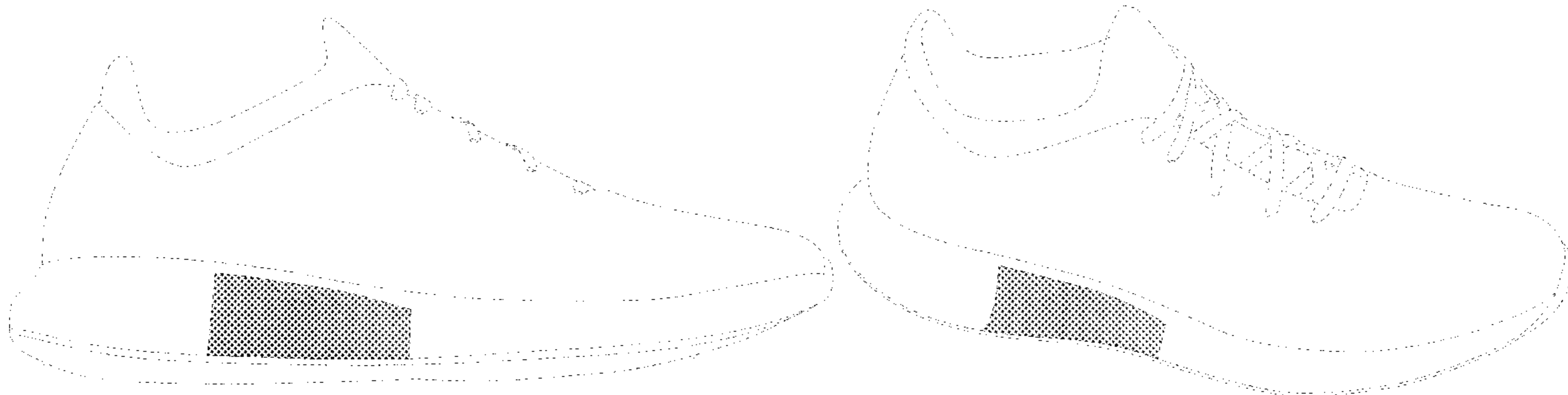
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a left side view of a shoe sole showing our new design;  
 FIG. 2 is a first perspective view thereof; and,

 The dash-dot-dash broken lines immediately adjacent the photographic area represents the bounds of the claimed design while all other broken lines are directed to environment. The broken lines form no part of the claimed design.

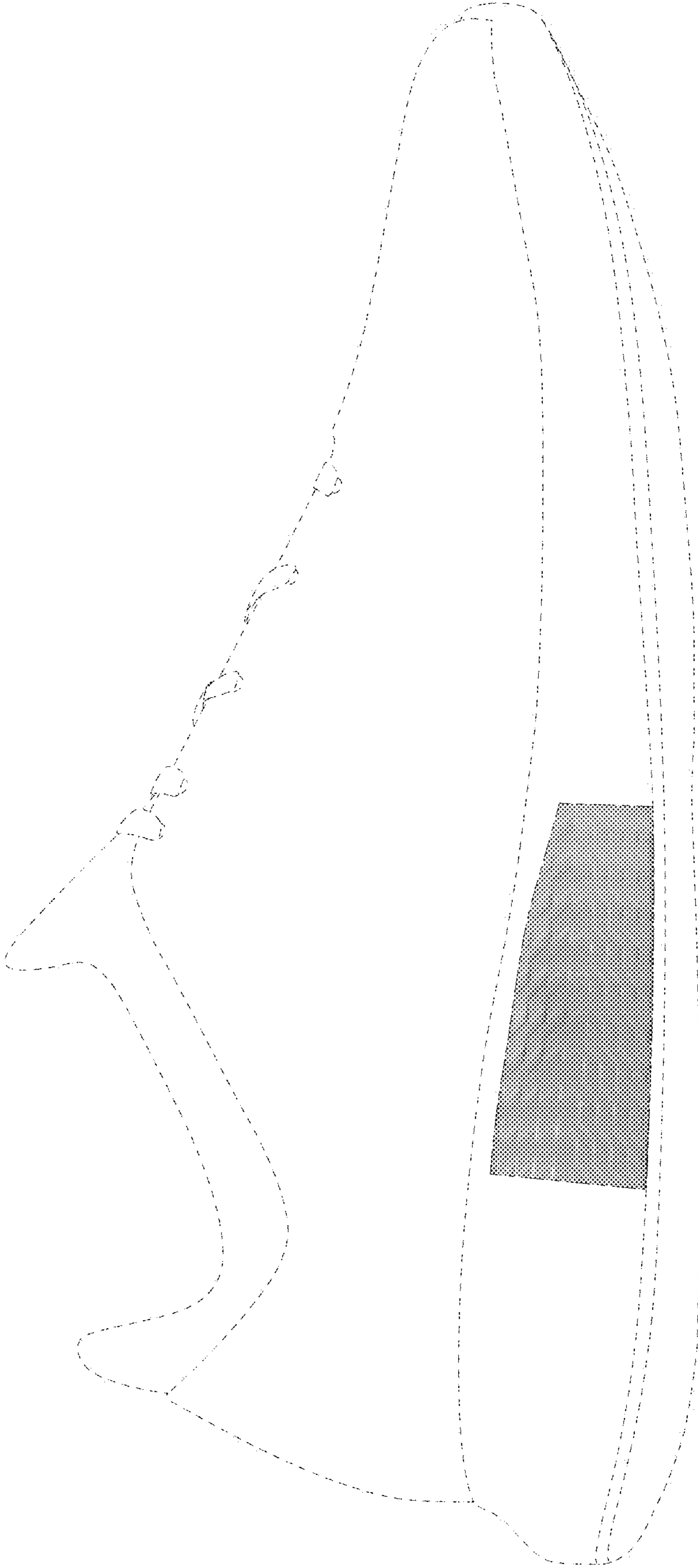

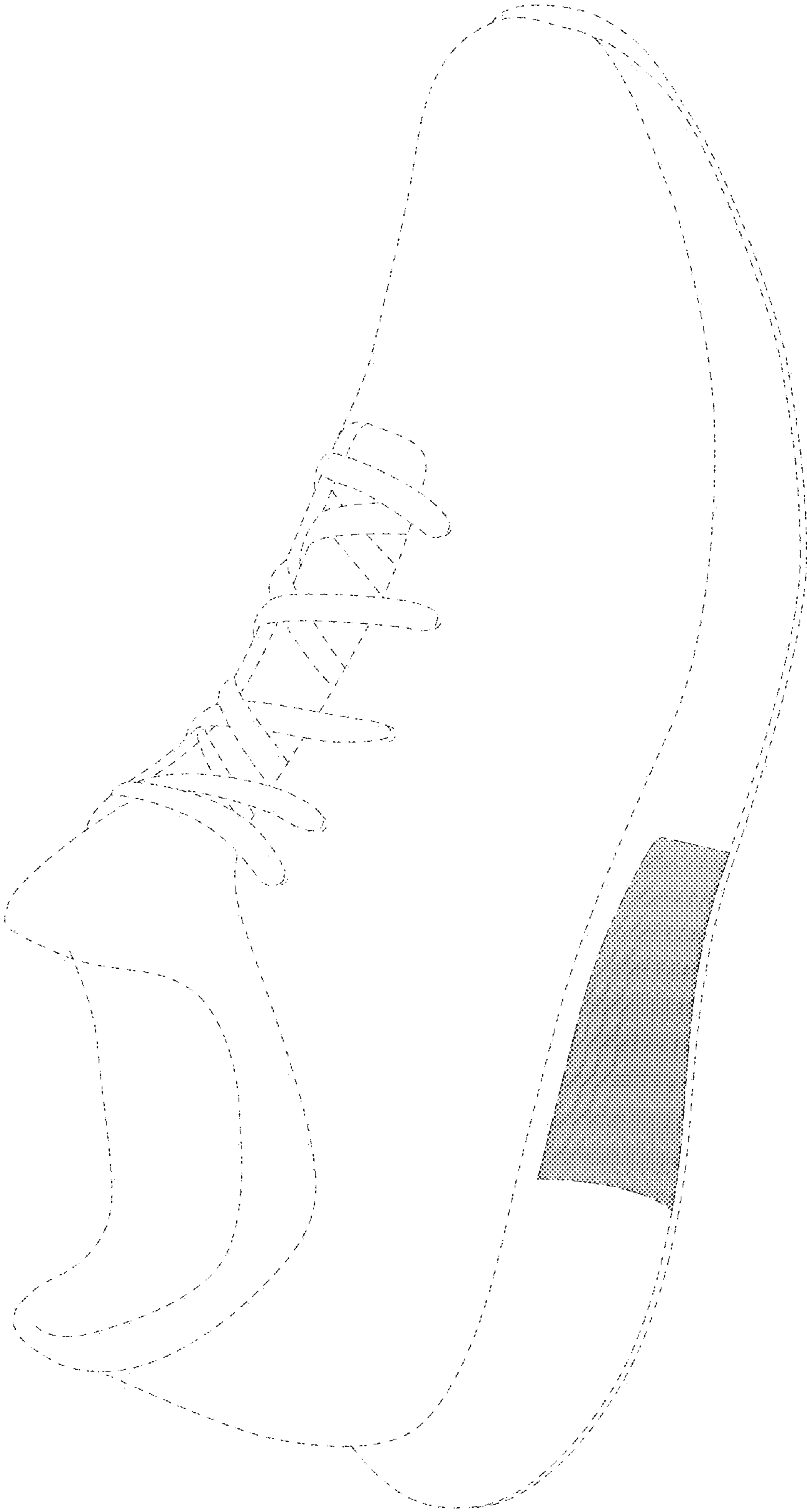

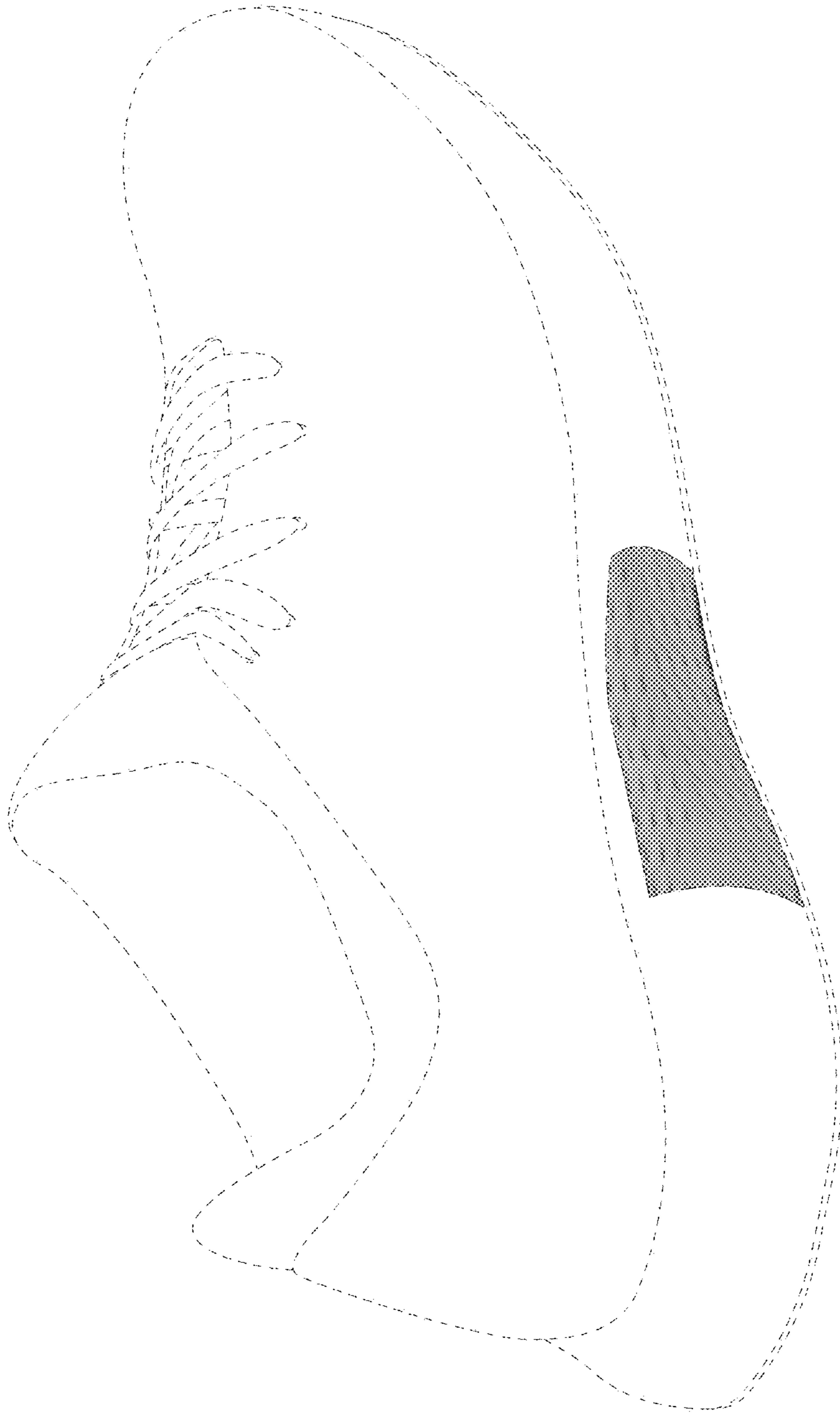
