(57) **CLAIM**

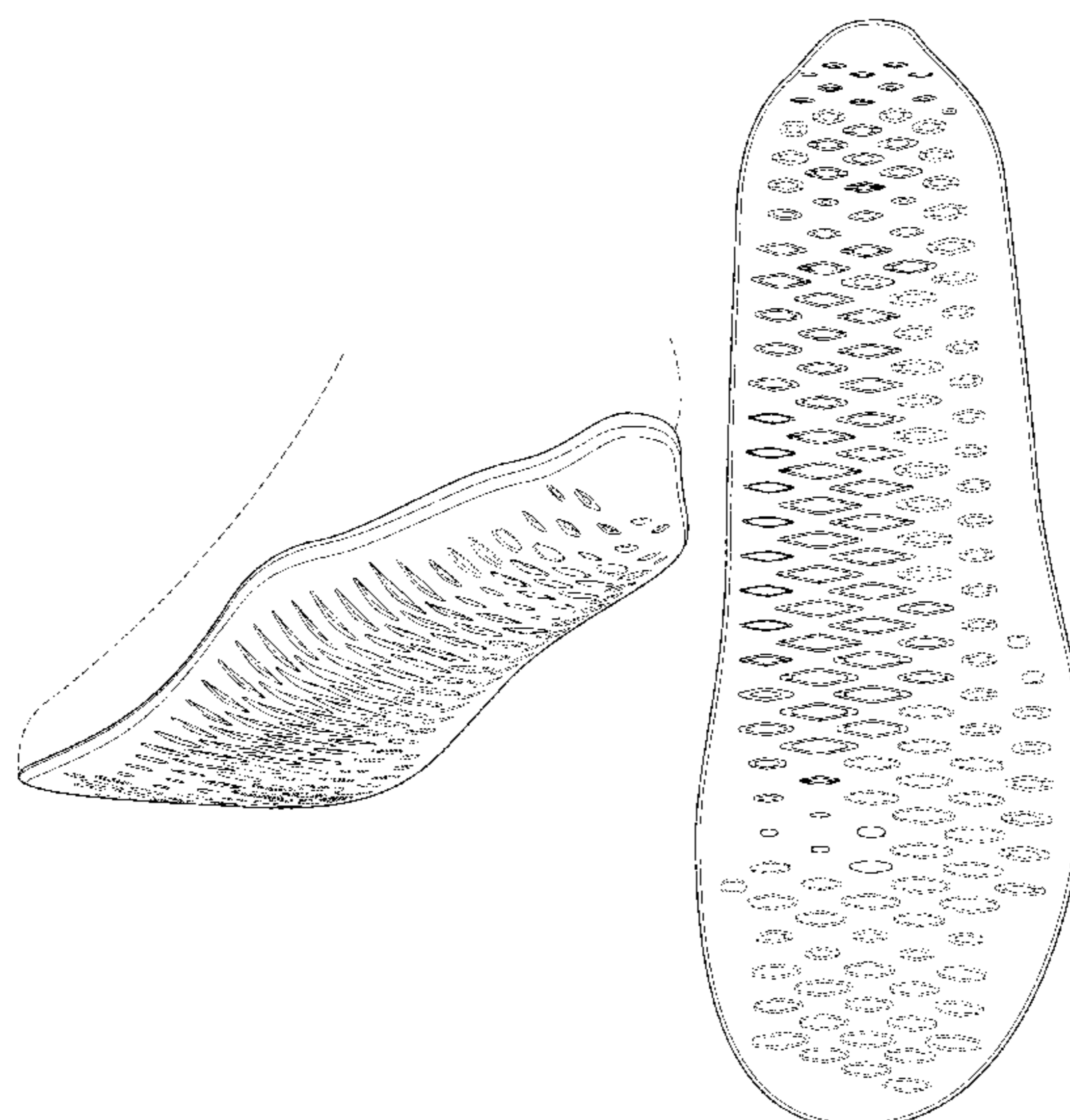
We claim the ornamental design for a sole for footwear, as shown and described.

**DESCRIPTION**

FIG. 1 shows a perspective view of an exemplary embodiment of a sole for footwear showing our new design; FIG. 2 shows a bottom view of the exemplary sole for footwear illustrated in FIG. 1; FIG. 3 shows a right side view of the exemplary sole for footwear illustrated in FIG. 1; FIG. 4 shows a left side view of the exemplary sole for footwear illustrated in FIG. 1; FIG. 5 shows a front view of the exemplary sole for footwear illustrated in FIG. 1; and, FIG. 6 shows a rear view of the exemplary sole for footwear illustrated in FIG. 1.

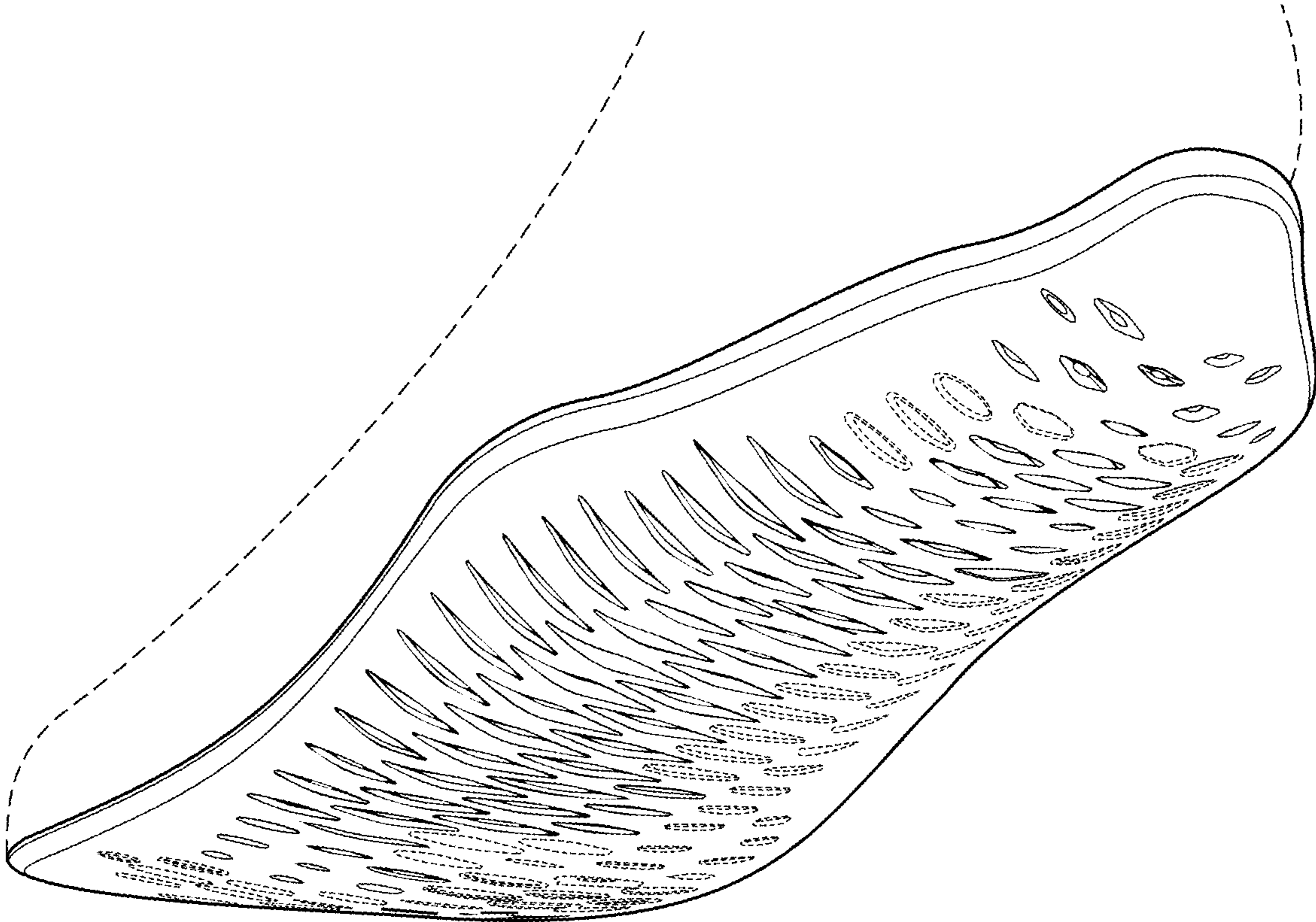

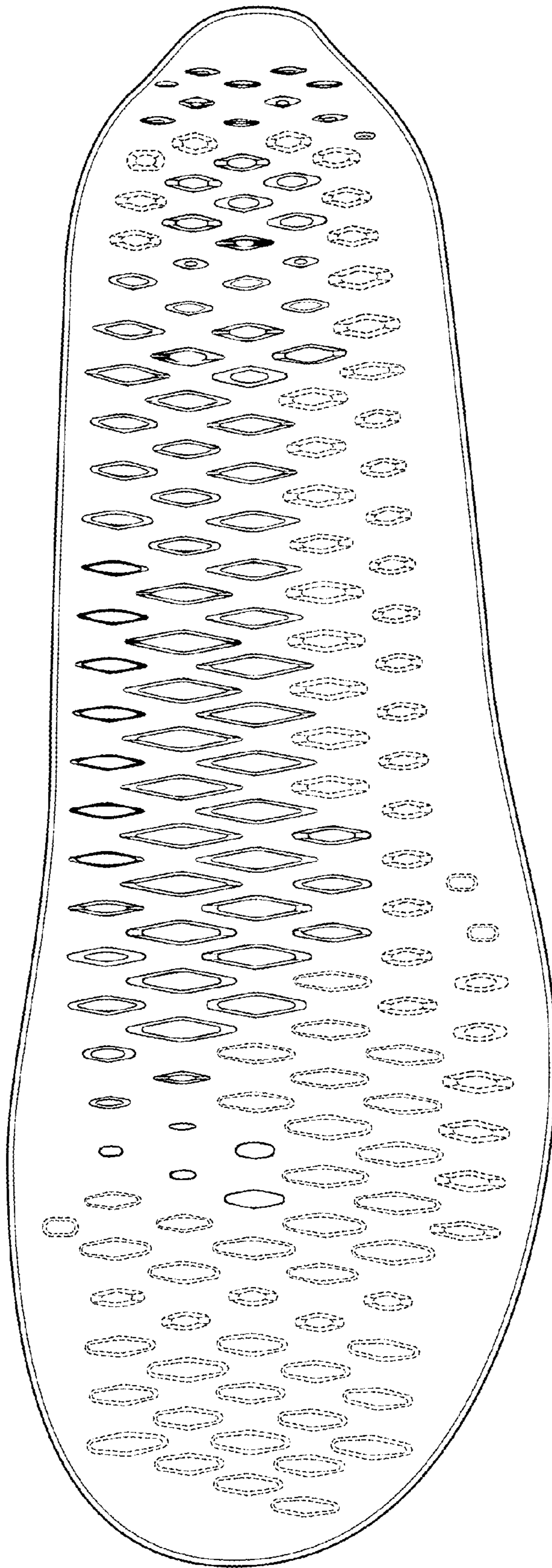

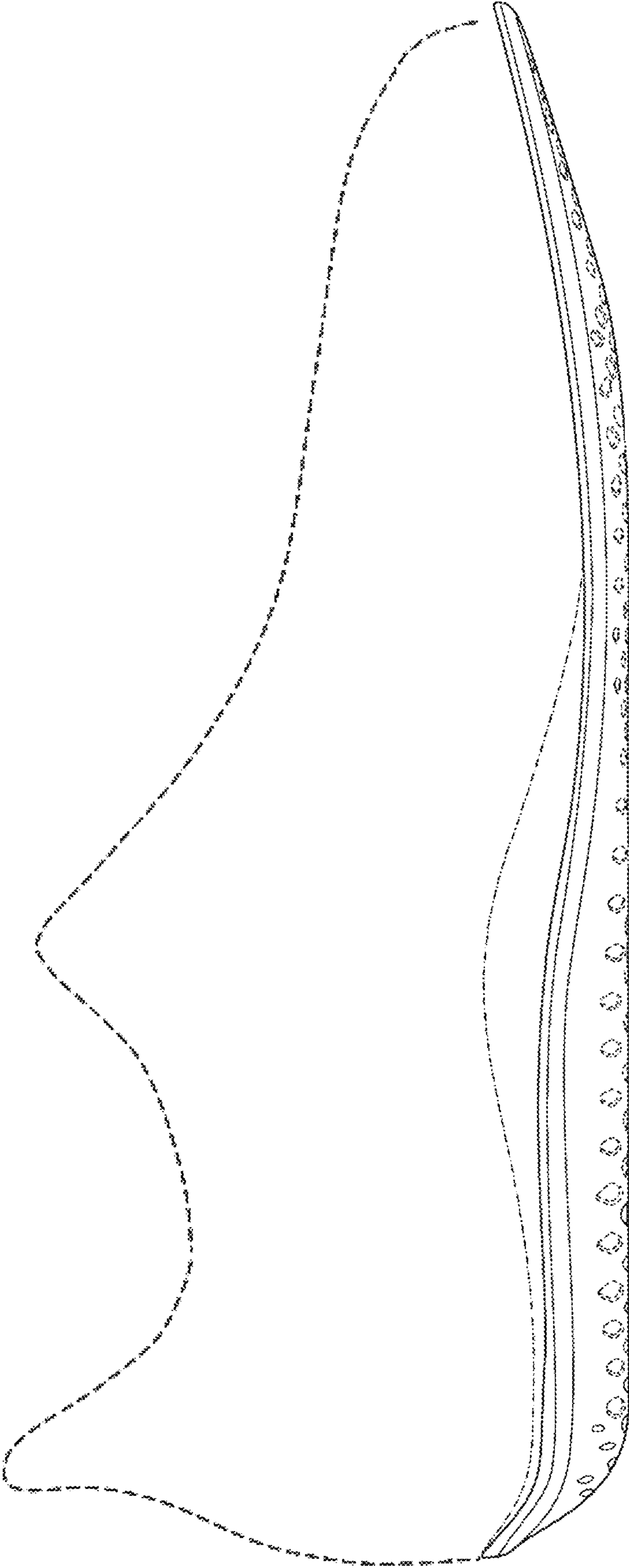

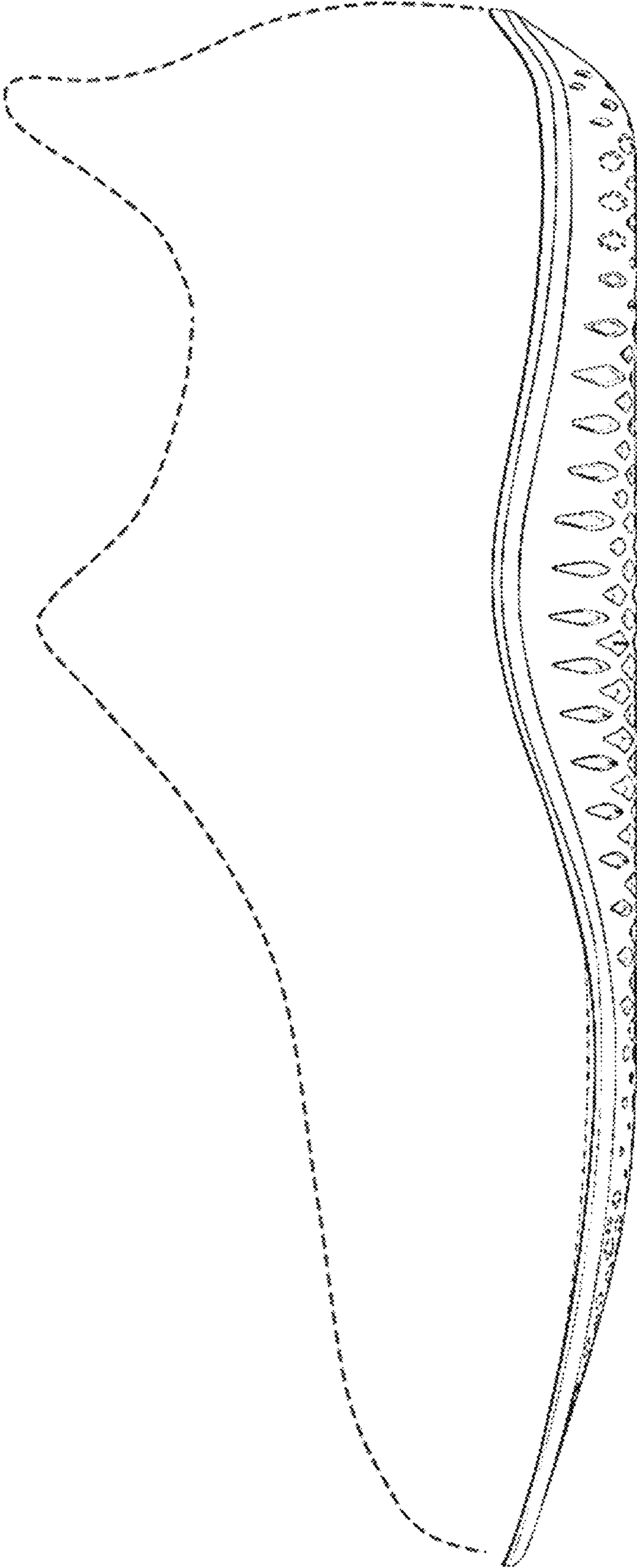
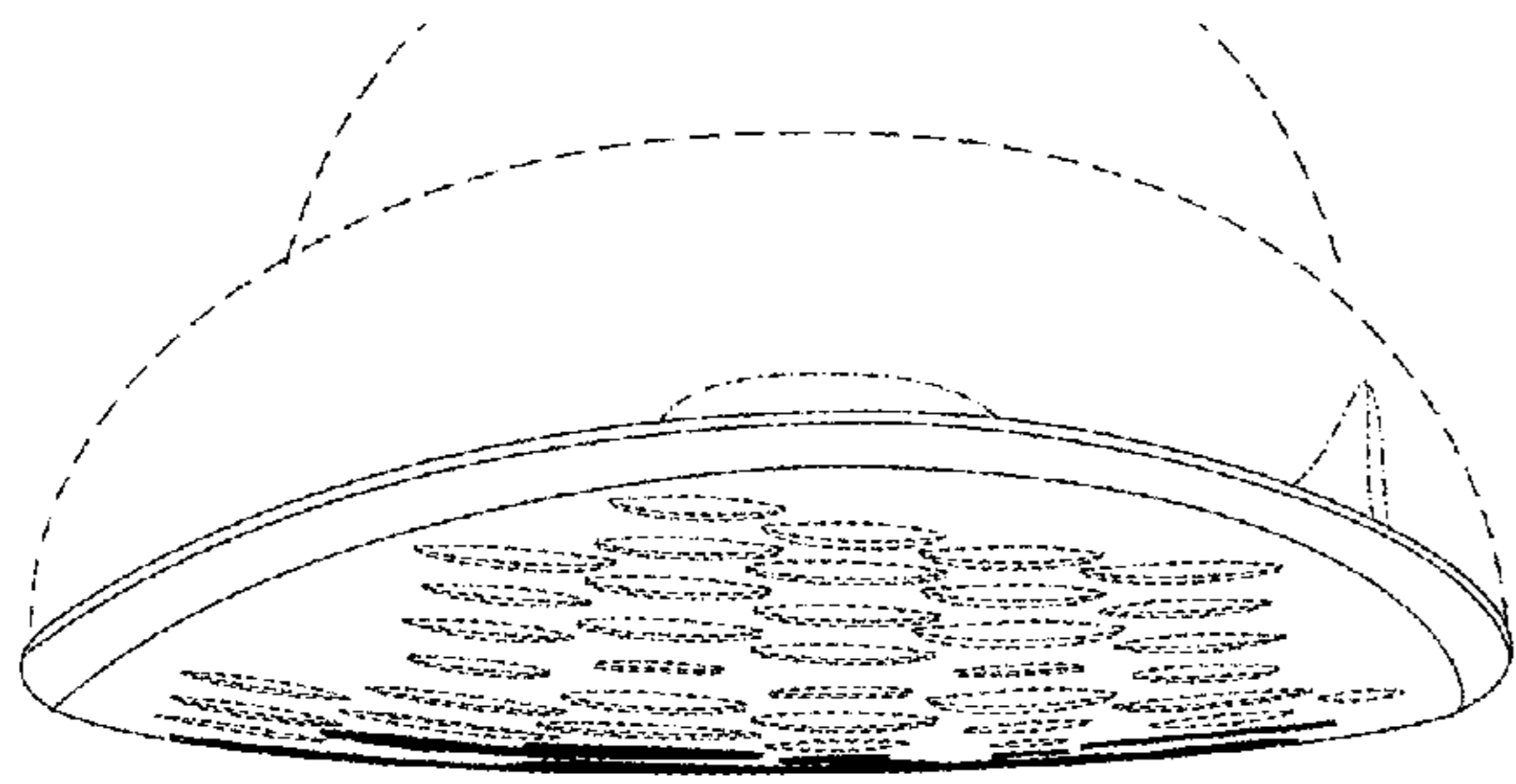
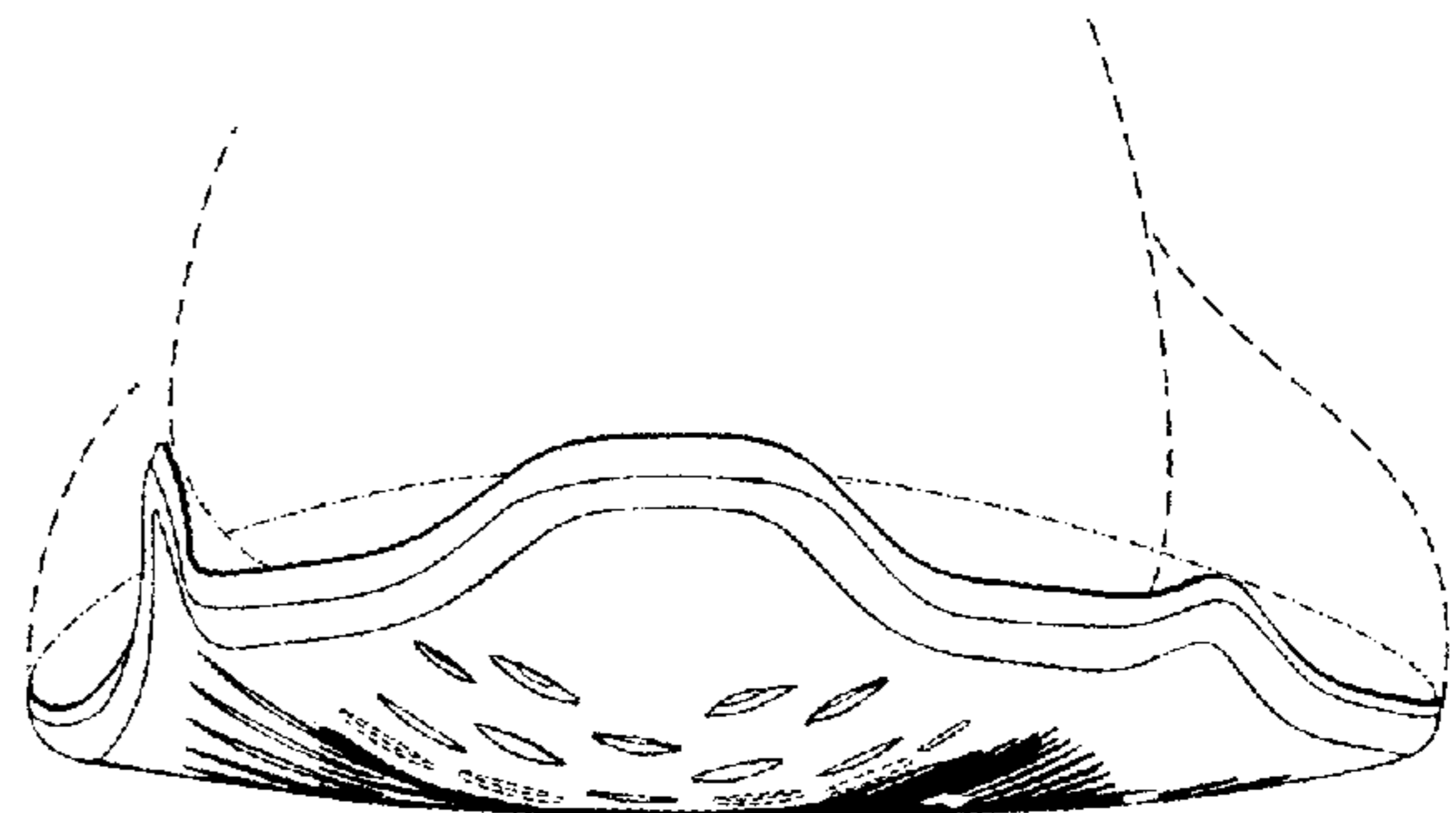
