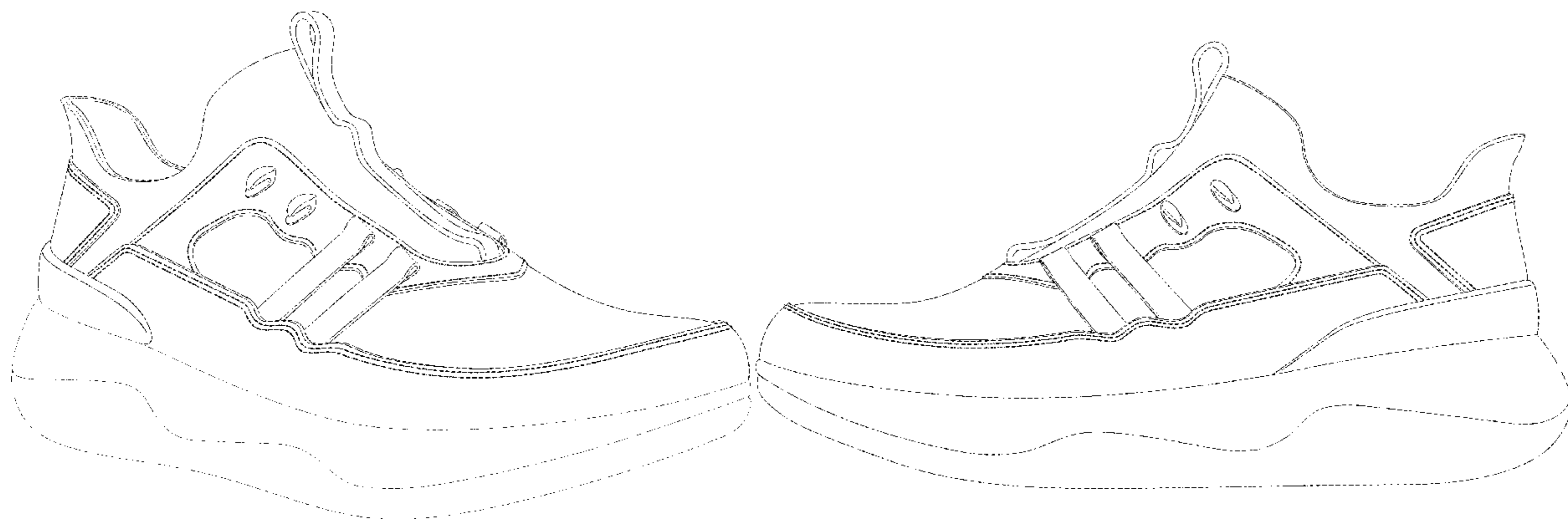
The ornamental design for a footwear upper, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the footwear upper embodying the new design;
FIG. 2 is a top view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a front perspective view thereof; and,
FIG. 6 is a rear perspective view thereof.

The dot-dash broken lines in the figures show features of an article of footwear that form no part of the claimed design. Further, the dot-dash broken lines immediately adjacent the

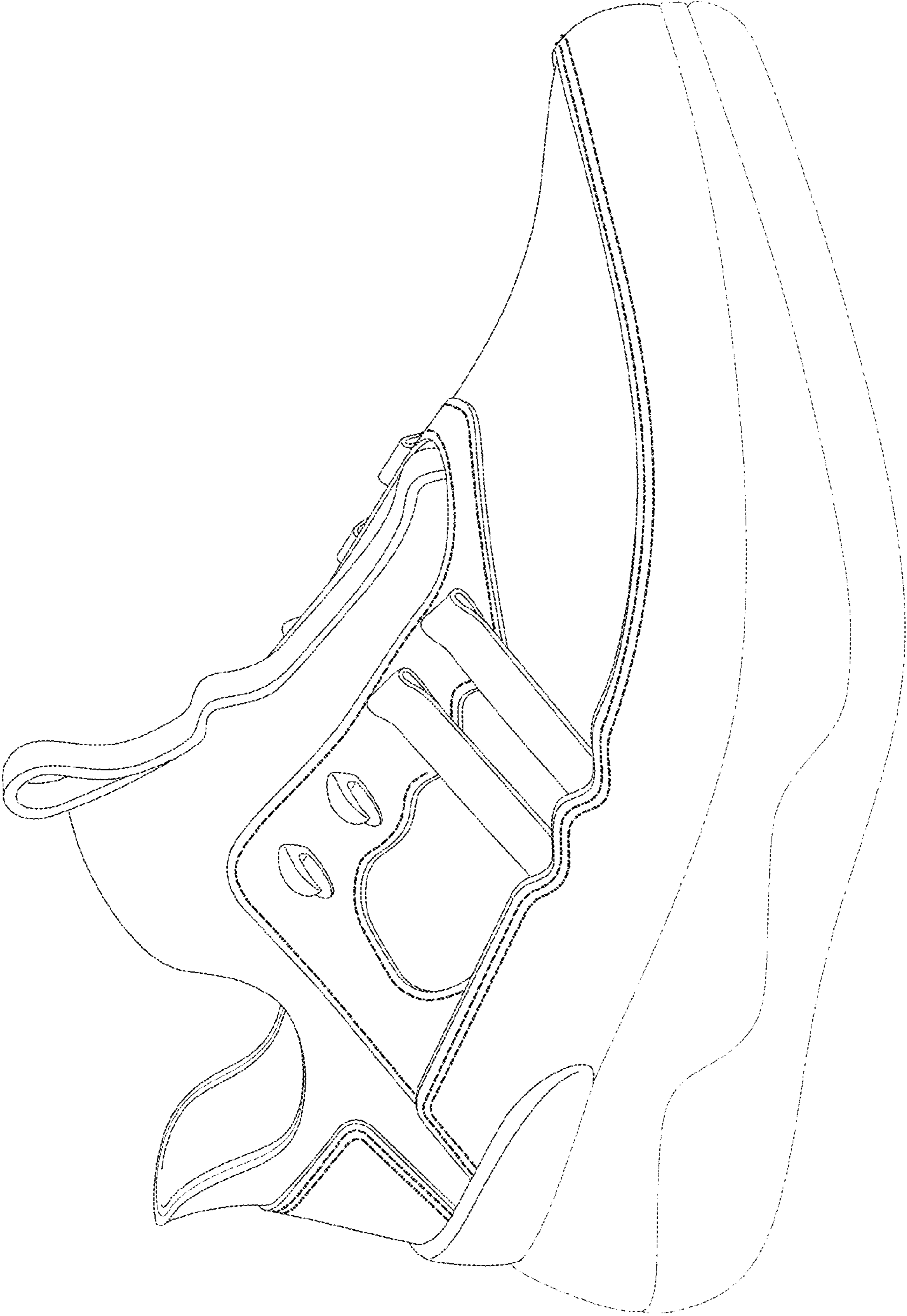

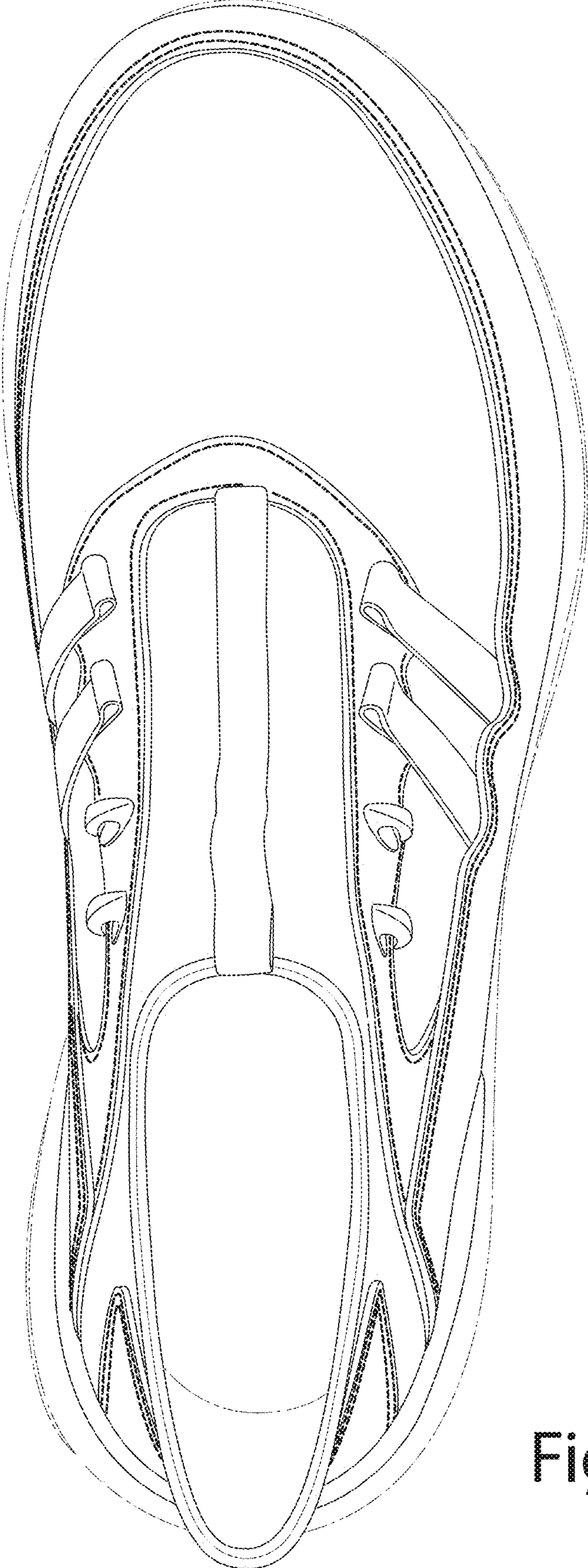

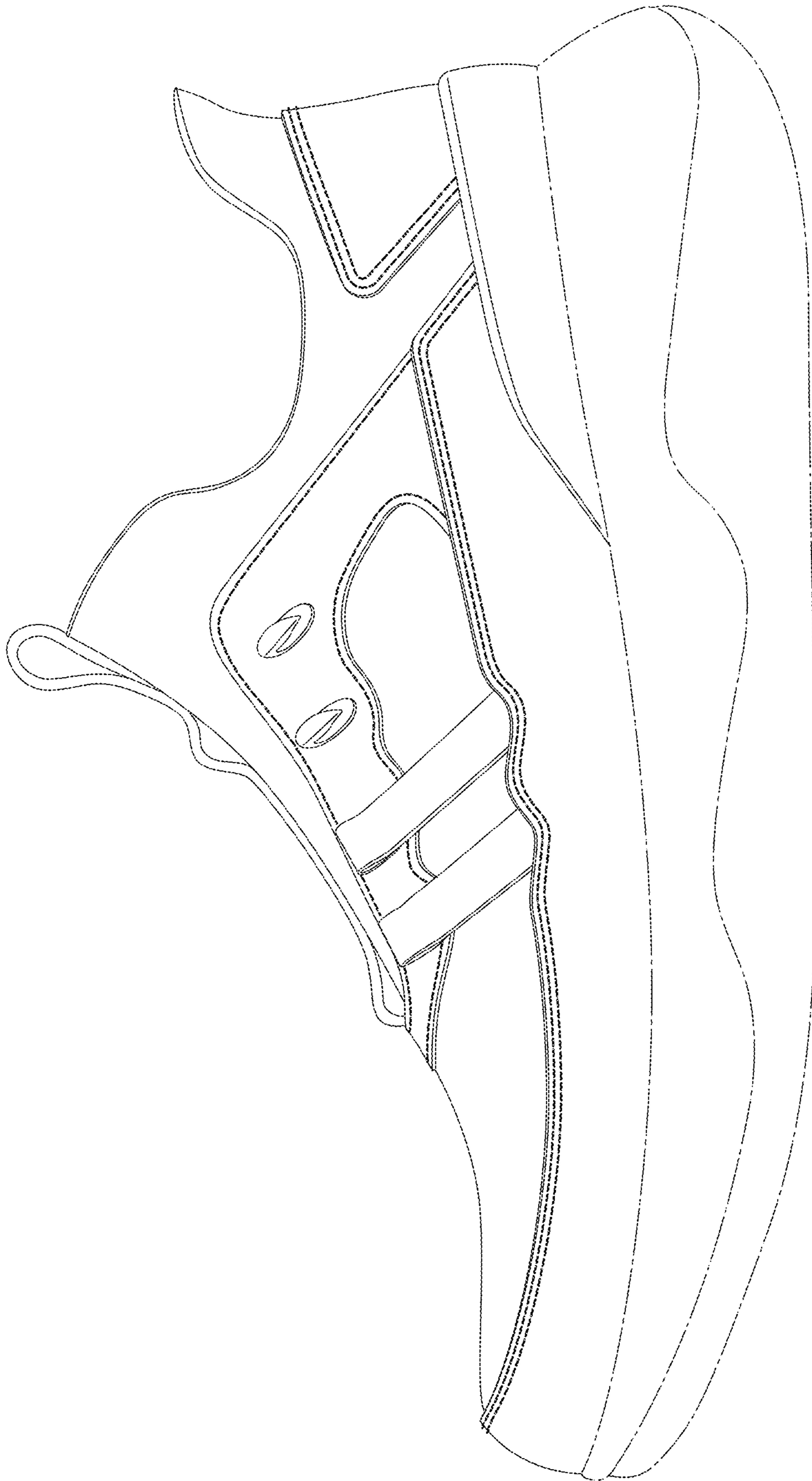

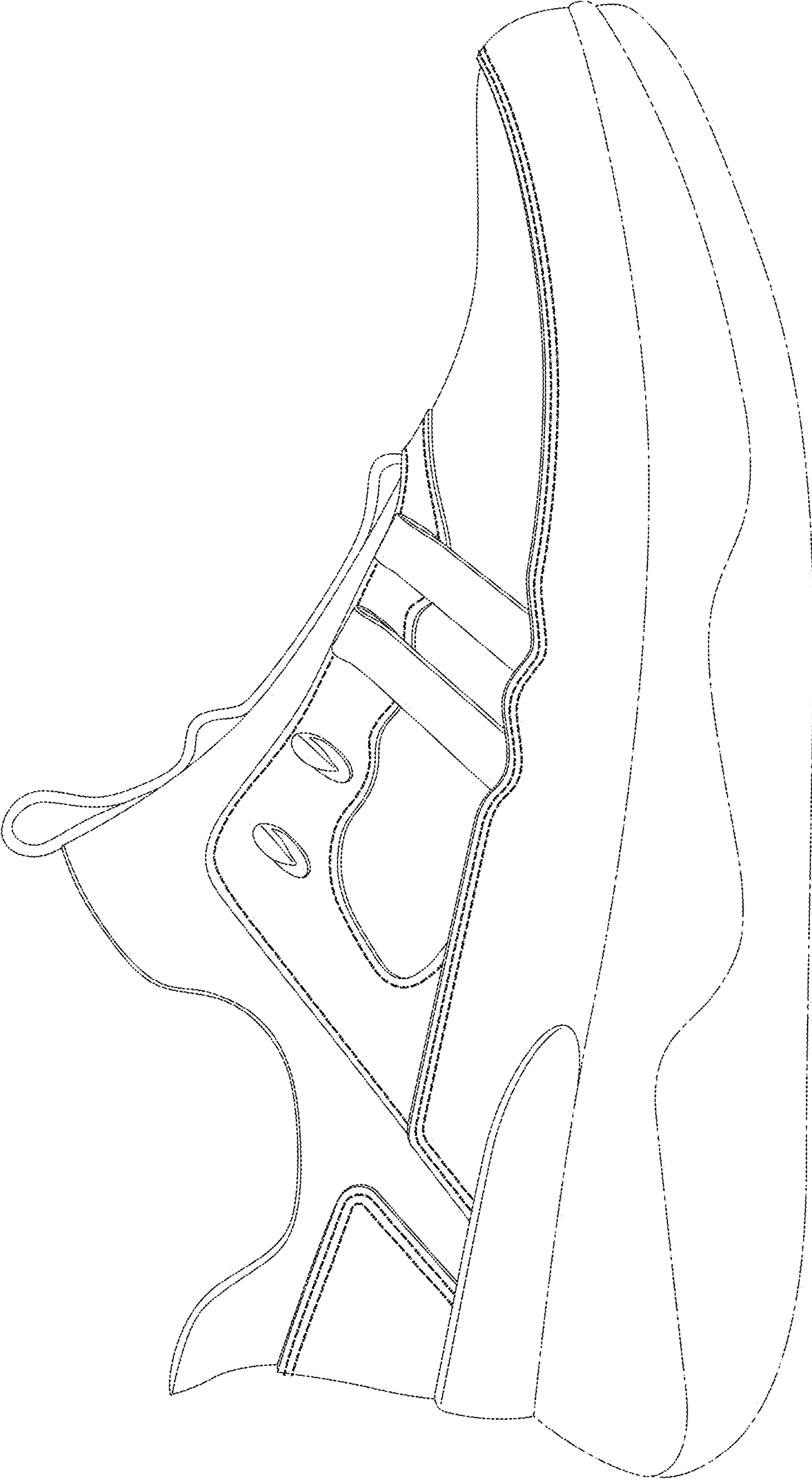

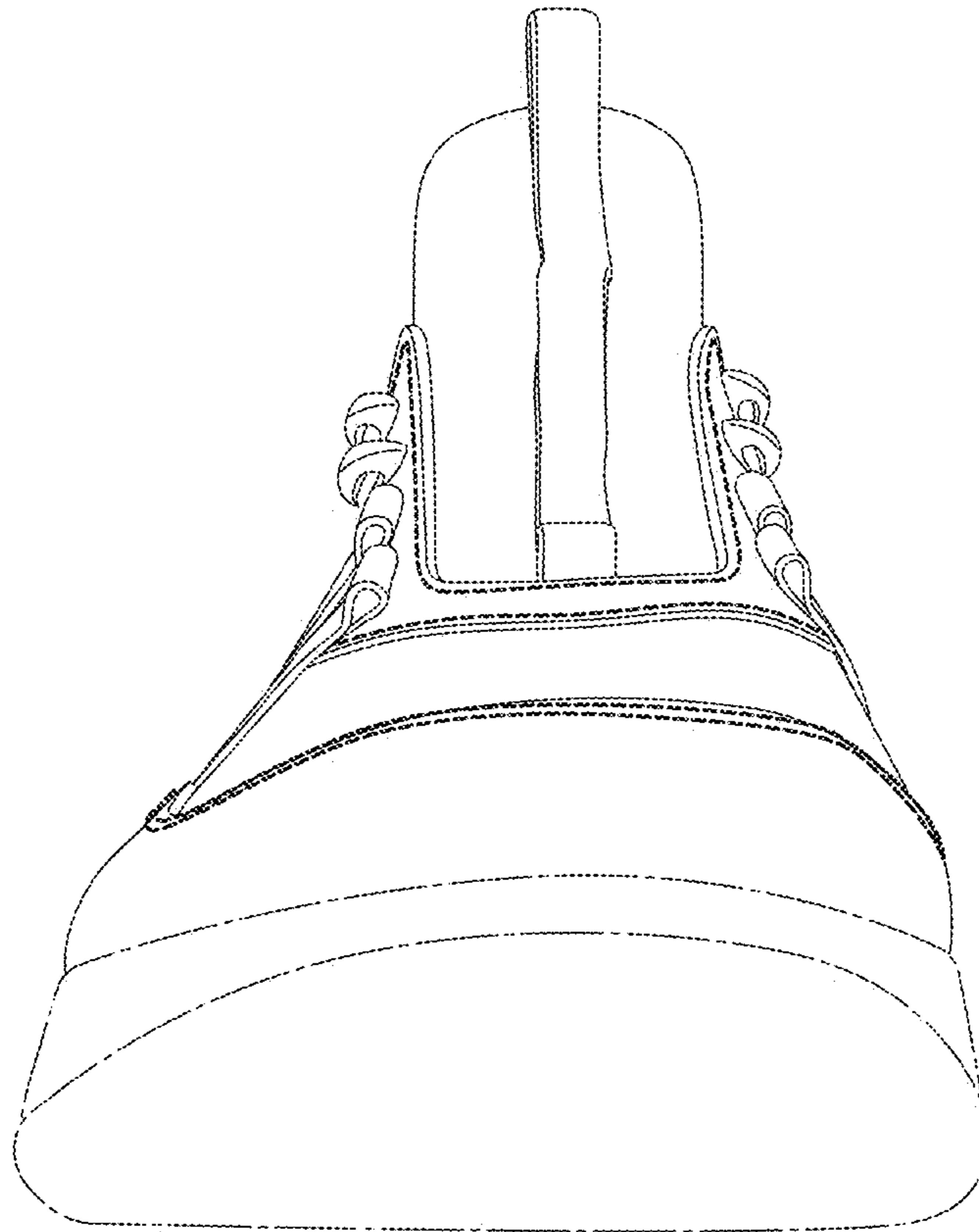

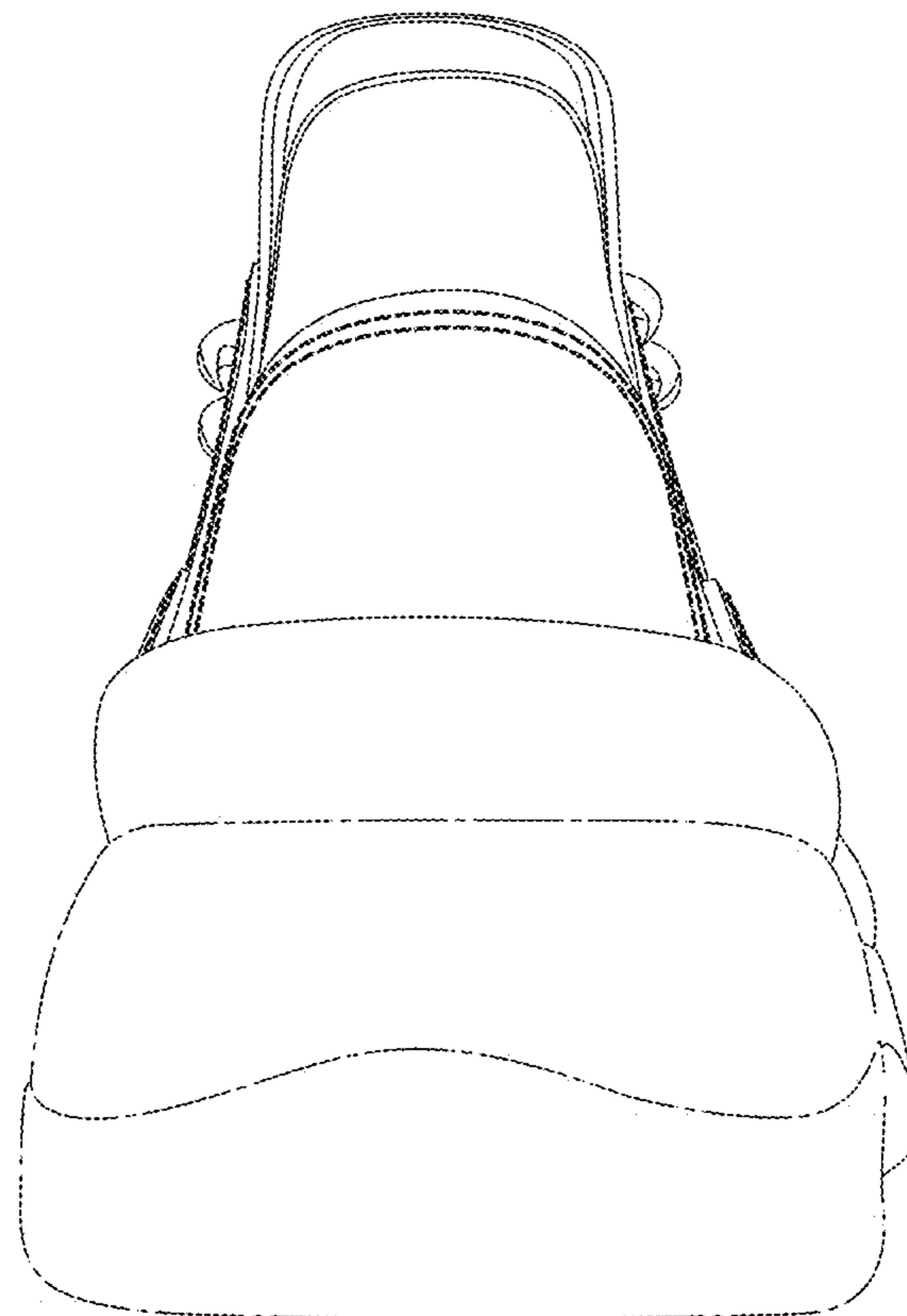
