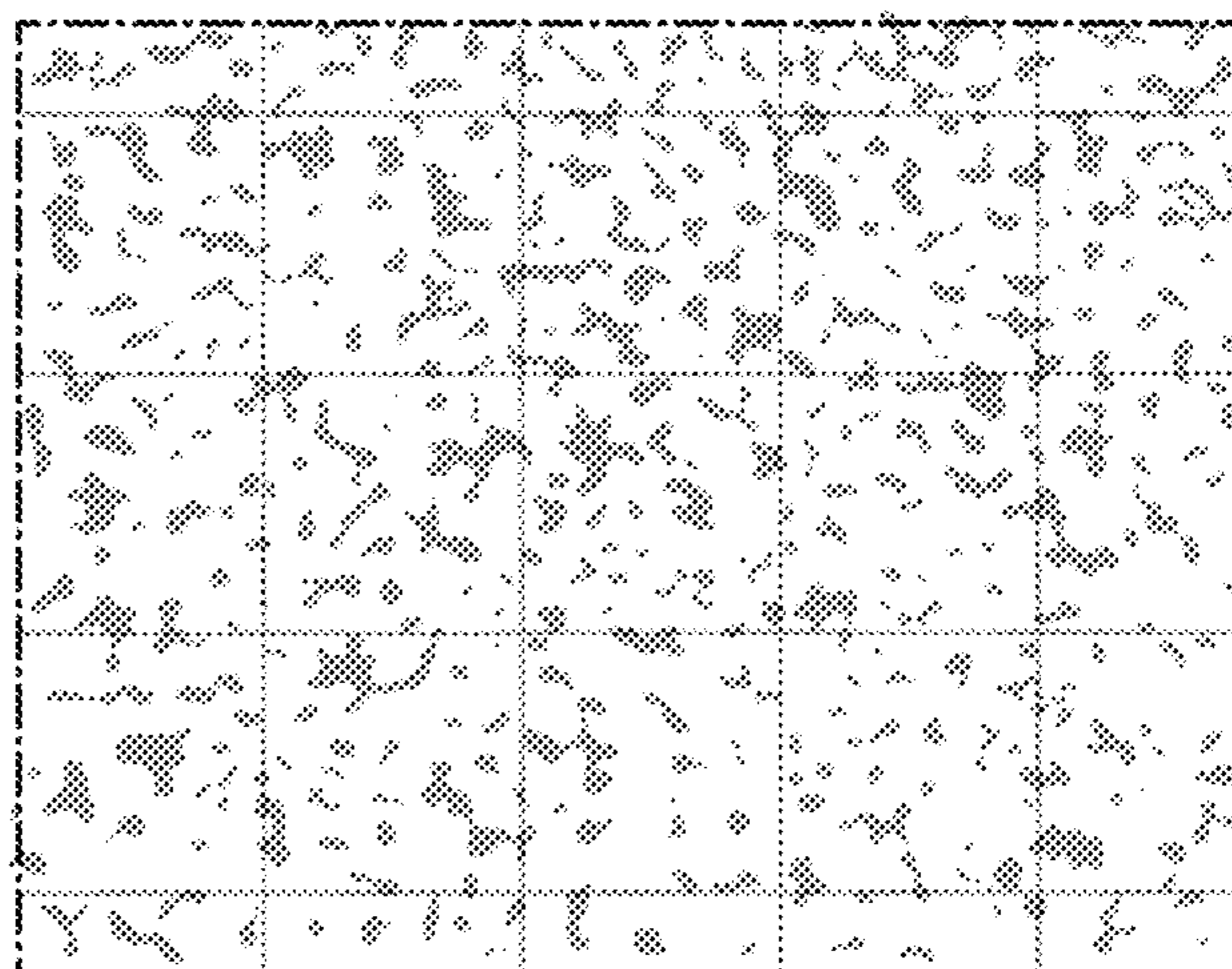
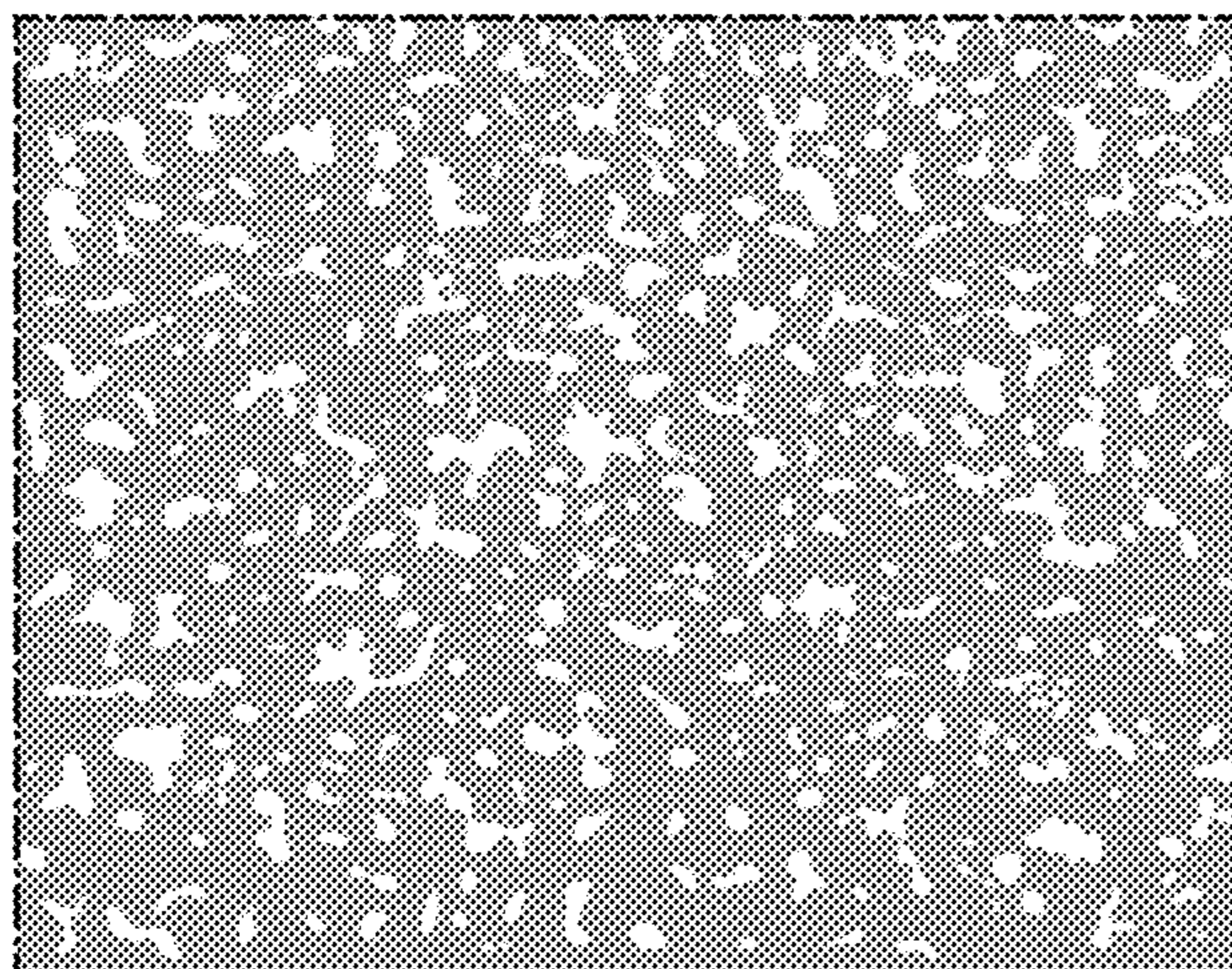
(57) **CLAIM**

The ornamental design for a film sheet for antiballistic articles, as shown and described.

**DESCRIPTION**

FIG. 1 is a top plan view of a first embodiment of a film sheet for antiballistic articles showing our new design, the bottom plan view being unornamented;  
FIG. 2 is a top perspective view thereof;  
FIG. 3 is a top plan view of a second embodiment of a film sheet for antiballistic articles showing our new design, the bottom plan view being unornamented;  
FIG. 4 is a top perspective view thereof;  
FIG. 5 is a top plan view of a third embodiment of a film sheet for antiballistic articles showing our new design, the bottom plan view being unornamented;  
FIG. 6 is a top perspective view thereof;  
FIG. 7 is a top plan view of a fourth embodiment of a film sheet for antiballistic articles showing our new design, the bottom plan view being unornamented; and,  
FIG. 8 is a top perspective view thereof.

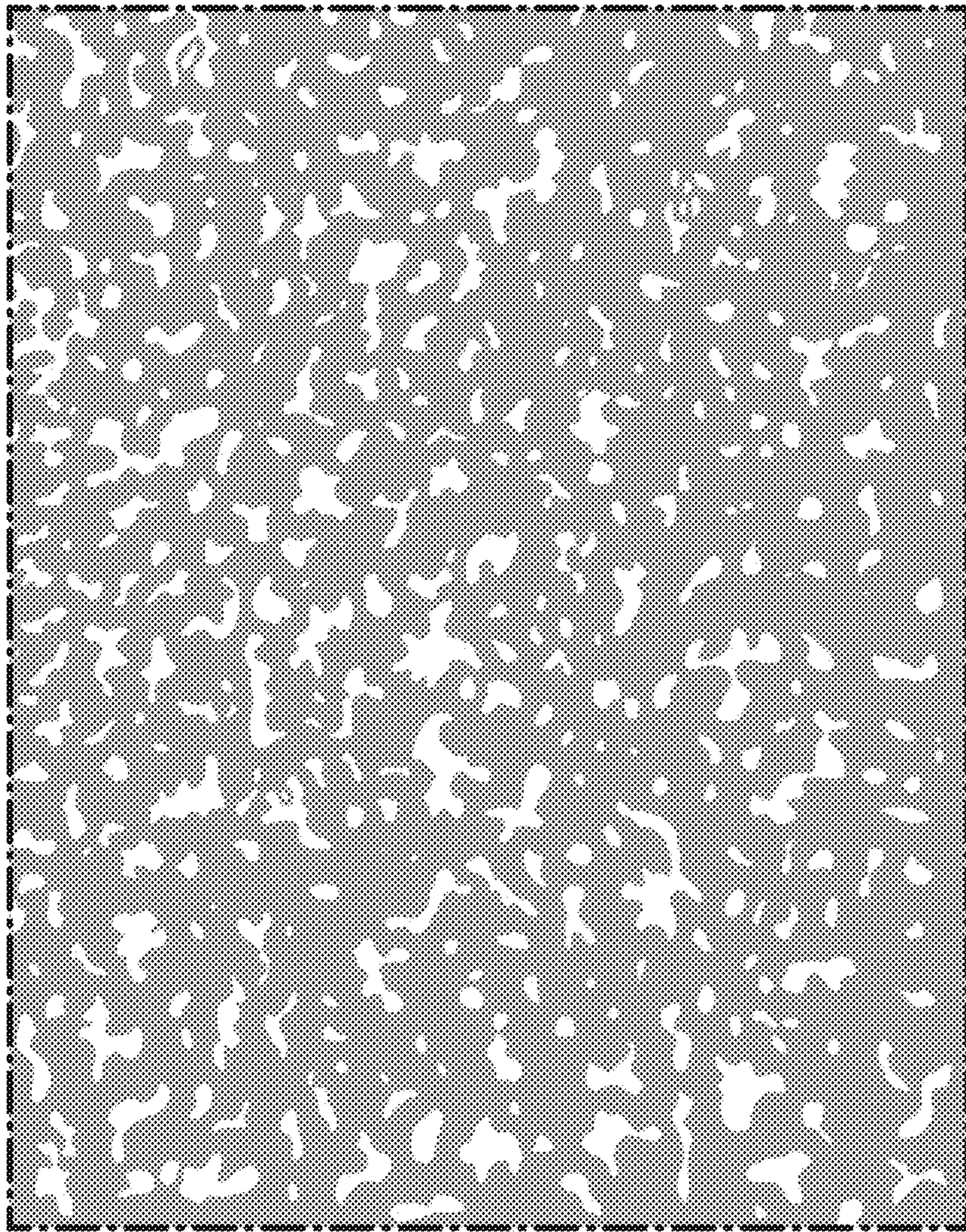

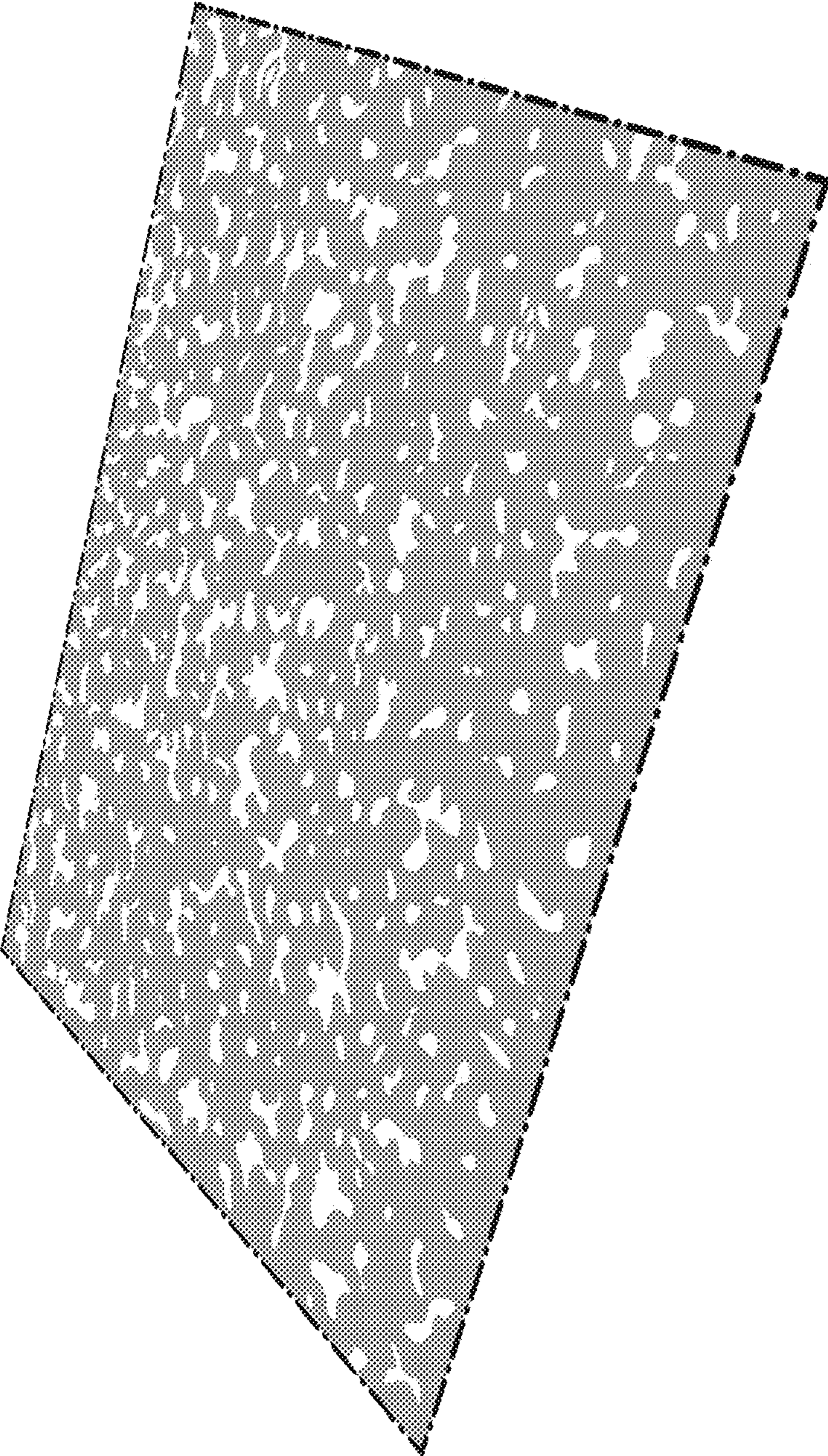

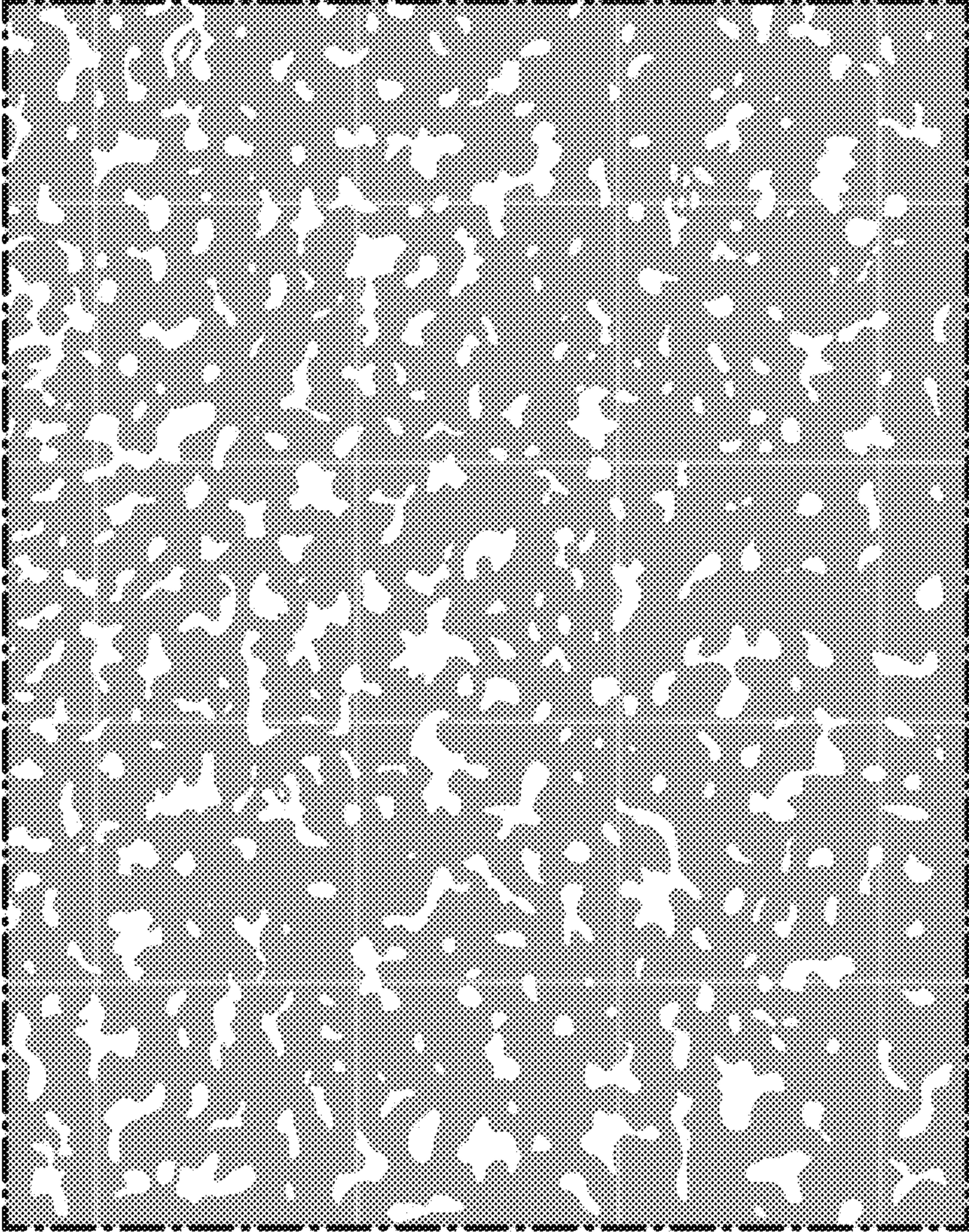

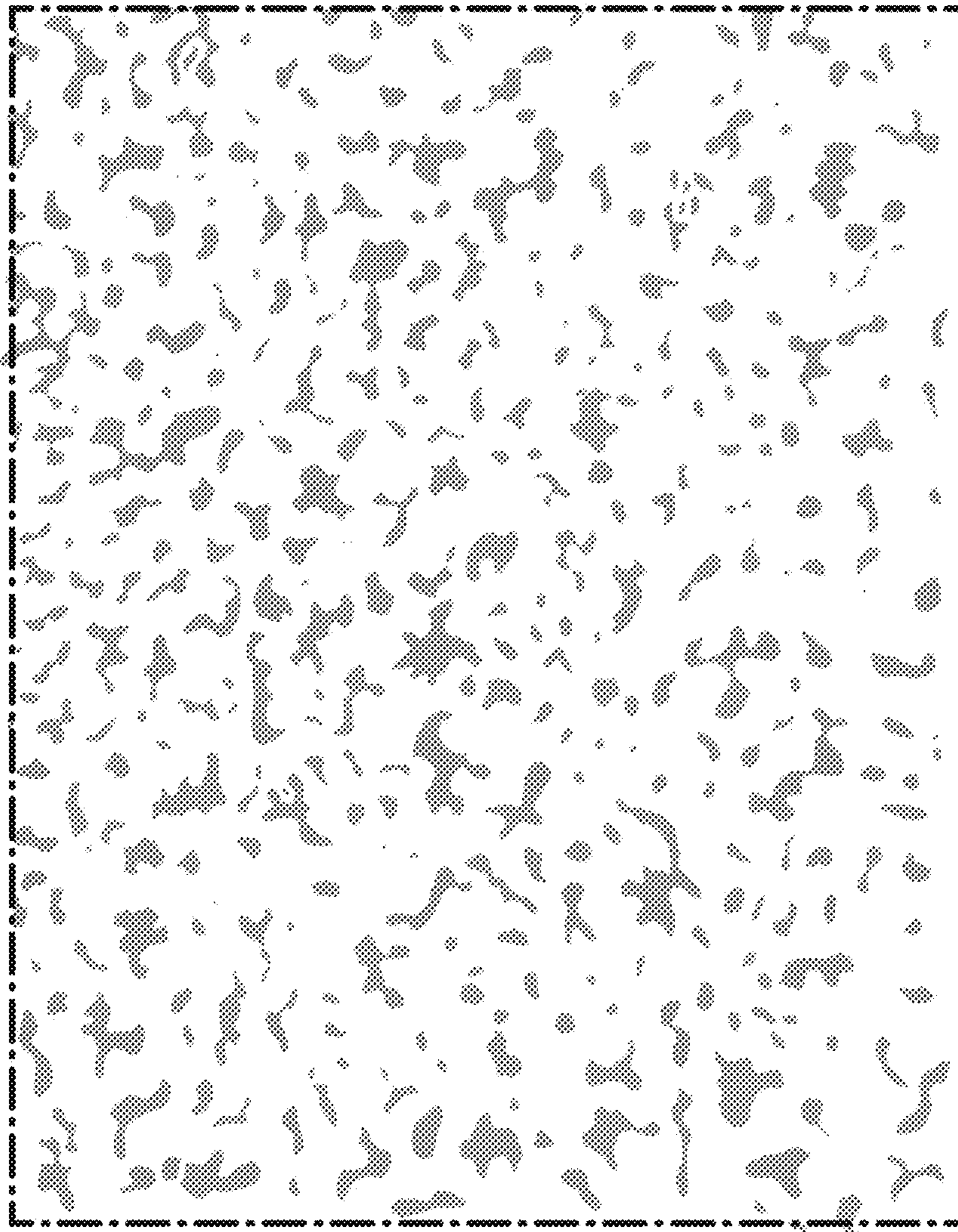

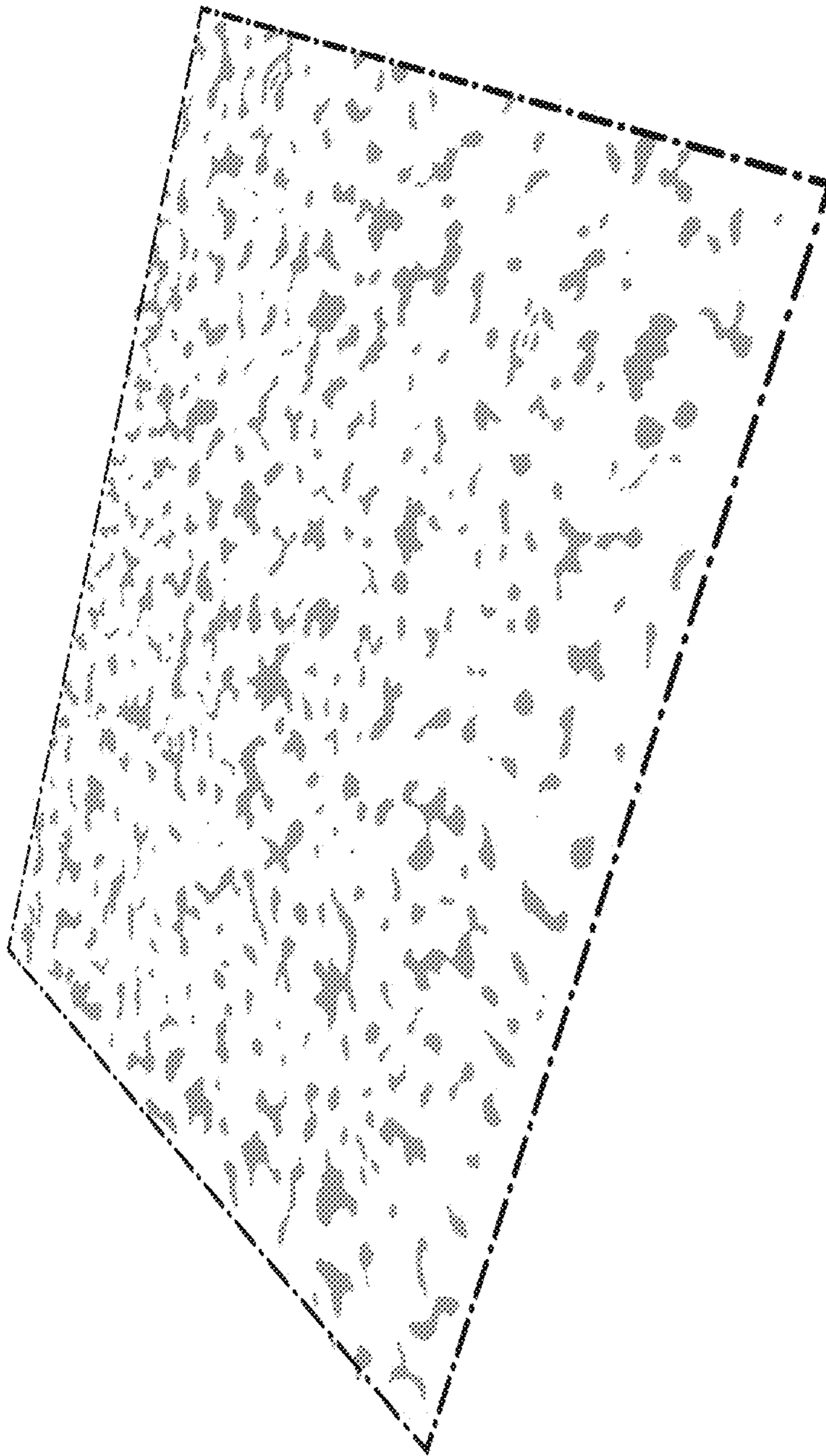

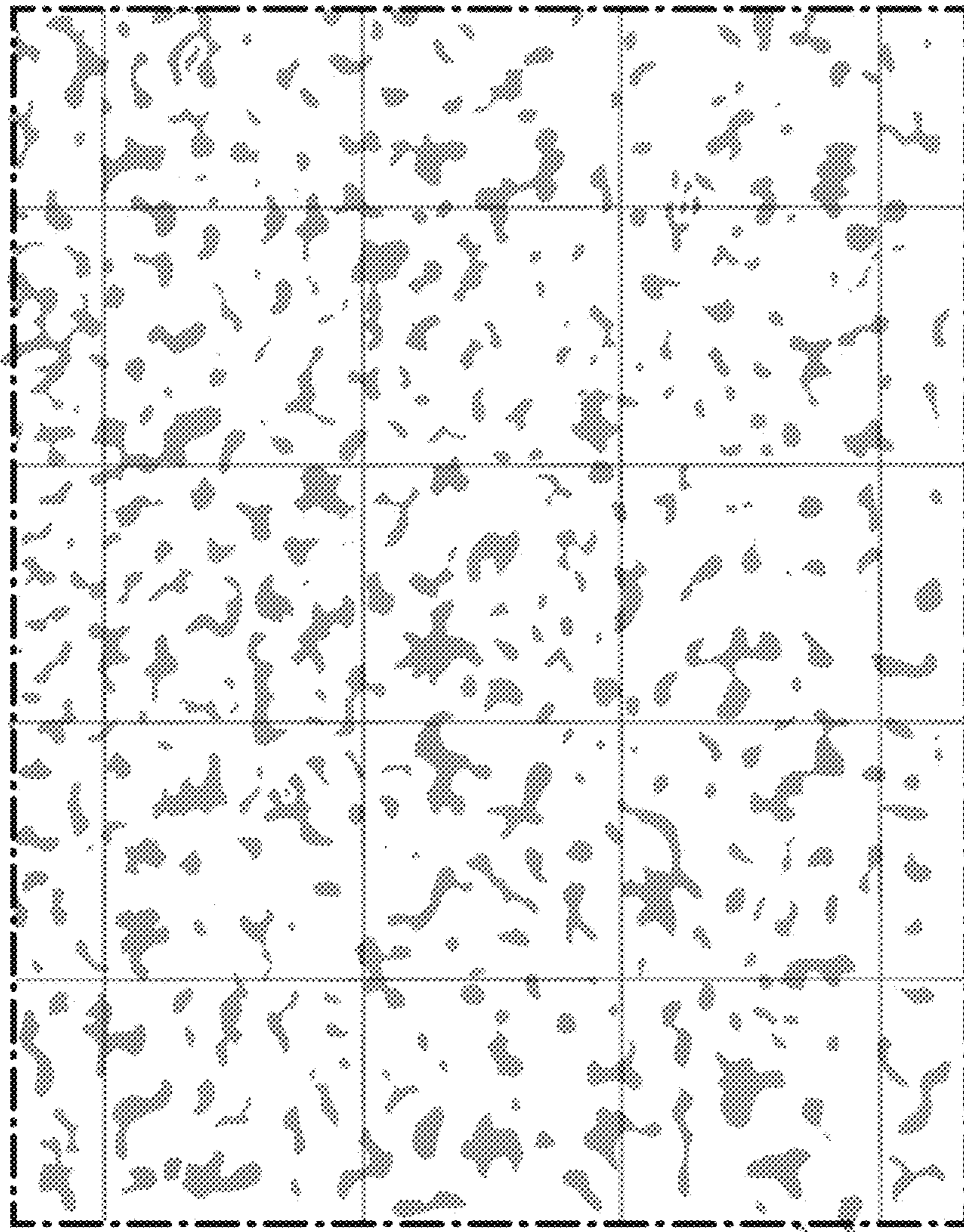

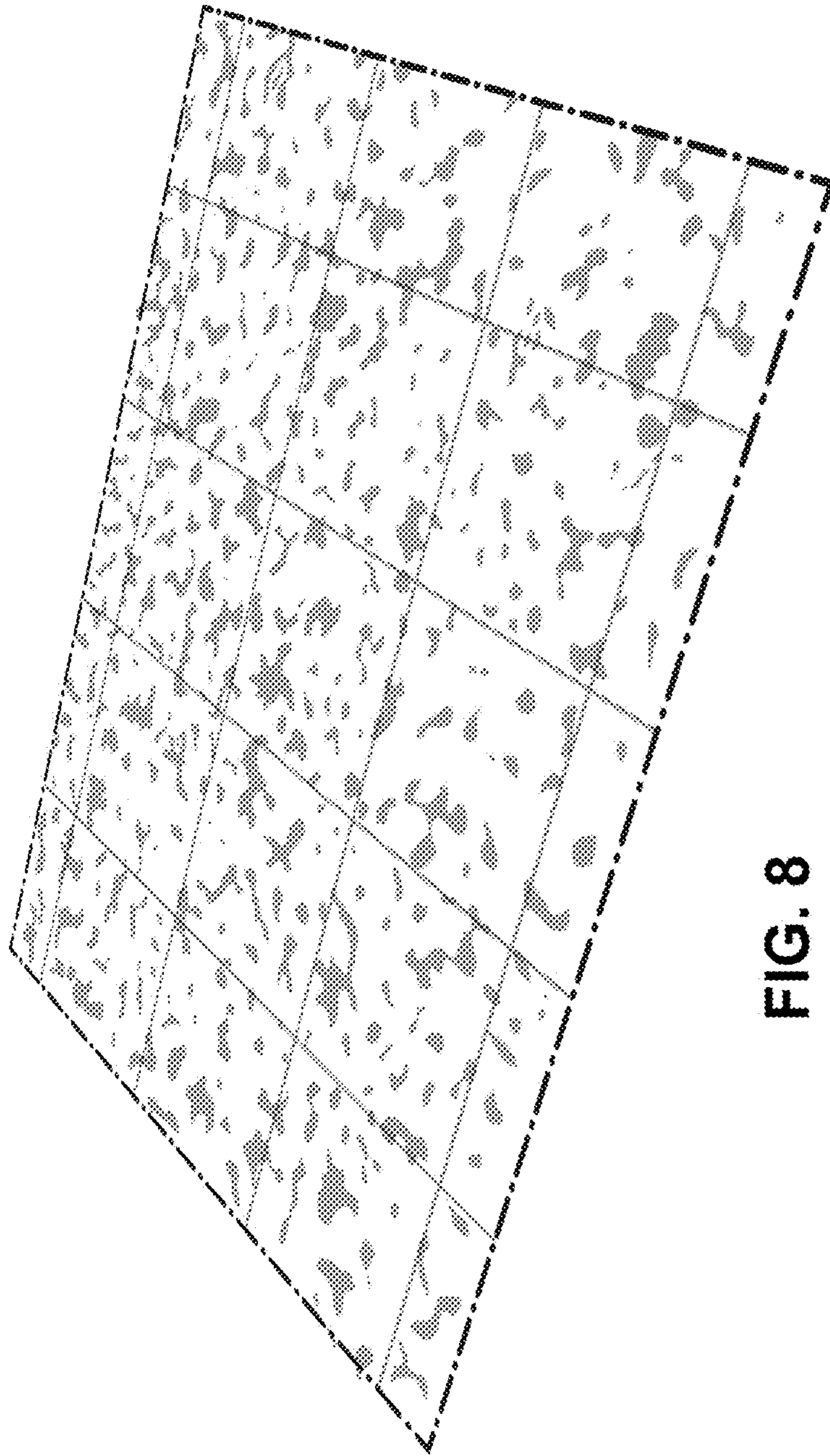
