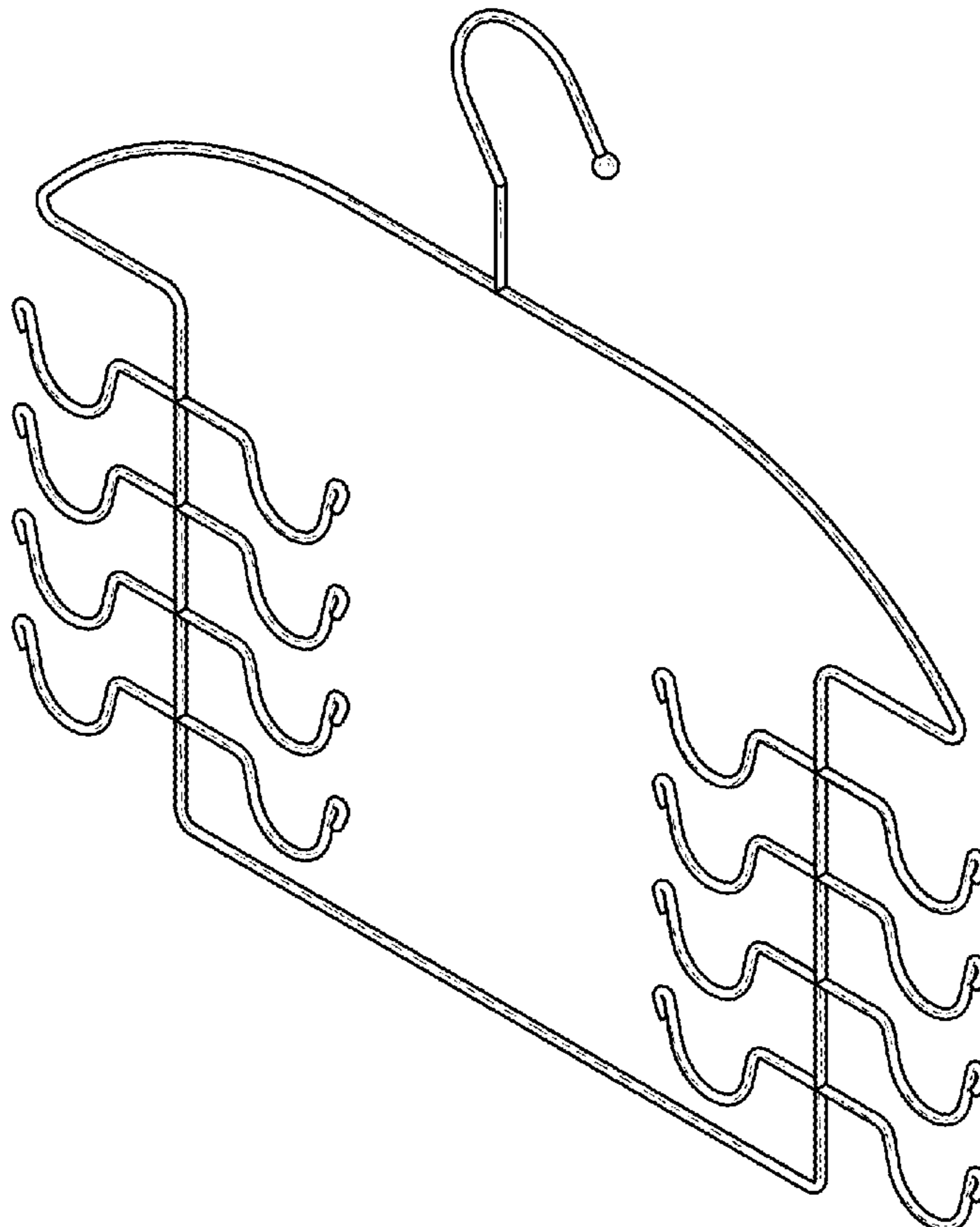
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top-front-left perspective view of a tank top hanger showing my new design;

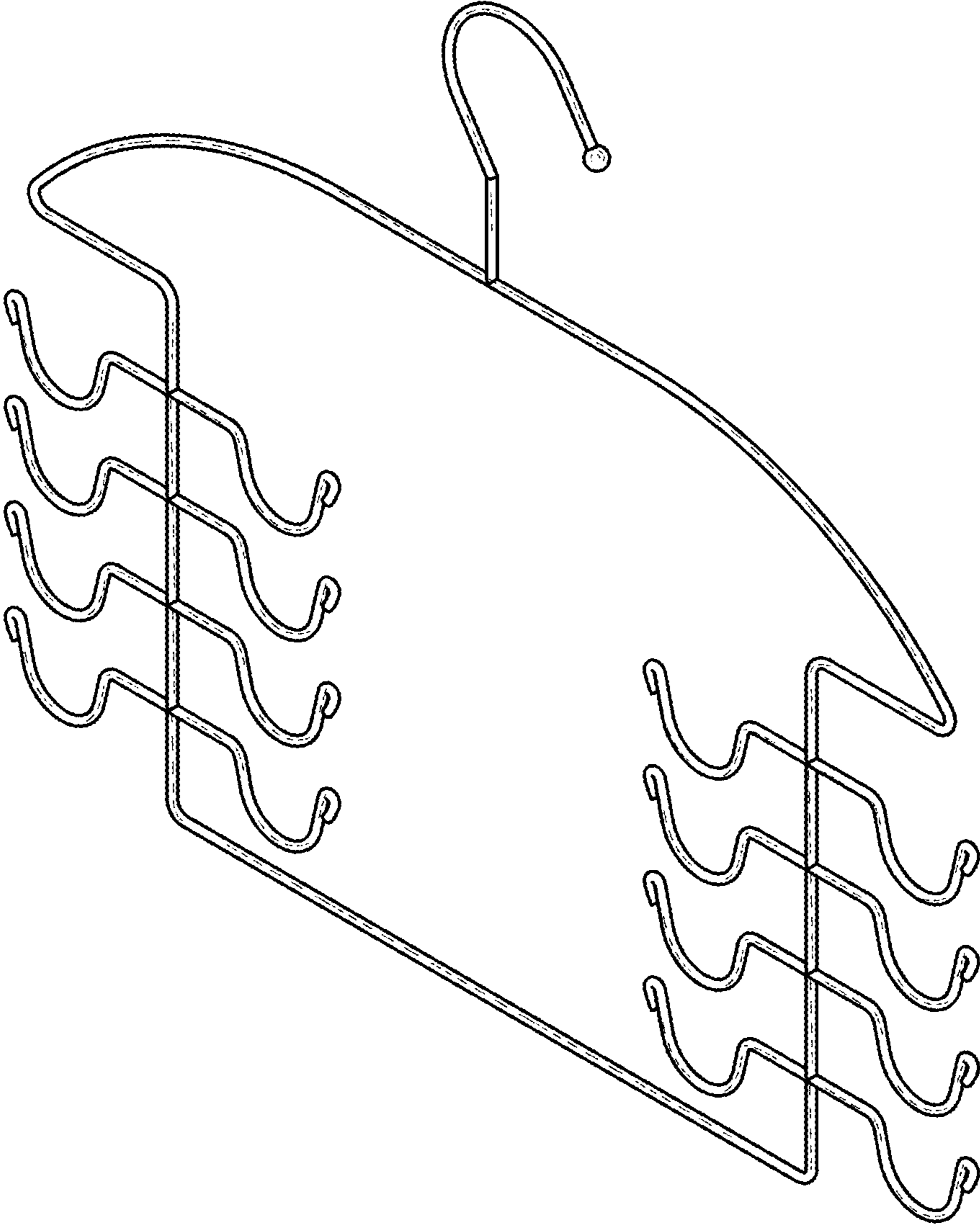

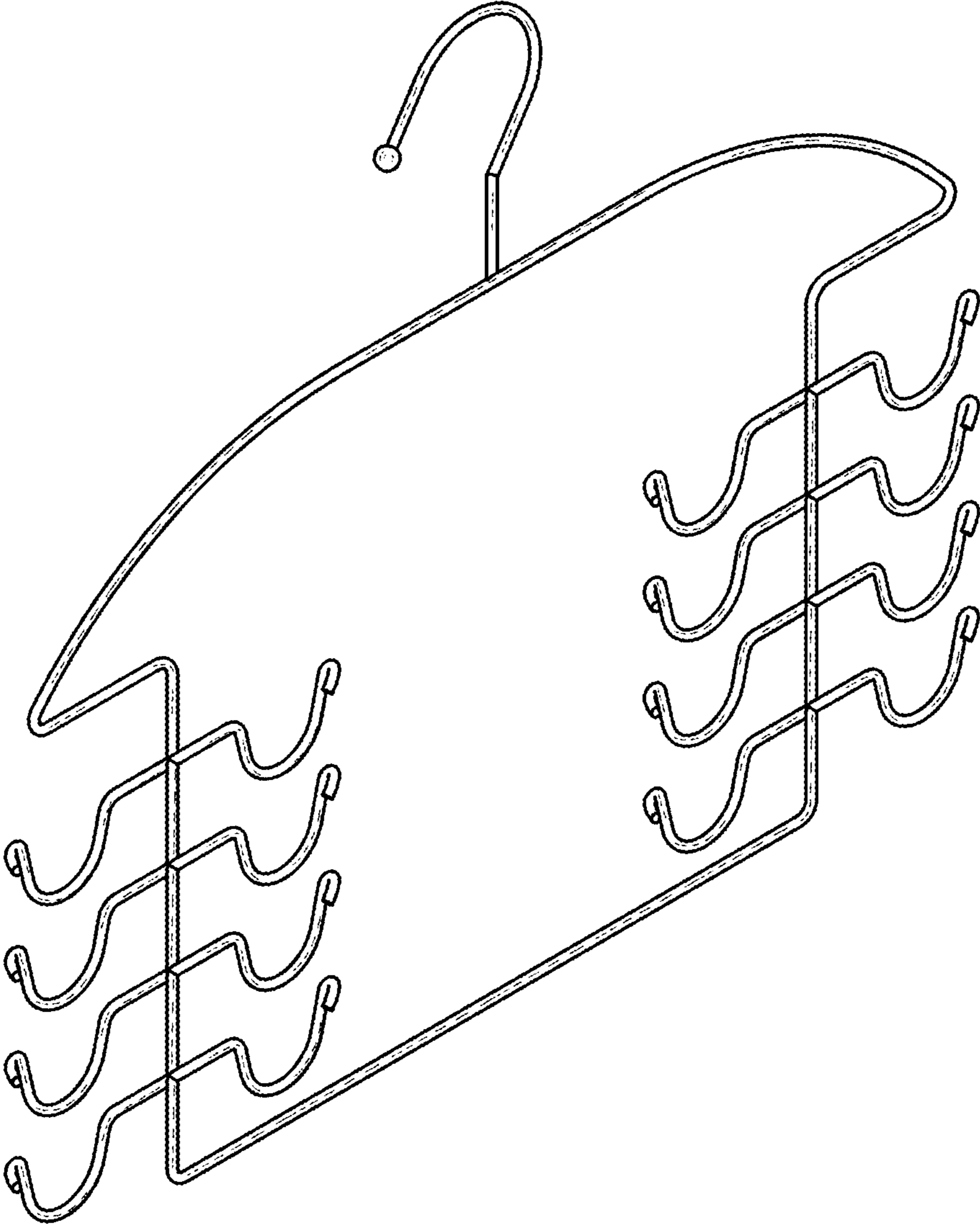

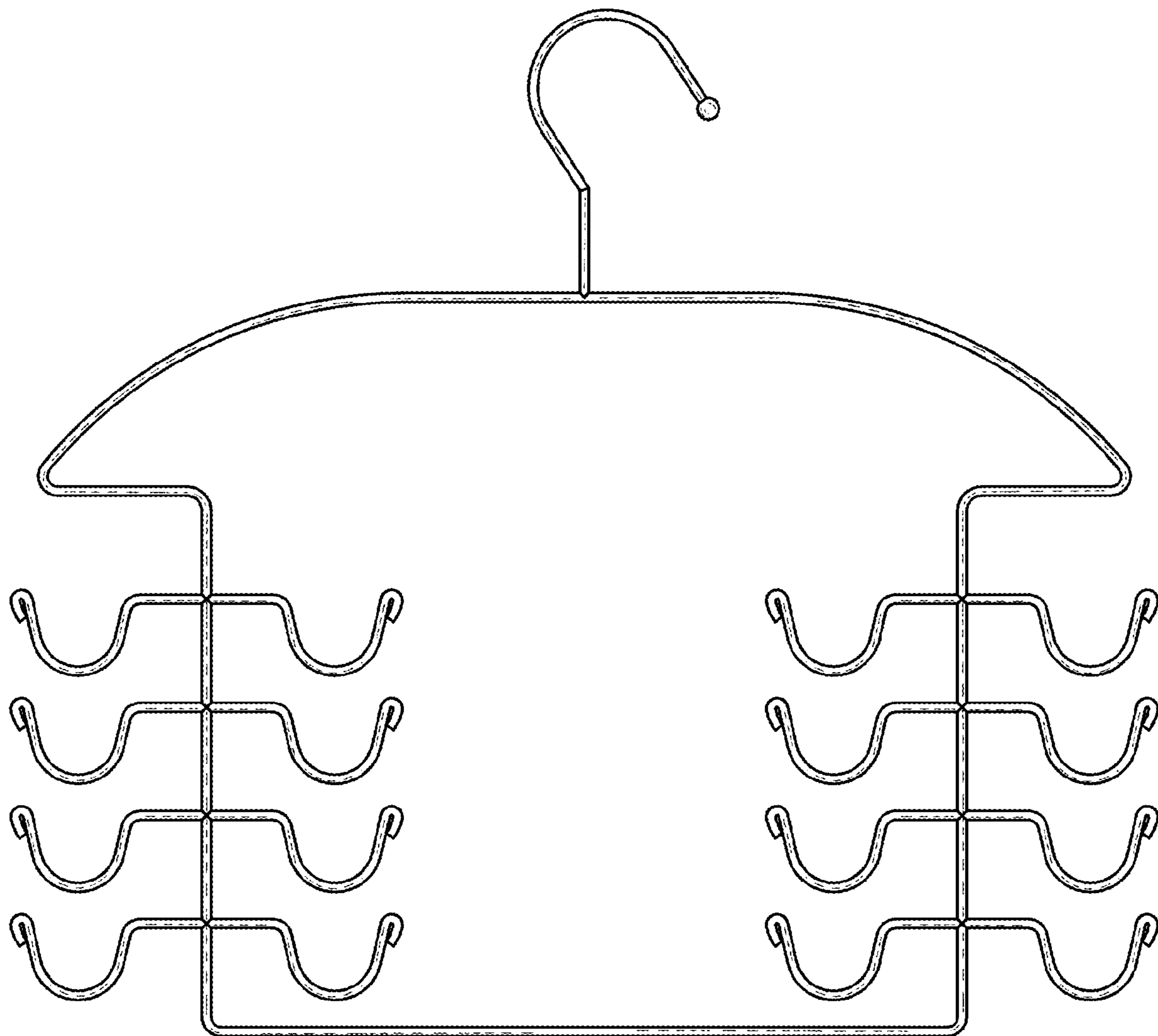

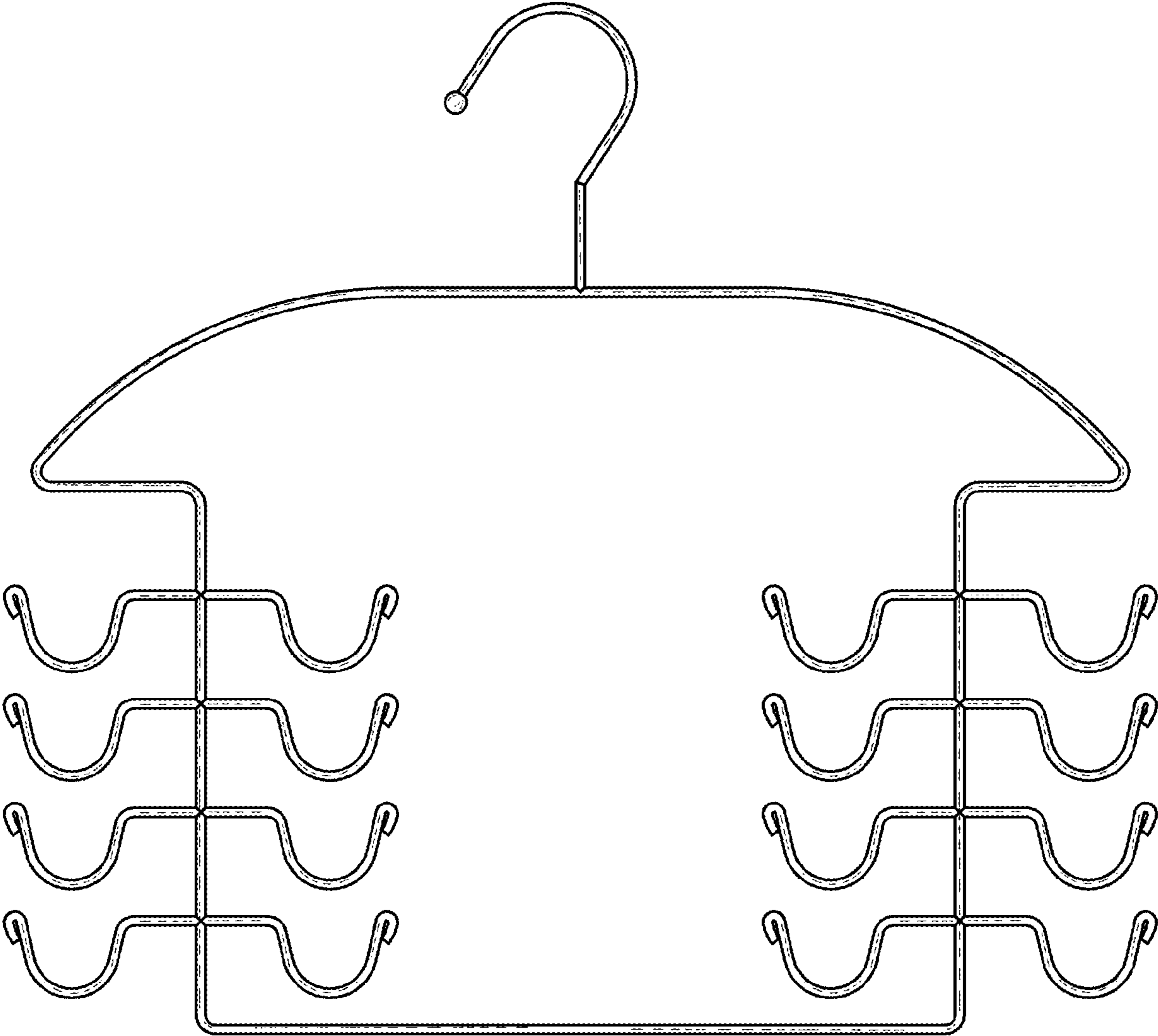
