**DESCRIPTION**

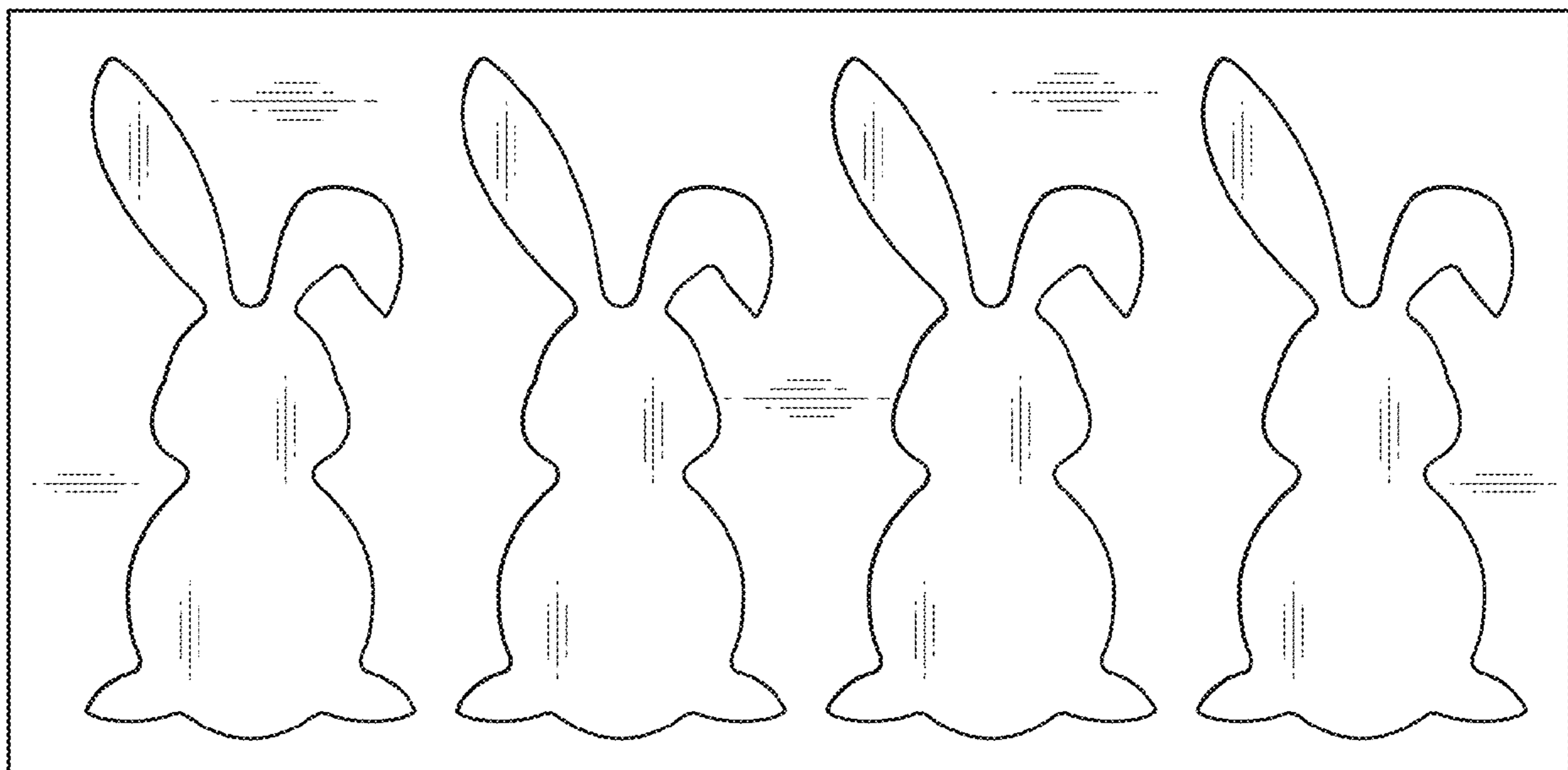
FIG. 1 is a top, left side and front perspective view of a silicone food mold, showing my new design,

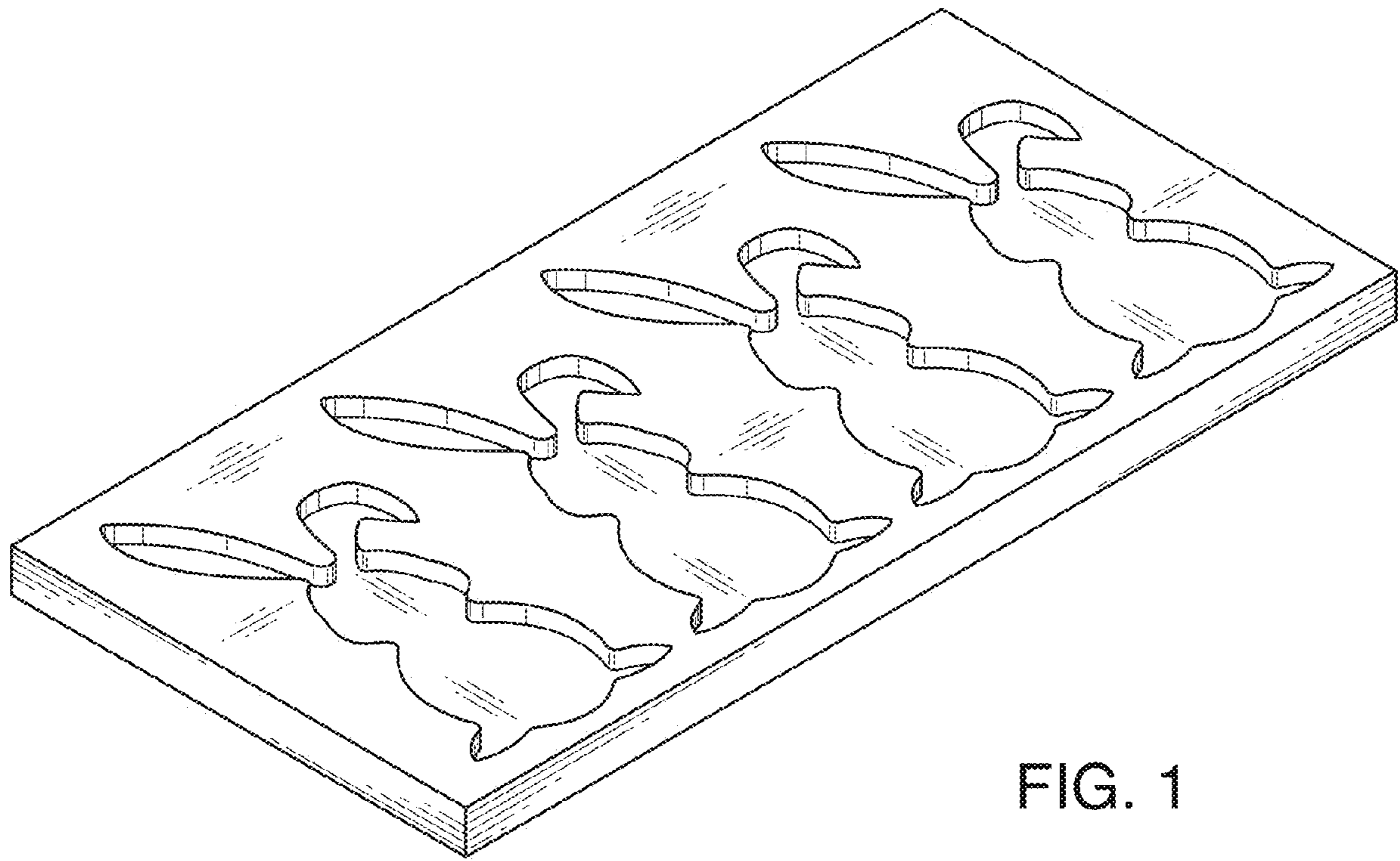

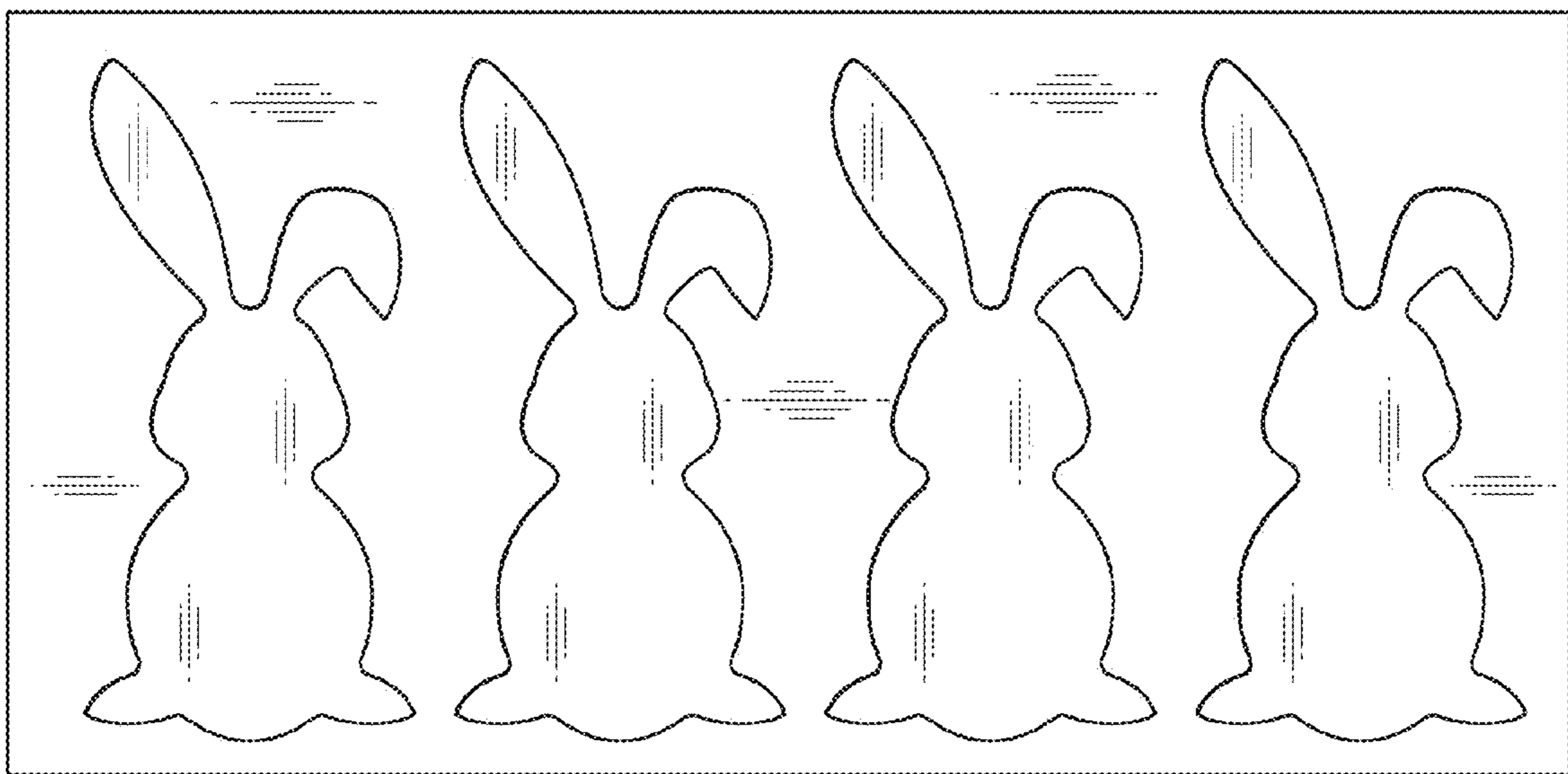

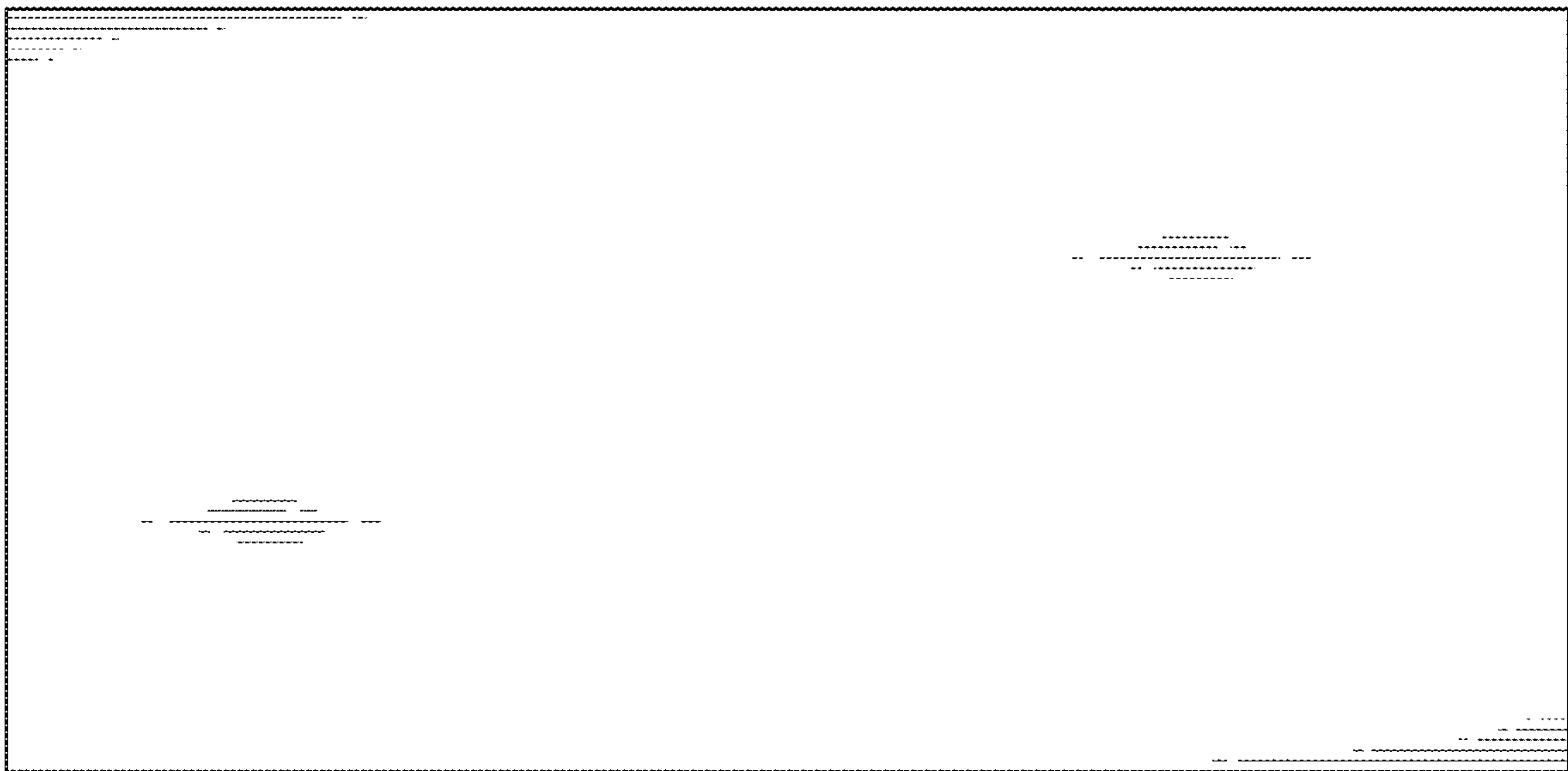
