FIG. 10 is a back view of the second embodiment of the package shown in FIG. 8.

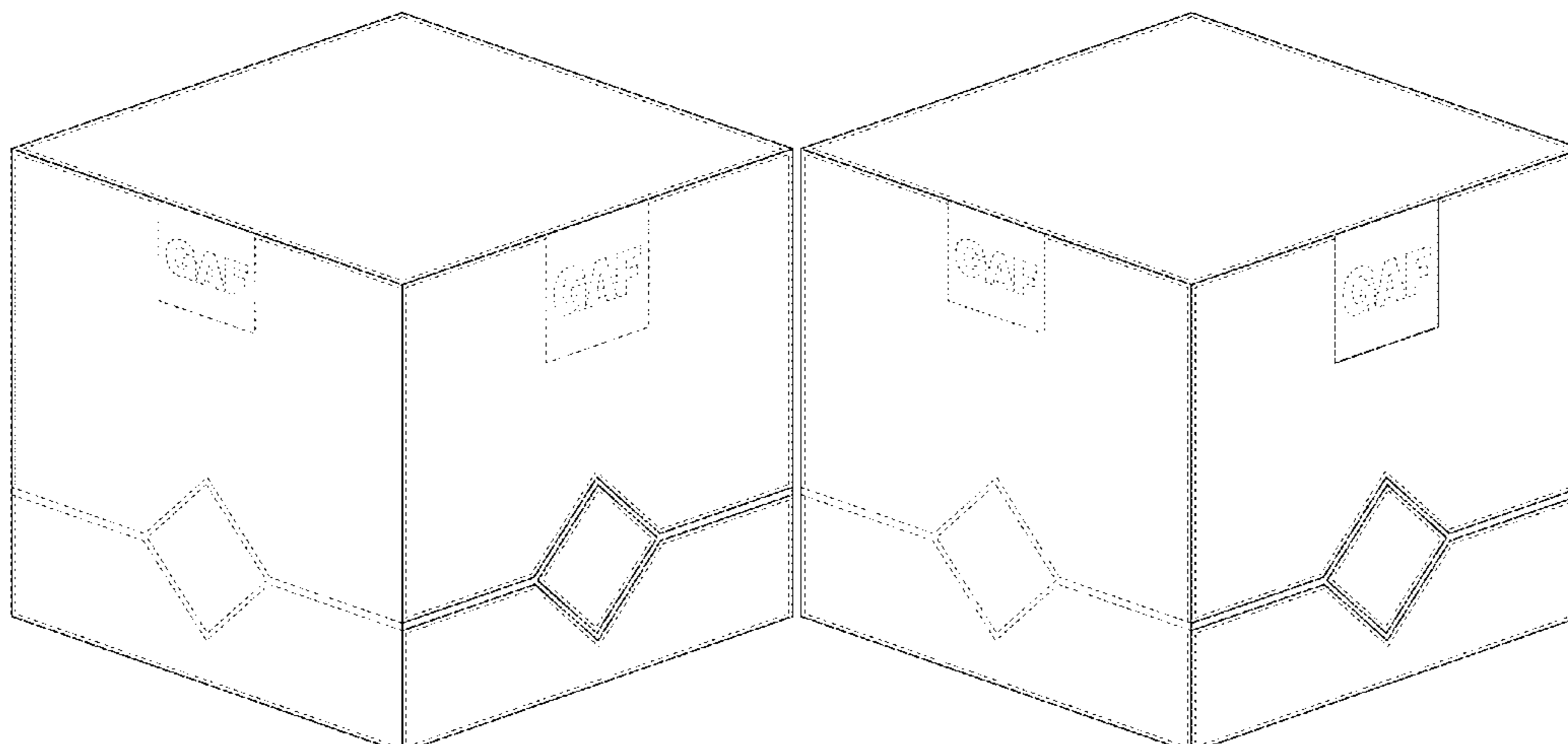
FIG. 11 is a right side view of the second embodiment of the package shown in FIG. 8.

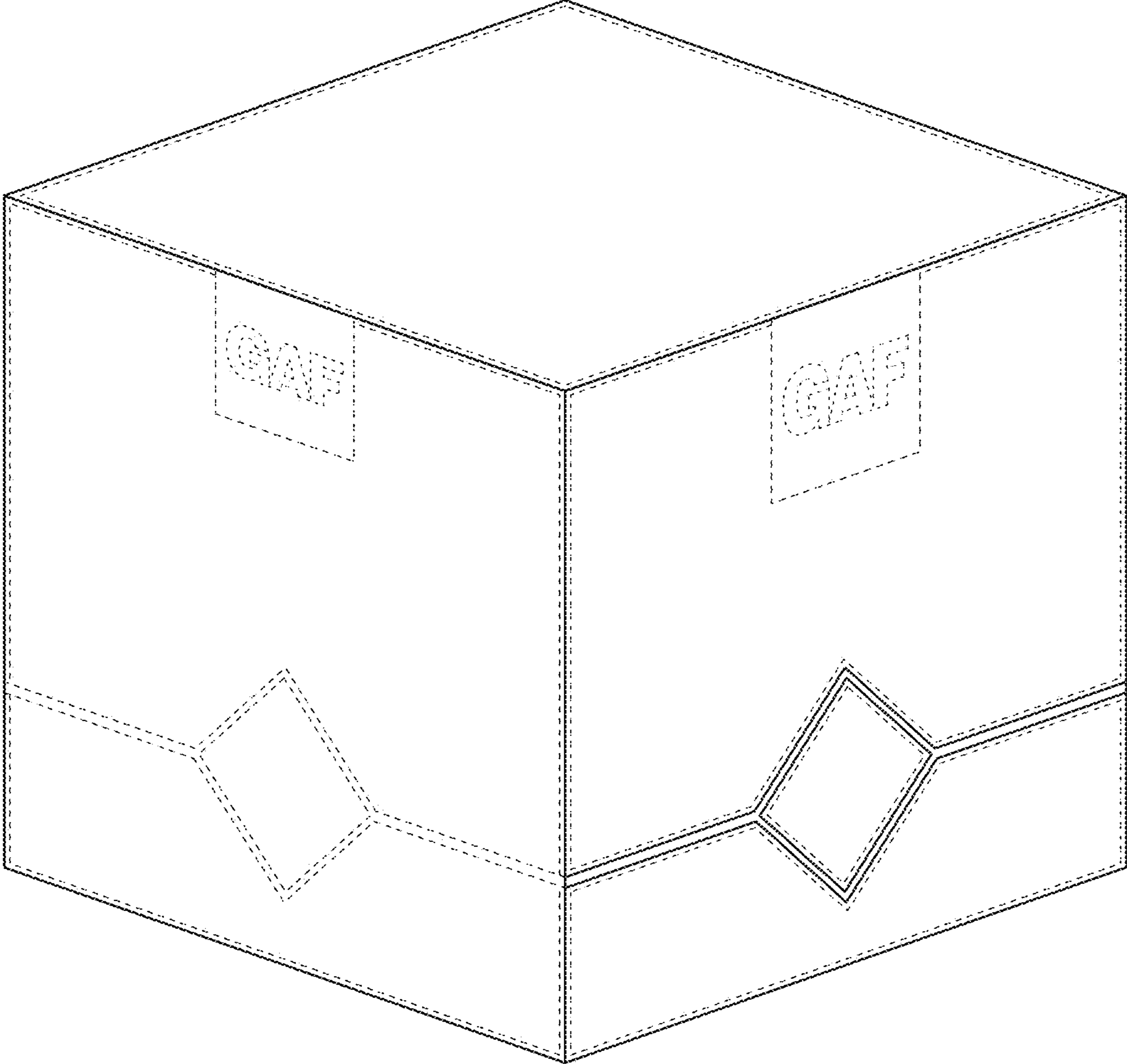

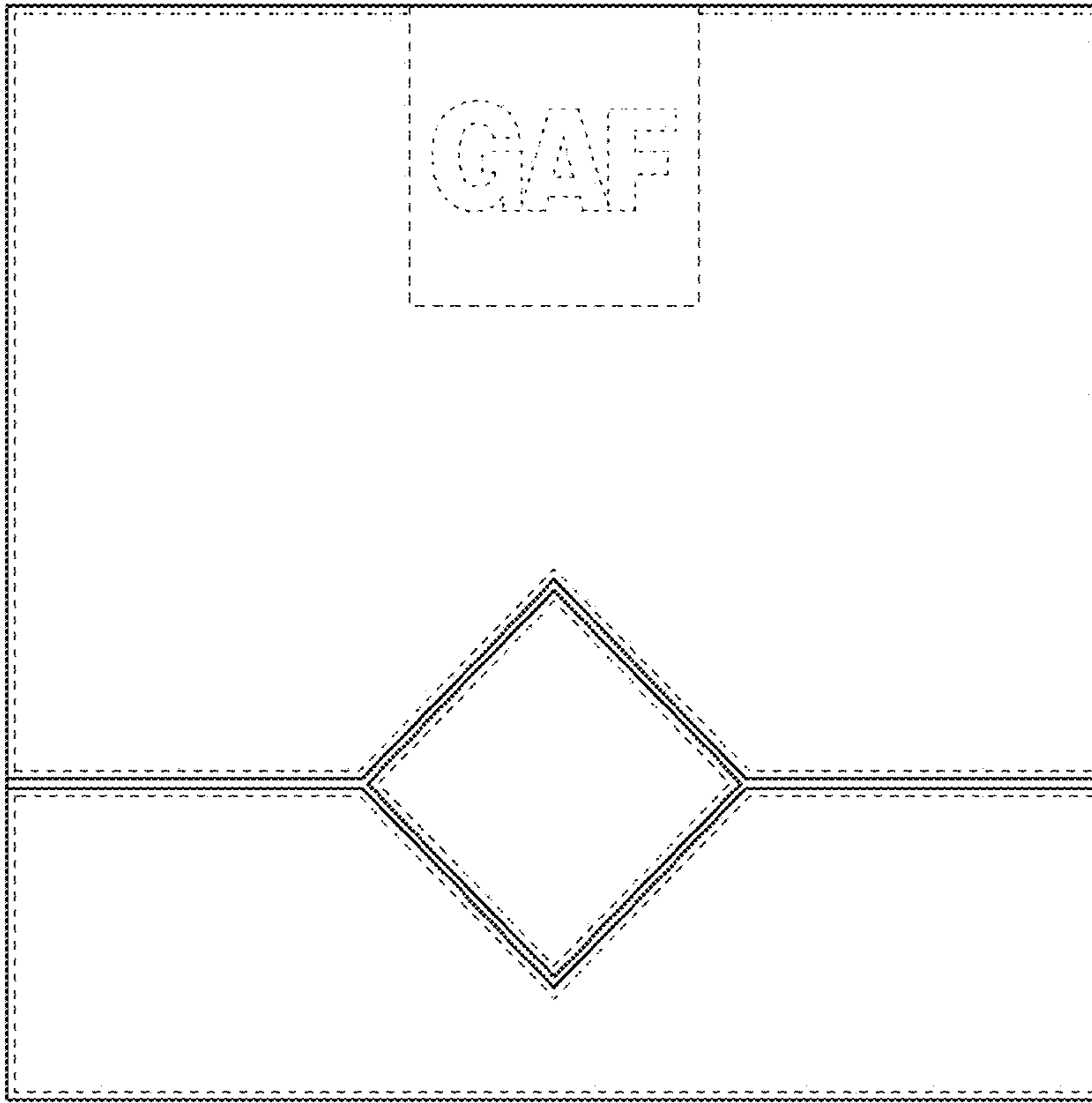

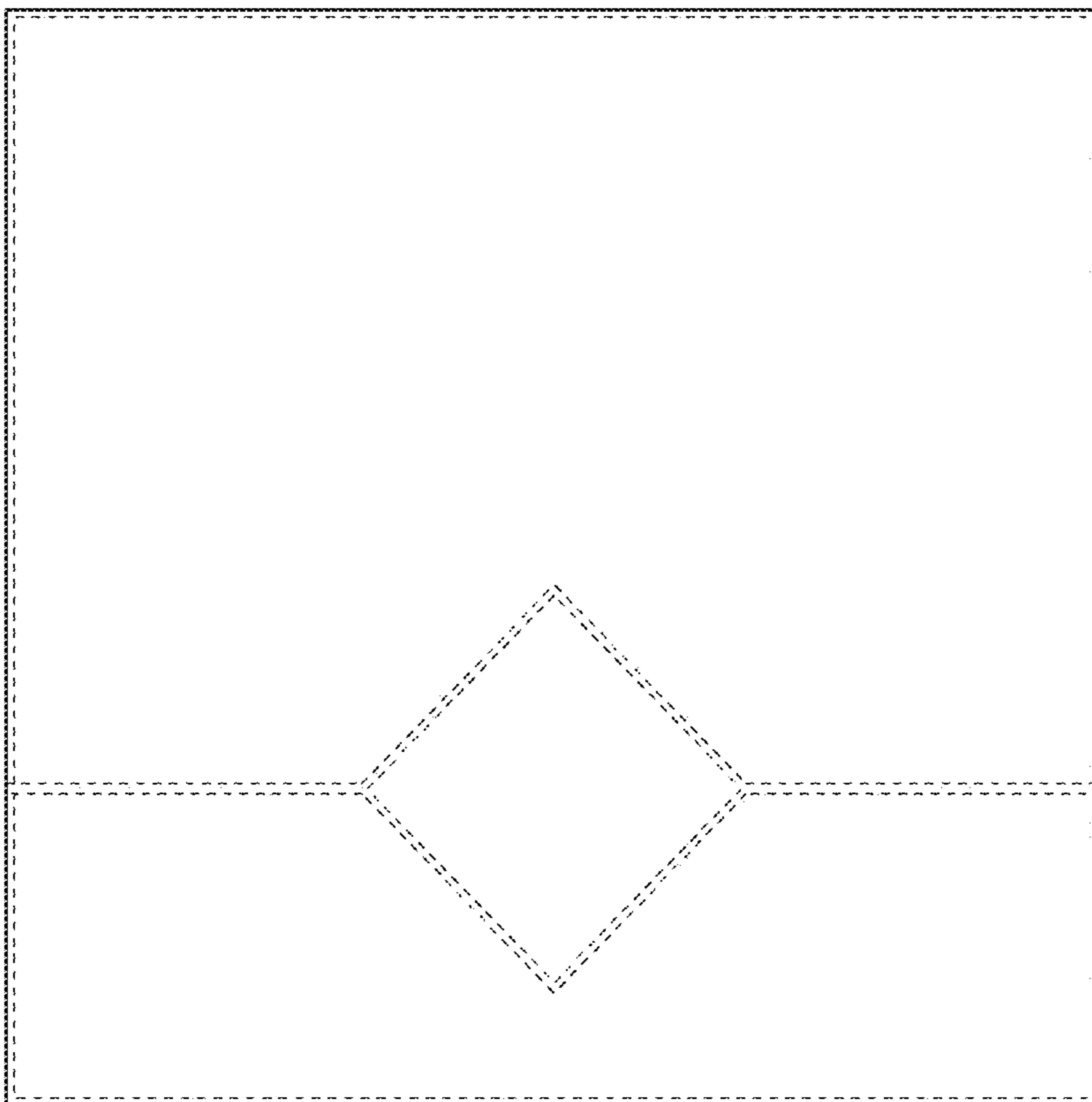

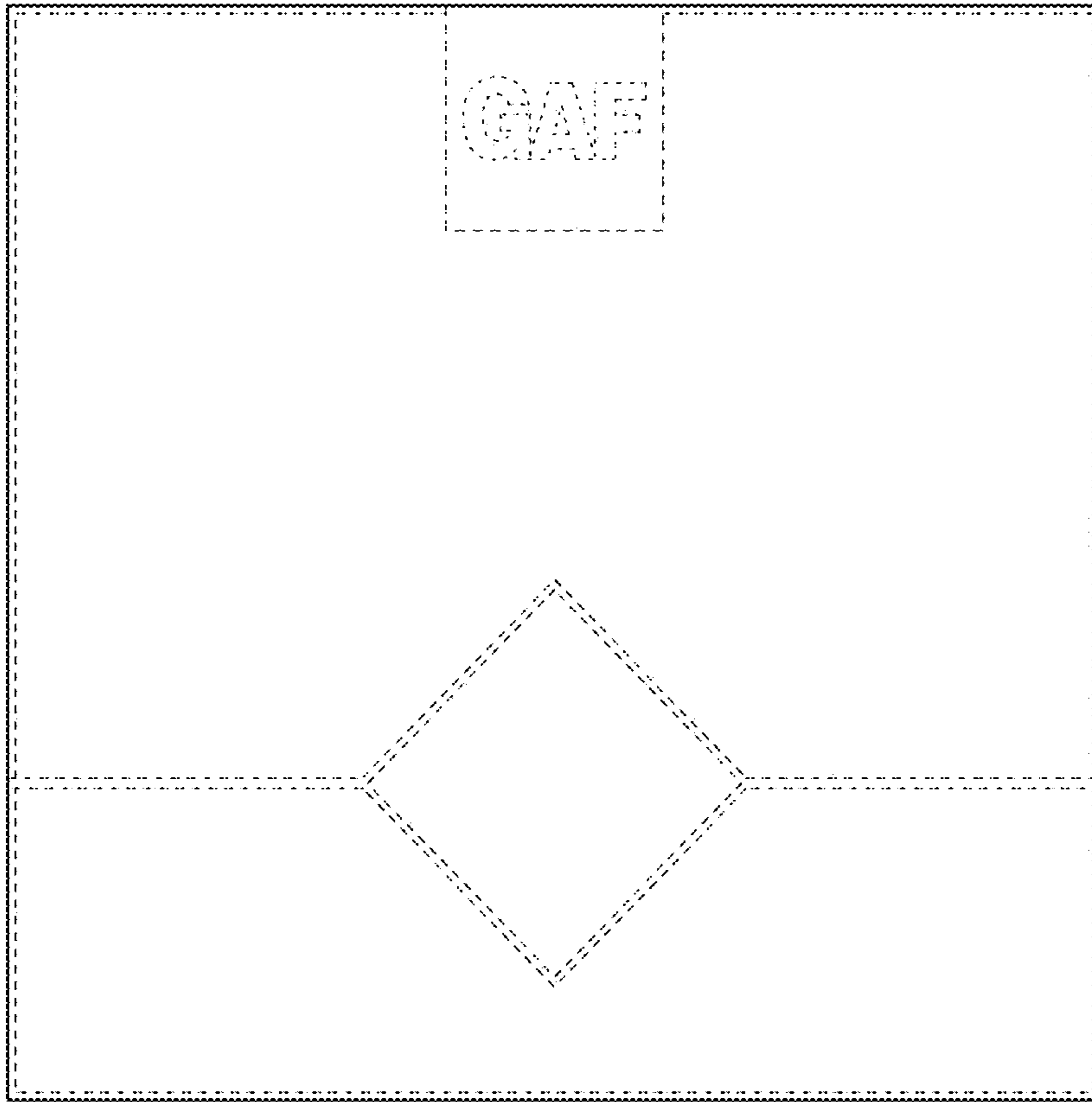

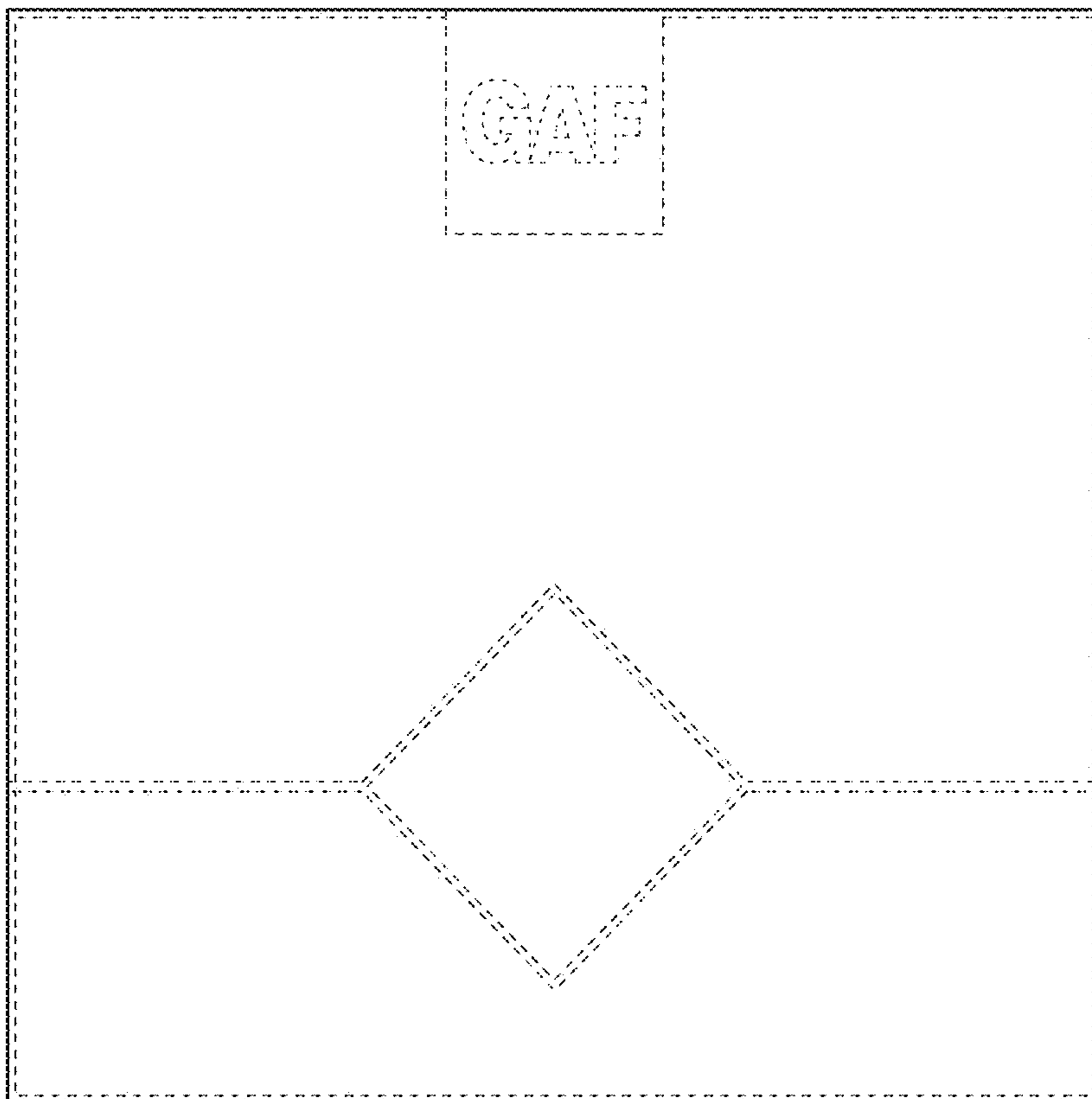

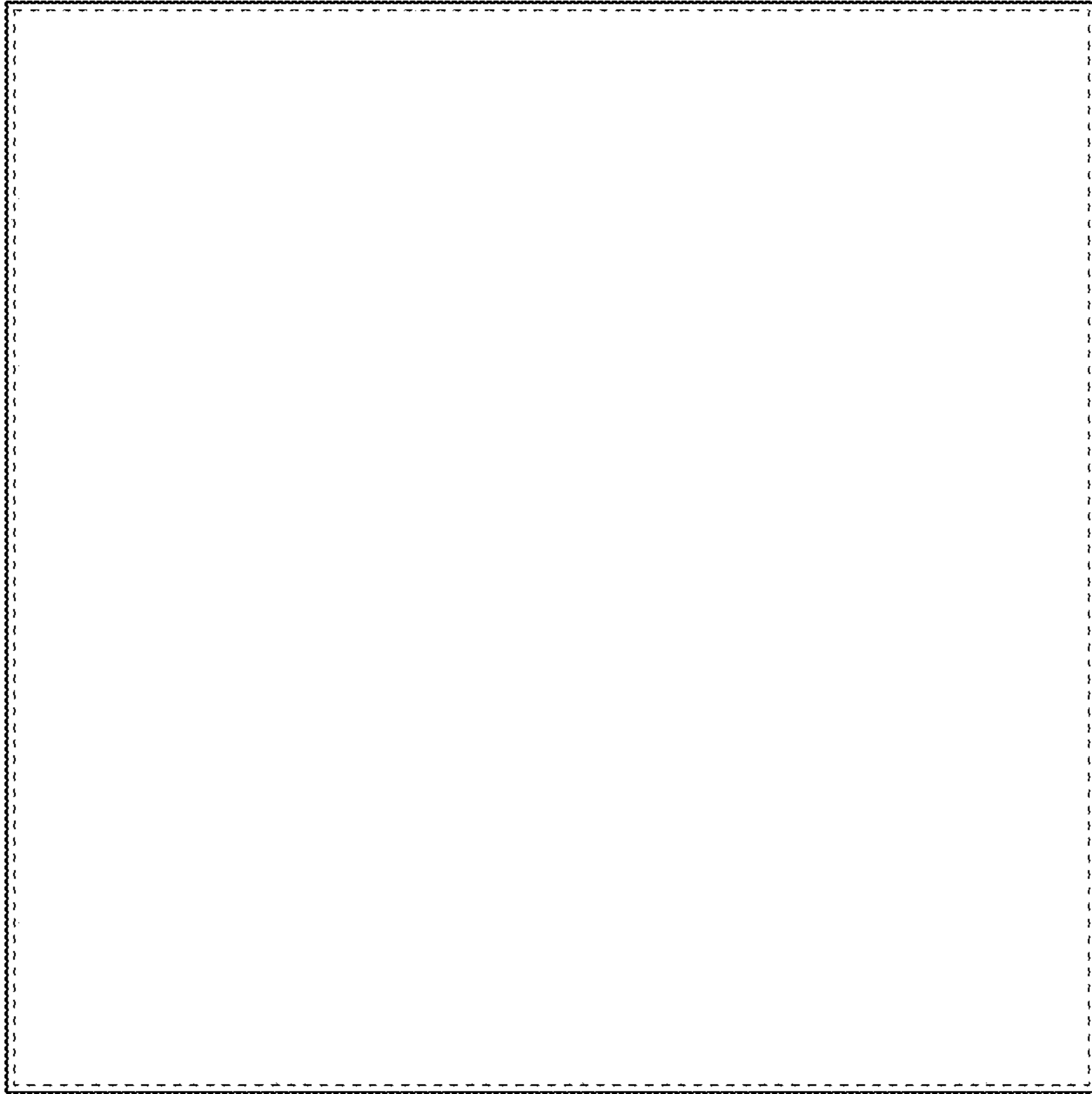

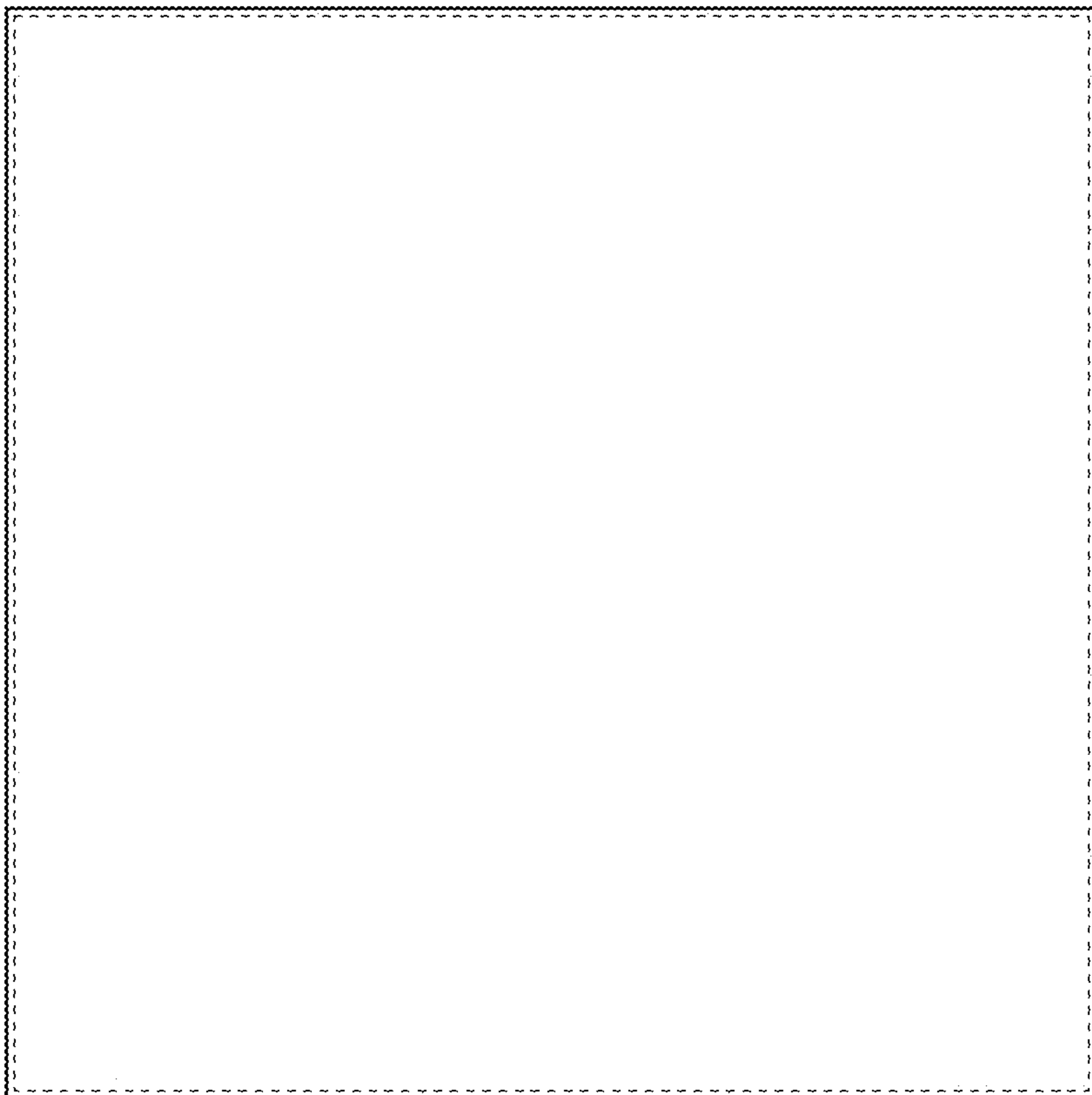

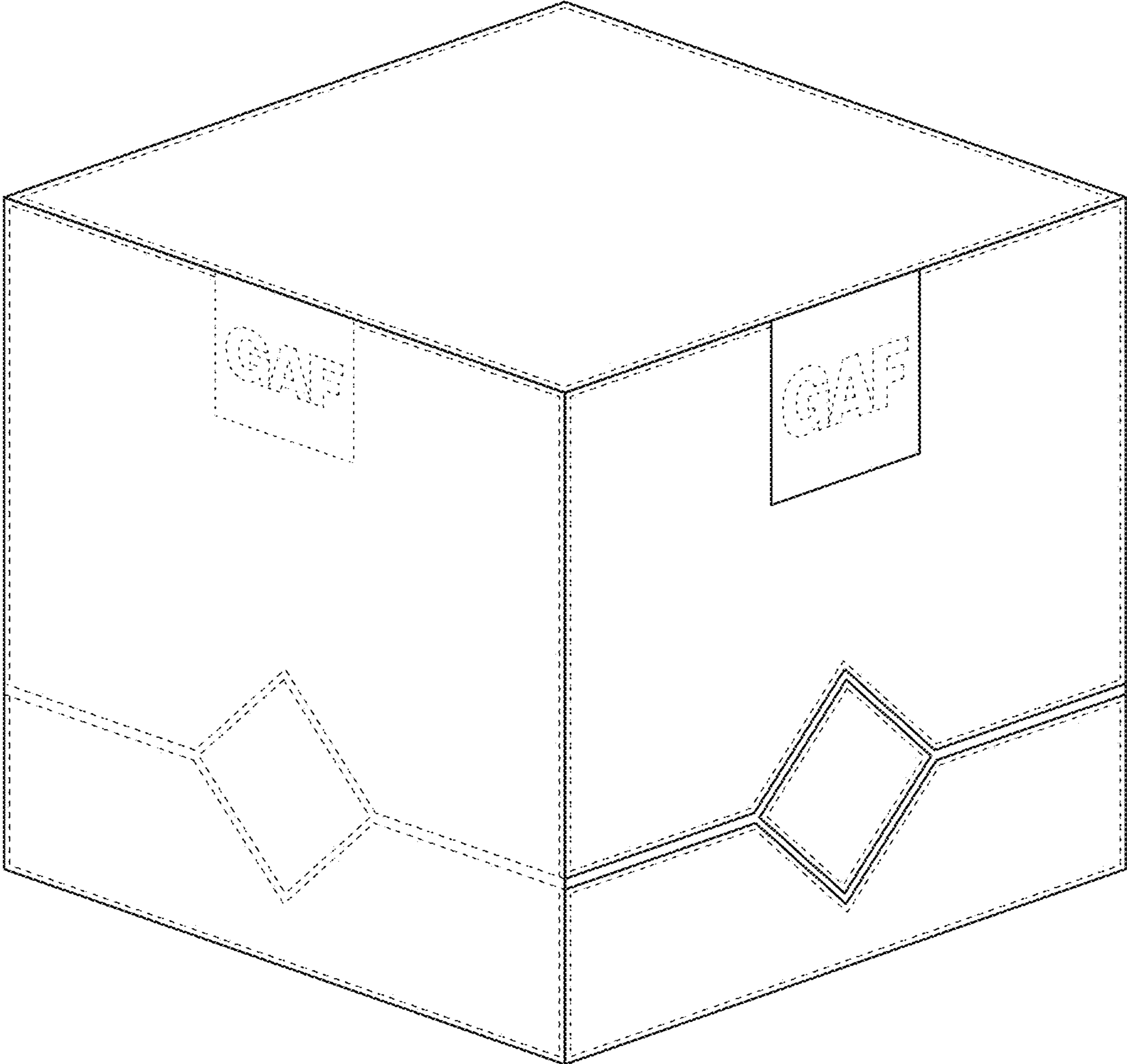

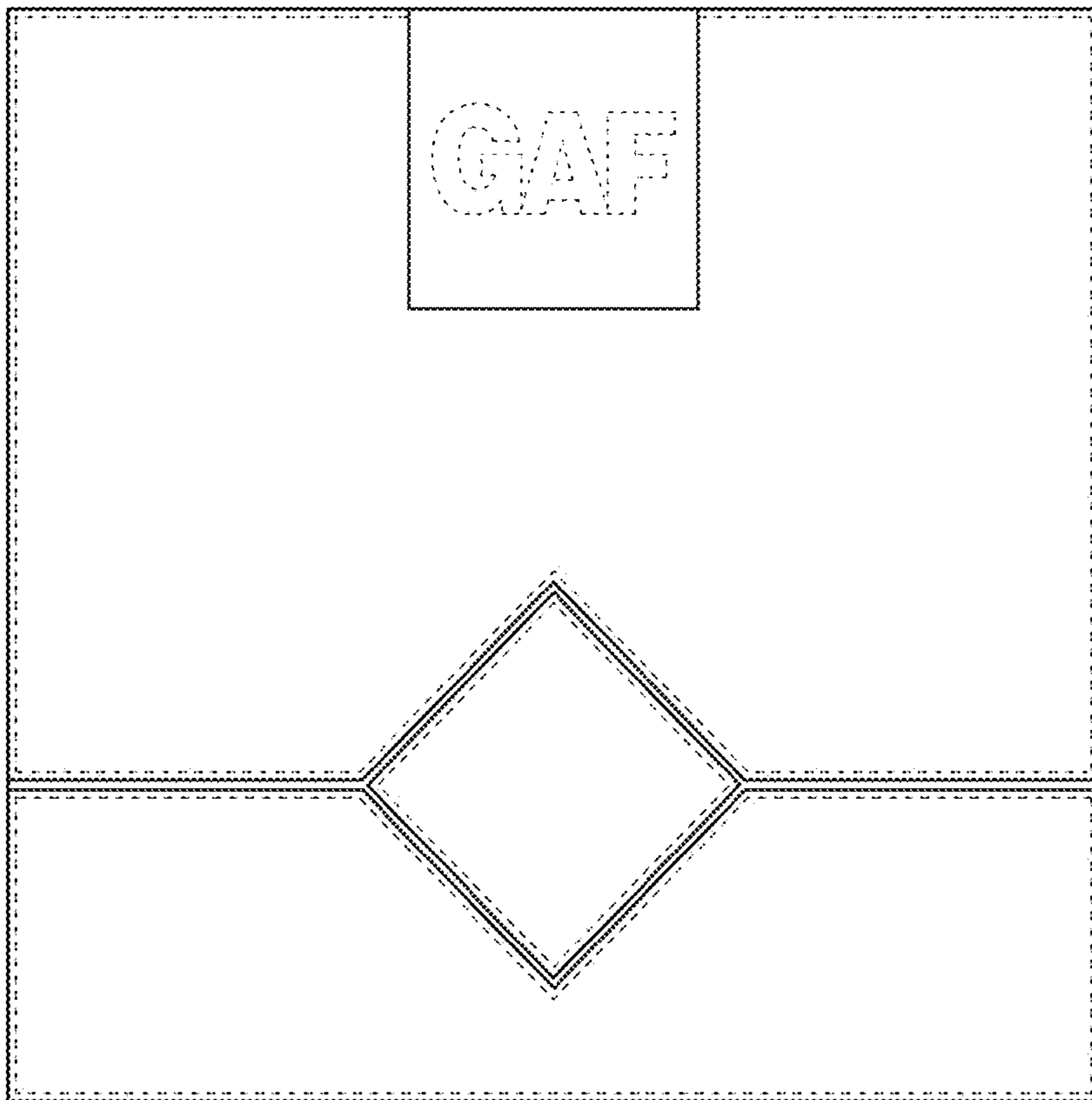

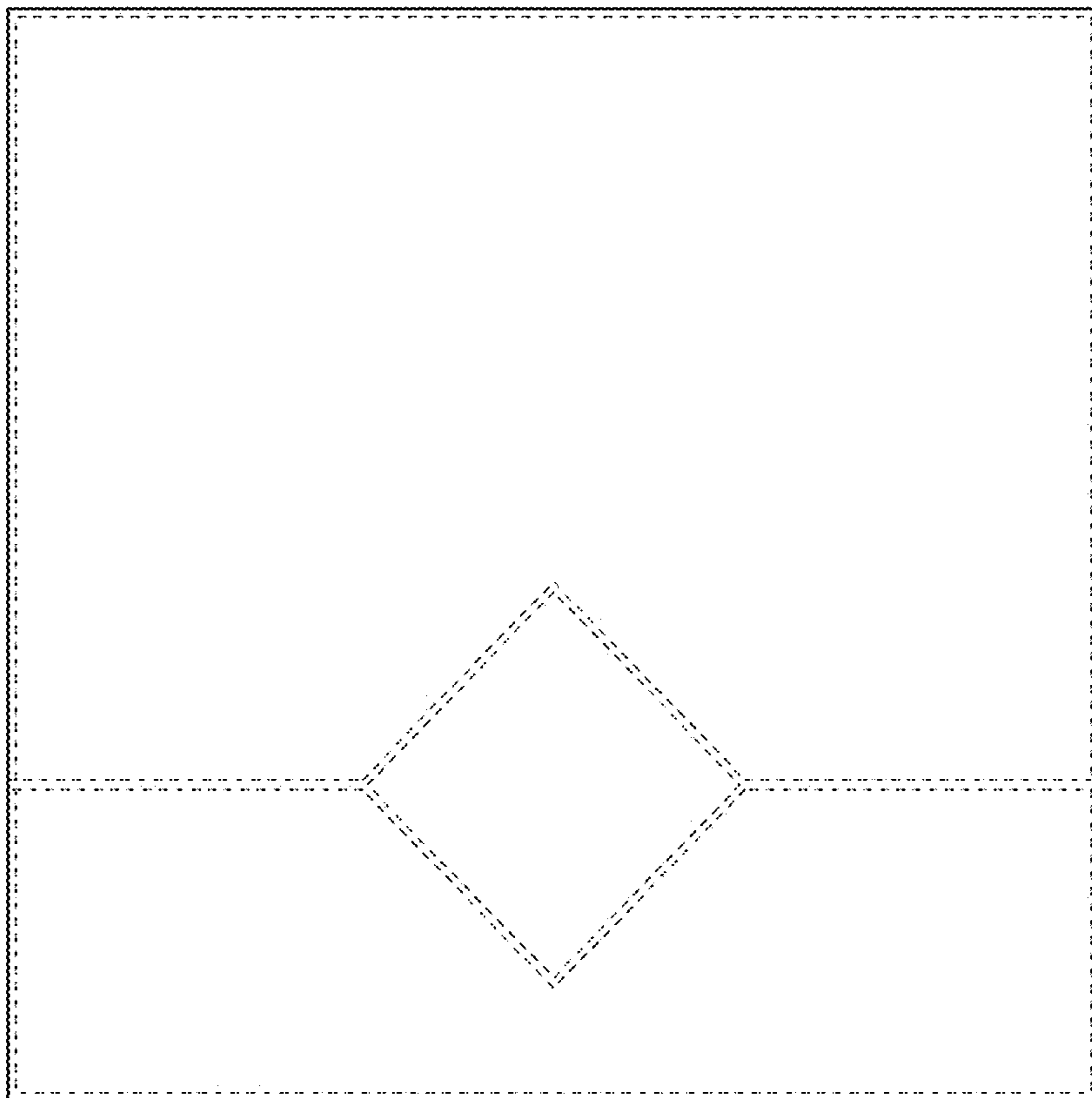

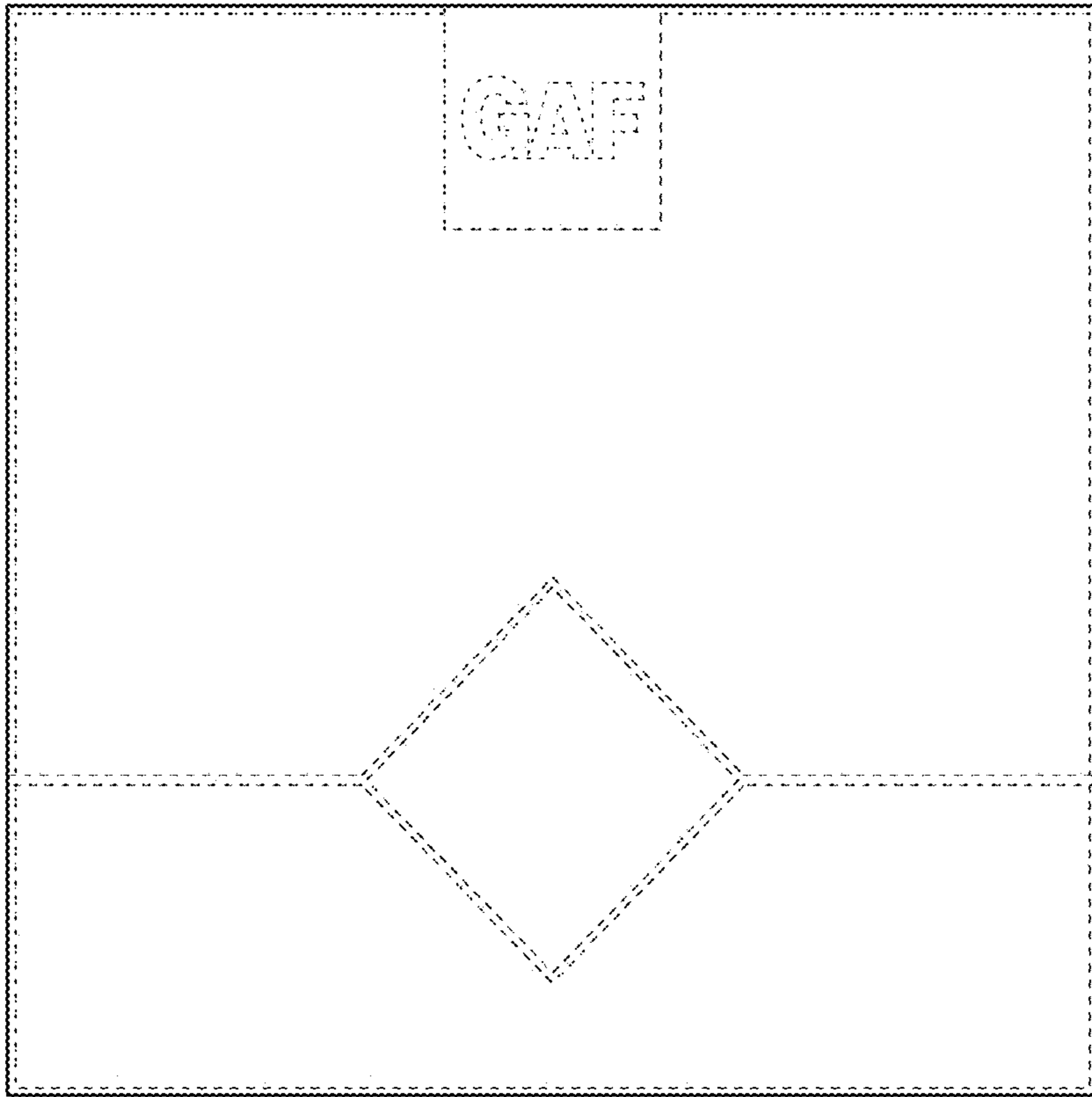

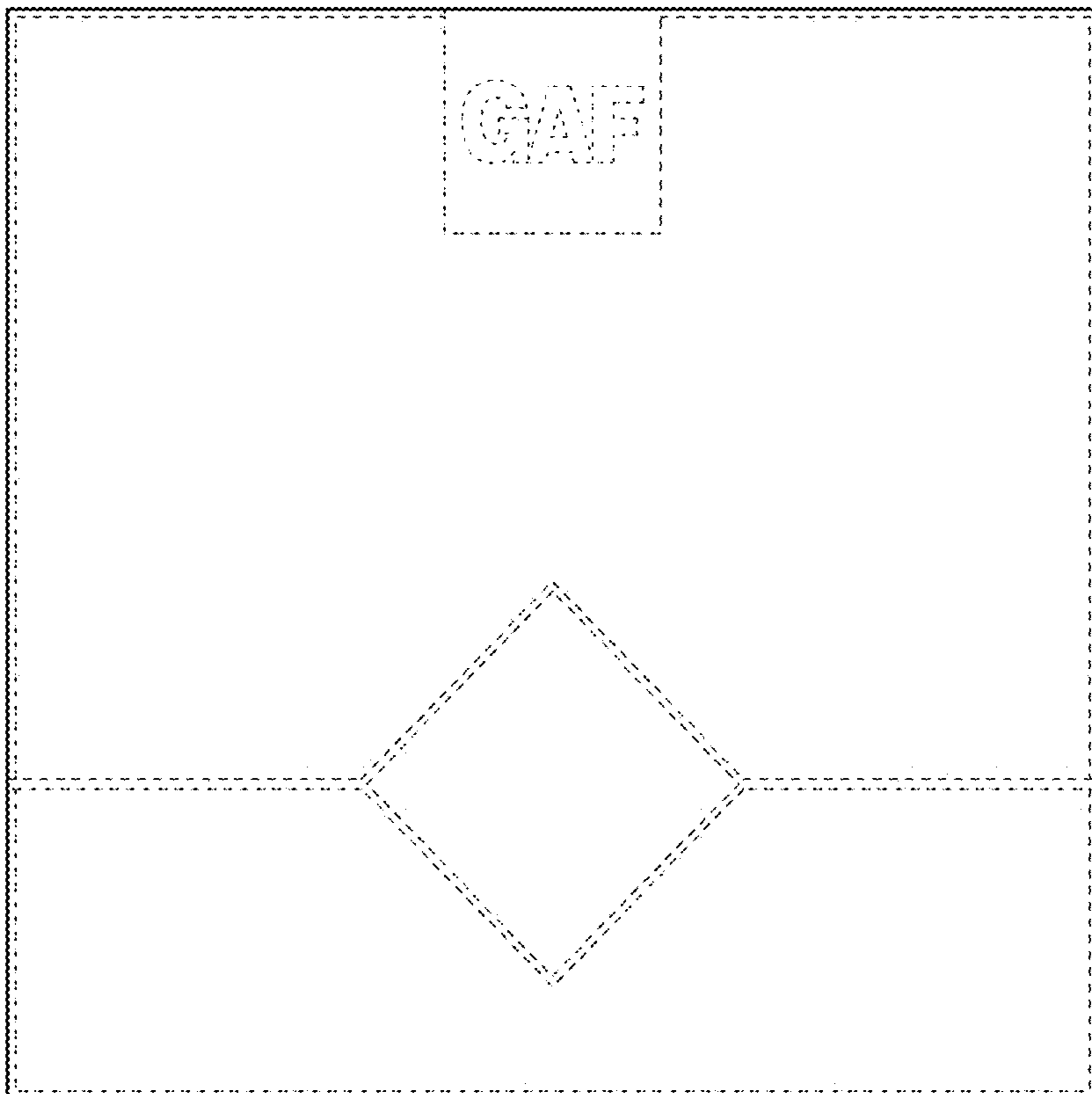

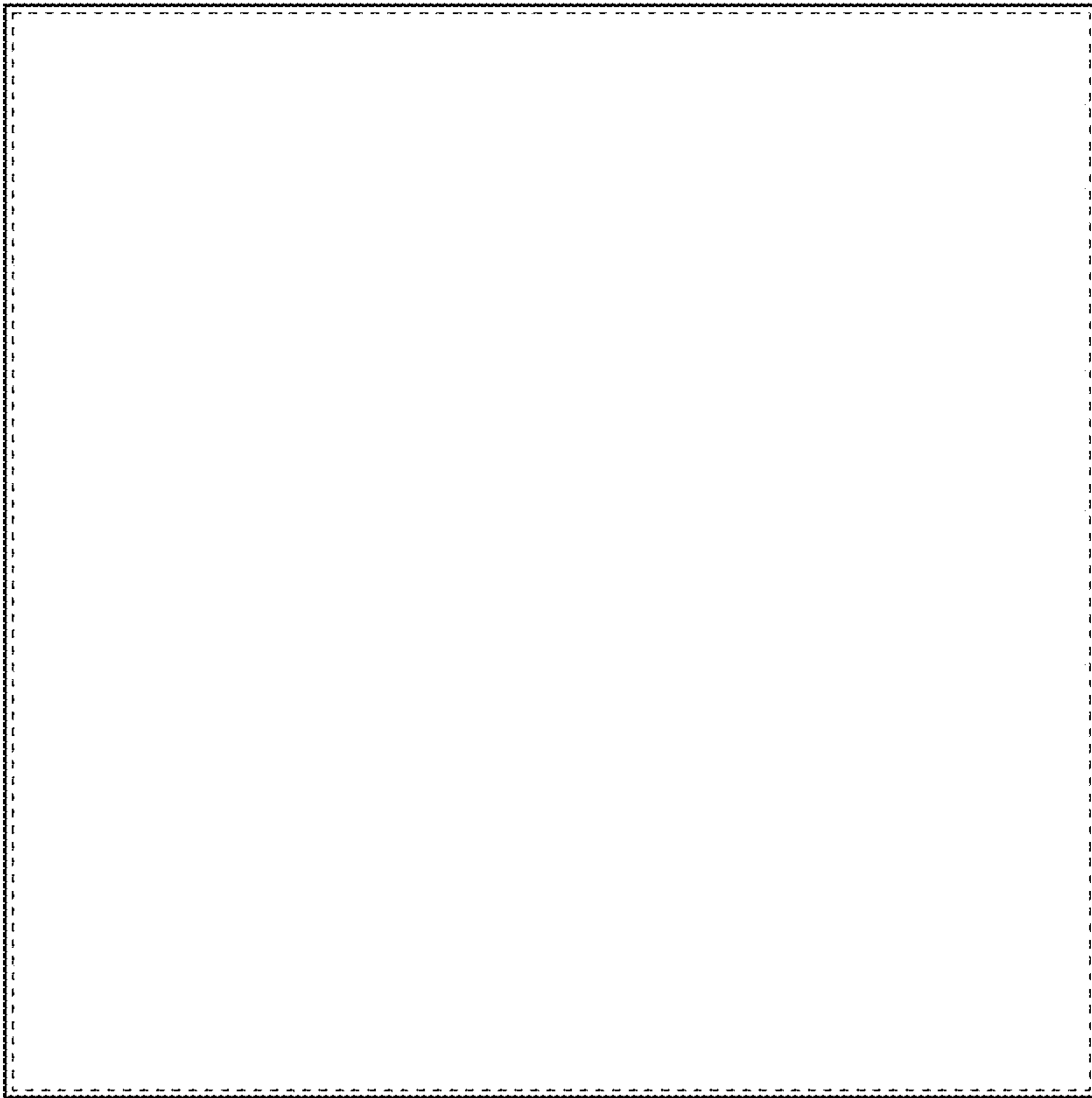

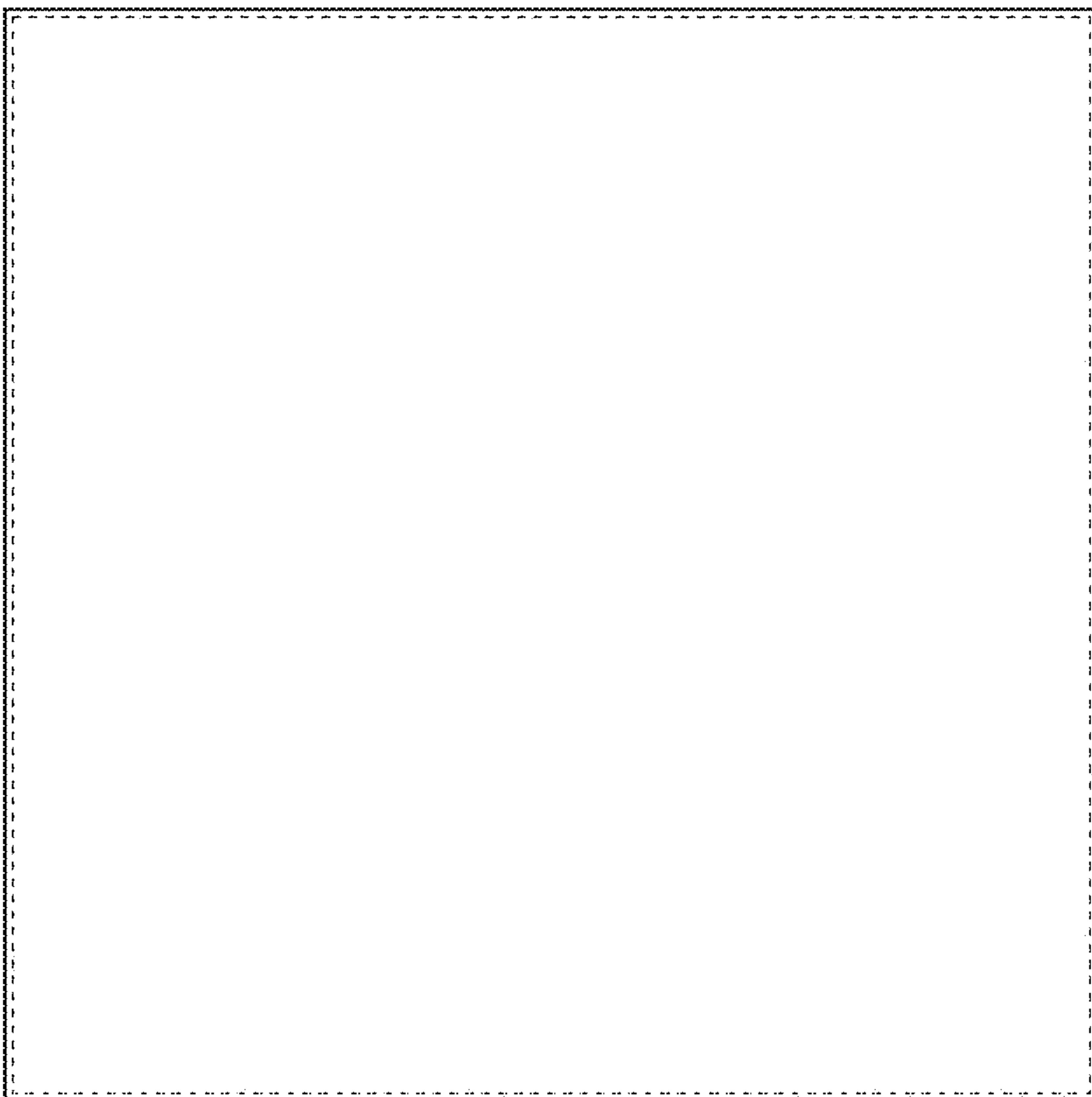
