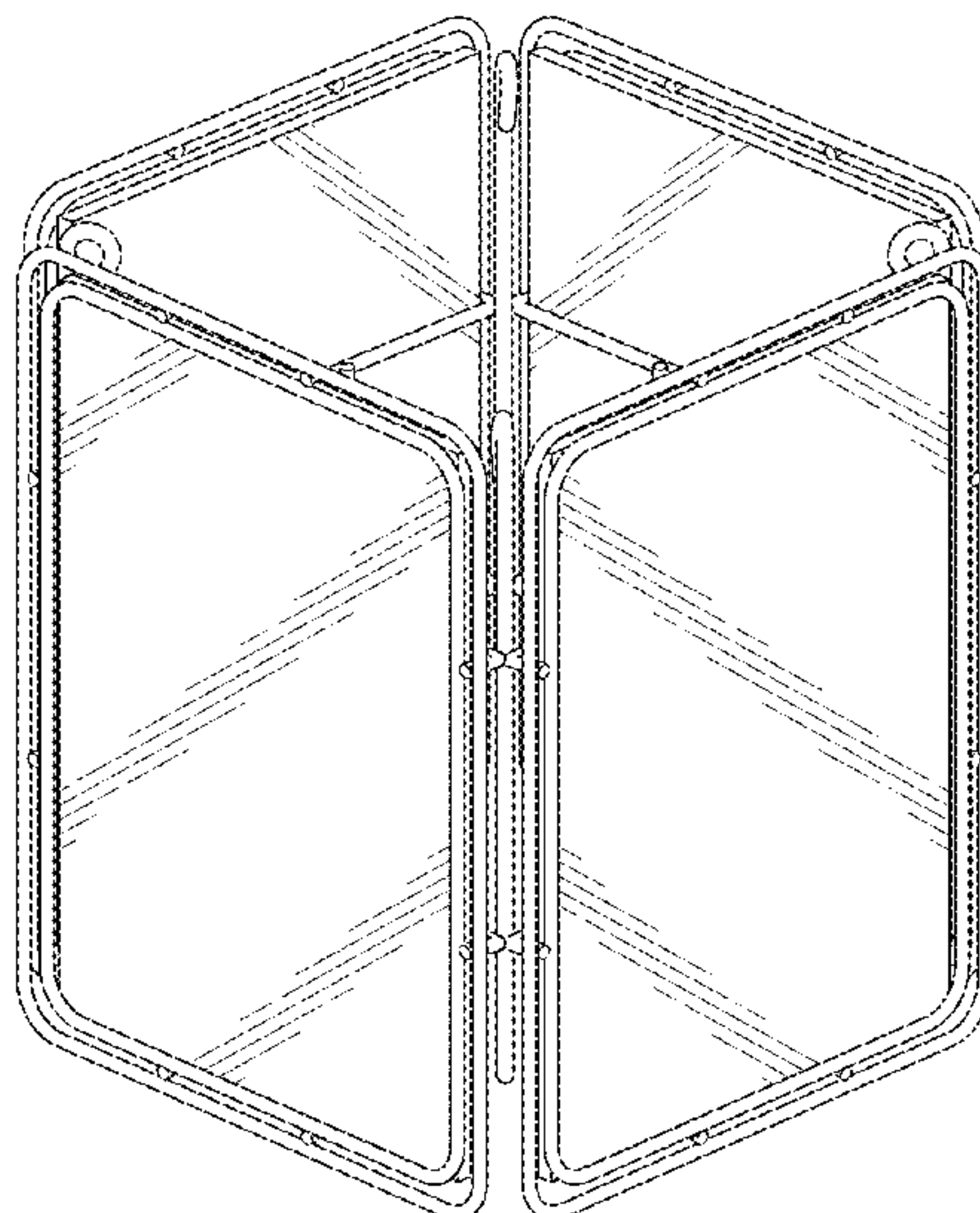
(57) **CLAIM**

The ornamental design for a hanging ornament with mirrored side panels, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hanging ornament with mirrored side panels, showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rears elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and,
FIG. 8 is a cross sectional view taken along line 8-8 in FIG. 6.

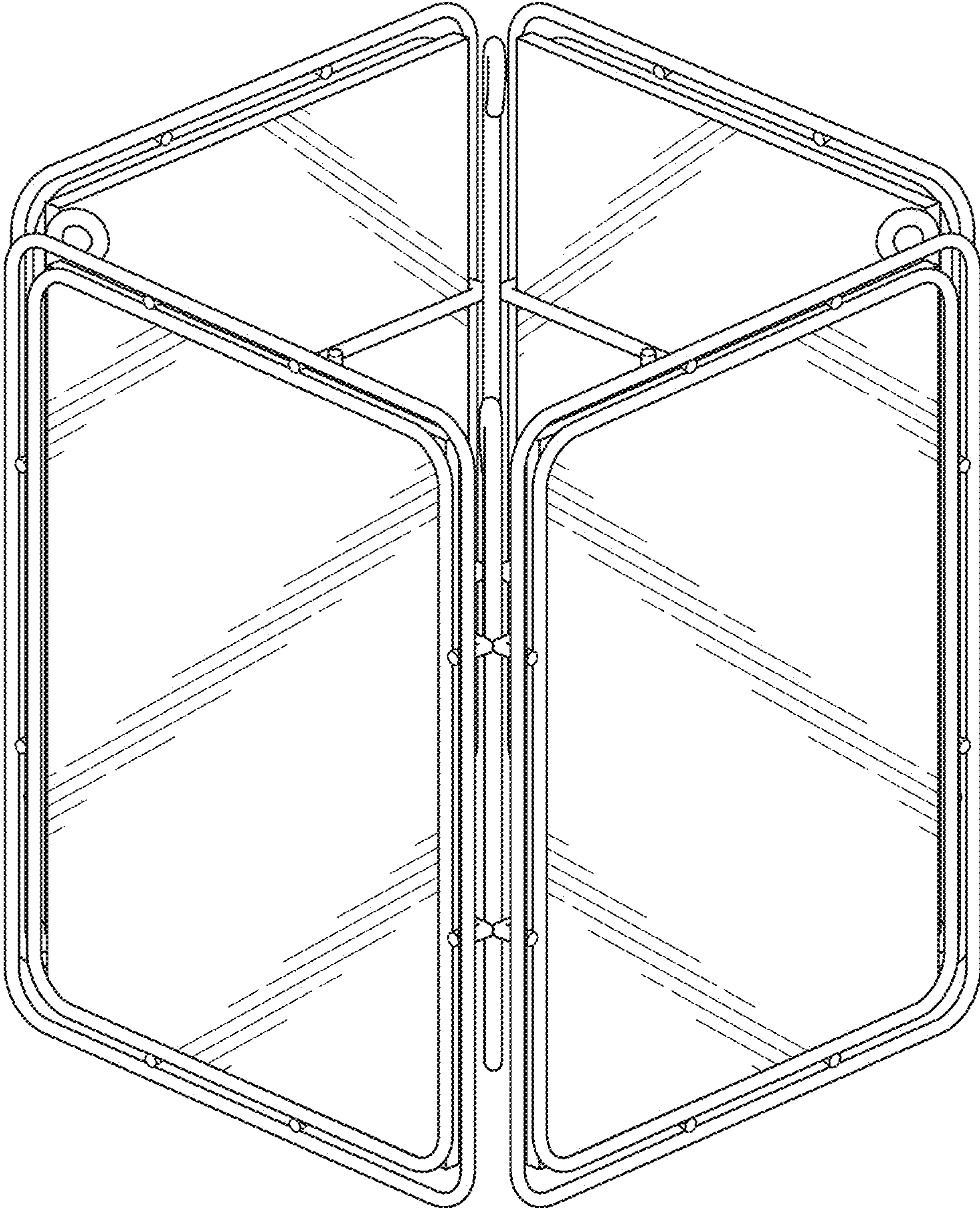

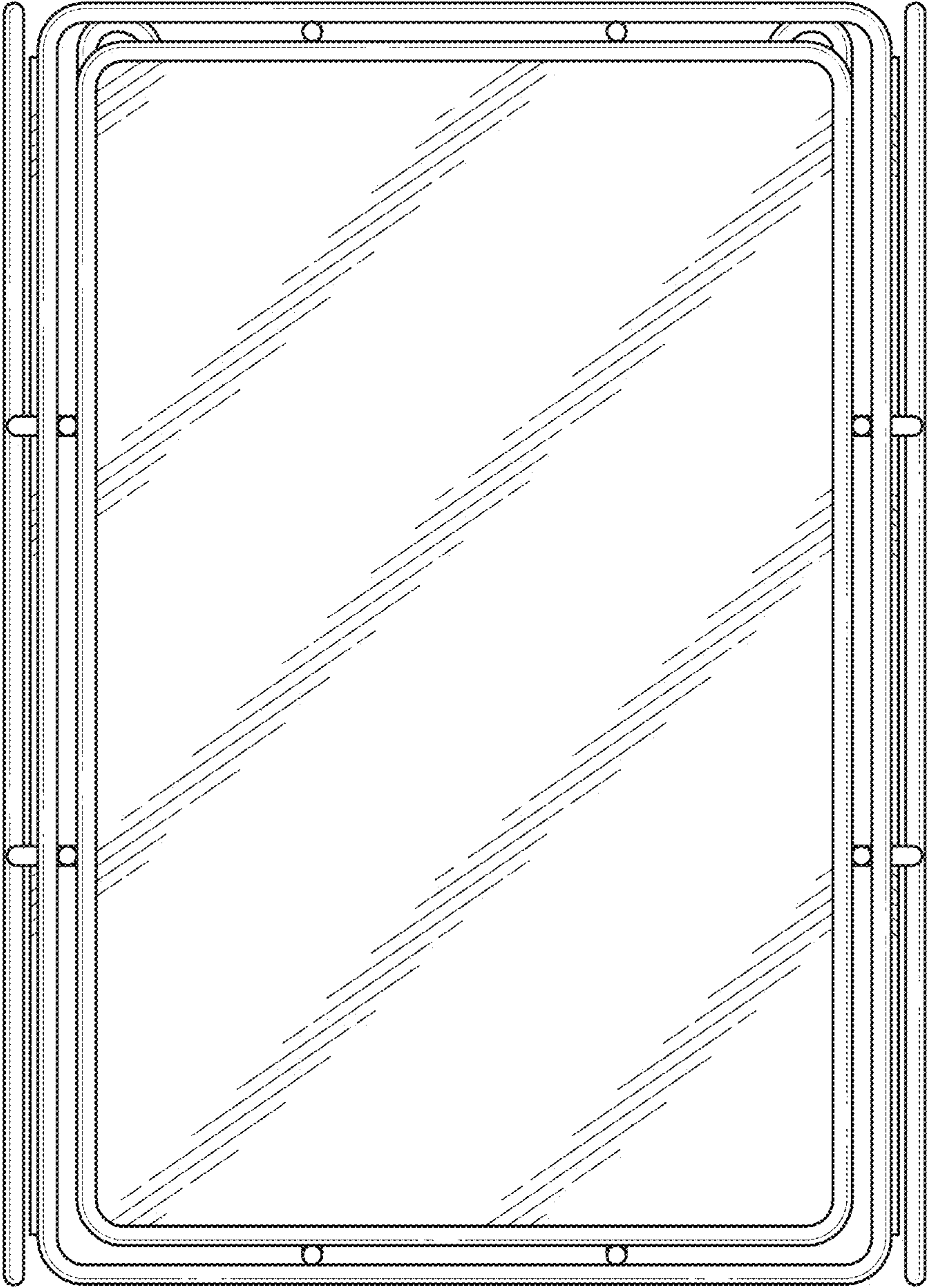

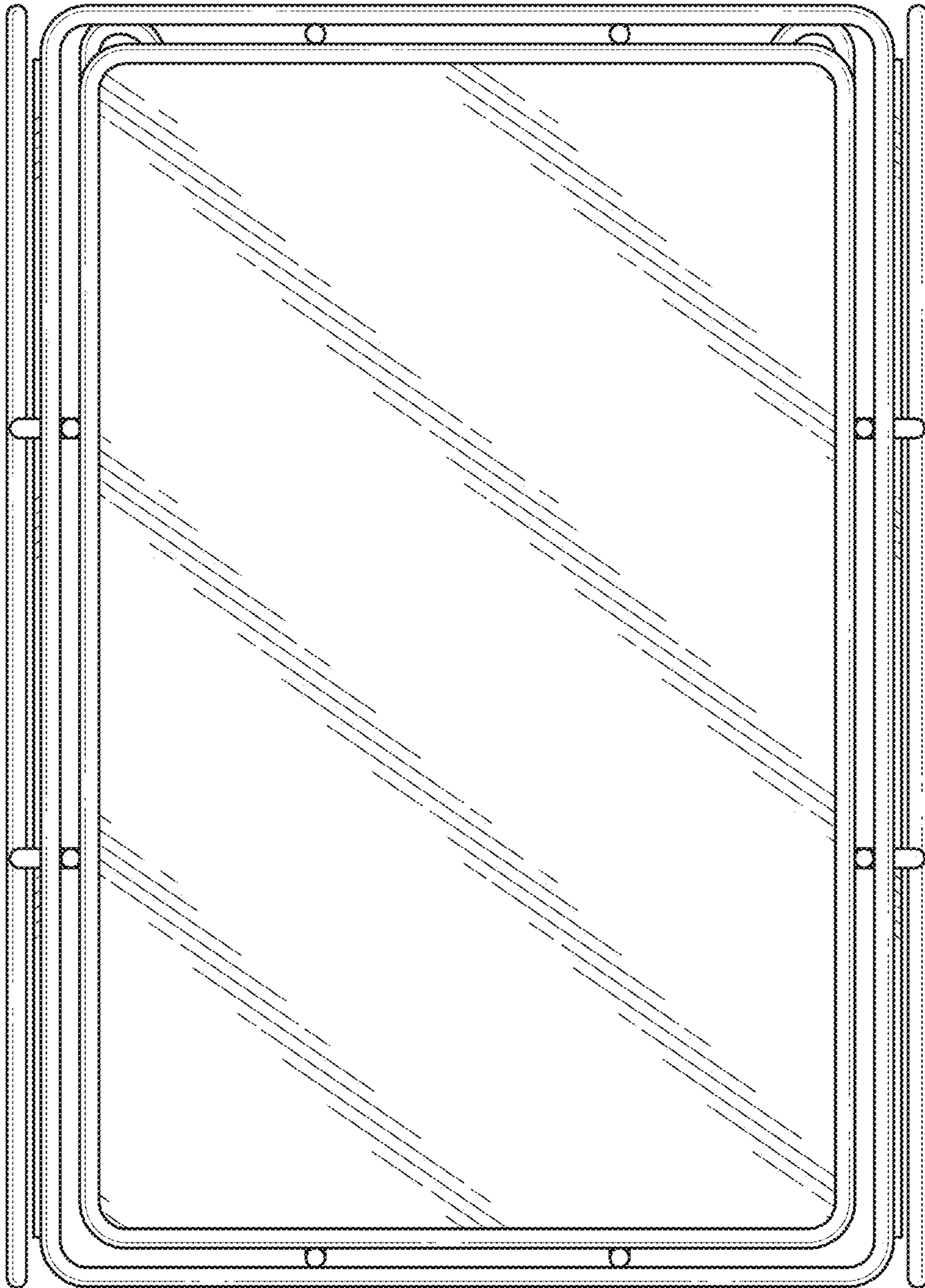

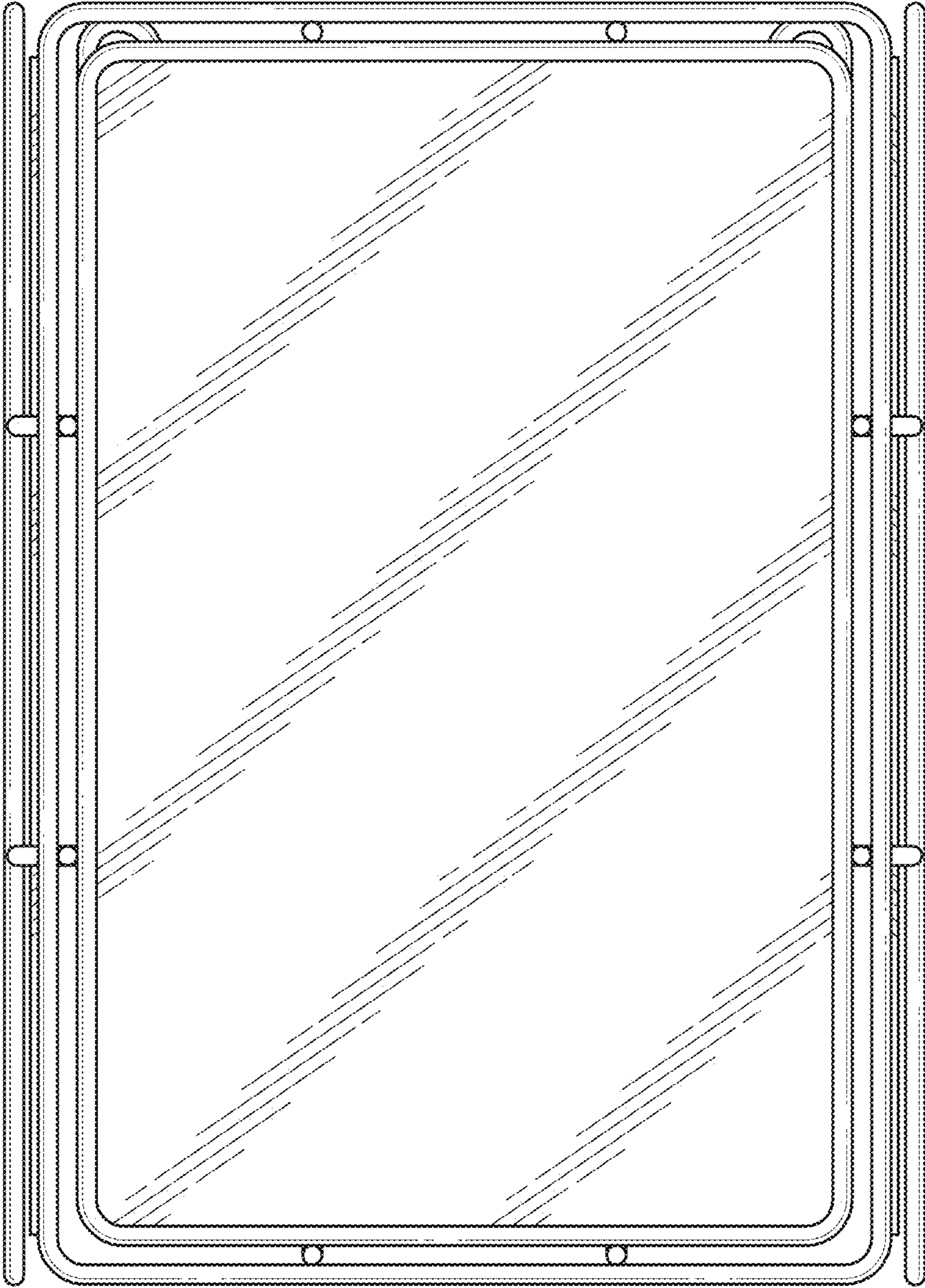

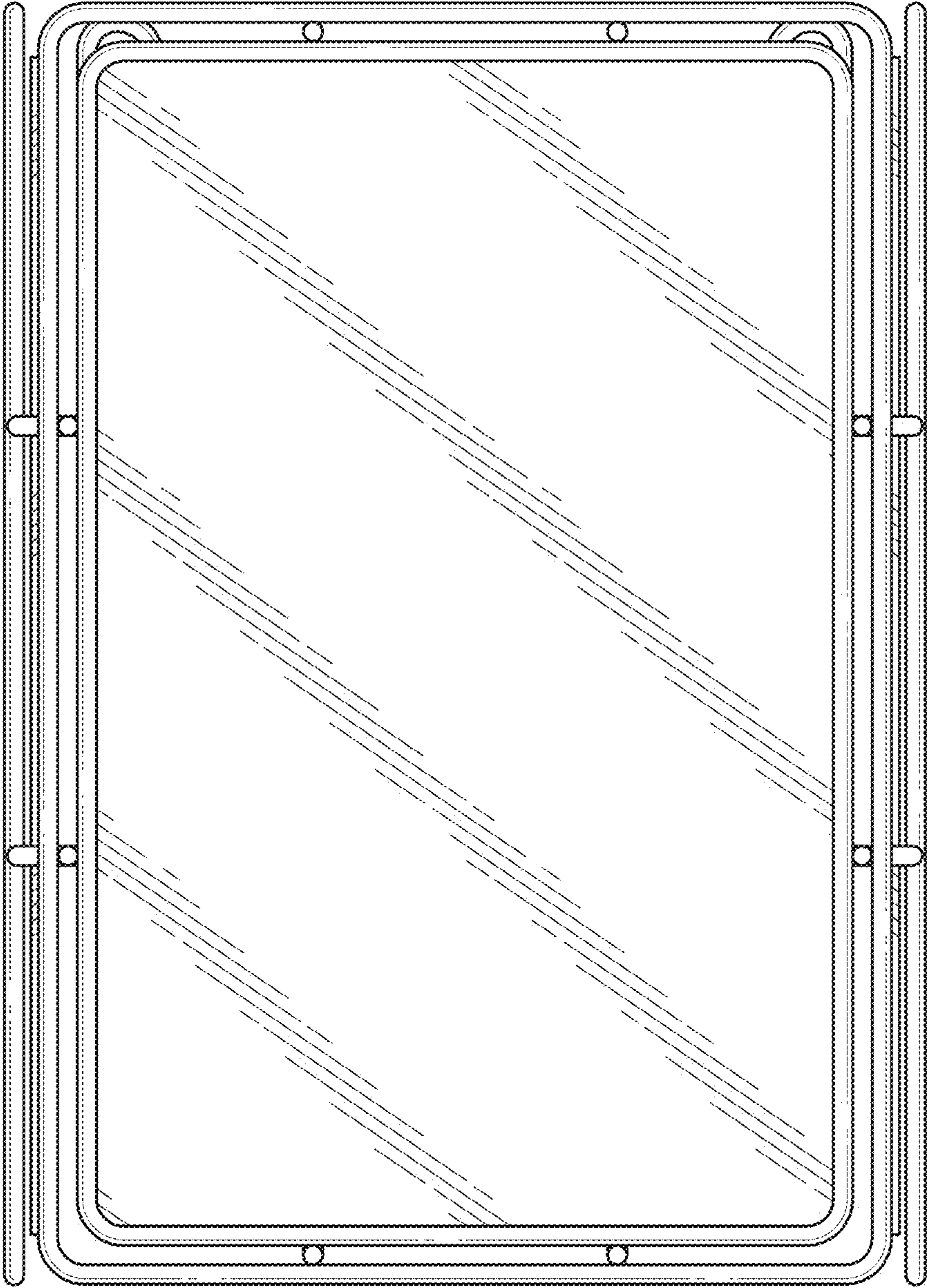

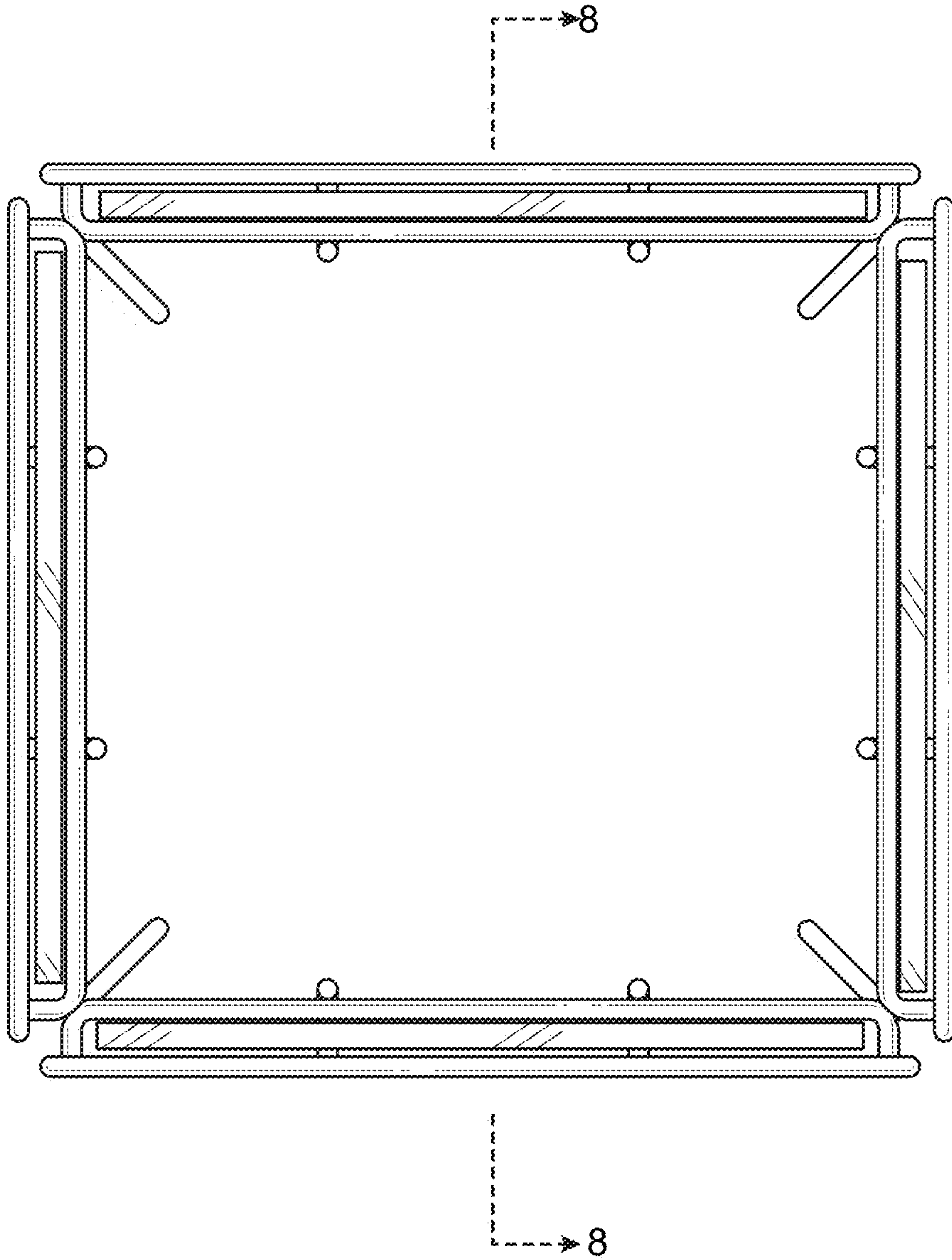

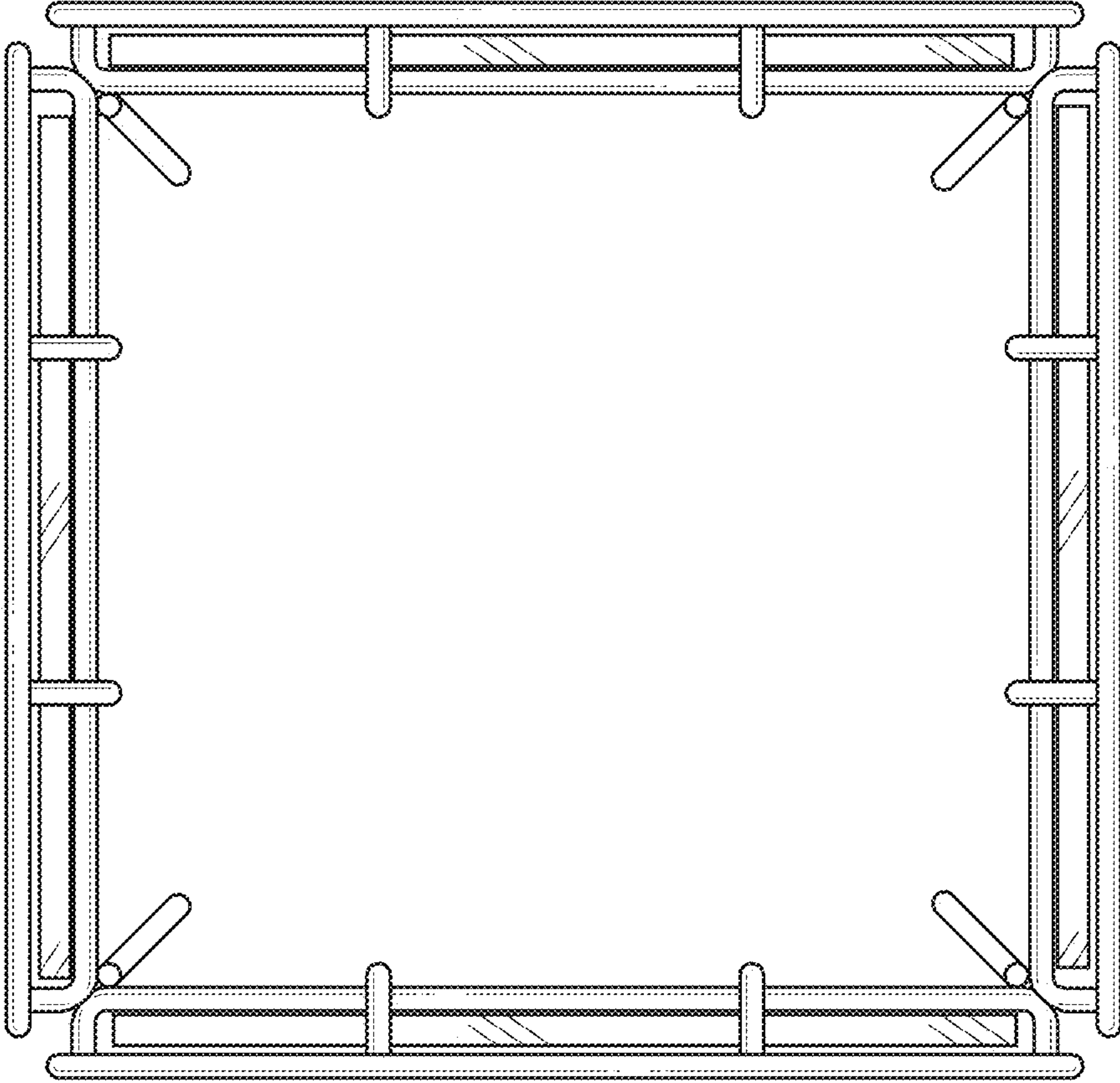

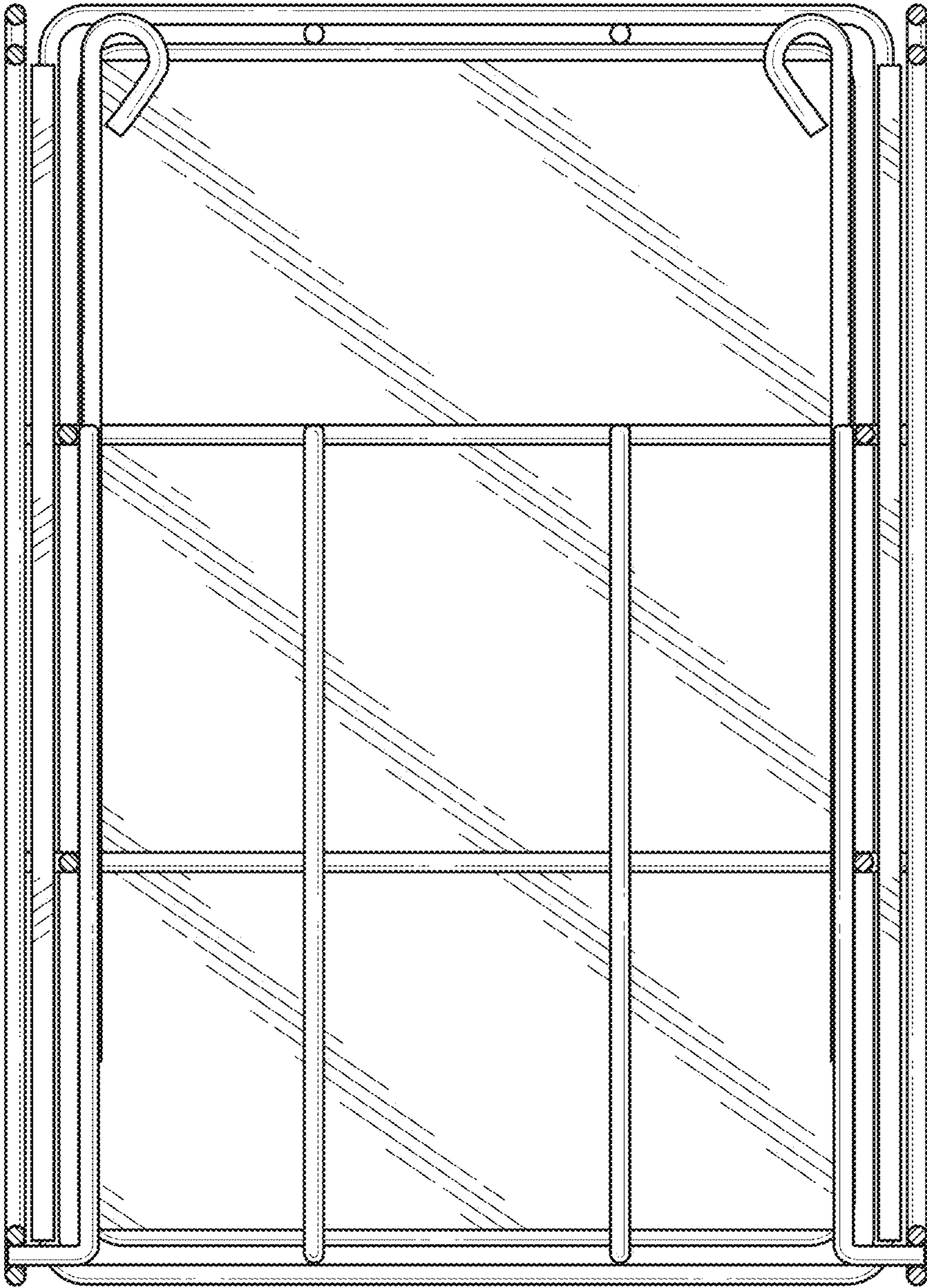
