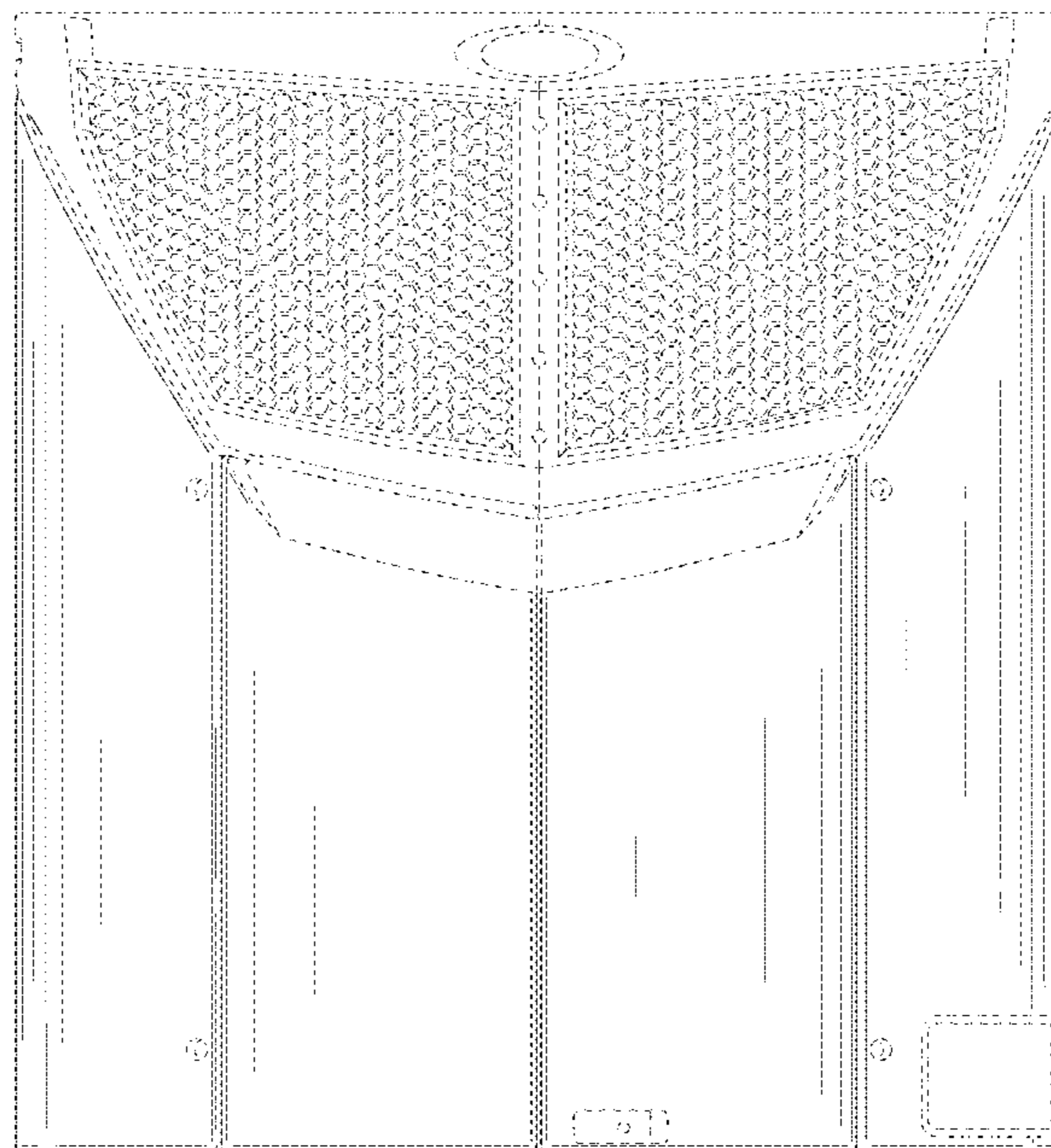
(57) **CLAIM**

We claim, the ornamental design for a cover for transport refrigeration unit, as shown and described.

**DESCRIPTION**

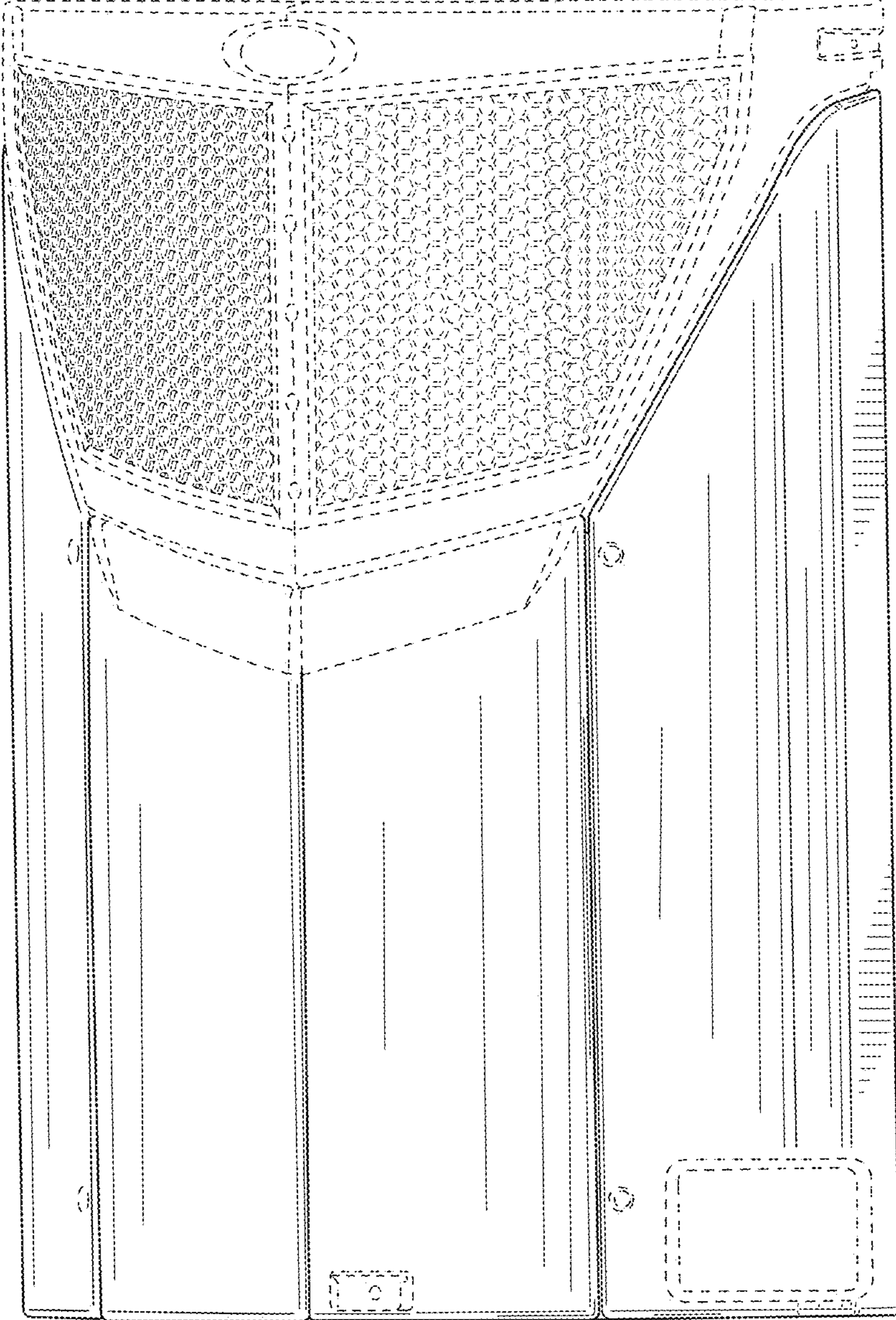

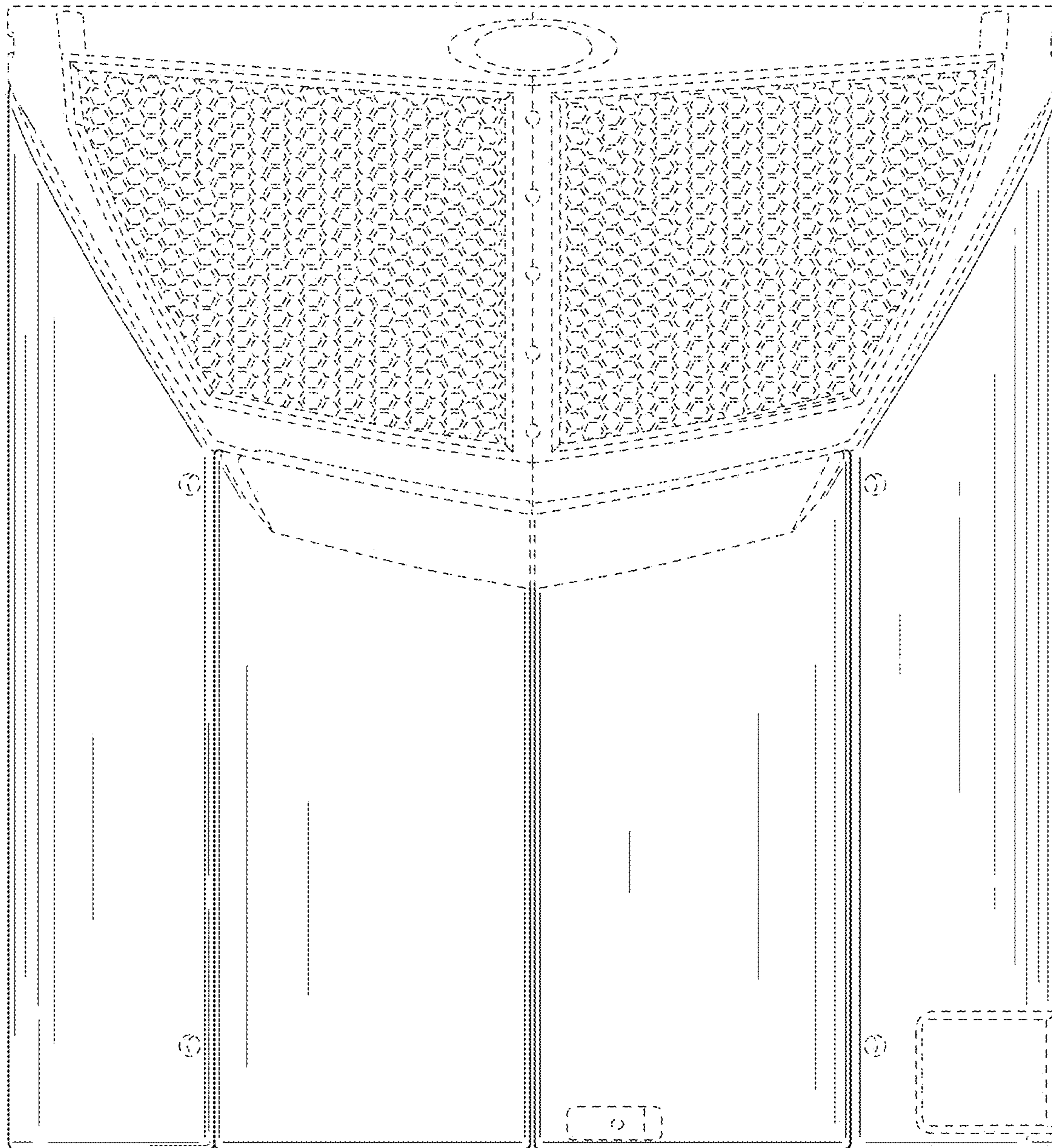

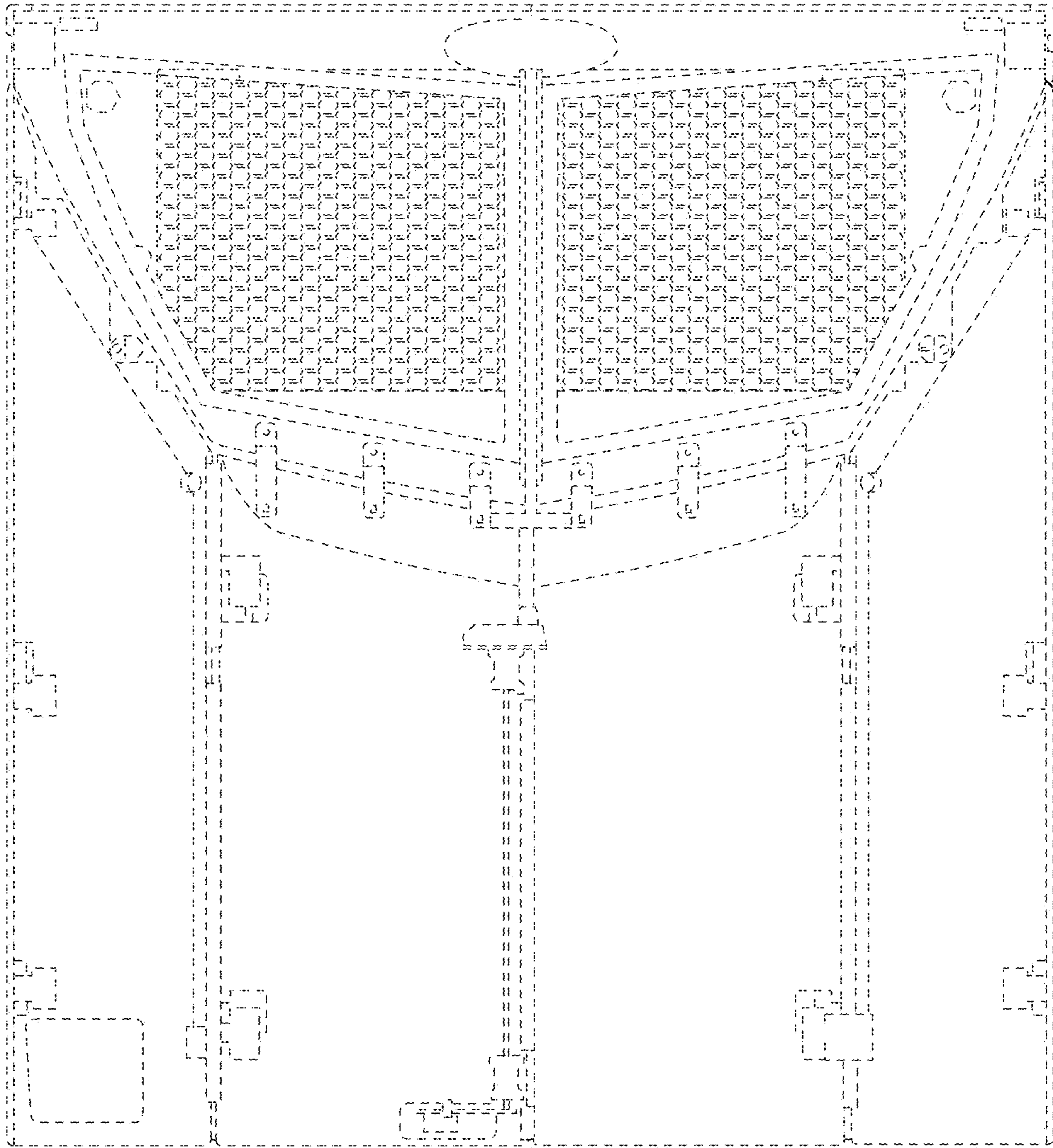

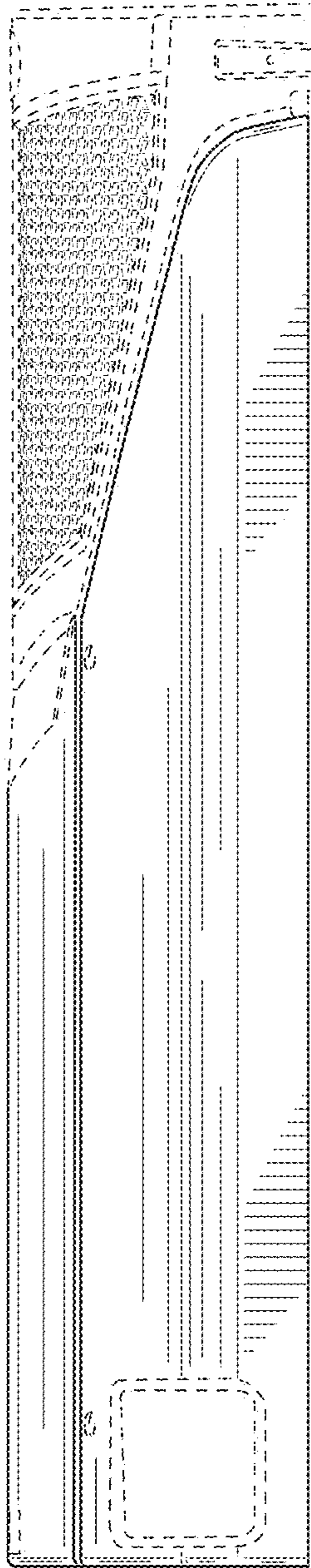

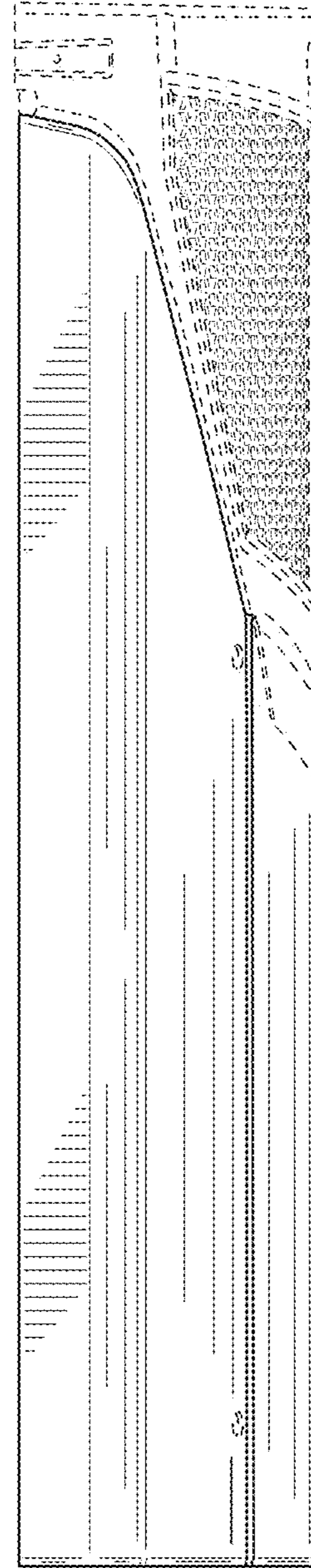

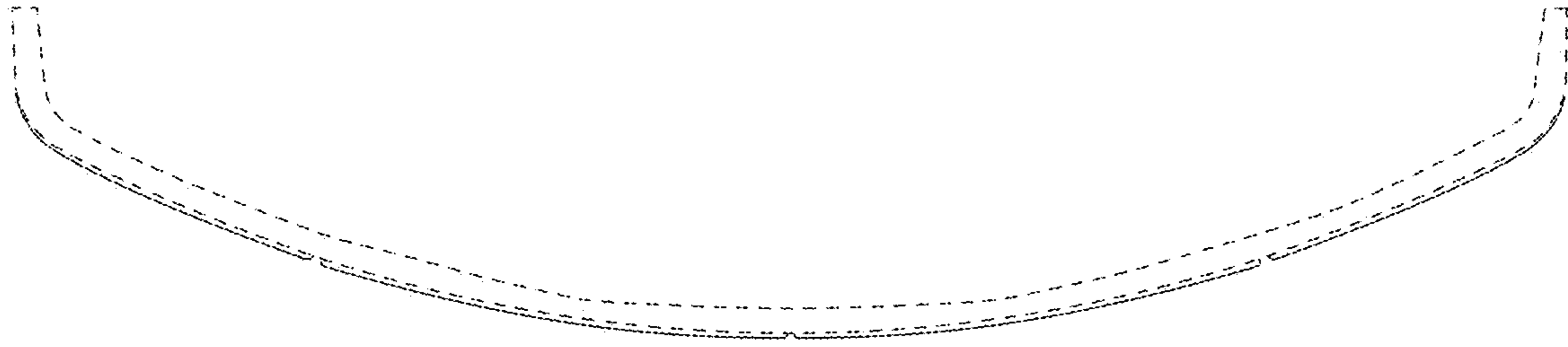

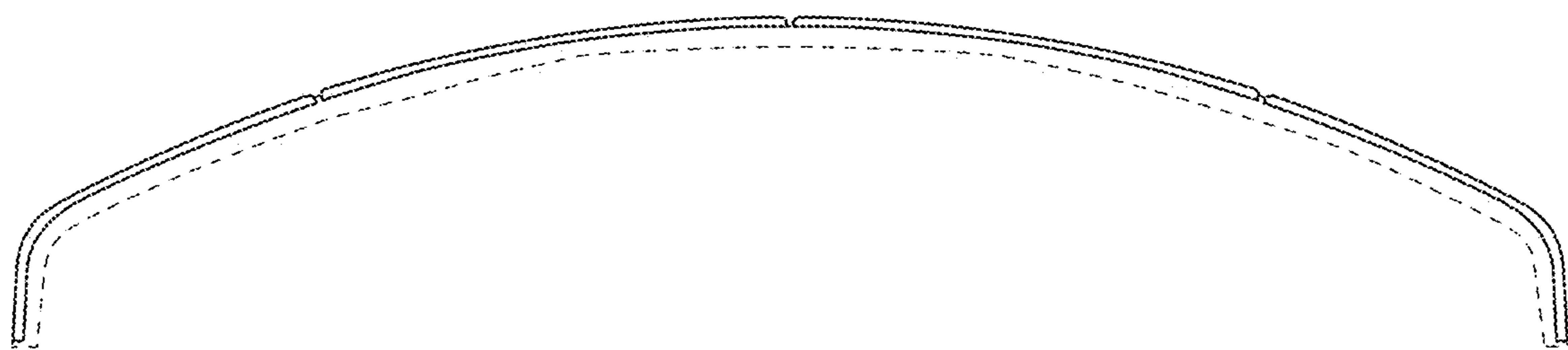

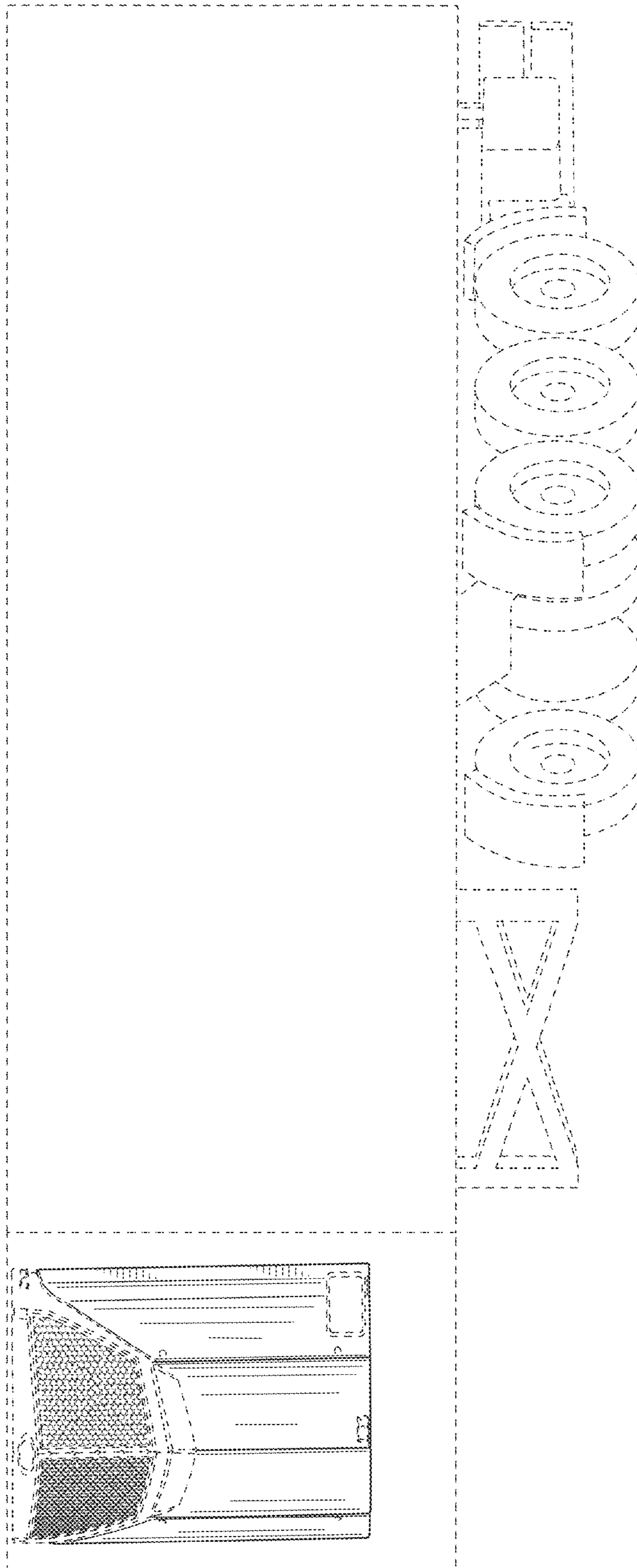
