DESCRIPTION

FIG. 1 is a front view of an inverter showing my new design; FIG. 2 is a first side view thereof; FIG. 3 is a second side thereof; FIG. 4 is a bottom view thereof; FIG. 5 is a top view thereof; FIG. 6 is a rear view thereof; FIG. 7 is a front-top-second side perspective view thereof; and, FIG. 8 is a back-top-first side perspective view thereof. 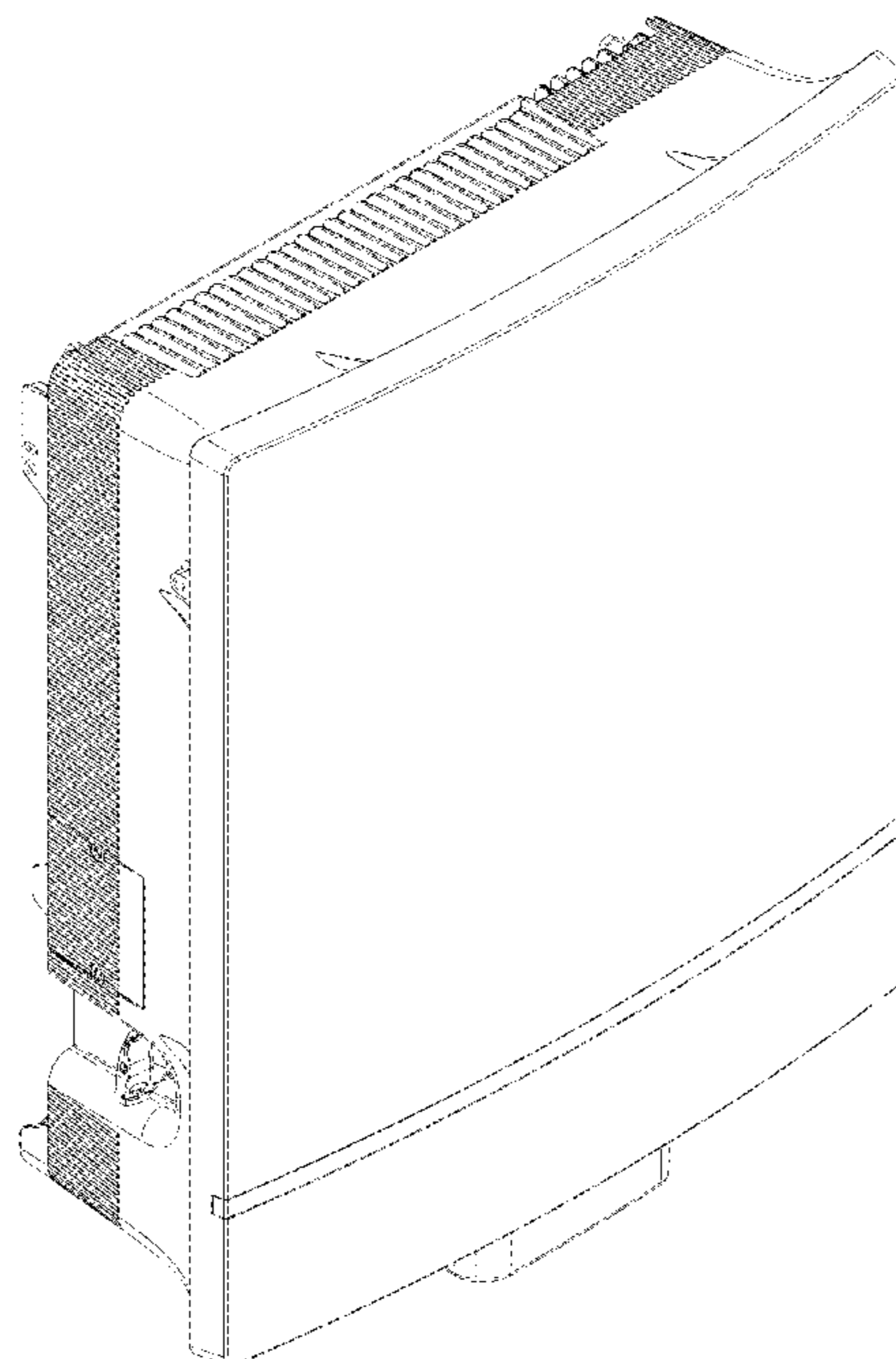

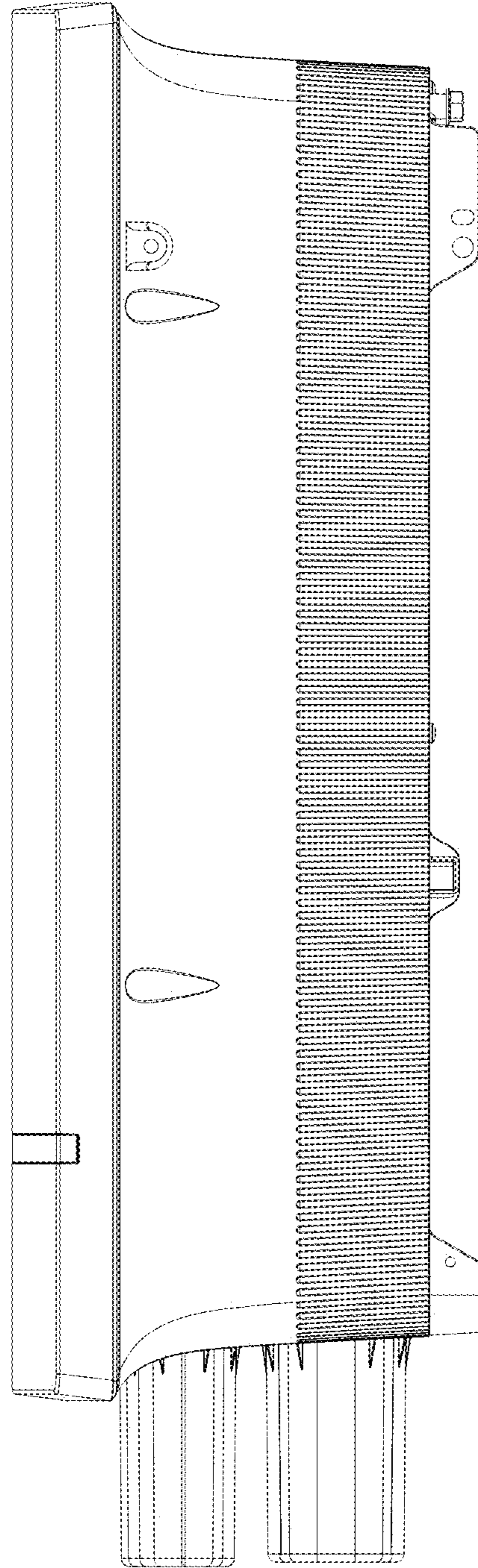

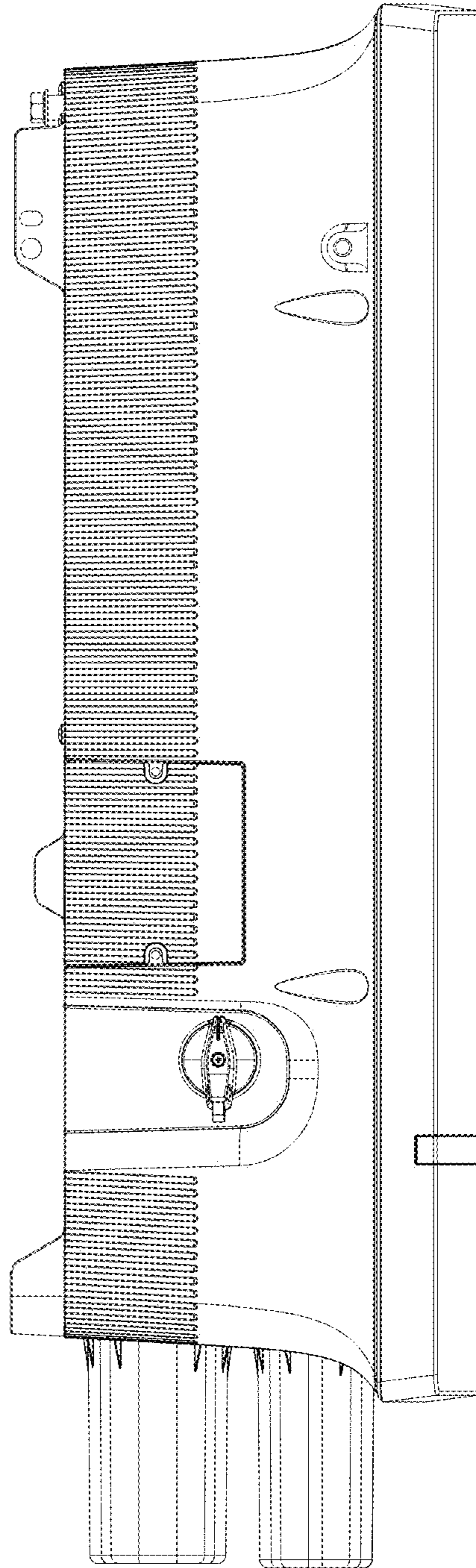

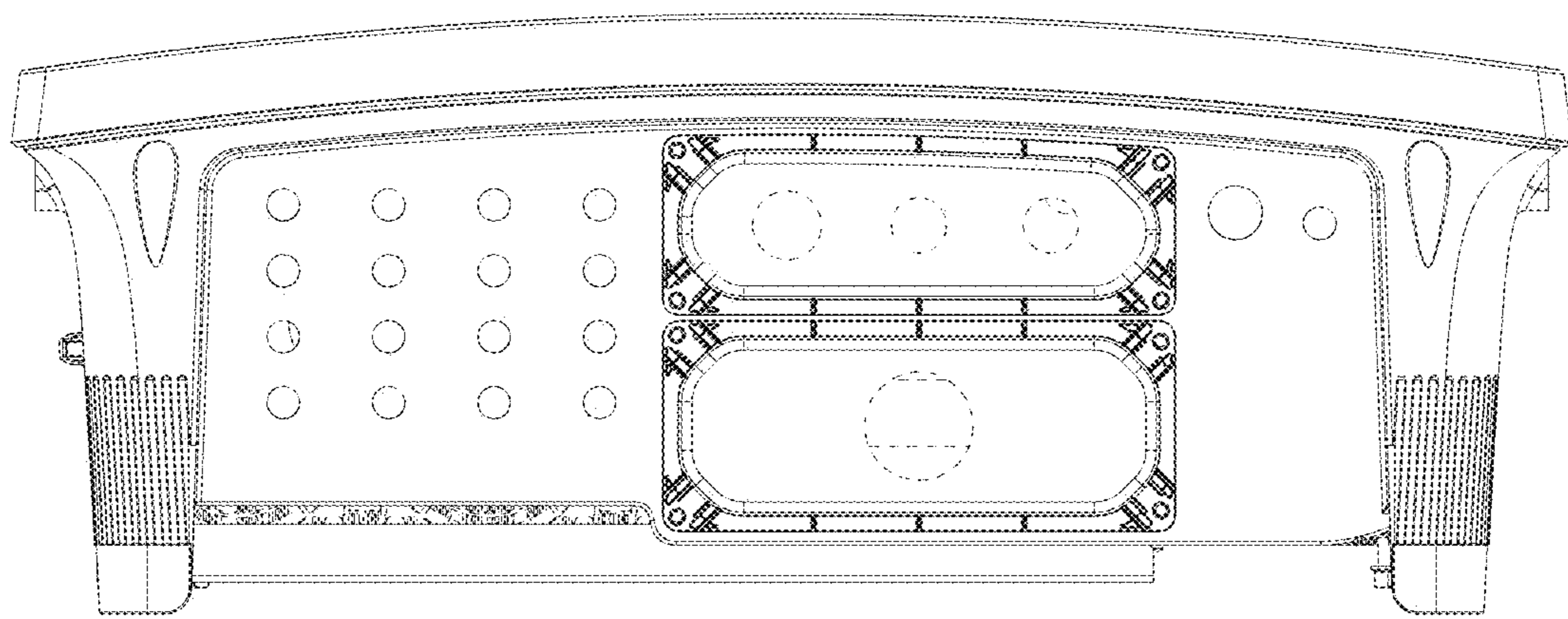

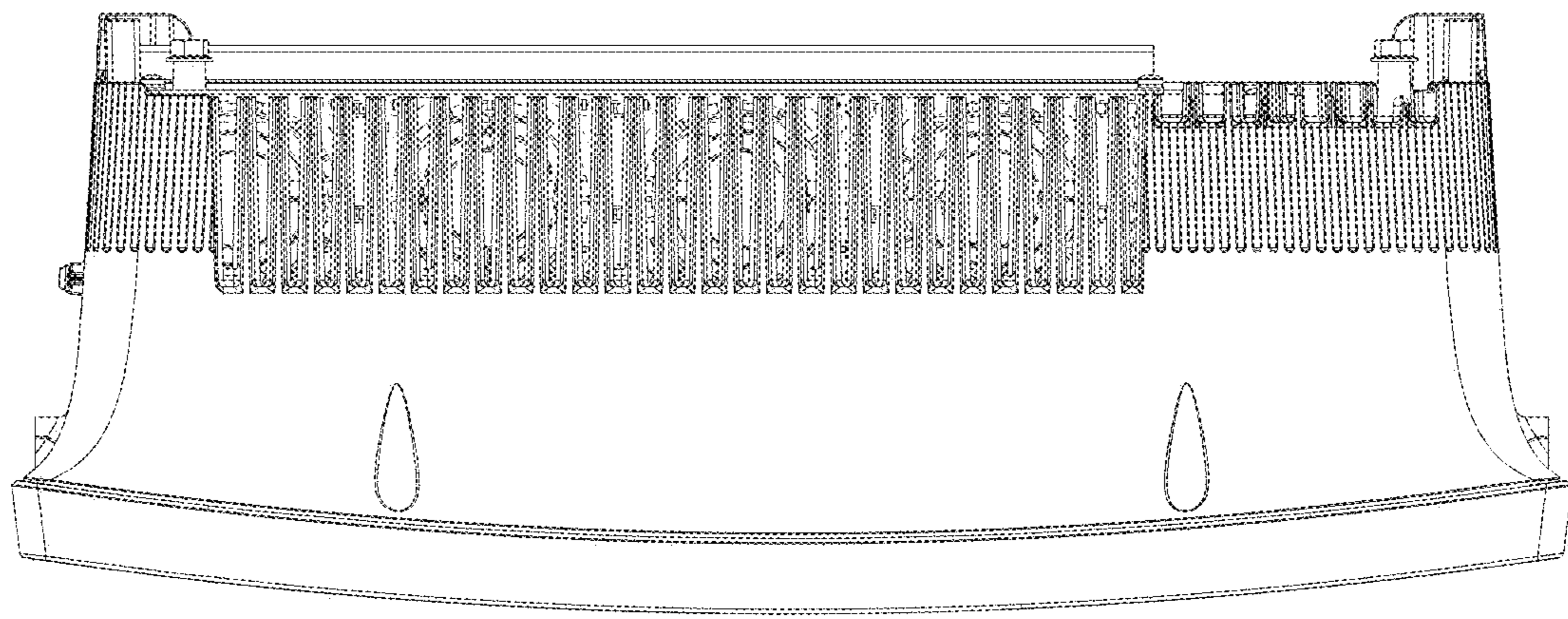

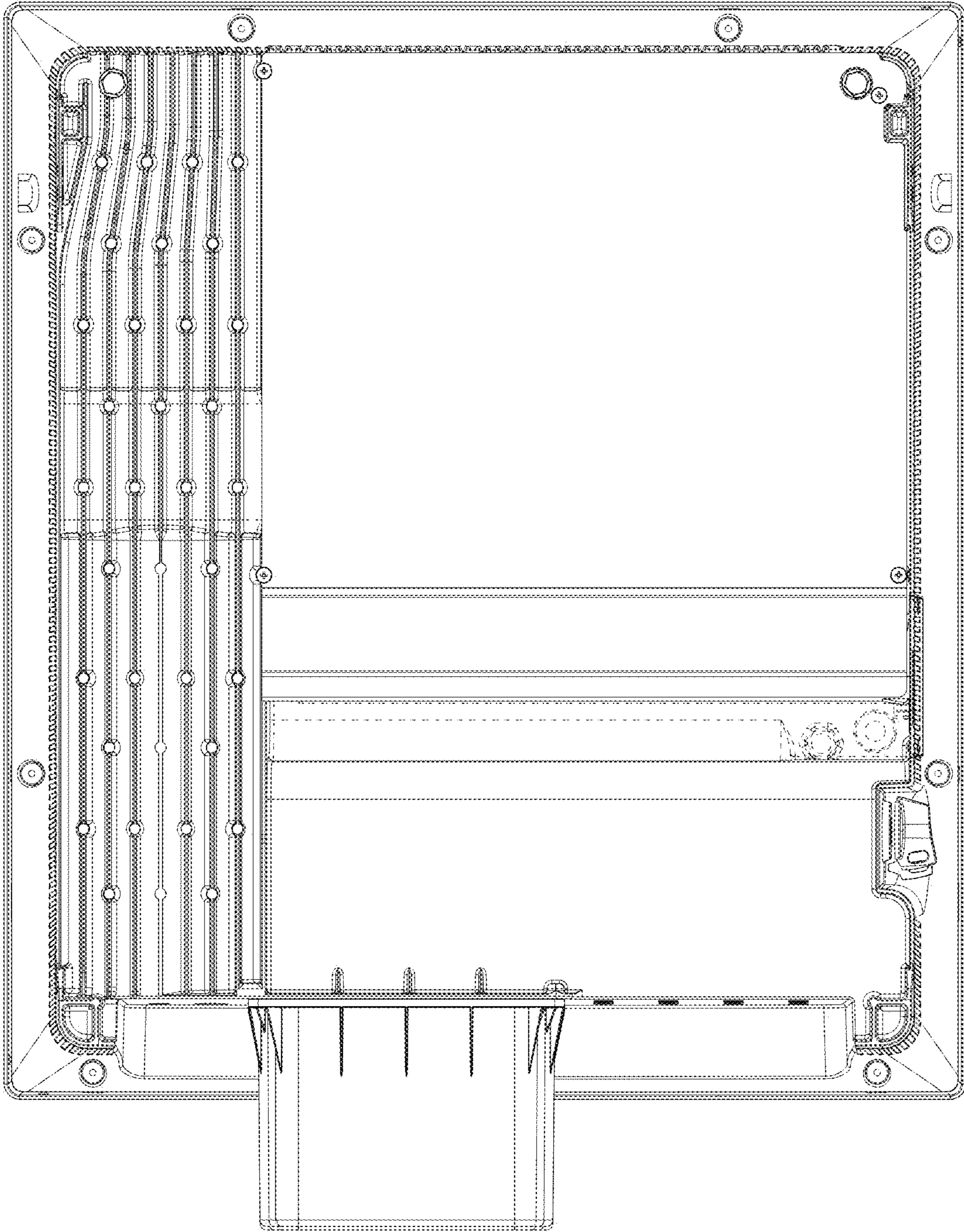

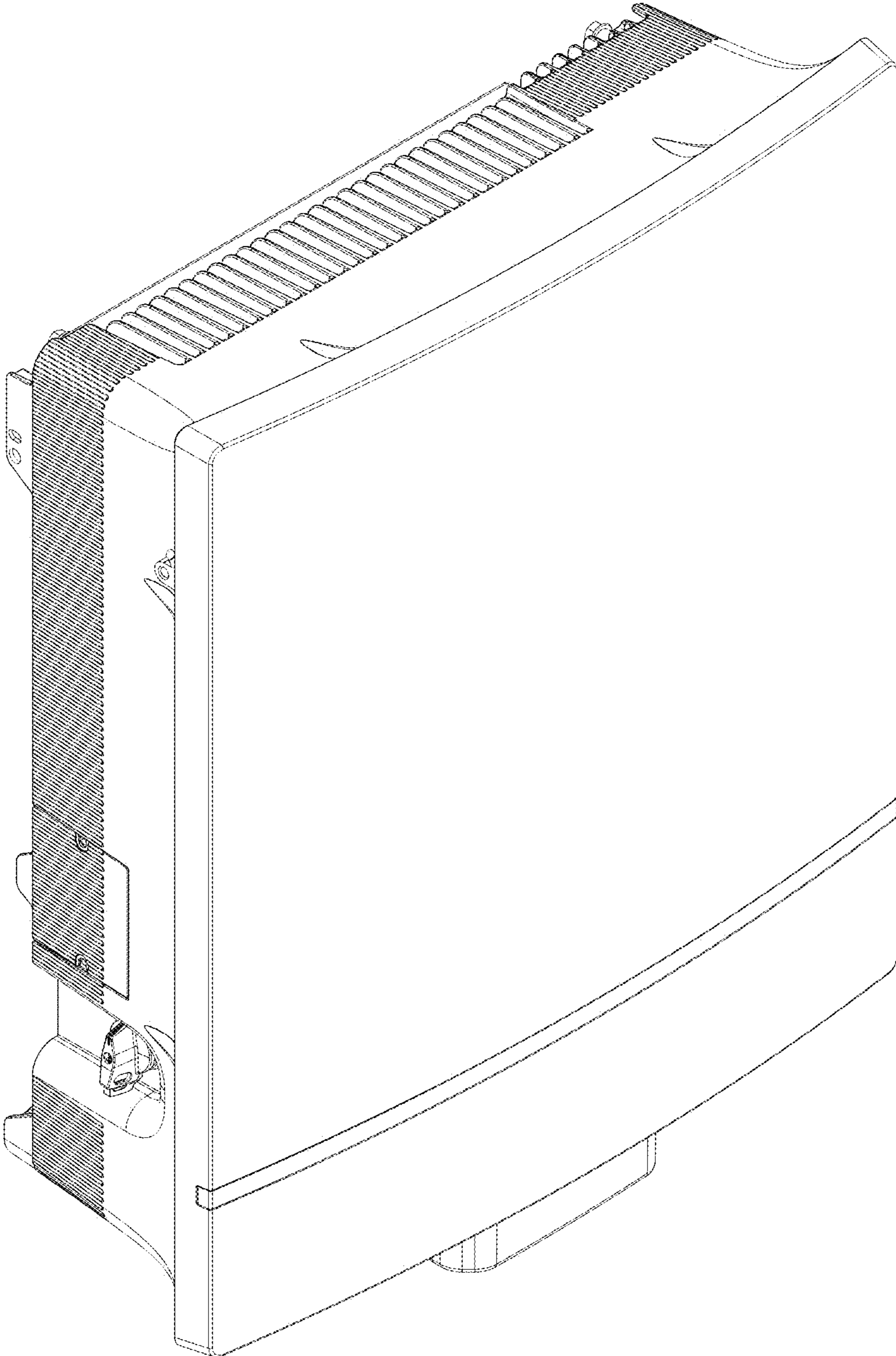

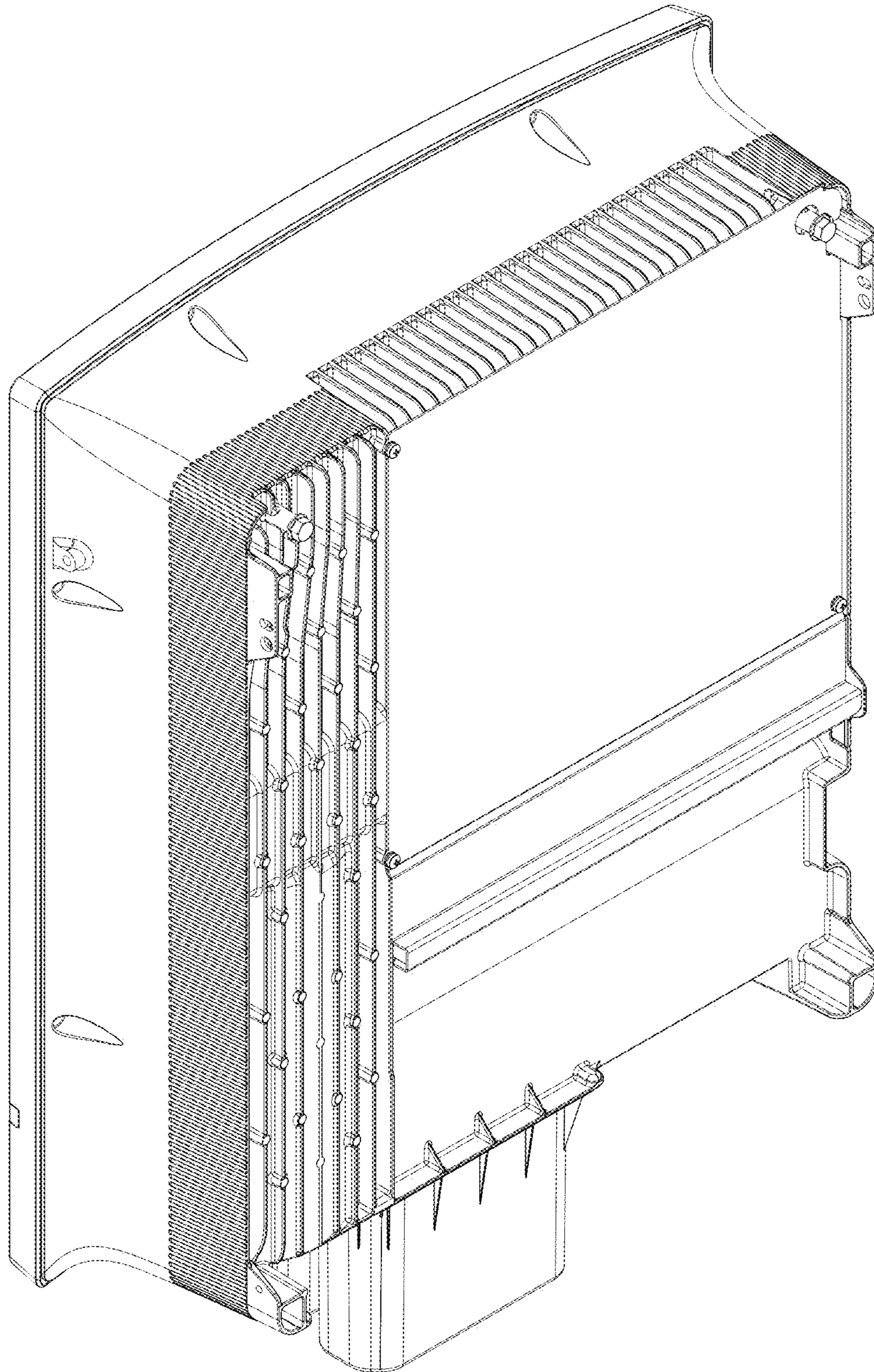
