(57) **CLAIM**

We claim the ornamental design for a case for electronic communications device, as shown and described.

DESCRIPTION

FIG. 1 is a front, right-side, and top perspective view of a case for electronic communications device showing our new design;

FIG. 2 is a front view thereof;

FIG. 3 is a rear view thereof;

FIG. 4 is a left-side view thereof;

FIG. 5 is a right-side view thereof;

FIG. 6 is a top view thereof;

FIG. 7 is a bottom view thereof;

FIG. 8 is a rear, left-side, and bottom perspective view thereof;

FIG. 9 is an enlarged view of the encircled portion in FIG. 5; and,

FIG. 10 is an enlarged view of the encircled portion in FIG. 7.

The evenly-dashed broken lines in the figures depict portions of the case for electronic communications device which form no part of the claimed design.

The dot-dash broken lines encircling portions of the claimed design that are illustrated in enlargements form no part of the claimed design.

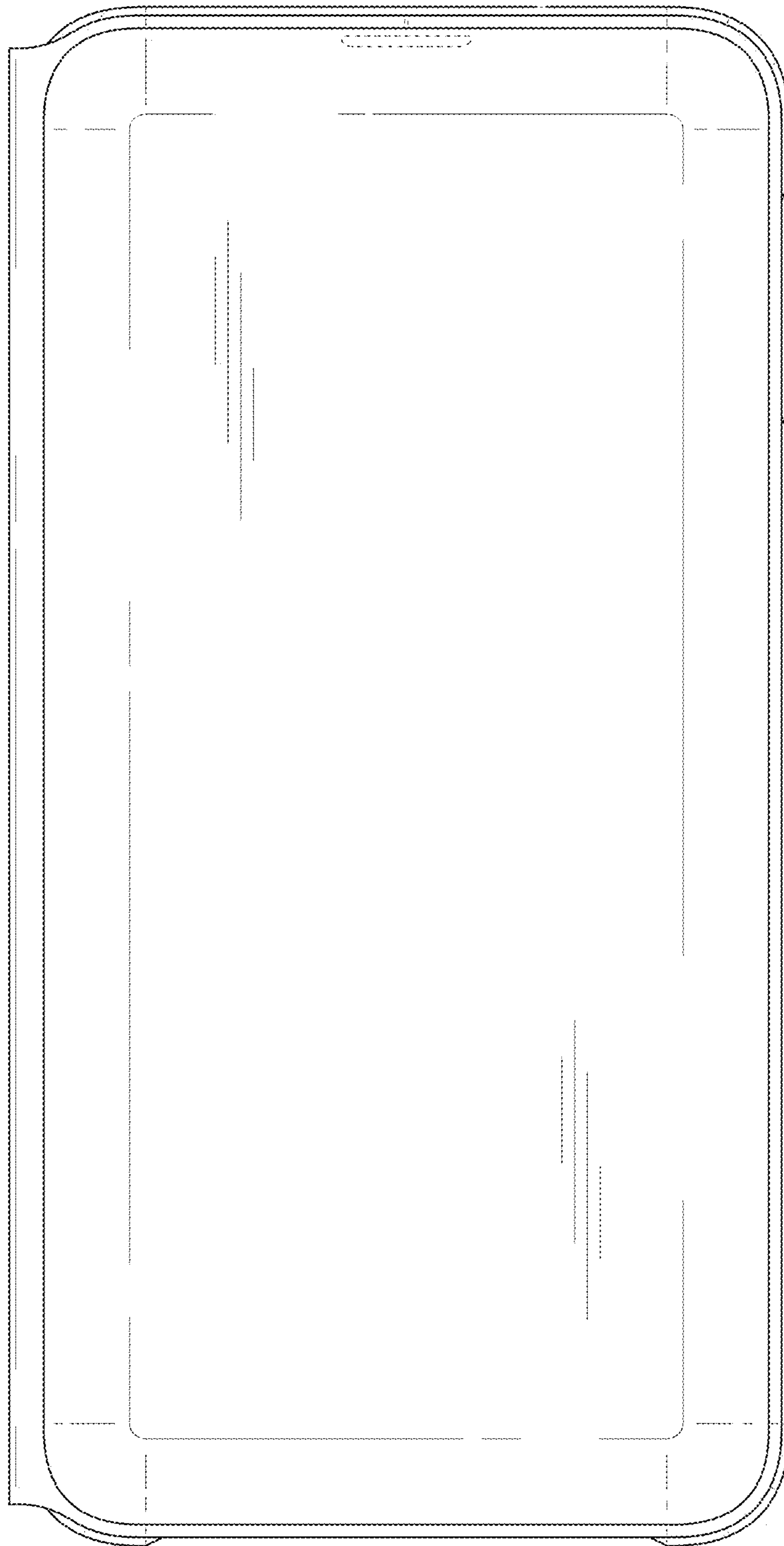

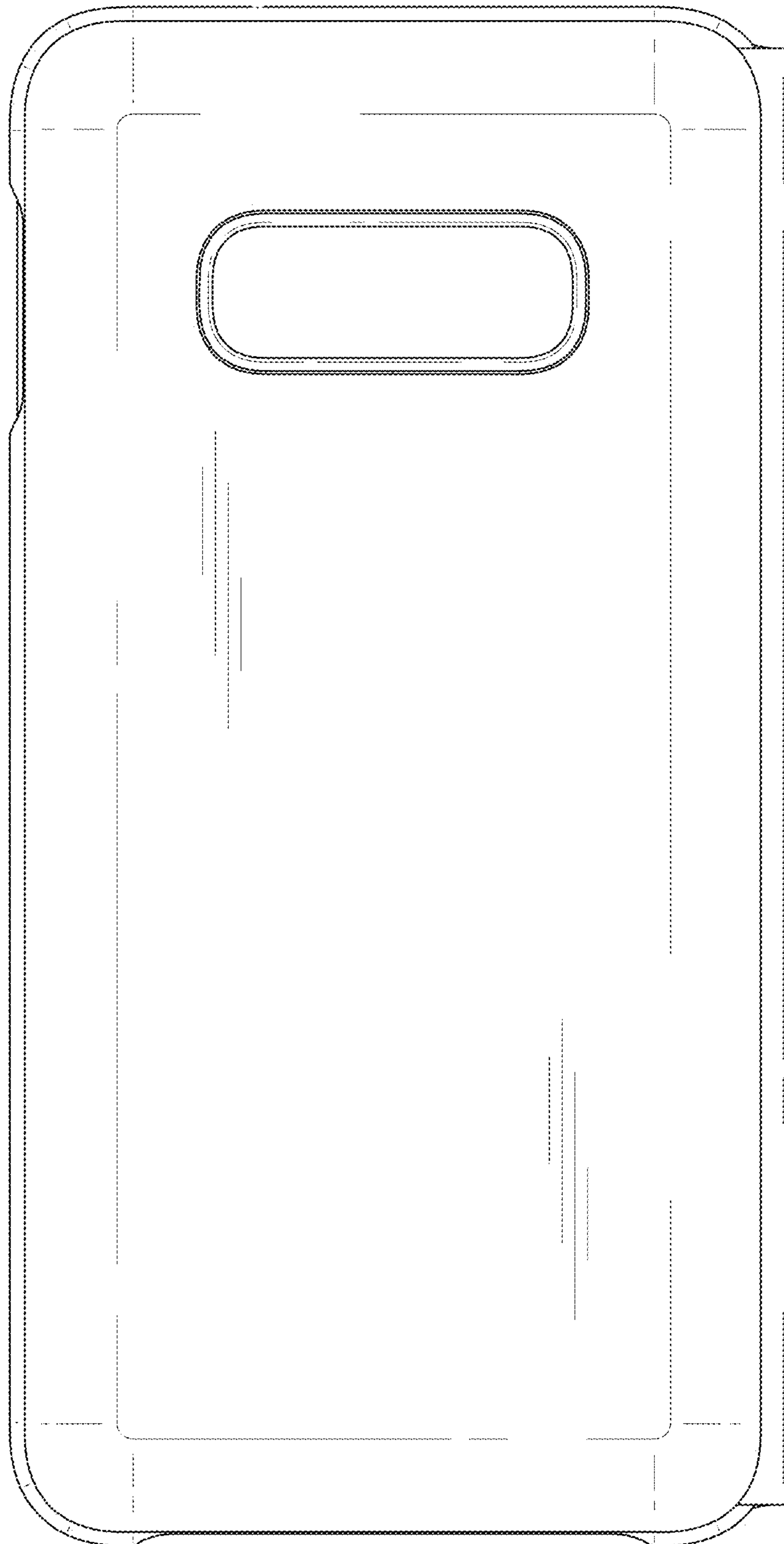

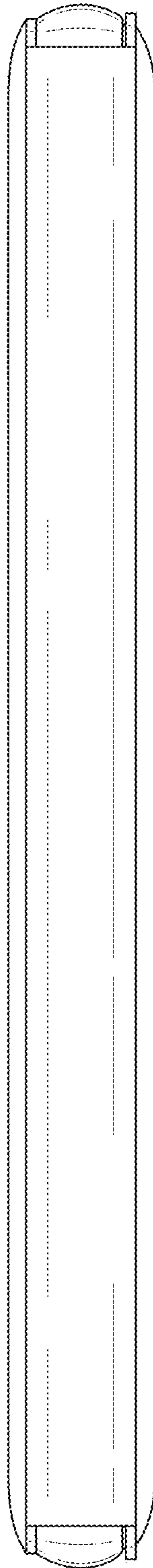

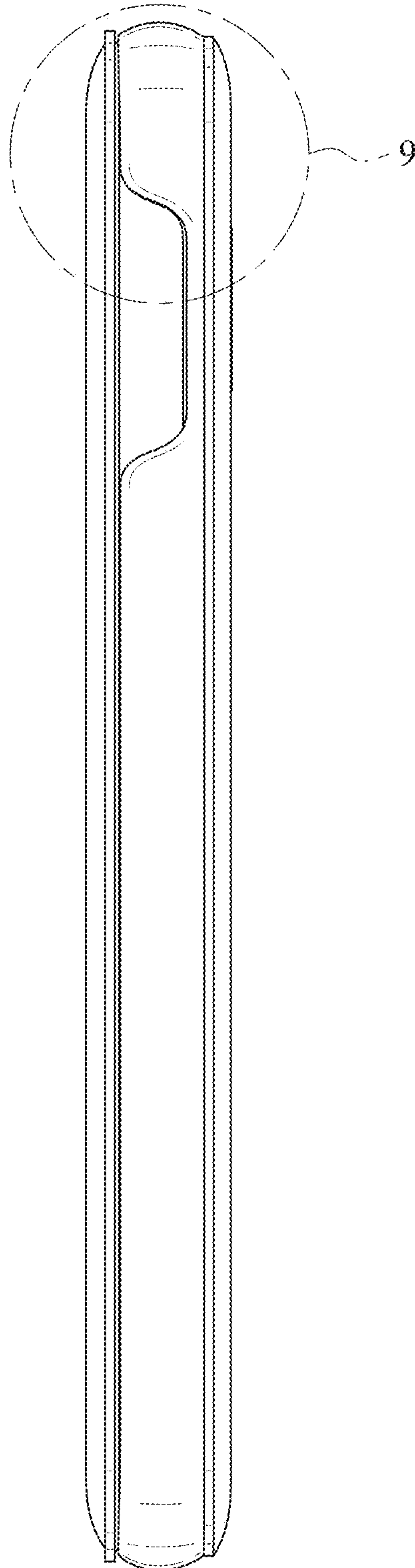

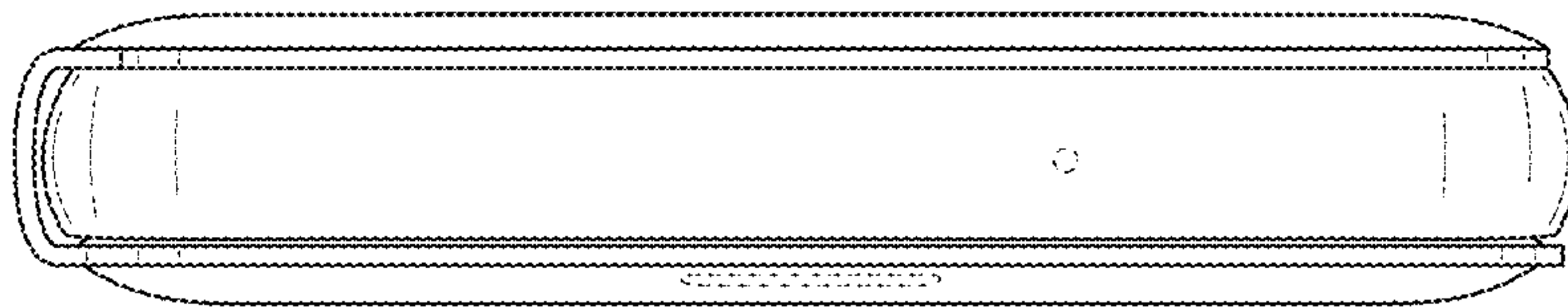

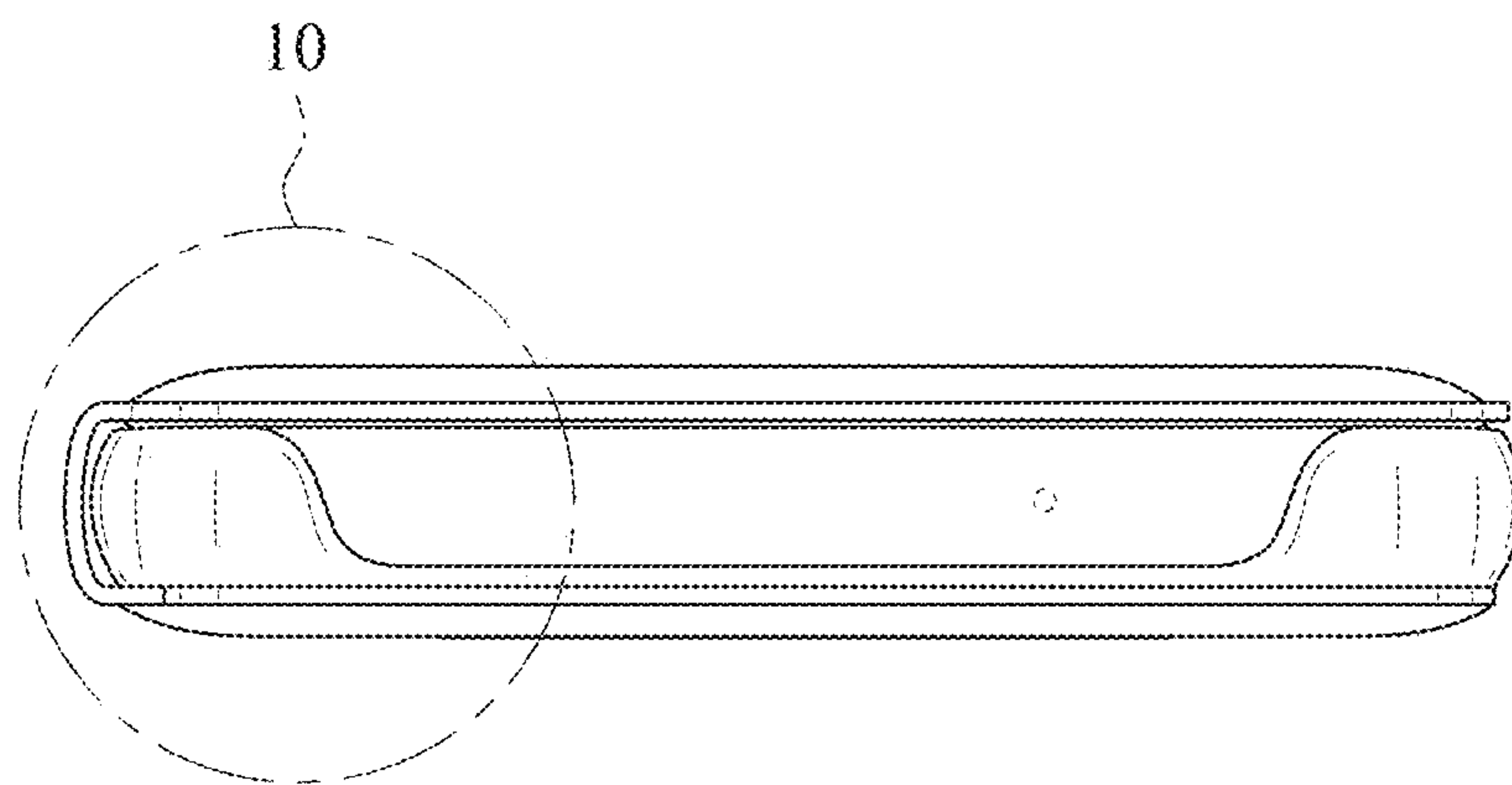

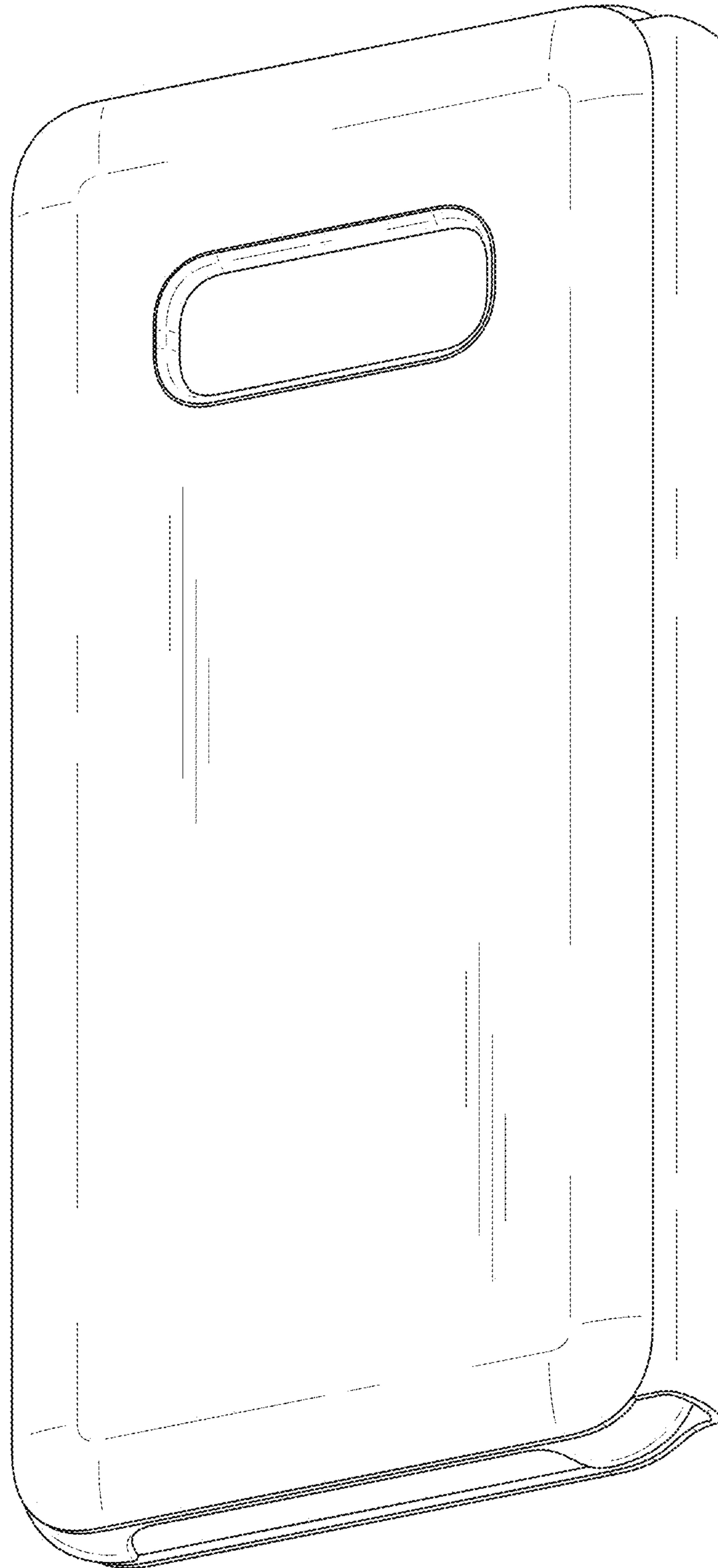

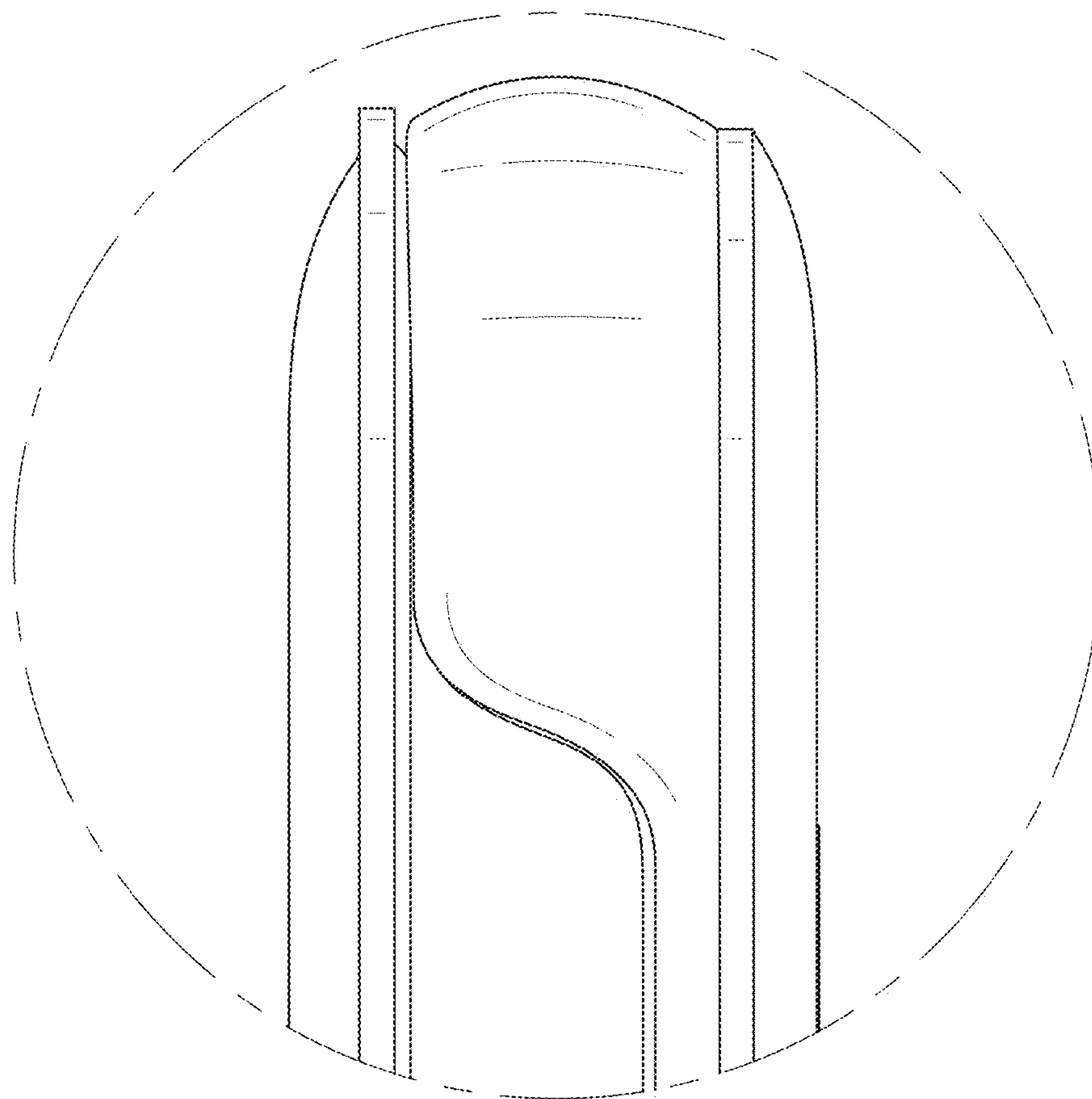
