(57) **CLAIM**

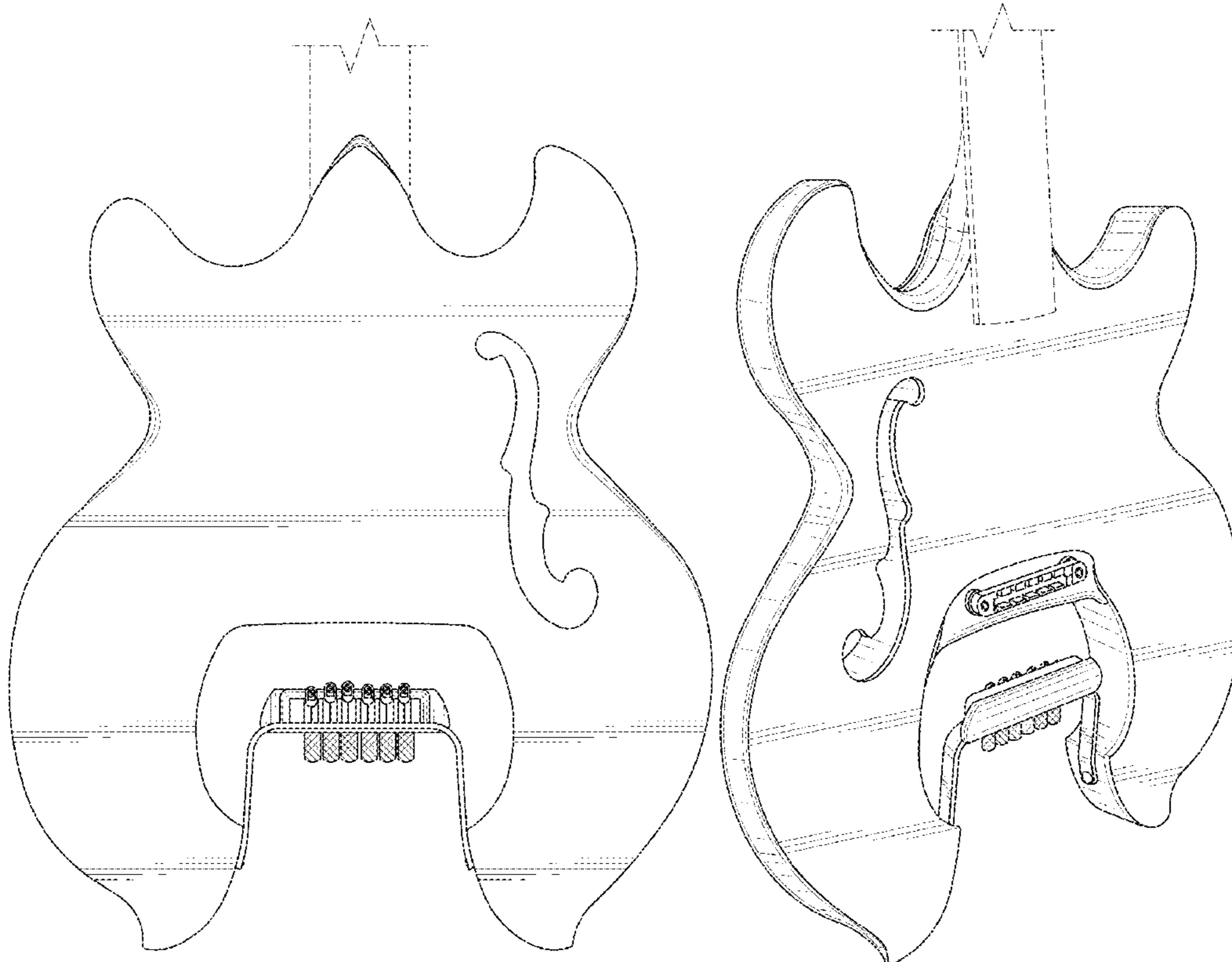
The ornamental design for a guitar body, as shown.

DESCRIPTION

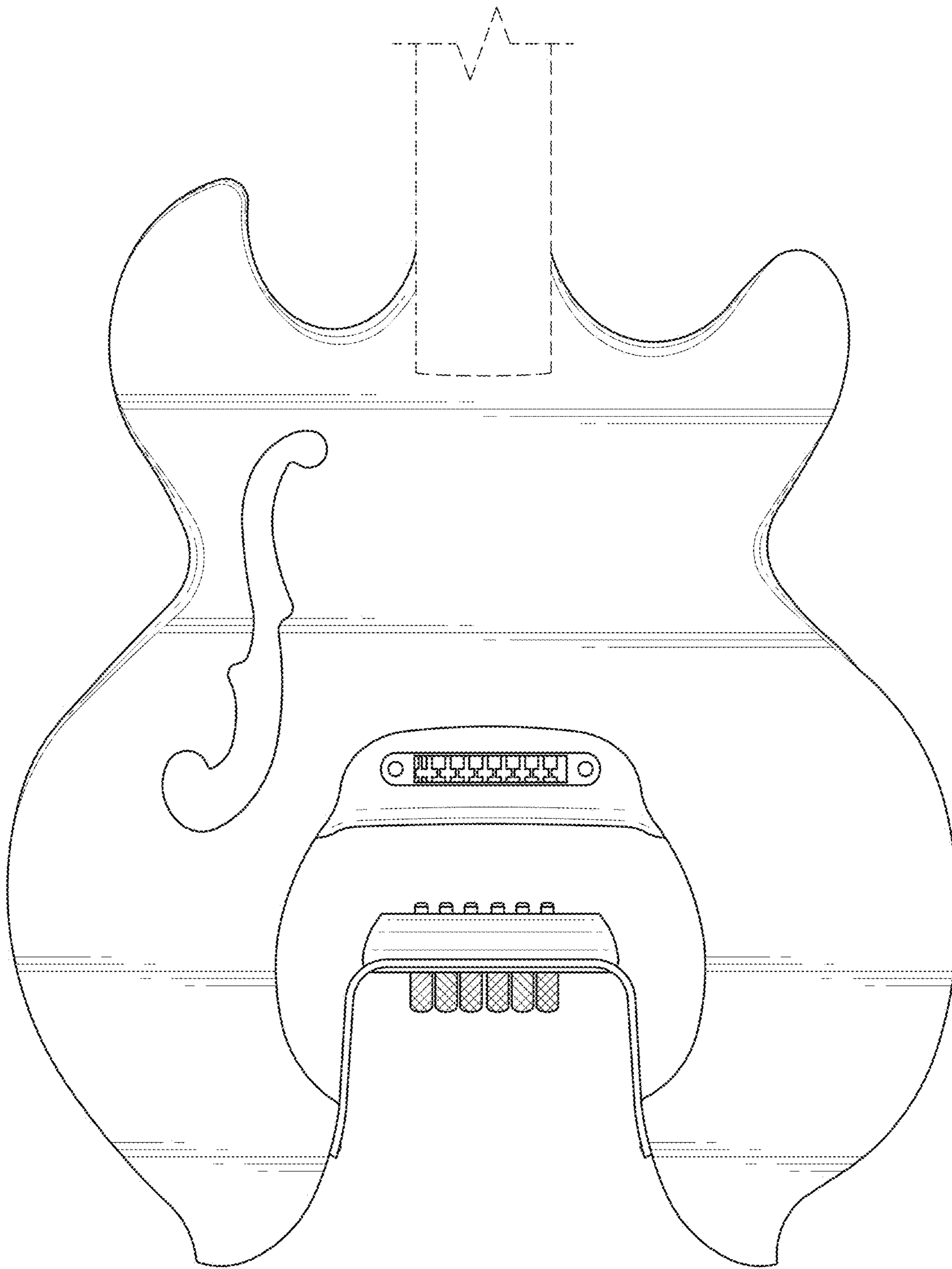

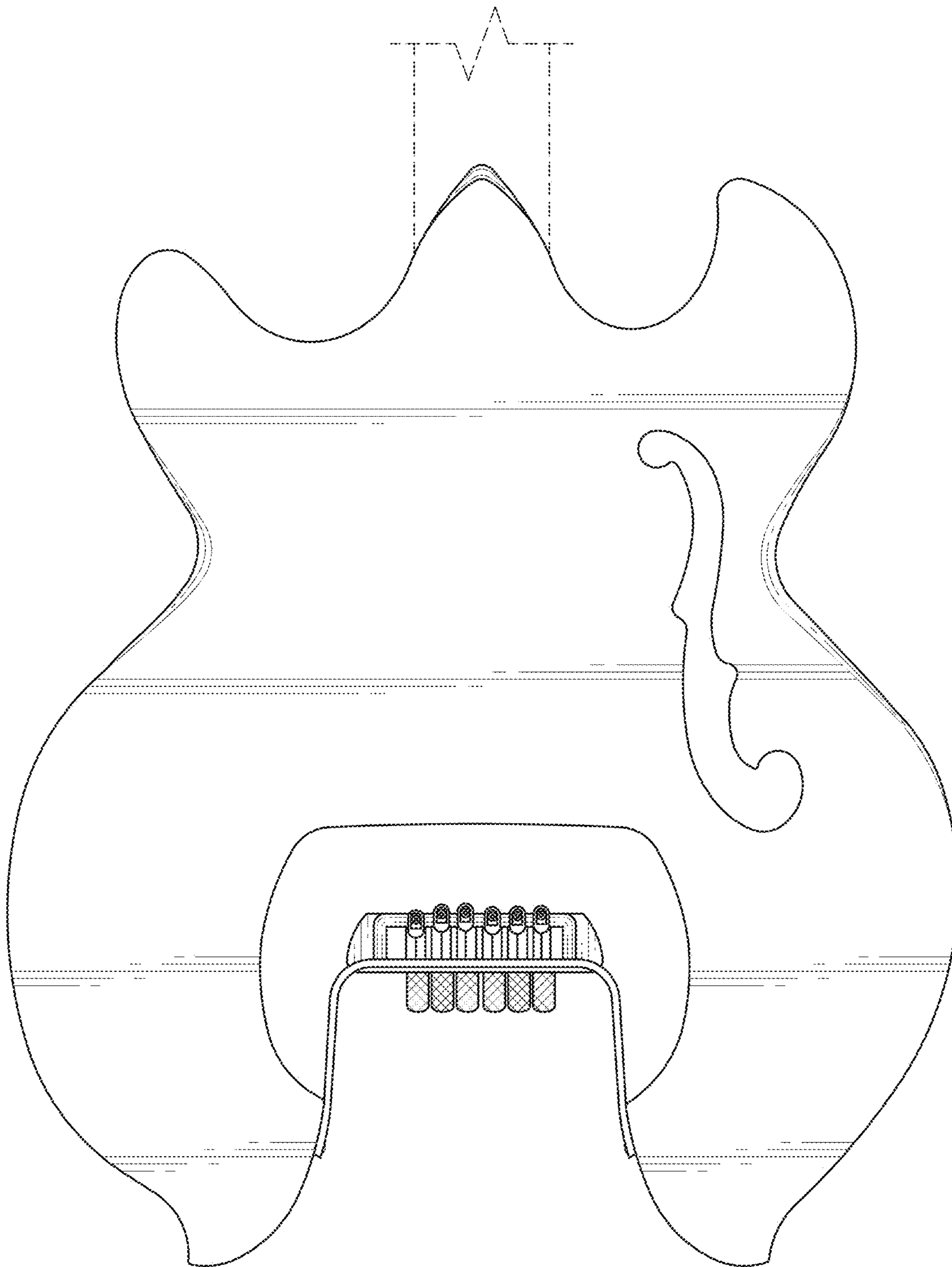

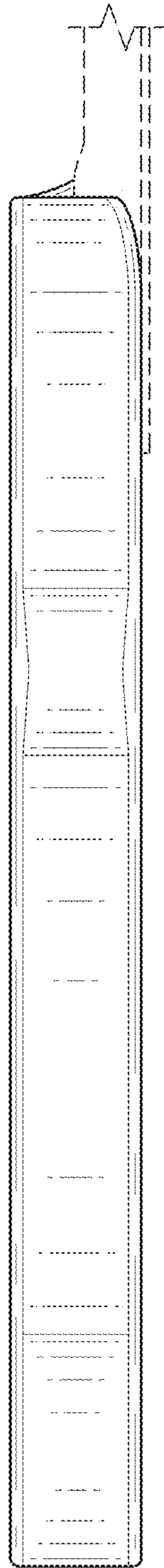

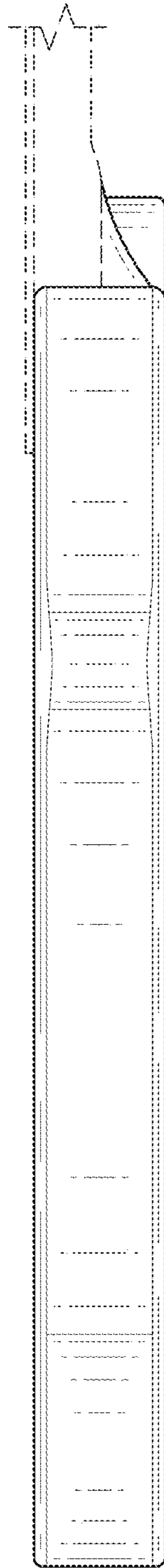

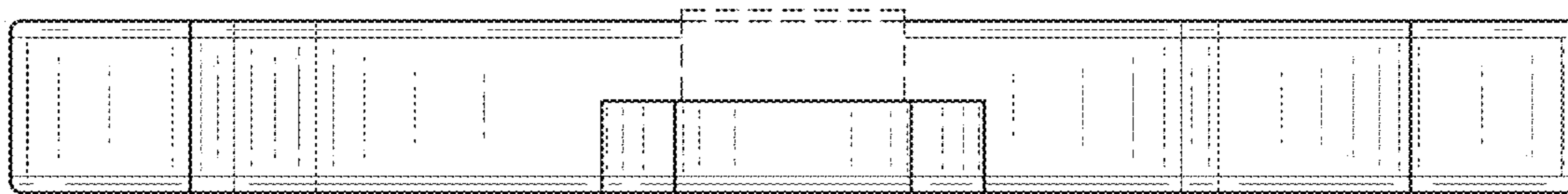

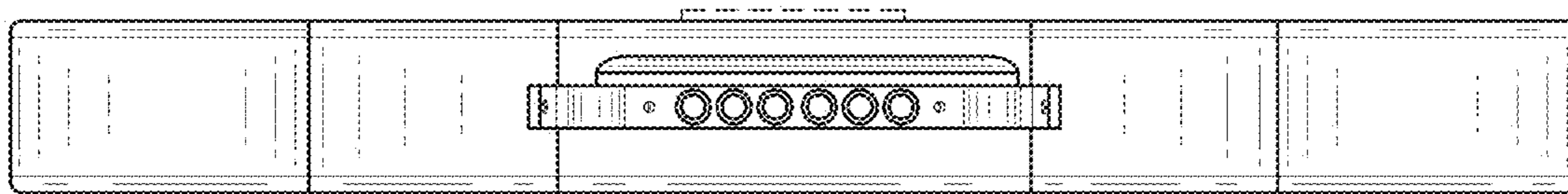

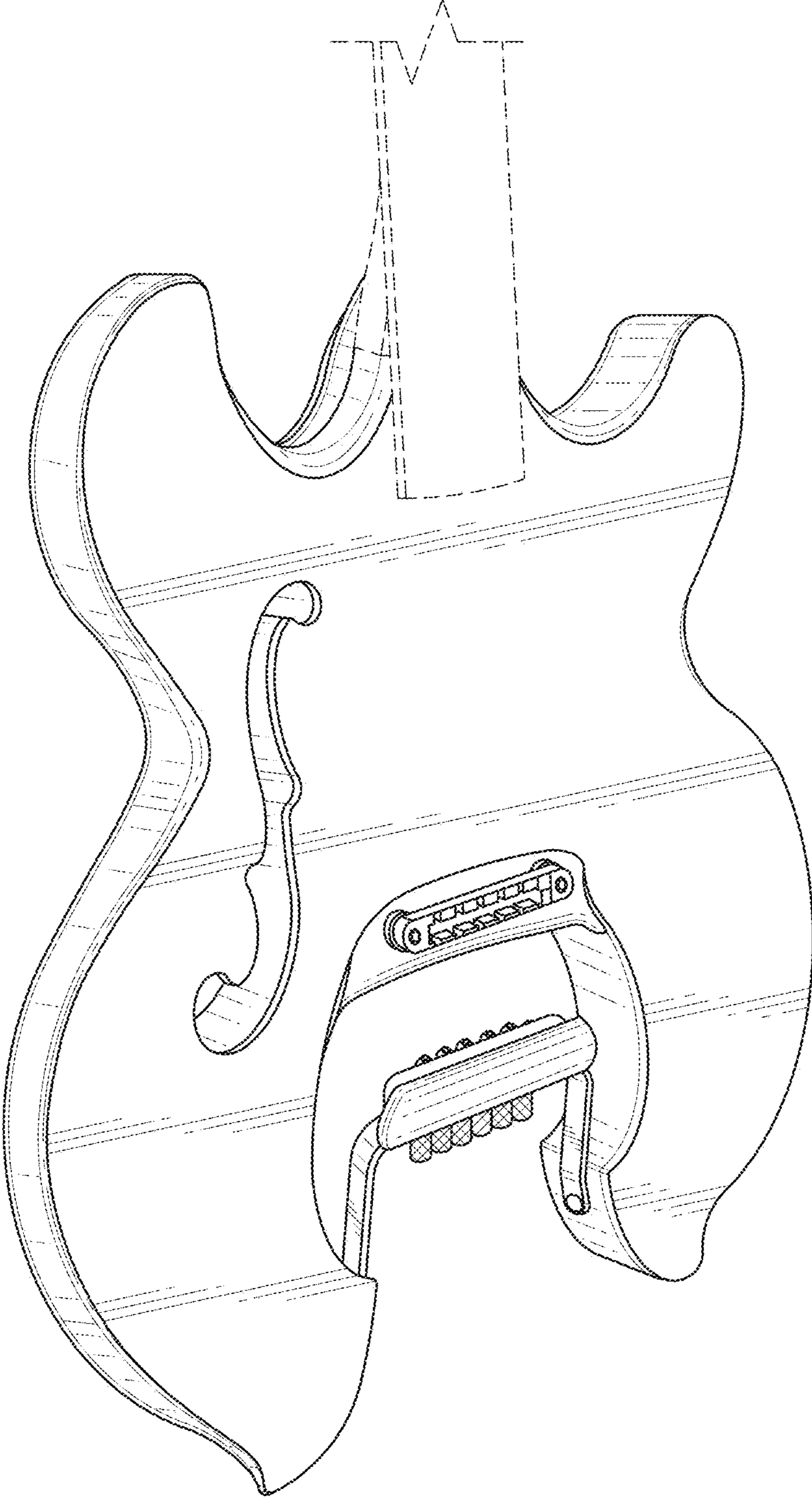

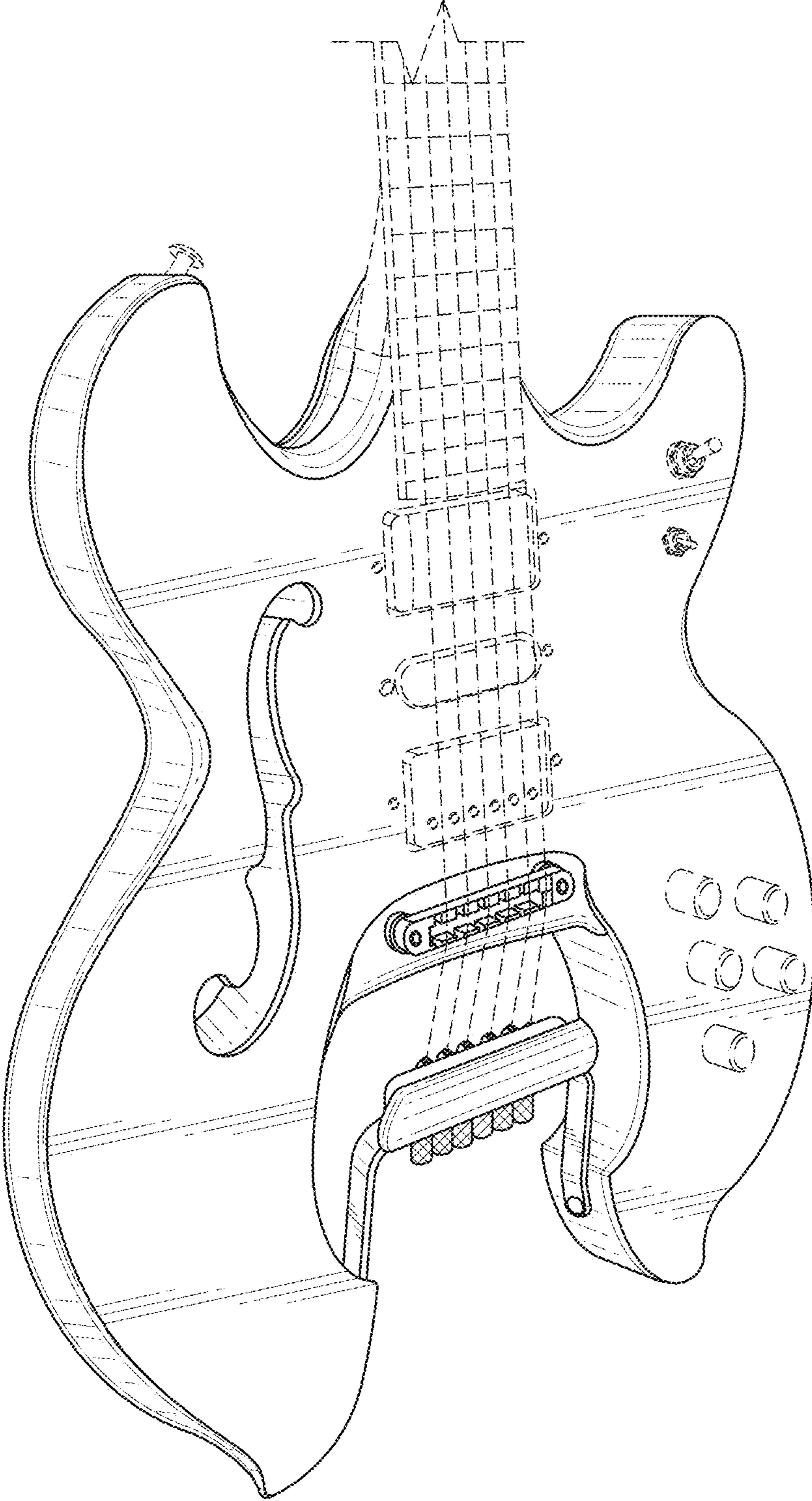
