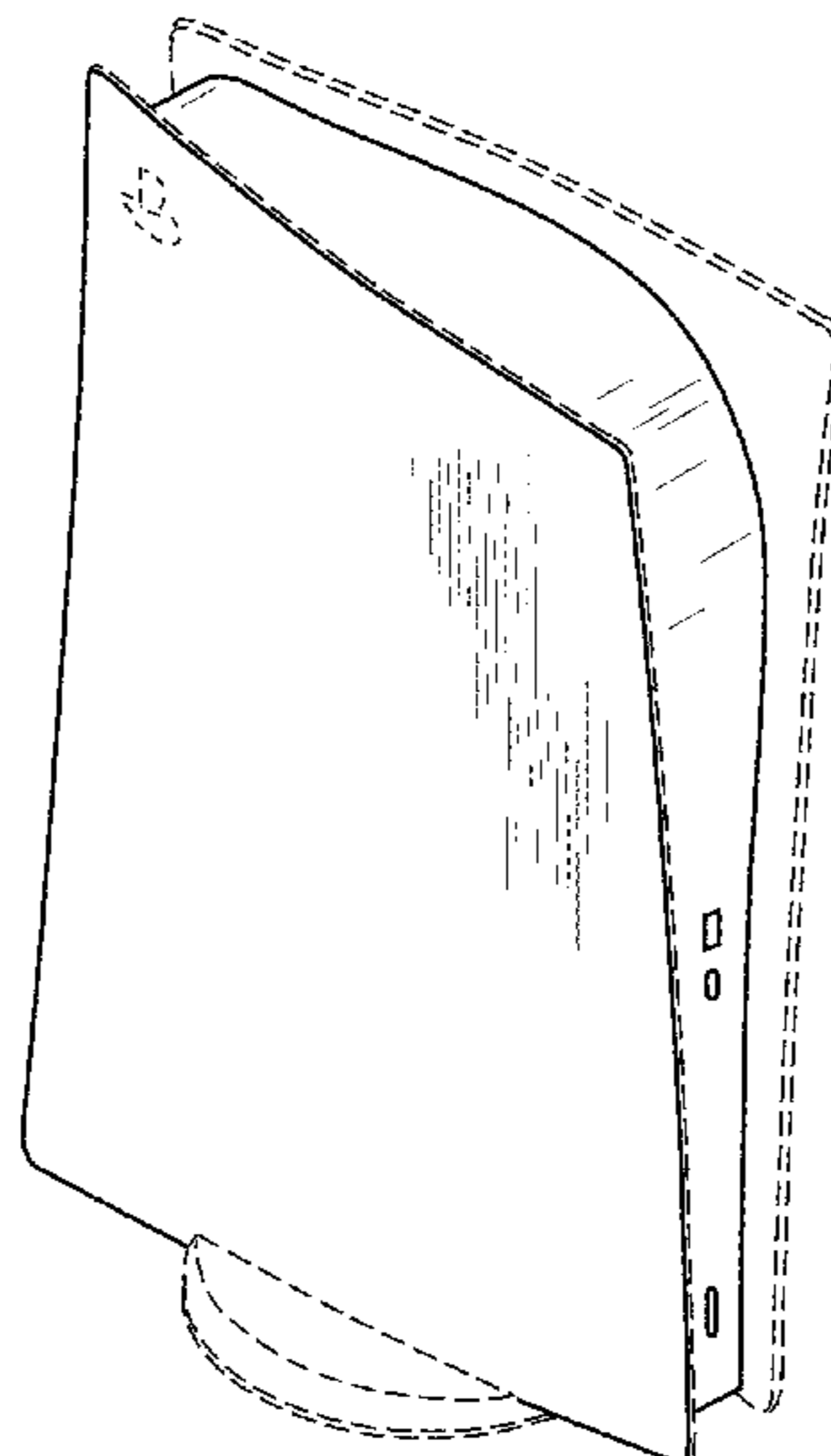
(57) **CLAIM**

The ornamental design for a skin cover set for a gaming console, as shown and described.

DESCRIPTION

FIG. 1 is a top plan view for a skin cover set for a gaming console showing my new design;
FIG. 2 is a left side elevation view;
FIG. 3 is a right-side elevation view;
FIG. 4 is a front elevation view;
FIG. 5 is a rear elevation view; and,
FIG. 6 is a top perspective view, showing the claimed design in its environment of use.
The broken line on the top left of the skin cover set for a gaming console depicts a portion that forms no part of the claimed design. The remaining broken lines illustrate environmental structure that form no part of the claimed design.

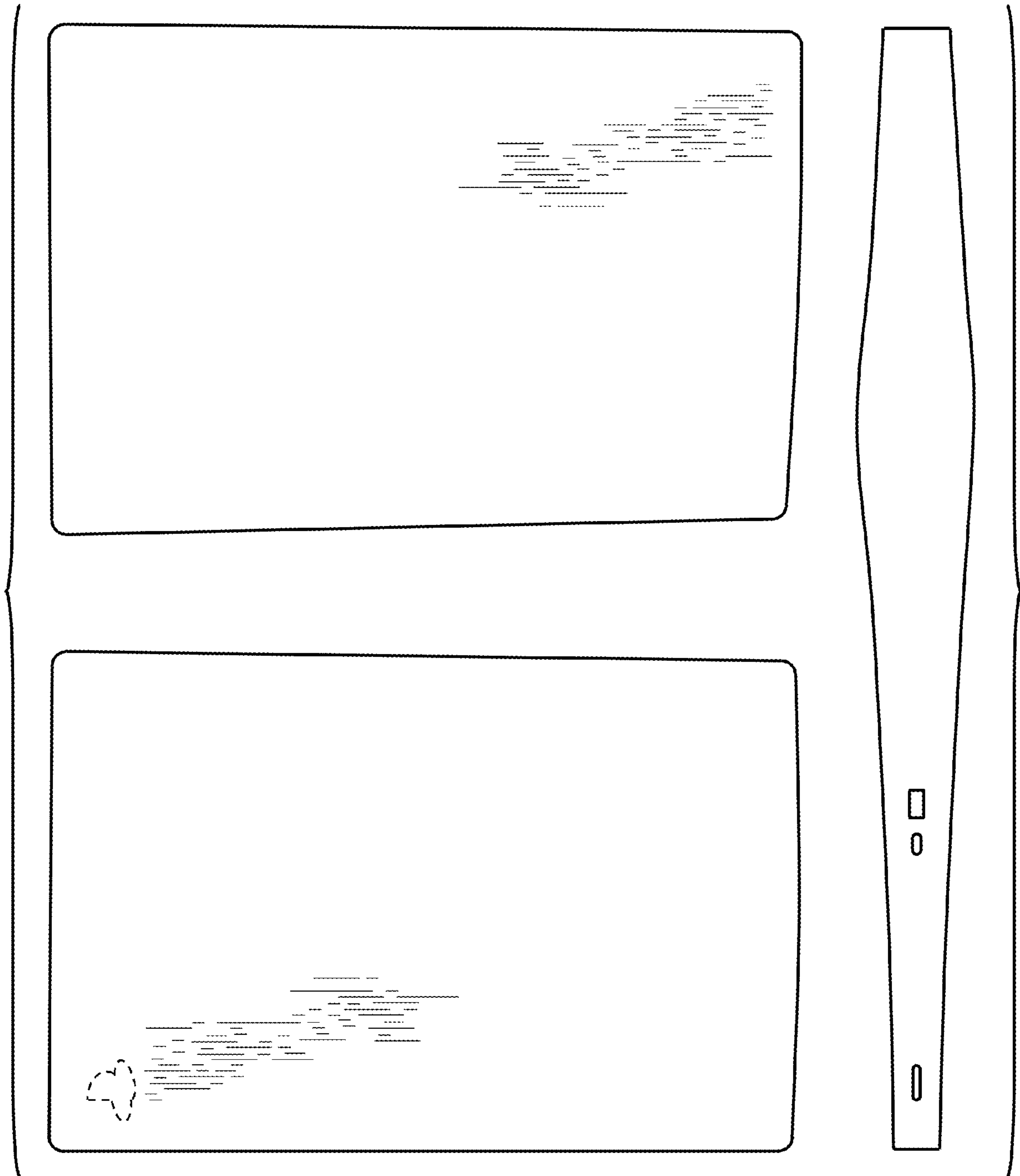

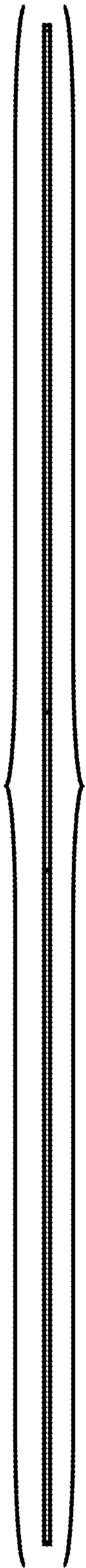

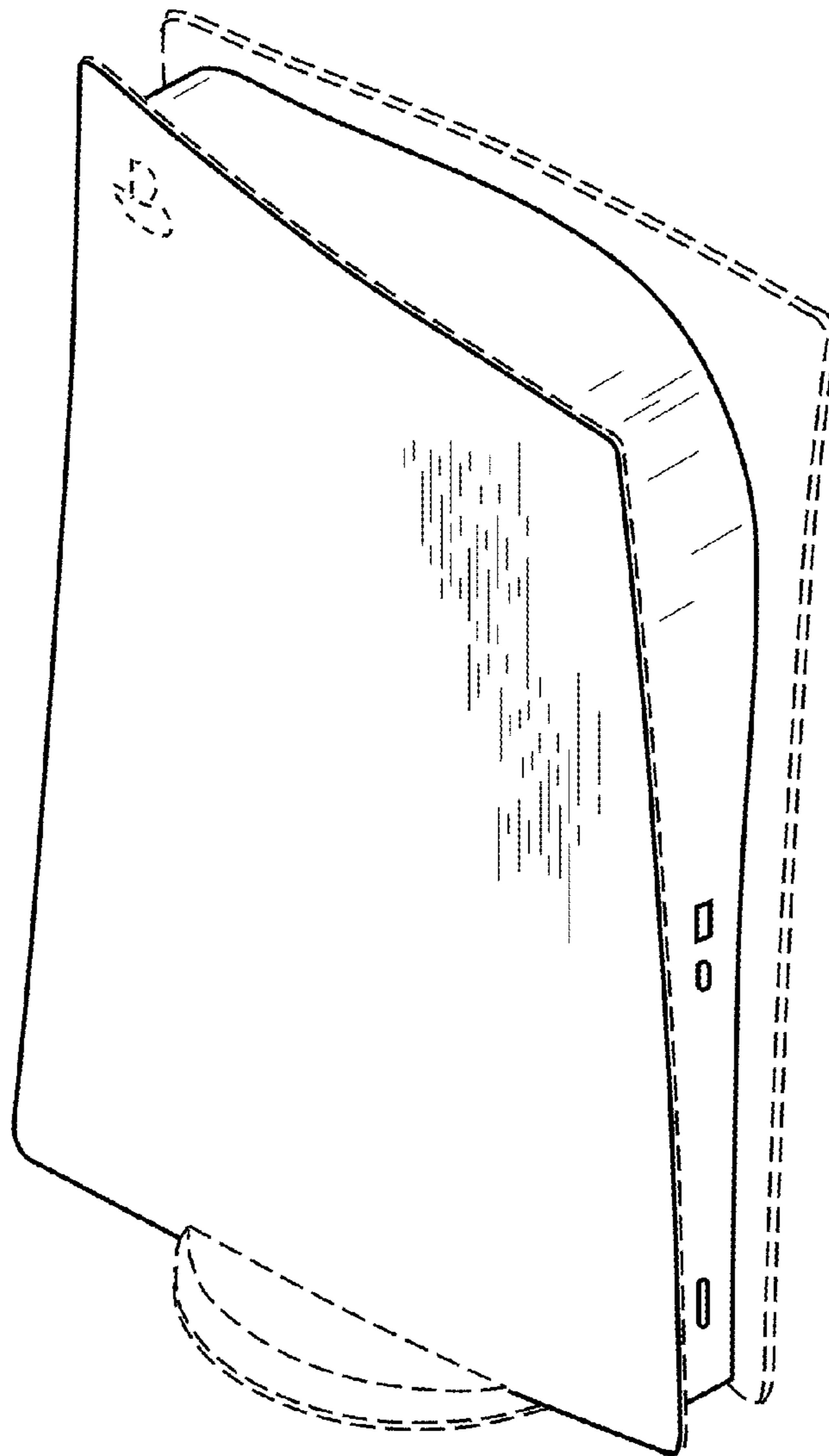
