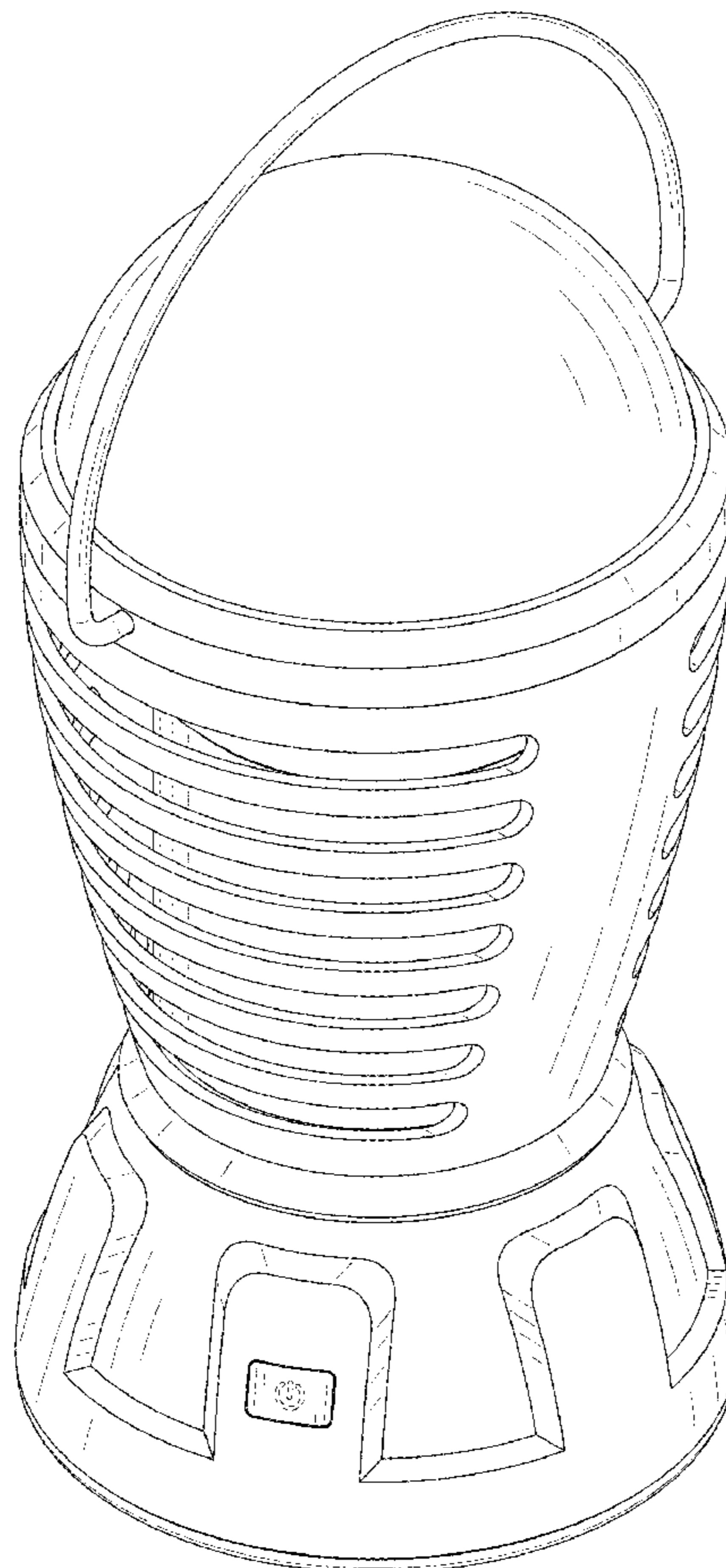
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a first perspective view of a starry sky mosquito light showing my new design;

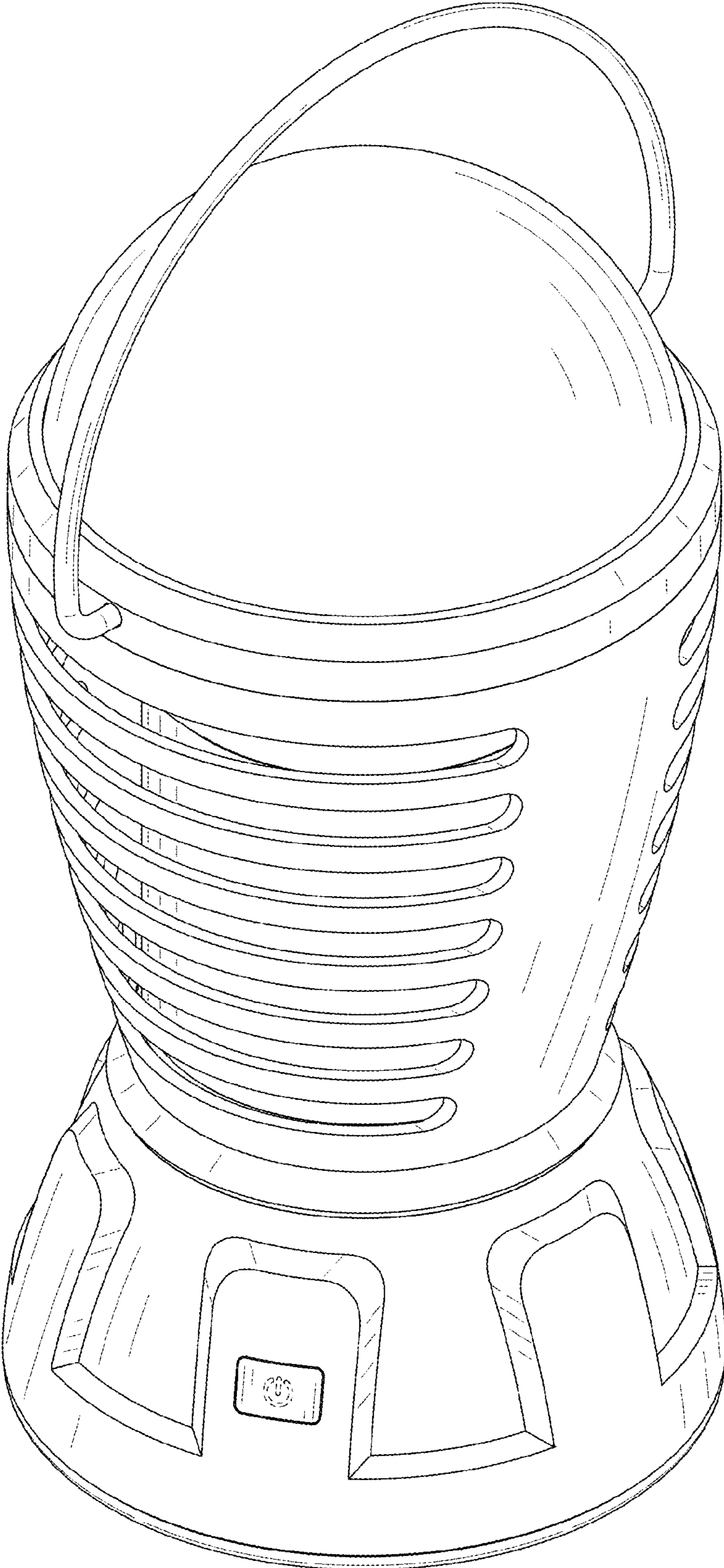

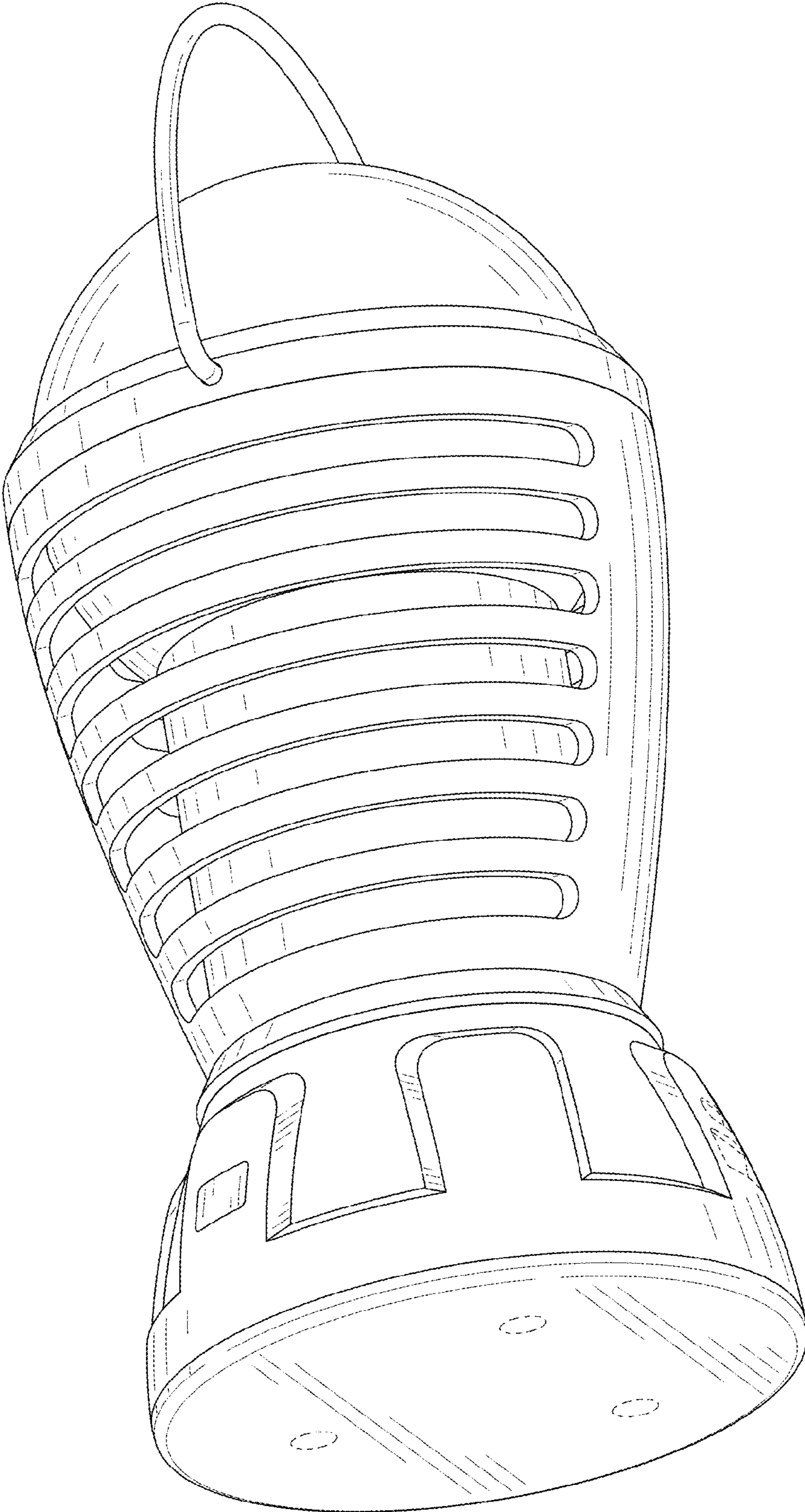

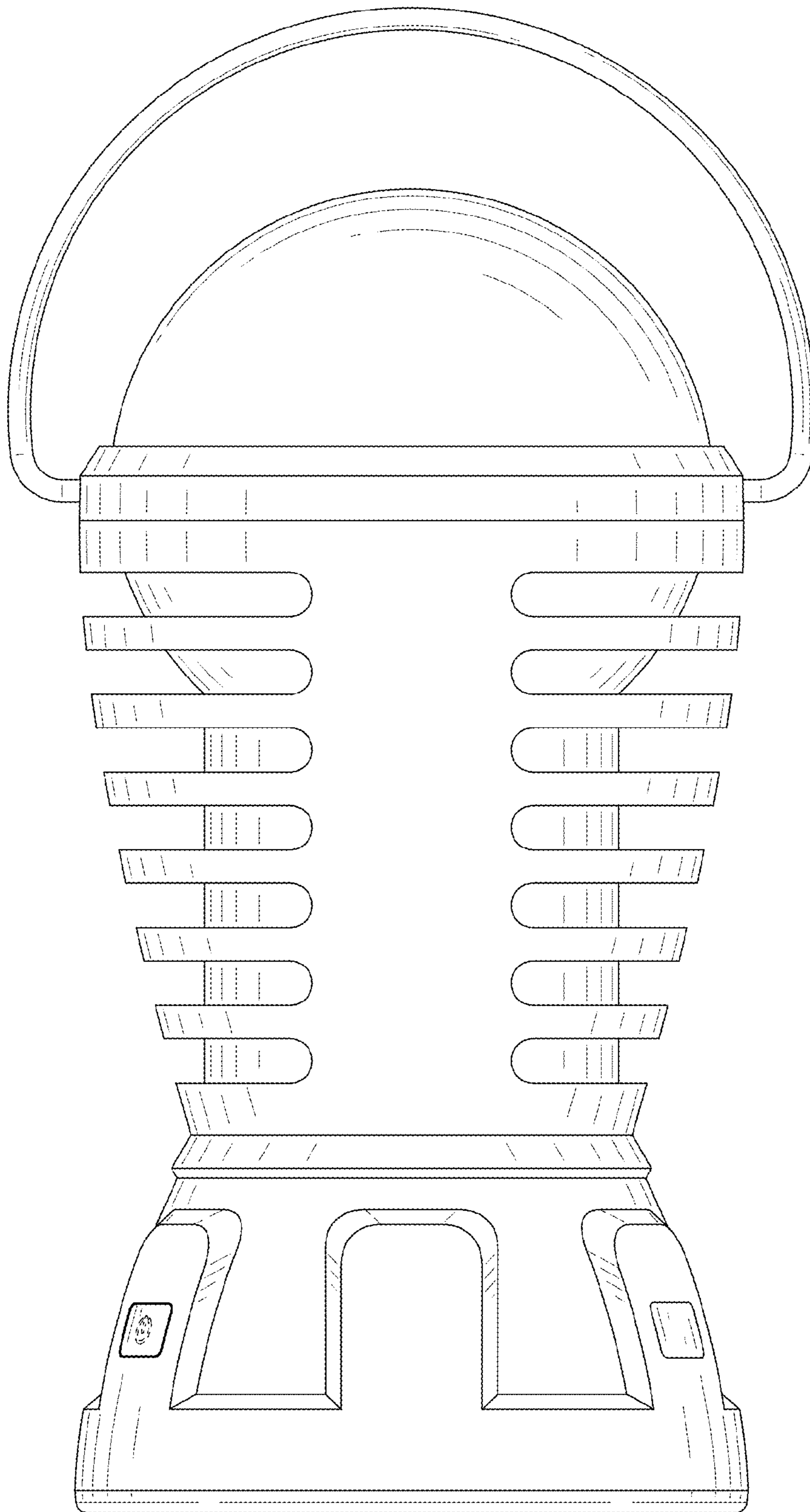

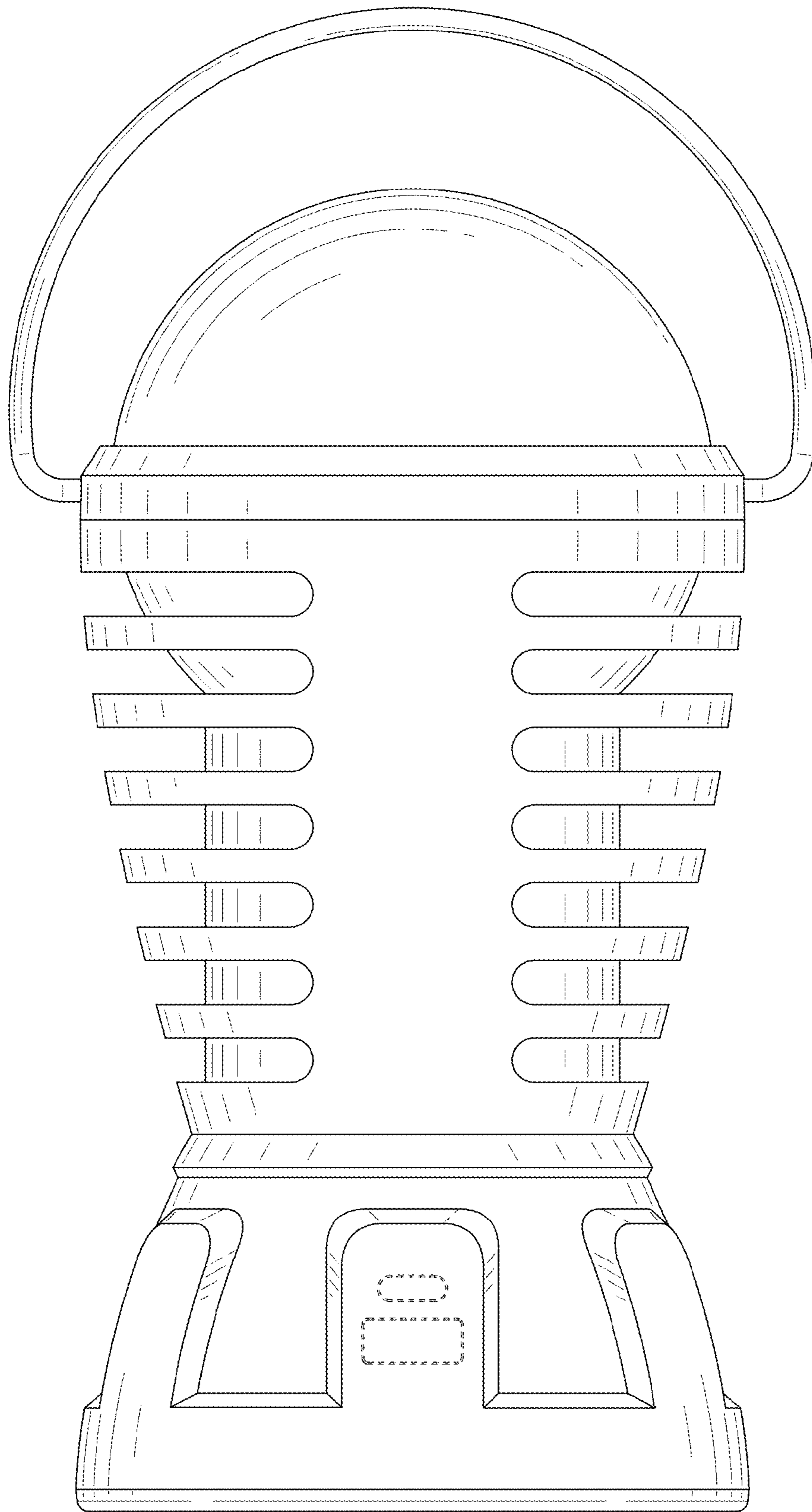

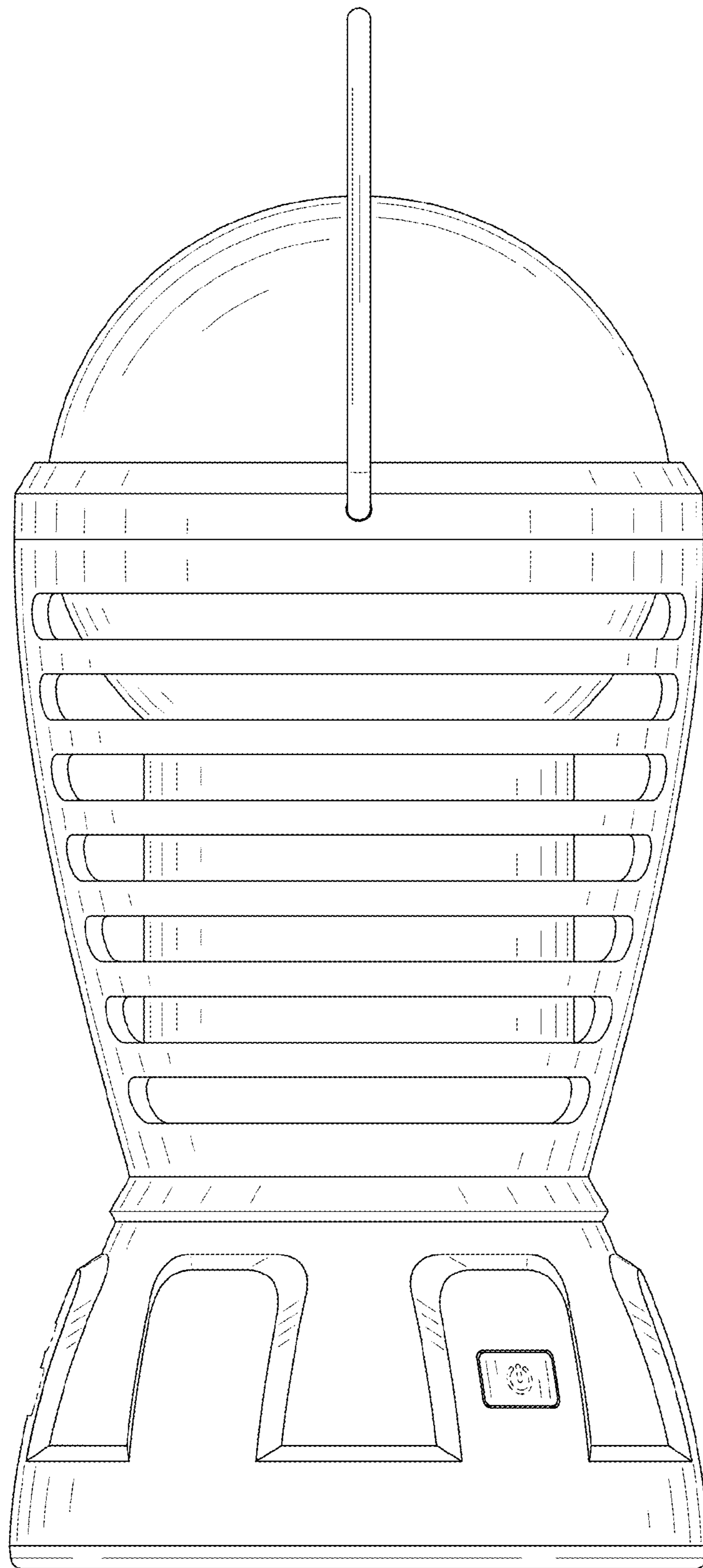

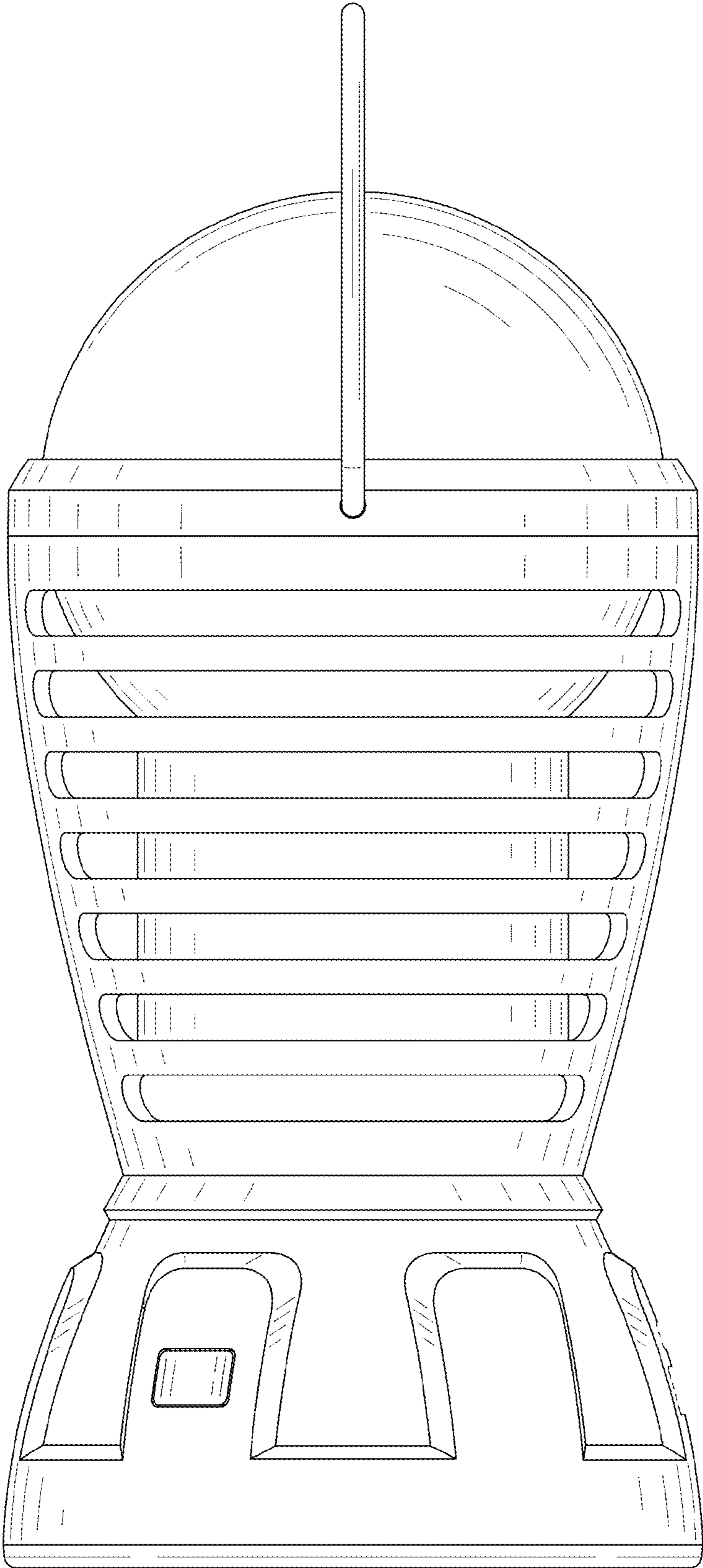

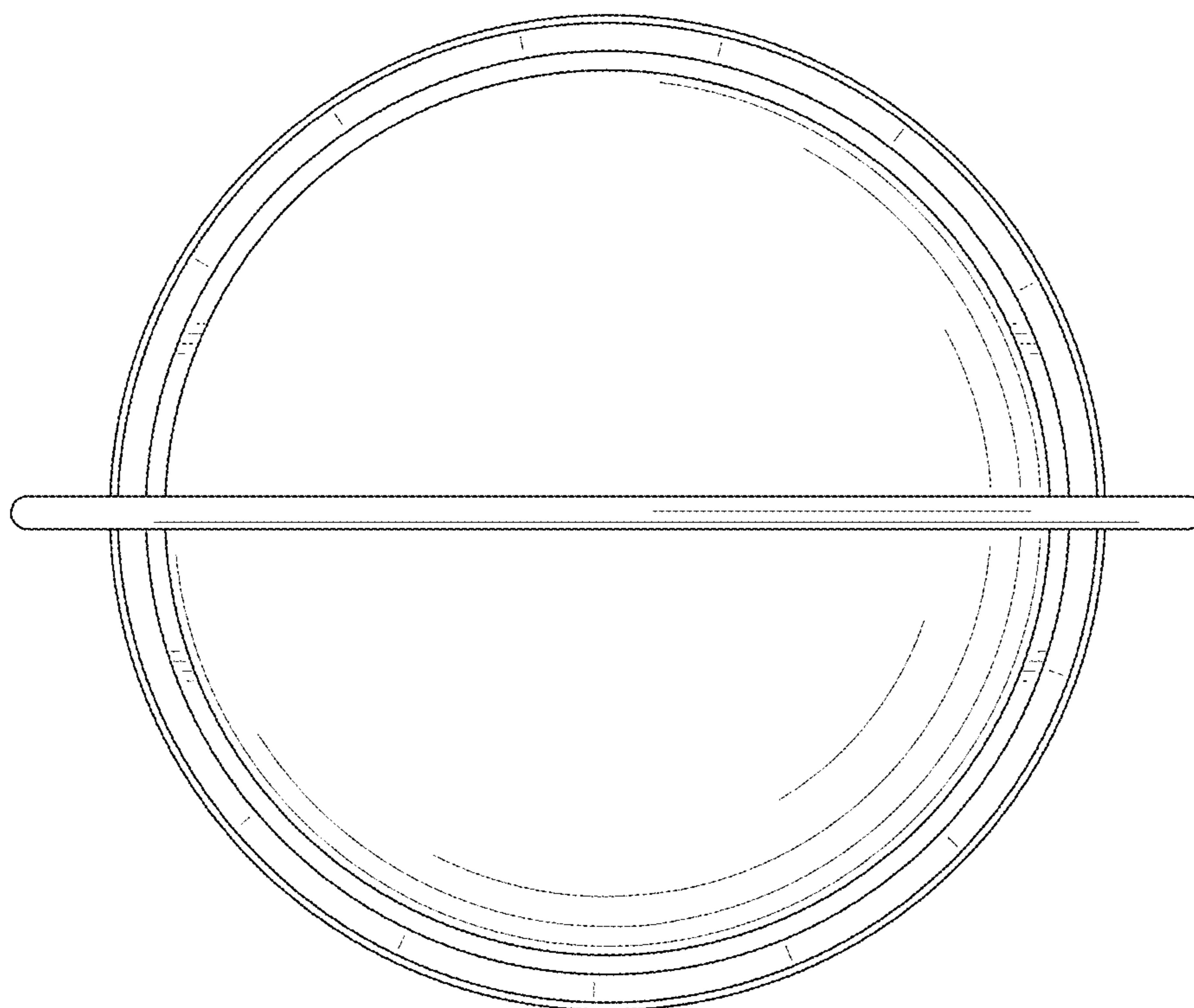

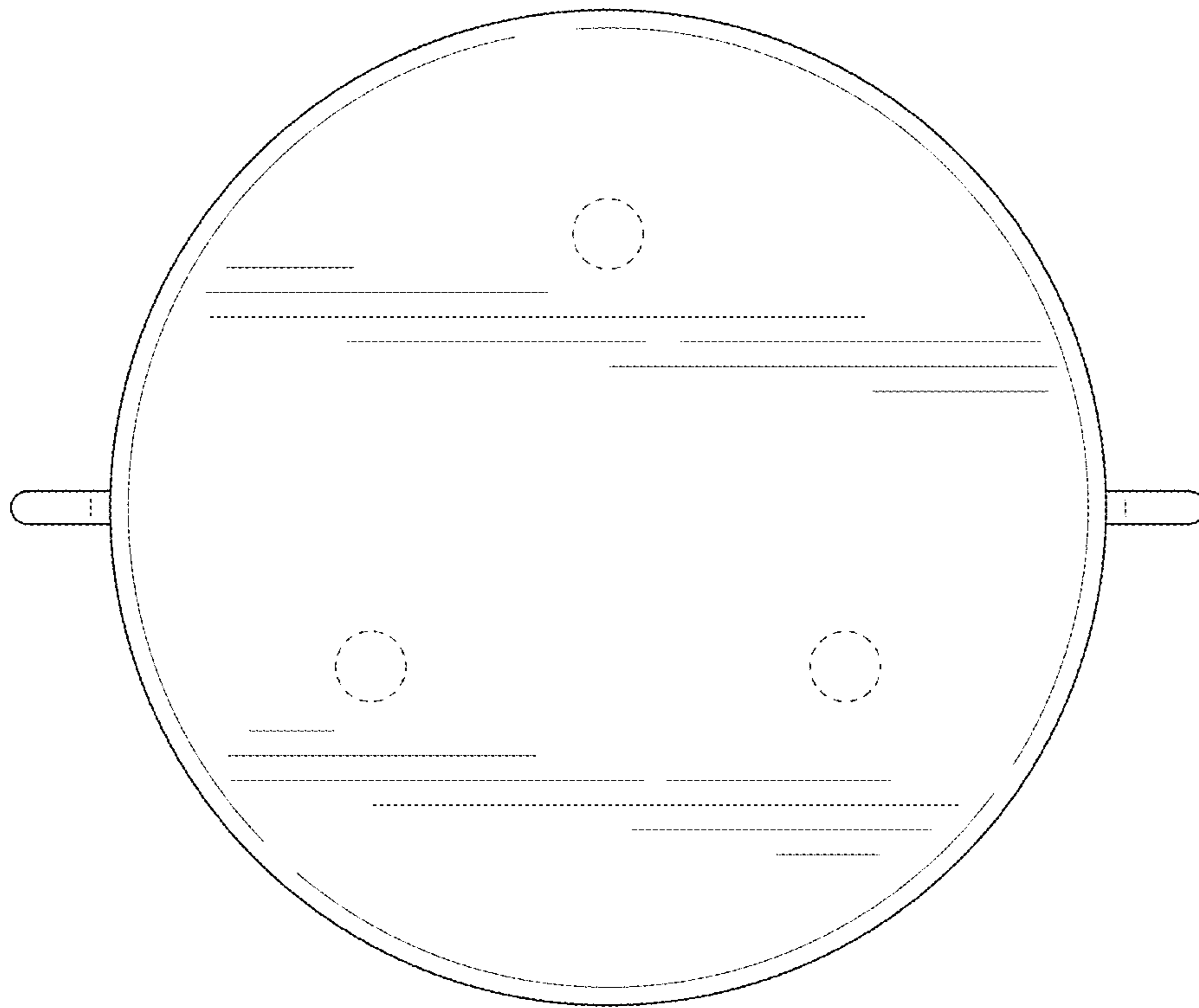
